# F irst E xcited B and of a Spinor B ose E instein C ondensate

#### Abstract

The analytical expression of the fractional parentage coe cients for the total spin-states of a spinor N -boson system has been derived. Thereby an S -conserved theory for the spinor BoseE instein condensation has been proposed. A set of equations has been established to describe the rst excited band of the condensates. N um erical solution for ${ }^{23} \mathrm{~N}$ a has been given as an exam ple.

In recent years, accom panying the experim ental realization of the spinor Bose E instein condensation (BEC) [10
 [12, 13]. T he total spin $S$ together $w$ ith its $Z$-com ponent are actually conserved in the spinor condensates. Furthem ore, the interactions are in generalspin-dependent. $T$ herefore, the strength of the $m$ ean eld $g$ that acts on the $m$ acroscopically occupied quantum states $m$ ight depend on $S$. In previous theories, the $S$-dependence of the strength $g$ has not yet been perfectly clari ed. A prim ary attem pt along this line was proposed in $R$ ef. [1] where the total spin-states have been introduced and the S-dependence of $g$ has been derived analytically.
$T$ he present paper is a continuation of the Ref. [141]. It is noted that the them odynam ical property of condensates at low tem perature depends on their low-lying spectra, this is an interesting topic scarcely touched. T he _rst aim of the paper is to generalize the study of $R$ ef. [14] from the ground band (G B) to excited bands. $R$ igorous total spin-states w ith good quantum numbers, $S$ and $S_{z}$, and with a speci c perm utation sym $m$ etry (see below) will be introduced, a set of equations is derived to describe, as a rst step, the rst excited band (FEB) of the spinor BEC.

W hen the totalspin states are adopted, how to achieve the $m$ atrix elem ents am ong them is crucial. The second aim of this paper is to develop a generaltool, nam ely the fractional parentage coe cients, to facilitate the theoretical treatm ent of spinor $N$-boson system $s$. $T$ he case of ${ }^{23} \mathrm{~N}$ a as an exam ple w ill be studied num erically. B efore going ahead, we need som e know ledge from few booson system s.

Let the interaction between a pair of spin-one bosons be $U_{i j}=\left(r_{i} r_{j}\right) O_{i j}, O_{i j}=g_{m} P_{m}+g_{q} P_{q}=c_{0}+$ $C_{2} F_{i} \quad F_{j}$. $W$ here $P_{m}$ and $P_{q}$ are projectors to the two-body spin-states with spin $S_{i j}=0$ and 2 (spin 1 is irrelevant since in this case both the spin wavefunction and the spatialw avefunction $m$ ust be antisym $m$ etric that prevents a point interaction), respectively, $g_{m}$ and $g_{q}$ are the associated strengths, $\mathrm{F}_{\mathrm{i}}$ is the spin operator of particle $i, c_{0}=\left(g_{m}+2 g_{q}\right)=3$, and $c_{2}=\left(g_{q} g_{m}\right)=3$. Let the $N$ bosons ( $w$ th $m$ ass $m$ ) be con ned by a harm onic trap w th frequency !. W hen $\sim$ ! and $\frac{\tilde{m} \text { ! are used as }}{\text { a }}$ units of energy and length, respectively, the H am iltonian

U sing the $m$ ethod as given in [ $\left.{ }^{-1}{ }^{-1}\right]$, the $H$ am iltonians for $N=3$ and 4 two-dim ensional system $s$ have been diagonalized. B oth the orbitalangularm om entum $L$ and $S$ are good quantum num bers, therefore the eigenenergies and eigenstates can be denoted as $\mathrm{E}_{\mathrm{LS}}$ and LS (there is actually a series of states having the sam e L and $S$; but only the lowest of them is concemed). It was found that, the levels are grouped as shown in Fig.1. In the low est ( rst) group allbosons rem ain $m$ ostly in the low est harm onic oscillator ( $\mathrm{h} . \mathrm{o}$.) shell, in the second group one of the bosons is m ainly in the rst excited h.o. shell, etc. .A ll the levels in the rst group have $L=0$, they would be degenerate if the interaction were spin-independent (i.e., $g_{q}=g_{m}$ or $c_{2}=0$ ), otherw ise they would split into a band, the ground band (GB). A ll levels in the second group have $\mathrm{L}=1$, they would be degenerate into two levels if $g_{q}=g_{m}$, and each would split into a band if $g_{q} \in g_{m}$. Thus, the tw o low est group contain totally three bands. In particular, we found that the third band is exactly a shiff as a whole of the ground band by the unit $\sim!$, therefore it is sim ply the cm. excited states of the ground band. $W$ e shall concentrate on the second band, nam ely the FEB.

Since the totalw ave function $m$ ust be totally sym $m$ etric $w$ ith respect to particle perm utation, it can be in generalw ritten as

where $\#_{S ; k}^{j}$ is the totalspin-statew ith the good quantum numbers $S, S_{z}$, and it is also the $j$ th basis function of the representation of the N -body perm utation group. The index $k$ refers to the $m$ ultiplicity, i.e., $m$ ore than one set of total spin states $m$ ight have the sam e $S$ and . [1]] $f_{L S k} ; j$ is a spatial function belonging to the sam e representation . The sum $m$ ation over $j$ is necessary to assure is to be totally sym $m$ etric. The sum $m$ ation over and $k$ is necessary because that they are not conserved under the interaction.

For a given state, from $\left.\underline{2}_{\mathbf{Z}}^{\mathbf{- 1}}\right)$ we can de ne the weight of a representation as

$W$ hen $g_{q}=g_{m}$ the perm utation sym $m$ etry is pure and therefore W Ls; $=1$ or $0 . W$ hen $g_{q} g_{m}$, the $m$ ixing of appears, but rem ains very weak. It $w$ as found that, for both $N=3$ and 4, the GB is dom inated by $=\mathrm{fN} \mathrm{g}$ , while the FEB by $=\mathrm{fN} 1 ; 1 \mathrm{~g}$. Even if the spindependent interaction is very strong $\left(g_{q}=g_{m}=0: 6\right.$ and $g_{m}+g_{q}=3$ ), the GB still has W os;fN g 0:996 and the FEB has $W_{1 s ; f N} 1 ; 1 \mathrm{~g} \quad 0: 998$, thus the $m$ ixing is still weak. Since the m ixing is so slight, is nearly a good quantum num ber. Therefore, the labels ( $L$; S; ) can be used to label the states as m arked in Fig.1.
$T$ here are four points notioeable.
(i) The zero-range interaction between two bosons would be zero if their spatialwave function is antisym $m$ etric (because in this case the tw o bosons do not overlap). Since the interaction is repulsive, the representation $\quad w$ ith $m$ ore antisy $m$ etric pairs is $m$ ore advantageous to binding because the repulsion can be thereby reduced.
(ii) W hen one and only one boson has been excited to the second $h . o$. shell, the spatial perm utation sym $m$ etry is restricted to $=\mathrm{fN} g$ and $\mathrm{fN} 1 ; 1 \mathrm{~g}$; and this explains why the second group contains two bands as shown in Fig.1. W here the band w ith fN $1 ; 1 \mathrm{~g}$ is lower due to the reason stated in point (i). Thus the FEB would in generalhave $=\mathrm{fN} 1 ; 1 \mathrm{~g}$.
(iii) The energy would also depend on $S$ due to the spin-dependent interaction. Thus, the levels $w$ ith the same would further split into a band.
(iv) W hen $\mathrm{g}_{\mathrm{q}}>\mathrm{g}_{\mathrm{m}}$, the pair coupled to $\mathrm{S}_{\mathrm{ij}}=2$ is $m$ ore repulsive than the pair coupled to 0 . Evidently, the $m$ any-body state $w$ th a larger $S$ would have $m$ ore pairs coupled to 2. Therefore, in a band, the state $w$ ith a larger $S$ is higher. On the contrary, when $g_{q}<g_{m}$, the state w ith a larger $S$ is low er as show $n$ in $F$ ig.1.

To generalize the above study to the case with a very large $N$, we need the know ledge of the total spinstates. For the m ost im portant case of $=\mathrm{fN} g$, there is an unique $\#_{\mathrm{S} ; \mathrm{k}}^{\mathrm{fN}}$ if $\mathrm{N} \quad \mathrm{S}$ is even, or there is none
 not necessary, and a sim pler notation $\#_{S}^{f N} g \quad \#_{S ; k}^{f N} g j$ can be used.

Let us start from a 2 -boson system with $\#_{S}^{f 2 g}(12)=$ ( (1) (2) $)_{S}$, where (i) is the single boson spin-state, $S=0$ or 2 . For $N=3$, the requirem ent that $N$. $S$ is even leads to $S=3$ and 1. They were given in [1] as

 $\#_{S^{0}}^{\mathrm{fN}}{ }^{1 \mathrm{~g}}$ of the $(\mathbb{N} \quad 1$ )-boson system have been known. $T$ hen, taking the rule ofangularm om entum coupling and the rule of outer product into account, the $\#_{S}^{\text {fN } g}$ of the N -boson system can be uniquely expanded as

where $a_{S^{0}} \mathrm{fN}^{\mathrm{N}}$ and $b_{S^{0}}^{\mathrm{fN} g}$ are the fractional parentage $\mathrm{CO}^{-}$ e cients (FPC) to be determ ined, how ever they are zero if $\mathrm{N} \quad \mathrm{S}$ is odd.

O n the other hand, since the $\#_{S}^{\mathrm{fN} g}$ is totally sym $m$ etric as required, the right hand side of $\left(\overline{\eta_{1}}\right) \mathrm{m}$ ust be invariant against the interchange of the $N$-th and ( $N-1$ )-th bosons. $T$ his leads to a set of three hom ogeneous equations. It tums out that they are linearly dependent, one of them reads

The FPC are very usefil because related $m$ atrix ele$m$ ents am ong the total spin-states can be thereby calculated.

N ow let us study the set of total spin-states w the $\mathrm{fN} \quad 1 ; 1 \mathrm{~g}$ sym m etry. It has been proved that the m ultiplicity ofth is set is one [16], therefore they can be labelled in a simplerway as ${ }_{S}^{i} \quad \#_{S ; k}^{f N} \quad 1 ; 1 g i \quad$. if $\mathrm{N} \quad \mathrm{S}$ is odd, where the notation $i$ represents all the bosons except the $i$ th . From the rule of outer product, (15) and (1-1) w ill contain only the sym $m$ etries fN $g$ and fi $1 ; 1 \mathrm{~g}$. However, when $\mathrm{N} S$ is even, (15긍) is orthogonal to the unique totally sym $m$ etric spinstate $\#_{\mathrm{S}}^{\mathrm{fN} g}$. Hence, it has the pure fN $1 ; 1 \mathrm{~g}$ sym m etry. W hen $\mathrm{N} \quad \mathrm{S}$ isodd, it hasbeen stated above that $\#_{\mathrm{S}}^{\mathrm{fN} g}=$ 0 , therefore (19) has also the pure fN $1 ; 1 \mathrm{~g}$ sym m etry. It is obvious from (121) and (13) that ${ }_{s}^{i}$ does not exist if $S=0$ orN . Thusthe $S$ of $\frac{i}{S}$ is ranged from 1 to $N \quad 1$ , while the index i of $\frac{i}{S}$ is ranged from 1 to $N$. This set of N states are not mputually orthogonalbut linearly dependent. They satisfy ${ }_{i}{ }_{S}^{i}=0$. This arises because the sum $m$ ation over i leads to a sym $m$ etrization, a state w ith fN g w ill not survive after the sym m etrization.

B ased on the know ledge of ${ }_{s}^{i}$, we can begin to study the FEB (three-dim ensional) of realistic cases. Let the norm alized single-particle state of condensation be denoted as' ${ }_{s}^{a}=\frac{1}{4} r_{r}^{a}(r)$, while the excited state be denoted as ${ }_{S}^{b}=\frac{1}{r} u_{S}^{b}(r) Y_{l m}(;)$ with $l=1$. As a basic assum ption we de ne the spatialwave function as

W here the sum $m$ ation over $i$ leads to a sym $m$ etrization as required, and the fN $1 ; 1 g$-representation has been introduced. The expansion in (18) is di erent from (2),
but both are eigenstates of the total spin and sym m etricalw th respect to particle perm utation, thus both are applicable.

Inserting (1d) into the Schrodinger equation, using the standard variationalprocedure, the equations for ${ }^{\prime}{ }_{s}$ and ${ }^{\circ}{ }_{\mathrm{S}}^{\mathrm{b}}$ can be deduced as

In the FEB, all the members with odd $N \mathrm{~S}$ do not have their partners in the ground band, they are the lowest states with the given $S$. If the system is cooled from higher to zero tem perature, and if no spin-relaxation $m$ echanism is available, the probability of staying in the FEB is nearly half. Incidentally,
when N is large, since $\mathrm{g}_{\mathrm{S}}^{\mathrm{a}}$ is very close to the $\mathrm{g}_{\mathrm{s}}=$ $c_{0}+(S(S+1) \quad 2 N)=(\mathbb{N}(\mathbb{N} \quad 1)) c_{2}$ of the ground band ${ }^{14}$ , thus ${ }_{S}^{\text {a }}$ is very close to that of the ground band ifN $S$ is even.

As an application we calculated the FEB of ${ }^{23} \mathrm{Na}$ atom strapped in a harm onjc well w th $\sim!=100 \mathrm{~Hz}$ and $w$ th $g_{m}=6: 351 \quad 10{ }^{4} \mathrm{P}$ ! , $g_{q}=g_{m}=1: 10$. The norm alized radial $w$ ave functions $R^{a}(r)=u_{S}^{a}(r)=r$ and $R^{b}(r)=u_{s}^{b}(r)=r$ are given in $F$ ig 2 (a) and (b) respectively.

Let $\mathrm{E}_{\mathrm{S}}{ }^{(g)}$ denote the energies of the GB $\left(\mathrm{E}_{0}{ }^{(g)}\right.$ is the ground state energy ). T he upper and low er bounds of the FEB, i.e., $\mathrm{E}_{\mathrm{N}}{ }^{(\mathrm{e})}{ }_{1}$ and $\mathrm{E}_{1}^{(\mathrm{e})}$ relative to $\mathrm{E}_{0}^{(\mathrm{g})}$ are plotted in $F$ ig.3. This gure dem onstrates how the FEB and GB
split. In particular when $N$ gets larger, the lower bound of FEB would cross the upper of the GB, it implies an overlap of these two bands.

In sum $m$ ary, we have derived a set of equations to describe the rst excited band, this $m$ ight lead to a deeper understanding of the condensates at very low tem perature. Furthem ore, we have achieved the analytical form of the fractional parentage coe cients. This will greatly facilitate the calculations dealing $w$ th the total spin-states, and will thereby prom ote the applicability of the $S$-conserved theory for various spinor $m$ any-body system s.
