First Excited B and of a Spinor Bose-Einstein C ondensate

The analytical expression of the fractional parentage coe cients for the total spin-states of a spinor N-boson system has been derived. Thereby an S-conserved theory for the spinor Bose-Einstein condensation has been proposed. A set of equations has been established to describe the rst excited band of the condensates. Num erical solution for ²³N a has been given as an example.

In recent years, accompanying the experimental realization of the spinor Bose-Einstein condensation (BEC) [1, 2, 3, 4, 5], corresponding theories based on the mean eld theory have been developed [6, 7, 8, 9, 10, 11, 12, 13]. The total spin S together with its Z-component are actually conserved in the spinor condensates. Furtherm ore, the interactions are in general spin-dependent. Therefore, the strength of the mean eld g that acts on the macroscopically occupied quantum states might depend on S. In previous theories, the S-dependence of the strength g has not yet been perfectly clari ed. A primary attempt along this line was proposed in Ref. [14] where the total spin-states have been introduced and the S-dependence of g has been derived analytically.

The present paper is a continuation of the Ref. [14]. It is noted that the therm odynam ical property of condensates at low tem perature depends on their low -lying spectra, this is an interesting topic scarcely touched. The rst aim of the paper is to generalize the study of Ref. [14] from the ground band (GB) to excited bands. Rigorous total spin-states with good quantum numbers, S and S_Z, and with a speci c permutation symmetry (see below) will be introduced, a set of equations is derived to describe, as a rst step, the rst excited band (FEB) of the spinor BEC.

W hen the total spin states are adopted, how to achieve the m atrix elements among them is crucial. The second aim of this paper is to develop a general tool, namely the fractional parentage coe cients, to facilitate the theoretical treatment of spinor N-boson systems. The case of 23 Na as an example will be studied numerically. Before going ahead, we need some knowledge from few-boson systems.

Let the interaction between a pair of spin-one bosons be U_{ij} = $(r_i r_j)O_{ij}$, $O_{ij} = g_m P_m + g_q P_q = c_0 + c_2 F_i E_j$. Where P_m and P_q are projectors to the two-body spin-states with spin $S_{ij} = 0$ and 2 (spin 1 is irrelevant since in this case both the spin wavefunction and the spatial wavefunction m ust be antisym m etric that prevents a point interaction), respectively, g_m and g_q are the associated strengths, F_i is the spin operator of particle i, $c_0 = (g_m + 2g_q)=3$, and $c_2 = (g_q g_m)=3$. Let the N bosons (with m ass m) be con ned by a harm onic trap with frequency !. When ~! and $\frac{\tilde{m}}{m!}$ are used as units of energy and length, respectively, the H am iltonian

reads

Using the method as given in [15], the Ham iltonians for N = 3 and 4 two-dimensional systems have been diagonalized. Both the orbital angularm om entum L and S are good quantum num bers, therefore the eigenenergies and eigenstates can be denoted as E_{LS} and L_{LS} (there is actually a series of states having the same L and S; but only the lowest of them is concerned). It was found that, the levels are grouped as shown in Fig.1. In the low est (rst) group allbosons remain mostly in the low est harm onic oscillator (h.o.) shell, in the second group one of the bosons is mainly in the rst excited h.o. shell, etc. . All the levels in the rst group have L = 0, they would be degenerate if the interaction were spin-independent (i.e., $g_q = g_m$ or $c_2 = 0$), otherwise they would split into a band, the ground band (GB). All levels in the second group have L = 1, they would be degenerate into two levels if g_q = g_m , and each would split into a band if $g_q \in g_m$. Thus, the two lowest group contain totally three bands. In particular, we found that the third band is exactly a shift as a whole of the ground band by the unit ~! , therefore it is simply the cm. excited states of the ground band. W e shall concentrate on the second band, namely the FEB.

Since the total wave function must be totally symmetric with respect to particle permutation, it can be in general written as

where $\#_{S,k}^{j}$ is the total spin-state with the good quantum numbers S, S_Z , and it is also the j th basis function of the representation of the N-body permutation group. The index k refers to the multiplicity, i.e., more than one set of total spin states m ight have the same S and . [16] $f_{LS,k;j}$ is a spatial function belonging to the same representation . The summation over j is necessary to assure $_{LS}$ to be totally symmetric. The summation over and k is necessary because that they are not conserved under the interaction.




FIG.1: The evolution of $E_{\rm LS}$ (in $\sim !$) with $g_q=g_m$ in 3-boson (a) and 4-boson (b) system s. (L;S;) are marked by the levels.

W hen $g_q = g_m$ the permutation symmetry is pure and therefore W_{LS;} = 1 or 0 . W hen $g_q \in g_m$, the mixing of appears, but remains very weak. It was found that, for both N = 3 and 4, the GB is dominated by = fN g, while the FEB by = fN 1;1g. Even if the spin-dependent interaction is very strong ($g_q=g_m = 0.6$ and $g_m + g_q = 3$), the GB still has W_{0S;fNg} 0:996 and the FEB has W_{1S;fN 1;1g} 0:998, thus the mixing is still weak. Since the mixing is so slight, is nearly a good quantum number. Therefore, the labels (L;S;) can be used to label the states as marked in Fig.1.

There are four points noticeable.

(i) The zero-range interaction between two bosons would be zero if their spatial wave function is antisym - metric (because in this case the two bosons do not overlap). Since the interaction is repulsive, the representation with more antisym metric pairs is more advantageous to binding because the repulsion can be thereby reduced.

(ii) W hen one and only one boson has been excited to the second h.o. shell, the spatial permutation symmetry is restricted to = fN g and fN = 1;1g; and this explains why the second group contains two bands as shown in Fig.1. W here the band with fN = 1;1g is lower due to the reason stated in point (i). Thus the FEB would in general have = fN = 1;1g.

(iii) The energy would also depend on S due to the spin-dependent interaction. Thus, the levels with the same would further split into a band.

(iv) W hen $g_q > g_m$, the pair coupled to $S_{\,ij} = 2$ is more repulsive than the pair coupled to 0. Evidently, the many-body state with a larger S would have more pairs coupled to 2. Therefore, in a band, the state with a larger S is higher. On the contrary, when $g_q < g_m$, the state with a larger S is lower as shown in Fig.1.

To generalize the above study to the case with a very large N, we need the know ledge of the total spin-states. For the most in portant case of = fN g, there is an unique $\#_{S,k}^{fN gj}$ if N S is even, or there is none otherw ise[14, 17]. Therefore both the labels j and k are not necessary, and a simpler notation $\#_{S}^{fN gj} \#_{S,k}^{fN gj}$ can be used.

Let us start from a 2-boson system with $\#_S^{f2g}(12) =$ ((1)(2))_S, where (i) is the single boson spin-state, S = 0 or 2. For N = 3, the requirement that N = S is even leads to S = 3 and 1. They were given in [15] as

Starting from (4) and (5), let us assume that all $\#_{S^0}^{fN}$ ^{1g} of the (N 1)-boson system have been known. Then, taking the rule of angularm on entum coupling and the rule of outer product into account, the $\#_{S}^{fN\,g}$ of the N-boson system can be uniquely expanded as

where $a_{S^0}^{fN \ g}$ and $b_{S^0}^{fN \ g}$ are the fractional parentage coe cients (FPC) to be determ ined, however they are zero if N S is odd.

From (6), a similar formula can be written for $\#_{S_1}^{fN}$ ^{1g}. Therefore, $\#_{S_1}^{fNg}$ can be expanded once more as

On the other hand, since the $\#_{S}^{fN~g}$ is totally symmetric as required, the right hand side of (7) must be invariant against the interchange of the N-th and (N-1)-th bosons. This leads to a set of three hom ogeneous equations. It turns out that they are linearly dependent, one of them reads

and W $(1SS1;TT^{0})$ is the wellknown Racah coe cients. From (8) we obtain

if N S is even, where the constant ${}_{\rm S}^{\rm fN~g}$ is introduced to assure $(a_{\rm S}^{\rm fN~g})^2 + (b_{\rm S}^{\rm fN~g})^2 = 1$, so that $\#_{\rm S}^{\rm fN~g}$ is norm alized. Eqs.(10) and (11) together with the condition of norm alization lead to a unique solution, thus we obtain the analytical form of FPC as

The FPC are very useful because related m atrix elem ents among the total spin-states can be thereby calculated.

Now let us study the set of total spin-states with the fN 1;1g symmetry. It has been proved that the multiplicity of this set is one [16], therefore they can be labelled in a simpler way as $\frac{i}{s} #_{S;k}^{fN}$ 1;1grin . Since the dimension of fN 1;1g representation is N 1, i = 1;2; ;N . M aking use of the FPC, they can be expanded as

ίfΝ S is odd, where the notation i represents all the bosons except the i th . From the rule of outer product, (15) and (16) will contain only the symmetries fNg and fN 1;1g. However, when N S is even, (15) is orthogonal to the unique totally sym m etric spinstate $\#_{S}^{fNg}$. Hence, it has the pure fN 1;1g symmetry. W hen N S is odd, it has been stated above that $\#_{S}^{fN g} =$ 0, therefore (16) has also the pure fN 1;1g sym m etry. It is obvious from (12) and (13) that $\frac{i}{s}$ does not exist if S = 0 or N . Thus the S of $\frac{i}{s}$ is ranged from 1 to N , while the index i of $\frac{i}{s}$ is ranged from 1 to N . This set of N states are not mutually orthogonal but linearly dependent. They satisfy $i_{i} = 0$. This arises because the sum m ation over i leads to a sym m etrization, a state with find find find for the symmetrization.

Based on the know ledge of $\frac{i}{s}$, we can begin to study the FEB (three-dimensional) of realistic cases. Let the normalized single-particle state of condensation be denoted as ${}'{}^a_s = \frac{p-1}{4-r} u^a_s(r)$, while the excited state be denoted as ${}'{}^b_s = \frac{1}{r} u^b_s(r) Y_{lm}$ (;) with l=1. As a basic assumption we denote the spatial wave function as

Then, the total wave function is written as

W here the sum m ation over i leads to a sym m etrization as required, and the fN 1;1g-representation has been introduced. The expansion in (18) is di erent from (2), but both are eigenstates of the total spin and symmetricalwith respect to particle permutation, thus both are applicable.

Inserting (18) into the Schrödinger equation, using the standard variational procedure, the equations for $\prime_{\rm S}^{\rm a}$ and $\prime_{\rm S}^{\rm b}$ can be deduced as

The energies of the states in the FEB are given by

where S can be even or odd, and is ranged from 1 to N 1.

U sing the expansions (15) and (16) twice (one is for the N 1 body system), with the FPC given by (12) and (13), the matrix elements among $\frac{i}{s}$ can be obtained as

In the FEB, all the members with odd N S do not have their partners in the ground band, they are the lowest states with the given S. If the system is cooled from higher to zero temperature, and if no spin-relaxation mechanism is available, the probability of staying in the FEB is nearly half. Incidentally, when N is large, since g_s^a is very close to the $g_s = c_0 + (S(S+1) 2N) = (N(N 1)) c_2$ of the ground band¹⁴, thus $\binom{a}{S}$ is very close to that of the ground band if N S is even.




FIG.2: The radial wave functions, R^{a} (in (a)) and R^{b} (in (b)), as functions of r. The dashed curves are for N = 100, while the solid ones are for $N = 10^{5}$. In each case the curves for S = N 1; N 2; 2, and 1 are plotted. However, they can not be distinguished except the case of R^{b} with a large N, where S are marked by the curves. In (b), when S lies in between and N S is even (odd), the associated curves are distributed between the curves with S = 2 and 99998 (1 and 99999). Obviously, when N S is odd, the S-dependence is less explicit, and the R^{b} with S = N 2 has a smallest size.

As an application we calculated the FEB of ^{23}Na atoms trapped in a harmonic well with $\sim\!!$ = 100H z and with g_m = 6:351 10 $^{4^{\text{P}}}$, $g_q=g_m$ = 1:10 . The normalized radial wave functions R^a(r) = u_{\text{S}}^{a}(r)=r and R^b(r) = u_{\text{S}}^{b}(r)=r are given in Fig.2 (a) and (b) respectively.




FIG.3: $E_{s}^{(e)} = E_{0}^{(g)}$ against N. The upper (lower) solid line has S = N = 1 (1). The dashed line is for $E_{N}^{(g)} = E_{0}^{(g)}$, namely the split of the GB.

Let $E_{S}^{(g)}$ denote the energies of the GB ($E_{0}^{(g)}$ is the ground state energy). The upper and lower bounds of the FEB, i.e., $E_{N}^{(e)}_{1}$ and $E_{1}^{(e)}$ relative to $E_{0}^{(g)}$ are plotted in Fig.3. This gure demonstrates how the FEB and GB

split. In particular when N gets larger, the lower bound of FEB would cross the upper of the GB, it im plies an overlap of these two bands.

In sum m ary, we have derived a set of equations to describe the rst excited band, this m ight lead to a deeper understanding of the condensates at very low temperature. Furtherm ore, we have achieved the analytical form of the fractional parentage coe cients. This will greatly facilitate the calculations dealing with the total spin-states, and will thereby promote the applicability of the S-conserved theory for various spinor m any-body system s.
