# Quantum -to-classical crossover for Andreev billiards in a magnetic eld

W e extend the existing quasiclassical theory for the superconducting proximity e ect in a chaotic quantum dot, to include a time-reversal-symmetry breaking magnetic eld. R andom -matrix theory (RMT) breaks down once the Ehrenfest time  $_{\rm E}$  becomes longer than the mean time  $_{\rm D}$  between Andreev rejections. As a consequence, the critical eld at which the excitation gap closes drops below the RMT prediction as  $_{\rm E} = _{\rm D}$  is increased. Our quasiclassical results are supported by comparison with a fully quantum mechanical simulation of a stroboscopic model (the Andreev kicked rotator).

#### I. IN TRODUCTION

W hen a quantum dot is coupled to a superconductor via a point contact, the conversion of electron to hole excitations by Andreev re ection governs the low energy spectrum. The density of states of such an Andreev billiard was calculated using random -m atrix theory (RMT) [1]. If the classical dynam ics in the isolated quantum dot is chaotic, a gap opens up in the spectrum. The excitation gap  $E_{gap}$  is of the order of the Thouless energy  $h=_{D}$ , with  $_{D}$  the average time between Andreev re ections. A lthough chaoticity of the dynam ics is essential for the gap to open, the size of the gap in RMT is independent of the Lyapunov exponent of the chaotic dynam ics.

If the size L of the quantum dot is much larger than the Ferm i wavelength  $_{\rm F}$  , a competing timescale  $_{\rm E}$  '

<sup>1</sup> ln (L=  $_{\rm F}$ ) appears, the Ehrenfest time, which causes the breakdown of RM T [2]. The gap becomes dependent on the Lyapunov exponent and for  $_{\rm E}$   $_{\rm D}$  vanishes as E  $_{\rm gap}$  ' h=  $_{\rm E}$ . The Ehrenfest time dependence of the gap has been investigated in several works [3, 4, 5, 6, 7, 8, 9]. For a recent review, see Ref. [10].

A magnetic eld breaks time-reversal symmetry, thereby reducing  $E_{gap}$ . At a critical eld  $B_c$  the gap closes. This was calculated using RMT in Ref. [11], but the e ect of a nite Ehrenfest time was not studied before. Here we extend the zero-eld theory of Silvestrov et al. [5] to non-zero magnetic eld. It is a quasiclassical theory, which relates the excitation spectrum to the classical dynamics in the billiard. The entire phase space is divided into two parts, depending on the time T between A ndreev re ections. Times T <  $_E$  are quantized by identifying the adiabatic invariant, while times T >  $_E$  are quantized by an elective RMT with  $_E$ -dependent parameters.

There exists an alternative approach to quantization of the Andreev billiard, due to Vavilov and Larkin [6], which might also be extended to non-zero magnetic eld. In zero magnetic eld the two models have been shown to give similar results [10], so we restrict ourselves here to the approach of R ef. [5].




FIG.1: Classical trajectory in an Andreev billiard. Particles are de ected by the potential V =  $(r=L)^2$  1 V<sub>0</sub> for r < L, V =  $4(r=L)^2 + 10(r=L)$  6 V<sub>0</sub> for r > L, with  $r^2 = x^2 + y^2$  (the dotted lines are equipotentials). At the insulating boundaries (solid lines) there is specular re ection, while the particles are Andreev re ected at the superconductor (y = 0, dashed line). Shown is the trajectory of an electron at the Ferm i level (E = 0), for B = 0 and E<sub>F</sub> = 0.84 eV<sub>0</sub>. The Andreev re ected hole will retrace this path.

The outline of the paper is as follows. We start by describing the adiabatic levels in Sec. II, followed by the effective RM T in Sec. III. In Sec. IV we compare our quasiclassical theory with fully quantum mechanical computer simulations. We conclude in Sec. V.

### II. AD IABATIC QUANTIZATION

W e generalize the theory of adiabatic quantization of the Andreev billiard of Ref. [5] to include the e ect of




FIG.2: Andreev re ection at a NS boundary (dashed line) of an electron to a hole. The left panel shows the case of perfect retrore ection (zero excitation energy E and zero magnetic eld B). The middle and right panels show that the hole does not precisely retrace the path of the electron if E or B are non-zero.




FIG.3: (C obr on line) Poincare m ap for the Andreev billiard of Fig.1. Each dot m arks the position x and tangential velocity  $v_x$  of an electron at the NS boundary. Subsequent dots are obtained by following the electron trajectory for E; B ! 0 at xed ratio  $B = E = \frac{1}{3}$  m =V<sub>0</sub>L<sup>2</sup>e<sup>3</sup>. The inset shows the full surface of section of the Andreev billiard, while the m ain plot is an enlargement of the central region. The drift is along closed contours de ned by K = constant [see Eq. (4)]. The value of the adiabatic invariant K (in units of m L<sup>2</sup>=eV<sub>0</sub>) is indicated for several contours. All contours are closed loops, but for some contours the opening of the loop is not visible in the gure.

a magnetic eld. An example of the geometry of such a billiard is sketched in Fig.1. The normal metal lies in the x-y plane and the boundary with the superconductor (NS boundary) is at y = 0. The classical mechanics of electrons and holes in such an Andreev billiard has been analyzed in Refs. [12, 13, 14]. We rst summarize the results we need, then proceed to the identication of the adiabatic invariant, and nally present its quantization.




FIG.4: D irected area for a classical trajectory, consisting of the area enclosed by the trajectory after joining begin and end points along the NS boundary (dashed line). D i erent parts of the enclosed area have di erent signs because the boundary is circulated in a di erent direction.

## A. Classicalmechanics

The classical equation of motion

$$r(t) = \frac{e}{m} \underline{r} \quad B + \frac{e}{m} r V(r)$$

is the same for the electron and the hole because both charge e and m ass m change sign. The vector B is the uniform magnetic eld in the z-direction and V (r) is the electrostatic potential in the plane of the billiard. The dots on r = (x; y) denote time derivatives. We follow the classical trajectory of an electron starting at the NS boundary position (x; 0) with velocity  $(v_x; v_y)$ . The electron is at an excitation energy E counted from the Ferm i level. A fter a time T the electron returns to the superconductor and is retrore ected as a hole. Retrore ection m eans that  $v_x$  ! v. The y-component v, of the velocity also changes sign, but in addition it is slightly reduced in magnitude,  $v_y^2$  !  $v_y^2$ 4E = m, so that an electron at an energy E above the Ferm i level becom es a hole at an energy E below the Fermilevel.

This refraction is one reason why the hole does not precisely retrace the path of the electron. A second reason is that a non-zero B will cause the hole trajectory to bend in the direction opposite to the electron trajectory (because the velocity has changed sign), see Fig. 2. It follows that if either E or B are non-zero, the hole will return to the NS boundary at a slightly di erent position and with a slightly di erent velocity. The resulting drift of the quasi-periodic motion is most easily visualized in a Poincare surface of section, see Fig.3. Each dot marks the position x and tangential velocity  $v_x$  of an electron leaving the NS boundary. At non-zero E or B, subsequent dots are slightly displaced, tracing out a contour in the  $(x;v_x)$  plane. In the lim it E ; B ! 0, the shape of these contours is determ ined by the adiabatic invariant of the classical dynam ics. In Ref. [5] it was shown that the contours in the Poincare surface of section are isochronous for B = 0. This means that they are given by  $T(x;v_x) = const$ , with  $T(x;v_x)$  the time it takes an electron at the Ferm i level to return to the NS boundary, as a function of the starting point  $(x;v_x)$  on the boundary. In other words, for B = 0 the time between Andreev re ections is an adiabatic invariant in the limit E = 0.

### B. A diabatic invariant

W e generalize the construction of the adiabatic invariant of Ref. [5] to B  $\Leftrightarrow$  0. W e start from the Poincare invariant

over a closed contour C (t) in phase space that moves according to the classical equations of motion. The contour extends over two sheets of phase space, joined at the NS interface. In the electron sheet the canonical momentum is  $p_+ = m v_+ eA$ , while in the hole sheet it is p = m v + eA. Both the velocity v, given in absolute value by  $jv j = (2-m)^{1-2} E_F E + eV(r)^{\frac{1}{2}-2}$  and directed along the motion, as well as the vector potential  $A = \frac{1}{2}Bz$  r are functions of the position r on the contour, determ ined, respectively, by the energy E and the magnetic eld B. (Since the contour is closed, the Poincare invariant is properly gauge invariant.)

Q uite generally, dI = dt = 0, meaning that I is a constant of the motion [15]. For E = B = 0 we take C (0) to be the self-retracing orbit from electron to hole and back to electron. It is obviously tim e-independent, with I = 0 (because the contributions from electron and hole sheet cancel). For E or B non-zero, we construct C (0) from the same closed trajectory in real space, but now with p (r) and A (r) calculated at the given values of E and B. Consequently, this contour C (t) will drift in phase space, preserving I (t) = I (0). The Poincare invariant is of interest because it is closely related to the action integral

The action integral is de ned as an integral along the periodic electron-hole orbit O<sub>eh</sub> followed by electrons and holes at E; B = 0. To every point (x; v<sub>x</sub>) in the Poincare surface of section corresponds an orbit O<sub>eh</sub> and hence an action integral I(x; v<sub>x</sub>). We compare the contour C (t) and the trajectory O<sub>eh</sub> intersecting the Poincare surface of section at the same point (x; v<sub>x</sub>). At t = 0 they co-incide and for su ciently slow drifts they stay close and therefore the action integral I = I (0) + 0 (t<sup>2</sup>) is an adiabatic invariant of the motion in the Poincare surface of section [15].

It remains to determ ine the adiabatic invariant I in terms of E and B and the chosen trajectory C (0). To linear order in E; B we nd

with  $A = \frac{1}{2}^{n}$  (r dr) 2 the directed area (see Fig. 4) enclosed by the electron trajectory and the NS boundary. Both the time T and the area A are to be evaluated at E = B = 0. Because E is a constant of the motion, adiabatic invariance of I in plies that K I=2E is an adiabatic invariant. At zero eld this adiabatic invariant is simply the time T between Andreev re ections. At non-zero eld the invariant time contains also an electrom agnetic contribution eAB=E, proportional to the enclosed ux.

Fig. 3 shows that, indeed, the drift in the Poincare surface of section is along contours  $C_K$  of constant K. In contrast to the zero-eld case, the invariant contours in the surface of section are now no longer energy independent. This will have consequences for the quantization, as we describe next.

### C. Quantization

The two invariants E and K de ne a two-dimensional torus in four-dimensional phase space. The two topologically independent closed contours on this torus are formed by the periodic electron-hole orbit  $O_{eh}$  and the contour  $C_K$  in the Poincare surface of section. The area they enclose is quantized following the prescription of E instein-B rillouin-K eller [16, 17],

The action integral (5a) can be evaluated explicitly, leading to

The second quantization condition (5b) gives a second relation between E and K, so that one can eliminate K and obtain a ladder of levels  $E_{mn}$ . For B = 0 the quantization condition (5b) is independent of E, so one obtains separately a quantized time  $T_n$  and quantized energy  $E_{mn} = (m + 1=2) h=T_n$ . For  $B \notin 0$  both  $K_{mn}$  and  $E_{mn}$  depend on the sets of integers m;n.

### D. Lowest adiabatic level

The value  $E_{00}$  of the low est adiabatic level follows from the pair of quantization conditions (5) with m = n = 0. To determ ine this value we need to determ ine the area




FIG. 5: Illustration of a bunch of trajectories within a single scattering band in the billiard de ned in Fig. 1. All trajectories in this gure have starting conditions in the band containing the contour with K = 11 of Fig. 3. Both T and A vary only slightly from one trajectory to the other, so that the whole band can be characterized by a single T and A, being the average of T and A over the scattering band.

0 (K) =  $\int_{C_K}^{H} p_x dx$  enclosed by contours of constant K, in the lim it of large K.

In Ref. [5] the area O (K) was determined in the case B = 0, when K = T and the contours are isochronous. It was found that

with the Lyapunov exponent of the norm al billiard without superconductor and O<sub>0</sub> a characteristic area that depends on the angular distribution of the beam of electrons entering the billiard (width L) from the narrow contact to the superconductor (width W). For a collim ated beam having a spread of velocities  $jv_x = v_F j \leq W = L$  one has O<sub>0</sub> = N h. For a non-collim ated beam O<sub>0</sub> = N h.W = L. The integer N is the num ber of scattering channels connecting the billiard to the superconductor. The quantization requirem ent O (T) h gives the low est adiabatic level in zero magnetic edd [5],

The Ehrenfest time  $_{\rm E}$  corresponds to a contour that encloses an area  $\,$  h.

In order to generalize Eq. (7) to B  $\notin$  0, we discuss the concept of scattering bands, introduced in Ref. [18] for a norm al billiard (where they were called transm ission and re ection bands). Scattering bands are ordered phase space structures that appear in open system s, even if their closed counterparts are fully chaotic. These structures are characterized by regions in which the functions T (x;v<sub>x</sub>) and A (x;v<sub>x</sub>) vary slow ly almost everywhere. Hence, they contain orbits of almost constant return time and directed area, that is, orbits returning by bunches. One such bunch is depicted in Fig. 5. The scattering bands are bounded by contours of diverging T (x;v<sub>x</sub>) and A (x;v<sub>x</sub>). The divergence is very slow (/ 1=h, with the distance from the contour [4]), so the mean return time T and mean directed area A in a scattering band remain nite and well de ned [19].

The area O<sub>band</sub> of a band depends on T as [18]

Since an isochronous contour must lie within a single scattering band, Eq. (7) follows from Eq. (9) and from the fact that the distribution of return times is sharply peaked around them ean T. Because contours of constant K = T eAB = E must also lie within a single scattering band, the area O (K) is bounded by the same function O<sub>band</sub> (T). We conclude that within a given scattering band the largest contour of constant T and the largest contour of constant K each have approximately the same e area as the band itself,

We are now ready to determ ine the magnetic eld dependence of the lowest adiabatic level E  $_{00}$  (B). The corresponding contour C  $_{\rm K}$  lies in a band characterized by a mean return time T =  $^{-1}$  ln (O  $_0$  = h), according to Eqs. (5b) and (10). This is the same E hrenfest time as Eq. (8) for B = 0 (assuming that the orbital e ect of the magnetic eld does not modify ). The energy of the lowest adiabatic level E  $_{00}$  is determined by the quantization condition (6),

The range of directed areas  $A_{m ax} < A < A_{m ax}$  is the product of the area L<sup>2</sup> of the billiard and the maximum number of times  $n_{m ax} \quad \text{W} T = L$  that a trajectory can encircle that area (clockwise or counterclockwise) in a time T. Hence  $A_{m ax} = v_F T L < v_F E L$  and we nd

We conclude that a magnetic eld shifts the lowest adiabatic level downward by an amount  $ev_F LB$  which is independent of  $_E$ . Eq. (12) holds up to a eld  $B_c^{ad}$  at which the lowest adiabatic level reaches the Fermi level,

W e have added the label \ad", because the true critical eld at which the gap closes m ay be smaller due to non-adiabatic levels below  $E_{00}$ . For B = 0, the ground state is never an adiabatic state [10]. In the next section we study the e ective RM T, in order to determ ine the contribution from non-adiabatic levels (return times T >  $_E$ ).

## E. Density of states

The pair of quantization conditions (5) determ ines the individual energy levels with T <  $_{\rm E}$  and Å j < A<sub>m ax</sub> =  $v_{\rm F}$   $_{\rm E}$  L. For sem iclassical system s with L=  $_{\rm F}$  1 the level spacing of the isolated billiard is so small that individual levels are not resolved and it su ces to know the sm oothed (or ensemble averaged) density of states  $_{\rm ad}$  (E). In view of Eq. (6) it is given by

in term s of the joint distribution function P (T;A) of return time T and directed area A. In the limit  $_{\rm E}$  ! 1 this form ula reduces to the Bohr-Som m erfeld quantization rule of Ref. [1] for B = 0 and to the generalization of Ref. [20] for B  $\stackrel{\bullet}{\bullet}$  0. The adiabatic density of states (14) vanishes for E <  ${\rm E}_{\rm gap}^{\rm ad}$ . Its high energy asymptotics (m eaning E  ${\rm E}_{\rm gap}^{\rm ad}$ , but still E ) can be estimated using P (T;A) = P (A jr)P (T) with the conditional distribution P (A jr) (which will be discussed in the next section) and the return time distribution P (T) = exp ( ${\rm T}=_{\rm D}$ ) =  $_{\rm D}$ . One gets

The lim it (15) is less than the value 2= , which also contains the contribution from the non-adiabatic levels with T >  $_{\rm E}$  .

#### III. EFFECTIVE RANDOM -MATRIX THEORY


The adiabatic quantization applies only to the part of phase space in which the return time T is less than the Ehrenfest time  $_E$ . To quantize the remainder, with T >  $_E$ , we apply the elective random -m atrix theory (RMT) of Ref. [5]. The existing formulation [5, 10] does not yet include a magnetic eld, so we begin by extending it to non-zero B.

### A. E ective cavity

The e ective RMT is based on the decomposition of the scattering matrix in the time domain into two parts,

The classical, short-time part  $S_{cl}$  (t) couples to N<sub>cl</sub> scattering channels of return time <  $_E$ , which can be quantized adiabatically as explained in the previous section.



The remaining

quantum channels, with return time >  $_{\rm E}$ , are quantized by RM T with e ective  $_{\rm E}$ -dependent parameters.

To describe the e ective RM T ensemble from which S<sub>a</sub> is drawn, we refer to the diagram of Fig. 6, following Ref. [10]. A wave packet of return time t >  $_{\rm E}$  evolves along a classical trajectory for the initial  $_{\rm E}$  =2 and the nal  $_{\rm E}$  =2 duration of its motion. This classical evolution is represented by a ctitious ballistic lead with delay time  $_{\rm E}$  =2, attached at one end to the superconductor. The transm ission m atrix of this lead is an N e N<sub>e</sub> diagonal matrix of phase shifts exp [i (B)] (for transmission from left to right) and exp [i ( B)] (for transmission from right to left). The ballistic lead is attached at the other end to a chaotic cavity having an N  $_{\rm e}$ N<sub>e</sub> scattering matrix S<sub>0</sub> with RMT distribution. The entire scattering matrix  $S_{\alpha}$  (t) of the elective cavity plus ballistic lead is, in the time domain,



The level spacing  $_{\rm e}$  of the electric cavity is increased according to

to ensure that the mean dwelltime 2 h=N  $_{\rm e}~_{\rm e}$  remains equal to  $_{\rm D}$  , independent of the Ehrenfest time.



For weak magnetic elds (such that the cyclotron radius m  $v_F$  =eB  $\,$  L), the phase shifts (B) are linear in B :

The phases  $_n$  are the channel dependent, m agnetic eld induced phase shifts of classical trajectories spending a time  $_E = 2$  in a chaotic cavity.

The conditional distribution of directed areas A for a given return time T is a truncated Gaussian [20, 21],

with (x) the unit step function. This implies that the distribution P ( ) of phase shifts = eAB = h for T = E = 2 is given by

The constant coforder unity is determ ined by the billiard geometry and B<sub>0</sub> denotes the critical magnetic eld of the Andreev billiard when  $_{\rm E}$  ! 0. Up to numerical coe cients of order unity, one has [11]

### B. Density of states

The energy spectrum of an Andreev billiard, for energies well below the gap of the bulk superconductor, is related to the scattering matrix by the determ inantal equation [22]

Since  $S_{cl}$  and  $S_q$  couple to di erent channels, we may calculate separately the contribution to the spectrum from the elective cavity, governed by  $S_q$ . We substitute the expression (19) for  $S_q$ , to obtain

In R ef. [10] the density of states was calculated from this equation for the case B = 0, when = 1.W e generalize

the calculation to B  $\notin$  0. The technicalities are very sim ilar to those of R ef. [23].

The scattering matrix  $S_0 \times B$  of the open e ective cavity can be represented by [24, 25]

in term s of the H am iltonian H<sub>0</sub>(B) of the closed e ective cavity and a coupling matrix W. The dimension of H<sub>0</sub> is M M and the dimension of W is M N<sub>e</sub>. The matrix W<sup>T</sup>W has eigenvalues M<sub>e</sub> = <sup>2</sup>. The lim it M ! 1 at xed level spacing <sub>e</sub> is taken at the end of the calculation. Substitution of Eq. (29) into the determ inantal equation (27) gives a conventional eigenvalue equation [23],

The H am iltonian H  $_0$  (B) of the ctitious cavity has the P andey-M ehta distribution [26],

Because  $N_e$  is we may replace in Eqs. (38(41) the sum  $_j f(j)$  by d P(), with P() given by Eq. (23). In the next section we will compare the density of states obtained from (38(41) with a fully quantum mechanical calculation. In this section we discuss the low and high energy asymptotics of the density of states.

In the lim it E ! 1, E we not from Eqs. (38{40) that  $G_{12} = G_{21} / 1 = E ! 0$  while  $G_{11} !$  i. Substituting this into Eq. (41) we obtain the high energy lim it,

This limit is larger than 2 = e because of the contribution from states in the lead, cf. Fig. 6. Together with Eq. (15) we nd that the total density of states,

tends to 2= for high energies, as it should be.

At low energies the density of states  $_{e}$  (E) obtained from the elective RMT vanishes for E < E  $_{gap}^{e}$ . In the lim it  $_{E}$   $_{D}$  the lowest level in the elective cavity is determined by the ctitious lead with return time  $_{E}$ . This gives the same gap as for adiabatic quantization,

which is smaller than  $B_c^{ad} \approx B_c = B_c^e$ . In the intermediate regime  $\frac{P}{L_D = v_F} < E_E < D$ , the critical eld  $B_c$  is given by

We do not have an analytical formula for  $B_c^e$  in this intermediate regime, but we will show in the next section that  $B_c^{ad}$  drops below  $B_c^e$  so that  $B_c = B_c^{ad}$ .

## IV. COM PAR ISON W ITH QUANTUM MECHANICAL MODEL

In this section we compare our quasiclassical theory with a quantum mechanical model of the Andreev billiard. The model we use is the Andreev kicked rotator introduced in Ref. [7]. We include the magnetic eld into the model using the three-kick representation of Ref. [27], to break time-reversal-symmetry at both the quantum mechanical and the classical level. The basic equations of the model are summarized in Appendix A.




FIG. 7: (Color online) Ensemble averaged density of states (E) of the Andreev kicked rotator. The dark (red) curves show the numerical results from the fully quantum mechanical model, while the light (green) curves are obtained from Eq. (43) with input from the classical limit of the model. The energy is scaled by the Thouless energy  $E_T = h=2_D$  and the density is scaled by the level spacing of the isolated billiard. The parameters of the kicked rotator are M = 2048, N = 204, q = 0.2, K = 200 in panela and M = 16384, N = 3246, q = 0.2, K = 14 in panels b, c, d. The three-peak structure indicated by the arrow in panels b, c, d is explained in Fig. 8.

In Fig. 7 we show the ensemble averaged density of states of the Andreev kicked rotator and we compare it with the theoretical result (43). The Ehrenfest time is given by [6, 7]

with M the dimensionality of the F loquet matrix. We neglect the correction term of order unity. The mean dwell time is  $_{\rm D}$  = (M =N)  $_{\rm 0}$  and the level spacing is = (2 =M)h= $_{\rm 0}$ , with  $_{\rm 0}$  the stroboscopic time. The

relation between  $B = B_0$  and the parameters of the kicked rotator is given by Eq. (A 10).

In Fig. 7a  $_{\rm E}$   $_{\rm D}$  and we recover the RMT result of Ref. [11]. The density of states is featureless with a shallow maximum just above the gap. In Figs. 7b, c, d  $_{\rm E}$  and  $_{\rm D}$  are comparable. Now the spectrum consists of both adiabatic levels (return time T <  $_{\rm E}$ ) as well as effective RMT levels (return time T >  $_{\rm E}$ ). The adiabatic levels cluster in peaks, while the elective RMT from sthe sm ooth background, with a pronounced bum p above the gap.




FIG.8: Conditional distribution P (A jr) of directed areas A enclosed by classical trajectories with T = 2<sub>0</sub>, for K = 14, q = 0.2 and <sub>D</sub> = 5<sub>0</sub>. The distribution was obtained from the classical map (A 11) at = 0. Trajectories with T = 2<sub>0</sub> give rise to a peak in the density of states centered around  $E = E_T = (m + 1=2) h=2_0$ , cf. Eq. (14). On the energy scale of Fig. 7 only the peak with m = 0 can be seen, at  $E = E_T = 2.5$  7.9. In a magnetic eld this peak broadens and it obtains the side peaks of P (A j2<sub>0</sub>).

The peaks in the excitation spectrum of the Andreev kicked rotator appear because the return time T in Eq. (14) is a multiple of the stroboscopic time  $_0$  [7]. The peaks are broadened by the magnetic eld and they acquire side peaks, due to the structure of the area distribution P (A fT) for T a small multiple of  $_0$ . This is illustrated in Fig. 8 for the central peak of Fig. 7. The distribution was calculated from the classical map (A11) associated with the quantum kicked rotator. The sam e map gave the coe cient c = 0.55 appearing in Eq. (23).




FIG.9: Critical magnetic eld B<sub>c</sub> of the Andreev kicked rotator as a function of the Ehrenfest time. The Ehrenfest time  $_{\rm E}$  =  $^{-1}$  ln (N<sup>2</sup>=M) is changed by varying M and N while keeping q = 0.2 and  $_{\rm D}$  =  $_{\rm O}$  = M =N = 5 constant. For the closed circles the kicking strength K = 14, while for the squares from left to right K = 4000, 1000, 400, 200, 100, 50. The solid curve is the quasiclassical prediction (47). The open circles are obtained from the closed circles by the transform ation  $_{\rm E}$  !  $_{\rm E}$  + 1:75, allowed by the term s of order unity in Eq. (48).

In Fig. 9 we have plotted the criticalm agnetic eld B<sub>c</sub> at which the gap closes, as a function of the Ehrenfest time. For  $_{\rm E}$   $_{\rm D}$  the Andreev kicked rotator gives a value for B<sub>c</sub> close to the prediction B<sub>0</sub> of RM T, cf. Eq. (A10). W ith increasing  $_{\rm E}$  we nd that B<sub>c</sub> decreases quite strongly. In the gure we also show the criticalm agnetic elds B<sub>c</sub><sup>d</sup> for adiabatic levels and B<sub>c</sub><sup>e</sup> for ective RM T. The form er follows from Eqs. (13) and (A14),

already announced in the previous section,  $B_c^{ad}$  drops below  $B_c^e$  with increasing E, which means that the lowest level  $E_{gap}$  is an adiabatic level corresponding to a return time T < E. The critical magnetic eld is the smallest value of  $B_c^e$  and  $B_c^{ad}$ , as indicated by the solid curve. The data of the Andreev kicked rotator follows the trend of the quasiclassical theory, although quite substantial discrepancies remain. Our quasiclassical theory seem s to overestim ate the low est adiabatic level, which also causes deviations between theory and num erical data in the low energy behaviour of the density of states (cf. Fig. 7, panels c, d). Part of these discrepancies can be attributed to the correction term of order unity in Eq. (48), as shown by the open circles in Fig. 9.

In the regime of fully broken time-reversal-symmetry the distribution of eigenvalues is determined by the Laguerre unitary ensemble of RMT [28, 29]. The ensem – ble averaged density of states vanishes quadratically near zero energy, according to




FIG.10: (Color online) Ensemble averaged density of states of the Andreev kicked rotator for fully broken TRS.The histogram shows the numerical results, while the curve is the theoretical prediction (50) of the Laguerre unitary ensemble. Both the energy and the density of states are scaled by the level spacing of the isolated billiard. The parameters of the kicked rotator are M = 2048, N = 204, q = 0.2, while K was varied between 200 and 250 to obtain an ensemble average.

In Fig. 10 we show the results for the Andreev kicked rotator in this regime and we nd a good agreement with Eq. (50) for  $_{\rm E}$   $_{\rm D}$ . We did not investigate the  $_{\rm E}$  dependence in this regime.

## V. CONCLUSION

W e have calculated the excitation spectrum of an Andreev billiard in a magnetic eld, both using a quasiclassical and a fully quantum mechanical approach. The quasiclassical theory needs as input the classical distribution of times T between Andreev re ections and directed areas A enclosed in that time T. Times T smaller than the Ehrenfest time  $_{\rm E}\,$  are quantized via the adiabatic invariant and times T >  $_{\rm E}$  are quantized by an e ective random -m atrix theory with E-dependent param eters. This separation of phase space into two parts, introduced in R ef. [5], has received m uch theoretical support in the context of transport [18, 27, 30, 31, 32, 33, 34]. The present work shows that it can be successfully used to describe the consequences of time-reversal symmetry breaking on the superconducting proxim ity e ect.

The adiabatically quantized and e ective RMT spectra each have an excitation gap which closes at di erent magnetic elds. The critical magnetic eld B<sub>c</sub> of the Andreev billiard is the sm allest of the two values  $B_c^{ad}$  and  $B_c^e$ . For relatively small Ehrenfest time E  $_{\rm D}$  the critical eld B<sup>e</sup><sub>c</sub> from e ective RMT is smaller than the critical eld  $B_c^{ad}$  of the adiabatic levels, so  $B_c = B_c^e$ . This value  $B_c^e$  is smaller than the value  $B_0$  of conventional RM T [11], because of the  $_{\rm E}$  -dependence of the parameters in e ective RMT.For E D the two elds B<sup>ad</sup> and B<sup>e</sup><sub>c</sub> coincide, but in an intermediate regime of comparable  $_{\rm E}$  and  $_{\rm D}$  the adiabatic value  $B_{\rm c}^{\rm ad}$  drops below the elective RMT value B  $_{\rm c}^{\rm e}$  . This is indeed what we have found in the speci c m odel that we have investigated, the Andreev kicked rotator [7]. The lowest level has T <  $_{\rm E}$  for su ciently large  $_{\rm E}$  and B . This is a novel feature of the Andreev billiard in a magnetic eld: For unbroken tim e-reversal sym m etry the low est level alw ays corresponds to longer trajectories T > E [8], and thus cannot be obtained by adiabatic quantization [5, 10].

## APPENDIX A: ANDREEV KICKED ROTATOR IN A MAGNETIC FIELD

The Andreev kicked rotator in zero magnetic eld was introduced in R ef. [7]. Here we give the extension to nonzero magnetic eld used in Sec. IV. W e start from the kicked rotator with broken tim e-reversal symmetry but without the superconductor. The kicked rotator provides a stroboscopic description of scattering inside a quantum

dot. The propagation of a state from time to time t+  $_0$ is given by the M M unitary Floquet operator F with m atrix elements [27]

breaks the parity symmetry for  $q \in 0$ . Time-reversal symmetry is broken by the parameter . For kicking strengths K > 7 the classical dynam ics of the kicked rotator is chaotic.

The Floquet operator (A1) describes electron excitations above the Ferm i level. The hole excitations below the Ferm ilevel are described by the F loquet operator F . E lectrons and holes are coupled by Andreev re ection at the superconductor. The N M matrix P, with elements
