A general transport equation for the center ofm ass $m$ otion is constructed to study transports of electronic system under uniform $m$ agnetic eld and $m$ icrow ave radiation. The equation is applied to study 2 D electron system in the lim it of weak disorder where negative resistance instability is observed when the radiation eld is strong enough. A solution of the transport equation $w$ th spontaneous AC current is proposed to explain the experim entally observed Radiation-Induced Zero Resistance State.

The discovery of the zero-resistance states (ZRS) in two dim ensional electron gas under uniform $m$ agnetic eldind and $m$ icrow ave radiation has triggered a lots of theoretical and experim ental activitiesin to understand the origin of this nontrivial state. M ost of the theoretical work suggested that the origin of the ZRS is closely related to a negativeresistance instability that occurs in the system due to the combined e ect of quantized Landau levels and photon-assisted scattering explained if the current-dependent resistance of the system which becom es negative at sm all current (for strong enough $m$ icrow ave radiation) becom es positive again when the current ~J becom es large enougher an equation
where $R$ [ $j$ ] is a phenom enological current-dependent resistance which is negative at $j=0$, increases as a function of $j$ and passes through zero at $\tilde{J} j=j{ }_{j}{ }^{\circ} \bar{L}^{2}, \mathrm{E}_{d}$ is the applied D C electric eld and $H$ is the ordinary $H$ all resistivity. It was shown that equation (ī) adm its tim eindependent, stripe-like spatially inhom ogeneous solution which leads to zero di erential resistance for net D C current less than a threshold value ${ }^{\sigma_{1}}$. A n obvious theoretical question is whether Eq. (1기) w ith the required property of $R$ [j] can be derived $m$ icroscopically. This is the sub ject of this paper.

Starting from rst principle we shall derive in the follow ing a transport equation for the center of $m$ ass velocity $v=\tilde{J}=n e$ that treats the e ect of radiation to all order $w$ ith the only expansion param eter in the problem being the strength of disorder. W e note that a transport equation can also be derived from a $Q$ uantum Boltzm ann Equation approadn-11. H ow ever it is di cult to obtain clear, analytical result in this approach because of the intrinsic com plexity of the Boltzm ann equation form ulation itself. W e shall see that the equation ofm otion for the center ofm ass o ers a m uch sim pler altemative.

O ur approach to the transport equation begins from the known observation that there exists an exact, one-to-one mapping between the solution of the Schrodinger equation of a (charged) $m$ any-particle system in the absence of the $m$ icrow ave radiation and in the presence of the radiation for a class of $H$ am iltonian

where $p_{i}=$ ihr $r_{i}$ is the canonical $m$ om entum for the $i^{\text {th }}$ particle in the system. $\mathbb{A}\left(x^{x}\right)=$ $\frac{1}{2}(x \quad \mathrm{~B})$ is the vector potential corresponding to a uniform, tim e-dependent m agnetic eld, $E^{2}(t)$ is a tim e-dependent uniform electric eld and $V(x)$ is the interaction potentialbetween particles. The last term represents an extemal harm onic potential acting on the particles.

The physics of the exact $m$ apping can be seen by perform ing a coordinate transform ation to the center of $m$ ass fram e of the $m$ any-particle system. In the non-relativistic lim it, the w avefunctions in the laboratory and CM fram es are related by

W e thus arrive at the conclusion that for the class of $H$ am iltonian (2), there exist a one-to-onem apping betw een the solution of the Schrodinger equation in the presence of the $m$ icrow ave radiation $\left(x_{i} ; t\right)$, and in the absence of the radiation $C M\left(x_{i}^{0} ; t\right)$, where $\left(x_{i} ; t\right)=c м\left(x_{i} \quad R(t) ; t\right) e^{i}{ }^{(t)}$. Physically, for the particular form of $H$ am iltonian we
considered, the wavefunction of the system follow s the center ofm ass m otion rigidity in the presence of the radiation eld.

The above result suggests that form ore general $H$ am iltonians of form $H_{G}(t)=H(t)+U$, a new perturbation schem ewhere the $m$ icrow ave radiation is treated exactly to allorder can be set up by treating $U$ as perturbation. The perturbation schem e can be set up $m$ ost easily in the center of $m$ ass fram $e$. $W$ e shall consider static im purity potential $U={ }^{P}{ }_{i} u\left(x_{i}\right)$ in the follow ing. N otice that a static potential becom e tim e-dependent in the CM fram e and should be treated by tim e-dependent perturbation theory.

To derive the transport equation we start from the exact $H$ eisenberg equation ofm otion

The equation is m anifestly gauge invariant and suggests that to second order in the im purity potential, the e ects ofparticle statistics and interaction are re ected only in the density-density response function. In the follow ing we shall apply this equation to study the $Z R S$ in 2 D electron system s .

In this case we consider $E^{(t)}=E_{0} \sin (!t)+E_{d}$, where $E_{d}$ is a sm all $D C$ electric eld. To sim plify the equation we divide the center ofm ass m otion into "fast" and "slow " parts,

$\mathrm{R}_{\mathrm{f}}(\mathrm{t})$ describes the center of m ass m otion induced by the radiation eld whereas $\mathrm{R}_{\mathrm{s}}(\mathrm{T})$ describes induced m otion under the DC eld $E_{d}$. The two kinds of m otions are coupled by
the im purity scattering term which is a non-linear function ofR ( $t$ ). W e shallassum $e$ that the coupling between $R_{s}(t)$ and $R_{f}(t)$ does not $m$ odify qualitatively the behavior of $R_{f}(t)$ and the $m$ ain e ect of coupling is to produce an e ective equation of $m$ otion for $R_{s}(t)$. N otioe
 $\mathrm{E}_{\circ}$ lim it when the size of the orbit $\mathrm{R}_{\mathrm{c}} \quad{ }^{\mathrm{q}} \overline{\mathbb{A}_{\circ}^{2}+\mathrm{B}_{\circ}^{2}}$ is $m$ uch less than the $m$ agnetic length $l=(h c=e B)^{1=2}$ and is justi able under the experim ental condition $n^{n+2 l i n i l}$ where the $m$ agnetic eld is weak and the $m$ agnetic length is very long.

The e ective foroe on $R_{s}(t)$ is derived from the $m=m^{0}$ term s in $(\underset{-1}{9})$. To order $\left(R_{c}=1\right)^{2}$ we keep only $m\left(m^{0}\right)=0 ; 1$ term s . Putting it back into the equation ofm otion $\left(\frac{\bar{T}}{1}\right.$, , we obtain

It is obvious that $\mathrm{R}[!; \mathbb{*}]$ represents dissipative response of the electron gas to extemal pertunbations whereas $[!; *]$ is an e ective $m$ ass correction on the center of $m$ ass $m$ otion com ing from the corresponding reactive response. $N$ egative contributions to the resistance shows up in the second term of $R$ for density-density response functions with resonant structure, ( $q ;!)_{n}{ }_{n} \frac{g_{n}(q)}{!} \frac{2!_{n}}{!2}!_{n}^{2}$, where $!_{n}>0$ are resonant energy levels and $g_{n}(q)$ is a positive de nite function. In this case, $R \quad{ }^{P}{ }_{n}\left(R_{1 n}!_{n}+R_{2 n}\left(!_{n} \quad!\right)\right)$, where $R_{1 n}$ and $R_{2 n}$ are positive de nite num bers. $W$ e see that negative contributions to $R_{2}$ exist for $!_{n}<!$. The physical origin of the negative resistance has been discussed in several earlier worksind and we shall not repeat them here. C orrespondingly, the e ective $m$ ass contribution from level $n$ is positive (negative) when $!>(<)!_{n}$. W e note that the e ective $m$ ass correction originates from the im purity scattering term is oforder [! ; v] m (1=! $\quad \mathrm{m}) \ll \mathrm{m}$ in the weak-disorder lim it, where $!_{B}=\Theta M=m C$ is the cyclotron frequency and $\quad\left(\Phi_{d}{ }^{2} j_{j} \mathcal{J}\right)^{1}$ is
 presence of the inertial term $m$ which allow s the system to adm it tim e-dependent solutions in the present case.

To whether $R[!; v]$ has the expected behavior we consider density response function of non-interacting gases where ${ }^{\text {in }}$ (q; ! ) =

R[!; \mathbb{*}]$ is evaluated num erically $w$ th these approxim ations. In gure one we present num erical results for the nom alized resistance $R(!; v)=R(0 ; 0)$, as a function of norm alized velocity $V_{N}=v=\left(1!_{B}\right)$ for $!=!_{\mathrm{B}}=0 ; 0: 85 ; 1: 0 ; 1: 1 ; 12$, taking $\left(\mathbb{R}_{\mathrm{C}}=1\right)^{2}=0: 1, \mathrm{E}_{\mathrm{F}} \quad 10!_{\mathrm{B}}, \mathrm{T}=2!_{\mathrm{B}}, \quad=0: 5$ and keeping 20 levels in the sum . W e observe that $R(!; v!0)$ becom es negative when! $>!_{B}$, in agreem ent with previous resultas ${ }^{\text {² }} 1$. For $!>!_{B} R(!; v)$ 's increases and cross zero at around $v_{\text {on }} \quad 0: 05$. The e ect ofm icrow ave radiation decreases rapidly for $v_{N}>0: 2$. These qualitative behaviors of $R(!; v)$ are in agreem ent with expectation and are not $m$ odi ed by changing $T$ or .

Eq. (İOַ) allow s tim e-dependent solutions. In the absence of the DC eld, a sim ple, spatially hom ogeneous solution which allow s the system to stabilize itself around the point

The solution represents a collective circular $m$ otion of the whole uid $m$ oving $w$ ith speed $v_{0}$. $N$ otige that a tim e-independent, spatially inhom ogeneous solution corresponding to a pattem of altemating current stripes $\overline{q^{8 \prime \prime}}$ still exist. H ow ever this solution is energetically less favorable because it requires a higher energy to create the charge inhom ogeneity needed to $m$ aintain the stripes of currents.

To understand the ZRS we have to consider the boundaries of the droplet of electron uid. For sharp boundaries the boundary condition $j_{?}=0$ has to be imposed where $j_{\text {? }}$ is the com ponent of current perpendicular to the boundary. A s a result an edge region with a tim e-independent current $j=\quad j_{0} \mathrm{~m}$ ust form. The size of this region is determ ined by the $m$ icroscopic charge dynam icsion which is still undeterm ined. N evertheless according to Eq. (1101) an electric eld perpendicular to the boundary w ith magnitude $E_{d}=B v_{0}=c$ has to be present in this region to $m$ aintain the steady current ow. A sim ilar edge region also exists at the opposite edge w ith a current running in the opposite direction, rather sim ilar to edge states in Q uantum H all E ect.

A state with a small net current ow can be created $w$ ith $m$ inim al disturbance to the system by shrinking the size of one edge region and enlarging the other. In this case, the net voltage drop across the sam ple is given by

corresponding to a resistance $m$ atrix $w$ ith $x x=0$ and $x y=y_{r}$, i.e. the ZRS.
Som e com $m$ ents about the validity of our theory is in order. W e note that in deriving Eq. ( $(\underline{1}-10)$ ) we $m$ ade the local approxim ation which assum es slow ly varying $v(t)$ whereas the spontaneous current state we propose oscillate with a frequency $!_{\mathrm{B}}$. The oscillatory solution is allowed because of the presence of the inertia term $m$ ( $t$ ). O ur analysis show s that the correction to the inertia term is $s m$ all $\left(m=\left(!_{B}\right)\right)$ in the lim it of weak disorder and the local approxim ation $m$ ainly a ects R [! ;v]. Therefore our general description of the ZRS should rem ain valid as long as the qualitative property of $R$ [! ;v] is correct. A nother sim pli cation weem ployed in our analysis is the assum ption ofcircularly polarized light. T he response of the system which is isotropic in this approxim ation would becom e anisotropic


Lastly we $m$ ade a com $m$ ent on the $m$ acroscopic nature of the spontaneous current state
 characterized by a position and tim e dependent (2D) unit vector eld $\hat{n}(x ; t)$ representing the direction of the current. The order param eter eld $\hat{n}(x ; t)$ has the sam e sym $m$ etry as the ordinary 2D x y model, or super uids. The main di erence between the ZRS state and super uids is that the rigidity of the order param eter is protected by repulsive interaction in the case of super uids, whereas it is protected by the principle of least dissipation in the ZRS.T he sim ilarity betw een the two system s suggests that the two system sm ay share som e com $m$ on $m$ acroscopic features. For exam ple, vortex-like solitonic excitations $m$ ay exist in the ZRS and $m$ ay lead to the residue resistance $R_{\circ} \exp \left(\quad\left(T_{0}=T\right)\right)$ observed in the ZRS stater ${ }^{-1 / 2]_{1}^{2}}$. The existence and nature of solitonic excitations depends on the detailed current dynam ics of the ZRS state and will be investigated in a com ing paper.
