Transport equation for 2D electron liquid under m icrow ave radiation plus magnetic eld and the Zero Resistance State

Abstract

A general transport equation for the center of mass motion is constructed to study transports of electronic system under uniform magnetic eld and microwave radiation. The equation is applied to study 2D electron system in the limit of weak disorder where negative resistance instability is observed when the radiation eld is strong enough. A solution of the transport equation with spontaneous AC current is proposed to explain the experimentally observed Radiation-Induced Zero Resistance State. The discovery of the zero-resistance states (ZRS) in two dimensional electron gas under uniform magnetic $eld^{1,2}$ and microwave radiation has triggered a lots of theoretical^{3,4,5,6,7,8,11} and experimental activities^{9,10} to understand the origin of this nontrivial state. Most of the theoretical work suggested that the origin of the ZRS is closely related to a negativeresistance instability that occurs in the system due to the combined e ect of quantized Landau levels and photon-assisted scattering^{3,4,5,6,11}. It was proposed that the ZRS can be explained if the current-dependent resistance of the system which becomes negative at small current (for strong enough microwave radiation) becomes positive again when the current j becomes large enough^{3,4,5,6}. The above physics was put together phenomenologically into an equation

where R [j] is a phenom enological current-dependent resistance which is negative at j = 0, increases as a function of j and passes through zero at $jjj = j_0^6$, E_d is the applied D C electric eld and _H is the ordinary H all resistivity. It was shown that equation (1) adm its tim eindependent, stripe-like spatially inhom ogeneous solution which leads to zero di erential resistance for net D C current less than a threshold value⁶. An obvious theoretical question is whether Eq. (1) with the required property of R [j] can be derived m icroscopically. This is the subject of this paper.

Starting from rst principle we shall derive in the following a transport equation for the center of mass velocity v = j=ne that treats the e ect of radiation to all order with the only expansion parameter in the problem being the strength of disorder. We note that a transport equation can also be derived from a Quantum Boltzmann Equation approach¹¹. However it is di cult to obtain clear, analytical result in this approach because of the intrinsic complexity of the Boltzmann equation formulation itself. We shall see that the equation of motion for the center of mass o ers a much simpler alternative.

Our approach to the transport equation begins from the known observation that there exists an exact, one-to-one mapping between the solution of the Schrodinger equation of a (charged) many-particle system in the absence of the microwave radiation and in the presence of the radiation for a class of H am iltonian^{4,7,8,11,12},

where $p_i = ihr_i$ is the canonical m on entum for the ith particle in the system. A (r) = $\frac{1}{2}$ (r B) is the vector potential corresponding to a uniform, time-dependent m agnetic eld, E (t) is a time-dependent uniform electric eld and V (r) is the interaction potential between particles. The last term represents an external harm onic potential acting on the particles.

The physics of the exact m apping can be seen by performing a coordinate transformation to the center of m ass frame of the many-particle system. In the non-relativistic limit, the wavefunctions in the laboratory and CM frames are related by

where $\Re(t) = \frac{1}{N} \prod_{i=1}^{P} \langle \mathbf{r}_{i}(t) \rangle$ is the center of mass coordinate in the laboratory frame, N = number of particles and $\Re(t)$ is an overall phase that depends on $\Re(t)$ only. The corresponding H am iltonian in the CM frame is

where $\mathbf{r}^0 = \mathbf{r} \quad \mathbb{R}$ (t), $\mathbf{p}_1^0 = -ihr^0$ and $\mathbf{A}^0(\mathbf{r}^0) = -\frac{1}{2}\mathbf{r}^0 \quad \mathbf{B}^0$. $\mathbf{B}^0 = \mathbf{B}$ and $\mathbf{E}^0(\mathbf{t}) = \mathbf{E}^{\prime}(\mathbf{t}) + \frac{1}{c}\mathbf{R}^{\prime}(\mathbf{t}) \quad \mathbf{B}^{\prime}$ are the Galilean transformed magnetic and electric elds in the CM frame valid in the nonrelativistic limit. The Schrödinger equation in the CM frame, $ih_{-CM} = H^0(\mathbf{t})_{CM}$ can be simplied by a performing a gauge transformation $_{CM} = _{CM} e^{i - (t)}$, where $h(t) = _{i}^{P} m \mathbf{R}^{\prime}(\mathbf{t}) \mathbf{r}^0 - \frac{1}{2}^{R_t} dt^0 \mathbf{R} (t^0) \mathbf{K}^{\$} \mathbf{R} (t^0)$. where $a(t) = e E'(t) + \frac{1}{c}(\mathbb{R}^{c}(t) B)$ $\overset{S}{K} \mathfrak{R}(t) \ m \mathfrak{R}(t) = 0. a(t)$ vanishes because it is the equation of motion for $\mathfrak{R}(t)$ derived directly from the corresponding Heisenberg equation of motion. We thus arrive at the conclusion that for the class of Ham iltonian (2), there exist a one-to-one mapping between the solution of the Schrödinger equation in the presence of the microwave radiation $(\mathfrak{r}_{i};t)$, and in the absence of the radiation $_{CM}(\mathfrak{r}_{i}^{0};t)$, where $(\mathfrak{r}_{i};t) = _{CM}(\mathfrak{r}_{i} \ \mathfrak{R}(t);t)e^{i}$ (t). Physically, for the particular form of Ham iltonian we

considered, the wavefunction of the system follows the center of mass motion rigidity in the presence of the radiation eld.

The above result suggests that form ore general H am iltonians of form H_G (t) = H (t) + U, a new perturbation scheme where the microwave radiation is treated exactly to all order can be set up by treating U as perturbation. The perturbation scheme can be set up most easily in the center of mass frame. We shall consider static in purity potential U = $P_i u(\mathbf{r}_i)$ in the following. Notice that a static potential become time-dependent in the CM frame and should be treated by time-dependent perturbation theory.

To derive the transport equation we start from the exact H eisenberg equation of motion for the center of m ass coordinate, $ih \mathcal{R}(t) = \mathcal{R}(t); H_G(t) with \overset{\$}{K} = 0^4$. We obtain after some simple algebra

where $n(\mathbf{r};t) = {P \atop i} < (\mathbf{r} \quad \mathbf{r}_i) > \text{ is the tim e-dependent average electron density. In the CM fram e where <math>n(\mathbf{r};t) = n_{CM}$ ($\mathbf{r} \quad \tilde{R}(t);t$), we obtain for small from linear-response theory

where $(\mathbf{r}^0 \ \mathbf{r}^{"}; t \ t^0)$ is the (equilibrium) retarded density-density response function in CM fram e derived with the H am iltonian H_o. G oing back to the laboratory fram e and perform ing the disorder-average < u ($\mathbf{r} > = 0$ and < u (\mathbf{r})u (\mathbf{r}^0) > = juf ($\mathbf{r} \ \mathbf{r}^0$), we obtain to second order in , an impurity-averaged equation of motion for \mathbf{R} (t) in laboratory fram e⁴,

The equation is manifestly gauge invariant and suggests that to second order in the impurity potential, the elects of particle statistics and interaction are rejected only in the density-density response function. In the following we shall apply this equation to study the ZRS in 2D electron systems.

In this case we consider \mathbf{E} (t) = $\mathbf{E}_{o} \sin (! t) + \mathbf{E}_{d}$, where \mathbf{E}_{d} is a small DC electric eld. To simplify the equation we divide the center of mass motion into "fast" and "slow" parts,

 \mathfrak{K}_{f} (t) describes the center of mass motion induced by the radiation eld whereas \mathfrak{K}_{s} (T) describes induced motion under the DC eld \mathfrak{E}_{d} . The two kinds of motions are coupled by

the in purity scattering term which is a non-linear function of \Re (t). We shall assume that the coupling between \Re_s (t) and \Re_f (t) does not modify qualitatively the behavior of \Re_f (t) and the main elect of coupling is to produce an elective equation of motion for \Re_s (t). Notice that we keep only the rist harmonic terms in \Re_f (t) in Eq. (8). This is valid in the small E'_o limit when the size of the orbit R_c $\frac{q}{R_o^2 + B_o^2}$ is much less than the magnetic length $1 = (hc=eB)^{1=2}$ and is justiable under the experimental condition^{1,2} where the magnetic length is weak and the magnetic length is very long.

valid for \mathbf{v} (t + T⁰) \mathbf{v} (t) << \mathbf{v} (t), where T⁰ 2 =!_B is the characteristic time-scale for the density response. The \mathcal{R}_{f} (t) \mathcal{R}_{f} (t⁰) term can be expanded in a series of \mathcal{A}_{o} ; \mathcal{B}_{o} using the identity $e^{ix \sin} = {}^{P}{}_{m} J_{m}$ (x) e^{im} . where $z(q) = (q \mathcal{A}_{\circ})^2 + (q \mathcal{B}_{\circ})^2$ and $\tan = q \mathcal{A}_{\circ} = q \mathcal{B}_{\circ}^4$. We shall consider $z(q)^2 = R_c^2 q^2 = 2$ in the following corresponding to circularly polarized light¹¹. In this case the response of the system is isotropic and the computation is much simplied. The elective force on $\mathcal{R}_s(t)$ is derived from the m = m⁰ terms in (9). To order $(\mathcal{R}_c = 1)^2$ we keep only m (m⁰) = 0;1 terms. Putting it back into the equation of motion (7), we obtain

It is obvious that R [! ;v] represents dissipative response of the electron gas to external perturbations whereas [!;v] is an e ective m ass correction on the center of m ass m otion coming from the corresponding reactive response. Negative contributions to the resistance shows up in the second term of R for density-density response functions with resonant structure, (q;!) positive de nite function. In this case, R P (R_{1n}!_n + R_{2n} (!_n !)), where R_{1n} and R_{2n} are positive de nite num bers. W e see that negative contributions to R_2 exist for $!_n < !$. The physical origin of the negative resistance has been discussed in several earlier works^{3,4,5,6,11} and we shall not repeat them here. Correspondingly, the e ective mass contribution from level n is positive (negative) when $! > (<)!_n$. We note that the elective mass correction originates from the impurity scattering term is of order [!;v] m (1=! $_{\rm B}$) << m in the $(q_{d}^{2}j_{d}^{2}j_{d}^{2})^{1}$ is weak-disorder limit, where $!_{B} = eM = mc$ is the cyclotron frequency and the elastic lifetime. Eq. (10) diers from the phenomenological equation (1) mainly in the presence of the inertial term m w which allows the system to adm it time-dependent solutions in the present case.

R [!;v] is evaluated num erically with ie. (these approximations. In gure one we present numerical results for the normalized resistance R (!;v)=R (0;0), as a function of normalized velocity $v_{\rm N} = v = (1!_{\rm B})$ for $!=!_{B} = 0;0.85;1.0;1.1;1.2$, taking (R_c=1)² = 0.1, E_F 10!_B, T = 2!_B, = 0.5 and keeping 20 levels in the sum . We observe that R (!; v ! 0) becomes negative when $! > !_{B}$, in agreement with previous results¹¹. For $! > !_B R (!;v)'s$ increases and cross zero at 0.05. The e ect of m icrowave radiation decreases rapidly for $v_N > 0.2$. These around v_{ON} qualitative behaviors of R (!; v) are in agreem ent with expectation and are not m odi ed by changing T or .

Eq. (10) allows time-dependent solutions. In the absence of the DC eld, a simple, spatially hom ogeneous solution which allows the system to stabilize itself around the point




FIG. 1: Normalized resistance as a function of velocity for $!=!_B = 0$ (i);0:85 (ii);1:0 (iii);1:1 (iv);1:2 (v).

with $R_o = v_o = !_s$ where $!_s = eB = (m + (!;v_o))c$ $!_B$. The solution represents a collective circular motion of the whole uid moving with speed v_o . Notice that a time-independent, spatially inhom ogeneous solution corresponding to a pattern of alternating current stripes⁸ still exist. However this solution is energetically less favorable because it requires a higher energy to create the charge inhom ogeneity needed to maintain the stripes of currents.

To understand the ZRS we have to consider the boundaries of the droplet of electron uid. For sharp boundaries the boundary condition $j_2 = 0$ has to be imposed where j_2 is the component of current perpendicular to the boundary. As a result an edge region with a time-independent current $j_{=}$ j_0 must form. The size of this region is determined by the microscopic charge dynamics⁶ which is still undetermined. Nevertheless according to Eq. (10) an electric eld perpendicular to the boundary with magnitude $E_d = B v_0 = c$ has to be present in this region to maintain the steady current ow. A similar edge region also exists at the opposite edge with a current running in the opposite direction, rather similar to edge states in Quantum HallE ect.

A state with a small net current ow can be created with minimal disturbance to the system by shrinking the size of one edge region and enlarging the other. In this case, the net voltage drop across the sample is given by

corresponding to a resistance matrix with xx = 0 and xy = H, i.e. the ZRS.

Some comments about the validity of our theory is in order. We note that in deriving Eq. (10) we made the local approximation which assumes slow ly varying \mathbf{v} (t) whereas the spontaneous current state we propose oscillate with a frequency $!_B$. The oscillatory solution is allowed because of the presence of the inertia term $\mathbf{m} \mathbf{v}$ (t). Our analysis show s that the correction to the inertia term is small ($\mathbf{m} = (!_B)$) in the limit of weak disorder and the local approximation mainly a ects R [!;v]. Therefore our general description of the ZRS should remain valid as long as the qualitative property of R [!;v] is correct. Another simplication we employed in our analysis is the assumption of circularly polarized light. The response of the system which is isotropic in this approximation would become an isotropic when this assumption is relaxed^{4,11}.

Lastly we made a comment on the macroscopic nature of the spontaneous current state we proposed. We note that in general a spontaneous current state with $j_{Y}(t)j = v_{o}$ is characterized by a position and time dependent (2D) unit vector eld fi(x;t) representing the direction of the current. The order parameter eld fi(x;t) has the same symmetry as the ordinary 2D x y model, or super uids. The main dimension between the ZRS state and super uids is that the rigidity of the order parameter is protected by repulsive interaction in the case of super uids, whereas it is protected by the principle of least dissipation in the ZRS. The similarity between the two systems suggests that the two system smay share some common macroscopic features. For example, vortex-like solitonic excitations may exist in the ZRS and may lead to the residue resistance $R_{o}exp((T_{o}=T))$ observed in the ZRS state^{1,2}. The existence and nature of solitonic excitations depends on the detailed current dynamics of the ZRS state and will be investigated in a coming paper.
