E lectron ically sm ectic-like phase in a nearly half-doped $m$ angan ite

#### Abstract

We use neutron scattering to study the spin and charge/orbital ordering ( $\mathrm{CO}-\mathrm{OO}$ ) in the nearly half-doped perovsk ite $m$ anganite $P r_{0: 55}\left(C a_{0: 8} S_{0: 2}\right)_{0: 45} \mathrm{M} \mathrm{nO}_{3}$ (PCSMO).On cooling from room tem perature, PCSMO rst enters into a CO-OO state below $T_{c o}$ and then becom es a CEtype long-range ordered antiferrom agnet below $T_{N}$. At tem peratures above $T_{N}$ but below $T_{C}$ o ( $T_{N}<T<T_{C O}$ ), the spins in PCSMO form highly anisotropic sm ectic liquid-crystal-like texture w ith ferrom agnetic (FM) quasi-long-range ordered one-dim ensional zigzag chains weakly coupled antiferrom agnetically. Such a m agnetic sm ectic-like phase results directly from the spin-orbit interaction and dem onstrates the presence of textured electronic soft' phases in doped $M$ ott insulators.


The $m$ anganese oxides $w$ ith general composition $R_{1} \times{ }_{x} \mathrm{MnO}_{3}$ (where $R$ and $A$ are rare- and alkalineearth ions) have been actively investigated over the past decades because of the colossal m agnetoresistance (CMR) e ect observed around $x=0: 30$. The fascinating properties of these $m$ aterials have been attributed to the electronic com plexity arising from the strong com petition betw een charge, orbital, lattice and $m$ agnetic degrees of freedom $\overline{[11}, \overline{2} 1]$. O f particular interest is the case of the half-doped ( $\mathrm{x}=0: 5$ ) m anganites. W hen cooling from room tem perature, they form a structure that has been described as a \charge and orbital ordered" (C O OO ) state, where $\mathrm{M} \mathrm{n}^{3+}$ and $\mathrm{M} \mathrm{n}^{4+}$ ions are arranged altematively in the form of checkerboard-like order below
 CE-type $m$ agnetic structure below $\mathrm{T}_{\mathrm{N}}$ ( F ig. 1 (a)). In the interm ediate tem perature region above $\mathrm{T}_{\mathrm{N}}$ but below $T_{C O}\left(T_{N}<T<T_{C O}\right)$, there is a coexistence of incom m ensurate and inhom ogeneous m agnetic and CO -
 is still unclear and it has been recently suggested that it is related to the em ergence of new electronic soft phases
 tron scattering studies on a nearly half-doped perovskite $m$ anganite $P r_{0: 55}\left(C \mathrm{a}_{0: 8} \mathrm{Sr}_{0: 2}\right)_{0: 45} \mathrm{M} \mathrm{nO}_{3}$ (PCSMO) focusing in the purported \electronically soft" phase regim e of $\mathrm{T}_{\mathrm{N}}<\mathrm{T}<\mathrm{T}_{\mathrm{C} O}$. We choose PCSMO because this materialhas wellseparated $\mathrm{CO}-\mathrm{O} \mathrm{O}$ and AF transitions ideally suited for our investigation $\left.\bar{T}_{-1}\right]$. W hile the $\mathrm{CO}-\mathrm{OO} \mathrm{uc}$ tuations in PCSM O are spatially isotropic as expected, the AF spin uctuations are highly anisotropic and indicative of the form ation ofquasi-long-range FM ordered 1D spin chains that are weakly coupled antiferrom agnetically. The anisotropic and low -dim ensional character of the spin uctuations is counterintuitive in a conventional
param agnetic state, as P C SM O is essentially cubic. We argue that these features are due to the an isotropy of the short-rangeD ouble E xchange interactions as proposed by
 and that the com plex coexistence of the $m$ agnetic and charge/orbital uctuations in this regim e arises from the $m$ agnetic exchange and the orbitaldegeneracy of the $M \mathrm{n}$ ions. O ur results highlight the role of the orbital physics in determ inig the electronic properties of the half-doped $m$ anganites and support the idea that the charge/orbital and $m$ agnetic uctuations have the sam em agnetic origin. The observed highly anisotropic spin texture is rem iniscent of the sm ectic phases [10 $0_{1}^{1}$ ] predicted in the doped M ott insulators $\left.[1]_{1}^{1}\right]$ and is the rst exam ple of the textured \electronically soft" phases in the CM R m anganites [id].

W e grew a single crystalofPCSM O using the oating zone m ethod [Tַ|' PCSM O has the P bnm symmetry in the low -tem perature orthornom bicphase (a b 3:85 A and c 3:79 A below $\mathrm{T}_{\mathrm{C}}$ ), slightly distorted from the cubic lattice. The sam ple is naturally tw inned due to the sm all orthornom bicity, the tw inning dom ains are 90 degree rotated w ith respect to each other in the scattering plane. For sim plicity, we use a pseudo-cubic unit cell w th lattice param eters of a b c 3:84 A, and all the wavevectors below refer to the cubic notation. Them om entum transfers $q=\left(q_{x} ; q_{y} ; q_{z}\right)$ in units of $A^{1}$ are at positions $(h ; k ; l)=\left(q_{x} a=2 ; q_{y} a=2 ; q_{z} a=2\right)$ in reciprocal lattice units (rlu). T he sam ple was aligned to allow the wavevector in the form of $(h ; k ; 0)$ accessible in the horizontal scattering plane. Our neutron scattering experim ents were carried out using them al neutron triple-axis spectrom eters at the H igh F lux Isotope Reactor ( $\mathrm{H} F \mathbb{R}$ ), O ak R idge N ational Laboratory, the NIST Center for $N$ eutron $R$ esearch, and the $\operatorname{RR}$ R 3

reactor JA ER I, T okai, Japan. The neutron energy was xed at $\mathrm{E}=14: 7 \mathrm{~m}$ eV using pyrolytic graphite crystals as monochrom ators, analyzers and lters.

U pon cooling PCSM O undergoes a series of transitions. It rst enters the $\mathrm{CO}-\mathrm{OO}$ state below $\mathrm{T}_{\mathrm{C}}$ 210 K and becom es a long-range antiferrom agnet below $\mathrm{T}_{\mathrm{N}} \quad 150 \mathrm{~K}$ w ith a CE-type spin arrangem ent ${ }_{1}^{2} 1 \mathrm{l}$ ]. Neu tron di raction is not sensitive to the ordering of orbitals but it can $m$ easure the superlattioes associated $w$ th the lattice distortions caused by such order. In a tw inned crystal, the characteristic propagation w avevectors of the CO -OO structure are $\mathrm{q}=(1=4 ; 1=4 ; 0)$ (which is also the propagation $w$ ave vector for the netw ork ofM $n^{3+}$ spins), and $q=(1=2 ; 0 ; 0)$ is the propagation $w$ ave vector for the $\mathrm{Mn}^{4+}$ spins netw ork [12]. Experim entally the intensity of the scattering at a $w$ ave vector $\sigma=(q+\sim)$, where $\sim$ is a vector of the reciprocal lattice and $q$ is the propagation wave vector, provides a m easurem ent of the order pa-
ram eter for such structure. Since the neutron scattering cross section is proportionalto the square of them agnetic form factor, which decreases rapidly at large scattering wavevectors, one can choose \large" wave vectors $\sigma$ to probe the CO -O O and \sm all" Q's to probe the m agnetic ordering. In our neutron di raction experim ents, we used $\sigma=(2: 25 ; 0: 25 ; 0),(0: 25 ; 0: 25 ; 0)$ and $(0: 96 ; 0 ; 0)$ to $\mathrm{m} \mathrm{ea}-$ sure the $\mathrm{CO} \bigcirc \mathrm{O}, \mathrm{AF}$ and FM uctuations, respectively. $W$ e also used $Q=(0: 5 ; 0 ; 0)$ to probe the $A F$ uctuations related to the $\mathrm{Mn}^{4+}$ spins ( F ig. $1(\mathrm{~b})$ ).

Figures 1 ( C )-( f ) show the tem perature dependence of the resistivity $\left[\overline{7}_{1}\right]$ and the peak intensities associated $w$ ith $A F, F M, C O O O$ uctuations as the sample is cooled in zero m agnetic eld. The resistivity exhibits insulating behavior at all tem peratures $w$ ith a distinct feature around $\mathrm{T}_{\mathrm{C} O}=210 \mathrm{~K}$ in the -T curve. T he hysteresis in the resistivity near $\mathrm{T}_{\mathrm{C}} \mathrm{o}$ is accom panied by a rst-order structural transition from pseudo-cubic to orthornom bic phase causing a sm allsplitting of the $(2,0,0)$ lattice peak. The CO OO peak intensity in Fig . 1 (e) also show s an abrupt change near $\mathrm{T}_{\mathrm{C}} \mathrm{o}$ w ith strong hysteresis. T he clear correlation betw een the resistivity and the CO-OO peak intensity indicates that the transport properties of these $m$ aterials are $m$ ostly govemed by the localization and delocalization of charge carries [131, 114.1]. P C SM O does not exhibit long-range FM order in zero m agnetic eld but develops short-rangeFM spin uctuationsabove $\mathrm{T}_{\mathrm{N}}$. These uctuations increase w ith decreasing tem perature, peak at $T_{C o}$, and are greatly suppressed at low tem peratures ( $F$ ig. 1 (e)). T he most interesting ndings com e from the tem perature dependence of the AF intensities associated $w$ ith the $\mathrm{Mn}^{3+}$ and $\mathrm{Mn}^{4+}$ spin uctuations. As show $n$ in $F$ igs. $1(d)$ and 1 ( $£$ ), weak AF spin uctuations appear just below $\mathrm{T}_{\mathrm{C}}$ o and increase gradually w th cooling. An abrupt change takes place below $\mathrm{T}_{\mathrm{N}} \quad 150 \mathrm{~K}$, w here the sam ple enters the long-range A F ordered pseudo-CE phase.

To probe the characteristics of AF uctuations in $\mathrm{T}_{\mathrm{N}}<\mathrm{T}<\mathrm{T}_{\mathrm{C} 0}$, we perform ed m esh scans in reciprocal space near the $\sigma=(0: 25 ; 0: 25 ; 0)$ and $\sigma=(0: 5 ; 0 ; 0) A F$ ordering positions corresponding to the $M n^{3+}$ and $M n^{4+}$ spin uctutations respectively. P anels (a), (c) and (e) of Fig. 2 show the evolution of the AF ordering associated w th the $\mathrm{Mn}^{3+}$ uctuations at $\mathrm{T}=190,170$ and 150 K . These AF uctuations are clearly anisotropic, w ith the pro le in the longitudinal $[1 ; 1 ; 0]$ direction being considerably broader than that in the transverse $[1 ; 1 ; 0]$ direction. This indicates that the correlation of spins in the $[1 ; 1 ; 0]$ direction is $m$ uch w eaker than along $[1 ; 1 ; 0]$. T he corresponding evolution of the AF ordering associated w th the $\mathrm{M} \mathrm{n}^{4+}$ uctuations, on the other hand, re$m$ ains isotropic at all tem peratures as ilhustrated in panels (b), (d) and (f). These observations are consistent $w$ ith the form ation of w eakly antiferrom agnetically coupled, quasi-long-range FM ordered 1D $\mathrm{M} \mathrm{n}^{3+}$ spins in an isotropic $\mathrm{Mn}^{4+}$ spins background. W hile our neutron

scattering $m$ easurem ents allow us to probe the netw orks of $\mathrm{M} \mathrm{n}^{3+}$ and $\mathrm{M}^{4+}$ spins separately, we cannot overlook the fact that these two types of spins interact strongly via the D ouble Exchange (DE) process. This m echanism allow s electron hopping betw een neighboring $M n^{3+}$ and $\mathrm{M} \mathrm{n}^{4+}$ if they have parallel spins and leads to the form ation ofthe zigzag altemating $\mathrm{M} \mathrm{n}^{3+} / \mathrm{M} \mathrm{n}^{4+}$ chains show n in $F$ ig. 1 (a) [ $\left.{ }_{[1}^{2}\right]$.
$F$ igure 3 show s the pro les of the scattering from AF and $\mathrm{CO}-\mathrm{O}$ uctuations at representative tem peratures on cooling and warm ing. Broad AF uctuation peaks can be $m$ easured below $T_{C o}$ (there is no $m$ easurable signal above this tem perature). The peak associated w th the $\mathrm{Mn}^{4+} \mathrm{AF}$ uctuations is commensurate w ith $\Phi_{c}=(1=2 ; 0 ; 0)$ at all tem peratures on cooling and on warm ing ( F igs. 3 (a)-(b)) w th no hysteresis. The peaks associated w th the Mn ${ }^{3+} \mathrm{AF}$ and CO-OO uctuations, on the other hand, are history dependent. They are incom $m$ ensurate at $T_{C} 0$, shift tow ard $~_{c}=(1=4 ; 1=4 ; 0)$ upon cooling, and lock into this com $m$ ensurate position at $T_{N}$. Upon warm ing to $T_{C} o$ the scattering rem ains com $m$ ensurate as sum $m$ arized in $F$ igs. 4 (a) and 4 (c). $F$ igure 4 (b) show s the $m$ easured longitudinal and transverse w idths of the scattering associated with M $\mathrm{n}^{3+}$ AF uctuations. These linew idths decrease upon cooling and the AF scattering becom es isotropic and resolution lim ited when $T \quad T_{N}$. From these linew idths we calculated the correlation lengths [1] $\left[_{1}^{-1}\right.$ along the 1D FM spin chains
(intra-chain coupling) and perpendicular to these (interchain coupling). The intra-chain correlation length $T$ is around 200 A at 190 K and is only weakly tem perature dependent. The inter-chain correlation correlation length L increases from 33 A at $\mathrm{T}=190 \mathrm{~K}$ to 75 A on cooling to $150 \mathrm{~K} . \mathrm{T}$ his result indicates that the quasi long-range FM 1D spin chains are only weakly coupled below $\mathrm{T}_{\mathrm{C}} \mathrm{O}$, and that the interchain coupling becom es stronger as $\mathrm{T}_{\mathrm{N}}$ is approached. This highly anisotropic spin texture is rem in iscent of the electronically liquid-crystal-like sm ectic phases proposed in the doped M ott insulators [ $\left[1 \overline{1}_{1}^{1}\right]$. The scattering from the $\mathrm{CO}-\mathrm{OO}$ uctuations is isotropic [16] w th linew idths that decrease upon cooling. These linew idths, how ever, rem ain greater than the instrum entalresolution ( F ig. $4(\mathrm{~d})$ ), even at the low est tem perature.

The di erences am ong the behavions described above suggest that the interplay between the AF and COOO uctuations in the param agnetic phase of PCSMO $\left(T_{N} \quad T \quad T_{C O}\right)$ is $m$ ore com plex than expected. The coexistence of AF and CO-OO uctuations suggests a strong correlation betw een them. The conventionalw isdom is that the $\mathrm{CO}-\mathrm{OO}$ should occur at a higher tem perature, of the order of the covalent bonding energy as originally proposed by G oodenough [ili the m agnetic interactions. H ow ever, $\bar{G}$ oodenough's con-

jecture of ordered $\mathrm{M}^{3+}$ and $\mathrm{M} \mathrm{n}^{4+}$ ions $m$ ay not be accurate as the actual charge disproportionality of the Mn
 terplay of M n charges, orbitals and spins would then be reduced to the com petition of the kinetic energy of the
 $T$ his com petition com bined w ith the orbital degeneracy should lead to the experim entally observed $\mathrm{CO}-\mathrm{O}$ and drive the form ation of 1D ferrom agnetic zigzag chains that are rst loosely correlated and then lock in them agnetic CE structure of F ig. 1 (a) below $\mathrm{T}_{\mathrm{N}}$. The idea that the $\mathrm{CO}-\mathrm{O}$ is independent of the m agnetic interactions seem s to be far from true, and it is even possible that the $\mathrm{CO} \bigcirc \mathrm{O}$ is driven by the sym m etry breaking caused by them agnetic texture $\left[\begin{array}{ll}9 \\ , 1 & 20 \\ 2\end{array}\right]$. It is rem arkable that despite the reported sm all charge disporportionality betw een the Mn ions $[7]$ haviors of the Mn ions located at the $\mathrm{Mn}^{3+}$ and $\mathrm{M}^{4+}$ sites as illustrated in Fig. low -dim ensional behavior of the $\mathrm{M}^{3+}$ ions in this basically cubic $m$ aterial highlights the role of the orbitals in the form ation of the 1D spin chains in this regim e.
 cussed the complex electronic behaviors deriving from the strong energy com petitions in the CM R m anganites. These authors proposed the presence of textured electronically soft phases w ith incom $m$ ensurate, inhom ogeneous and $m$ ixed orders in the param agnetic state. T he observed sm ectic liquid-crystal-like weakly coupled, 1D FM zigzag chains in PCSMO con $m$ the presence of the sought after textured electronic soft phase predicted in


In sum $m$ ary, we have studied the $\mathrm{CO-OO}$ and m agnetic ordering in the nearly half-doped $m$ anganite PC$\mathrm{SM} O$ using neutron scattering. In the param agnetic state $\mathrm{T}_{\mathrm{N}}<\mathrm{T}<\mathrm{T}_{\mathrm{C} O}$, we nd the coexistence of $\mathrm{FM}, \mathrm{CO}-\mathrm{O}$ and AF uctuations. This coexistence arises from the com petition betw een the kinetic energy and the $m$ agnetic exchange, and from the orbital degeneracy of the Mn ions. W hile the CO-OO andAF uctuations are strongly correlated in this tem perature region, they also exhibit distinctive behaviors. Rem arkably, the AF short-range spin uctuations of the $\mathrm{M}^{3+}$ spins are highly an isotropic and exhibit anisotropic sm ectic-like spin texture, consistent w th the presence of a electronically soft phase as recently proposed in the literature.
