Stoner G ap in the Superconducting Ferrom agnet U G e_2

W e report the tem perature (T) dependence of ferrom agnetic B ragg peak intensities and dc m agnetization of the superconducting ferrom agnet UG e₂ under pressure (P). We have found that the low -T behavior of the uniform m agnetization can be explained by a conventional Stoner m odel. A functional analysis of the data produces the following results: The ferrom agnetic state below a critical pressure can be understood as the perfectly polarized state, in which heavy quasiparticles occupy only m a prity spin bands. A Stoner gap (P) decreases m onotonically with increasing pressure and increases linearly with m agnetic eld. We show that the present analysis based on the Stoner m odel is justimed by a consistency check, i.e., com parison of density of states at the Fermi increase deduced from the analysis with observed electronic speci c heat coe eients. We also argue the in unce of the ferrom agnetism on the superconductivity.


I. IN TRODUCTION

Since a pioneer paper by G inzburg on the coexistence of ferrom agnetism and superconductivity [1], the interplay between these two long-range orderings has been an interesting topic in solid-state physics. Superconductivity and magnetism would be antagonistic because of the com petitive nature between the superconducting screening (Meissnere ect) and the internal elds generated by m agnetic orderings. During the last three decades, how ever, the discovery of a num ber of m agnetic superconductors has allowed for a better understanding of how magnetic order and superconductivity can coexist. It seems to be generally accepted that antiferrom agnetism with local m om ents com ing from rare-earth elem ents readily coexists with type II superconductivity. This is because superconductivity and magnetism are carried by di erent types of electrons; magnetism is connected with deeply seated 4f electrons, while superconductivity is fundam entally related to the outerm ost electrons such as s, p, and d electrons.

In the case of a ferrom agnetic superconductor, a trickier negotiation is needed for the coexistence, because internal elds are not canceled out in the range of a superconducting coherence length in contrast with an antiferrom agnetic superconductor. In the classical magnetic superconductor $ErRh_4B_4$ with a superconducting transition tem perature 8.7 K, for example, once the Er sublattice starts to order ferrom agnetically below about 0.8 K, the superconductivity is im mediately destroyed, except a very narrow coexistence region near 0.8 K [2]. Here we note that the magnetic structure coexisting with the superconductivity is not purely ferrom agnetic but spacially modulated. ErN i_2B_2C is a modern example of m agnetic superconductor. A m icroscopic coexistence between weak ferrom agnetism and superconductivity was reported, but detailed neutron di raction investigations indicated that the magnetism coexisting with the superconductivity is not purely ferrom agnetic $[\beta]$, again. These examples seem to indicate that superconductivity hardly coexists with ferrom agnetism, even though superconductivity and ferrom agnetism are carried by di erent types of electrons. Recently, Saxena et al. discovered a new type of ferrom agnetic superconductor UGe_2 in which superconductivity occurs at high pressures [4]. It is particularly interesting to note that both of ferrom agnetism and superconductivity may be carried by itinerant 5f electrons, which can be hom ogeneously spread in the real space, although it is still a matter of debate and remains to be resolved. This observation has renewed our interest on the interplay of ferrom agnetism and superconductivżγ.

Figure 1 shows a temperature (T) vs pressure (P) phase diagram of UG e_2 . A Curie tem perature (T_{FM}) is about 52 K at am bient pressure, and m onotonically decreases with increasing pressure. Then it collapses to zero tem perature at a ferrom agnetic critical pressure P_{FM} (1.5 GPa). In the ferrom agnetic phase, another phase transition or crossover seem to appear at T_X (' 32 K at am bient pressure). This characteristic tem perature T_X also decreases with increasing pressure and becomes suppressed to zero at a critical pressure P_X (12 GPa). The transitions at P_X and P_{FM} are likely of the rst order in nature [5]. Superconductivity en erges in the pressure range between 1.0 and 1.5 GPa. Since a maxim um superconducting transition tem perature (T_{SC} 0.7 K) is observed at around P_X [4], we speculate that the critical point P_X plays an important role in the onset of

the superconductivity (see, for example, W at anabe and M iyake [6], Sandem an et al. [7], and references therein). Very recently, Nakane et al. provided a supporting evidence for the speculation by means of ac magnetic susceptibility measurements under external magnetic elds H; in a plot of T_{SC} as functions of P and H, the superconductivity always appears at around the critical point P_X , not around P_{FM} [8]. However, there are still m any unsolved questions in this unique material to be further clari ed. To shed more light on the nature of the ferromagnetism as well as its pressure variation, we present in this paper the T-dependence of the uniform magnetization under pressure by the neutron di raction technique, together with the dcm agnetization method. Sim ilar measurements were already reported, however the present experim ent is so precise that we can analyze the functional dependence of the magnetization. Actually, we have found that the low T-dependence of the uniform magnetization can be described by a conventional Stoner model. This enables us to extract new inform ation about the ferrom agnetism as follows: The low-T and low-P region of the ferrom agnetic state, i.e., the FM 1 region in Fig. 1, is understood as a perfectly polarized state in which only a majority spin band is occupied. As the pressure increases tow and P_X , a Stoner gap (P) in the heavy quasiparticle bands decreases monotonically, sim ilarly to T_X (P). W hen the pressure exceeds P_X , the gap seems to jump up, although the applicability of the Stoner model to this high pressure ferrom agnetic state (FM 2) is less convincing compared to the region P $\,<\,$ P_X . From these results, we argue the in uence of an e ective internal eld produced by the ferrom agnetism, which is found to be remarkably large below P_X , on the superconductivity.



II. EXPERIMENT

Single crystals were grown by the C zochralsky pulling method using a tetra-arc furnace installed at O arai Branch of Institute for Material Research, Tohoku University [9]. The pressure was generated using a copperberyllium (CuBe) based piston-cylinder clam p device [10] with Fluorinert FC-75 (3M Co. Ltd., Tokyo) as a pressure transmitting medium. The low temperature pressure was determined by measurements of the change in a lattice param eter of N aC 1 put together with the sam ple. Elastic neutron scattering experiments were done on the ISSP cold neutron triple-axis spectrom eter HER (C1-1) installed at JRR-3M, JAERI, Japan, with a typical conguration of energy $k_i = 1.11 \text{ A}^{-1} \text{ or } 1.555 \text{ A}^{-1}$ and collim ations of Guide-Open-80'-80'. A cooled Be 1ter was placed before the sam ple to rem ove higher order contam inations. The crystals were oriented with the aaxis perpendicular to the scattering plane. Tem perature was cooled down to 1.4 K using a ⁴He-pum ping ILL-type orange cryostat. The dc m agnetization m easurem ents were carried out using a conventional vibrating sample m agnetom eter (VSM) [9].

III. RESULTS AND DISCUSSION




FIG.2: (Color online) Tem perature dependence of the ferrom agnetic B ragg peak intensities at Q = (0,0,1) against the tem perature T m easured at various pressures. \BG " denotes background intensities in the param agnetic phase of about 1250, which arise from the incoherent scattering of both the crystal itself and the pressure cell. Note that $P_X = 1.2$ G Pa. The solid lines are calculated results on the basis of the Stoner m odel described in the text.

In Fig. 2 we show the T-dependence of magnetic Bragg peak intensities I_B (T) at Q = (0,0,1) for several pressures. All data were accumulated at $k_i = 1.555$ A ¹ in the process of increasing tem perature. In contrast with a conventional dc m agnetization m easurem ent, neutron scattering experiments do not su er from complications arising from a pressure cell contribution to the magnetization as well as a magnetic domain e ect in a ferrom agnetic sample, and hence the present results are not obscured at all by these e ects. W hile there is no apparent anomaly in the curve of P = 0.28 GPa, we clearly observe a steep increase below T_X 10 K at 1.1 GPa. (In the present study, we de ne T_X as a maximum tem perature appearing in the second derivative of the $I_{\!B}\,$ (T) curve with respect to T; Note that this de nition yields a T_X -value close to previously reported ones.) W e note that the overall feature of the present result is consistent with the Bragg peak intensity and static magnetization data previously reported in Refs. [9, 11, 12]. At 1.23 GPa, such an anom alous behavior was not observed in accordance with P_X 12GPa.

Remembering that the neutron intensities are proportional to the square of magnetization M , we calculate the magnetic B ragg peak intensities in terms of the Stoner model, which is expressed as follows (see, for example, [13]);

where M₀ indicates the magnetization at zero tem perature, a so-called Stoner gap, E_F a Ferm i energy, and ⁰ is a molecular eld coe cient. The results are shown in Fig. 2 by solid lines. Interestingly, we nd good agreement between the low-T magnetization data and the calculation. (The observation of the exponential like T-dependence of the magnetization, instead of a conventional T-power law behavior due to spin wave excitaions, is probably related to a huge uniaxial magnetic anisotropy of UG e₂.) This agreement suggests that the decrease in the magnetization at low temperatures is mainly caused by electron-hole excitations in quasiparticle bands.




FIG.3: (C olor online) P ressure dependence of the obtained parameters from the Stoner m odel. The solid lines are guides to the eye. (a) , ⁰, and T_X plotted are normalized with respect to a respective ambient pressure value; = 39.5 K, ⁰ = 83.4 K, and T_X = 30.2 K.W e also plot T_X taken from R ef. [14]. (b) Ratio of ⁰/E_F is plotted against P below P_X. Note that the pressure region of P < P_X corresponds to the perfectly polarized state in the Stoner m odel, i.e., ⁰/E_F > 2 ¹⁼³. For the region above P_X, see the discussion in the text. (c) Inverse Ferm i energy 1/E_F is plotted against P below P_X together with an electronic speci c heat coe cient taken from R ef. [14].

From the least square thing of the data, we estimate a set of parameters and in eq. (1), which further enables us to evaluate $E_{\rm F}$ and 0 using eq. (2). First we concentrate on the pressure region below $P_{\rm X}$. In Fig. 3 (a) we show and 0 together with $T_{\rm X}$, each of which is normalized to unity at ambient pressure. It is interesting to note that these quantities seem to lie on a single line, suggesting that the characteristic energy scale of unknown origin, $T_{\rm X}$, is related to the Stoner gap (equivalently 0).

In Fig. 3 (b) we plot a ratio of ${}^{0}/E_{\rm F}$ against P. A coording to the Stoner model, the ratio greater than $2^{\frac{1}{3}}$ (0.793) m eans that the system is in a perfectly polarized ferrom agnetic state, where only a majority spin band is occupied. When the ratio lies between 2/3 and $2^{\frac{1}{3}}$, an in perfectly polarized ferrom agnetic state occurs, where a minority spin band becomes to be partially occupied by quasiparticles. Further in the case that the

ratio is smaller than 2/3, the system is param agnetic. As seen in the gure, our analysis indicates that the perfectly polarized state is realized below P_X . This result is supported by band structure calculations indicating that Ferm i surfaces have a predom inantly majority spin character [15, 16].

In Fig. 3 (c) we plot an inverse of Ferm i energy $1/E_F$ deduced from the above analysis as a function of P. To estim ate a density of states at the Ferm i energy, D (E_F), we assume that E_F D (E_F) is a constant value independent of pressure. Then, $1/E_F$ corresponds to D (E_F). On the other hand, D (E_F) can be directly obtained from an

electronic speci cheat coe cient ,which is also shown in Fig. 3 (c) for camparison [14]. As is clearly seen, $1/E_{\rm F}$ is proportional to , i.e., $1{=}E_{\rm F}$ = c with a P-independent constant c. This coincidence justi es our interpretation based on the Stonerm odel.

Figure 4 (a) shows the dcm agnetization M (T) at 1.18 GPa (< P_X) under external magnetic eds H_{ext} . (The magnetization of the pressure cell was subtracted from the total measured magnetization.) The magnetic edd was applied along the magnetization easy a-axis. We observed that the M (T) curve shows a step-like increase at lower edds similarly to the $\frac{1}{2}$ (T) curve, and that T_X exhibits an increase with H_{ext} in accordance with the previous results [5, 8]. We nd that the static low-T magnetization can also be well described by the Stoner m odel (see dotted lines).

In Fig. 4 (b) we plot as a function of H $_{\rm ext}$, which was obtained in the same manner as above. It is found that increases almost linearly with H $_{\rm ext}$, as shown by a broken line. This is highly expected from the Stoner m odel; the gap in the quasiparticle bands should linearly increase with the magnetic eld due to the Zeem an elect as follows,

Here, is a value at zero m agnetic eld, i.e., (H = 0), g and S denote a g-factor and the m agnitude of the quasiparticle spin, respectively, and _B is the B ohrm agneton. Indeed, the value of ' 12 K estim ated from the extrapolation to zero eld is consistent with a value obtained from the Bragg peak intensity (at H = 0) mentioned above. A set of parameters, g = 6/7 and S = 5/2 corresponding to an f electron, produces better agreement between the observation and the calculation than a different set of parameters, g = 2 and S = 1/2 for a free electron. This may reject that the heavy quasiparticle arises from f electrons.

The slope of the broken line in Fig. 4 (b) is calculated to be about 0.3 K /kO e. It is very interesting to note that this value is almost the same as the slope of curves in a plot of $T_{\rm X}~$ vs H (see, for example, Ref.[6] and references therein). This clearly supports that $T_{\rm X}~$ is related to the Stoner gap ~, as mentioned above.

Figure 4 (c) shows the H $_{\rm ext}$ -dependence of 1=E $_{\rm F}$ (at 1.18 G Pa) obtained from the least square tting of the M (T) data to the Stoner m odel. We also plot reported values of the -coe cient observed at 1.15 G Pa under external magnetic elds [17]. Again, we nd the same relation 1=E $_{\rm F}$ = c with the same scale factor c as the above. Note that there is no adjustable parameter at all, nevertheless we nd the good agreem ent between D (E_{\rm F}) estim ated from the Stoner m odel and deduced from the heat capacity experiments. This clearly proves the validity of our m odel analysis.

Let us return to the pressure region of $P > P_X$. As m ay be seen from Fig.2, the accordance between the calculated and the experimental results is less convincing




FIG.4: (Color online) (a) Temperature dependence of the static magnetization at 1.18 GPa under various magnetic elds along the magnetization easy a-axis. (b) Stoner gap

com pared with that for $P < P_X$, for which there are two possible explanations: First, the low T-dependence of the uniform magnetization (for $P > P_X$) can no longer be described by the Stoner model. Second, the Stoner model is still applicable to the FM 2 region, but a pressure distribution within the sam ple will cause the M (T) curve to deviate from the Stoner model. (The Curie temperature decreases steeply above P_X (see Fig. 1). In such a case, the experimental results could be obscured by even a small pressure distribution within the sam ple [10, 18].) Since it is unclear which is dominant, we tentatively tried to apply the Stoner model to the FM 2 region. The obtained -values are as follows; = 40 (6), 25 (5), and 7 (7) K at P = 123, 128, and 1.40 G Pa, respectively. We not that shows a jump near at P_X on going from

We nd that shows a jump near at P_X on going from the FM 1 to FM 2 region, and that decreases m onotonically with further increasing pressure and nally tends toward zero in the vicinity of the ferrom agnetic critical pressure $P_{\rm FM}$. Note that the jump of rejects the sudden change in the solpe of the $I_{\rm B}$ (T) curves below and above P_X . A further investigation is needed to clarify whether the magnetization in the FM 2 region can be described by the Stoner model or not.

Finally we discuss the correlation between the ferrom agnetism in the FM 1 region and the superconductivity. It is evident that the Stoner gap behavior in the FM 1 region is m ly established by the consistency check, i.e., the comparison of our results with the -coe cients. Using the parameter ⁰ in eq. (2) obtained from the tting, we can estimate an electrice internal eld H_{eff} seen by the itinerant electrons due to the ferrom agnetism by the de nition of $_{\rm B} H_{eff} = k_{\rm B}$ ⁰. Then we nd it to be very large; for example, H_{eff} 100 T at am bient pressure and H_{eff} 40 T at 1.1 GPa (see Ref. [19] for detail). This m ay explain an asymmetric shape of the superconducting dom e with respect to P_X in the T-P phase diagram, if we assume that the superconductivity does not survive under such a strong internal eld. In the literature, it has been speculated that the nonunitary superconducting state would be realized in UG e₂; otherw ise the superconductivity would not coexist with the ferom agnetism. How ever, it seem s very unlikely that the strong internal

eld m entioned above dose not kill the superconductivity, even if the spin-triplet pairing state would be form ed. This leads us to suggest spatially inhom ogeneous coexistence of the ferrom agnetism and the superconductivity, provided that the superconductivity below P_X is intrinsic, but not due to the pressure inhom ogeneity. W e need a further experiment to con m this possibility.

IV. SUMMARY

We investigated the uniform magnetization of the pressure-induced superconductor UGe_2 by the neutron di raction technique together with the dc magnetization measurements under pressure. For this strongly anisotropic ferromagnet, we found that the bw-T behavior in the magnetization of the FM 1 region can be explained by the conventional Stoner model. Our analysis based on the Stoner model produces the following results: The ferromagnetic state below the critical pressure P_X (12GPa) is understood as the perfectly polarized state in which the heavy quasiparticles occupy only

the majority spin band. The Stoner gap in the heavy quasiparticle bands was estimated to be about 40 K at am bient pressure, and was found to decrease m onotonically with increasing pressure P and to increase linearly with magnetic eld H. The similarity between the Pand H -dependences of $\operatorname{and} T_X$ suggests that the characteristic energy T_X of unknown origin can be related to the Stoner gap. Assuming that the product $E_F D$ (E_F) is constant, we evaluated the P - and H -dependence of a density of states at the Ferm i energy D (E $_{\rm F}$) using the Stoner model. Then we found that $D(E_F) = c$ with the same constant c for both the P - and H -dependence of the electronic speci cheat coe cient . This justi es our interpretation based on the Stoner model. Finally we argued the relationship between ferrom agnetism and superconductivity; the e ective internal eld seen by itinerant electrons is estim ated to be su ciently strong that the superconductivity would hardly survive, which leads us to suggest the spatially inhom ogeneous coexistence of ferrom agnetism and superconductivity. We hope that these results stimulate further theoretical investigations.
