The a-axis optical conductivity of detw inned ortho-II Y B a₂C u₃O 6:50

The a-axis optical properties of a detw inned single crystal of Y B a_2 C u_3 O $_{6:50}$ in the ortho II phase (0 rtho II Y 123, T_c = 59 K) were determ ined from rejectance data over a wide frequency range (70 -42~000 cm⁻¹) for nine temperature values between 28 and 295 K. Above 200 K the spectra are dominated by a broad background of scattering that extends to 1 eV. Below 200 K a shoulder in the rejectance appears and signals the onset of scattering at 400 cm⁻¹. In this temperature range we also observe a peak in the optical conductivity at 177 cm⁻¹. Below 59 K, the superconducting transition temperature, the spectra change dram atically with the appearance of the superconducting condensate. Its spectral weight is consistent, to within experimental error, with the Ferrell-G lover-T inkham (FGT) sum rule. We also compare our data with magnetic neutron scattering rates can be modeled as the combined eject of the neutron resonance and a bosonic background in the presence of a density of states with a pseudogap. The model shows that the decreasing am plitude of the neutron resonance with temperature is compensated for by an increasing of the bosonic background yielding a net temperature independent scattering rate at high frequencies. This is in agreem ent with the experiments.

The complete phase diagram of the high tem perature superconducting (HTSC) cuprates is still under intense debate. The norm alstate, particularly in the underdoped region, is dom inated by a variety of not-well-understood cross-over phenom ena that m ay either be precursors to superconductivity or competing states. These include the pseudogap [1], the magnetic resonance [2, 3, 4], the anom alous Nemste ect [5, 6], stripe order [7, 8, 9, 10] and possible superconducting uctuations [11, 12]. The situation is further complicated by the presence of disorder and the practical considerations that lead to a situation where a given cuprate is not investigated with all the available experimental techniques. Ideally, one would like to have a system where disorder is minimized and several experim entaltechniques can be used with the sam e crystals. As a step in that direction we present detailed a-axis optical data on the highly ordered ortho-II phase of YB a_2 C u_3 O $_{6:50}$ (O rtho $\rm II$ Y 123) and compare these data with recent results from magnetic neutron scattering and m icrow ave spectroscopy on crystals from the sam e source.

An important motivation for a comparison between transport properties and the magnetic neutron resonance comes from the observation that the carrier life time, as measured by infrared spectroscopy, is dominated by a bosonic mode [13, 14, 15, 16, 17] whose frequency and intensity, as a function of temperature and doping level, tracks the inelastic magnetic resonance at 41 meV with in-plane momentum transfer of (;) [15, 16]. The magnetic resonance has also been invoked to explain other self-energy e ects such as the kink in the dispersion of angle-resolved photo emission spectra (ARPES) [18, 19, 20, 21] and as a hum p-peak structure in tunneling spectra [22]. These e ects have also been attributed to the electron-phonon interaction [23]. W hile the bosonic excitation m ay not be the fundam entalengine of superconductivity [16, 24], nevertheless it is im portant to m ap out the regions in the phase diagram where it can be found and correlate the various experim ents that yield evidence of its presence.

The YBa2Cu3O7 $_{\rm X}$ (Y123) material has been one of the most thoroughly studied of all the HTSC systems but, like most cuprates, it su ers from disorder associated with the charge reservoir layer, in the case of Y 123, disordered oxygen chains. However, at an oxygen doping level of x = 0.50, an ordered ortho-II phase occurs with alternating full and empty CuO chains, doubling the unit cell along the a-direction, and yielding a well ordered stoichiom etric com pound [25, 26]. A further advantage of this system is the availability of very large crystals, suitable for neutron scattering. A disadvantage of the Y123 system is that the crystals are not easily vacuum -cleaved and as a result, surface sensitive probes such as angle resolved photoem ission or scanning tunneling m icroscopy have been used less with Y123. In contrast B i_2 Sr₂C aC u_2 O $_8$ (B i-2212) cleaves easily and unlike Y 123, can also be overdoped. Optical spectroscopy has the advantage of working on both systems equally well and o ers a bridge between the ARPES surface sensitive experim ents and the large-volum e probe of neutron scattering.

The paper is organized as follows. We start with a brief introduction to the experim entalmethod followed by a presentation of the raw rectance data and an analysis where we use the extended D rude model to extract the various optical constants, in particular the real and

im aginary parts of the scattering rate. To improve the accuracy of the data, we nst remove known features in the conductivity spectra such as the transverse optical phonons and the delta-function response of the superconducting condensate. The measured scattering rates are then compared with a theoretical model. We next discuss the overall results by comparing them with data from other experiments on Ortho II Y 123, in particular recent neutron data [27] on samples from the same source.

EXPERIMENTAL METHOD AND RESULTS.

The detw inned ortho-IIY Ba₂Cu₃O_{6:50} sam ple used in this study was grown by a ux method using BaZrO₃ crucibles [28], annealed under pure oxygen gas ow at 760 °C, and detwinned at 300 °C by applying uni-axial stress of 100 atm along the a-direction [25]. The dimension of the sample is $1.5 \quad 1 \quad 0.2 \quad \text{mm}^3$. The nearly norm al-incident re ectance of the sample was measured over a wide frequency range $(70 - 42000 \text{ cm}^{-1})$ at nine tem peratures between 28 K and 295 K with a Bruker IFS 66v/S Fourier transform spectrom eter with linearly polarized light. A polished stainless steel m irror was used as an interm ediate reference to correct for instrum ental drifts with time and temperature. An in situ evaporated gold Im on the sample was the absolute re ectance reference [29]. The re ectance of the gold lm swas in turn calibrated with a polished stainless steel sample where we relied on the D rude theory and the dc resistivity as the ultim ate reference. An advantage of this technique is that it corrects for geom etrical e ects of an irregular surface. The in situ gold evaporation technique gives an absolute accuracy of the re ectance of better than

0.5~% . For the re ectance data above 14 000 cm $^1\,$ we used alum inum instead of gold as the coating material.

TABLE I: The tting param eters of O rtho IIY 123 re ectance at three tem peratures, T = 28 K, 100 K, and 295 K. The unit of $!_{pj}$, $!_{j}$, and $_{j}$ is cm⁻¹. An extra band for T = 28 K is the super uid band at zero frequency. The extra band for T = 100 K shows additional spectral weight at low frequency at low tem perature (see Fig. 5). The peak S1 splits at 100 K into two components.

Figure 1 shows the raw re ectance data for nine di erent tem peratures in the frequency region from 75 cm $^{1}\,$

to 3000 cm 1 . The inset extends the data up to 42 000 am¹. A strong tem perature dependence is observed in the low frequency range but becom es weaker at higher frequencies. Two speci c features show tem perature dependent am plitudes: a broad shoulder at 400 cm⁻¹ and a less obvious depression in relectance at 175 cm 1 . In addition, signatures of well-known transverse optical phonons can be seen as sharp m in in a in the low tem perature spectra [30, 31, 32]. At low tem perature the overall curvature of the re ectance is negative at low frequencies changing to a positive curvature at high frequency, which gives rise to an in ection point at 700 cm^{-1} . The inset shows the high frequency re ectance with a prom inent plasm a edge at 13 000 cm⁻¹ and a relatively weak tem perature dependence above 25 000 cm 1 .

Figure 2 shows the lowest frequency range on an expanded scale. In addition to the transverse phonons, we observe a new feature at 175 cm 1 , that appears below 171 K, and is denoted S1. The thin lines are the m easured re ectance curves and the solid thick lines are oscillator ts where the phonons have been modeled as D rude-Lorentz oscillators. The electronic background is represented as a broad D rude peak in the norm al state and a two- uid model with an additional delta function at the origin in the superconducting state. The param eters used in the tare shown in Table I. From the t we get a superconducting condensate density of 72 10^6 cm² expressed as the square of a plasm a frequency in cm¹. This corresponds to a penetration depth of 1900 A. In comparison, the recent Gd Zero- eld Electron Spin Resonance (ESR) measurements on samples from the same source yield a penetration depth of 2000 A and are shown as open circles at very low frequency at 28 K [33]. Our estim ated overall error in the absolute value of the relectance of 0.5% translates to a 300A error in penetration depth. W e conclude that our data are in agreem ent with the ESR results, consistent with errors associated with the measurement of absolute reectance. If we assume an overall monotonic variation of the tted curves with tem perature, we can estim ate, from the deviation from this monotonicity, a relative error of 0.2% for the tem perature dependence of the re ectance. Finally, from the noise level of the spectra, estim ated to be 0.05 % at 300 cm 1 and rising to 0.3 % at 100 cm 1 , we can set an upper lim it of 250 cm 1 to the plasm a frequency of any phonon features we could have m issed above 200 cm^{-1} . This lim it would be higher at lower frequencies.

The optical conductivity and the other optical constants were determ ined from the measured a-axis reectance by K ram ers-K ronig analysis [34], for which extrapolations to ! ! 0 and 1 must be supplied. For ! ! 0, the re ectance was extrapolated by assuming a H agen-R ubens frequency dependence in the norm alstate, $(1 R) / !^{1=2}$, and below T_c an $(1 R) / !^4$ extrapolation was used. W e used the oscillator the shown in Fig.2 to investigate the sources of error arising from the low

frequency extrapolations. The re ectance was extended to high-frequency (between 40 000 and 350 000 cm 1) using data from R om berg et al. [35]. Free-electron behavior (R / ! 4) was assumed to hold at higher frequencies.

The top panel of gure 3 displays the optical conductivity for the nine tem peratures, eight in the norm alstate and one in the superconducting state. The optical conductivity can be written as $(!) = i! ((!)_{H})=4$ where $_{H}$ is the dielectric constant at a high frequency (2 eV). At all tem peratures we observe four sharp phonon modes out of the six infrared active phonon modes [30, 31, 32] expected for this polarization of the incident radiation. The phonons have been labelled P1 $\{P4 \text{ in the gure. We tted the optical conductivity of$ these lines with a D rude-Lorentz m odel and found theline intensities to be tem perature independent and of am agnitude expected for transverse optic (TO) phonons.Table I show s the param eters of the m odel.

The bottom panel of gure 3 shows the optical conductivity without the four phonon modes obtained through the subtraction of the tted D rude-Lorentz conductivities from the measured conductivity. Several features stand out. First, there is a prominent onset of conductivity that appears at low tem perature around 400 cm⁻¹. This feature is common to all cuprate superconductors and was identified early on as an onset of scattering from a bosonic mode [13, 14, 36]. Secondly, a strong peak at 180 cm⁻¹, designated S1, grows as the tem perature is low ered. At low er frequencies, below 150 cm⁻¹,

there appears to be an additional strong absorption band, but any structure here must be interpreted with caution since they are derived from re ectance data close to unity which are subject to large system atic errors. Finally, at higher frequencies, there is a broad continuous background absorption that extends up to the plasm a frequency and has been attributed to the in uence of strong correlations [37, 38].

We de ne the e ective number of carriers per copper atom in terms of the partial sum rule: N_{eff}(!) = $\frac{2m V_{Cu}}{e^2} \frac{R!}{0^+} \frac{1}{1} (!^0) d!^0$ where m is the free electron mass and V_{Cu} is the volume per copper atom, 57.7 A³. Figure 4 shows N_{eff}(!) calculated from the optical conductivity. In the frequency region shown N_{eff}(!) increase uniform ly with frequency and temperature in the norm al state.

In the superconducting state at 28 K, shown in Figure 4 as a heavy solid curve, there is a dramatic loss of spectral weight due to the formation of the superconducting condensate. The elective number of carriers per copper atom in the condensate can be estimated from the partial sum rule by subtracting the normal state curve at 67 K from the superconducting curve at 28 K, also shown in the gure. The resulting dilerence curve rises rapidly at low frequency and saturates at a value of N $_{\rm s} = 0.0264$ above 1000 cm 1 . To indicate the result of the superconducting curve at 28 K at the superconduction of the superconduction of the superconducting curve at 28 K.

N $_{\rm s}$ we need to estim ate the norm all state curve at 28 K . W e do this by extrapolating the tem perature dependence in the norm al state to 28 K (see Fig. 5). W ith the corrected value of N_{eff} at 28 K we get a more accurate value of N_s = 0:0276. The condensate density can also be estim ated from the imaginary part of the conductivity provided the contribution from the residual conductivity is not included i.e. N $_{\rm s}^{0} = \frac{m V_{\rm Cu}}{4e^2}$! [2 (!) 2r (!)] = 0:0283 where 2r is the residual quasiparticle conductivity in the superconducting state. Figure 4 shows both N $_{\rm s}$ and N $_{\rm s}^0$ and it is clear that the two curves (when corrected) approach one another closely and the two methods di er by 2.5 % wellwithin our 5 % estimated experimentalerror. There have been several reports of ab-plane spectral weight changes on entering the superconducting state, in other high T_c cuprates [39, 40, 41] at the 1 to 2 %level, but it should be noted that system atic errors in the absolute value of re ectance have a large in uence on the magnitude of both N $_{\rm s}$ and N $_{\rm s}^0$, although the error of the di erence is smaller. We estimate that our error in N $_{\rm s}$ and N $_{\rm s}^{\rm 0}$ is 30 % but less than 5 % in the di erence N_s^0 N_s. Thus, at this point, we are unable to conclude from our data that there is evidence for any added orm issing low frequency spectral weight when the superconducting state form s in the O rtho II Y 123.

Figure 5 shows the tem perature dependence of the partial spectral weight at various frequencies referred to the spectral weight at 300 K.W e note that below 16 000 \times

cm¹ the spectral weight increases as the tem perature is lowered while above this frequency there is a decrease. At 16 000 cm 1 the partial spectral weight is tem perature independent. Since this frequency is close to our estim ate of the lim it of the free carrier conductivity, we conclude that there is a transfer of spectral weight to low frequencies as the tem perature is low ered within the free carrier band on two frequency scales: a lower scale of the order of 500 cm⁻¹ shown by the spreading of the curves in Figure 4, and a higher one of the order of 5000 cm $^{-1}$ that is responsible for the tem perature dependence below 10 000 cm 1 in Figure 5. W e also note here that the tem perature dependence of the partial spectral weight show s no sign of any precursors to superconductivity at 67 K which is 8 K above the bulk superconducting transition tem perature.

The extended D rude modelo ersa detailed view of the charge carrier scattering spectrum and its contribution to the e ective m ass [42]. In this picture the scattering rate in the D rude expression is allowed to have a frequency dependence:

where $!_p$ is the plasm a frequency, 1 = (!;T) is the scattering rate and (!)+1 = m (!)=m, m (!) is an electrive m ass and m the barem ass. We also introduce the optical self energy $_{1}^{op}$ + i $_{2}^{op}$, where 2 $_{1}^{op}$ = ! (!;T) and 2 $_{2}^{op}$ = 1 = . The optical self energy is, apart from a cos() 1 factor, where is a scattering angle, an average over the Ferm i surface of the quasiparticle self-energy [16, 17, 43, 44] as measured by ARPES.C ontrary to expectations, in optim ally doped B i-2212 where both optical and ARPES data exist, the self-energies derived from the two spectroscopies[45] are surprisingly sim ilar to one another [15, 16, 18].

Figure 6 shows the scattering rate calculated from the extended D rude model where 1 = (!;T)

 $2 {}_{2}^{op}(!;T) = \frac{!_{p}^{2}}{4} \operatorname{Re} \frac{1}{(!;T)}$ for 0 rtho IIY 123. We also evaluate the realpart of the optical self-energy, which is given by: $2 {}_{1}^{op}(!;T) = ! (!;T) = \frac{!_{p}^{2}}{4} \operatorname{Im} \frac{1}{(!;T)}$! and is shown in Figure 8. For the calculation of the optical self-energy and the scattering rate we need a value for the plasm a frequency which includes spectral weight up to the interband transitions. Using a procedure adopted in a previous study [46] we nd a plasm a frequency $!_{p} = 15 110 \text{ cm}^{-1}$.

In F ig. 6 we see an overall increase in scattering both with temperature and frequency. The frequency dependence is monotonic with two thresholds, shown with arrows, where the scattering rate undergoes a step-like increase, a prominent low frequency one at 400 cm¹ and

a weaker, higher frequency one at 850 cm 1 . The variation of the scattering rate with tem perature is roughly linear at low frequency, but becomes much weaker at high frequency above the high frequency threshold. The scattering rate is larger than the frequency at all tem peratures except at 28 K in the superconducting state, i.e. h = > h!.

Fig.7 shows the elective optical scattering rate de ned as:

O ne advantage of this quantity is that to calculate it the plasm a frequency is not needed. This quantity is also m ore linear with frequency than the optical scattering rate [47].

In Fig. 8 we show the real part of the optical selfenergy. It is related by K ram ers-K ronig transform ations to the scattering rate shown in Fig. 6. The separation of the two components of scattering is less obvious in this plot but in analogy with the Bi-2212 system where we have investigated the detailed doping dependent data on this quantity [16], we nd that the bosonic mode gives rise to a peak on top of a broader background. With increased underdoping in Bi-2212 the peak becom es triangular and harder to resolve from the background and is very sim ilar in appearance to the 0 rtho II Y 123 data shown here. We can attempt to resolve the peak by focusing on the break in slope that occurs between 1000 cm 1 and 1400 cm 1 in the tem perature range from 28 K to 171 K. Above 200 K the break in slope cannot be resolved. The inset to Fig. 8 shows a plot of the slopes of two straight dashed lines that have been tted to the experim ental data above and below the break frequency.

We nd that a plot of the two slopes shows that they cross at 155 K, i.e. the second derivative of the optical self-energy goes through zero at this tem perature. This is shown in the inset to Fig. 8

Recent calculations [21] of the self-energy of the charge carriers interacting with collective spin excitations suggest that the self-energy acquires an S-shaped frequency dependence in the presence of a sharp mode, whereas in the absence of such a mode the curve has a monotonically negative second derivative. From these observations we conclude, as a rst approximation, that the bosonic mode is con ned to temperatures below 155 K.

For another estim ate of the strength of the interaction of the charge carriers with the sharp mode we used the procedure introduced by M arsiglio et al. [15, 36, 48] where the bosonic spectral function is derived from the second derivative of the optical scattering rate. This function can be written as follows [36, 42, 49]:

and W (!) ${}^{2}F$ (!) at zero tem perature in the normalstate, where is a coupling constant, and F (!) is a bosonic density of states. The results are shown in Fig. 9. The normal state shows two broad peaks; a prominent one at 350 cm 1 and a much weaker one at 800 cm 1 . The higher frequency peak does not change with

tem perature while the lower frequency one growsmonotonically as temperature decreases. Another interpretation is in terms of a temperature dependent peak and a temperature independent background, four times lower in amplitude. In the superconducting state there is a dram atic shift of the lower peak to higher frequency and the development of a region of negative spectral function W (!) between 700 and 1000 cm⁻¹. This behavior has been predicted by A banov et al. [48].

Fig.10 shows the area under the peak S1 as a function of tem perature obtained from a t of a Lorentzian function to the conductivity peak. We see that the intensity of this feature decreases linearly with tem perature going to zero at 200 K. On the same graph we have plotted the area under the neutron resonance and it is clear that the two phenom ena have parallel tem perature dependencies. We note that the spectral weight of the S1 peak, 8000 cm² represents only 0.006 % of the total free carrier spectral weight, 1.25x10⁸ cm².

We note that to obtain a nite frequency absorption peak such as the peak S1, we need to break translational symmetry of the charge carriers. We can rule out phonon absorption which would be inconsistent with the large spectral weight of the peak S1 and the fact the spectral weight is temperature dependent as shown in Fig 10. There are a number of possible candidate mechanism s but we would like to focus on the static chargedensity patterns seen by scanning probe microscopy in Bi-2212 [50, 51]. Models for optical absorption by striplike patterns have been described by Benfatto and M orais

Sm ith [10]. The model describes the optical absorption by charges con ned by a static pinning potential with two parameters, the strength of the potential and the modulation amplitude.

Finally, we show the calculated dc resistivity extracted from the extrapolated zero frequency lim it of the optical conductivity. Figure 11 shows the resulting dc resistivity for the eight norm al state tem peratures. The resistivity shows the fam iliar linear tem perature dependence with an intercept on the temperature axis of 90 K, typical of underdoped samples of high T_c cuprates. A more detailed comparison shows some discrepancies with the best dc transport data [52]. First, our absolute value of the resistivity at 300 K is 0.7 (m cm)¹ while Ando et al. nd, at the sam e doping level, a resistivity of 1.0 (m cm)¹. The second di erence is the value of the resistivity in the low tem perature plateau region just above T_c where Ando et al. measure a residual resistivity of about 200 (om)¹ w hereas our extrapolation yields less than 50 (cm)¹. We think this di erence may originate in the more ordered chain layer in our sam ples which were annealed whereas the sample of Ando et al. were quenched and presumably more disordered. The low er absolute value of the 300 K resistivity is harder to understand since we don't expect inelastic scattering, a mechanism responsible for the high tem perature resistivity, to depend on disorder. One often suspects contact geom etry in dc transport but as Ando et al. have shown, errors from those sources amount to at most a few percent in their data. W here the two data sets are in good

agreem ent is the value of 90 K for the intercept on the tem perature axis.

DISCUSSION

We now turn to a general interpretation of our data in terms of models proposed for the electrodynamics of cuprates focusing our attention on the low frequency spectral region below the free carrier plasm a edge 10 000 cm¹. It is clear from even the most super cial view of the data that the optical properties shown here are not those of a set of free carrier interacting weakly with in purities through elastic scattering or with lattice vibrations through inelastic scattering. Two approaches have been used to account for these deviations, the one and the two component models of conductivity. In the one component model any deviation from the simple D rude form ula are attributed to a single set of charge carriers interacting with a variety of bosonic excitations while in the two component model a low frequency D rude com ponent is separated by curve thing and any remaining absorption is attributed to a mid-infrared band.

There is am ple evidence that m any conducting oxides do have a separate well-de ned mid-infrared band with a peak frequency that moves to low er frequencies with doping [53]. This is also true of the one-layer cuprates, in particular $La_{2x} Sr_x CuO_4$ [54]. In some materials, when the peak reaches zero frequency, striking changes occur in the transport properties, for example, $Ba_1 \times K_x BiO_3$ becom es superconducting at this doping level [55]. Recent evidence from therm al conductivity suggests that $La_{2 \times} Sr_{x}CuO_{4}$ becomes an insulator below a doping level of 0.06 where superconductivity also sets in whereas Y 123 remains in the conducting pseudogap state well below the doping level [56] of the superconductivity boundary. These observations suggest that the one-component to two-component transition occurs at di erent doping levels for these two materials and that the Y 123 system remains metallic to the lowest doping levels. We conclude that, at least at the level of doping of ortho-II Y 123, we are justi ed in using the one-component model.

The striking result of the one-component model is the strong frequency dependent scattering rate 1 = (!;T)shown in Fig 6. There is a nearly perfect linear variation of scattering at high frequency with a strong threshold at 400 cm⁻¹ at low temperatures that gradually washeswith increasing temperature. We will interpret our spectra within the one-component model in terms of a scattering rate that is averaged over the Brillouin zone and is the sum of two frequency dependent terms, a bosonic mode that dom inates at low temperature but whose spectral weight weakens as the temperature rises and a featureless temperature independent background that extends to high frequencies.

Several theoretical models of strongly correlated sys-

tem have been evoked to explain the strong linearly rising frequency dependent scattering rate. Earlier models included the M arginal Ferm i Liquid [57], the N ested Ferm i Liquid m odels [58], the N early A ntiferrom agentic Liquid [38, 59], and the Luttinger Liquid m odel [37]. A ll m odels predict a continuous linear rise of scattering govemed by an energy scale of the order of 0.5 eV. The large energy scale rules out a sim ple phonon m echanism for the broad background scattering which would predict a attening of the scattering rate beyond the m axim um phonon frequency [17]. The strongly tem perature dependent threshold has generally been interpreted in term s of coupling to a bosonicm ode [13, 14], in particular the the 41 m eV m agnetic resonance [15, 16, 17].

Bosonic M ode A nalysis of the Optical Scattering R ate

Here we will adopt the approach of Schachinger et al. [17] and treat both the mode and the continuum scattering on an equal basis assuming that both originate from coupling of the charge carriers to bosonic uctuations.

To study the temperature dependence of the coupling of bosonic modes to charge carriers we used the follow-ing expression to model the scattering rate within the extended D rude form alism :

where $\ ^2F$ () is the bosonic spectral function [60], N (z) is the normalized density of state of the quasiparticles, n_B () = 1=(e $\$ 1), f (z) = 1=(e $\$ z + 1) are the boson and ferm ion occupation numbers, respectively, and = 1=(k_B T).

Eq.4 represents a nite temperature generalization of the T = 0 expression [61],

Eq. 4 is derived using the m ethod proposed by Shulga et al. [62] and its derivation will be given elsewhere [63]. Both Eq. 4 and 5 are suitable for the case when the quasiparticle density of states, N (z), cannot be taken as constant in the vicinity of the Ferm i levels, e.g. in the pseudogap state.

The density of state N (z) was modelled with a pseu-

dogap with a quadratic gap function:

where 1 N (0) is the depth of the gap, (z) is the Heaviside step function, and = 350 cm^{-1} is the frequency width of the gap based on spectroscopic data for the pseudogap from tunneling [64], and c-axis infrared conductivity [65]. An example for a depth of the gap of 0.50 is shown in Fig. 13.

For the bosonic spectral function ${}^{2}F$ () we used the sum of two functions, a peak and a background.

where PK () is a G aussian peak and BG () is the background which we have modelled on the spin uctuation spectrum of M illis, M onien, and P ines (M M P) [38]. A is the area under the G aussian peak, d is the full width at half maximum (FW HM), and $_{\rm PK}$ is its center frequency. We ked the parameters of the G aussian peak to values shown in Table II based on the inelastic neutron scattering results of Stock et al. [66]. I_s is the intensity of the M M P background and $_0$ is the frequency of the background at maximum. The complete bosonic spectral function 2F () used is shown in Fig. 12. It has two adjustable parameters, the amplitude of the G aussian peak A and depth of the pseudogap 1 N (0). All the other parameters have been determined from other experiments.

W e used least squares to t our scattering rate data shown in Fig. 6 to Eq. 4. The amplitude of the MMP background and its center frequency were determ ined by

tting the data at 295 K including only the MMP background in ${}^{2}F$ () with a very shallow gap (see Table II) in the Ferm ion density of states N (z). We xed the background parameters for all other lower temperatures to their 295 K values. For further ts at lower temperatures, only two free parameters were used: the depth of the gap in the density of states and the area under the resonance peak, A. The calculated 1= (!) spectra are compared with the measured data in Fig 15. The dim ensionless coupling constant or mass enhancement factor is de ned as:

The contributions to $_{\rm P\,K}$ and $_{\rm B\,G}$, from the peak and the background as well as other param eters of the m odel are shown in the Table II.

O ne result of our t is the tem perature dependence of the depth of the pseudogap shown in the lower panel of Fig. 13. The depth, we nd, corresponds to a 41 % depression of the density of states at low tem perature decreasing gradually to 17 % at room tem perature. The depth of the pseudogap in the c-axis optical conductivity is m ore pronounced [65] but it is known that c-axis transport is weighted m ore heavily in the antinodal direction where the pseudogap is deeper whereas ab-plane transport ism ore evenly distributed in m om entum space.

Next, we compare our spectral function ${}^{2}F$ () in Fig. 12 with the magnetic susceptibility ${}^{00}(!)$ deter-

m ined by neutron scattering at 6 K (< T_c) by Stock et al. (see inset in Fig. 12). The two sets of curves are very sim ilar although it should be pointed out that our data are in the norm al states and neutron data are in the superconducting state and that the width of our mode has been set equal to that of the neutron resonance mode.

C om paring the relative am plitudes of the peak and the background, we nd a substantial di erence with the neutron data. For the ratio of the background to the peak amplitude our ${}^{2}F$ () at 67 K gives 0.17 while the neutron $^{(0)}(!)$ gives 0.27 in the norm alstate (we estim ated the ratio in the norm alstate from the tem perature dependent intensity of the neutron m ode [27]). The relative am plitude of the peak in our spectra is 63 % stronger than what is seen by neutron scattering. In the absence of a more detailed calculation of the spectral function, this discrepancy is not surprising since the coupling of the charge carriers to spin uctuations involves integrations over the Ferm i surface and we are reporting only on weighted averages. On the other hand our data leaves open the possibility that the high frequency channel of conductivity, that is active in producing our background, is not well described by the MMP spin uctuations. In addition to the relative amplitudes we can also compare the areas under the peak and background spectral functions. There is a sum rule for the area under (!) which is related to our optical function ${}^{2}F$ () by a coupling constant, q^2 . Neutron scattering nds that the area under the spin resonance is about 3 % of the total area. In our case at 67 K this fraction is about 25 % , considerably larger. It can be argued that the coupling to the resonance g^2 could be larger than its background value by a factor of 8. This is reasonable since the resonance is around (,) where the susceptibility is also expected to peak.

In Fig. 16 we com pare three quantities: the total area under the magnetic susceptibility in the 25 to 43 meV energy range from Stock et al. [27], the area under the

peak at 350 cm 1 in the W () 2 F () obtained from the second derivative of 1= (!), and the area under the peak at 248 cm 1 in the 2 F () from our t. We note that the two areas from the two di erent procedures for deriving 2 F () show alm ost identical temperature dependencies. The area under the peak obtained from the m agnetic susceptibility shows a temperature trend sin ilar to those of the optical data.

DISCUSSION AND CONCLUSIONS.

The two channels of scattering of the charge carriers

In analyzing the optical properties of 0 rtho II Y 123 we have adopted the one-component model of conductivity, attributing any deviations from the simpleD rude form ula to inelastic processes. We nd that the high frequency processes are well described by the MMP spectrum of spin uctuations with a temperature dependence that originates in the bosonic occupation numbers, but a tem – perature independent spectral function, while at lower frequencies a strong temperature dependence sets in and the conductivity is well described by the extended D rude

model with a tem perature dependent spectral function.

The two methods we used to estimate the shape and tem perature dependence of the bosonic spectrum gave very sim ilar results. The main contribution to the spectralweight came from a prominent peak at 350 cm 1 which was strongly temperature dependent in strength. From this temperature dependence we identi ed the mode with the neutron resonance which has a frequency of 248 cm⁻¹. The 100 cm⁻¹ discrepancy we attributed to the e ect of the pseudogap in the density of states which, as calculations suggest, has the e ect of shifting upward the frequency of any bosonic mode. To the data, the strength of the mode had to be temperature dependent and the electronic density of states had to have a gap whose depth was also temperature dependent. These observations are in accord with what is known about the norm alstate of underdoped Y 123 from other experim ents.

The properties of the sharp bosonic resonance in the infrared scattering rate agree with the properties of the (;) spin- ip neutron resonance mode. The frequency of the bosonic resonance 248 cm 1 or 31 m eV agrees with the frequency of the neutron mode measured by Stock et al. [27] (provided the pseudogap is included in the model). The tem perature dependence of the strength of the mode also agrees with the neutron measurements on 0 rtho II Y 123 samples from the same source. The total spectral weight of the mode determined from least squares ts drops monotonically with temperature and reaches zero between 200 and 300 K, in agreement with the spectral weight of the neutron mode.

Fig 14 shows separately the two contributions to the scattering rate. We see that the combination of a sharp mode whose strength decreases with temperature and a tem perature independent background solves a long standing problem in the optical conductivity of the cuprates: there is a strong tem perature dependence at low frequencies but above 500 cm 1 the scattering is nearly tem perature independent. In the picture of mode and background, both caused by coupling to bosons, this high frequency behavior is the result of a competition between a rising absorption due to occupancy of the background boson population and a decrease in the strength of the bosonic mode with temperature. This scenario predicts an overall linear tem perature dependence at all frequencies above the tem perature where the sharp mode disappears. There is some evidence for this kind of behavior in the data for La_{2 x} Sr_xCuO₄ which does not have a magnetic resonance but shows a linear tem perature dependence characteristic of bosons both in the dc resistivity [67] and optical scattering rate at high frequency [68].

In sum m ary, we have shown that two optical phenom – ena in O rtho II Y 123 have a close association with the m agnetic resonance as m easured for sam ples from the sam e source. The rst is the onset of scattering associated with a bosonic resonance. This has been suggested by several previous investigators [15, 16, 17, 20], but here, for the rst tim e we base our conclusions on experiments that use crystals with the sam e, well-de ned doping level grow n by the sam e technique.

The second is the low temperature conductivity peak that we have designated S1. Its connection to the magnetic resonance is not obvious since the magnetic resonance by itself is not optically active. One possible mechanism is the growth of in-plane coherence that takes place in this temperature region and has been suggested to be the closely related to the transverse plasm a resonance that is seen in interplane conductivity [69]. The peak S1 m ay be such a resonance associated with inplane charge density modulations either through pinning to defects [10] or through a transverse plasm a resonance associated with the inhom ogeneous charge density that seem s to be present in underdoped cuprates in the norm al state [50, 51].
