⁵⁹C o N M R study of the C o states in superconducting and anhydrous cobaltates

 59 CoNMR spectra in oriented powders of the superconducting (HSC) Na_{0:35}CoO₂,1.3H₂O and Na_{0:35}CoO₂ compounds reveal a single electronic Co state with identical T independent NMR shift tensor. These phases di erm arkedly from Na_{0:7}CoO₂, in which we resolve 3 types of Co sites. The large T variation of their spin susceptibilities $_{\rm s}$ and the anisotropy of the orbital susceptibility orb allow us to conclude that charge disproportionation occurs, in a non magnetic Co³⁺ and two m agnetic sites with about 0.3 and 0.7 holes in the t_{2g} multiplet. The data are consistent with those for the single Co site in the anhydrous and HSC phase assuming the expected Co^{3:65+} charge.

The superconductivity (SC) induced by water insertion in N a_x C oO 2 [1] has led to suggest an analogy with H igh T_c cuprates [2]. Indeed, metallic and magnetic states [3] occur in the phase diagram of these layered transition m etaloxides and the SC, which occurs for a lim ited range of carrier contents [4], m ight be explained by the m agnetic scenarios proposed for the cuprates. The triangular lattice of the cobalt planes introduces a frustration of interactions between Co spins which could be even more favorable than in the cuprates to the form ation of exotic spin ground states [5]. Furtherm ore, cobaltates might display a richer variety of properties due to the two possible C o electronic con gurations (C ∂^+ , S = 0 and C o^{4+} , $S = \frac{1}{2}$) in the high trigonal crystal eld of the CoO_2 plane. A segregation into these 3^+ and 4^+ charges has been suggested [6] and results, at least for x_0 0:7, in a C o charge order correlated with the atom ic arrangem ent of the Na layers [7]. This charge ordered m etallic state, presum ably responsible for the therm oelectric properties [8], should be physically quite distinct from the insulating charge and spin stripe order due to hole localization in som e cuprates [9].

Prior to fully addressing these comparisons, it seems essential to perform atom ic probe determ ination of the Co states all over the phase diagram. This issue is connected with that of the role of H₂O in inducing SC .W hile H₂O insertion should not a priori modify the electronic structure [10], it has been recently proposed [11, 12] that $(H_{3}O)^{+}$ ions increase the doping of the CoO₂ plane from 0.35 to 0.7, so that the electronic properties of the SC would be similar to those of the x₀ 0.7 phase.

In the present work we use 59 CoNMR, in oriented powders in order to probe the electronic properties of the Cosites. The analysis of the NMR shifts enables us to determ ine the orbital susceptibility orb which is directly related to the charge state of the Co. We show for the

rst time [13] that three types of C o states occur in the x_0 phase at variance with the anticipated C o³⁺ /C o⁴⁺ scenario [14]. On the contrary, the x 0.35 sample is found to display a uniform C o^{3:65+} charge state which is not modiled upon water insertion. We therefore stress

the contrast between the electronic properties on the two sides of the x = 0.5 com position. The large anisotropy of ^{orb} found for the hole doped Co sites allows us to propose a scheme to reconcile the con icting data [15,16] reported below T_c in the HSC samples, and to propose singlet SC. Our results open the way for experimental electronic characterization of the various magnetic states found for large Na content [17], and should stimulate realistic band structure calculations.

Two x_0 0:7 and the x 0:35 sam ples were already used in Ref. 7. Their NMR signals did not evolve during the last 18 months. A new x_0 sam ple with negligible Co_3O_4 content has been synthetised. A part of the x 0:35 batch was hydrated into a HSC sam ple (T_c = 3:9 K) and the c axes of the sam ple crystallites were aligned in water in a 7 T applied eld. The sam ple was then frozen and kept below 0 C.

The I= 7=2 nuclear spin of 59 Co both senses the magnetic properties of the Co site and couples through its nuclear quadrupole m om ent Q to the electric eld gradient (EFG) tensor V created by its charge environm ent. The ⁵⁹CONMR signal detected for H kc in the HSC sam ple is the most typical spectrum for a single site for which c is principal axis of the EFG. It is reported in Fig.1 as a recording versus H of the NMR spin echo intensity obtained with a $\frac{1}{2}$ $\frac{1}{2}$ pulse sequence. It displays a set of seven equally spaced peaks sym m etrically arranged around the central $\frac{1}{2}$ \$ $\frac{1}{2}$ transition. The frequency splitting $_{O} = 3eQV_{ZZ} = (h2I(2I \ 1))$ is a measure of the EFG component V_{ZZ} with Zkc. For H ? c the in plane ab axes of the crystallites are random in our samples, which results in a powder spectrum. The lineshape re-

ects then the anisotropy = $j(W_Y - W_{X,X})=V_{Z,Z}$ jofthe in plane components of the EFG. The simulations of the spectra yield $_Q = 4.103 (10) \text{ MHz}$; = 0.22(2), in perfect agreement with NQR existing data [18]. The spectra for the anhydrous x - 0.35 sample are quite similar to that of the HSC sample. The small di erence relates to slight discrete changes of $_Q$ resolved only for H kc. These can easily be attributed to EFG contributions of diverse local arrangements of Na⁺ ions which are negligible in the SC

sam ples due to the larger Na⁺ – Co distances upon water insertion. Remarkably, the spectra in the anhydrous sam ple display a unique central line for all Co sites. Furtherm ore, its anisotropic NM R shifts, which measures the local , are identical and nearly T independent in the two sam ples (K_c=1:9% and K_{ab}=3.2%, see Fig.1 and insert) [19]. This is strong evidence that the HSC and anhydrous sam ples display a quite identical uniform ly charged state, e.g. $Co^{3:65+}$, with no resolvable di erence in local , whatever the Na environment.

The situation is opposite for the spectra of the x_0 0:7 phase which display many di erent Co sites (Fig. 2b) with distinct EFGs and magnetic shifts. To resolve the latter we took spectra with H tilted of $= \{\mathbf{q}^{1}; \mathbf{c}\}$, such that $3\cos^2 = 1$. For that "magic angle" (MA) the quadrupole satellites of the lines with = 0 m erge w iththeir central lines and the quadrupole spectra for $\frac{1}{6}$ 0 are also narrowed (Fig. 2a). Besides the ²³N a signal one can easily distinguish then three Co sites, indexed with increasing shifts Col, Co2 and Co3. The Co2 line has the largest broadening, to be associated hereafter with a large anisotropy of its NMR shift. In Fig. 2a we also show how we contrast the signals of these sites using their very distinct transverse spin spin relaxation time T2. Indeed, a spin echo signal dies away for T_2 , and for a short delay time (s) the MA spectrum displays all sites, while for a long delay time $(_{\rm L})$ only the Co1 and Na signals remain. This reveals that the signals of the "m ore m agnetic" C o2 and C o3 sites have $T_2 < L \cdot O nce$ the Col spectrum is determined with the $(_{\rm L})$ data, it can be rescaled and deduced from the (s) spectrum to isolate the Co2 and Co3 signals ("Di" in Fig.2).

This procedure has been quite powerful in resolving

the spectra for any as exemplied for H kc in the lower part of Fig. 2. The (L) signal for Col is seen to display more than 7 well resolved quadrupolar lines and a full analysis reveals that it consists of the superposition of spectra of two sites Cola and Colb with similar shifts and slightly di erent $_{\circ}$. The spectrum of C o2 and Co3 in Fig. 2c reveals that Co2 consists also of a set of quadrupole lines which also correspond to two slightly di erent sites C o2a and C o2b with $_{0}$ about twice larger than for Col. The highly shifted Co3 component appears on top of the simulated Co2 spectrum. In this Letter, the lower part of Fig. 2 is displayed to let the reader understand the m ethod used, but the param eters listed in Table I result from information taken on more than a hundred spectra at di erent T and H . W e postpone the details on the EFG data to a full technical report and focus hereafter on the physical inform ation extracted from the shifts.

The large T variations of of 59 C o NMR shifts, which re ect the anom alous magnetism of the CoO₂ planes [7], are detected in all cases except for the Col sites for H ? c, as reported in Fig. 3a. For this reason this signal had been attributed to non magnetic Co³⁺ in Ref. 6. We do

nd here that for H kc the Col and Co2 sites exhibit a sim ilar increase of K $_{\rm c}$ with decreasing T , and a larger one for Co3, although less accurately determ ined. For

H ? c; it is harder to resolve the powder spectrum of C o2 similar to that of Fig. 1. We better monitored the anisotropy of the C o2 and C o3 shifts by comparing K $_{\rm c}$ to the isotropic K $_{\rm iso}$ = K =3 obtained from MA spectra.

The macroscopic susceptibility taken in a direction

involves the diam agnetism of the ion cores and the orbital and spin terms splitted in their Co(i) sites components. The NMR shifts of sites i are linked to the ⁰s through speci c hyper ne couplings A

The ⁵⁹Co diam agnetic shift contribution is included in the reference taken [19]. As the ^{23}Na shift [7] is purely due to the T dependent spin term , it is essential to com pare 59 K_i; to 23 K_{iso}. As can be seen in Fig. 3b a linear dependence is found for all sites below 120 K when the Namotion is frozen. So these data con m that all Copertain to the same phase in which a single T variation characterizes the local $\frac{s}{i;}$ (T). The slopes of the linear ts give the relative m agnitude of the spin contributions $K_{i:}^{s} = {}^{23}K$, while their ${}^{23}K = 0$ intercept give the estim ates of the CoorbitalNMR shifts K i. reported in Table I. For comparison SQUID data for m (T) taken in H = 5 T for our oriented sample with minimal C $o_3 O_4$ content, also plotted in Fig. 3b versus ²³K; con m this unique T dependence. These data allow us to separate $^{\rm s}$ (T) from ($^{\rm dia}$ + $^{\rm orb}$), the latter being the extrapolation to 23 K = 0. W ith tabulated values we calculate for $Na_{0:7}CoO_2$ dia = 0:35 and then ab = 3:1(2) and $_{c}^{orb} = 2:3(2)$, in 10⁴ em u/m ole units [20].

This anisotropy of orbital , seen on both the m acroscopic $^{\rm orb}$ and the local K $_{i;}^{\rm orb}$, being m ainly of ionic origin, give us an insight on the ionic states of the Co sites. For a C o³⁺ ionic state, the lower energy t_{2g} triplet levels are led and the ionic shell has a spherical symmetry, so that $^{\rm orb} = 2 \frac{2}{B} =$ is isotropic. Here is

e energy splitting. Holes introduced on the the t_{2q} t_{2g} levels yield modi cations of $_{i;}^{orb}$ which depend of the spatial direction of the populated hole orbitals. Therefore the isotropy of K $_{1;}^{\text{orb}}$ allow s us to assign C o³⁺ to the C o1 site, while the anisotropic values of K_{2}^{orb} and K_{3}^{orb} in ply that Co2 and Co3 have hole contents x_i , which will be estimated from our data. A st relation between the x is given, for $x_0 = 0.7$, by the charge neutrality condition $0.55x_2 + 0.19x_3 = 0.3$; using the fractional occupancies I₁ of the Cosites given in Table I.W ith the rough but sensible assumption that the orbital anisotropy scales with the hole content x_1 , we obtain x_2/x_3 0:44 from the data for K $_{i,jso}^{orb}$ -K $_{i,c}^{orb}$ listed in Table I, which results in charge states $Co^{+3:3(1)}$ and $Co^{+3:7(1)}$ respectively for Co2 and C o3.

In the light of these results we may now reexam ine the anisotropic ⁵⁹Co shift data found hereabove in the x 0:35 samples. As the 0.65 hole content of the $\frac{1}{2}$ g orbital in the latter samples is similar to that estim ated for the Co3 site we m ight expect similar orbital shifts $K_c = 1:6(4)$ %; K_{iso}^{orb} 2:9(1)%, that is K_{ab}^{orb} 3:5(4)%. These values are remarkably close to the total shifts $K_c =$ 1:9%, $K_{ab} = 3:2\%$, reported in Fig.1 in the HSC sample, in which case the spin shifts K ^s are then quite small in the HSC samples. In case of singlet SC these spin shifts are expected to decrease below T_c and to vanish at T = 0. Two con icting reports indicate (i) a decrease from K =3:2 to 2:7% [15] suggesting singlet SC and (ii) no variation ofK = 1:9% [16] pointing tow ards triplet SC. Com paring their norm al state data with ours, it is clear that the authors of (i) and (ii) respectively monitored the H ? c and the H kc central line singularities in partially oriented sam ples. So their results do not contradict each other if the spin shifts are K $_{ab}^{s}$ 0.5% and K_c^s 0. In that case the data of (i) strongly supports spin singlet SC .W e can further notice that K $_{\rm c}^{\rm s}$ 0 would be consistent with our observation (see Table I) that K orb 1:9% is nearly independent of the charge state of the Co. This therefore leads us to suggest that the data are quite consistent and strongly support singlet SC. To conclude on the properties of the HSC phase, we have dem onstrated here that water insertion does not modify the electronic properties for Х 0:35, which contradicts recent proposals [11, 12]. Therefore, the absence of SC in the anhydrous sample could result from a depression of T_c induced by the Na⁺ ion disorder. Even if such a disorder also exists in the HSC samples one can anticipate that it might be screened then by the water layers, and would less a ect the CoO_2 plane carriers.

As for the x_0 0:70 sample we have dem onstrated that the fraction of Co3+ is quite sm all, which totally discards the purely ionic Co^{3+}/Co^{4+} picture, which would presum ably yield a M ott Hubbard insulating state. Our results allow us to establish that extracting Na⁺ from N aC oO 2 rather leads to delocalized states on speci c C o sites, while only a few Co sites remain Co³⁺. This evidence for partial hole lling on C o2 and C o3 sites is more com patible with a metallic state, such as a commensurate CDW state, although a nearly localized behaviour is still required to explain the drastic T variation of the local . We have emphasized here the di erent magnetic characters of the Co sites through the modi cations of K ^{orb}. The spin shifts K $_{i;}^{s}$ do also probe the local magnetism and the fact that K $_{i,iso}^{s} = {}^{23}K_{iso}$ is small (2.3) for Col and increases to 10 and 20 for Co2 and Co3, is in perfect qualitative agreem ent with an increase of hole content on the t_{2q} multiplet for these sites. However a nuclear spin is coupled both to its own electron orbitals giving an on-site hyper ne eld (HF) and to its nearest neighbours (transferred HF). So, further analysis of the K^s_{i:} data require a know ledge of the arrangem ent of the di erently charged C o sites to undertake electronic structure estimates of the hyper necouplings $A_{i:}^s$. Although the EFG 's and the site occupancies will help in this process, special care is presently devoted to secure st the atom ic structure through x rays and neutron investigations, since it is clear that the atom ic arrangem ent of N a is correlated to that of the Co charges.

It is often soundly suggested that the N a1 which sits on top of the Co atom s stabilize the less positively charged $\mathrm{C}\,\mathrm{o}^{3^+}$, so that the role of the N a order could be essential for the physics of the x 0:5 phases. The fact that large high T Curie-W eiss dependencies occur quite generally for x > 0.5 m ight as well indicate that m agnetism is an incipient property of the CoO₂ planes with su cient hole doping on the Co. The subtle N a ordering could also play a second, m ore m arginal 3D role, by favouring caxis couplings between hole doped magnetic Co ions, which m ight explain the diverse low T ordered m agnetic states [17] found for x > 0.75: We believe that the methods used here to determ ine the Co charge states can be applied for other N a ordered phases and should help to resolve these issues. In any case the results of the present work strongly suggest that m agnetic m odels should not consider all C o sites on the same footing and will not be sim ple realizations of H eisenberg spin H am iltonians. F inally, it is of course obvious at this stage that our mainly ionic approach can only be qualitative, as we are dealing with an original organization of C o charges in a strongly correlated band in which carriers avoid som e sites. Further progress will have to aw ait realistic band structure calculations taking into account the correlations, which could reproduce both charge disproportionation and anom alous magnetism .
