### Generalized BBV M odels for W eighted Complex N etworks

W e will introduce two evolving models that characterize weighted com plex networks. Though the microscopic dynamics are dierent, these models are found to bear a similar mathematical framework, and hence exhibit some common behaviors, for example, the power-law distributions and evolution of degree, weight and strength. We also study the nontrivial clustering coe cient C and tunable degree assortativity coe cient r, depending on speci c parameters. Most results are supported by present empirical evidences, and may provide us with a better description of the hierarchies and organizational architecture of weighted networks. Our models have been inspired by the weighted network model proposed by A lain Barrat et al. (BBV for short), and can be considered as a meaningful development of their original work.

#### I. IN TRODUCTION

The recent few years have witnessed a great developm ent in physics community to explore and characterize the underlying laws of complex networks, including as diverse as the Internet [1], the W orld-W ide W eb [2], the scienti c collaboration networks (SCN) [3, 4], and worldwide airport networks (WAN) [5, 6]. Many em piricalm easurem ents have uncovered som e general scale-free properties of those real systems, which motivated a wealth of theoretical e orts devoted to the characterization and m odelling of them . Since Barabasiand A lbert introduced their sem inal BA model, most e orts have been contributed to study the network topological properties [7]. However, networks as well known are far from boolean structures, and the purely topological representation of them will miss important attributes often encountered in realworld. For instance, the amount of trac characterizing the connections of communication systems or large transport infrastructure is fundam ental for a full description of them [8]. M ore recent years, the availability of m ore com plete em pirical data and higher com putation ability perm it scientists to consider the variation of the connection strengths that indeed contain the physical features of m any real graphs. W eighted networks can be described by a weighted adjacency N N matrix, with elem ent w<sub>ij</sub> denoting the weight on the edge connecting vertices i and j. As a note, this paper will only consider undirected graphs where weights are symmetric. A s conrm ed by m easurem ents, com plex networks often exhibit a scale-free degree distribution P (k) s k with 2 3  $[5,\,6].$  Interestingly, the weight distribution P  $\left(\!w\,\right)$  is also found to be heavy tailed in some real systems [9]. As a generalization of connectivity ki, the vertex strength

is de ned as  $s_i$  = i2 (i) wij, where (i) denotes the set of i's neighbors. This quantity is a natural measure of the importance or centrality of a vertex in the network. For instance, the strength in WAN provides the actual tra c going through a vertex and is obvious m easure of the size and importance of each airport. For the SCN, the strength is a measure of scientic productivity since it is equal to the total num ber of publications of any given scientist. Em pirical evidence indicates that in most cases the strength distribution has a fat tail [6], sim ilar to that of degree distribution. Highly correlated with the degree, the strength usually displays scale-free property ssk with 1 [10, 11]. Driven by new empirical ndings, A lain Barrat et al. have presented a simple model (BBV for short) that integrates the topology and weight dynam ical evolution to study the dynam ical evolution of weighted networks [12]. An obvious virtue of their model is its general simplicity in both mechanisms and mathematics. Thus it can be used as a starting point for further generalizations. It successfully yields scalefree properties of the degree, weight and strength, just depending on one parameter BBV that controls the localdynam ics between topology and weights. Inspired by BBV'swork, a class of evolving models will be presented in this paper to describe and study specic weighted networks. This paper is organized as follows: In Section II, we will introduce a tra c-driven model to m in ic the weighted technological networks. A nalytical calculations are in consistent with num erical results. In Section III, a neighbor-connected model is proposed to study social networks of collaboration, with the comparison of simulations and theoretical prediction as well. At the end of each section, we discuss the di erences between the BBV model and ours, from the microscopic mechanisms to observed m acroscopic properties. W e conclude our paper by a brief review and outlook in Section IV.

#### II. MODELA

# A. The Tra c-D riven M odel for Technological N etw orks

The network provides the substrate on which num erous dynam ical processes occur. Technology networks provide large em pirical database that simultaneously captures the topology and the tra c dynam ics taking place on it. W e argue that tra c and its dynam ics is a key role for the understanding of technological networks. For Internet, the information ow between routers (nodes) can be represented by the corresponding edge weight. The total (incom ing and outgoing) inform ation that each router deals with can be denoted by the node strength, which also represents the importance or load of given router. Our tra c-driven model starts from an initial con guration of N<sub>0</sub> vertices fully connected by links with assigned weight  $w_0 = 1$ . The model is de ned on two coupled mechanisms: the topological growth and the increasing tra c dynam ics:

(i) Topological G rowth. At each tim e step, a new vertex is added with m edges connected to m previously existing vertices (we hence require N<sub>0</sub> > m), choosing preferentially nodes with large strength; i.e. a node i is chosen by the new according to the strength preferential probability:

The weight of each new edge is also xed to  $w_0 = 1$ . This strength preferential mechanism have simple physical and realistic interpretations in Ref. [12, 13].

(ii) Tra c Dynamics. From the start of the network growing, tra c in all the sites are supposed to constantly increase, with probability proportional to the node strength  $s_i = \frac{1}{k} s_k$  per step. We assume the grow-ing speed of the network's total tra c as a discrete constant W (each unit can be considered as an information packet in the case of Internet). Then in statistic sense the new ly created tra c in site i per step is

These new ly-added packets will be sent out from ito their separate destinations. Our model does not care their species cic destinations or delivering paths, but simply suppose that each new packet preferentially takes the route-way with larger edge weight (data bandwidth of links), i.e. with the probability  $w_{ij}=s_i$ , and it hence will increase the trac (strength) in the corresponding neighbor j of node i. It is a plausible mechanism in many real-world webs. For instance, in the case of the airport networks, the potential passenger trac in larger airports (with larger strength, often located in in portant cities) will be usually greater than that in smaller airports, and busy airlines often get busier in development. For Intermet, routers

#### B. A nalytical R esults vs. N um erical S im ulations

The model time is measured with respect to the number of nodes added to the graph, i.e.  $t = N = N_0$ , and the natural time scale of the model dynam ics is the network size N. In response to the dem and of increasing trac, the system smust expand in topology. With a given size, one technological network assumably has a certain ability to handle certain trac load. Therefore, it could be reasonable to suppose for simplicity that the total weight on the networks increases synchronously by the natural time scale. That is why we assume W as a constant. This assumption also bring us the convenience of analytical discussion [13]. By using the continuous approximation, we can treat k; w; s and the time t as continuous variables. The time evolution of the weights w<sub>ij</sub> can be computed analytically as follows:

The term  $W_{ij} w_{ij} = s_i$  represents the contribution to weight  $w_{ij}$  from site i. Considering

one can rew rite the above evolution equation as:

The link (i,j) is created at  $t_{ij} = m \text{ ax } (i,j)$  with initial condition  $w_{ij}(t_{ij}) = 1$ , so that

Further, we can obtain the evolution equations for  $s_i\left(t\right)$  and  $k_i\left(t\right)$  :

These equations can be readily integrated with initial conditions  $k_i\left(t_i\right)$  =  $s_i\left(t_i\right)$  = m , yielding

The strength and degree of vertices are thus related by the following expression




FIG.1: The average strength  $s_i$  of the nodes with connectivity  $k_i$  for dierent W (log-log scale). Linear data ttings all give slope 1:00 0:02, dem onstrating the predicted linear correlation between strength and degree.

In order to check the analytical predictions, we perform ed num erical simulations of networks created by the present model with various values of W and minimum degree m. In Fig. 1, we report the average strength  $s_i$  of vertices with connectivity  $k_i$  and con m the validity of Eq. (11).

The time  $t_i = i$  when the node i enters the system is uniform ly distributed in [0;t] and the strength probability distribution can be written as




FIG.2: Cumulative strength probability distribution  $P_c$  (s) with various W . Data agree well with the power-law form s  $^{A}$ . The inset reports  $_{A}$  from data tting (led circles), in comparison with the theoretical prediction  $_{A} = 2 + \frac{m}{2W + m} = 2 + \frac{5}{2W + 5}$  (line), averaged over 20 independent networks of size N = 7000.

where (x) is the D irac delta function. Using equation  $s_i(t)$  (t=i)<sup>a</sup> obtained from Eq. (9), one obtains in the in nite size limit t ! 1 the power-law distribution P (s) s  $_{A}$  (as shown in Fig. 2) with




FIG.3: W eight probability distribution P (w) with various values of W. D at a are consistent with a power-law behavior w  $^{A}$ . In the inset we give the value of  $_{A}$  obtained by data tting (lled circles), together with the analytical expression  $_{A} = 2 + m = W = 2 + 5 = W$  (line). The data are averaged over 20 independent realizations of network size N = 7000.

O by iously, when W = 0 the model is topologically equivalent to the BA network and the value  $_{\lambda} = 3$  is recovered. For larger values of W, the distribution is gradually broader with  $_{\lambda}$  ! 2 when W ! 1 . Since s and k are proportional, one can expect the same behavior of degree distribution P (k) k  $^{\wedge}$  . A nalogously, the weight distribution can be calculated yielding the scale-free property P (w) w  $^{\wedge}$ , with the exponent  $_{\lambda} = 2 + m = W$  (See Fig. 3).

#### C. Clustering and Correlations

A complete characterization of the network structure must take into account the level of clustering and degree correlations present in the network. Information on the local connectedness is provided by the clustering coe – cient  $c_i$  de ned for any vertex i as the fraction of connected neighbors of i. The average clustering coe cient  $C = N^{-1} \frac{1}{i} c_i$  thus expresses the statistical level of cohesivenessmeasuring the global density of interconnected

vertices' triples in the network. Further inform ation can be gathered by inspecting the average clustering  $\cos - \operatorname{cient} C$  (j) restricted to classes of vertices with degree k:

In m any networks, C (k) exhibits a power-law decay as a function of k, indicating that low-degree nodes generally belong to well interconnected communities (high clustering coe cient) while high-degree sites are linked to m any nodes that m ay belong to di erent groups which

are not directly connected (sm all clustering coe cient). This is generally the signature of a nontrivial architecture in which hubs (high degree vertices) play a distinct role in the network. Correlations can be probed by inspecting the average degree of the nearest neighbors of a vertex i, that is,  $k_{nn\,i} = k_i^{1} \, _j \, k_j$ . A veraging this quantity over nodes with the same degree k leads to a convenient m easure to investigate the behavior of the degree correlation function

If degrees of neighboring vertices are uncorrelated, P  $(k^0 k)$  is only a function of  $k^0$  and thus  $k_{nn}$  (k) is a constant. W hen correlations are present, two m ain classes of possible correlations have been identi ed: assortative behavior if  $k_{nn}$  (k) increases with k, which indicates that large degree vertices are preferentially connected with other large degree vertices, and disassortative if  $k_{nn}$  (k) decreases with k. The above quantities provide clear signals of a structural organization of networks in which di erent degree classes show di erent properties in the local connectivity structure. A lm ost all the social networks empirically studied show assortative mixing pattem, while all others including technological and biological networks are disassortative. The origin of this difference is not understood yet. To describe these types ofm ixing, Newm an further proposed som e sim pler m easures, which is called assortativity coe cients [14]. In this paper, we will also use the form ula proposed by New -




FIG.4: The scaling of C (k) with k for various W . The data are averaged over 20 independent runs of network size N = 7000. The inset shows the average clustering coe cient C, depending on increasing W .




FIG.5: A verage connectivity  $k_{nn}$  (k) of the nearest neighbors of a node depending on its connectivity k for dierent W. The data are averaged over 20 network realizations of N = 7000. The assortativity coe cient r depending on W is shown in the inset.

man [14],

where  $j_i$ ,  $k_i$  are the degrees of vertices at the ends of the ith edges, with  $i = 1; \dots, M$  is the total number of edges in the observed graph). Sim ply, r > 0 m eans assortative mixing, while r < 0 im plies disassortative pattern.

In order to inspect the above properties we perform simulations of graphs generated by the model for different values of W, xing N = 7000 and m = 5. In the case of clustering, the model also exhibits properties

which are depending on the basic parameter  ${\tt W}$  . More precisely, for small W , the clustering coe cient of the network is small and C (k) is at. As W increases how ever, the global clustering coe cient increases and C (k) becom es a power-law decay sim ilar to real network data [15]. Fig. 4 shows that the increase in clustering is determ ined by low-degree vertices. The average clustering coe cient C is found to be a function of W , as shown in its inset. This num erical result obviously dem onstrates the important e ect of tra c on the hierarchical structure of technological networks. A nalogous properties are obtained for the degree correlation spectrum . For sm all W, the average nearest neighbor degree  $k_{nn}$  (k) is quite at as in the BA model. The disassortative character em erges as W increases and gives rise to a power law behavior of  $k_{nn}$  (k) k (Fig. 5). The assortativity coe cient r versus  ${\tt W}$  , as reported in the inset of Fig. 5, demonstrates the tunable disassortative property of this model, which is supported by measurements in real technological networks [1]. The qualitative explanations of the correlations and clustering spectrum can be found in [16], and their theoretical analysis appears in [17]. In sum, all the simulation results for clustering and degree correlation, as empirically observed, imply us that the increasing tra c m ay be the driven force to shape the hierarchical and organizational structure of real technological networks.

#### D. Comparison with the BBV model

One may notice that if the parameter W is replaced by  $W = m_{i}$ , then the mathematical framework of our tra c-driven model is equivalent to that of BBV's [16], though the speci c weights' dynam ics are quite di erent between the two. By comparison with  $_{\rm BBV}$  (that is, the fraction of weight which is locally \induced" by the new edge onto the neighboring others), the parameter in our model, with macroscopic perspectives, is the ratio of the total weight increment on the expanding structure (W) to the number of new ly-established links (m)at each time step. It is an important measure for the relative growing speed of tra c vs. topology, and controls a series of the network scale-free properties. Thus, there is an obvious di erence between BBV model and ours: the form er is based on the local rearrangem ent of weights induced by newly added links, while the latter is built upon the global trac growth and the redistribution of weights according to the local nature of network. Noticeably, the weight dynam ical evolution of the BBV model is triggered only by newly added vertices, hardly resulting in satisfying interpretations to collaboration networks or the airport systems. For these two cases, even if the size of networks keeps invariant, coauthored papers will still com e out and airports can becom em ore crow ded as well. In contrast, this di culty for practical explanations naturally disappear in our model, due to its global weight dynam ics. Above all, the tra c-

driven m odel here, without loss of sim plicity and practical senses, has generalized BBV's work and narrowed its applicable scope to technological networks. Based on it, m ore complicated variations of the m icroscopic rules m ay be im plem ented to better m in ic technological networks. Especially worth remarking is that the present em pirical studies on airport networks and Internet indicate the nonlinear degree-strength correlation s k with > 1. In Ref. [16], Barrat et al. proposed the heterogeneous coupling mechanism to obtain this property. This is not di cult to introduce into the present tra c-driven version. Moreover, we nd that the nontrivial weight-topology correlation can also em erge from the accelerating growth of tra cweight [18] or from the accelerating creation and reinforcem ent of internal edges [13, 18].

#### III. MODELB

## A. The N eighbor-C onnected M odel for Social N etw orks

Social networks are a paradigm of the complexity of hum an interactions, which have also attracted a great deal of attention within the statistical physics community. The study of social networks has been traditionally hindered by the sm all size of the networks considered and the di culties in the process of data collection (usually from questionnaires or interviews). More recently, however, the increasing availability of large databases has allowed scientists to study a particular class of social networks, the so-called collaboration networks. The coauthorship network of scientists represents a prototype of complex evolving networks, which can be de ned in a clear way. Their large size has allowed researchers to get a reliable statistical description of their topological and weight properties, and hence reach reliable conclusions of the network structure and dynam ics. In weighted social networks, the edge weight between a pair of nodes can represent the tightness of their connection. The larger weight indicates the more frequency of interaction; e.g. the num ber of co-authored papers between two scientists, the frequency of telephone or em ail contacts between two acquaintances, etc. In addition, it is more probable that two vertices with a comm on neighbor get connected than two vertices chosen at random . Clearly, this property leads to a large average clustering coe cient since it increases the num ber of connections between the neighbors of a vertex. This is already observed in a model proposed by Davidsen, Ebeland Bomhodt [19].

O ur neighbor-connected model starts from an initial graph of N<sub>0</sub> vertices, fully connected by links with assigned weight  $w_0 = 1$ . Its evolution then is simply based on the dynam ics of connecting nearest-neighbors: A t each time step, a new vertex n is added with one primary link and m secondary links, which connect with m + 1 existing vertices (the initial network con guration hence requires

 $N_0 > m + 1$ ). A ctually, the new ly-built connections are not independent, but related with each other. The primary link ( $w_0 = 1$ ) rst preferentially attaches to an old node with large strength; i.e. a node i is connected by the primary link with probability

Then, the m secondary connections (assigned  $w_0 = 1$  each) are preferentially built between the new vertex and m neighbors of node i, with the weight preferential probability

where j 2 (i). A fter building the primary link (n; i), the creation of every secondary link (n; j) is assumed to introduce variations of network weights. For the sake of simplicity, we limit ourselves to the case where the introduction of a primary link on node i will trigger only local rearrangement of weights on the existing neighbors j 2 (i), according to the rule

In general, depends on the local dynam ics and can be a function of di erent param eters such as the weight w<sub>ij</sub>, the degree or the strength of i, etc. In the following, we will simply focus on the case that = const. A firer the weights have been updated, the evolving process is iterated by introducing a new vertex until the desired size of the network is reached.

The above mechanisms have simple physical and realistic interpretations. Once a fresh member joins a social community, he will be introduced to his neighbors or take initiatives to interact with them. Then, his social connections will soon be built within his neighborhood. It is reasonable that the entering of this newmember can trigger the local variation of connections. Take the SCN for example, a scientist joining a research group will often collaborate with both the group director (primary link) and the other group members (secondary links). The scientist's a liation can naturally boost the research productivity of the group and also, enhance the collaborations of othermembers. The above scenario may be a best interpretation of the origin of ourm odel parameter . We use

to control the e ect of the new ly-introduced m ember on the weights of connections among the local neighbors. In the proceeding section, we will see the model also gives a wealth of scale-free behaviors depending on this basic parameter.

#### B. A nalytical and N um erical R esults

A long the analytical lines used in Section  $\Pi$ , one can also calculate the tim e evolution of the strength, weight




FIG.7: Strength probability distribution with m = 3. Data agree well with the power-law form P (s) s <sup>B</sup>. The inset reports <sup>B</sup> from data tting (lled circles) averaged over 100 independent networks of size N = 7000, in comparison with the theoretical prediction Eq. (26) (line).

Integrating with the initial conditions  $k_i (t = i) = s_i (t = i) = m + 1$ , we have

$$s_{i}(t) = (m + 1) \frac{t}{i}$$

$$k_{i}(t) = (m + 1) \frac{s_{i}(t) + 2m}{1 + m + 2m}; \quad (25)$$

which determ ine the scale-free distributions of both strength and degree, with the same power-law exponent

$$_{\rm B} = 1 + \frac{1}{-} = 2 + \frac{1 + m}{1 + m + 2m}$$
: (26)




FIG.8: The average strength  $s_i$  of vertices with connectivity  $k_i$  for di erent with m = 3 (log-log scale). Linear data ttings all give slope 1:00 0:02, con m ing the prediction = 1.

We also perform ed num erical simulations of networks generated by the model with various values of and minimum degree m. As one can see, Fig. 6 and 7 recover the theoretical predictions for scale-free distributions of weight and strength, and Fig. 8 validates the linear strength-degree correlation. It is worth stressing that the empirical evidence in co-authorship networks just indicates the linear correlation s k [6].

#### C. D iscussions

There are two important di erences between the BBV model and our neighbor-connected one, though the latter can be regarded as an interesting variation of the form er. First, in the BBV model the evolution and distributions of such quantities as strength, weight and degree are simply depending on the parameter  $_{\rm BBV}$  which controls the coupling between local topology and weights. In our model, how ever, the evolution and distributions of those quantities are controlled by two parameters ( and




FIG.9: The scaling of C (k) with k for various with m = 3. Their tted power-law exponents all give 0.94 (dashed line). The data are averaged over 100 independent runs of network size N = 7000. The inset shows the average clustering coe - cient C depending on increasing .




FIG.10: The scaling of C (k) with k for various m with = 1. The data are averaged over 100 independent runs of network size N = 7000. The inset shows the average clustering coe cient C depending on increasing m.

m, as rejected in theoretical part), which together determine the e ect of the new node on the local weights and topology. Though we have xed m in most simulations, the role of parameterm should not be ignored. As Fig. 9 reports, the curvature of C (k) is not sensitive to the variations of , but it nontrivially depends on m as shown in Fig. 10. Second, given the same minimum degree, the average clustering coe cient C of our neighbor-connected model (see the inset of Fig. 9) can be much larger than that of BBV 's model or of our M odel A, because the secondary links in M odel B considerably increase the density of triangles within the system. C om pared with the original model, this larger clustering demonstrate an important.




FIG.11: A verage connectivity  $k_{nn}(k)$  of the nearest neighbors of a node depending on its connectivity k for di erent with m = 3. The data are averaged over 100 network realizations of N = 7000. The assortativity coe cient r versus is also reported in the inset.

tant advantage of M odel B in m odelling the sm all-world property of real com plex networks. O ne question arises from the inset of F ig. 10: at rst sight, it m ay be surprising to see that C greatly decreases when increasing the secondary linking number m. A ctually, larger m in

the model means larger minimum degree. When a new node arrives, the number of triangles in the system will increase by m . But for a sm allest-degree node i, its clusterring is  $c_i (m) = 2N_M (i) = m (m + 1)$  where  $N_M (i)$  denotes the num ber of connected neighbors of node i. Therefore, increasing m, we will decrease ci m ore greatly, resulting in the decaying of C. A dm itted ly, there still exists a com m on point which leads to the restriction of M odel B to m in ic and interpret social networks. The degree correlations in both m odels are negative (see the inset of F ig. 11), indicating their disassortative m ixing patten that is opposite in social networks. Is it possible to nd out a uni ed m in in um m odel to characterize both the assortative and disassortative networks? This question is very challenging and appears am ong the leading ones in front of network researchers [8]. Our recent studies may shed some new light on this tackling problem [20]. A nyway, the present neighbor-connected model (though disassortative) has maintained the simplicity of the BBV model and appears as a more speci c version for weighted social networks, considering its larger clustering and clearer hierarchical structure.

#### IV. REVIEW AND OUTLOOK

In this paper, we have presented and studied two evolving models for weighted complex networks. These two models intend to m in ic technological networks and social graphs respectively, and can be regarded as a meaningful developm ent of the original BBV model. Though their specic evolution dynam ics are dierent, allofthem are found to bear sim ilar mathematical structures and hence exhibit several com m on behaviors, e.g. the powerlaw distributions and evolution of degree, weight and strength. In each case, we also studied the nontrivial clustering coe cient C and tunable degree assortativity r as well as their degree-dependent correlations. In such context, we com pared our generalized m odels with the original one, and got several interesting conclusions, which m ay provide us with a better understanding of the hierarchical and organizational architecture of weighted networks. For all the above reasons, we would like to classify these models into a class, within which the BBV's is the rst one and may be the simplest one. It must be admitted that this class of models do not take into account the internal connections during the network evolution, which is yet beyond the scope of this paper. Still, we hope that our generalized work can make this model fam ily more diversi ed and help bring it som e new sights.
