# A new $m$ ethod for determ ining dipole－dipole energy in 1D and 2D system $s$

#### Abstract

An altemative $m$ ethod for com puting dipole－dipole interaction energy in system $s$ of 1D and 2D periodicity like nanow ires，nanotubes and thin $\mathrm{m} s$ is presented．The approach is based on the use of periodic $G$ reen＇s functions that satisfy Laplace＇s equation and are analytically determ ined．The $m$ ethod，when combined w ith short－ranged interaction as in e ective $H$ am iltonian，is sultable for studying nite－tem perature properties of low－dim ensional ferroelectric system s．

## I．INTRODUCTION

In the past decade it $w$ as shown that the nite－ tem perature behaviour of ferroelectric systems like $\mathrm{BaT} \mathrm{O}_{3}$ can be successfully sim ulated by using the sta－ tisticalm echanics of an $E$ ective $H$ am iltonian，which，in its tum，is based on the rst－principles calculations of to－ tal energies for sm all distortions of the high－tem perature cubic structure．Such an approach predicts sequence of phase transform ations，electrom echanical responses and other nite－tem perature properties in a good agreem ent w th experim ent．

The conventionale ective rst－principles H am iltonian approach is developed for the bulk system $s$ in nitely re－ peated in all three $C$ artesian directions（3D case）［1］ Form ally it can also be applied to the system swhich are e ectively in nite only in one or two dim ensions sim－ ply repeating them $m$ any tim es in nite direction（s）（in this case su ciently thick vacuum gap（s）m ust be created betw een periodic replicas）．Such a procedure，how ever， inevitably leads to errors in depolarizing electric elds and in corresponding shape－dependent electrostatic en－ ergy $\bar{\sim}$ tem $s$ w ith three－to that w ith two－and one－dim ensional periodicity the part of the e ective H am iltonian con－ nected w ith long－range dipole－dipole interactions should bemodi ed．
$T$ he existing $m$ ethods for rapid evaluation of dipole－
 tem $s$ are based on Ewald type sum $m$ ation technique ex－ ploiting the integral representation of the Gam m a func－ tion（or Euler＇s integral）and Poisson sum $m$ ation for－ mula．This technique leads to fast convergent sum $s$ in real and reciprocal spaces，which，how ever，are rather bulky．

H ere，we present a new elegant $m$ ethod for the treat－ $m$ ent ofdipole－dipole interaction in partially periodic sys－ tem swhich leads to much simpler nal expressions than the Ewald technique．T he m ethod is based on using the analytically determ ined periodic $G$ reen＇s function of the Laplace＇s equation $G\left(r^{0} ; r\right)$ ．The simplicity of our nal expressions is partly due to the fact that we do not use Ewald type transform ations in 1D case at all，whereas in 2D case we use it only for the special case when the the interacting dipoles lay in the sam e plane．$T$ he other
reason com es from the fact that we perform the sum $m$ a－ tion ofdipole－dipole interactions（from dipoles located in di erent unit cells）entirely in reciprocalspace\｛ w ith the only exception for the 1D case w hen the dipoles lay along the line parallel to the periodicity direction．

> II. D IPOLE D IPOLE INTERACTIONS IN
> SYSTEMSW ITH 1D AND 2 D P PRIOD IC ITY

W e regard the system swith 1D and 2D periodicity as in nite in one and tw o of the three C artesian directions correspondingly．T hey can be obtained by replicating a ＂unit cell＂an in nite num ber of tim es along that direc－ tions．The dipole－dipole interaction energy can be w rit－ ten as

$N$ ow our task is to evaluate $G\left(r ; r^{0}\right)$ and then $E_{\text {dip }}$ for $1 D$ and 2D cases according to ( $\overline{4}$ ).

> A. 1D case

Let $z$-axis to be along the in nite dim ension, then all the vectors $R_{k}$ lay in it. $W$ e represent each vector $r$ as decom posed into two com ponents $f$; zg, where is the projection of the $r$ on the ( $x ; y$ ) plane. A ccordingly, the $D$ irac functions ( $r \quad r^{0}+R_{k}$ ) in the right-hand side of Eq. $(\bar{\sigma})$ ) become ( $\left.{ }^{0}\right)\left(z \quad z^{0}+R_{k}\right)$. The 2D and the sum of 1D D irac functions can be expressed as Fourier integral and sum correspondingly:

$w$ here $k$ ? is the 2D wave-vector perpendicular to the $z-$ direction, $a$ is the period along this direction, and $\mathrm{G}_{\mathrm{k}}$ are the reciprocal lattice vectors corresponding to the 1D lattice of repeated cells. W e shall look for the G reen's function in the form

where $K_{0}(x)$ is the 0-th orderm odi ed Bessel's function of the im aginary argum ent. Since the Bessel function $K_{0}(x)$ decays exponentially for large argum ent $x$, the series over $G_{k}$ (111) converge $m$ uch faster than the direct lattice sum [1]). This is valid only for the contributions to $E_{\text {dip }} w i$ th $i{ }_{j}$. As to contributions com ing from the dipole-dipole interactions w ith $i=j$ or, in other words, from the chains of dipoles parallel to the $z$-axis, they can be easily calculated in the real space; the corresponding 1 D sum s are rapidly convergent like $1=\mathrm{n}^{3}$. M oreover, doing so one can autom atically solve the problem of excluding of the "self-interaction" term from the sum (క్ర -

$w$ here the prim $e$ at the sum $m$ eans that the term $n=0$ is to be excluded for the case $i=j$. The last sum in (12ㄱ) describes the contribution to the energy associated w ith the chains parallelto the z -axis; this contribution is separated from the rst two sum sm arked by the prim es. $N$ ote that the function $\left.f\left(\dot{z}_{i j}\right\rangle\right)$ is periodical in real space w ith period a. It is also worth noticing that the term $G_{k}=0$ does contribute to the sum (12). If all $d\left(r_{i}\right) k$ to $z$, this contribution tums to zero. In the $m$ acroscopic lim it it describes the energy connected $w$ ith the depolarizing eld.

> B. 2D case

Consider a slab or thin m with norm al along the $z$-direction, each layer of which representing an in nite array of electric dipoles in the ( $\mathrm{x} ; \mathrm{y}$ ) plane. For this geom etry the vectors $R_{k}$ form a 2D lattice parallel to this plane. The corresponding $G$ reen's function, as easily to show acting sim ilar to the previous case and using the

where $S$ is the prim tive unit sell area [ $\left.{ }^{[1}{ }^{-1} 1\right]$, parallel to the slab plane, $G_{k}$ are the reciprocal lattice vectors corresponding to the 2 D lattice and $=\mathrm{fx} ; \mathrm{yg}$. By inserting (15) into (4) it can be show $n$ that only the contributions to $E_{\text {dip }} w$ th $z_{i} \not z_{j}$ exponentially converge as $G_{k}$ increases (com pare w the 1D case). The term $s$ with $z_{i}=z_{j}$ describing the dipole-dipole interactions in the $z-$ layers need additional care; we separate these term $s$ and denote them as A. Now instead of Eq. $T$ he prim e at the second sum in (1]) indicates the term $s$ w ith $\mathrm{z}_{\mathrm{ij}}=0$ to be dropped. To evaluate these term s (collected together in A ) w e apply the E w ald type transform ation to the $G$ reen's function ( 1 근) representing it in both coordinate and reciprocal spaces:
