#### Abstract

W e consider a strongly interacting B ose $E$ instein condensate in a spherical harm onic trap. The system is treated by applying a slave-boson representation for hard-corebosons. A renorm alized $G$ ross $P$ itaevskiitheory is derived for the condensate w ave function that describes the dilute regim e (like the conventionalG ross $P$ itaevskii theory) as well as the dense regim e. W e calculate the condensate density of a rotating condensate forboth the vortex-free condensate and the condensate $w$ ith a single vortex and determ ine the critical angular velocity for the form ation of a stable vortex in a rotating trap.

## 1. Introduction

In this paper we shall study two aspects of a strongly interacting Bose gas at high density. O ne is related to a consistent treatm ent of a strongly interacting B ose gas in term $s$ of an e ective $G$ ross $P$ titaevskii (GP) Eq. w ith renorm alized param eters. The second aspect is related to the form ation of a vortex in a trapped condensate in the presence of strong interaction.

The stationary form of the conventional GP Eq.

describes the condensate order param eter of B ose gas in a trapping potential at zero tem perature, where is the chem ical potential and $g$ the repulsive coupling constant [1, [2, 3]. In the absence of a trapping potential, a solution of Eq. (1) is given by

$T h$ is describes a linearly increasing condensate density (the latter is proportionalto $j j^{2}$ ) w ith respect to the chem ical potential. A though it takes the repulsion into account by a factor $1=g$ which is decreasing $w$ ith increasing coupling constant $g$, the saturation of $n_{0}$ cannot be seen in this solution. From the physical point of view, in a realistic description for large densities, the particle density $m$ ust saturate because there is a nite scattering volume around each particle. Furtherm ore, for increasing particle density, the condensate density should reach a m axim um and for even larger densities, decrease again until its totaldestruction, because of the increasing interparticle interaction. This behaviour has also been found by variationalperturbation theory [4] and di usion M onte Carlo calculations [5]. In other words, the strong e ect of the repulsion in a dense condensate is not really described by the conventional GP Eq. In order to describe condensates at higher densities, the second order term in the low-density expansion of the energy density has been taken into account which lead to a modied GP theory [1, 5, 6, 6, 7].

A though in $m$ any experim entally realized situations the BEC is in the weakly interacting regim e where it is well described by GP theory, it might be possible to reach the strongly interacting regim $e$. The $m$ ain problem at high particle densities is the instability of the Bose gas by the form ation of $m$ olecules due to three-particle interactions [8]. Here, we w ill assum $e$ that $m$ olecule form ation does not occur. This $m$ ight be unrealistic for som e system $s$, but in others it is not, e.g. for Bose gases in optical lattioes.

It has been shown that the slave-boson approach to a hard-core B ose gas provides a m ean- eld Eq., sim ilar to the GP Eq., that leads to a saturation of the condensate $n_{0} \quad 1[9,10,11,[12,13]$. H ere we will discuss a sim pli ed version of this m ean-eld equation which is the sam e type of nonlinear Schrodinger Eq. like in the GP approach. H ow ever, in contrast to the latter the param eters are renorm alized such that Eq. (2)

$w$ here the renom alized param eters $R_{R}$ and $g_{R}$ are functions of the bare param eters and $n_{0}$. At the phase transition betw een the non-condensed B ose gas and the BEC $\quad$ R vanishes, then increases linearly w ith increasing, reaches a maxim um and decreases again until the condensate is destroyed totally due to strong interaction e ects. W e use this approach to calculate the condensate density pro le of a trapped BEC.

The formation of vortices in a rotating condensate is understood as a local destruction of the condensate. From the depletion e ect due to strong interaction it can be anticipated that the tendency of vortex form ation is enhanced in a dense B ose gas. This im plies a reduction of the critical angular velocity $c w$ ith increasing density by the interaction. Vortex form ation in rotating traps in the region beyond the validity of G P has also been studied by the m odi ed G P theory and by variationalM onte C arlo m ethods [7].

The paper is organized as follow s: In the follow ing section we survey the results of the slave-boson approach for a hard-core B ose gas on a lattice and derive a corresponding $m$ ean eld theory for a continuous system in an extemal trap potential. Then we derive the renorm alized G P Eq. and evaluate solutions with and without a straight vortex and determ ine the critical angular velocity for the vortex form ation.

## 2. The M odel

The slave-boson representation of a strongly interacting B ose gas is based on the idea that the bosons ll the space with nite density, where each particle occupies a lattice cell related to a sphere $w$ ith radius $a_{s}$ (s-w ave scattering length) [10]. Singly occupied and em pty sites are described by two com plex elds $\mathrm{b}_{\mathrm{x}}$ and $\mathrm{e}_{\mathrm{x}}$, respectively [11]. Here, $b_{x}$ and $b_{x}$ represent a creation and annihilation process of a boson at site $x$, while $e_{x}$ and $e_{x}$ represent the creation and annililation of a \hole". In the functional integral representation [14], the grand canonicalpartition function in classical approxim ation is given as

is the nearest-neighbour tunneling rate and $x=\quad V_{x}$ is the space-dependent chem ical potential that includes the trapping potential $V_{x}$. Instead of $x$ we will write only subsequently and assum e im plicitly that the e ective chem ical potential can depend on

space. The elds e and b are dim ensionless. M oreover, we rescale all physical energies by a multiple of the hopping rate $J$ to obtain dim ensionless quantities:

The hopping term is quartic in the eld variables, due to the fact that a hopping process is characterized as an \exchange process" of a boson and an em pty site. The function enforoes the constraint that each lattioe site is either singly occupied or em pty but excludes a m ultiple occupation.

A sim ilar approach has been applied to the B oseHubbard model which allow s multiple occupation, by introducing additional elds, one for each occupation num ber [12, [13]. The well-know $n$ zero-tem perature phase diagram $w$ th M ott-insulating phases for integer lattice llings $n=0 ; 1 ; 2 ;::$ ( $(\backslash \mathrm{lobes} ")$ was found. In contrary, our hard-core B oson m odel is restricted to the tw o lattice llings $\mathrm{n}=0 ; 1$ which is a simpli cation, but contains all relevant aspects of Bose $\pm$ instein condensation $w$ ith repulsive interaction. A second simpli cation of our approach is, that we neglect quantum uctuations by treating the grand-canonical partition function in classical approxim ation. This allow s us to integrate out the constraint exactly. On the other hand, it restricts the applicability of our approach to non-zero tem peratures.

Two new elds are introduced by a Hubbard-Stratonovidh transform ation, the complex eld $x$ which describes the condensate wave function, and the real eld 'x which is related to the total density ofbosons [10]:

Integration over the elds and' leads badk to Eq. (3). On the other hand, the elds $\mathrm{b}_{\mathrm{x}}$ and $\mathrm{e}_{\mathrm{x}}$ can be integrated out in (5) because they appear in the exponent as quadratic form S . $T$ his leads to the partition function

W e apply a saddle-point approxim ation to the integration in Eq. (6) . This is controlled by the $m$ inim ized action, which $m$ eans that we have to solve the equation

In order to derive a m ean-eld equation which is applicable to a continuous trapping potential, we perform the continuum approxim ation of (11). If the eld $r$ is varying only very slow ly betw een neighbouring lattioe sites, we can approxim ate

for the spacially dependent order param eter ( r ) in a three-dim ensional space and a is the lattioe constant of the discrete system. In the continuum a looses its identity as lattioe constant, but describes a characteristic length scale in Eq. (12), and can be interpreted as the spacial extension of a boson. Thus, it should be of the sam e order of $m$ agnitude as the $s$ w ave scattering length $a_{s}$ (1]. Eq. (12) is the analogue of the GP Eq. in the case of our slave-boson approach. The param eters can be identi ed with those of the conventionalGP Eq.: Them ass $m$ of the particles is given by the hopping constant $J$ and the lattioe constant a via

A fter neglecting the term of order $j j^{6}$ in the expansion (15), we get the renorm alized G rossP itaevskii (RGP) Eq.

It has the sam eform as the conventionalGP Eq. (1), when and $g$ are replaced by $R$ and $g_{R}$. Their -dependence is plotted in F ig. (1). In the case of a trapping potential, where the chem ical potential is space-dependent, $R$ and $g_{R}$ are space-dependent aswell. $W$ hile $g_{R}$ is always positive, $R$ can change sign. A BEC exists if $R_{R}>0$. The phase transition betw een the BEC and the non-condensate phase, i.e. the point at which the condensate order param eter vanishes, is given by the relation ${ }_{R}(; J)=0$.

## 4. R esults

### 4.1. Zero-tem perature result

In the zero-tem perature $\lim$ it we can integrate out the' - eld in Eq. (8) exactly by a saddle-point integration, as shall be show $n$ in this paragraph. T herefore, we w rite

The solution of the $m$ ean- eld equation is plotted in $F$ ig. 2 for zero-tem perature and near the critical tem perature $T_{c}$ where the BEC breaks down. In the dihute regim e at $T=0$, the chem icalpotential can be written as $=J+$, where $J$. In this lim ting case we nd $R=\quad+O\left({ }^{2}\right)$ and $g_{R}=2 J$, which is consistent with the conventionalGP Eq. w ith a shifted chem ical potential.

### 4.2. V ortex-firee trapped condensate

A ssum ing a dense condensate, w here the repulsive interaction betw een bosons dom inates their kinetic energy, we neglect the di erential term in Eqs. (12) and (14). This is called the $T$ hom asFerm i (T F ) approxim ation [1]. In the follow ing we use a sphericaltrapping potential

In typical experim ents, the oscillator length $d_{h o}=\frac{q}{h=m!_{h o}}$ is of the order of a few $m$ [1], where ! ho is the trap frequency m easured in Hz . C onsidering, for instance, ${ }^{85} \mathrm{R} . \mathrm{b}$ atom s near a Feshbach resonance [15], we can study a B ose gas in a dense regim e w ith a scattering length $a_{s}$ a 200 nm . In our calculations we choose the param eters

and keep the hopping constant $J$ xed. Thus all energies can be scaled $w$ ith $J$.
To calculate the pro le of the condensate density in a B EC w thout vortex, we solve the TF equation

Solutions for typical values of the param eters are plotted in Fig . 3. T he results we get from the renorm alised GP approxim ation shows only $s m$ all deviations from the num erical solutions of Eq. (24). W e nd a condensate depletion at the trap center for ${ }^{0}=1$. This is due to the fact that the condensate is partly suppressed by strong interaction e ects [4, 5, 11]. For ${ }^{0}=2$ the condensate is com pletely destroyed at the trap center. W e nd particle numbers in the condensate of the order $\mathrm{N}_{0} \quad 10^{6}::: 10^{5}$.
$W$ e note that the total particle density $n_{\text {tot }}$ is $m$ uch larger than the condensate density $n_{0}$ and takes values of about $0: 5 \mathrm{a}^{3}$ at the trap center. Thus the interaction betw een the non-condensed and the condensed part of the B ose gas plays a signi cant role. This im plies that the conventionalG P Equation, which neglects the non-condensed part, is not reliable in this param eter regim e.

### 4.3. R otating condensate w ith a single vortex

In the case of a trap rotating about the $z$-axis $w$ ith an angular velocity, one must include the additional angular $m$ om entum term $\quad L_{z}(r)$ to the left hand side of the di erential equation (12), where $L_{z}$ is the $z$-com ponent of the angular $m$ om entum operator. This term must also be kept in the TF approxim ation. The condensate wave function $m$ ay develop a vortex then. W e assum e here a straight single vortex along the $z$-axis. $T$ his can be described by using cylindrical coordinates and the ansatz

A condensate that is rotating with given angular velocity form sa stable vortex, if its total energy is low er than that of a vortex free condensate. This is equivalent to the condition

which can be checked num erically by using the TF approxim ation of Eq. (14) for a condensate $w$ th vortex $S_{F T}^{v o r t}()$ and $w$ thout vortex $S_{T F}$. The critical angular velocity
c above which the vortex is stable is plotted against the num ber of condensed bosons $\mathrm{N}_{0}$ in F ig. 4, where $\mathrm{N}_{0}$ is given as

The RGP approxim ation is in good agreem ent with the results of the full mean-eld equation. The decreasing criticalangular velocity for higher values of $N_{0}$ indicates that a high interaction energy favours the form ation of a vortex. It agrees w ith results derived from the GP Eq. by perturbation theory [16] as well as num erically [17].

Typical solutions for shapes of condensate density pro les of BECswith a stable single vortex are shown in Fig. 5. In contrast to the case without a vortex, the condensate is alw ays com pletely destroyed at the trap center, a feature that also show $s$ up in the conventionalG P approxim ation [1]. A gain, the RGP approxim ation is in good agreem ent $w$ th the num erical results from (26).

## 5. C onclusion

The slave-boson approach allowed us to study the condensation of a trapped highdensity Bose gas in a regim e where the conventional G ross P itaevskii approach is not valid. Starting from the saddle-point approxim ation, we have derived a renom alized G ross P itaevskii Eq. w ith a space dependent coupling constant. This provides good results in com parison $w$ th the $m$ ore com plicated slave-boson saddle-point calculations. At high densities, we have found a depletion of the condensate at the trap center due to the interaction betw een the condensate and the non-condensate part of the B ose gas. T his feature is not covered by the conventional G ross P itaevskii Eq . The behaviour of the critical angular velocity for the form ation of a single vortex agrees qualitatively w ith previous results in the literature but supports also the form ation of a vortex for increasing $\mathrm{N}_{0}$.
