JORDAN-W IGNER APPROACH TO DYNAM IC CORRELATIONS IN 2D SPIN $\frac{-1}{2}$ M ODELS)

We discuss the dynamic properties of the square-lattice spin- $\frac{1}{2}$ XY model obtained using the two-dimensional Jordan-Wigner fermionization approach. We argue the relevancy of the fermionic picture for interpreting the neutron scattering measurements in the two-dimensional frustrated quantum magnet C s₂C uC l₄.

Dynam ic properties of two-dim ensional quantum spin models have attracted considerable attention from both experim entalists and theoretists. Am ong recent experim ental studies in this eld the neutron scattering on $C s_2 C u C l_4$ [1, 2, 3, 4] seems to be very intriguing. $C s_2 C u C l_4$ is a two-dim ensional low-exchange quantum magnet. The two-dim ensional character arises owing to the layered crystal structure, whereas the in-plane superexchange routemediated by two nonmagnetic C l ions provides a small exchange interaction (1 4 K) between $C u^{2+}$ ions carrying a spin of $\frac{1}{2}$. In each layer the exchange paths form a triangular lattice with nonequivalent interactions along chains (J) and along zig-zag bonds (J^0). The minimal H am iltonian which determines the magnetic order is the two-dimensional H eisenberg H am iltonian

where the rst term describes the noninteracting chains (J = 0.374(5) m eV) and the second one describes the interchain coupling (J⁰ = 0.34(3)J). The interlayer coupling is small J⁰ = 0.045(5)J and it stabilizes the long-range magnetic order below $T_N = 0.62(1)$ K. The neutron scattering measurements in the spin liquid phase (i.e. above T_N but below J, J⁰ when the two-dimensional magnetic layers are decoupled) clearly indicate that the dynamic correlations are dominated by highly dispersive excitation continual which is a characteristic signature of fractionalization of spin-1 spin waves into pairs of deconned spin- $\frac{1}{2}$ spinons. Linear spin-wave theory including one—and two-magnon processes cannot describe the continuum scattering.

Two theories of the dynam ical correlations in the spin liquid phase in $C s_2 C u C l_4$ have so far been proposed. A quasi-one-dimensional approach [5] starts from antiferrom agnetic Heisenberg chains along the strongest-exchange direction in the two-dimensional triangular planes (thus immediately introducing spinon language) and perturbatively treats all other terms in the Hamiltonian. Note, however, that the coupling between chains is relatively large. A nother approach is based on the explicitly two-dimensional resonating-valence-bond picture in which spinons appear to be two spin- $\frac{1}{2}$ ends of a broken singlet bond that separate away through bond rearrangement [6, 7].

In what follows we discuss the two-dimensional Jordan-W igner ferm ionization approach to dynamic correlations [8] which eventually may capture the physics in spin liquid phase as well. To be speciet, we consider a simpler square-lattice spin- $\frac{1}{2}$ X Y model denied by the Hamiltonian

Here J (J_2) is the exchange interaction in the horizontal (vertical) direction. We are interested in the zz dynam ic structure factor

Perform ing the transform ation to spinless ferm ions [9],



and adopting the m ean-eld treatm ent of the phase factors w hich appear in (2) we arrive at the H am iltonian

which can be diagonalized by the Fourier and Bogolyubov transform ations. The zz correlation function which enters (3) is the density-density correlation function in ferm ionic picture (5); it can be calculated with the help of the W ick-B loch-de D om inicis theorem . As a result we get




Fig. 1. S_{zz} (k;!) (6) of the square-lattice spin- $\frac{1}{2}$ X Y m odel (2) with J = 1, J_? = 0:3 at zero tem perature. Frequency shapes are shown along $k_x = \frac{1}{4}$, $k_y = 0$ (a), $k_x = \frac{1}{2}$, $k_y = 0$ (b), $k_x = \frac{3}{4}$, $k_y = 0$ (c), $k_x = -$, $k_y = 0$ (d), $k_x = 0$, $k_y = -$ 2 (e), $k_x = -$ 2, $k_y = -$ 2 (f), $k_x = -$ 3, $k_y = -$ 2 (g), $k_x = 0$, $k_y = -$ 3 (h), $k_x = -$ 3, $k_y = -$ 3 (i), $k_x = -$ 3, $k_y = -$ 5 (j).

where C = $\cos\frac{q+k}{2}\frac{q}{2}$, $\cos_k = \frac{J_2\cos k_y}{k}$, $k = \sqrt{J^2\sin^2k_x + J_2^2\cos^2k_y}$ and n_k is the Ferm i function. The zz dynam ic structure factor (6) similarly to the one-dimensional cases [10] is conditioned by particle-hole pair excitations. This two-ferm ion excitation continuum implies nonzero values of S_{zz} (k;!) only in the restricted k {! region with a sharp high-frequency cuto . Within the excitation continuum S_{zz} (k;!) exhibits severalwashed-out excitation branches, in particular, the spin wave [8]. The representative scans throughout the Brillouin zone of the zero-tem perature S_{zz} (k;!) plotted in Fig. 1 show an extended structure and, at

least at a qualitative level, strongly resemble some features of the frequency shapes measured by neutron scattering in $C >_{\mathcal{D}} C u C \mid_{4}$ (see Fig. 6 of Ref. [4]).

To sum m arize, we have com puted the zz dynam ic structure factor of the squarelattice spin $\frac{1}{2}$ X Y model using the two-dimensional Jordan-Wigner fermionization approach. The dynamic structure factor exhibits both sharp particle-like peaks and extended continuum pro les in the constant wave vector frequency shapes which arise owing to particle-hole excitations. Such features which have been observed experim entally in Cs2CuCl4 appear im mediately within the two-dimensional Jordan-Wigner ferm ionization approach that is obviously an attractive feature of this scheme. One may also expect that in the limit of small interchain interaction this approach works well since it contains the exact result if $J_2 = 0$ (or J = 0). Note, however, that this is not a perturbation theory with respect to the interchain interaction. The main shortcoming of the exploited approach is a poorly controlled m ean-eld treatm ent of the phase factors that arise after inserting (4) into (2). New theoretical work is needed to go beyond this approximation [11]. Another challenge is to clarify whether such a theory is capable of capturing the physics in spin liquid phase in Cs, CuCl. For this purpose the calculations should be repeated for the Heisenberg model on a triangular lattice (1) (probably with the Dzyaloshinskii-M oriya interaction [3]). We have left this problem for future studies.
