# P ressure { induced am orphization, crystal { crystal transform ations and the m em ory glass e ect in interacting particles in two dim ensions

W e study a model of interacting particles in two dimensions to address the relation between crystal-crystal transform ations and pressure-induced am orphization. On increasing pressure at very low tem perature, our m odel undergoes a m artensitic crystal-crystal transform ation. The characteristics of the resulting polycrystalline structure depend on defect density, com pression rate, and nucleation and growth barriers. We nd two di erent limiting cases. In one of them the martensite crystals, once nucleated, grow easily perpendicularly to the invariant interface, and the nal structure contains large crystals of the di erent m artensite variants. Upon decom pression alm ost every atom returns to its original position, and the original crystal is fully recovered. In the second lim iting case, after nucleation the growth of martensite crystals is inhibited by energetic barriers. The nalm orphology in this case is that of a polycrystal with a very small crystal size. This may be taken to be am orphous if we have only access (as experim entally m ay be the case) to the angularly averaged structure factor. However, this X -ray am orphous' material is anisotropic, and this shows up upon decom pression, when it recovers the original crystalline structure with an orientation correlated with the one it had prior to compression. The memory e ect of this X-ray am orphous material is a natural consequence of the memory e ect associated to the underlying martensitic transform ation. We suggest that this kind of mechanism is present in many of the experimental observations of the m em ory glass e ect, in which a crystal with the original orientation is recovered from an apparently am orphous sample when pressure is released.

I. IN TRODUCTION

Several crystalline materials are known to become am orphous under changes of the am bient pressure,<sup>1,2,3</sup> and this may occur under compression or decompression. Am ong the most thoroughly studied cases, due to its technological or geophysical importance, we nd H<sub>2</sub>O, SiO<sub>2</sub>, GeO<sub>2</sub>, A  $\mathbb{P}O_4$  and other isostructural compounds. The occurrence of pressure induced am orphization (P IA) is characteristic of (although not limited to) tetrahedrally coordinated materials.

The simple statem ent that a material becom es am orphous under pressure covers a broad range of di erent experim ental situations and possible theoretical interpretations. The simplest possibility is a crystalline material that transforms (upon change of the external pressure) to a completely am orphous structure when a wellde ned transition pressure is reached. Wew ill call this possibility true PIA (TPIA). This strict case of PIA is by nomeans the only possible one. A reason for this is that typically PIA is claim ed to occur (on an experim ental basis) when the obtained sam ple does not display sharp X -ray di raction peaks. W e will refer to these sam ples as X -ray am orphous' m aterial. A relatively large am ount of local order can still be present in an X-ray am orphous. For instance, a polycrystal with a su ciently sm all crystal size is an X-ray am orphous material. An eventual transition from a single-crystal sample to this kind of polycrystal should be considered, on an experim ental basis, to be a

PIA transition. This is a second case of PIA that we will call Weak' (W PIA).

Experimentally, W PIA or some variants of it may be the rule more than the exception. It is seen in many cases that am orphization occurs through a sequence of transformations in which one or more intermediate crystalline phases can be identified. For instance, a crystalcrystal pressure induced transformation was shown to occur in quartz between 21 and 30 G pa<sup>4,5,6</sup>. The new crystalline phases, quartz II and a P  $2_1$ =c phase, may be intermediate states in the path toward complete am orphization, occurring at higher pressures. Yet, the nal am orphous material may well be only an X-ray am orphous material.

A common characteristic of both W PIA and TPIA is that the starting crystalline sample becomes unstable upon pressure. This instability does not typically disappear iftem perature is reduced. This is an indication that in most, if not all cases, the mechanisms of PIA can be discussed in the lim it of T = 0. In this lim it, all structural transform ations that m ay eventually occur are of a mechanical nature, i.e., the displacement of the particles during the transform ation is strictly guided by the tendency of the system to minimize its mechanical energy. In addition to being a simplifying assumption, the consideration of vanishingly small temperature is conceptually important, as in this case structural transform ations are necessarily related to mechanical instabilities in the system . We notice that although we will present all our analysis at T 0, this is in principle applicable also to any temperature below the glass transition temperature  $T_g$  of the uid phase, where di usion e ects are negligible. We only need to consider in this case that the parameters of the model may depend on temperature. Since at T <  $T_g$  di usive processes are almost totally inhibited, any structural transition (in particular, PIA) occurring in this temperature range is of a displacive nature. This raises the question of the relation between PIA and martensitic transform ations.<sup>7</sup> In fact, the discussion of the similarities between PIA and martensitic transform ations is one of the main aim s of the present paper.

There is also a long standing controversy about whether PIA is of a mechanical or therm odynamical  $\operatorname{nature}_{r}^{2,8,9,10,11,12}$  and this in turn is related to the two possible mechanisms of melting at higher temperatures: mechanical or therm odynamical.<sup>13</sup> Therm odynamical melting implies the growth of the uid phase when it starts to be more stable than the solid phase. This grow this heterogeneous and occurs in the presence of extended nucleation centers, such as grain boundaries or even the surface of the sample. If these defects do not exist (som ething that can be achieved in num erical simulations by the use of single-crystalline samples with periodic boundary conditions), then the uid phase is not able to nucleate until the ultim ate mechanical equilibrium conditions are violated. This is known as Bom's m echanical stability criteria, and the melting mechanism in this limit is called mechanical melting. Mechanical melting is hom ogeneous, as it a ects the whole sample at the same time, and occurs very rapidly once the stability lim it is reached. It has been suggested that these twom elting mechanisms can be extended to describe two di erent am orphization m echanism  $s_{\bullet}^{13}$ 

There are quite a few numerical models devised to study PIA in di erent materials. In some cases, a thorough description of a particular material is pursued. In this case, the models range from st principle density functional calculations<sup>14,15</sup> to molecular dynam ics sim ulations with di erent pair-potential interactions.<sup>16,17,18</sup> W ithin these models, PIA can be directly studied in concrete systems such as  $H_2O$  or  $SiO_2$ . A more qualitative approach is obtained by using core-softened potentials,<sup>19,20</sup> which proved to be very useful for the study of water-like anomalies and polyamorphism in tetrahedrally coordinated m aterials.<sup>21,22,23,24,25</sup> The aim of this approach is not to carry out an analysis of the properties of a speci c m aterial, but to nd out general trends and qualitative behaviors that shed light on the properties of a large fam ily of m aterials. This is the approach that we will follow here.

We study here a two-dimensional model of identical particles interacting through a spherically sym metric two body potential. We have recently shown that choosing appropriately the interaction potential, the model presents TPIA upon pressure release if we start from the stable high pressure phase.<sup>26</sup> Here we analyze in detail

the W P IA that occurs when we increase pressure starting from the stable low pressure phase. We show that this transform ation is of a martensitic nature, and analyze the nucleation and growth of the crystallites of the new phase. Depending on details of the potential, two di erent extrem e possibilities occur. In one of them, the new phase grows in large crystallites of the (three) di erent martensitic variants, and crystallites grow perpendicularly to the habit line of the martensitic transform ation. This is a case of idealm artensitic transform ation. In the other lim iting case, the new crystallites nucleate but can hardly grow. In this case, a W PIA scenario is realized. The nalsample is X -ray am orphous, but it conserves a m em ory of its original starting con guration. This m em ory manifests upon pressure release: the sam ple recovers (partially) the orientation it had prior to compression. W e discuss the characteristics of the interaction potential that are responsible for the di erent behavior.

The paper is organized as follows. In Sec. II, we present the model and details of the perform ed num erical simulations. The ideal martensitic transform ation is introduced in Sec. III. In Sec. IV, we describe the martensitic transform ation for the case when low energy barriers are involved in the growth process. The case were this energy barriers are higher, which leads to a W PIA, is discussed in Sec. V. Finally, Sec. VI contains som e discussion and conclusions.

## II. THE MODEL, NUMERICAL DETAILS AND EQUILIBRIUM PROPERTIES

We consider a two-dimensional system of particles, interacting through a specially devised isotropic, purely repulsive pairwise potential. Its main characteristic is the existence of two competing distances  $r_0$  and  $r_1 > r_0$  at which neighbor particles prefer to be located, depending on the applied pressure. This kind of core-softened potential has been previously used to study anom also properties of tetrahedrally coordinated materials,<sup>21,22,24,25</sup> and it was recently used to study the TPIA case also.<sup>26</sup> The interaction potentialV (r) between two particles separated a distance r is explicitly given by<sup>24,26</sup>




FIG.1: Pairwise core-softened interparticle potential used in the present work [from Eq. (1)]. The distances  $r_0$  and  $r_1$  are schem atically shown.

Here, " and a x the energy and length scales, and w is a control parameter that allows us to change the height of the shoulder of the interparticle potential (see Fig. 1). N eighbor particles prefer to be located on both sides of the shoulder, in the positions qualitatively indicated in Fig. 1 as  $r_0$  and  $r_1$ . Simulation results will be presented mainly for w = 6 and w = 10 to assess the e ect of the barrier height on the morphology of the microstructure obtained. Note that, although for w = 10 the curvature of the interparticle potential does not change sign, the potential gives rise to two preferred distances when analyzing two-or three-dimensional con gurations.

The system is simulated by standard molecular dynam ics in the NVT ensemble.<sup>27,28</sup> This choice allows us to survey all regions of the volum e-pressure curve, including those that would be unstable in constant pressure simulations. We perform simulations with 9540 particles, with a time step of  $t = 0.01t_0$  (where  $t_0 = a$  m =" is the time unit, m being the mass of each particle). Pressure and elastic constant are calculated along the simulations using standard formulas (see the Appendix for details). W e alwaysuse periodic boundary conditions (PBC). This is a particularly convenient choice when we want to avoid the heterogeneous nucleation of the new phase. On the contrary, in the case in which we study the heterogeneous nucleation, we introduce the nucleation centers by hand in the crystalline structure. The use of PBC in this case does not impose any strong additional restriction in the possible transform ations to be observed, as our system s contain enough atoms to accommodate essentially any possible new phase, even using PBC.

The volume of the system is changed at a xed rate during the simulation. This change is done by rescaling all coordinates of the particles and size of the simulation box. The volume change rate is taken to be as low as possible (within reasonable computational time) to sim – ulate a quasistatic process. However, it is of course a very large rate in physical units. For instance, a typical volume change rate we use is  $10^{4} t_{0}^{-1}$ , and for an atom ic particle ( $t_{0}$  10<sup>15</sup>s) this in plies a rate of the order of 10<sup>2</sup> per fem to econd.

By rescaling down the velocities of the particles during the simulation, tem perature is kept constant at a very sm all value of the order of 10 5" (we take the Boltzm ann constant to be unity). A s the transform ation process im – plies local mechanical instabilities, there is a system atic transform ation of potential energy into kinetic energy. In experiments, this rejects an increase of the tem perature of the system. Here the kinetic energy excess is taken away through the mentioned velocity rescaling procedure.

W e em phasize that the use of a two-dim ensional system is dictated by the simplicity of the simulation and also of the interpretation of the results. W hile we expect the same qualitative kind of results to reappear in full three dim ensional systems, the computational time increases noticeably, and the adequate identication of the phases becomes much more involved. Note that in a previous work it has been shown that the number of equilibrium solid phases noticeably increases when passing from two to three dimensions,<sup>29</sup> then adding to the complexity of the three-dimensional case.

O ne of the m ost striking properties of particles interacting through the potential described in the previous section is that the stable crystalline ground state is not necessarily the triangular lattice. In fact, although at low

(high) pressures the ground state of the system is a triangular structure with a lattice parameter around  $r_1$  ( $r_0$ ), at interm ediate pressures low erenergy congurations can be obtained that have some of its rst neighbors at distances  $r_0$ , and some others at  $r_1$ . By increasing the pressure, the conguration to which the low density triangular (LDT) structure is expected to transform is the chainlike (CH) structure.<sup>21</sup> This is the transition that we will be mostly interested in, and we will analyze it for two di erent values of w, namely w = 10 and w = 6. We will see that there are noticeable di erences between the two cases.

#### III. THE IDEAL MARTENSITIC TRANSFORMATION




FIG. 2: Ideal (a) LDT and (b) CH structures. The lattice parameter and the crystallographic directions are shown, together with the perfect and distorted hexagonal unit. (c) Interphase between the LDT and CH structures at equilibrium. The invariant line AB is rotated <sup>e</sup> with respect to the LDT structure. The [1;0] direction of the CH structure is rotated <sup>e</sup> with respect to the [1;0] direction of the LDT structure.

We will study the behavior of the LDT phase upon volum e reduction. The LDT-CH transform ation adm its a natural description as a martensitic transform ation as depicted in Fig. 2. In this description, the LDT corresponds to the austenite phase, and the CH to the martensite phase. Upon volum e reduction, the martensite phase becomes stable above the equilibrium transition pressure  $P^e$ . Two structures can coexist at this pressure, namely a LDT structure with lattice parameter  $r^e$  [Fig. 2(a)], and a CH structure (corresponding to an oblique twodimensional B ravais lattice) with parameters  $r_0^e$ ,  $r_1^e$ , and

<sup>e</sup> Fig. 2(b)]. To m inim ize the interface energy at the equilibrium pressure, the two structures have to m atch along a particular line, called the invariant line or habit line (habit plane in three dimensions, line AB in Fig. 2). This line is determ ined from the condition that both phases are unstrained away from it.<sup>7</sup> A relative rotation of the two phases is necessary in order to de ne the invariant line. The orientation of the invariant line can be easily evaluated given the parameters of the martensite

and the austenite phase. The structural parameters of the austenite (LDT) and martensite (CH) phases at the equilibrium pressure are given in Table I.

The ideal transform ation between the LDT and CH structures does not imply bond breaking, which means that each particle conserves the same enst neighbors in the two phases. This implies microscopic memory in the sense that each local neighborhood transforms back to exactly the original conguration upon decompression. Furthermore, this implies that after a cyclic LDT-CH-LDT transform ation, the original structure is recovered with the same initial orientation. This property is directly related to the shape memory end ect of martensites.

If an invariant line separating the two coexisting phases has form ed at the transform ation pressure, the transform ation can proceed as volume is reduced by reaccom – m odating particles of the austenite close to the interface to t into the sites of the martensite.<sup>30</sup> T he advance of the interface occurs through the lateral movem ent of the steps that form the interface, and at the equilibrium pressure it in plies the sum ounting of an energy barrier. Then, at T = 0 a sm all overpressure is necessary to climb this energy barrier. As we will see, this ideal grow th mechanism in the direction perpendicular to the invariant line becomes more complicated when strains are involved, and depends strongly on the height of the barrier for the transform ation between the austenite and m artensite phases.

### IV. NUCLEATION AND GROW TH IN THE CASE OF A LOW {ENERGY BARRIER

The previous ideal description of the martensitic transformation can dier from the actual way in which the martensite nucleates and grows from the pure austenite phase in a real situation. In this section, we study this

process using the potential in Fig. 1 with w = 10.0 n increasing pressure, the low density triangular structure becom es therm odynam ically unstable against the chainlike structure beyond P<sup>e</sup>. However, as this transform ation is rst order, at T = 0 the perfect LDT structure survives in a metastable state at higher pressures until it nally becomes mechanically unstable. For the case of a perfect (without defects) starting sample, we call the instability pressure P<sup>c</sup> (and the corresponding speci c volum e v<sup>c</sup>). The mechanical stability lim it corresponds to the value of pressure at which one of the norm alm odes (phonons) of the original structure rst destabilizes. The calculation of the phonon structure of the triangular lattice is straightforward. For our model potential Eq. (1) interactions with second and further neighbors are identically zero, and the stability condition can be written

$$\frac{\varrho^2 V}{\varrho r^2} + \frac{3}{r} \frac{\varrho V}{\varrho r} > 0; \qquad (2)$$

where r is the nearest neighbor distance of the triangular lattice. At the instability pressure P<sup>°</sup>, three equivalent shear phonon branches become zero energy. They correspond to shear phonons in the three equivalent directions [0;1], [1;0], and [1;1] (Fig. 2). Note that, due to the lack of next nearest neighbors interactions, the phonon branch along these directions is of the type sin (k), and at P<sup>°</sup> the whole phonon branch becom es dispersionless.

The fact that the destabilization is initiated by a shear phonon is consistent with an analysis in terms of B om inequalities<sup>31</sup>. In fact, condition (2) is equivalent to the generalization of B om stability criteria to stress dependent conditions<sup>32,33</sup> in the static (zero temperature) limit. In two dimensions, the B om stability criteria establish that a system is stable if the stress dependent shearm odulus  $G^0 = (C_{11} \quad C_{12})=2$  P is positive<sup>33</sup>. For the zero temperature case  $G^0 = -3=4$  [ $V^{00}(\mathbf{r}) + 3V^0(\mathbf{r})=\mathbf{r}$ ] (see Appendix), and then the B om stability criteria reduce to condition (2).




FIG.3: (a) Volum e-pressure curves for w = 10. The dotted line is the analytic expression for the evolution of the LDT structure if this remains stable, and the thin continuous line marks the equilibrium transition to the CH structure and the subsequent evolution of this structure. The full and open sym bols correspond to simulations with and without a vacancy in the original sam ple. Vertical dashed arrows indicate the compression-decompression paths. (b) Evolution of the stress dependent shearm odulus G<sup>0</sup> = (C<sub>11</sub> C<sub>12</sub>)=2 P upon decompression for w = 10. The dotted line is the analytical result for G<sup>0</sup> evaluated for the perfect triangular lattice (see the Appendix). Note how in the defect free case, the approach to the transition point (v ! v<sup>°</sup>) is signaled by the vanishing of the stress dependent shearm odulus.

The results of numerical simulation [Fig. 3(a)] conm the previous analysis. Starting from a perfect triangular structure at zero tem perature, once the system reaches the instability volum  $ev^c$ , the triangular con guration destabilizes and a new stable con guration should em erge. The evolution of the stress dependent shear m odulus upon volum e decrease is shown in Fig. 3(b), where it is clear that it vanishes at the mechanical instability point.

The consideration of a perfect sample without defects is important in order to realize the equivalence of the m echanical instability lim it with the vanishing of the energy of a phonon m ode. M oreover, in the present case it also coincides with the vanishing of an elastic constant (a long wave length elastic constant), because of the lack of interactions to next nearest neighbors.<sup>34</sup> But certainly, a defect free sample is not typically encountered in experim ents. It is important to realize that even tiny am ounts of defects can produce in portant changes in the triggering of the transform ation. For instance, a single vacancy can destabilize the lattice at pressures much lower than  $P^{c}$ . This was shown already in the case of TPIA,<sup>26</sup> and it is also true here. The evolution of pressure upon volum e decrease for a lattice with a single vacancy is also shown in Fig. 3(a). We see that a single vacancy is able to destabilize the original triangular lattice without essentially any pressure overshooting. Note, how ever, that the inclusion of a single vacancy has no appreciable e ect on the values of the shearm odulus prior to the transition [Fig. 3(b)]. This means that even in the presence of tiny am ounts of disorder, the exam ination of the elastic constants (or even of the whole phonon spectrum ) will not indicate the approach to the instability point. In fact, the instability occurs because of the destabilization of localized modes close to the defect, which have no e ect

on the spectrum of the (extended) phonons. The absence of m acroscopic e ects signaling the approach to the instability is usually associated to therm ally activated rst order transitions. We see that a similar phenom enology occurs here in the absence of therm al uctuations, and within a scenario of a transition driven only by mechanical instabilities.




FIG. 4: (Color online) Snapshots of the system with w = 10 corresponding to: (a)  $v=a^2 = 2:7$ , (b)  $v=a^2 = 2:6$ , (c)  $v=a^2 = 2:5$ , (d)  $v=a^2 = 2:4$ , (e)  $v=a^2 = 2:3$ , on compression, and (f)  $v=a^2 = 2:3$  after decompression from the conguration in (e). Only collapsed particles are shown joined by segments, with three di erent colors to identify the three di erent variants of the martensite (intact austenite is not plotted for clarity). The starting system contains a single vacancy at the position where the three di erent variants start nucleating in (a). Note that periodic boundary conditions are used.

In Fig. 4, a sequence of snapshots is shown to follow the morphology of the transform ed regions in the case in which a single vacancy is present in a monocrystalline sam ple. W e can see that the stinstability produces the collapse of adjacent rows of particles, around the defect. These collapses generate three platelets that propagate out of the vacancy [Fig. 4(a)]. The collapse directions in the three platelets are di erent, and are related to the three di erent variants of the martensitic transform ation. In this stage, the martensite crystallites are compressed in the longitudinal direction, in order to match the lattice parameter of the original triangular structure.<sup>30</sup> In a subsequent stage [Fig. 4(b),(c)], the new crystallites reaccomm odate to take the form of wedge shaped crystallites, with the interface between the martensite and austenite phase being very close to the ideal habit line of the transform ation. Then upon further compression Fig. 4 (c-e)] the crystallites grow perpendicularly to the habit. line, very much as described for the ideal case in the pre-

vious Section. The nal state of the system (when the whole sample has transform ed to the martensitic phase) consists of a polycrystalline sample with the three di erent orientation of the possible variants [Fig. 4(e)]. Note from Fig. 3(a), that after nucleation, pressure has remained essentially constant during the whole transform mation from the LDT to the CH structure, at a value slightly larger than the equilibrium value. This value re-

ects the overpressure needed to keep the transform ation proceeding.

If the volume of the system is increased back starting from the sample completely in the martensitic phase, upon complete pressure release essentially any particle in the system returns to its original position, in which it has exactly the same neighbors as before compression. In particular, this im plies that the original monocrystalline




FIG.5: Evolution of the averaged structure factor S (k) with decreasing volum e for the LDT-CH transform ation with w = 10 (the curves are vertically displaced, for clarity). D i erent curves correspond to the con gurations in Fig. 4 (a)-(e).




FIG. 6: Two-dimensional (upper) and angularly averaged (lower) structure factors of the conguration in Fig. 4 (e), and of the conguration obtained by quenching from the melt at the same density. In the top, the two-dimensional structure factors of the polycrystalline CH structure (left) and quenched am orphous structure (right) are shown. In the lower gure, bold and thin lines correspond to the averaged S (k) for the polycrystalline CH and quenched am orphous structures, respectively. There is a clear crystalinity observable in the rst case, even if we look only at the radial structure function. This sample should be characterized as polycrystalline.

austenite sam ple is reobtained, with the sam e orientation as in the starting con guration<sup>35</sup> This is not a surprise, since it is in the essence of the shape memory elect of martensites. It can be seen in Fig. 3 (a) that the return occurs with a noticeable hysteresis with respect to compression. This hysteresis is a consequence of the individual hysteresis of pairs of neighbor particles on passing between the two equilibrium distances, and can be used to quantify the energy dissipated during a compressiondecompression cycle.

Now we want to discuss how the transform ation m anifests when we observe the di raction patterns of the structures. In Fig. 5 we show the angularly averaged structure factor S (k) corresponding to the con gurations in Fig. 4 (a)-(e). It is possible to see how som e characteristic peaks of the LDT structure progressively disappear while new peaks appear that correspond to the CH structure. A broadening of the peaks is also apparent, due to the nite size of the crystallites in the new con guration. This broadening however is not large enough to consider the sample as X -ray am orphous. By com paring the structure factor of this structure with that of a sam ple obtained by quenching from the melt at the same density (Fig. 6), we rst observe that the two-dimensional structure factor displays clear evidence of the polycrystalline character of the sam ple. But even if we look only at the radial structure factor, there are much sharper peaks for our sample compared to the quenched liquid. Then the con guration in Fig. 4 (e) can be correctly identi ed from its structure factor as a polycrystalline sam ple.

## V. BLOCKED GROW TH FOR LARGE ENERGY BARR ER




FIG.7: (a) Volum e-pressure curves for w = 6. The dotted line is the expected evolution of the LDT structure, and the thin continuous line m arks the equilibrium transform ation to the CH structure and the subsequent evolution of the new structure. The full and open sym bols correspond to sim ulations with and without a vacancy in the original sam ple. Vertical dashed arrows indicate the com pression-decom pression paths. (b) Evolution of the stress dependent shear m odulus  $G^0 = (C_{11} \quad C_{12})=2$  P upon decom pression for w = 6. The dotted line corresponds to  $G^0$  evaluated from the interatom ic potential (see the Appendix). P<sup>c</sup> and v<sup>c</sup> are given by the vanishing of the stress dependent shear m odulus in (b) (see Table I).




FIG. 8: (Color online) Snapshots of the volum e controlled simulation of the system with w = 6 corresponding to: (a)  $v=a^2 = 2.95$ , (b)  $v=a^2 = 2.8$ , (c)  $v=a^2 = 2.6$ , (d)  $v=a^2 = 2.3$ , (e)  $v=a^2 = 2.1$ , on compression, and (f)  $v=a^2 = 3.05$  on decompression from  $v=a^2 = 2.1$ . Only collapsed particles are shown joined by segments, with three di erent colors to identify the three di erent variants of the martensite (intact austenite is not plotted for clarity). The starting system contains a single vacancy at the position where the three di erent variants start nucleating in (a). Note that periodic boundary conditions are used.

In the present section, we will study the modi cation brought upon by a change of the parameter w of the potential. The value used here is w = 6. In principle, the sam e description of the idealm artensitic transform ation is valid also in this case. The value of the crystallographic parameters are given in Table I. In Fig. 7(a), we show the volum e-pressure evolution of the volum e controlled com pression for w = 6.0 pen symbols correspond to the starting sample without defects. The simulation shows that the system remains in the triangular structure until the mechanical stability lim it  $(\mathbb{P}^{c}; \mathbf{v}^{c})$  is reached. On the contrary, the sam ple with a single vacancy begins to transform when local mechanical instabilities occur, before reaching the mechanical stability lim it. The behavior of the stress dependent shear modulus for the present case, with and without the vacancy, is shown in Fig. 7 (b). The phenom enology up to here is very sim ilar to the case of the previous section. How ever, in portant di erences appear when we look at the morphology of the samples and the structure factors. We again focus on the case of a system with a single vacancy. In Fig. 8, snapshots of the system as volume is decreased are shown. As in the previous case, the st elements of the new phase to

be nucleated are the platelets starting at the position of the vacancy. But contrary to the previous case, they do not rearrange to generate an interface along a habit line. As the growth process in these conditions in plies much higher overpressure, the growth remains mostly blocked, and upon further compression nucleation of new platelets throughout the sam ple occurs. New and old platelets interact elastically, and deform each other, generating at the end a structure that in spite of being martensitically related to the original one, contains crystallites that are extrem ely sm all.

On very general grounds, since our polycrystalline structure has very small crystallites, a broadening of the characteristic peaks of the azim uthally averaged X-ray pattern is expected.<sup>36</sup> There is a continuous crossover how ever from this broadened peaks' scenario, to one in which no sharp peaks are observed. In the last case the sam ple should be characterized as X-ray am orphous. But even in this case it can possess speci c crystal characteristics, and in particular it may conserve a structural relation with the parent structure that will manifest upon decom pression.




FIG. 9: Evolution of the averaged structure factor S (k) with decreasing volume for the LDT-CH transformation with w = 6. Each curves correspond to the con gurations in Fig. 8 (a)-(e).

In Fig. 9, we show angularly averaged structure factors corresponding to the congurations shown in Fig. 8 (a)-(e). Again, the peaks of the LDT structure disappear while reducing the volume, but the intensity of the peaks corresponding to the CH structure is much weaker than




FIG.10: Comparison of the structure factor corresponding to the sample obtained in the LDT-CH transformation [Fig. 8(e)] with a quenched amorphous structure at the same density. In the top the two-dimensional structure factors for the polycrystalline CH structure (left) and quenched amorphous structure (right) are shown. The angular averaged S (k) is plotted at the bottom for the polycrystalline CH structure (bold continuous line) and quenched amorphous structure (thin continuous line).

in the w = 10 case. In Fig. 10 the two-dimensional X ray di raction patterns of the structure obtained from a single crystal LD T sample, and an am orphous structure obtained by quenching from the melt (with the same density), are shown. We see that the two-dimensional pattern of the sample obtained by compression possesses an angular structure rem in iscent of the original crystal orientation (in fact, this structure will be responsible for a hern ory e ect' when the sam ple is decom pressed, see below). However, if our starting sample is already polycrystalline, as is usually the case experim entally, the X ray pattern is by de nition isotropic. In that case all the inform ation available is the radial X-ray pattern. The angularly averaged S (k) are shown at the bottom of Fig. 10. On the basis of the S (k) function, the compressed sam ple cannot be clearly distinguished from that obtained

by quenching from the melt. This sample is then X -ray am orphous. Thus, we have here a sample that has W PIA .

The fact that this sam ple is X -ray am orphous, but still has within its structure some information of the parent crystalline phase from which it was obtained m ay be related to the so-called m em ory glass e ect (M GE). The M GE was rst identi ed in A PQ berlinite,<sup>37,38</sup> and then it was recognized to occur in a variety of m aterials such as SnI<sub>4</sub> and LiK SO<sub>4</sub>.<sup>2</sup> The e ect consists in the am orphization of a sam ple under pressure, and the successive recovery of a crystalline sam ple, with the sam e original orientation upon decom pression. In the follow - ing, som e characteristics of the M GE for the present m odel system are studied.




FIG.11: v P compression-decompression cycles for dierent values of the nal volume reached. From bottom to top  $v_{m \text{ in}} = a^2$  goes from 1:6 to 2:6, in steps of 0:1. D otted and thin continuous lines as in Fig. 7.




FIG.12: (Coloronline) Snapshots of the system as recovered from the compression-decompression cycles shown in Fig.11.All the snapshots correspond to a nalvolume of  $v=a^2 = 3.05$ . The minimum volumes reached are (a)  $v=a^2 = 2.4$ , (b)  $v=a^2 = 2.2$ , (c)  $v=a^2 = 2.0$  and (d)  $v=a^2 = 1.8$ . Dierent colors indicate particles collapsed along each of the directions of the possible martensitic variants. Dots corresponding to the position of the particles are shown in order to identify the appearance of polycrystallinity.

The complete v P curves during volume controlled compression-decompression cycles are shown in Fig. 11 for di erent values of the nal volume reached,  $_{\rm M}$  in. The nal con gurations after the cycling are shown in Fig. 12. All the snapshots correspond to a recovered volume of v=a<sup>2</sup> = 3.05. Shown are the defects introduced by the cycling, corresponding to sm all regions of the di erent martensitic variants. Sm all dots correspond to the position of the particles. On a direct examination of the recovered structures, it is seen that the system has a tendency to recuperate its original orientation upon decompression. A closer inspection shows that the recovered LDT structure retains its initial orientation for high v<sub>m in</sub>, but becomes polycrystalline for lower v<sub>m in</sub>, losing the h em ory' of the initial orientation.

It is convenient to have a single parameter that measures the degree of memory of the structure. We take this parameter to be W, de ned as

where k and  $k^0$  are the nearest neighbors of particle j before and after the compression-decompression cycle, and




FIG.13: The parameter W dened in Eq. (3) as a function of the minimum volume  $v_{\rm m}$  in reached in the compression-decompression cycles shown in Fig. 11.

 $_{jk(k^0)}$  is the angle between  $\mathbf{r}_{k(k^0)}$   $\mathbf{r}_{j}$  and an arbitrary reference direction. In particular, it can be seen that if the sample returns exactly to its initial con guration, we get W = 1.0 n the other hand, if the nallocal orientations in the sample are completely uncorrelated with the original ones, then W = 0. W e take as the reference volume to compute W the value  $v=a^2 = 3.05$  and the plot of W as a function of the minimum volume  $v_{m in}$  reached during compression is seen in Fig. 13. We see in fact, that this num ber is close to one for  $v_m$  in  $=a^2 > 2$ , whereas it is essentially zero when  $v_{m in} = a^2 < 1.9$ . The memory of the system is lost continuously when vm in becom es low er, but note the interesting fact that for  $v_m$  in = 2:1, in which there is no LDT phase left in the compressed sample (see Fig. 8), the value of W is still clearly di erent from zero. All the memory of the system here can be associated to the preferred orientation of the crystals of the CH phase, which in turn occurs because of the martensitic nature of the LDT-CH transition. As for this volume the sample is X-ray am orphous, this is an example of MGE.

### VI. DISCUSSION AND CONCLUSIONS

We have studied a two dimensional model at T = 0 that displays a pressure driven martensitic transform ation between a triangular structure (the austenite) with rotational C<sub>6</sub> symmetry, and a chain like structure (the martensite) with a lower (C<sub>2</sub>) rotational symmetry. The martensite phase can be considered to be obtained from the austenite through a compression in one direction and an expansion in the perpendicular direction. The transformation occurs with an appreciable volume change. This is natural since pressure (which couples to volume in the free energy) is the driving force of the transformation.

The transition does not spontaneously occur at the equilibrium transformation pressure because an energy barrier exists. An excess pressure is needed to trigger the transform ation. D effects in the original crystalline structure produce the appearance of 'reaction paths' which have (at the equilibrium pressure) relatively low energy barriers. These barriers vanish with a relatively low overpressure, triggering the transition. The necessary overpressure in the presence of defects is typically much smaller than that needed to destabilize the defect free structure. We have shown in particular, that vacancies are very e ective in favoring the nucleation of three platelets related to the three variants of the martensite, which are however elastically distorted with respect to the ideal martensite. We call them pseudo-martensitic crystals.30

A fler the nucleation of pseudo-m artensite platelets, two di erent evolutions were observed. In one case, the pseudo-m artensitic platelets nd the way to become wedge shaped crystallites of the true m artensitic structure. In this process, the internal stress of the m artensite

relaxes, and the interface between austenite and m artensite becomes very nearly the ideal invariant line of the transform ation. These wedge shaped crystals grow upon volume decrease, until the whole sam ple consists of a collection of crystallites of the three di erent variants of the m artensite, and no austenite rem ains. In this case, the nal size of the crystallites is expected to depend mainly on the density of defects in the system and the compression rate, since there are no other important limitations to martensite growth. In principle, very large crystal sizes can be obtained in samples with low concentration of defects driven at very a low compression rates.

In a second case, the conversion of pseudo-martensite to true martensite is strongly inhibited. In this case, upon com pression, new platelets of pseudo-martensitic structure nucleate, that interact with preexisting ones. The structure obtained when the austenite has com pletely disappeared is much more disordered than in the previous case, and in particular, the nal crystallite size in this case is expected to remain of the order of few interatom ic distances. In some cases, the angularly averaged di raction pattern of the nal structure m ay well be taken by that of an amorphous structure. We have called this phenomenon weak pressure induced amorphization. This is not a true pressure induced am orphization since the nalstructure has a memory of its parent crystal that is observable, for instance, in the full twodim ensional di raction pattern. U pon decom pression of this sample, a defective crystal is obtained, which, how ever, has a consistent tendency to be oriented in the same form as the original parent crystal. This is a description of the memory glasse ect' (MGE), observed in di erent experim ental situations.

The two di erent behaviors were obtained by changing the param eters of the interparticle potential. Concretely, the easy grow th of the m artensite was observed when the barrier between the two possible interparticle distances was sm all, whereas inhibited grow th was observed when this barrier was higher.

A lthough the present model is not aim ing to reproduce the characteristics of a speci c real system with its com plex interactions, some sim ilarities concerning PIA, m artensitic transform ation and the MGE, may be addressed between this sim ple model system and real system s.

As we neglect temperature e ects in our molecular dynamics simulation, the transformation between the austenite and martensite phases is of a mechanical nature

(and this should be qualitatively correct for any  $T < T_q$ ). Thism eans that the austenite is driven into a metastable region, until a mechanical instability lim it is reached, and the martensite starts to nucleate spontaneously. Note the important fact (already present in our previous results in<sup>26</sup>) that once nucleated, the interface between the two phases can propagate spontaneously, and this propagation, which occurs essentially at the sound velocity, is not lim ited by the di usivity of the particles in any of the two bulk phases (which is zero here). In the case of defect free samples the mechanical instability of the austenite is signaled by the softening of a phonon m ode. How ever, in the presence of defects the rst mechanical instability corresponds to localized m odes around the defects, and therefore it is not observable in the phonon spectrum . Thus, our present and previous<sup>26</sup> results reinforce our view that PIA is a mechanical transition, i.e. always triggered by mechanical instabilities. We nd that defects can cause the transition pressure to be depressed to a value very close to the ideal therm odynam ical equilibrium pressure between the two phases. We recognize how ever, that this result can be not universal but system dependent. The relevance of defects density in low ering the am orphization pressure was recently experimentally highlighted,<sup>39</sup> although whether the am orphization pressure approaches the extrapolated melting line upon introduction of more defects is not clear. The experim ental evidence of am orphization occurring near the extrapolated melting line in som e system s is at the base of a 'therm odynam ical' soenario for PIA as directly related to the therm odynam ical melting' mechanism at higher temperatures. We see that this evidence is also fully compatible with a mechanical mechanism.

A transform ation rem iniscent of our martensitic transform ation with easy grow th occurs between the high pressure phases of G aPO<sub>4</sub>. In this case, the low-cristobalite phase of G aPO<sub>4</sub> transform sto a Cm cm structure on pressure loading.<sup>40,41</sup> The transform ation is of a displacive nature, and the mechanism consists of a fourfold-to-sixfold coordination change of the gallium coordination shell.<sup>40</sup> The peaks of the polycrystal are clearly identi-

ed, which indicates a large crystal size. In view of the results presented here, it could be interesting to exploit the martensitic point of view in analyzing this kind of pressure induced transform ation.

On the other hand, the transform ation in the case of blocked growth is in line with investigations of the high pressure transform ations of A  $\mathbb{PO}_4$  and the MGE  $^{42,43,44,45,46}$  W hat was rst viewed as a true PIA with MGE, was later identi ed as a crystalcrystal pressure-induced transform ation between a berlinite A  $\mathbb{PO}_4$  structure and a Cm cm polycrystalline structure with very sm all crystal size, i.e., in our language, a W PIA .C arefully done m olecular dynam ics sim ulations<sup>43</sup> and X-ray experiments<sup>44</sup> have identi ed some peaks of the X-ray di raction patterns of the high pressure phase as corresponding to the Cm cm structure. In addition, recent work has been devoted to establish that the Cm cm structure is the stable one at high pressures,<sup>46</sup> but little is known about the mechanism of the transform ation. In view of the similarities between the MGE in our twodimensional model and in the APO<sub>4</sub> case, we suggest that MGE occurs simply as a consequence of the amorphization being only of the weak type, instead of a true one. Furtherm ore, we speculate that the mechanism of the berlinite-Cmcm transformation in APO<sub>4</sub> could be very similar to the mechanism of the low cristobalite-Cmcm transformation in GaPO<sub>4</sub>. However, the grow th of the Cmcm structure over the berlinite phase of APO<sub>4</sub> could be inhibited by energetic barriers, leading to the polycrystal with very small crystal size.

To conclude, we notice how the present model, although highly simpli ed and not representing any particular real system, captures much of the phenom enology observed in a variety of real cases. A s such, it is an im portant theoretical tool to guide the analysis of concrete cases. We expect to be able to go further in this direction in the future.

Consider the static (zero tem perature) lim it. In this lim it one has to consider only the perfect crystal structure without any thermal uctuation. In this case the

rst term of Eq. (A 1), proportional to the tem perature, vanishes. The second term, which m easures the uctuation of the pressure tensor, vanishes too. Besides, the term containing the momentum of the particles in Eq. (A 2) is zero, and  $C_{ijk1} = B_{ijk1}$ . Then, in this limit, the calculation of the elastic constant is straightforward, and instead of using the com plete uctuation form ulas, which needs an ensemble average to be performed, we use the static limit Eq. (A 3) calculated over a given sam ple.
