The mechanical response of semi exible networks to localized perturbations

P revious research on sem i exible polym ers including cytoskeletal networks in cells has suggested the existence of distinct regimes of elastic response, in which the strain eld is either uniform (a ne) or non {uniform (non {a ne) under external stress. A ssociated with these regimes, it has been further suggested that a new fundam ental length scale em erges, which characterizes the scale for the crossover from non {a ne to a ne deform ations. Here, we extend these studies by probing the response to localized forces and force dipoles. We show that the previously identied nona nity length D A. Head et al. PRE 68, 061907 (2003).] controls the mesoscopic response to point forces and the crossover to continuum elastic behavior at large distances.

I. IN TRODUCTION

Sem i exible polymers such as lamentous proteins resem ble elastic rods on a molecular scale, while exhibiting signi cant therm al uctuations on the scale of m icrom eters or even less. This has made them useful as model system s allowing for direct visualization via optical microscopy. But, sem i exible polymers are not just large versions of their more well-studied exible cousins such as polystyrene. Filam entous proteins, in particular, have been shown to exhibit qualitatively di erent behavior in their networks and solutions. A fundam ental reason for this is the fact that the therm alpersistence length, a m easure of lam ent sti ness as the length at which therm al bending uctuations becom e apparent, can becom e large com pared with other im portant length scales such as the spacing between polymers in solutions, or the distance between chem ical crosslinks in a network.

O ne of the most studied sem i exible polymers in recent years has been F-actin, a lamentous protein that plays a key structural role in cells [1, 2, 3]. These occur in combination with a wide range of speci c proteins for crosslinking, bundling and force generation in cells. These composites, together with other lamentous proteins such as microtubules, constitute the so-called cytoskeleton that gives cells both mechanical integrity and structure. This biopolymer gel is but one example of a large class of polymeric materials that can store elastic energy in a combination of bending and extensional deform ations of the constituent elements. Such system s can be called sem i exible gels or networks.

O ne of the important lessons from recent experimental and theoretical studies is that the shear modulus of cross-linked sem i exible networks bears a much more complex relationship to the mechanical properties of the constituent laments and to the microstructure of the gel than is the case for exible polymer gels [4]. Recently, it has been shown that sem i exible gels exhibit a striking cross-over [5, 6, 7, 8, 9] between a response to external shear stress that is characterized by a spatially heterogeneous strain (a non-a ne regim e [10, 11]) and a uniform strain response (an a ne regim e [12]). This crossover is governed primarily by cross-link density and molecular weight (lament length). The bulk shear modulus of the network simultaneously increases by about six orders of magnitude at this nona ne-to-a ne cross-over. The underlying mechanism responsible for this abrupt cross-over appears to be the introduction of a new, mesoscopic length scale in the problem that is related to both the bending sti ness of the constituent polymers and the mean spacing between consecutive cross-links along the chain [5, 8].

One can associate this mesoscopic length with the length below which the deformation of the network departs from the standard a nity. The nona nity length

, introduced in Refs. [5, 8], can be qualitatively understood as the typical length overwhich one nds nona ne deformation in the network. In this previous work we presented a scaling analysis that relates this mesoscopic length scale to the network density and the stretching and bending moduli of the constituent laments. The macroscopic shear response of the network is then controlled by a competition between (the nona nity length) and the lament length, L. On the one hand, when the 1ament length is long, nona ne corrections to the deformation eld, which are localized to regions within of the lam ent ends, do not signi cantly a ect the mechanical properties of the network; the shear m odulus of the macroscopic system is well-described by calculations based on a ne deform ation re ecting the fact that nona ne deform ations of the lam entends are subdom in ant corrections in this lim it. Moreover, the elastic energy is stored primarily in the (hom ogeneous) extension and compression of laments. On the other hand, when the lam ents are of a length com parable to, or shorter than the nona nity length, i.e. L < then the nona ne deform ations of the ends play a large, even dom inant role in determ ining the m echanical properties of the network. The network is found to be generally m ore com pliant, and the elastic energy under applied shear stress is stored in a spatially heterogeneous m anner in the bending of lam ents. The existence of these distinct regim es as a function of lam ent length re ects a fundam ental di erence of these sem i exible polym er networks with respect to their exible counterparts: polym ers can m aintain their m echanical integrity and state of stress/strain across network nodes or crosslinks.

These results naturally lead one to pose a number of basic questions regarding the elastic properties of sem iexible networks. W hile these random networksmust on basic theoretical grounds appear as continuum, isotropic m aterials at the longest length scales, these considerations do not predict the length at which the continuum approxim ation applies. The previous identication of the nona nity length, as the only mesoscopic length associated with the nona ne-to-a ne cross-over in uniform ly sheared sem i exible networks suggests that this length should more generally control the cross-over to continuum behavior [8]. A fier all the a ne deform ation of the network under uniform stress at scales large com pared to

shows that in one case at least the nona nity length controls the cross-over to continuum behavior. One of the principal results of the present work is the dem onstration that more generally controls this cross-over to continuum mechanics in sem i exible gel system s.

Prior work has focussed exclusively on simple shear and uniaxial extension. In order to better exam ine the universality of the previous results, we study the opposite lim it of a highly localized external force in the form of a point force monopole or dipole. If one can show that the elastic (displacement) G reen's function of the system similarly depends on only one additional param eter then it would appear that this quantity com pletes the coarse-grained elastic description of the system on all length scales down to the mean distance between crosslinks. It may be, however, that the deform ation eld of these semiexible networks is much more complex and the simplication introduced by in the description of the network's response to uniform shear strain cannot be generalized to deform ations resulting from more general forcing conditions.

W hile our results below, indeed, show that does largely control the crossover to (the far eld) continuum elasticity, the observed elastic G meen's function is sensitive to the local structure of the network on length scales below . Below we discuss how we quantify the structure of the G meen's function and its approach to the form required by continuum elasticity. The observed elastic G meen's function, how ever, depends not only on the

{dependent Lam e coe cients of the m aterial, but also on local properties of the displacement eld im m ediately surrounding the the point force. In e ect one m ay im agine that, upon the application of the point force, the network acts as a type of com posite m aterial: within a distance of the point force it deforms in a way not well described by continuum theories, while outside of that zone it does appear to act like an elastic continuum. The com plete G reen's function depends, of course, on the material properties of both m edia. Unfortunately, only one of those m edia (the outer zone) is well characterized by the sim ple continuum theory of an isotropic elastic solid, so the com plete G reen's function remains com plex and depends on the detailed network structure within the inner zone surrounding the applied force.

There is another set of questions that may be addressed via the study of the network's response to point forces and force dipoles. Such forces not only probe the material properties of the network in a manner com plim entary to the uniform strains explored earlier, they also have direct physical implications for microrheology in F-actin networks and for the dynam ics of the cytoskeleton in response to the activity of nanoscale molecular motors, e.g. m yosin. Fluctuation-based m icrorheology, an application of the uctuation-dissipation theorem to the study of theology via the statistical analysis of the therm ally uctuating position of sub-m icron tracer particles em bedded in the medium, requires one to understand the elastic Green's function of the medium. Thus understanding the response of sem i exible networks to localized forces has direct experimental implications and consequences for force production in the cytoskeleton.

In the biological context, the sem i exible network m aking up the cytoskeleton is generally found in association with molecular motors that, to a good approximation, generate transient localized force dipoles in the material. To both understand force generation in the cell as well as the material properties of these cytoskeletal networks driven into nonequilibrium steady states by these molecular motors, one must determ ine the displacement eld associated with such motor-induced forces.

Notwithstanding our biological motivation for this work, our ndings also bear on the broader problem of elastic modes in am orphous materials. It has been show n that the vibrational modes of deep { quenched Lennard { Jones system s approach a continuum description only on scales exceeding som e m esoscopic length [13, 14]; for the protocols considered, a value 30 particle dim ensions was robustly found. This was physically identi ed with a length scale for non{a nity, suggesting a direct correspondence with our (although our can be controlled by varying the mechanical properties of the constituents). A com parable length was also found to control the self{averaging of the G reen's function to the form expected by continuum elasticity [15]. These ndings for radially interacting particles are broadly in keeping with our own investigations for sem i exible polym ernetworks. W e also m ention here that the relationship between continuum elasticity and the G reen's function has also been discussed for mildly disordered spring networks [16].

The remainder of this paper is organized as follows: In section II we develop our model of sem i exible, perm anently cross-linked gels, sum marize the num erical sim ulations used to study it, and discuss the expected structure of the displacement eld when averaged over numerous realizations of the network. In section III we report our results for both point forces in IIIA and force dipoles in IIIB. We then discuss our studies of the bulk elastic properties of these networks in IIIC before concluding in section IV.

II. MODEL

A. The sem i exible network

A highly successful continuum continuum model of individual sem i exible polymers is the worm {like chain. This treats the linear laments as elastic rods of xed contour length and negligible thickness, so that the dom inant contribution to the elastic energy comes from bending modes and the H am iltonian linearized to sm all deviations from a straight con guration that is given by

where u is the transverse displacement of the lament relative to an arbitrary straight axis, s is its arc length, and the elastic modulus gives the bending energy per unit length s.

The longitudinal response of the worm like chain m odel is calculated from the increase in free energy due to an extensional stress applied along the m ean lam ent axis [12, 17]. However, the num erical algorithm used in our simulations is based on the m inim ization of the H am iltonian of the system, and hence is fundam entally athem al. The reason for this choice is essentially one of e ciency: assuming there are no subtle convergence issues, m inim ization is expected to be faster than stochastic m odelling and, it is anticipated, give better statistics for a given CPU time. This does, how ever, m ean that the entropic m echanism governing the longitudinal response is absent, and an explicit energetic term is required.

An unconstrained lament at T = 0 forms a straight con guration, and thus elongation of its end{to{end distance must be accompanied by a change in the absolute contour length. It is therefore natural to incorporate longitudinal modes by adding a second elastic term to the H am iltonian for the extension or shortening of the lam ent backbone,

where dl(s)=ds gives the strain or relative change in local contour length, and is the Young's modulus of the lament (essentially a spring constant normalized to 1/[length]). Of course, such modes also exist in thermal systems, but may be dominated by the entropic spring terms [12], except possibly for very short lament segments or very densely cross-linked gels. The connection between therm al/entropic and atherm allongitudinal com pliance is discussed in greater detail in Ref. [8].

The two elastic_oco<u>e</u> cients and together de ne a = , which will shall refer to as the length scale l_b = intrinsic bending length by observing that an isolated 1am ent constrained to have di erent tangents at its end points will deform with this characteristic length. To avoid potential confusion, however, we note that this is not the typical length scale for bending deform ations of a semiexible lament. Rather, the bending energy of lam ents tends to m ake the longest unconstrained wavelength bending mode the dom inant one. Thus, for instance, in a crosslinked gel, laments are expected to be bent primarily on a length comparable to the distance between crosslinks. Nonetheless l_{b} is a useful measure of lam ent rigidity, in that large lo corresponds to rigid laments, and small $l_{\rm b}$ to exible ones.

A lthough and have been introduced as fundam ental coe cients, if the lam ent is regarded as a continuous elastic body with uniform cross section at zero tem perature, then they can both be expressed in terms of the characteristic lam ent radius a and intrinsic bulk modulus Y_f as $Y_f a^4$ and $Y_f a^2$. Thus I_b a, and thinner lam ents are more exible than thick ones (as m easured by I_b), as intuitively expected. G iven the possibility of entropic e ects in , however, we shall treat these as independent parameters of the theory [8]

The gel is constructed by depositing laments of monodisperse length L and zero thickness onto a two{ dim ensional substrate. The center { of{m ass position vector and orientation of the laments are uniform ly distributed over the maximum allowed range, so the system is macroscopically isotropic and hom ogeneous. W henever two laments overlap they are cross-linked at that point. Deposition continues until the required m ass density, asm easured by the m ean distance between crosslinks l_{c} , has been reached. The network thus constructed can be described by three lengths: L; l, and l, and one m odulus scale: . In two-dimensions l_c characterizes both the mass density and cross-link density in spatially random, isotropic networks. The length 1/2 characterizes the mechanical properties of the constituent laments via the ratio of their bending to stretching com pliance. The overallm odulus scale will be absorbed into the point forces applied to the network.

P reviously [5, 8], we identi ed an additional length $= l_c (l_c = l_b)^z$, where z ' 1=3. This non {a nity length characterized the crossover from non {a ne to a ne network response. Speci cally, for lam ent lengths L much larger than (i.e., high molecular weight), the bulk network properties could be understood quantitatively in terms of a ne strains, while signi cant non {a ne e ects were observed for L . Although this length arose naturally from considerations of bulk network properties [5], its dependence on l_c and l_b can be understood in terms of a balance of stretching/com pression and bending energies of a single lam ent, treated in a self(consistent way within a network [8]. It is important to note that this (m aterial) length is interm ediate, between the (geom etric) network length l_c and the m acroscopic scale. In fact, in dilute networks, for which l_c l_b , we shall argue below that the network can be thought of on scales & as a quasi{continuum : continuous, as opposed to discrete, but not necessarily described by m acroscopic continuum elasticity. We shall nd that this non {a nity length will play a key role in our analysis of the displacement eld on this interm ediate/quasi{continuum scale.

In order to apply the point forces, a crosslink is chosen at random and identi ed as the origin of the system; it is this crosslink that will later be perturbed. A xed circular boundary at radius R from the origin is in posed, and any laments or lament segments that extend beyond the boundary are simply removed or truncated, respectively. Filaments ending on the rigid boundary are xed there by another freely rotating bond as are found at all cross-links in the system. The allowed free rotation at the boundary means that the boundary supplies arbitrary constraint forces on the network but cannot support any localized torques.

B. Num ericalm ethod

D etails of the simulation m ethod have been presented elsewhere [8]. Here we brie y summarize the procedure, with particular attention on those aspects that are central to the problem s studied in this paper.

The system Hamiltonian H (fxig) is constructed from discrete versions of (1) and (2) applied to the geometry generated by the random deposition procedure described above. The degrees of freedom fx_iq , or hodes,' are the position vectors of both crosslinks and m idpoints between crosslinks, the latter so as to incorporate the st bending mode along the lam ent segments. Additional nodes could be included at the cost of additional run time, but are expected to have a sm alle ect, since the longest unconstrained wavelengths tend to dom inate bending deform ations. C rosslinks are treated as constraints on the relative position of each connected lam ent segm ent, but not on their relative rotation. Physically this corresponds to an inextensible but freely rotating linkage. As previously noted, constrained bending at crosslinks has a sm all e ect except at high network concentrations (speci cally, when $l_{\rm c}$ becomes comparable to a) [8]. Nodes on the boundary are immobile. Note that, as in our earlier work [5, 7, 8], the network is assumed to be initially unstressed on both m acroscopic and m icroscopic length scales.

There are two ways in which the system may be perturbed. The rst, which we call monopole forcing, is to apply an arbitrarily small external force f^{xt} to the crosslink at the origin. The network is then allowed to relax to a new con guration consistent with mechanical force balance at every node. The second, which we call dipole forcing, is to introduce a geometrical defect into the system by moving the central crosslink along the contour length of one of the lam ents to which it belongs, but not the other. Physically, this corresponds, e.g., to a motor introducing relative motion of one lam ent with respect to another lam ent. In the simulations, this effect is incorporated by in nitesimally Shifting' the image of the central node with respect to other nodes on one lam ent.




FIG.1: (C obr online) An example of a network of laments of uniform length L (grey line segments) perturbed by an external force, denoted by the large red arrow, applied to the crosslink at the origin of a circular system of radius R = L. The arrow lengths are logarithm ically calibrated to the magnitude of the displacement of at each crosslink. In this exam – ple, $L=l_c$ 29:1, =L 0:191 and the force is perpendicular to one of the laments that form the central crosslink; forces can also be applied parallel to a lament.

Once the perturbation has been specified, the displacements of the nodes in the new mechanical equilibrium are calculated by minimizing the system Hamiltonian H (fx_ig) using the conjugate gradient method [18]. This generates a displacement eld for the particular geometry under consideration, as shown in Fig. 1. Note that H (fx_ig) is linearized about small nodal displacements f x_ig from their original positions fx_ig, so linear response is assured. The bulk response to non{linear strains has been recently studied by Onck et al. [19].

C. Decom position of mean displacement eld




FIG.2: (Cobronline) M ean response after averaging O (10^5) networks with the same parameters as in Fig. (1) (including one lament xed perpendicular to the external force) except for , which is (a) =L 0:089 and (b) =L 0:42. For easy visualization, a green circle of radius has been inserted into the background of each plot. Vectors near the center of each system have not been plotted for clarity.

A s shown in Fig.1, the displacement eld for a particular network is quite com plex and generically shows anticorrelations between displacements and the local mass distribution. A lthough these uctuations reject inherent and possibly interesting physical properties of the gels, a more basic and immediately applicable quantity to measure is the mean displacement eld, found by averaging many individual runs with diering geometries but identical system parameters R, L, l_c and (or equivalently R, L, l_c and l_b). Two examples for diering (the radius of the green circle centered on the point of force application) are given in Fig.2. These plots demonstrate one of the prim ary results of this paper, namely that the crossover between continuum (or quasi{continuum}) response at large lengths, to a more exotic displacement eld at shorter lengths, happens at a length of order () with a prefactor close to unity.

In order to precisely describe the structure of the deformation eld, we consider its most general possible form. For monopole forcing, the displacement eld u(r) at position vector r relative to the origin can be projected onto 3 other vectors, namely the direction of the external force \hat{f} , the unit position vector \hat{r} and the axis \hat{n} of one of the laments to which the approximate is attached

lam ents to which the crosslink is attached,

where f is the magnitude of the external force, and $_{\rm a}$ is the shear modulus as predicted for a ne deformation. This depends on L and $l_{\rm c}$ but not $\,$, and is included here to factor out the density dependence of the response. As de ned, the g $^{(~)}$ (and the h $^{(~)}$ below) are dimensionless quantities in two dimensions.

Each $g^{()}$ can be further decomposed into angular modes in , where $\cos = \hat{n} \hat{r}$,

Term s in sin (m) vanish since the ensem ble{averaged response must be invariant under , and cos(m) term s with m odd also vanish due to ft ft invariance. This latter symmetry may appear to violate the known polarity of typical sem i exible biopolymers such as F-actin and microtubules [20]; however, we are interested here in the mechanical properties of the laments, which, within the approximations of our model, are indeed invariant under ft ft.

For dipole forcing, the above procedure is followed with the additional simplication that \hat{n} is proportional to \hat{f} , since the displacement (and hence force) dipole induced by the motion of a motor will always be parallel to one

lam ent axis. The decom position is therefore som ew hat sim pler,

The scalar f is the magnitude of the force dipole; since it is actually a displacement that is imposed, f is unknown as will be treated as a tting parameter. The angular

decom position is identical to before,

Later sections will refer to the continuum solution for

each of the two forms of forcing. These are given in the appendix. For the monopole case, only two continuum modes are non{zero, namely $g_0^{(r)}$ and $g_0^{(f)}$. We shall refer to these components of the G reen's function as continuum modes in order to distinguish from those components (non{continuum modes) that must vanish in the continuum. We do this even though for our nite systems the non{continuum modes do not vanish.




FIG.3: (Cobronline) M ean displacement eld after averaging over 0 (10^5) individual elds induced by imposing a displacement dipole at the origin. The orientation of the dipole is given by the red arrow. A sexplained in the text, the mean dipole moment vanishes after averaging and the resulting eld is quadrupole. A green circle at a radius = 0:191L from the origin is also shown.

The dipole modes are slightly more subtle: after averaging of m any dipole elds generated by the simulation, the resulting eld is quadrupolar. This is an immediate consequence of the means of forcing the system . Recall that in an elementary step, a motor moves parallel to one lam ent axis. This has the e ect of com pressing the lam ent in front of the dipole, while stretching the trailing segment. Thus two lament segments are perturbed, each of which can be treated as a force dipole which, for a particular network geom etry, will be of di erent m agnitudes and hence the resulting eld is dipole. However, the net bias of this dipole is symmetrically distributed around zero, and thus vanishes after averaging, leaving a quadrupole eld as shown in Fig. 3. As derived in the appendix, the non{zero modes for this eld are $h_0^{(r)}$, $h_2^{(r)}$, $h_0^{(f)}$ and $h_2^{(f)}$.

III. RESULTS

The mechanical response to a localized perturbation depends on the distance from the point of perturbation. W e divide the discussion of these results into the follow ing parts. First, we exam ine the response to a point force using the decomposition of the displacement eld outlined in previous section. We contrast the decay of the non-continuum modes of the displacement eld with the behavior of the continuum modes of the displacem ent eld and discuss the nite-size e ects in the simulations. At large length scales, we nd that the deform ation eld approaches a quasi{continuum form, in which all but a sm all num ber of ensem ble { average m odes decay rapidly toward zero. The remaining modes of the deformation eld are the same as those predicted by continuum elasticity. In other words, the strain eld about a point force re ects the expected tensorial character and rotational symmetries based on continuum elasticity theory. We nd that again plays a central role in controlling the cross-over from the near-eld to the quasi-continuum.

W e then turn to the spatial structure of the elastic energy density eld around the point force paying particular attention to the partitioning of that energy density between stretching and bending modes of the laments. W e observe that the ratio of these energy contributions achieves the bulk value overm uch shorter distances from the point force than does the structure of the displacement eld acquire its far-eld, or bulk structure. W e then extend our analysis to consider force dipoles in the medium. Lastly, we extend our previous analysis of the bulk elasticity of the lament network by examining both the Young's modulus and the Poisson ratio of the network.

A. The response to point forces

1. The Displacem ent Field

In this section we focus on the short length scale behavior of the monopole response, for which the non{ continuum modes are non{zero. We wish to distinguish two distinct forms of this non{continuum behavior: (i) higher angular modes $g_m^{(r)}$ and $g_m^{(f)}$ with m > 0 are non{zero, and (ii) the $g_m^{(n)}$ modes do not vanish, i.e. the response depends on the orientation of the lament to which the force is applied. This latter observation gives a clear indication of the gel on short length scales.




FIG. 4: $g_2^{(f)}$ (which is dimensionless) versus distance from point of force application r for system s with the same =L 0:191 and crosslink densities $L = l_c$ as given in the key (L is the lament length). The system radius R = L in all cases.

An example demonstrating the appearance of non{ continuum modes at short lengths is given in Fig. 4, which shows the $g_2^{(f)}$ mode for systems with di erent crosslink densities $L=l_c$ but with the lament exibility chosen to give the same 0.191L in each case. This plot show sthe decay of the $\cos(2)$ amplitude of the component of the displacement eld in the direction of the

applied force (at the origin). In all three system s one observes a rapid decay of this angular harm onic that m ust vanish for a continuum isotropic system . M oreover, the characteristic length scale for this decay appears to be of order (' 02R), although we exam ine this point m ore quantitatively below. For all network densities and values of studied it is clear that the magnitude of $g_2^{(f)}$ vanishes rapidly with distance from the point force. No data are shown for larger values of L=L since at high network densities the num erical convergence of the strain eld is so slow as to prevent attaining meaningful statistics.




FIG.5: $g_0^{(n)}$ versus r=R for =L 0:191, R = L and the L=l_c given in the key.

This picture of non {continuum modes decaying to near zero at a length comparable to holds also for the m > 2 modes of $g_m^{(f)}$ and for all the m > 0 modes of $g_m^{(r)}$. For reasons of space we do not show these data here. Instead we present data in Fig. 5 that demonstrate the decay of $g_0^{(n)}$ with r for three networks densities such that in each case 0:191L. This non {continuum mode of the displacement eld measures the circularly averaged am - plitude of the component of displacement in the direction fi, i.e. along the axis of the rod to which the force has been applied. Clearly, such behavior has no counterpart in an isotropic continuum elastic model. It is interesting to note that this amplitude also appears to decay exponentially with a decay length of order .




FIG. 6: Log linear plots of $g_2^{(f)}$ versus the scaled distance from perturbation r= for system swith various values of as given in the key. The system radius R = L in all cases. Data within a boundary layer of width from r = R is not shown (see text for details).

In order to test quantitatively whether indeed controls the decay of those components of the displacement ekt that have no counterparts in the continuum theory, we exam ine, as an example, $g_2^{(f)}$ vs. r more closely in Fig. 6. Here we plot this for a range of values of networks density and of . If, as suggested above, the decay is exponential with characteristic length , then plotting these data log-linear with radial distances scaled by should cause all these curves to exhibit the same slope. We have shifted the data sets vertically in order to facilitate visual comparison. (We note that, although a

known force is applied to the origin of our sample, since we expect the unknown local constitutive relations in our system to depend on density and other parameters, the amplitudes cannot be directly compared. Here, we wish only to establish the nature of the decay of the non { continuum modes.) We have also introduced the solid lines corresponding to exp(r=) merely as guides to the eye. These are not ts, although ts to these data for various L=l_c and demonstrate decay lengths of within 10%.

Thus, we observe a near eld regime in which the decay of the $g_2^{(f)}$ appears to be generically more rapid than exp(r=) followed by the quasi-continuum regime where the exponential decay with decay length is observed. This demonstrates that the nona nity length, indeed, controls the approach toward the expected con-

tinuum behavior (i.e., vanishing of the non{continuum modes). Sim ilar results (not presented here for reasons of space) are also found for the other non{continuum modes. Speci cally, the decay lengths are also found to be within 10%.

O f course, the xed zero-displacem ent boundary condition at r = R requires all components of the displacem ent eld to vanish there. The essential distinction between the continuum and non-continuum modes lies in the manner in which their amplitudes decay upon approach to the rigid boundary. The non-continuum modes exam ined above decay exponentially with a decay length proportional to . We demonstrate in the next section that the continuum mode amplitudes, in contrast, do not appear to decay in the sam e way. In particular, their approach to zero at the rigid boundary is not controlled by

2. Continuum modes and nite{size e ects

In this section we address two related points: (i) the fundam ental change in the structure of the displacem ent eld as one moves away from the immediate vicinity of the applied force, and (ii) the role of nite size e ects in our numerical simulation in two-dimensions. We cannot address the form er point without confronting the latter one for the following reason. Due to the presence of the rigid boundary, allm odes of the displacement eld decay to zero at the boundary.

We show in this section, however, that the decay of the non-continuum m odes is controlled by internal, m esoscopic length scales in the network, while the decay of the continuum m odes is determ ined by the m acroscopic geom etry of the system including the presence of the rigid boundary. Since the distinction between the continuum and non-continuum m odes depends essentially on the presence of the boundary and speci cally on the separation of the system size R from the internal length scales controlling the decay of the non-continuum m odes (/), we consider this distinction along with a m ore general discussion of nite size e ects in our simulation.

To have a well-de ned elastic response in twodimensions (meaning that the displacement eld vanish at large distances from the applied point force) one needs to impose a rigid boundary. In order to eliminate the differential in uence of the boundary on the various angular modes of the displacement eld we chose this boundary to be a circle of radius R centered on the point of force application. This rigid boundary forces all components of the displacement eld to vanish exactly at r = R. Such a rigid boundary can be expected to introduce a boundary layer near the edges of our system, which we observe and discuss below.




FIG.7: $g_0^{(r)}$ versus r=R for =L 0:191, R = L and di ering L=l_c as shown in the legend.

Figure 7 shows the decay of the $g_0^{(r)}$ mode amplitude for system s of size R = L and 0:191L. We note that the decay of this continuum mode is qualitatively distinct from the decay of the non-continuum modes shown

in Figs. 4, 5, and 6. We do not observe an exponential decay of this continuum mode am plitude. Nevertheless, observing an exponential decay having a long decay length, or, more reasonably, the product of an algebraic function and such a weak exponential decay would be di cult to resolve in this plot.




FIG.8: $g_0^{(r)}$ versus r=R for =L 0:191, L=l_c 29:1 and the system radii R given in the key. The continuum response for the bulk elastic m oduli corresponding to these parameter values (as given by (9)) is shown as a solid line.

To study these issues further, we plot in Fig. 8 $g_0^{(r)}$ for various system sizes from R = L=2 to 5L. We observe both an apparent convergence for the larger system s to a com m on curve w hen distances are m easured relative to the size of the system, as well as a system atic down-turn near the boundary. The rst of these observations suggests that the sample geom etry controls the dependence of this continuum mode, as opposed to intrinsic lengths like . The down-turn in these data within a distance of order (here, ' 0:2L) of the boundary is to be expected from the observations above concerning the role of the length scale . One can view this crossover length as the distance along a lam ent over which a force applied to the lament dissipates/expands into a (quasi-) continuum stress/displacement eld. Thus, the e ects of the boundaries on the individual lam ents contacting the boundary are expected to propagate at least this distance into the system. Because of this, we have also rem oved all data within a distance of the boundaries in Fig. 6 above, which exhibit a similar down-turn near the boundary.




FIG.9: $g_0^{(r)}$ versus r=R for R = 3L on log{linear axes, with =L and L=l_c as given in the key. Each curve has been shifted vertically by a {dependent scale factor to attem pt data collapse. Since varies by over a factor of 4, the rough collapse is enough to rule out any signi cant {dependence on the decay. Error bars are not shown for clarity.

In Fig. 9 we exam ine the radial dependence of $g_0^{(r)}$ for three di erent values of =L for a large system where R = 3L. In this case, we see a coincidence of the data for di erent , indicating that the long-range behavior of $g_0^{(r)}$ is not controlled by .

A lthough we were unable to obtain su cient statistics on the non{continuum (and sub{dom inant) modes for larger systems, the combination of the qualitatively di erent behavior from the continuum modes, together with the consistent dependence on the crossover length lead us to conclude that the principal results of the prior section are not strongly in uenced by nite-size e ects. T hus, controls the disappearance of the non-continuum m odes of the system .

We also see a large discrepancy between the expected continuum solution and the observed displacement of the simulated lament network as shown in Fig. 8. This di erence cannot be simply attributed to nite-size effects; as can be seen in Fig. 8, there is no observable convergence of the larger system data for the continuum m odes to the predictions of continuum elasticity for a m aterial having the appropriate Lame coe cients. Nevertheless, we clearly observe the m ore rapid decay of the non-continuum m odes on a length-scale controlled by 0 ne is left with the follow ing puzzle: The tensorial structure and the rotational symmetry of each com ponent of the displacement eld approaches the form required by the continuum theory, but the continuum model appears to never quantitatively agree with the num erical data.

W e m ay speculate about the underlying cause of this discrepancy. It is clear that that the deform ation of the m aterial in the imm ediate vicinity of the point force (this \near zone" extends out to a distance / from the point force) and in a boundary region at the rigid wall is not welldescribed by any continuum theory. We suggest that under the application of the point force at the origin, the network e ectively partitions itself into three di erent elastic materials. In the near eld region r < around the point force the deform ation response to the point force is quite complex. Sim ilar complexities appear to exist near the rigid wall, where R r < . These regions apply a complex set of tractions on the circles r and r R r bounding the interm ediate region that deform s in a m anner consistent with som e continuum elastic m aterial. Because these tractions are not them selves determ ined by a simple, continuum model, the resultant deform ation of the interm ediate region is also not simply derivable from an analysis of the elastic G reen's function for a continuum .

O nem ight in agine that for very large systems having a consequently larger intermediate region, the complexities of the tractions in the transition zones become less signi cant. Because of the rigid boundary at r = R and the low-dimensionality of the system, this may not be the case. The continuum G reen's function contains logarithm ic terms and, due to the rigid boundary, growing polynomialterms as well. Thus, we do not expect convergence to the continuum G reen's function even for signicantly larger systems. O nem ay ask whether three dimensional systems will show similarly poor convergence to the continuum solutions. Further research here is needed.

We suggest that we do indeed observe the approach of the structure of the elastic G meen's function to that predicted by continuum theory. We term the region surrounding the point force where the deform ation eld has the expected form the quasi-continuum. Based on our num erical data, we do not expect to nd a region in which the deformation eld agrees quantitatively with the predictions of continuum elasticity using the Lam e coe cients appropriate to the medium as determ ined by uniform stress measurements. This suggests that sem iexible networks adm it a highly com plex point force response that cannot be fully captured by continuum elasticity even in the far-eld. The full im plications of this com plexity have not been explored.

3. Energy Density

A nother instructive m easure of the m onopole response is the density of elastic energy $_{\rm E}$ at a given distance from the point perturbation, which m easures gradients of the displacement eld and therefore complements the analysis of u (x) given above. In addition, since the simulation contains explicit terms for the transverse and longitudinal lament deform ation modes, it is straightforward to measure the partitioning of the energy between these modes. Based on previous work [5, 6, 8], under hom ogeneous shear strain the partitioning of elastic energy between the bending and stretching modes of the laments is determined entirely by the a ne-to-nona ne crossover. The ratio of L= was found to control this energy partitioning at a macroscopic or average level. It remains to be seen how this partitioning of the elastic energy occurs in vicinity of a point force.

The freedom to choose the angle between the point force and the direction of the lam ent to which that force is applied allows one to determ ine locally the partitioning of the elastic energy between bending and stretching modes of the laments. Forces directed along the lam ent axis generate prim arily stretching deform ations in the immediate vicinity of the origin (where the force is applied). Forces directed perpendicular to the lam ent axis, however, locally create a large bending deform ation. As seen in the previous hom openously imposed strain deformation calculations, for any given value of L= the network responds very di erently to the bending or stretching deform ations. Thus it is not surprising that the decay of the energy density from the point of force application to the boundary is strongly dependent on whether the force is applied parallel or perpendicular to one of the laments at the crosslink.






FIG. 10: Density of elastic energy $_{\rm E}$ (in arbitrary units) versus distance r from an externally applied force that is directed along the lament to which it is applied. L=l_c is varied as given in the key, and R = L and =L 0:191 in all cases.

Fig.10 shows $_{\rm E}$ for parallel forces, where is xed but the lament density L=l_c varies. There is an approximate data collapse onto a single curve as shown. The most notable discrepancy occurs near the boundary, where the low {density data remains higher than those for larger L=l_c values. This is most likely due to the boundary layer already discussed above for the displacement modes.

In contrast, $_{\rm E}$ for forces perpendicular to a lament exhibits much richer behavior, as shown in Fig.11, which

shows the same data plotted against $r=l_c$ and r=. For large distances, the data for di erent $L=l_c$ appear to differ by only a scale factor. Since there is one arbitrary multiplicative factor for each curve (as only the magnitude of the applied force is xed, not its displacement and hence work done on the network), these portions of the curves can be made to collapse after scaling, as in the parallel force case, suggesting that beyond some near- eld regime, the decay of elastic energy density is once again exponential and governed by { see Fig.11 lower panel. However, in this near- eld regime for perpendicular forces there is clearly no possibility of such a collapse. Instead, it appears that the more rapid decay of elastic energy density in this near- eld regime is governed by the length l_c , as can be seen in the upper panel of F ig. 11 where the (rescaled) energy density data are plotted vs. r= l_c and shown to decay as exp(r=l) for distances r[<] 5 l_c (ignoring nite size e ects).

Based on the two di erent regimes of data collapse shown in Fig. 11, we conclude that there is a near-eld region in which the decay of elastic energy is governed by a microscopic length scale{the mean distance between cross-links{and a longer-range regime in which the spatial decay of elastic energy density is controlled by the mesoscopic length . To better study this cross-over, we exam ine the partitioning of elastic energy between bending and stretching modes of the laments. Recall that in the a ne limit, the elastic energy is stored primarily in the stretching and compression of the laments. In the nona ne regime, on the other hand, the elastic energy is stored alm ost entirely in bending modes of the laments.




FIG.12: Proportion of elastic energy due to lament stretching, H $^{\rm k}$ = (H $^{\rm k}$ + H $^{\rm ?}$), for three system s having di ering values of l_c (see key) but the same value of .




FIG.13: The fraction of elastic energy due to lam ent stretching in networks with the sam e L=l_c 29:1 (in fact, the exact sam e geom etries), R = L but di erent . The di erent values of the stretching energy fraction in the interm ediate regime re ect the di ering values of the ratio L= for the networks. For com parison, the macroscopic energy fraction under bulk shear is shown as horizontal dashed lines, in the sam e order as the data points (i.e. =L 0:089, 0.191 and 0.412 from top to bottom).

P lotted in Fig. 12 is the proportion of elastic energy due to longitudinal lam ent deform ation for the perpendicular force case. Three data sets are displayed having di erent values of l_c and { see gure caption. The distance from the point of force application has been scaled by the geometric mean of l_c and L leading to the observed coincidence of the crossover between regimes in the data. C lose to the point of the application of the force, the displacem ent response is clearly dom inated by bending modes of the laments. This is to be expected since the perpendicularly directed force directly injects bending energy into the system at the origin { the point of force application. The energy partitioning is inconsistent with that which is expected based on previous hom ogeneous shear m easurem ents. From that work, one expects the network to determ ine the energy partitioning based only on the ratio: L= . We observe the fraction of stretching energy to rapidly increase tow ards the expected value based on L= [5, 8] and we may characterize each curve has having a knee' separating the region of varying energy ratio from a nearly constant interm ediate regim e where the partitioning of elastic energies corresponds well with the previously identi ed fraction of stretch/compression energy under macroscopic strain. This correspondance is dem onstrated in Fig. 13. The horizontal lines show the fraction of stretching energy in periodic system s subjected to m acroscopic shear, and clearly coincide with the plateau reached beyond the knee. At the largest distances one notices the vanishing of bending energy as the fraction of stretching energy approaches unity. This last e ect is due to the fact that each lam ent has a freely rotating bond at the outer, rigid wall. As this wall cannot support torques, the bending energy vanishes in a boundary layer whose width is determ ined by the mean distance between cross-links. We return to this point below .

The observed coincidence of the knees of all three curves under the rescaling of distances by l_cL suggests that this length sets the scale overwhich in jected bending energy is redistributed into the combination of bending and stretching appropriate for long-length scale deform a-

tions.

Based on these observations we note that in all networks the strain eld acquires the structure of the point force response based on continuum elasticity over a (typically m esoscopic) length scale of . When the networks is subjected to large, local bending deformations, how - ever, it readjusts the partitioning of bending to stretching energy over a generally much shorter length scale, l_c . Thus the system is able to repartition the local elastic energy storage to the value appropriate for its L = ratio over smaller length scales than does the system recover the expected long length scale structure of its continuum

elastic response.




FIG.14: The fraction of elastic energy stored in the H $^{\rm k}$ term of the H am iltonian for perpendicular forces, as a function of distance from the origin r for system sizes R = L, 3L and 5L. In all cases L=l_c 29:1 and 0:191L.

We have already shown that in the interm ediate eld regin e the fraction of stretching elastic energy in the system approaches its far-eld value as determ ined by the ratio: L= .Nevertheless, we in fact nd that at the edges of our sam ple the network energy becom es stored solely in stretching modes regardless of the value of L = . As m entioned above we attribute this nal redistribution of the elastic energy density between bending and stretching modes to a boundary e ect imposed by the freelyrotating nature of coupling of the network lam ents to the rigid boundary. To further test that this nal redistribution is indeed a boundary e ect, we consider a few larger system sizes as shown in Fig. 14. In that gure the force remains perpendicular to the direction of the lament to which it is applied while the system size is varied from R = L to R = 5L for a network of xed

. When the data are plotted against the radial distance from the point force scaled by system size, we nd an excellent collapse in the interm ediate regime and in the putative boundary layer. For the smallest system size considered, R = L, we note poorer data collapse in the near eld region suggesting that one must study systems that are are least larger than a single lament length to access the bulk behavior of the network with quantitative accuracy. C learly, all three curves taken together are consistent with the notion of an elastic boundary layer that is produced by the freely-rotating boundary at the wall and that extends distance approxim ately equal to into the sam ple.

B. Network response to force dipoles




FIG.15: h_0^r for dipole forcing for xed =L 0:191 compared to the continuum solution (sm ooth line), which has one free tting parameter, namely the overall magnitude of the dipole forcing. Both data and curve are negative, so the magnitudes have been plotted to allow use of a logarithm ic axis. Each data curve has been scaled by $(L=l_c)^2$ to ensure the same m ean dipole magnitude (see text). The system radius was R = L.




FIG.16: h_0^r for same systems as in Fig.15. The only tting parameter for the continuum solution is the same as used previously for h_0^r , so there are no remaining free tting parameters in this plot. Much of the data for r=R > 0:6 is negative and hence not visible on these axes.

W e now consider the mechanical response of the network to localized force dipoles at the origin. Understanding this response function is central to elucidating the

e ect of molecular motor activity in the cytoskeleton. M any of the general features observed in the response of the system to point force monopoles are also in evidence. For example in Fig. 15 we see the rough collapse in the far eld of the mode amplitude $h_0^r(r)$ to the continuum solution for three di erent networks having the sam e value of . Note that the amplitude has been scaled by l_{\perp}^2 since the magnitude of the imposed force dipole for each realization of the network will depend on the distance to the next constraint, i.e. cross-link, which is l. Since the displacement eld when averaged over network realizations is quadrupolar, being the di erence in two dipole, that length must enter squared. The analogous displacement eld amplitude, $h_0^r(r)$ from the continuum solution (solid line in Fig. 15) was calculated using unit forces so this amplitude is known only up to an overall scale factor; that scale factor was adjusted to best t the data. A similar comparison can be made for the other continuum modes of the displacement eld (see the Appendix). Fig. 16, for example, shows $h_0^{t}(r)$ with the same arbitrary prefactor. The agreem ent to the continuum theory scaled as discussed above is quite poor. A s is also seen in the point-force response of the strain eld, higher angularm odes, which vanish in the continuum theory such as h_4^{I} are signi cantly non {zero in the data. The amplitude of the non-continuum modes in the dipolar response is even more dram atic than in the point-force response of the network exam ined earlier.

The simulation data for the response of the network to force dipoles can be broadly summarized as follows: The amplitude of the continuum modes of the dipolar displacement eld from the naive continuum theory do not agree with simulation data. In light of the discussion regarding such disagreements between the monopole data and the continuum calculation, this is perhaps not surprising. More interestingly, the observed displacement eld has signi cant amplitudes of higher order angular modes. In short the universality of the response of sem iexible networks to localized point forces does not appear to extend to their response to localized force dipoles.

We speculate that the principal di erence between these two cases stems from the fact that the network's response to the force dipole probes the more detailed microscopic structure of the network in the immediate vicinity of the point of the force dipole application. The am plitude of the low est order force multipole com municated from the near eld region to the far eld where we expect a continuum based theory to apply is not constrained by elem entary force balance. Neither are the am plitudes of any higher order force multipoles generated within the near eld region. Thus, upon reaching the inner edge of the far eld region the force dipole in posed at the origin has generated a highly complex set of tractions on the rest of the material whose structure depends on local details of the connectivity of the network near the origin. In contrast for the case of the force monopole, the dom inant term in those tractions is the xed totalm onopolar force acting on the interm ediate region. The higher order force

multipoles created in the inner region decay rapidly with distance from the origin leaving one with highly reproducible results for the response of the network to applied forces. The amplitude of the force dipole communicated from the near eld region to the intermediate region, on the other hand, is not similarly constrained. It appears that one generically generates large amplitude higher order force multipoles in addition to whatever force dipole is communicated to the intermediate region making convergence to a simple dipolar form slow and di cult to observe in our nite samples.

C. Bulk moduli




FIG.17: Young's moduli scaled by the a neprediction versus =L on $\log \{\log \text{ axes. The a ne prediction, which depends only on L=L, can be found in [8]. The symbols are larger than the error bars.$

Lastly, we present new results on hom ogeneous deformations of semiexible networks. It has already been shown that the macroscopic elastic moduli of this class of model networks depend in a crucial way on the ratio to the lament length L [5, 8]. For =L of 1, thedeform ation is approximately a ne, whereas non {a ne deform ation modes dom in the when $=L^{>}1$. Previously this was dem onstrated only for the shear m odulus; here we can now con m that the Young'sm odulus Y behaves in an identical manner. Fig. 17 shows Y measured from uniaxial extension of a rectangular cell, scaled by the prediction for an a ne strain, plotted against =L for the range of L=l_c considered in this paper. There is a clear data collapse, as for the shearm odulus. Furtherm ore the deviation from the a neprediction is small for =L1. but becomes increasingly pronounced as =L increases. This con m s that =L controls the m acroscopic elastic response of these system s.




FIG. 18: The Poisson ratio for the same systems as in Fig. 17. The solid line corresponds to $=\frac{1}{2}$.

Fig. 18 gives the Poisson ratio for the same system s as in Fig. 17. It is striking to observe that, within error bars, is consistent with the value $=\frac{1}{2}$, which is the value expected for an a ne deform ation [8]. However, it is apparent from this gure that the measured values are consistent with $=\frac{1}{2}$ for all data points, even those well into the non {a ne regime. The mechanism behind this striking robustness currently evades us (is has nothing to do with incompressibility, which xes = 1 in two dimensions). Note that at the rigidity percola-5:933 (at which the elastic moduli vanish) tion L=L $\frac{1}{3}$ [7], which is clearly inconsistent with the data is in Fig. 18 and con m s our earlier claim s that the non{ a ne regime is distinct from the scaling regime of the transition.

IV. DISCUSSION

In this paper we have presented the results of numerical studies on the response of sem i exible networks to both point forces and to hom ogeneously in posed strain. The data presented on the Young's modulus taken in combination with previous work on the static shear modulus shows that the mechanical response of the system can be understood in terms of Lam e coe cients that depend on the ratio of the lam ent length to the nona nity length: L=. The Poisson ratio of the material, how ever, appears to be remarkably insensitive to this ratio. We can o er no explanation for this insensitivity at this time. The data presented on the point force response form a necessary com plim ent to previous work on the developm ent of a long length scale elastic theory of such materials.

Based on these data, it appears that the storage of elastic energy and the structure of the strain eld is rather complex in the immediate vicinity of the applied point force. We characterize these quantities by considering three qualitatively di erent regim es as a function of radial distance from the applied point force. Im m ediately surrounding the point force in the near-eld regime we nd that the partitioning of elastic energy into bending and stretching is determ ined prim arily by the angle between the applied force and the direction of the lam ent to which that force is applied. The disorder-averaged strain eld is rather com plex having higher angular harm onics that predicted by continuum elasticity theory. In the interm ediate eld regim e farther from the point force the partitioning of elastic energy is determ ined solely by the ratio L= as found in the hom ogeneous shear measurem ents. The higher angular harm onics present in the strain eld appear to decay exponentially with a decay length proportional to with a constant of proportionality near unity. These results taken in combination with our previous work suggests that one may think of as setting the minimum length scale for the applicability of continuum modeling quite generally.

In the quasi-continuum regime (r >), we nd a strain eld consistent with structure of that predicted by continuum model. The strain itself, how ever, cannot be sim ply computed from a know ledge of the e ective Lam e coe cients. W e believe the source of this discrepancy is the fact that the interm ediate region, being poorly described by the continuum theory, applies a much more complex set of tractions to the material in the far-eld where the continuum theory must apply. If these boundary conditions were known, we suspect that one could in fact calculate the resulting displacement eld using the continuum theory. This belief is supported by the fact that in the far-eld regime the displacement eld for dierent networks having the same collapse onto the same curve as one would expect for any e ective continuum theory in which the Lame coe cients depend on .

To sum marize these results, we suggest that there is an emerging description of the mechanics semiexible networks. There mechanical behavior over length scales longer than appears to be described by a modi ed elastic theory in which the e ective Lam e constants depend on the ratio L= . For point forces and presum ably any force applied over regions having a characteristic length scale that is small compared to , the local response of the network is quite com plex and the material appears to be anom alously com pliant; at longer length scales, how ever, the structure of the deform ation eld appears to be consistent with the predictions of continuum elasticity. We believe that it should be possible to construct an elastic continuum theory of these networks that is applicable in both the interm ediate and far-eld and that is based on a modi ed gradient expansion of the strain eld incorporating explicitly the mesoscopic length . The behavior of the strain eld on scales much smaller than appears to depend on other, more m icroscopic length

scales.

Understanding the response of sem i exible networks to localized forces is a necessary for both microrheological investigations of sem i exible networks and for understanding the e ect of molecular motors in the cytoskeleton. C learly, further num erical investigations are required as well as a theoretical exam ination of the developm ent of elastic continuum models applicable to the interm ediate and far- eld regim es.

M oreover, additional investigations are required to exam ine the analogous questions in three dim ensional sem iexible networks. W hile we expect the basic physics outlined above, including the existence of a m esoscopic length , to persist in three dim ensions, the expected 1=r decay of the elastic G reen's function should alter the results. M oreover them ore rapid decay of the displacem ent eld and energy density in the continuum three dim ensional system m ay further sim plify the structure of the analogous G reen's functions for the sem i exible network.

APPENDIX

Here we derive the displacement eld u (x) predicted by continuum elasticity for the cases of both monopole and dipole forcing. For the monopole case, a point force f (x) is applied to the origin of an elastic sheet with Lam e coe cients and , or equivalently and the Poisson ratio = = (2 +). For an isotropic elastic body, the stress obeys $_{ij}$ = ($(e_i u_j + e_j u_i) + _{ij}r$ u and the resulting equation for force balance is [21]

A naive calculation of the corresponding dipole solution tion would simply superpose the abovem onopole solution for two point forces, f (x) and f (x ") with " = \hat{f} ", and then take the lim it "! 0. How ever, this ignores the boundary at radius R, which should be kept xed but is shifted a distance " by the above procedure. An exact calculation would require the monopole solution for force applied near to (but not at) the center of a circular system, which, since it no longer obeys radial symmetry, is likely to be highly complex. Here we ignore such issues and simply use the above monopole solution, in the expectation that it will closely approximate the exact case except possibly near the boundary. The displacement eld induced by the force dipole is then

As explained in Sec. IIC, the dipole solution above applies for a single realization on large length scales, but after averaging over m any networks on short lengths (as in the simulations) the dipole m om ent vanishes, leaving a quadrupole displacem ent eld. The required quadrupole is one consisting of two parallel dipoles of equal and opposite m agnitude, aligned along their axes, i.e.
