Scaling Laws of Stress and Strain in Brittle Fracture

A num erical realization of an elastic beam lattice is used to obtain scaling exponents relevant to the extent of dam age within the controlled, catastrophic and total regim es ofm ode-I brittle fracture. The relative fraction of dam age at the onset of catastrophic rupture approaches a xed value in the continuum limit. This enables disorder in a real material to be quantiled through its relationship with random samples generated on the computer.

Besides having wide practical relevance, breakdown in complex media touches on a range of fundamental issues involving structural disorder. However, it is only within the past two decades or so that adequate tools have become available which m in ic how a truly com plex material breaks [1]. These tools, known as lattice models, have their origin in statistical physics and are especially well suited to describe the interplay between a continually evolving non-uniform stress-eld and a random meso-structure.

D eviation from a perfect structure will usually a ect the way a material breaks under strain. This is especially so where brous, porous or granular media are concerned. Moreover, in comparisons between components made from the same non-perfect material, sam pleto-sam ple variations obtained in the response of stress to strain are typically large when the disorder is high. In this paper we calculate the average values of stress versus strain for a very large number of sam ples to obtain the breakdown characteristics of materials with a given type, or strength, of disorder.

Since the breaking characteristics of brittle materials depend crucially on the disorder, such information can be very useful in quality control. The size of the stable regime of fracture, for instance, within which an increasing amount of strain may be applied before catastrophic nupture sets in, increases with the disorder. Indeed, structural disorder on the m icroscopic level is often a desired trait in m any m aterials. Consequently, if a relationship can be established between disorder and the breaking characteristics, prelim inary conclusions may be drawn about average strength and its expected variability based on know ledge about the disorder in the material. This is helpful in cases where experiments are either costly or di cult to set up. W ith the disorder known, ultrasound or other non-destructive probing techniques can be used to determ ine how close a given com ponent under stress is to complete failure. Vice versa, with a properly calibrated lattice m odel detailed experim ental know ledge of the average stress-strain response should help to quantify the disorder and thereby predict, through simulations, other disorder-dependent properties which m ight not be easy to access experim entally. In alloys and com posite m aterials such inform ation can be used as an aid to optim ize the m ixture used, for instance, with respect to a desired strength speci cation.

Earlier results indicate that the scaling with system size of the maximum force obtained in quasi-static brittle fracture is universal with respect to the disorder. This has been reported in calculations with both the random fuse model [2] and the beam model [3, 4]. Those results, however, were obtained at a time when num erical resources were far more limited than today. Our calculations present evidence which is contrary to this. Speci cally, in large-scale num erical simulations involving a great m any sam ples and spanning a wide range of disorders, the exponents which characterize scaling in the controlled, catastrophic and total regim es ofm ode-I brittle fracture are all found to be non-universal. W hereas for weak disorder the exponents are strongly dependent on the disorder, there is a slow convergence on the screened percolation value in the lim it of in nite disorder.

A universal exponent, on the other hand, would be very useful for predicting strength properties since the scaling behaviour of stress and strain would then be the same for all materials, regardless of the details of the disorder. An additional relationship is required for the exponents to be useful in the case of non-universal scaling behaviour. Speci cally, it should be possible for the disorder in a realmaterial to be quantied in terms of the same parameters as those that are used to generate random samples on the computer. Presently we show that, in the continuum limit, the fraction of damage which occurs prior to catastrophic breakdown approaches a xed value which is speci c to the disorder.

It is indeed the ease with which disorder can be included which makes stochastic lattice models practical. The model used in our calculations is the elastic beam model used by Herrmann et al. in Ref. [4] and Skjetne et al. in Ref. [5]. The disorder is in posed on the break-




FIG.1: Force f_L versus displacement $_L$ obtained for system sizes L = 10, 14, 17, 20, 23, 27, 32, 40, 50, 63, 80 and 100, for a range of disorders with D > 0. On the left are shown (a) D = 0:1, (b) D = 0:17, (c) D = 0:25 and (d) D = 0:33. On the right are shown (e) D = 0:5, (f) D = 1, (g) D = 2 and (h) D = 4. W hereas in (a) { (d) the scale on $_L$ is $1:33f_L$, it varies on the right as (e) $2:5f_L$, (f) $5f_L$, (g) $13f_L$ and (h) $100f_L$. The arrow in (a) { (d) shows the onset of dam age for the L = 100 system.

ing thresholds of the beam s, and the elastic properties are assumed to be identical from beam to beam. Two random sets are generated for each lattice sample, corresponding to the maximum breaking strengths in pure axial loading and pure exure. The thresholds conform to the distribution which results when a random number r, chosen uniform ly on the interval 0 r 1, is raised to a power D. This power law distribution is the most practical way to generate multifractality, i.e., the type of behaviour which is fundam entally associated with the existence of scaling laws [6]. Hence, for D > 0 the cum ulative distribution reads

where 0 t 1 is distributed with a tail towards weak beam s. For D < 0, we have

now with 1 t < 1 being distributed with a tail towards strong beam s. The important thing is to include zero or

in nity within the range of thresholds, otherwise the distribution is asymptotically equivalent to no disorder[6]. Both fundam ental types of disorder are included in the present calculations. Fracture m ay then be fully explored as a function of disorder sim ply by varying the m agnitude of D, with sm all or large values of (D j corresponding to weak or strong disorders, respectively.

The lattice is broken by applying a uniform displacem ent to the nodes de ning the top row, and the rst beam to break is that which has the low est axial strength. A fler this, the breaking sequence depends on how local stresses interact with the quenched disorder. Each time a beam is removed from the lattice, the new mechanical equilibrium is obtained by minimizing the elastic energy. In practice this is done via relaxation, i.e., using conjugate gradients [7]. The process by which mechanical equilibrium is attained is assumed to be much more rapid than the breaking of the beam s, hence the simulation emulates quasi-static fracture.




FIG.2: The exponents and for the scaling with system size, L, of dam age in the controlled (solid lines) and catastrophic (dotted lines) regimes, respectively, as a function of the disorder D.A lso shown is the exponent for the scaling of total dam age () with L. For comparison, the data from R ef. [4] (), relevant to the total dam age for D = 0.5, D = 1 and D = 2, have also been included.

Results obtained for D > 0 are shown in Fig.1, where the data points represent the average values of stress and strain calculated for each broken beam . The exponents , and , obtained for the scaling of broken beam s in the controlled (stable), catastrophic (unstable) and total regimes of fracture, i.e., N $_{\rm S}$, N $_{\rm U}$ and N $_{\rm T}$, respectively, have been obtained from

and are shown in Fig. 2.

For weak disorders most of the thresholds are to be found in the vicinity of the upper bound. On the application of external force fracture therefore proceeds in a controlled manner only for the rst few breaks. During this phase, any small crack caused by the rem oval of a

weak beam is prevented from further opening up by the stronger thresholds in the immediate neighbourhood of the beam just broken. Since, at this stage, fracture is dominated by quenched disorder rather than stress, the external force must now be increased to break the next beam. A new crack will then most likely appear away from the neighbourhood of the previously broken beam, especially in the case of a large lattice. For sm all lattices the statistics of extrem es dictates that the limited number of beams present should reduce the probability of weak thresholds occurring. Hence, fracture is unstable from the onset.

This cross-over in disorder between, on the one hand, system s for which there is alw ays a regime of stable crack grow th (regardless of system size) and, on the other hand, system s for which crack grow th is unstable, or conditionally stable, from the very beginning, can, in fact, be identi ed. U sing general arguments Roux et al. [8] show ed that, for a fracture criterion of the type relevant to the fuse model, such a cross-over can be expected to occur at D 0.5. Hence, for lower values of D one should not expect scaling laws to exist.

The exact value of the disorder beyond which a controlled regime appears might be slightly dierent in the beam model, due to a dierent breaking formula. Nonetheless, Fig. 2 shows that a transition indeed occurs in the region 0.5. D. 1. A lthough the dependence of the exponents upon the disorder is less pronounced beyond D = 1, especially in the case of , the scaling is clearly non-universal, with the D > 1 exponents slow ly approaching the value 2 in the limit of in nite disorder. The exponent which governs the scaling behaviour of the total dam age, how ever, is very nearly 1:9 within a wide range of disorders.

In Fig. 1 the onset of dam age for the largest system included, L = 100, is shown by the small arrow in the cases of (a) D = 0.1, (b) D = 0.17, (c) D = 0.25 and (d) D = 0.33. In (a) there is a very small controlled




FIG. 3: Same as Fig. 2, but also including a wide range of D < 0 disorders, where the thresholds are distributed with a tail towards in nitely strong beam s.




FIG. 4: The same as Fig. 1, but for D < 0. The plots on the left show (a) D = 0.5, (b) D = 1, (c) D = 1.5and (d) D = 2. Plots on the right show (e) D = 2, (f) D = 2.5, (g) D = 3 and (h) D = 4. Note that there is a scale-shift in going from (d) to (e), the scale on the horizontal axes being otherwise the same.

regime before catastrophic nupture sets in. Stress and strain then backtracks along the original straight-line response towards the origin before encountering a section where decreasing values of force correspond to the same displacement. The situation here is one of conditional stability, where a small perturbation is su cient to propagate the crack further.

Exponents relevant to fracture in the D < 0 regime are shown in Fig. 3, where stress-strain curves for disorders up to \mathcal{D} j= 15 have been analyzed. Stress-strain curves between D = 0:5 and D =4 are shown in Fig. 4. Here the initial response, a straight line from the origin to the position of the st broken beam, is not shown. Fig. 3 shows that for small D there exists a regime of nite extent, i.e., 2 D 0, w ithin which = 1. The scaling behaviour here is trivial, being simply proportional to system size, and the rst beam to break triggers catastrophic rupture. W ithin this regime the tailtow ards strong beams is not very pronounced and consequently the next beam in the path of the crack will most likely be comparable in strength with that just broken. Since the loading on neighbouring beam s is rendered higher by its removal, crack growth is now localized. The case of




FIG. 5: The number of beam s belonging to the controlled regime of fracture, N_C, shown as a function of inverse system size, L¹, for (A) D = 0.25, (B) D = 0.333, (C) D = 0.5, (D) D = 1, (E) D = 2, (F) D = 4, and (G) D = 5. Straight lines have been t to the data in (D) { (G), and, based on the most signi cant data (), a straight line t has also been conjectured in (C).

D = 0.5, for instance, is shown in plot (a) of Fig. 4 where fracture is completely unstable. Stress and strain is seen to backtrack along the original linear response, as in the case of D > 0, before encountering a region of conditional stability. A ssum ing displacement control, fracture proceeds in a manner of slow ly decreasing force until the system is completely broken.

For D < 3 a region of stable crack growth appears, as can be seen from plot (h) of Fig.4. The tail towards strong beams has now become a dominating feature in the threshold distribution, with only a few beams re-




FIG.6: The extent of damage at catastrophic rupture, N $_{\rm C}$, obtained for system sizes between L = 32 and L = 100, and extrapolated to the continuum limit, L = 1, based on the straight line ts in Fig.5.

m aining in the vicinity of the lower bound. In the early stages of fracture, therefore, a sm all crack will most likely be arrested by strong beam s in its immediate neighbourhood. The situation is then similar to the case of D > 0 in the sense that force must now be increased to further propagate dam age.

For large \mathcal{D} jthe essential features are similar to those for D > 0, with the scaling being governed by nonuniversal exponents. A s before, the scaling of total dam – age shows the weakest variation, with 1:9 within a very large region of disorders.

At the onset of catastrophic nupture the relative am ount of dam age is $e^{D} = N_{C} = N_{T}$, where N_{C} is the number of beam s broken in the controlled phase and N_{T} is the total number of beam s broken. In Fig. 5, this quantity is shown as a function of inverse system size for D > 0. For the sizes included in the present calculations, a straight-line relationship is obtained for disorders larger than D = 1. W ith the L = 125 data having been left out due to low statistical signi cance, a line has also been t to the data for D = 0.5, although the relationship is probably not linear here. For disorders below D = 0.5the relationship is clearly non-linear, as can be expected based on the arguments of R ef. [8].

The same data are shown in Fig. 6, now however as functions of the disorder. The result extrapolated for the continuum limit, corresponding to L = 1, is the intersection of the straight-line t in Fig. 5 with the vertical axis 1=L = 0. This establishes a link between the disorder, as generated on the computer (presently using a power-law distribution), and the stress-strain characteristic obtained in the breaking of real materials. Such a relationship is valuable where com parisons are sought between simulation and experiment. As such, the present quasi-static result for brittle materials is mainly relevant to breakdown associated with fatigue, i.e., slow fracture processes.
