Statistics of excitons in quantum dots and the resulting m icrocavity em ission spectra

A theoretical investigation is presented of the statistics of excitons in quantum dots (Q D s) of di erent sizes. A form alism is developed to build the exciton creation operator in a dot from the single exciton wavefunction and it is shown how this operator evolves from purely ferm ionic, in case of a sm all Q D, to purely bosonic, in case of large Q D s. Nonlinear optical emission spectra of sem iconductor microcavities containing single Q D s are found to exhibit a peculiar multiplet structure which reduces to M ollow triplet and R abidoublet in ferm ionic and bosonic limits, respectively.

I. IN TRODUCTION

Sem iconductor quantum dots $(QDs)^1$ are a leading technology for the investigation of the quantum realm. They o er exciting possibilities for quantum com putation and are in portant candidates for the next generation of light em itters. In most cases, the best control of the states of the con ned carriers in QDs is obtained through coupling to light². This light-m atter interaction can be considerably enhanced by including the dot in a m icrocavity, with pillars³, photonic crystals⁴ and m icrodisks⁵ being the currently favoured realizations. References [3,4,5] describe the st reports, in each of these structures, of vacuum eld Rabi splitting, whereby one excitation is transferred back and forth between the light and the matter elds. This contrasts with the weak coupling regime previously studied, 6,7 where only quantitative perturbations of the dynam ics occur, such as reductions in the lifetim es of the dot excitations (Purcell effect). In the case of strong coupling, how ever, the coherent exchange of energy m erges the light and m atter excitations into a new entity. This is commonly referred to as an exciton-polariton in sem iconductor physics," with an important example being the two-dimensional polaritons in planar m icrocavities, rst observed by W eisbuch et al.9 In cavity quantum electrodynam ics (cQED), the equivalent concept is the dressed state of atom s by the quantised electrom agnetic eld.

In QD s, optical interband excitations create electronhole pairs or excitons, con ned by a three-dimensional potential which makes their energy spectrum discrete. If this potential is much stronger than the bulk exciton binding energy, and if the size of the dot is smaller than the corresponding exciton Bohr radius, the C oulom b interaction between electrons and holes can be considered as a perturbation. For the lowest exciton states, this is the ferm ionic limit where the P auli exclusion principle dom inates. In the opposite limit, if the con ning potential is weak or the size of the dot is much greater than the exciton B ohr radius, the exciton is quantized as a whole particle. In this case, the bosonic nature of excitons is expected to prevail over ferm ionic nature of individual electrons and holes. An important question for the description of emission from QDs embedded into cavities in the strong coupling regime is whether the dot excitations coupled to light behave like ferm ions or like bosons. Here we address the question of which statistics (Bose-E instein, Ferm i-D irac or a variation thereof) best describes excitons in QDs. This is a question which is very topical in view of the recent experimental achievements, and which has elicited substantial theoretical works in the past, in connection with the possibility of exciton Bose condensation.

In this paper we derive the exciton creation operator in a QD which allows the calculation of nonlinear optical spectra of QDs in m icrocavities. The model we develop takes into account the saturation of the transition due to Pauli exclusion alone and does not attempt to solve the complex manybody problem which arises when C oulom b interactions between excitons are included. Hence the model is most accurate in describing the departure from ideal bosonic behaviour in large dots rather than near the ferm ionic limit in small dots. We analyze the dot size e ect on the statistics of excitons and demonstrate the transition from the ferm ionic to bosonic regime. To motivate this, we begin by summarizing how the coupling of light modes with ferm ionic and bosonic material excitations di er.




FIG.1: (Color online) Energy diagrams of the two limiting cases of dressed bosons (left) and fermions (right). In the rst case the nth manifold has constant energy splitting of 2hg between all states and couples to the (n 1)th manifold by removal of a quantum of excitation with energy h! hg which leads to the R abidoublet, Fig. (a), with splitting 2hg. In the second case, each manifold is two-fold with a splitting which increases like a square root. All four transitions are allowed, leading to the M ollow triplet, Fig. (b), for high values of n when the two middle transitions are close $_{\rm pin}$ energy. The distance from the central peak goes like 2hg $\stackrel{\rm in}{\rm n}$ and the ratio of peaks is 1 : 2. The two lowest manifolds (in blue) are the same in both cases, making vacuum eld R abi splitting insensitive to the statistics.

The Rabi doublet, with splitting amplitude 2hg as shown on Fig. 1(a), is well accounted for theoretically by the coupling with strength hg of two quantized oscillators a and b both obeying Bose algebra,

and equivalently for b. W e shall describe this well known and elementary case in detail as it provides the foundation for most of what follows. Neglecting o -resonant terms like $a^{y}b^{y}$, the ham iltonian reads¹⁰

W e assumed degenerate energies h! for the two oscillators, which will not a ect our qualitative results, while simplifying considerably the analytical expressions. One oscillator, say a, describes the light eld while the other, b, describes a bosonic matter eld. The analysis of (2) can be made directly in the bare state basis j_i ; j_i with i excitations in the matter eld and j in the photonic eld, i, $j \ 2 \ N$. The value of this approach is that the excitation, loss and dephasing processes generally pertain to the bare particles. For instance matter excitations are usually created by an external source (pumping) and light excitations can be lost by transmission through the cavity mirror. This physics is best expressed in the bare states basis.

On the other hand (2) assumes a straightforward expression in the basis of so-called dressed states which diagonalises the H am iltonian to read:

where p^y and q^y create a coherent superposition of bare states, respectively in and out of phase:

For clarity we shall note ji; ji the dressed states, i.e., the eigenstates of (3) with i dressed particles of energy h! hg and j of energy h! + hg. The manifold of states with n excitations thus reads, in the dressed states basis:

Its energy diagram appears on the left of Fig. 1 for manifolds with zero (vacuum), one, two and seven excitations. W hen an excitation escapes the system while in manifold H $_{\rm n}$, a transition is made to the neighbouring m anifold H n 1 and the energy di erence is carried away, either by the leaking out of a cavity photon, or through exciton em ission into a radiative m ode other than that of the cavity, or a non-radiative process. The detailed analysis of such processes requires a dynam ical study, but as the cavity mode radiation spectra can be computed with the know ledge of only the energy level diagram s, we shall keep our analysis to this level for the present work. The important feature of this dissipation is that, though such processes involve a or b (rather than p or q), they nevertheless still result in rem oving one excitation out of one of the oscillators. Hence only transitions from ji; jii 1; ji or ji; j 1 ii are allowed, bringing away, reto ï spectively, h! + hg and h! hg of energy, accounting for the so-called Rabidoublet (provided the initial i and j are nonzero in which case only one transition is allowed). From the algebraic point of view, this of course follows straightforw ardly from (4) and orthogonality of the basis states. Physically it comes from the fact that, as in the classical case, the coupled system acts as two independent oscillators vibrating with frequencies ! g. In the case of vacuum eld Rabi splitting, a single excitation is shared between the two elds, and so the manifold H $_1$ is connected to the single line of the vacuum manifold.

In this case there is obviously no possibility beyond a doublet.

D i erent physics occurs when the excitations of the m aterial are described by ferm ionic rather than bosonic statistics. In the case of cavity QED the m aterial is usually a beam of atoms passing through the cavity, and a single excitation is the independent responses of the atoms to the light eld excitation. The simplest situation is that of a dilute atom ic beam where a single atom (driven at resonance so that it appears as a two-levels system) is coupled to a Fock state of light with a large num ber of photons. This case is described theoretically by the Jaynes-Cummingsmodel¹¹, in which a (the radiation eld) remains a Bose operator but b becomes a ferm ionic operator which describes two-levels systems, $b^{\rm y}$! $_{\rm +}$ with :

Then the atom must be in either the ground or the excited state, allowing for the manifolds

provided that n 1. The associated energy diagram sappear on the right of Fig. 1, with two states in each m anifold (in our conventions j);ni refers to the bare states with atom in ground state and n photons, while jl;n 1i has atom in excited state and n 1 photons). For the resonant condition, where the two-levels transition m atches the cavity photon energy, the dressed states for this m anifold are split by an energy nhg. In the general case, all four transitions between the states in manifolds H n and H_{n-1} are possible, which results in a quadruplet. It is hard to resolve this quadruplet, but it has been done in Fourier transform of time resolved experiments¹². It is simpler to consider photolum inescence directly under continuous excitation at high intensity (where the uctuations of particles num ber have little e ect). In this case, w ith n 1, the two interm ediate energies are alm ost degenerate and a triplet is obtained with its central peak being about twice as high as the two satellites. This is the M ollow triplet of resonance uorescence¹³.

Thus we are faced with two limiting cases, one is a pure bosonic limit with equally spaced dressed states resulting in the linear R abi doublet, the other the pure ferm ionic limit with pairs of dressed states of increasing splitting within a manifold but decreasing energy di erence between two successive manifolds, giving rise to the M ollow triplet. In many of the strong coupling experiments conducted so far, and in all the reports concerning sem iconductor QD s, only one single excitation is exchanged coherently, so that the states are dressed by the vacuum of the electrom agnetic eld, resulting in the Rabi doublet. How ever, at this level of excitation, there is com – plete agreem ent between the bosonic and ferm ionic m odels, with both providing a good description of the experim ental observations. The prospect of stronger pumping, with more than one excitation shared between the two elds, makes it important to understand whether a realistic sem iconductor QD will correspond to the bosonic or ferm ionic case, or som ething interm ediate between the two.

We review and discuss some of the more signi cant achievements in this eld in section II. In section III we lay down a general formalism for building the exciton creation operator. In section IV we study two limiting cases which resemble Bose and Ferm i statistics. We show how in the general case the lum inescence behaviour interpolates between these two limits which we have already discussed, and calculate the second order coherence of the emitted light. In section V we draw the experimental consequences of the various statistics and discuss how the spectra obtained allow a qualitative understanding of how excitations distribute them selves in the excitonic eld. In the nal section we conclude and discuss brie y ongoing work to re ne the modelling of the excitonic wavefunction.

II. EXCITONSASQUASI-PARTICLES

The generic optical excitation in an intrinsic sem iconductor is the electron-hole pair. In bulk, the two oppositely charged particles can be strongly correlated by the C oulom b interaction and bound as hydrogenic states (Wannier-Mott exciton). Although nding binding energies and wavefunctions for the single exciton case is a di cult problem in various geometries, 14,15,16 as far as the vacuum coupling lim it is concerned, the exciton eld operator which links the two manifolds H₁ and vacuum always assumes the simple form + regardless of the details of the exciton. As a particle constituted of two ferm ions, the exciton is commonly regarded as a boson, from consideration of the angular momentum addition rules and the spin-statistics theorem . For a single particle, this is an exact statem ent, albeit a trivial one. It is how ever generally agreed to hold at sm all densities¹⁷. In this case the Rabi doublet is obtained, as observed experim entally^{3,4,5}.

At higher excitation power, the problem assumes considerable com plexity as well as fundam ental im portance for physical applications. A lready at the next higher excitation with one more electron, hole or electron-hole pair added to the rst exciton the situation o ers rich and various phenom ena both in weak^{18,19} and strong²⁰ coupling, owing to the underlying com plexity of the excitonic states. In this work we shall be concerned with resonant optical pum ping, so that excitations are created in pairs and the system always remains electrically neutral. We shall describe as an exciton any state of an electron-hole pair, whether it is an atom -like 1s state or has both particles independently quantised, 15 and in a more general sense we shall also use the term for any combination of particles which takes part in the excitonic phase. Indeed the excitonic phase with more than

one pair requires at the most accurate level a description in terms of an excitonic complex, e.g., in term of biexcitons/bipolaritons for strong coupling of two electrons and two holes with light²⁰. This com es from the Coulom b interaction which links all charge carriers together and, in a most fundam ental way, also from the antisymmetry of the wavefunction which dem ands a sign change whenever two identical ferm ions (electrons or holes) are swapped in the system . How ever in some con gurations, especially in planar cavities, a widely accepted hypothesis of bosonic behavior of excitons and the derived polaritons has been investigated for e ects such as the exciton boser²¹, polariton ampli $er^{22,23,24}$ and polariton lasers^{25,26}. The internal structure of the exciton which gives rise to both deviations from the Bose-statistics and interactions of the electron-hole pairs is then expressed as an e ective repulsive force in a bosonised Hamiltonian (due to Coulomb interaction and Paulie ect in the form of phase-space lling or exchange interaction 27,28).

This bosonic approach for excitons met early opposition in favour of an analysis in the electron-hole basis^{29,30,31}. Combescot and co-workers investigated the possibility of bosonisation of excitons^{32,33,34,35} and concluded against it. They point out its internal inconsistency, as the same interaction binds the underlying ferm ions, and therefore de nes the exciton, while also being responsible for exciton-exciton scattering; this is inconsistent with the indistinguishability of the particles. These authors introduce the \proteon" as the paradigm for Bose-like composite particle and propose a form alism (\commutation technics") which essentially relies on evaluating quantum correlators in the ferm ion basis with operators linked through the single exciton wavefunction. The importance of Ferm i statistics of the underlying constituents has also been pointed out by Rom bouts and co-workers in connection to atom ic and excitonic condensates 36,37 . In both cases the composite \boson" creation operator reads

in term of k, δ_k the ferm ion operators

(same for δ_k), respectively for an electron and hole (or proton in the atom ic case³⁷) of momentum k. This operator creates excitons with the center-of-mass momentum K = 0 in a system with translational invariance. It was appreciated long ago¹⁷ that the operators B^Y and B are no-longer exact bosonic operators, but instead satisfy,

where D is a nonzero operator, though with sm allm atrix elements at low exciton densities.

O urapproach is based on a de nition sim ilarto Eq. (8) for the exciton operator. Instead of analysing the deviations in the commutation relationship (10) we derive the

m atrix elements of the operator B^y. The direct analysis of these matrix elements allows us to trace departures from Bose-statistics and to investigate the transitions between bosonic and fermionic behaviours of excitons in QD s. W e shall compare our results with those of Refs. [32,33,34,35,36,37]. For convenience, we will refer to these two sets of publications through the names of their rst authors, keeping in m ind that they are co-authored papers, as listed in the references.

III. FORMALISM

W e consider a QD, which localises the excitation in real space. Thus our main departure from C om bescot and R om bouts is that our exciton creation operator, X $^{\rm y}$, is expressed in real space and without the zero center-of-mass m om entum restriction,

where n_e and $\&n_h$ are ferm ion creation operators, cf. (9), for an electron and a hole in state $\prime_{n_e}^e$ and $\prime_{n_h}^h$, respectively:

with jDi denoting both the electron and hole vacuum elds. W e carry out the analysis in real space with the set of basis wavefunctions

with $r_{\rm e}$ and $r_{\rm h}$ the positions of the electron and hole, respectively. Subscripts $n_{\rm e}$ and $n_{\rm h}$ are multi-indices enumerating all quantum numbers of electrons and holes. The speci cs of the three-dimensional connement manifests itself in the discrete character of $n_{\rm e}$ and $n_{\rm h}$ components.

W e restrict our considerations to the direct band sem iconductor with non-degenerate valence band. Such a situation can be experimentally achieved in QDs formed in conventional III-V or II-V I sem iconductors, where the light-hole levels lie far, in energy, heavy-hole ones due to the e ects of strain and size quantization along the growth axis². Therefore, only electron-heavy hole excitons need to be considered. Moreover, we will neglect the spin degree of freedom of the electron-hole pair and assume all carriers to be spin polarized. This can be realized by pumping the system with light of de nite circular polarization, as spin-lattice relaxation is known to be very ine cient in QDs.

The (single) exciton wavefunction ${\tt j}$ i results from the application of X $^{\rm y}$ on the vacuum . In real space coordinates:

At this stage we do not specify the wavefunction (that is, the coe cients C $_{n_e,n_h}$), which depends on various factors such as the dot geom etry, electron and hole e ective m asses and dielectric constant. R ather, we consider the n excitons state which results from successive excitation of the system through X y :

W e later discuss in m ore details w hat approxim ations are being m ade here. For now we proceed by norm alising this wavefunction

The creation operator X $^{\rm y}$ can now be obtained explicitly. We call $_{\rm n}$ the non-zero matrix element which lies below the diagonal in the excitons representation:

We now undertake to link $_n$ with the coecients $C_{n_e;n_h}$, which assume a speci c form only when the system itself has been characterised. The general relationship is more easily obtained in the real space than with the operator representation (11). Indeed the nonnorm alized n-excitons wavefunction assumes the simple form of a Slater determinant

explicitly ensuring the antisymmetry of $_n$ upon exchange of two identical fermions (holes and electrons), as results from the anticommutation rule (9) in the nth power of operator X $^{\rm y}$, cf. (11).

The determ inant can be computed explicitly, by expansion of its m inors which results in the recurrent relation

The determ inant can also be solved by direct combinatorial evaluation, counting all combinations which can be factored out as products of $_m$. The result expressed in this way reads:

where p(n) is the partition function of n (number of ways to write n as a sum of positive integers, i.e., as an integer partition of n) and (i) is the number of times that i 2 N appears in the th partition of n. The coe cients C _n read:

where the product is taken over the integers n_i which enter in the th partition of n, i.e., $n = \frac{1}{2}$, n_i .

The procedure to calculate the matrix elements of the creation operator is as follows: One starts from the envelope function ' $(r_e; r_h)$ for a single exciton. Then one calculates all overlap integrals m as given by (22), for 1 m n where n is the highest manifold to be accessed. Then the norm s can be computed, the more practical way being recursively with (21). Finally the matrix elements n are obtained as the successive norms ratio, cf. (18). Once n are known the em ission spectra can be calculated with ease. W e note here that the num erical computation of the m and n values needs to be carried out with great care. The cancellation of the large numbers of terms involved in Eq. (21) requires a very high-precision evaluation of m .

Although derived from the formulation in real space (20), the recurrent relation (21), or its analytical solution (23), is a property of ferm ion pairs, so it applies to the ferm ionic operators in (8) as well. The core of the mathematical results contained in these two expressions has in fact been obtained by C on bescot³² through di-

rect evaluation with the operator algebra involved in B $^{\rm y}$. The only di erence with her approach and ours is that her corresponding quantity $_{\rm m}$ (which she notes $_{\rm m}$) appears as a series in the (reciprocal space) wavefunction

as opposed to the overlap integral (22).

W ith such a simple expression as (24), C om besoct et al. have been able to obtain approxim ate analytical form s for 1s states of excitons in both 3D and 2D. The sum over reciprocal space is approximated as an integral in the continuum ling it, and since $_{R \ k}$ depends on $k = \frac{1}{k} \text{jonly}$, this becomes $_k j_k j^m ! V_k j_k j^m dk w ith <math>V_k = 4 \ k^2$ or 2 k, respectively, yielding³²




FIG. 2: Normalization constant N₂ vs. ratio of crystal size L to 3D exciton B ohr radius a_B . D ashed line shows the result using the approximated expression (25) for $_m$ and solid line using the exact evaluation of the sum on the mesh in reciprocal space. The negative value of the norm used as a criterion for boson wavefunction breakdown in Ref. [32] is an artifact of this approximation. W ith the genuine wavefunction, our procedure yields a non-arbitrary way to consider how the wavefunction. Inset displays N₁ vs. L= a_B computed on mesh (solid) and according to Eq. (25) (dashes).

with z and y dim ensionless parameters involving the ratio of Bohr radius a_B to the size of the system . In Ref. [32], this continuous approxim ation is used even when the system size becom es so sm all that the quantization becom es noticeable, as a result of which a negative norm is obtained even for a well de ned wavefunction. However, the authors interpret incorrectly this negative norm as the result of an unphysical exciton wavefunction and thus the breakdown of the bosonic picture. To dem onstrate this, we have computed num erically the values of m by direct sum m ation of Eq. (24) and used them to evaluate norm alization constants N_n. Som e results of the com putation are shown in Fig. 2. The inset shows the dependence of N $_1$ $_1$ vs. the ratio of crystal size L to 3D exciton Bohr radius a_B . The continuous approximation Eq. (25) gives $_1 = 1$, shown by the dashed line in the inset. The solid line displays the value of $_1$ computed exactly with (24): it approaches 1 when $L=a_B$! 1 but departs strongly from 1 as the size of the system reduces, since the realwavefunction changes as the system shrinks about it. At the very least this needs to be taken into account by correcting the norm alization constant of k, as otherwise unphysical result may arise. The main part of the gure shows the two-excitons normalization N $_2$ calculated by both m ethods. We nd that for all $L=a_B$, the exact N₂ never becom es negative in clear constrast with the behavior obtained with the approxim ated value (25). Hence it is not possible to use the appearance of a negative norm as a criterion for bosonic breakdown.

IV. LIM IT ING CASES

W e shall not attempt in this paper to go through the lenghty and complicated task of the num erical calculation of the exciton creation operator matrix elements for a realistic QD. R ather, we consider here a model wavefunction which can be integrated analytically and illustrates

som e expected typical behaviours. Before this, we com m ent brie y on the limiting cases of Bose-Einstein and Ferm i-D irac statistics and how they can be recovered in the general setting of this section.

This will be made most clear through consideration of the explicit case of two excitons (n = 2). Then the wavefunction reads

This result has a transparent physical meaning: since two identical ferm ions from two excitons cannot be in the same quantum state, it is \harder" to create two real excitons, where underlying structure is probed, than two ideal bosons. We note that if L is the QD lateral (a_b =L)² dimension, 2 1 when L a_B . Thus in large Q D s the overlap of excitonic wavefunctions is small, 2 and the bosonic lim it is recovered. On the **SO** 2 other hand, in a smallQD, where Coulomb interaction is unimportant compared to the dot potential con ning the carriers, the electron and hole can be regarded as quantized separately:

We now turn to the general case of arbitrary sized QDs, interpolating between the (sm all) ferm ionic and (large) bosonic limits. We assume a Gaussian form for the wavefunction which allows to evaluate analytically all the required quantities. As num erical accuracy is not the chief goal of this work we further assume in-plane coordinates x and y to be uncorrelated to ease the computations. The wavefunction reads:

This ham iltonian de ness the two length scales of our problem, the 2D B ohr radius $a_{\rm B}$ and the dot size L :




FIG. 3: Ratio of parameters $_{eh}$ and (with $= _{e} = _{h}$) as a function of $L=a_{B}$. For large dots where L a_{B} , $_{eh}= 2$ which corresponds to the bosonic limit where the electron and hole are strongly correlated. For shallow dots where L a_{B} , $_{eh}= 0$ with electron and hole quantized separately. The transition is shown as the result of a variational procedure, with an abrupt transition when the dot size becomes comparable to the Bohr Radius.

Eq. (36a) is an eigenstate of the center-ofm ass energy operator and equating its param eters with those of the exact solution yields the relationship 2 + $_{eh} = 2=L^2$. This constrain allows to m inim ise (36b) with respect to a single param eter, a = $_{eh}=2+1=(2L^2)$, which eventually amounts to m inim ise $4a_B=a^2+a_Ba^2=L^4$ 2 = a. Doing so we have obtained the ratio $_{eh}=$ as a function of L=a_B displayed on Fig.3. The transition from bosonic to ferm ionic regime is seen to occur sharply when the dot size becomes commensurable with the Bohr radius. For large dots, i.e., for large values of L=a_B, the ratio is well approximated by the expression

One can readily check that (32) gives, in the case 2° e h, an exciton binding energy which is eh ! smaller by only 20% than that calculated with a hydrogenic wavefunction, which shows that the Gaussian approximation should be tolerable for qualitative and sem iquantitative results. M oreover, its form corresponds to the general shape of a trial wavefunction for an exciton in an arbitrary QD, 38 with the only di erence that we take the Gaussian expression instead of a Bohr exponential for the wavefunction of the relative motion of the electron and hole. This com prom ise to num erical accuracy allows on the other hand to obtain analytical expressions for all the key parameters, starting with the overlap integrals (22) which take a simple form in terms ofmultivariate Gaussians:

Together with (33), (41) and (42), expression (38) provides the $_{\rm m}$ in the G aussian approximation. One can see the considerable complexity of the expressions despite the sim plicity of the model wavefunction. Once again, even a num erical treatment meets with di culties owing to manipulations of series of large quantities which sum to sm all values. W e had to tum to exact algebraic computations to obtain n coefcients free from num erical artifacts. Before we present the num erical results, we once again turn to the lim iting case of a large QD (L a_B) where the bosonic behaviour may be expected, putting again for simplicity $e_{h} = h_{h} = .$ When Eq. (37) holds, rather lengthy algebraic m an ipulations yield

Thus in the small-n limit the matrix elements of the exciton creation operator are close to that of bosons and the corrections arise proportionally to the parameter n $(a_B = L)^2$.




FIG. 4: (a) Matrix elements n of the exciton creation operator X y calculated for n 15 for various trial wavefunctions. The top curve shows the limit of true bosons where $n = \frac{p}{n}$ and the bottom curve the limit of true fermions where $n = \frac{n}{n;1}$. Intermediate cases are obtained for values of eh from $1.95 \frac{p}{eh}$ down to $0.2 \frac{p}{eh}$, interpolating between the boson and ferm ion limit. (b) M agni ed region close to the ferm ion limit. Values displayed are everywhere given in units of $\frac{p}{eh}$.

Fig. 4 shows the behaviour of n for dierent values of _{eh} interpolating from the bosonic case ($_{eh} = 2^{O} \frac{1}{e_{h}}$) to the ferm ionic case ($_{eh}$ = 0). The crossover from bosonic to ferm ionic limit can be clearly seen: for $_{\rm eh}$ close to $2 \frac{1}{e}$, the curve behaves like \overline{n} , the deviations from this exact bosonic result becoming more pronounced with increasing n. For e^{-h} close to 2^{-h} , the curve initially behaves like $\lceil n \rceil$, the deviations from this exact bosonic result becoming more pronounced with increasing n. The curve is ultimately decreasing beyond a num ber of excitations which is smaller the greater the departure of $_{eh}$ from 2^{o} $_{eh}$. A fter the initial rise, as the overlap between electron and hole wavefunctions is sm all and bosonic behaviour is found, the decrease follow s as the density becom es so large that P auli exclusion becom es signi cant. Then excitons cannot be considered as structure-less particles, and ferm ionic characteristics em erge. W ith eh going to 0, this behaviour is replaced by a monatonically decreasing n, which means that it is

\harder and harder" to add excitons in the sam e state in the QD; the ferm ionic nature of excitons becom es m ore and m ore important.

An important quantity for single mode particles, especially in connection to their coherent features, is the (norm alised) second order correlator g_2 which in our case reads




FIG.5: Second order correlator $g_2(0)$ of the excitonic eld for Fock states jui given by Eqs. (15{16) as a function of $e_h = \frac{p}{e_h}$ which interpolates between the ferm ionic (0.5, 1 and 1.5) and bosonic (1:9, 1:95, $\frac{1}{p}$:99) lim its. Upper line corresponds to pure bosons ($e_h = 2\frac{p}{e_h}$). W ith increasing ferm ionic character the antibunching is very pronounced at high intensities. Close to the ferm ionic lim it, g_2 is always very sm all and vanishes quickly.

Note that regardless of the model, $q_2(0) = 0$ for n = 1. General results are displayed on Fig. 5. They correspond to the exciton eld which is the one of most interest to us, and could be probed in a two-photons correlation experiment with the light emitted directly by the exciton. We compare the result to the pure bosonic case where $n = \frac{P}{n}$ and therefore $g_2(0) = (n)$ 1)=n so that g_2 ! 1 with increasing number of particles which expresses the similarity of an intense Fock state with a coherent state (especially regarding their uctuations). In our case, how ever, the underlying ferm ionic structure results in an antibunching of excitons, i.e., the probability of nding two excitons at the same time is lowered at high exciton densities. C lose to the ferm ionic lim it, this antibunching is very pronounced and it is very unlikely to have more than one exciton in the system .

V. COUPLING TO A SINGLE RADIATION MODE OF A MICROCAVITY

We now present the emission spectra of the coupled cavity-dot system when the exciton eld is described by the creation operator X^{y} . The procedure is straightforward in principle and is a direct extension of the concepts discussed at length in the introduction. The ham iltonian assumes the same form as previously, but now with X as we de ned it for the matter- eld b:

If $_n$ does not vanish, the basis has +1 states in this manifold with last state j;0i having all photons transferred in the excitonic eld. In the case where $_n$ vanishes, the excitonic eld saturates and the further excitations are constrained to remain in the photonic eld.

Following the nom enclature laid down in the introduction, we write the dressed state j; i for the th eigenstate of the manifold with = n + m excitations (n excitons + m photons) and $c_n^{\,i} = hn$; nj; i its decomposition on bare states of this manifold, i.e.,

In cavity QED term inology, I_{end} and I_{lat} correspond to end{emission and lateral{emission photo{detection respectively, while in lum inescence of a microcavity, one observes the linear combination of the two contributions simultaneously. I_{lat} re ectsm ost the behaviour of the excitonic eld. To separate the two, one can make use of the scattering geom etry; in a pillar structure, for instance, the cavity photon emission is predom inantly through the end mirrors, so I_{lat} could be detected on the edge of the structure. These measurements display the most interesting features and we focus on them.




FIG. 6: (Color online) Spectra for various intensities of the light eld at specic values of $_{\rm eh}$: (a) close to the bosonic limit with $_{\rm eh} = 1.9^{\circ} \frac{1}{{\rm e} {\rm h}}$ for n = 1 (solid red), 2 (dashed blue) and 7 (dotted black) featuring a broadened and red-shifted Rabidoublet as the intensity increases and the onset of a multiplet structure, (b) intermediate case: $_{\rm eh} = \frac{p}{{\rm e} {\rm h}}$ for n = 2 (solid black) and 10 (dashed blue) demonstrating a complicated multiplet structure and (c) close to the ferm ionic case with $_{\rm eh} = 0.05 \frac{p}{{\rm e} {\rm h}}$ for n = 2 (solid black) and 10 (dashed blue) demonstrating a Mithematic case with $_{\rm eh} = 0.05 \frac{p}{{\rm e} {\rm h}}$ for n = 2 (solid black) and 10 (dashed blue) the black) and 10 (dashed blue) featuring quadruplet structure going towards M ollow triplet at high intensities.

Fig. 6 shows the calculated emission spectra I_{lat} of a QD embedded in a cavity. All the spectra are broadened by convolution with a Lorentzian of width 0:2g. Figs. (a), (b) and (c) are, respectively, the results close to the bosonic limit ($_{eh} = 1.99 \frac{1}{e}$), in between ($_{eh} = \frac{p}{e}$) and close to the ferm ionic limit ($_{eh} = 0.05 \frac{1}{e}$). Each curve is labelled with the number of excitations in the manifold, re ecting the intensity of the pumping eld. Fig. 6(a) shows a pronounced Rabidoublet in the case n = 1 (vacuum eld Rabisplitting) in accordance with the general theory set out in the introduction. Higher manifolds reveal nonbosonic behaviour, with a reduced Rabi splitting doublet when n = 2, and the onset of a multiplet structure when n = 5, where sm all peaks appear at E h (! 2g). The increase of dot con nem ent in the case $_{\rm eh}$ = e h in Fig. 6(b), makes deviations from bosonic behaviour more pronounced, so even for n = 2 a multiplet structure is observable. For higher manifold num bers, more lines appear, and a decrease of the splitting of the central Rabidoublet occurs. Further strengthening the con nement to $_{\rm eh} = 0.05 \, {\rm m}$ makes the manifestations of ferm ionic behaviour very clear; for n = 2, a quadruplet structure is seen, with the central two peaks alm ost merged. The situation is similar to the Mollow triplet of the exact ferm ionic lim it, even m ore so for an increase of manifold number from n = 2 to n = 10, where the separation of the side peaks grow s and the central ones m erge further. It can be seen from Fig. 6 that the decrease of the QD size and the corresponding change of the exciton quantisation regime (with $_{\rm eh}$ ranging from $2^{\rm p}$ $_{\rm eh}$ to 0) is manifest in the emission spectra as a transition from a Rabidoublet to a Mollow triplet. The increase of the excitation power (at xed QD size) leads qualitatively to the same e ect; ferm ionic behaviour becom es m ore pronounced with the increase of the excitation power and decrease of the QD size.

Having dem onstrated how our model interpolates be-




FIG.7: Energy diagram of the dressed excitons over the interval $_{\rm eh} 2$ [$2^{\rm o} - {\rm e} + i$;0] for the 7th manifold. The extrem al values recover the diagram s of Fig.1 with n + 1 equally spaced energy levels in nth dressed boson manifold (far left) and twofold energy diagram with square root splitting for dressed ferm ions (far right). The two outer boson energies connect sm oothly to the two ferm ion energies while the n 1 other one degenerate into a central line which disappears right when the system hits the Ferm i lim it (this point, $_{\rm eh} = 0$, is shown by circle).

tween Ferm i and Bose statistics, we now investigate in further detail the intermediate regime, by following the evolution of a single manifold between the two limits. In Fig. 7 the eigenvalues are displayed for the 7th manifold, also shown on Fig. 1 for bosons and fermions. Eigenvalues are plotted as a function of $_{\rm eh}$ running from $2 \frac{P}{e} \frac{1}{h}$, which recovers the left hand side of Fig. 1, to 0, which recovers the right hand side. O ther manifolds behave in qualitatively the same way. In all cases,

the n + 1 equally spaced energies of the dressed bosons link to the two energies of the dressed ferm ions as follows: the upper energy h! + hg of the Bose lim it links to the upper energy $h! + p^{-}hg$ of the Ferm i lim it, and the symmetric behaviour occurs with the lower limit, link-ing h! hg with h! p hg. M ore interestingly, the interm ediate energies degenerate from the equal spacing of the Bose lim it towards h! near the Ferm i lim it, with a discontinuity when 2 becomes zero and only two eigenenergies rem ain. Physically, this discontinuity arises because for any eh 6 0, form ally, an in nite number of excitations can be tted in the QD, i.e. n never becom es exactly zero, see Fig. 4. With eh approaching zero these modes couple to light more and more weakly, thus the energies of the dressed states become close to the bare energy $h! \cdot W$ hen $_{eh} = 0$ the ferm ionic regime is recovered and only two dressed eigenstates with energies h! hq survive.

A lthough the eigenvalue structure of the dressed excitons in the general case is simple and uniform, as is seen in Fig. 7, the multiplet structures which arises from it is, as has been seen in the spectra previously investigated, rich and varied. In the general case where

 $2^{p} \frac{1}{e + h} < e_{h} < 0$, two adjacent manifolds contain respectively n + 1 and n levels, transitions between any pair of which are possible. One may expect n (n + 1) lines in the emission spectra with a range of intensities and positions. The phenom enological broadening we have introduced leads to the decrease of the num ber of resolvable lines. In all cases the n = 1 to n = 0 transition provides only two lines, with constant energies throughout,




FIG. 8: Transition from Ferm i to Bose limits as observed in the optical emission spectra. (a) Superpositions of spectra for $_{\rm eh} = 2^{\rm O} \frac{1}{{\rm e}_{\rm h}}$ in front of the gure to $_{\rm eh} = 0$ at the back, recovering respectively the Rabi doublet and M ollow triplet. In the interm ediate region, intricate and rich patterns of peaks appear, split, m erge, or disappear. (b) Sam e data as in (a), but as a density plot on logarithm ic scale, to discrim inate the peaks, their positions and splitting as well as their relative intensities. All spectra are norm alized to m axim um intensity equal to 1.

because with only one exciton present the question of bosonic or ferm ionic behaviour is irrelevant. To access the consequences of exciton statistics, one must, unsurprisingly, reach higher manifolds.

In Fig. 8 we show the evolution of the spectra between the boson and ferm ion limits. They two panels are different projections of the same data, namely the multiplet structure as a function of $_{\rm eh} 2$ [$2 \frac{1}{e_{\rm eh}}$;0] for n = 12. The Rabidoublet is seen to evolve into a M ollow triplet going through a complex and intertwined set of peaks whose splitting and relative heights vary with the value of $_{\rm eh}$ considered. The spectrum obtained is therefore a direct probe of the underlying exciton quantum statistics. As a nal comment, we note that if Eq. (46) was to hold for all n, it would yield, apart from a renormalization by N, the D icke m odel³⁹, which has been widely used to describe various strong light-matter coupling phenom ena^{40,41}. In our model it is recovered when m = 1=N ^(m 1), a case that we have investigated in Ref. [42].

At the heart of D icke model lies the creation operator J_+ for an excitation of the \m atter eld" which distributes the excitation throughout the assembly of N identical two-levels system s described by ferm ion operators $_{i}$, so that b^{y} in Eq. (2) maps to J_{+} with

One checks readily that J_+ and $J_- = J_+^{\gamma}$ thus dened obey an angular momentum algebra with magnitude N (N + 1) (and maximum z projection of J_z equal to N). In this case the Rabi doublet arises in the lim it where the total number of excitations (shared between the light and the matter eld) is much less than the number of atom s, N, in which case the usual commutation relation $[J; J_+] = 2J_2$ becomes $[J = N; J_{+} = N]$ 1, which is the commutation for a bosonic eld. This com es from the expression of a Dicke state with excitations shared by N atom s given as the angularm om entum state j N =2 + i. Therefore the annihilation/creation operators J , $J_{\scriptscriptstyle +}$ for one excitation shared by N atom s appear in this lim it like renorm a lised bose operators $p \underline{N} a$, $N a^{\gamma}$, resulting in a Rabidoublet of splitting 2hg N. Such a situation corresponds, e.g., to an array of sm allQD s inside a m icrocavity such that in each dot electron and hole are quantized separately, while ourm odel describes a single Q D which can accomm odate several excitons. The corresponding em ission spectra are close to those obtained here below the saturation lim it

N, while the nonlinear regime N $\,$ 1, $\,$ 1 has peculiar behaviour, featuring non-lorentzian em ission line shapes and a non-trivial multiplet structure, like the \D icke fork".⁴²

VI. CONCLUSIONS AND PROSPECTS

The spectrum of light em itted by quantum dot excitons in leaky modes of a microcavity | which could be typically lateral em ission | is a signature of the quantum statistics of excitons. A multiplet structure has been theoretically predicted with various features which can help identify the exciton eld statistics. We provided the formalism to obtain the spectra expected for a general dot in various geometries based on the form of the single exciton wavefunction. We investigated a generic case analytically through a Gaussian approximation. The richness and speci city of the resulting spectra provides a means to determ ine, through the peak splittings and strength ratios, the parameter $_{\rm eh}$ that measures how close excitons are to ideal ferm ions or bosons. A lthough heavy num erical computations are required for realistic structures, physical sense motivates that in small dots a Ferm i-like behaviour of excitations with separately quantised electrons and holes is expected, while in larger dots behaviour should converge towards the Bose lim it. These trends should be observable in the nonlinear regime (where more than one exciton interacts at a single time with the radiation mode): depending on whether Rabi splitting is found, or if a M ollow triplet or a more complicated multiplet structure arises, one will be able to characterize the underlying structure of the exciton eld.

W e have left the discussion of the interaction between excitons out of the scope of the present paper considering the e ects which arise solely from P auli exclusion principle. The e ect of interactions, through screening of C oulom b potential by the electron-hole pairs, has been discussed in R efs. [37,43]. These papers demonstrate that the interactions will make ferm ionic behaviourm ore pronounced, since presence of other excitons screens the C oulom b interaction which binds electron and hole and leads to the increase of the B ohr radius. The question whether interactions will predom inate over P auli exclusion lies beyond the scope of this paper and we post-

pone it for a future work. Our prelim inary estimations show that even at moderate excitonic density the elect of screening is small and does not lead to strong qualitative deviations.⁴⁴

To sum marise, we have studied the e ect of Pauli exclusion on the optical emission spectra of microcavities with embedded QDs in the strong coupling regime. We derived general expressions for the exciton creation operator which allow systematic computation of the light-matter coupling. The crossover between bosonic behaviour observed in large QDs as Rabidoublet to the fermionic behaviour observed in smallQDs as Mollow triplet has been demonstrated.
