## M ott states under the in uence of ferm ion-boson conversion: Invasion of super uidity

I study the in uence of ferm ion-boson conversion near Feshbach resonances on M ott states of C ooper pairs and dem onstrate possible invasion of super uidity. The quantum dynam ics of Ferm i-Bose gases is studied using both an e ective coupled U (1) U (1) quantum rotor H am iltonian and a coupled X X Z X X Z spin H am iltonian. I also point out two distinct branches of collective m odes in super uid states, one of which involves anti-sym m etric phase oscillations in ferm ionic and bosonic channels and is always gapped because of ferm ion-boson conversion.

Recent activities on atom ic system s near Feshbach resonances have generated much interest. By varying the two-body scattering length near Feshbach resonances, several groups have successfully achieved ferm ionic super uid in a strongly interacting regim  $e^{1/2,3,4}$ . Super uid states near Feshbach resonances turn out to be related to the BCS-BEC crossover studied long time ago  $^{5,6,7,8}$  . This was recently pointed out by a few groups<sup>9,10,11,12,13,14</sup>. These groups have also made various e orts to incorporate the two-body resonance between C ooper pairs (open channel) and molecules (close channel) explicitly in the m any-body H am iltonian and clearly illustrated an interesting role of atom ic resonances. Near a Feshbach resonance the usual C ooper pairing am plitude and m olecule condensate wave function are proportional to each other; the Feshbach resonance introduces an e ective interaction between ferm ions, the interaction constant of which is  ${}^{2}_{\rm FB} = (2$ v). Here  $_{\rm F\,B}\,$  is the resonance width, v is the detuning energy of molecules and is the chemical potential of ferm ions.

In this letter I am going to study a M ott state under the in uence of Feshbach resonances, especially the effect of ferm ion-boson conversion. A M ott state of bosons or of C ooper pairs appears whenever bosons or C ooper pairs in lattices are strongly repulsively interacting and if the corresponding lling factors are integers. One of in portant properties of a M ott state is its incom pressibility, or a nite energy gap in its excitation spectra. And when hopping is renormalized to be zero due to repulsive interactions, the number of particles at each site is strictly quantized and discrete; particles are bcally conserved. I am going to show that in general M ott states are unstable with respect to ferm ion-boson conversion near Feshbach resonances. The primary reason is that ferm ions or bosons involved in resonating conversion are not conserved separately. So the conversion not only mediates an attractive interaction between ferm ions as realized before, but also, more importantly violates the local conservation law and introduces a novelm echanism to transport particles in some limit. The necessary condition for particles to be localized, or the num ber of ferm ions or bosons should be quantized m ight no longer exist. Ind the invasion of super uidity into a part of a param eter space where only M ott states are expected to be ground states if there are no Feshbach resonances.

The model I employ to study this subject is an M - orbit Ferm i-Bose Hubbard M odel (FBHM). Consider the following general form of FBHM

Here k, and label lattice sites, on-site orbits and = ";#.  $f_{k}^{Y}$ (f<sub>k</sub>) is the spins; = 1;2;::M, creation (annihilation) operator of a ferm ion at site k, with on-site orbital energy and spin  $b_{i}^{y}(\mathbf{b}_{k})$  is the creation (annihilation) operator of a boson at site k (For simplicity, I assume there is only one bosonic orbital degree of freedom at each site). The ferm ion and boson number operators are, respectively,  $\hat{n}_{bk}$  = ;  $f_k^{\mathtt{Y}} \ f_k$  .  $t_f$  and  $t_b$  are hopping in $b_k^{\gamma} b_k n_{fk} =$ tegrals of ferm ions and bosons respectively and hopping occurs over neighboring sites labeled as < kl>. is the attractive coupling constant in the Cooper channel which I assume to be much larger than the rest of couplings. F inally,  $V_{\rm f}$  ,  $V_{\rm b}$  and  $V_{\rm fb}$  are the strength of repulsive interactions between ferm ions, bosons, and ferm ions and bosons in the density-density channel<sup>15</sup> (O ne further assum es  $V_b V_f > V_{fb}^2$  to ensure that hom ogeneous states are stable). FBHM s sim ilar to Eq.(1) were previously applied to study Bose-Ferm im ixtures in optical lattices<sup>16</sup>; most recently an FBHM with ferm ion-boson conversion was generalized to study the BCS-BEC crossover in lattices<sup>17</sup>. In the absence of the conversion term, FBHM consists of decoupled (attractive) Ferm i-Hubbard model and Bose-Hubbard model; main properties of latter are know n<sup>18</sup>.

I rst study the large-n lim it where  $n_b$  and  $n_f$  (M), the average numbers of fermions and bosons are both much bigger than unity. Because is much larger than other coupling constants, the ground state of fermions for the on-site part of the H am iltonian H f should be a BCS state. This suggests that it should be convenient to work with the following coherent state representation,

Here v ;u are the coherence factor in the BCS wave function which m inizes the total on-site energy;  $g_0(n_{bk})$ is a unity for  $n_{max} + n_b > n_{bk} > n_b$   $n_{max}, n_{max}$  is much larger than one. These states form a low energy H ilbert subspace and are orthogonal in the lim it which interests us, or < f  ${}^0_{fk}$ g; f  ${}^0_{bk}$ g; f  ${}^f_{fk}$ g; f  ${}^f_{fk}$ g; f  ${}^f_{fk}$ g > is equal to zero if  ${}^f_{fk}$   $\mathfrak{f}^0_{fk}$  or  ${}^b_{bk}$   $\mathfrak{f}^0_{bk}$ . In the subspace spanned by the coherent states de ned above, I nd that the e ective H am iltonian is

The exchange couplings  $J_{\rm f}$  ,  $J_{\rm b}$  and  $_{\rm FB}$  can be estimated as

 $E = {}^{P} \frac{1}{(p_{f}^{2} + \frac{2}{0})}$  is the quasi-particle energy and 0 is the on-site BCS energy gap. Furtherm ore,  $n_{f}$  and  $n_{b}$  are functions of , v and  $V_{f,b;fb}$ :

O by iously, the detuning energy v has to be su ciently small in order for the population of bosons  $n_{\rm b}$  to be positive.

Eq.(3) and Eq.(4) de ne the low energy quantum dynamics of fermions and bosons under the in uence of ferm ion-boson conversion near Feshbach resonances. In the absence of both Feshbach resonances ( $_{FB} = 0$ ) and V<sub>fb</sub>, the e ective H am iltonian describes two decoupled sets of quantum U (1) rotors in a lattice, the behaviors of which are well known. If  $n_f = 2 \text{ or } n_b$  is a positive integer, the e ective model can be used to study super uid-M ott state transitions. A Mott phase corresponds to U (1) symmetry restored states and U (1)-symmetry breaking solutions represent a super uid phase. For the bosonic (Cooper pair) sector, the phase transition takes place when  $r_f = zJ_f = V_f$  ( $r_b = zJ_b = V_b$ ) is equal to a critical value  $r_{fc}(r_{bc})$  (z (> 1) is the coordination number). The critical values which are of order of unity are usually calculated num erically.

In the presence of  $_{\rm FB}$ , the H am iltonian describes a coupled U (1) U (1) quantum rotor model in a lattice. U (1) U (1) symmetry breaking solutions when both  $r_{\rm f,b}$  are much larger than unity correspond to a super uid phase. In the super uid phase, the H am iltonian in Eq.(4) further leads to the following sem iclassical equation of motion in the long wave length limit

Here  $\hat{n}_{fk,bk} = \hat{n}_{fk,bk}$   $n_{f,b}$ . I have taken a continuum lim it and k labels the coordinate of phases of bosons and ferm ion pairs ( $_{fk,bk}$ ) in this equation; is a Laplacian operator. The lattice constant has been set to be one. This sem iclassical equation shows that there are two branches of collective m odes the dispersion relations of which are given below:

 $_{f;b}$  (!;Q) are the Fourier components of phase elds  $_{fk;bk}$  (t). In general,  $_0$ , and depend on various

parameters in the Ham iltonian; and  $_0$  is always proportional to  $_{\rm FB}$  and on the other hand is independent of  $_{\rm FB}$ . When  $V_{\rm fb}$  = 0,  $V_{\rm f}$  =  $V_{\rm b}$  =  $V_0$  and  $J_{\rm f}$  =  $J_{\rm b}$  =  $J_0$ , the dispersion relations are given as  $_0^2$  = 2  $_{\rm FB}V_0$ , = =  $2J_0V_0$ .

It is worth emphasizing that in the long wave length lim it, mode a) is fully symmetric in phase oscillations of ferm ions and bosons, independent of various parameters; mode b) represents out-of-phase oscillations in ferm ionic and bosonic channel and becomes fully antisymmetry when  $V_b = V_f$ . In the absence of conversion ( $_{FB} = 0$ ), these two modes correspond to two gapless Goldstone modes associated with breaking two decoupled U (1) symmetries. However, in the presence of Feshbach resonances only the symmetric mode a) remains gapless corresponding to the usual Goldstone mode of super uid while the antisymmetric mode b) is fully gapped because of the phase-bocking elect of Feshbach resonances.

In general, the wave functions for the many-body ground state and excitations  $_n$  (f  $_{bk}g$ ; f  $_{fk}g$ ) (n = 0 is the ground state) are the eigenstates of the Ham iltonian in Eq.(4). The boundary conditions are periodical along the directions of  $_{fk,bk}$  with a period 2 , so the wave functions are electively de ned on an  $^{\circ}S^1$  torus with radius of each S $^1$  equal to 2 . If the average num ber  $n_f=2$  and  $n_b$  are integers, one introduces a gauge transform ation !  $_k \exp($  in  $_f f_k=2$  in  $_b b_k$ ); the shifted num ber operators become  $\hat{n}_{fk}=2 = i (e_{fk}, \hat{n}_{bk} = i (e_{bk})$ . In this new basis, a spontaneous-symmetry breaking solution with wave function

 $f_{k}$  (fk 0) (bk 0) represents a typical superuid state.  $f_{0}$  symmetry-unbroken solution with wave function (2)<sup>1</sup> exp(im fk fk) exp(im bk m k) (m fk,bk = 0 for all k) on the other hand corresponds to a M ott state with  $\hat{n}_{fk(bk)} = 0 \text{ or } \hat{n}_{fk(bk)} = n_{f(b)}$  at each lattice site.

To understand the in uence of Feshbach resonances on M ott states, I now consider a situation where again both  $n_{\rm b}$  and  $n_{\rm f}$  =2 are integers and  $r_{\rm f}$  is much less than r<sub>fc</sub> so that Cooper pairs are in a M ott state in the absence of Feshbach resonance. On the other hand rb is much less than the critical value  $r_{bc}$  so that bosons are condensed. For simplicity, I have also assumed that V<sub>bf</sub> is much smaller than V<sub>f</sub> so that it can be treated as a perturbation. I am interested in the responses of C ooperpair M ott states to ferm ion-boson conversion and carry out the rest of discussions in a mean eld approximation (MFA). In this MFA,  $f_k = f_k$ ,  $f_k = b_k$  for any lattice site k. The ground state  $_0$  ( $_b$ ;  $_f$ ) (again de ned on an  $S^1$  $S^1$  torus with radius 2 ) is the lowest energy state of the following mean eld Hamiltonian

Here again z is the coordination number; I have also in-

troduced two self-consistent order param eters

Here <> stands for an average taken in the ground state. Notice that the order parameters de ned above are nonzero only when the U (1) symmetries are broken; particularly, f is proportional to the usual BCS pairing amplitude. Following Eq.(2) and discussions above one indeed shows that <  $f_k^y \ _{k} f_k^y = (u \ v) f$ , <  $b_k^y >= \frac{p}{n_b} b^{19}$ . And  $f_{ib}$  vanish in a Mott state and are nonzero for super uid states.

As  $zJ_b$  is much larger than  $V_b$ ,  $_b$  has very slow dynam ics; and the corresponding ground state for  $_b$  can be approximated as a symmetry breaking solution. That is

Here  $_{\rm b}$  should be approximately equal to one in this limit; and in the zeroth order of V<sub>f</sub><sup>1</sup>,  $_{\rm 0f}$  doesn't break the U (1) symmetry and stands for a M ott-state solution. Finally taking into account Eq.(10) and (11), one nds that the self-consistent solution to  $_{\rm f}$  is

In the absence of  $_{\rm FB}$ ,  $_{\rm f}$  vanishes as expected for a M ott state. However, the M ott state solution is unstable in the presence of any Feshbach conversion and the pairing order parameter  $_{\rm f}$  is always nonzero in this lim  ${\rm it}^{20}$ .

I want to emphasize that the average number of ferm ion per site is not a ected by the ferm ion-boson conversion and remains to be an even integer (21); rather, closely connected with the instability is the breakdown of particle quantization. Indeed, one obtains in the M FA the following results for  $\hat{n}_{fk}$ ,  $\langle \hat{n}_{fk} \rangle = n_f = 2I$ ,  $\langle {}^2\hat{n}_{fk} \rangle = 1=2({}_{FB}=V_f)^2 2 {}^2_f$ . This illustrates that the resonance between states with di erent numbers of ferm ions at a lattice site eventually leads to a nonzero pairing amplitude f.

However, if  $r_{\rm o;f}$  are much smaller than  $r_{\rm bc;fc}$ , then both Cooper pairs and bosons are in M ott states. Similar calculations lead to self-consistent solutions f = b = 0 and m ore in portantly, the following correlations for  $bf = < \cos(b - f) > 19$ ,

The second equality above simply shows the absence of super uidity. But the rst one indicates a subtle hidden order in the M ott states under consideration. Notice that  $b_{\rm f} < b_{\rm k}^{\rm Y} f_{\rm k} \ {}_{\rm r} f_{\rm k} \ {}_{\rm s} >$  and represents a tri-linear order.

The main conclusions arrived here do not depend on the large-n approximation introduced here. One can consider the opposite limit by assuming M = 1 and there is only one orbital degree of freedom at each lattice site. The two interaction terms (with two interaction constant and  $V_f$ ) in  $H_f$  (see Eq. (1)) in the single orbital limit can be rewritten in one term:  $V_f^{0}=4_k \hat{n}_{fk}(\hat{n}_{fk} = 1)$  if one idential es  $V_f^{0} = V_f = 2$ . In the limit where is much larger than  $V_f$  form ions are paired at each lattice site.

larger than  $V_{\rm f}$ , ferm ions are paired at each lattice site. Furtherm ore I assum e bosons have hard core interactions ( $V_{\rm b}$  = 1 ) such that there can be only zero or one boson at each site.

So the low energy Hilbert subspace Sk at each lattice site k consists of four states: 1) no Cooper pair, no boson; 2) no Cooperpair, one boson; 3) one Cooperpair, no boson; 4) one Cooper pair, one boson. They also correspond to a product of two pseudo spin S = 1=2 subspaces:  $S_{bk}$ ,  $j_{fk}^{z} = 1 > 2 S_{fk}$ ,  $j_{bk}^{z} = 1 > 2 S_{bk}$ ;  $S_k = S_{fk}$  $S_k$  is the on-site H ilbert space, and  $S_{{\rm f}\,k\,;bk}$  are the on-site pseudo spin spaces for ferm ions and bosons respectively.  $j_{fk}^{z} = 1 > = f_{k}^{y} f_{k\#}^{y} jvac > f, j_{bk}^{z} = 1 > = jvac >_{f};$  $j_{bk}^{z} = 1 > = b_{k}^{y} jvac >_{b}, j_{bk}^{z} = 1 > = jvac >_{b}.$ jvac  $>_{f;b}$  are the vaccuum of ferm ion and bosons respectively. Finally, in this truncated subspace, the following identities hold  $f_k^+ = f_k^y f_{k\#}^y$ ,  $f_k = f_{k\#} f_{k"}$ ,  ${}^{z}_{fk} = 2f^{y}_{fk} f^{y}_{fk\#} f_{fk\#} f_{fk}$  1;  ${}^{+}_{bk} = b^{y}_{k}$ ,  ${}^{bk}_{bk} = b_{k}$ ,  $_{bk}^{z} = 2b_{k}^{y}b_{k}$  1. So to have super uidity, either  $_{bk}$ or fk, or both of them need to have a nite expectation value in the XY plane. For instance to have ferm ionic super uid, the expectation values of fk need to be nonzero.

The e ective Ham iltonian can then be written as<sup>19</sup>

Here  $J_f^1 = t_f^2 = V_f^0$ ,  $J_b^1 = t_b$ ,  $J_{FB}^1 = J_{FB}^2$ ,  $h_f^2 = + V_f^0 = 2$ and  $h_b^2 = v=2$ . The Ham iltonian is invariant under a rotation around the z-axis or has an X Y symmetry. The z-direction fully polarized phase of pseudo spins  $_{bk}$ ( $_{fk}$ ) represents the M ott phase of bosons (ferm ions) and the X Y symmetry breaking states of pseudo spins  $_{bk}$ ( $_{fk}$ ) stand for the super uid phase of bosons (ferm ions). The ferm ionic sector of this Ham iltonian was previously obtained and studied<sup>21</sup>; it was also used to study BEC – BCS crossover in lattices<sup>17</sup>.

W hen  $\frac{1}{FB} = 0$ , the M ott phase of C ooper pairs with lling factor equal to one occurs when  $h_{f}^{z}$  is much larger than  $J_{\rm f}$  . A ssum e that in this case  $h_{\rm b}^{\rm z}$  is much less than  $J_{\rm b}$ so that bk are ordered in the xy plane; then bosons are condensed. Taking into a nite amplitude of  $\frac{1}{FB}$ , one considers a solution where the pseudo spin symmetry of bk is spontaneously broken along a direction in the XY plane speci ed by < bk > (the expectation value is taken in the ground state). In them olecularm ean eld approximation, the e ective external eld acting on pseudo spins  $_{\rm fk}$  is  $h_{\rm f;eff}$  =  $zJ_{\rm f}$  <  $_{\rm fk}$  > +  $_{\rm FB}^1$  <  $_{\rm bk}$  > +  $h_{\rm f}^ze_z$ ; and < fk > is calculated self-consistently in the ground state when h<sub>f;eff</sub> is applied. One then arrives at the following lies in the X Y plane. A sm entioned before, developm ent of such a component signi es super uidity, or nonzero pairing am plitude.

In conclusion, I have shown that certain M ott states are unstable with respect to the resonating ferm ion-boson conversion; in general super uidity invades M ott phases because of the ferm ion-boson conversion.
