The spherical 2 + p spin glass m odel: an analytically solvable m odel with a glass-to-glass transition.

We present the detailed analysis of the spherical s + p spin glass model with two competing interactions: am ong p spins and am ong s spins. The most interesting case is the 2 + p model with p 4 for which a very rich phase diagram occurs, including, next to the paramagnetic and the glassy phase represented by the one step replica sym metry breaking ansatz typical of the spherical p-spin model, other two am orphous phases. Transitions between two contiguous phases can also be of di erent kind. The model can thus serve as mean-eld representation of am orphous-am orphous transitions (or transitions between undercooled liquids of di erent structure). The model is analytically solvable everywhere in the phase space, even in the lim it where the in nite replica sym metry breaking ansatz is required to yield a therm odynam ically stable phase.

Spin glasses have become in the last thirty years the source of ideas and techniques now representing a valuable theoretical background for \com plex system s", with applications not only to the physics of am orphous m aterials, but also to optim ization and assignment problem s in com puter science, to biology, ethology, econom y and

nance. These systems are characterized by a strong dependence from the details, such that their behavior cannot be rebuilt starting from the analysis of a 'cell' constituent but an approach involving the collective behavior of the whole system becomes necessary. One of the feature usually expressed is the existence of a large num ber of stable and m etastable states, or, in other words, a large choice in the possible realizations of the system and a rather di cult (and therefore slow) evolution through m any, details-dependent, interm ediate steps, hunting its equilibrium state or optim al solution.

M ean- eld m odels have largely helped in com prehending m any of the m echanism s yielding such com plicated structure and also have produced new theories (or com bined am ong each other old concepts pertaining to other

elds) such as, e.g., the spontaneous breaking of the replica symmetry and the ultrametric structure of states.

Am ong mean- eld models spherical models are analytically solvable even in the most complicated cases. Up to now only spherical models with one step Replica Symmetry B reaking (IRSB) phases were studied, mainly due to their relevance for the fragile glass transition.^{1,2,3} The possibility of the existence of Full Replica Symmetry B reaking (FRSB) phases in spherical models was rst pointed out by N ieuwenhuizen⁴ on the basis of the sim - ilarity between the replica free energy of some spherical models with multi-spin interactions and the relevant part of the free energy of the Sherrington-K inkpatrick (SK) model.^{5,6} A complete analysis, how ever, was not provided up to now. The problem has been considered some years later⁷ in connection with the possible di erent scenarios for the critical dynam ics near the glass transition.⁸

fore analyzing only the dynam ical behavior in the 1RSB phase.

The model we present here, the 2 + p spherical spin glass model, displays four di erent phases: together with the replica symmetric, the 1RSB and the FRSB phases also a new phase occurs. The evidence for the existence of such peculiar am orphous phase has been rst presented in Ref. 9 and, for what concerns the organization of the states, it seems to yield the properties of a glass up to the rst level of the ultram etric tree (i.e. inside and just outside a valley of the free energy landscape) and those of a spin-glass above.

Concentrating on the study of am orphous m aterials, in recent years som e evidence has been collected for the existence of am orphous to am orphous transition (AAT), in certain glass-form ing substances. One way of looking at an AAT has been to consider the kinetics of the coordination transform ation occurring in strong glasses such as the vitreous G erm ania (G eO $_2$ - from fourfold to sixfold coordination rising the pressure) and Silica (SiO $_2$ from tetrahedral to octahedral coordination).¹⁰ Exactly as for the liquid-glass transition also this transition is not a therm odynam ic one, but it am ounts to a qualitative change of the (slow) relaxation dynam ics, apparently expressing a recombination of the glass structure (see also the num erical simulations of Ref. 11 for a di erent point of view). Another kind of pressure induced AAT takes place in densi ed porous silicon, where the high-density am orphous Sitransforms into a low density am orphous Siupon decompression.¹² A similar transition also takes place in undercooled water.13

Theoretical models have been introduced to describe an AAT.As, for instance, a model of hard-core repulsive colloidal particle subject to a short-range attractive potential that induces the particle to stick to each other.^{14,15,16} In the framework of the Mode Coupling Theory (MCT) it has been shown that the interplay of the attractive and repulsive mechanisms results in the existence of a high (er) tem perature \repulsive" glass, where the hard-core repulsion is responsible for the freezing in of many degrees of freedom and the kinetic arrest, and a low (er) tem perature \attractive" glass that is energetically more favored than the other one but only occurs when the therm al excitation of the particles is rather sm all. Such theoretical and num erical predictions seem to have been successfully tested in recent experiments.^{17,18,19} A nother model where AAT is found is the spherical p-spin model on lattice gas of Caiazzo et al.²⁰ where an o -equilibrium Langevin dynamics is considered, thus going beyond the MCT assumption of equilibrium. The model we consider here m ight, as well, be a good mean- eld representative of an am orphousam orphous transition.

The goal of this paper is to give a detailed discussion of the di erent solutions describing the low temperature phase of the spherical 2 + p spin glass model. As it happens in system s with a phase described by a 1R SB solution one must distinguish between the \static solution" obtained from the partition function and the \dynam ic solution" obtained from the relaxation dynam ics.^{2,21,22} To keep the length of the paper reasonable we shall consider in detail only the static approach and introduce the the dynam ic solution with the help of the com plexity.²³ The com plete dynam ic approach will be presented elsewhere.

In section I we present the spherical 2 + p spin-glass model. In section II its static behavior is studied with the help of the replica trick²⁴ and the Parisi replica symmetry breaking scheme:²⁵ four di erent phases occur, together with the relative transitions between them . The nature of the phases is thoroughly discussed and analytical exact solutions for order param eters, transition lines and therm odynam ic functions are provided all over the parameter space. In section III the existence of an exponential num ber of energetically degenerate pure states is considered by analyzing the complexity function. The connection between the \m arginal condition" (m axim um of the complexity in free energy) and the dynam ical solution leads, in section IV to the discussion of the latter in those cases where it di ers from the static one. In Appendix A and B we show, respectively, the Parisi anti-parabolic equation for the 2 + p m odel, and its analytical solution. In appendix C som e basic features of the behavior of the much sim plers + pm odel (s, p > 2)are given.^{7,26} Eventually, in appendix D, a proof is given that no phases other than those here presented exist for the spherical 2 + p spin glass m odel.

I. THE MODEL

The spherical 2 + p spin glass model is de ned by the H am iltonian

where p is an integer equal or larger than 3 and $_i$ are N continuous real spin variables which range from 1 to +1 subject to the global spherical constraint

The coupling strengths $J_{i_1:::i_p}^{(p)}$ (p = 2; 3; :::) are quenched independent identical distributed zero mean G aussian variables of variance

The scaling with the system size N ensures an extensive free energy and hence a wellde ned therm odynam ic lim it N ! 1 . W ithout loosing in generality one may take either J_2 or J_p equal to 1 since this only amounts in a rescaling of the temperature T. To keep the discussion as simple as possible in this paper we shall not consider the e ect of an external eld coupled linearly with the spin variables $_i$.

The properties of the model strongly depend on the value of p. For p = 3 the model reduces to the usual spherical p-spin spin glass model in a eld with a low temperature phase described by a 1R SB solution. For p > 3 the model exhibits di erent low temperature phases which, depending on the temperature and the ratio $J_p=J_2$ between the strength of the non-harm onic and the harm onic parts of the H am iltonian, are described by 1R SB and/or FR SB solutions.

II. THE STATIC SOLUTION

The static solution is obtained from the minimum of the free-energy functional computed from the partition function. The model contains quenched disorder and hence the partition function must be computed for xed disorder realization: 27,28,29

with $= 1=T \cdot W$ e have explicitly shown the dependence of the Ham iltonian on the realization of the random couplings to stress that Z_N is itself a function of the couplings realization. The trace over the spins is de ned as:²

and includes the spherical constraint (2). As a consequence Tr (1) is equal to the surface of the N dimensional sphere of radius N $^{\rm 1=2}$ and its logarithm gives the entropy of the model at in nite temperature.

The partition function $Z_{\,N}\,$ is a random variable, therefore the quenched free energy per spin is given by

The therm odynam ic lim it N ! 1 of the free energy = $\lim_{N \ ! \ 1} N$ is well de ned and is equal to the lim it $\lim_{N \ ! \ 1} \ln Z_N [J^{(2)}; J^{(p)}] = N$ for alm ost all coupling realizations (self-average property).

The analytic com putation of the quenched free energy, i.e., of the average of the logarithm of the partition function, is quite a di cult problem, even in simple cases as nearest neighbor one dimensionalm odels. Since the integer moments \overline{Z}_N^n of the partition function are easier to compute, the standard method to evaluate (6) uses the so called \replica trick" by considering the annealed free energy (n) of n non-interacting identical 'replicas' of the system, 28,29,30

The quenched free energy is then recovered as the continuation of (n) down to the unphysical limit $n = 0^{31}_{r}$

In the last equality we assumed that the replica limit n ! 0 and the therm odynamic limit N ! 1 can be exchanged. The existence of such a limit has been recently rigorously proved.^{32,33}

The replica method gives a simple way of perform ing the disorder average, at the expenses of introducing an elective interaction among dilerent replicas in the ndimensional replica space. The interested reader can ind a detailed presentation of the replica method for disordered systems in Refs. [28] and [29] and for the particular case of spherical models in Ref. [2].

Applying the replica m ethod the integer m om ents of the partition function of the spherical 2 + p spin glass m odel can be written, neglecting all unnecessary constants and term s irrelevant for N ! 1, as?

The spherical constraint, Eq. (2), in plies that the diagonal elements of the matrix q are all equal to one: q = $\overline{q} = 1$.

In the therm odynam ic lim it N ! 1 the integrals in (10) can be evaluated by the saddle point m ethod and the quenched free energy per spin reads:

where G[q]m ust be evaluated on the solution of the saddle point equation which, in the n ! 0 lim it, reads:

Stability of the saddle point calculation requires that the quadratic form

must be positive de nite. Here above q = q (= q) is the uctuation of q from the saddle point value (16). Details of the derivation of these equations can be found in Ref. [2].

The structure of the overlap matrix q re ects the organization of the di erent therm odynam ic states, called pure states, in which each replica can be found. This how ever does not follow from the replica calculation and therefore to evaluate explicitly G [q] som e ansatz on the structure of q m ust be in posed.

A. The Replica Symmetric Solution (RS)

The simplest ansatz is the one in which all replicas are in the same pure state, so that q cannot depend on the replica indexes:

This is called the Replica Symmetric (RS) ansatz. This assumption is reasonable for coupling strengths not too large or high temperatures, i.e., $_2$ and $_p$ sm all enough. In both cases, indeed, the system can explore almost the whole available phase space so that di erent replicas will be found in the same pure state.

Inserting the RS form (18) of q into Eq. (11) one gets

In absence of external elds the saddle point equation always adm its the \param agnetic" solution q = 0. How ever since $q=(1 \quad q)^2$ diverges as $q! \quad 1$ and vanishes for q = 0 for particularly chosen values of the param eters $_p$ and $_2$ there may also be solutions with 0 < q < 1.

The RS solution is stable, i.e. the quadratic form (17) is positive de nite for n ! 0, provided that the eigenvalue³⁴

is positive. If $q \in 0$ then dividing the saddle point equation (20) by q and adding the result to (21) one gets that the requirement $_1 > 0$ is equivalent to

This inequality cannot be satis ed for any q > 0, thus we are left with the q = 0 solution only.

For q = 0 the eigenvalue 1 reduces to 1 = 1 2. Therefore, in the (p; 2) plane the param agnetic RS solution q = 0 is stable everywhere below the 2 = 1 line, which represents the D e A lm eida-Thouless line³⁵ of the m odel.

The instability of the param agnetic solution is due to the presence of the quadratic term in the H am iltonian. If this is m issing, as for example in the spherical 3 + p spin glass model in which the two-body interaction is replaced by a three-body interaction, the param agnetic solution is stable everywhere in the phase space, similarly to what happens for the spherical p-spin model without a eld².

B. The One Step Replica Symmetry Breaking Solution (1RSB)

The stability of the RS solution q = 0 does not depend on $_p$. However, from the analogies with the spherical pspin spin glass model we expect that for $_p$ large enough a solution with a non vanishing order parameter of the 1RSB type m ight lead to a therm odynam ically m ore favorable phase.

The 1RSB solution corresponds to group the n replicas into n=m clusters of m replicas. Any two replicas

• within the same cluster have overlap q_1 , whereas replicas in di erent clusters have overlap $q_1 < q_1$. As a consequence the n n q matrix breaks down into (n=m) (n=m) blocks of dimension m m. If the element q with ϵ belongs to one of the diagonal block then q = q_1 , otherwise q = q_0 . The overlap m atrix for the 1R SB ansatz can be conveniently written as:

The solution of these equations depends on the value of m that, in the limit n ! 0, is restricted to the interval 0 m 1. In principle any value of m which leads to a stable 1R SB solution can be chosen. However in the spirit of the saddle point calculation perform ed to evaluate the free energy we choose for any value of $_{\rm p}$'s the value of m which m inimize the functional G [q].³⁷ This leads to the additional equation

The stability analysis of the 1R SB saddle shows that in the limit n ! 0 the 1R SB solution is stable as long as the 1R SB eigenvalues³⁴

are both positive.

The saddle point equation (28) adm its always the solution $q_0 = 0$. It may also have solutions with $0 < q_0 < 1$,

however by using arguments similar to those that lead to the inequality (22) for the RS solution, one can show that in absence of external eld any 1RSB solution with $q_0 > 0$ is unstable since it has a negative $\begin{pmatrix} 3 & 38 \\ 0 & \cdot \end{pmatrix}^{(3)}$.

The 1RSB saddle point equations for q_1 and m can be solved for any p using the same procedure used for the spherical p-spin spin glass model. The rst step is to obtain $g(q_1)$ from equation (30) [w ith $q_0 = 0$] and divide it by q_1 (q). Then using the saddle point equation (29) [w ith $q_0 = 0$] to express (q) one ends up w ith the equation

is the auxiliary z-function introduced by C risanti and Sommers² (CS) for the solution of the spherical p-spin spin glass model, and

By using y and m as free parameters eqs. (29) [w ith $q_0 = 0$] and (33) can be solved for ($_p$; 2). A straightforward algebra leads to:

By xing the value ofm in the interval [0;1] and varying y these equations represent the parametric equations of the so called m-lines in the (p; 2) plane. By de nition y can take any value between 0 and 1 included, how ever, from Eq. (37) we see that since z(0) = 0, 2 becomes negative for y su ciently close to 0. Setting 2 = 0 from Eq. (37) one gets

which gives the minimum value $y_{m in}$ of y. The CS zfunction (34) is a monotonous increasing function of y varying in the range 0 z 1, as a consequence, p is always non-negative.

A second condition on y comes form the stability analysis of the 1RSB solution. A simple inspection shows that $\binom{(1)}{1} > \binom{(3)}{0}$ so that the condition which marks the

Both boundary values $y_{m in}$ and $y_{m ax}$ are functions of p only. For example, for p = 3, we have

The fact that for p = 3 the maximum is $y_{m ax} = 1$ makes the 2+ 3 m odeldi erent from any other 2+ p m odelwith p > 3, as we shall see in a while.

From the stability condition (39) it follows that if the quadratic term in the Ham iltonian were missing, as for the already mentioned $3 + p \mod 2$, then the 1R SB solution would be stable everywhere. In the Appendices C and D we shall show that indeed in this case the 1R SB solution is the only possible non-trivial solution, besides the RS solution.

1. The Transition Lines between the Param agnet and the 1RSB-G lass phase

To nd the transition lines which bound the 1RSB phase we start by noting that them -lines do not cross and that the value of $_2$ for which the 1RSB becomes unstable increases as m decreases, see Eq. (39). Moreover, all m-lines start from $_2 = 0$. As a consequence the rstm - line one encounters in moving from the RS phase at xed $_2 < 1$ and increasing $_p$ is the m-line with m = 1. This line, which m arks the transition between the RS (paramagnetic) phase and the 1RSB (glass) phase, starts on the $_p$ axis at the point $_p = _p$ (ym in; m = 1) and goes up to the point $_p = _p$ (ym ax; m = 1) and $_2 = 1$, as can be easily seen from Eq. (39) evaluated for m = 1.

The transition between the RS (q = 0) and the 1RSB ($q_1 \notin 0, q_0 = 0$) phases is not due to an instability but occurs because the 1RSB solution leads to a therm odynam ically more favorable state. Since we are dealing with the replica trick, thism eans that the 1RSB solution yields a value of the free energy functional (15) larger than the RS solution.³⁷

This mechanism resembles that of ordinary rst order transitions, and indeed the order parameter q_1 jumps discontinuously from zero to a nite value, and vice-versa, at the transition. However, the free energy remains continuous across the transition {at m = 1 the free energies of




FIG.1: The RS and 1RSB phases for the $2 + 4 \mod 1$ m odel in the (4; 2) plane. The thick lines are the transition lines between di erent phases.

the two solutions are equal and no discontinuity occurs in its rst derivatives.

The 1RSB solution becomes unstable when $_{0}^{(3)} = 0$. This leads to a second transition line whose parametric equation in the ($_{p}$; $_{2}$) plane is obtained by setting $y = y_{m ax}$ into eqs. (36)-(37) and varying m from 1, to 0. For m ! 0 the values of both $_{p}$ and $_{2}$ diverge but

and hence the 1RSB phase does not cover the full \bw tem perature" phase of the m odel.

In Figure 1 the transition lines found so far are shown together with the m -lines with m = 0.7; 0.5. In the gure p = 4, but any p > 3 leads to a qualitatively similar scenario.




FIG.2: The phase diagram of the 2 + 3 m odel in the $(_3;_2)$ plane. The thick lines are the transition lines between the RS and 1RSB phases. In particular the thick dashed line, the m -line with m = 1, is the discontinuous transition while the horizontal thick full line is the continuous transition.

A long this line $q_1 = 0$, see e.g. Eq. (35), and the 1R SB solution reduces to the RS solution. We have seen that the RS solution becomes unstable for $_2 = 1$ thus the critical line (44) m arks the transition between the RS and the 1R SB phases. The transition is continuous in both the free energy and the order parameter q_1 . The transition lines for the 2 + 3 m odel are shown in Figure 2. In conclusion the 2 + 3 m odel presents only one \low tem perature" phase of 1R SB type and, in this respect, is equivalent to the spherical p-spin spin glass m odel in a eld².

C . The One-Full R eplica Sym m etry B roken Solutions (1-FRSB)

From Figure 1 one clearly sees that for p > 3 the RS and 1RSB solutions do not cover the whole phase space

of the 2 + p m odel. In the region where both the RS and 1RSB solutions are unstable the organization of pure states has a more complex structure which cannot be described by a simple 1RSB ansatz which groups them into n=m equivalent clusters. Therefore, to describe this region one m ust allow for clusters of di erent type. To this end each one of the n=m clusters is divided it into $m = m_1$ sub-cluster of size m_1 . If the procedure is repeated R times, dividing at each step the smallest clusters into yet smaller clusters, one has the R-RSB ansatz in which the replica symmetry is broken R-times. The overlap q between two replicas depends on the num ber of divisions separating the o spring clusters to which the replicas and belong from the common ancestor cluster.

A simple way proposed by Parisf²⁵ to param etrize the overlap matrix q for R steps in the replica symmetry breaking consists in dividing q into successive boxes of decreasing size p_r , with $p_0 = n$ and $p_{R+1} = 1$, and assigning the elements q of the matrix q so that

The number R is arbitrary. Setting R = 0 or R = 1one recovers respectively the RS and the 1RSB expressions, the latter with $m = p_1$, while for R ! 1 one gets the 1 -RSB solution or Full Replica Symmetry Broken (FRSB) solution. In this limit the di erences p_{+1} p become in nitesimal and the set of overlaps fq;:::;q_R g is replaced in the limit n ! 0 by a non-decreasing continuous function q(x) de ned on the intervalx 2 [0;1].

The free energy functional (46) for the Parisi R-RSB ansatz can be conveniently expressed by using the function

This expression is valid for any R, and hence also for the FRSB solution. In the limit R ! 1, q_r becomes continuous and we can de neq(x) as the inverse of x (q). It can be shown that dx (q)=dq gives the probability density of overlaps.^{25,41}

It is easy to verify that taking for q(x) = 0 or $q(x) = q_1$ (x m) the above functional reduces to those found with the RS and 1RSB ansatzs, respectively.⁴²

The FRSB solution with a continuous q(x) was introduced to describe the spin-glass phase of the SK m odel,²⁵ and since then it has been found in many other related m odels. A continuous order parameter function q(x) is, however, not general enough to describe the state of the 2 + p m odel with p > 3 in the whole parameter space. From the stability analysis of the 1RSB solution we see indeed that the instability occurs because the eigenvalue

 $_{0}^{(3)}$ vanishes. This eigenvalue is associated with uctuations that involve the overlaps of one cluster as a whole with the other clusters as a whole.² Roughly speaking these uctuations are similar to uctuations in the RS phase with single replicas replaced by the clusters of m replicas considered as single entities. As a consequence we expect that, as it happens for the uctuations in the RS phase, a non zero overlap q_0 between clusters would stabilize the uctuations. The solution how ever cannot be of 1R SB type since we have seen that any 1R SB solution with $q_0 \in 0$ is unstable.

Based on the analogy with the instability of RS solution with clusters playing the role of single replicas, it turns out that the correct ansatz for the 2 + p model with p > 3 is a mixture of 1RSB and FRSB, which we have called 1-FRSB solution,⁹ described by a discontinuous order parameter function in the interval [0;1] of the




FIG.3: Schematic form of the order parameter function q(x) in the 1-FRSB phase.

where q(x) is a non-decreasing continuous function in the sem i-open intervalx 2 [0;m), with $\lim_{x \le m} q(x) = q_0 < q_1$ and q(0) = 0,³⁸ see Fig. 3. For $q_0 = q_1$ one recovers the FRSB solution.⁴³ In appendix D we show that the 1-FRSB solution is the only other possible non-trivial solution, beside the 1RSB (modeling a mean-eld glass) and the FRSB (modeling a spin-glass) ones, for the 2+ p model with p > 3. It is interesting to note that this solution also follows by solving numerically in the whole interval [0;1] the Parisi equations derived from the stationarity of the functional (49) with respect to order param eter function q(x), see Appendices A, B. The partial di erential equation is solved numerically by means of a pseudo spectral technique, see e.g. Ref. [44], without xing a priori any special ansatz for q(x).

The free energy functional for the 1-FRSB ansatz can be obtained either by inserting the explicit form (50) of q(x) into Eq. (49), or by taking in Eq. (46) $p_R = m$, $q_R = q_1, q_{R-1} = q_0$ and $p_R = p_{R-1}$ nite as R ! 1. In both cases one ends up with

Equations (59)-(61) are the parametric equations of the 1-FRSB m -lineswhich are drawn in the ($_{\rm p}$; _2) plane by xing the value of m in the interval [0;1] and varying t from 0 to 1. The 1-FRSB m -line begins for t = 0 at the boundary with the 1RSB phase and ends for t = 1 where the 1-FRSB solution goes over to the FRSB solution. The values of y for this lim iting cases are:

By comparing Eq. (62) with Eq. (40) one recognize that the value of y for t = 0 is equal to the maximum allow able value of y for the 1R SB m lines. As a consequence 1-FR SB m -lines and the 1R SB m -lines with the same m m atch continuously at the transition point between the two solutions.

By evaluating Eq. (58) for $q = q_0$ it is easy to see that the eigenvalue ${}_0^{(3)}$ Eq. (32)] is identically zero in the whole 1-FRSB (and FRSB) phase, in agreement with the marginal stability of FRSB solutions.⁴⁵ The eigenvalue ${}_1^{(1)}$ Eq. (31)] remains positive in the whole 1-FRSB phase and vanishes for t = 1 where the 1-FRSB solutions disappears in favor of the FRSB solution.

The continuous part q(x) of the order parameter function can be obtained from Eq. (58). Indeed from this equation it follows that




FIG. 4: The probability distributions of the overlap are plotted for di erent values of p. The values for the other parameters are $_2 = 2$; $_p = 3$ and $q_0 = 0.2$. The qualitative picture for sm all q's only depends, anyhow, on the value of p. Referring to the vertical ax, from top to bottom the P_p(q) for p = 3.5;4;4.5;5 and 5.5 are reproduced. At p = 3.5 (top curve) the P (q) diverges at q = 0, for p = 4 it goes to a nite value. When p > 4 it tends to zero as q ! 0.

W e note that as q ! 0 the probability density of the overlaps dx (q)=dq goes as q^{p-4} so that it diverges for 3 , is nite for <math>p = 4 and vanishes for p > 4 (see Fig. 4).

Unlike the SK case⁴⁶ the function q(x) for the 2 + p m odel with p > 3 is not a linear function of x for x 1. From the solution (65) it is easy to see that

The function q(x) for a generic p can be obtained by expanding the rh.s of Eq. (65) in powers of q^{p-2} and then inverting the series. As an example we give the rst few terms for the case $p = 4 \cdot 4^7$




FIG.5: $x_c = x (q_0)$ versus the $q_1 = q_0$ in the 1-FRSB phase for p = 4 and m = 0.5; 0:7; 1.




FIG. 6: The order parameter function q(x) in the 1-FRSB phase of the 2 + 4 m odel. In the gure m = 0.8, 4 = 3 and 2 = 1.4.

The continuous part of the order param eter functions ends for $q = q_0$ at the point $x_c = x (q_0)$. In the 1-FRSB phase x_c is always smaller than m and becomes equal to it at the boundary line with the FRSB phase. In Figure 5 we show the value of x_c as function of the dimension of the value of x_c as function of the dimension x_c and m the order parameter function q(x) remains constant and equal to q_0 , and then jumps to q_1 as x goes through m, see Figure 6.

1. The Transition Lines among the Amorphous Phases (1RSB, 1-FRSB and FRSB)

W e have seen that the 1-FRSB m -lines are the continuations into the 1-FRSB phase of the 1RSB m -lines. As a consequence, as the 1RSB m -line with m = 1 m arks the transition between the 1RSB phase and RS phase, so the 1-FRSB m -line with m = 1 m arks the transition between the 1-FRSB phase and the FRSB phase. The transition is discontinuous in the order parameter since q_1 q_1 does not vanish at the transition, but the discontinuity appears for m = 1 and the free energy and its derivatives remain continuous across the transition.

The 1-FRSB m -line with m = 1 ends at the critical point (t = 1)

For $_2 > _2$ the transition between the 1-FRSB phase and the FRSB takes place continuously in the order param eter function with $q_1 = q_1 ! 0$ and $x_c ! m$ at the transition. The continuous transition between the 1-FRSB and the FRSB phases occurs on the line of end points of the 1-FRSB m -lines. Inserting t = 1 into eqs. (59)-(60) one easily gets the param etric equations of the critical line:




FIG. 7: The static phase diagram of the $2 + 4 \mod 1$ model in the (4; 2) plane.

Finally the 1-FRSB phase is bounded by the transition line with the 1RSB phase. Indeed by setting t = 0 into eqs. (59)-(60) one recovers the param etric equations of the 1RSB instability line: ${}_{0}^{(3)} = 0$ and $q_0 = 0$. The transition is continuous in both free energy and order param – eter function since q_0 ! 0 continuously as the transition line is approached from the 1-FRSB side.

All the transition lines, together with the m -lines with m = 0.7 and m = 0.5, and the phases of the 2 + p m odel with p > 3 are shown in Figure 7. In the gure p = 4, but the phase diagram does not change qualitatively with the value of p, provided that it rem ains larger than 3.




FIG.8: Borders lines of the 1-FRSB and FRSB phases for p = 3.01 and p = 3.1.

In the limit p ! 3 the 1-FRSB and FRSB phases shrink to zero while the transition lines separating the two phases collapse sm oothly onto the vertical line (0; 2) with 2 1 and the horizontal line (1; p) with 0 p 1 where $q_0 = q_1 = 0$, see Figure 8. One then sm oothly recovers the phase diagram of the 2+3 m odel, Figure 2.

From Figure 8 we see that the continuous transition line between that 1-FRSB and the FRSB phases displays a point of vertical slope in the ($_p$; $_2$) plane. A long the continuous transition line between the 1-FRSB and FRSB phases the point of vertical slope is attained for

D . The Full R eplica Sym m etry B roken Solution (F R SB)

For the FRSB solution the order parameter function q(x) is continuous. The equations for the FRSB phase are easily obtained from those of the 1-FRSB by setting $q_0 = q_1$ and m = 1 so that only the continuous part of the order parameter function survives. In the FRSB phase the function x (q) is still given by Eq. (65) but with $q_0 = q_1$ solution of [see Eq. (58)]




FIG.9: Order parameter function q(x) in the FRSB phase. In the gure for $p = 4_4 = 2$ and $_2 = 1.5$.

The transition between the FRSB and RS phases occurs for $_2 = 1$ where both q_1 and $x_c = x (q_1)$ vanish and the FRSB solution goes over the RS solution q = 0. The transition line ($_p$;1) ends at the crossing point with the m-line with m = 1. The transition between the FRSB and the RS phases is continuous in the order parameter function and hence in the free energy.

III. COMPLEXITY

The 1RSB and 1-FRSB ansatz both contain the parameter m which gives the location of the discontinuity in the order parameter function. Strictly speaking the replica calculation does not give a rule to x it. Going back to the expression of the moments of the replica partition function, Eq. (10), one indeed sees that the replica calculation requires that for any overlap matrix q the free energy functional must be extrem ized for N ! 1 with respect to the elements of the matrix. How ever, it does not say anything about the structure of the matrix q . This means that in the 1RSB [and 1-FRSB] ansatz the free energy functional must be extrem ized with respect to q_1 [and q(x)] but not necessarily with respect to m, since it is related to the matrix structure. This rises the question of which value of m has to be taken when there exist di erent values of m, all of which leading to a stable solution. In the solution discussed so far the value of m yielding the maximum of the free energy³⁷ was chosen.

The free energy functional, Eq. (15), evaluated on the stable saddle point solution gives the free energy of a single pure state. As a consequence, choosing form the value which maxim izes the free energy functional is thermodynamically correct, provided that the logarithm of the number of di erent pure states with the same free energy, called complexity or con gurational entropy, is not extensive. If the con gurational entropy is extensive, it gives a contribution to the therm odynam ic free energy which must be considered when computing the extrem a. In other words if the num ber of states is extensive the extrem a of the therm odynam ic free energy follow from a balance between the single state free energy and the con gurational entropy. This is what happens in system swith a 1RSB phase, as rst noted in the p-spin m odel, 21,22 and changes the condition for x ing the value ofm .

W e shall not give here the details of the direct calculation of the complexity for the $2 + p \mod 2$, but rather we shall use the shortcut of deriving it from a Legendre transform of the replica free energy functional with respect to m.

To be more speci c the complexity \pm in the 1R SB and 1-FRSB phases is obtained as the Legendre transform of m (m) where (m) is the replica free energy functional (15) evaluated with the 1R SB or 1-FRSB ansatz keeping m as a free parameter:

We shall use for the complexity the notation $_{\pm}$ to stress that it is obtained from the Legendre transform, and to distinguish it from the \self-energy" function (x) used in section II. Strictly speaking this is the complexity density, even if it is custom any to call it just complexity. In the Legendre transform, Eq. (86), f is the variable conjugated to m

where q_0 and q_1 must be evaluated as function of $_p$, $_2$ and m using the saddle point equations (54) and (58). A lternatively we can use Eq. (54) to eliminatem in favor of q_1 so that the expression of the complexity for the 1– FRSB solutions becomes:

The complexity for the 1R SB solution is obtained just setting $q_0 = 0$ into the 1-FRSB complexity [and neglecting Eq. (90)]. A simple check of the 1R SB complexity consists in verifying that for $_2 = 0$ one recovers the complexity of the spherical p-spin m odel.⁴⁸

By varying q_1 one selects 1RSB or 1-FRSB solutions with di erent m. As a consequence not all values of qbetween 0 and 1 are allowed but only those which lead to stable solutions must be considered. This means nonnegative eigenvalues ${1 \atop 1}^{(1)}$ and ${3 \atop 0}^{(3)}$ for 1RSB solutions and non-negative eigenvalue ${1 \atop 1}^{(1)}$ for 1-FRSB solutions. The eigenvalue ${3 \atop 0}^{(1)}$ is identically zero for 1-FRSB solutions. The requirement that only solutions with non-negative ${1 \atop 1}^{(1)}$ are physically acceptable is also know as the Ple-

fka's criterion.^{49,50} H ere it com es out naturally from the stability analysis of the replica saddle point, how ever it can be shown to have a m ore general validity.

The complexity $_{lt}$ is the logarithm of the number of states of given free energy, divided by the system size N. It is, therefore, clear that in the therm odynamic limit only solutions with a non-negative complexity must be considered. All others will be exponentially depressed and hence are irrelevant.

The static solution discussed in previous Sections was obtained by imposing ((m) = 0m = 0. The complexity \pm is consequently zero for the static solution, and the number of ground states is not extensive.

The solution with the largest complexity, of both 1R SB or 1-FRSB type, is the one for which $\begin{pmatrix} 1 \\ 1 \end{pmatrix}$ vanishes,




FIG.10: $_{\rm lt}$ (q₁) as function of q₁ in the region where only 1R SB solutions are stable and have non-negative complexity. Only the part of the curve $_{\rm lt}$ (q₁) 0 is shown. The thick line shows the relevant part of the curve. The dashed line correspond to unstable solutions. The point marked \D ynam ic" is where $_{1}^{(1)}$ vanishes and corresponds to the solution of largest complexity. The gure is for the 2+4 model with $_{2}$ = 3 and $_{4}$ = 10.




FIG.11: $_{\rm lt}$ (q₁) as function of q₁ in the region where both 1R SB and 1-FR SB solutions are stable and have non-negative complexity. We have indicated explicitly which part of the curve corresponds to each solutions. Only the part of the curve $_{\rm lt}$ (q₁) 0 is shown. The thick line shows the relevant part of the curve. The dashed line correspond to unstable solutions. The point marked \D ynam ic" is where $_{\rm l}^{\rm (1)}$ vanishes and corresponds to the solution of largest complexity. The gure is for the 2 + 4 m odel with $_{\rm 2}$ = 3 and $_{\rm 4}$ = 7.




FIG.12: $_{\rm lt}$ (q₁) as function of q₁ in the region where 1R SB and 1-FRSB solutions have non-negative complexity but only the latter are stable. We have indicated explicitly which part of the curve corresponds to each solutions. Only the part of the curve $_{\rm lt}$ (q₁) 0 is shown. The thick line shows the relevant part of the curve. The dashed line correspond to unstable solutions. The point marked \D ynam ic" is where $_{\rm l}^{(1)}$ vanishes and corresponds to the solution of largest com – plexity. The gure is for the 2 + 4 model with $_{\rm 2}$ = 3 and $_{\rm 4}$ = 4.

In Figures 10, 11 and 12 we show the behavior of $_{\rm lt}$ (q₁) in the three relevant regions where (i) only 1R SB solutions have non-negative complexity and are stable, (ii) both 1R SB and 1-FR SB solutions have non-negative complexity and are stable and (iii) both 1R SB and 1-FR SB solutions have non-negative complexity but only the latter are stable.

The condition of maximal complexity (91) is known as the $\mbox{marginal condition}$ " since for ${}_{1}^{(1)} = 0$ the saddle point is marginally stable.

In the relaxation dynam ics the eigenvalue $\begin{pmatrix} 1 \\ 1 \end{pmatrix}$ is related to the decay of the two-times correlation function to the \interm ediate" value q_1 , and hence the marginal condition comes naturally in as the condition for critical decay.^{7,22} For this reason the solution of maximal com – plexity is also called the \dynam ic solution" as opposed to the \static solution" discussed so far which, on the contrary, has vanishing com plexity.

In the FRSB phase $\binom{(1)}{1}$ is identically zero and the two solutions, static and dynam ic, coincide.

IV. THE DYNAM IC SOLUTION

In this paper we shall not give here the full derivation of the dynam ic solution, and of the marginal condition (91), starting from the relaxation dynam ic equations but rather we shall rely on the fact that the dynam ic solution can be obtained from the replica calculation just

using the marginal condition instead of stationarity of the replica free energy functional with respect to m 22,48 It can be shown that this shortcut applies also to the 1-FRSB solution.⁵¹

The static and dynamic solutions di er only for what concern the 1RSB and 1-FRSB phases, therefore here we shall only discuss shortly the main di erences in the phase diagram which follows from the 1RSB and 1-FRSB dynam ic solutions.

A. The Dynam ic 1R SB Solution

The equations of the dynam ic 1R SB solution are given by Eq. (29) with $q_D = 0$ and by the marginal condition (91). Solving these equations for ($_p$; 2) and using q_1 as a free parameter one gets the parametric equations of the dynam ical 1R SB m -lines

For any 0 m 1 the maximum allowable value of q is xed by the requirement that $_2$ 0, while the minimum by the requirement that the eigenvalue $_3^{(0)}$, Eq. (32) with $q_0 = 0$, be non-negative. In the dynamic approach this eigenvalue controls the long time relaxation of the two-times correlation function²² and hence must be nonnegative. A straightforward calculation shows that

1. The D ynam ic Transition Line B etween the P aram agnet and the 1R SB-G lass P hase

The dynam ic transition line between the RS and the 1RSB phases is given by the dynam ic 1RSB m -line with m = 1. Inserting m = 1 into eqs. (92)-(93) one obtains the parametric equations of the transition line

where $_{3}^{(0)}$ vanishes. The transition between the RS and the dynam ic 1RSB phase is discontinuous in the order parameter q_{1} since it jumps from zero, on the RS side, to a nite value on the m-line with m = 1.

The dynam ic 1RSB phase is bounded by the critical line of equation ${}_{3}^{(0)} = 0$ which marks the transition between the dynam ic 1RSB and the dynam ic 1FRSB phases. The explicit form of the equation of this transition line is obtained by inserting $q_1 = (p \ 3)=(p \ 3+m)$, see Eq. (94), into the equations of the dynam ic 1RSB m - line and reads




FIG.13: Phase diagram $_{2}-_{4}$. Counterclockwise the RS, 1RSB, 1FRSB and FRSB phases are plotted, separated by the static phase transition lines (full curves). The PM /1RSB and the 1RSB/1FRSB transitions also occur in the dynam ics and the relative lines are drawn as dashed curves. Their continuation as FRSB/1FRSB transition lines are the dynam ic (dashed) and static (full) m = 1-lines, computed in the 1-FRSB ansatz. They merge at the \End Point" (see inset). For a comparison, we also plot the dynam ic and static m - lines with m = 0.5. They merge on the FRSB/1-FRSB phase transition line above the end point. A sm decreases from one, the whole continuous FRSB/1-FRSB line is covered. Inset: the discontinuous transitions FRSB/1-FRSB ($_{2} > 1$) and PM /1RSB ($_{2} < 1$).

As expected, the dynam ic transition lines do not coincide with the static ones but, in the (p; 2) plane, they are displaced toward lower values of p with respect to the corresponding static transition lines, see Figure 13.

B. The Dynam ic 1-FRSB Solution

The equations of the dynamic 1-FRSB solution are given by the saddle point equations (53) and (54) and by the marginal condition (91). As a consequence, the parametric equations of the dynamic 1-FRSB m -lines are still (59)-(60) but with the value of y given by

The dynam ic 1-FRSB m -line are drawn in the ($_{\rm p}$; $_2$) plane by xing the value of m and varying t from 0 to 1.

1. The D ynam ic Transition Line between the 1RSB and the 1-FRSB Am orphous P hases

By setting t = 0 into the equations of the dynam ic 1-FRSB m-lines and varying m from 1 to 0 one recovers the critical line $q_0 = 0$ and $_3^{(0)} = 0$ which m arks the boundary with the dynam ic 1RSB phase. Indeed for t = 0 Eq. (101) yields y = 1 = (p 2) so that eqs. (59)-(60) reduce to the param etric equations (99)-(100) of the critical line. M oreover on this line $q_1 = (p 3) = (p 3+m)$, the same value found from the dynam ic 1RSB solution, therefore as it happens for the static solution the dynam ic 1-FRSB m -lines and the dynam ic 1RSB m -lines with the sam e m m atch continuously on the critical line $_3^{(0)} = 0$ [and $q_0 = 0$]. This transition is continuous since q_0 goes to zero as the transition line is approached from the 1-FRSB side while q_1 is continuous through the line.

The dynam ic 1 - FRSB m -line with m = 1, continuation of the 1RSB m -line with m = 1 into the 1-FRSB phase, marks the boundary between the 1-FRSB and FRSB phases. A long this line the order parameter is discontinuous since q1 jumps from zero in the FRSB phase to a non-zero value on the line. The discontinuity oc- $\operatorname{curs} \operatorname{atm} = 1$ so that the free energy remains continuous despite the jump in the order parameter. The dynamic 1 - FRSB m - line with m = 1 starts from the end point (98) of the dynam ic 1R SB m -line with m = 1 and stops at the sam e end point (69)-(70) of the static 1-FRSB m line with m = 1. From this point the transition between the 1-FRSB phase and the FRSB phase occurs continuously in the order parameter, i.e., with q_1 q ! 0 as the transition line is approached form the 1-FRSB side (see Fig. 13).

The continuous transition between the 1-FRSB and FRSB phases occurs along the critical line obtained by setting t = 1 into eqs. (59)-(60) and varying m from 1 to 0. From Eq. (101) it follows that

so that the end point of the dynam ic $1 \pm R SB \, m$ -line coincides with the end points of the static $1 \pm R SB \, m$ -line for any m, and not only for m = 1. Therefore, the dynam ic and the static continuous critical lines between the




FIG.14: Phase diagram T-J₄ in J₂ units. C lockwise a param – agnetic phase (PM), a glassy phase (G-I) described by m eans of a 1RSB ansatz, another glassy phase represented by a 1-FRSB ansatz and a purely spin-glass phase (SG) computed in the FRSB ansatz occur. The transitions to and from the two glass-like phases take place both as dynamic (dotted lines) and as static (full lines). In tem perature the dynamic transition lines are always above the relative static lines.

1-FRSB and the FRSB phases coincide. Indeed, when studying the static solution we have seen that along the continuous transition line between the 1-FRSB and the FRSB solutions the eigenvalue ${1 \atop 1}^{(1)}$ vanishes so that the di erence between the two solutions disappears. On this line both solutions have zero com plexity and it remains equal to zero in the whole FRSB phase.

In Figure 13 we show the full phase diagram of the spherical 2 + p spin glass model in the ($_{p}$; $_{2}$) space with both the static and the dynam ic critical lines.

By noticing that both $_{\rm p}$ and $_2$ are proportional to 2 we see that the discontinuous dynam ic transition occurs at a tem perature higher than that of the equivalent static transition, as can be clearly seen from F igure 14 where the phase diagram in the T=J₂ = $1=^{p}\frac{1}{2}$ and $J_{\rm p}=J_{\rm 2}=p^{p}\frac{1}{2}\frac{1}{p}=(p-2)$ plane is shown.

V. CONCLUSIONS

In this paper we have provided a detailed study of the phase space of the spherical 2 + p spin glass model using the static approach of Ref. [2] which employs the replica method to evaluate the disorder-averaged logarithm of the partition function. By performing the Legendre transform of the replica free energy functional we have de ned the complexity function that, whenever it is extensive, counts the number of equivalent di erent m etastable states. This allow ed us to discuss the dynam ic solution as the solution which maxim izes the com plexity. In both solutions, i.e., static and dynam ic, the model displays four di erent phases, characterized by di erent replica sym m etry breaking schemes, in which the system can nd itself as the therm odynam ic parameters and the intensity of the interaction is changed. One of the nice feature of this model is that it can be completely solved even in the phase described by a full replica sym metry breaking. To our know ledge this is the rst example of an analytical FRSB solution.

The main result of the present study is the existence of two phases exhibiting the qualitative features of glassy materials. One is the 1R SB solution, displayed by those systems that are considered as valid mean-eld models for the glass state. Even though no connection with the microscopic constituents of a real glass former can be set, the collection of spins interacting through a p-body quenched disordered bound behaves very much like, e.g., the set of SiO₂ molecules in a window glass. The single breaking occurring in the 1R SB solution corresponds, in a dynamic interpretation^{52,53,54} to a tim e-scale bifurcation between the fast processes in a real am orphous material (the -processes) and the slow processes () responsible for the structural relaxation.

A nother phase emerges in the study of the spherical 2 + p spin glass model. Som ething not occurring in any Ising spin glass model.⁵⁵ In a whole region of the phase space the stable phase is, indeed, described by m eans of an overlap function q(x) that is continuous up to a certain value q_0 and then displays a step, as in aforem entioned 1R SB solution. We call it the one step-full R SB solution (1FR SB). Exploiting the static-dynam ic analogy once again, in this phase, in the relaxation towards equilibrium, a rst time-scales bifurcation takes place (\ bifurcation") just as above, but it is no m ore unique. As the time goes by a continuous set of further bifurcations starts to occur between slow and even slower processes, as in the case of a proper spin-glass.³ In the continuous part, any kind of sim ilarity between (ultram etrically

ous part, any kind of similarity between (ultram etrically organized) states is allowed but above q_0 the hierarchy ends in only one extra possible value: the self-overlap, or E dw ards-A nderson order parameter q_1 .

The stability of the 1-FRSB solution in the replica space is not limited to a single, self-consistent, choice of the order parameter (in particular the point discontinuity can change in a certain interval) and this in plies that in each point of the phase diagram belonging to this phase there will be an extensive number of metastable states, having free energies higher than the equilibrium free energy. In order for this phase to appear a strong enough couple interaction must be present (that is the source of the continuous, spin-glass like contribution) but the p-body interaction must have a broader distribution of intensities than the 2-body ($J_p > J_2$).

If this new phase can be considered as a glassy phase di erent from the 1RSB one, the phase diagram that we have com puted describes an am orphous-am orphous transition, with the second glass having a much m ore com plicated structure outside the single valleys (for very long tim e-scales in the dynam ic language). W hether there is a correspondence with the am orphous-am orphous tran-

sition between hard-core repulsive and attractive glassy colloids^{14,15,16,18,19} and at which level the analogy can be set is yet to be clari ed and further investigation of the dynam ic properties is needed in order to make a link between the interplay of 2-body and p-body interaction in spherical spin glasses and the role of repulsive and attractive potentials in colloids undergoing kinetic arrest.

In writing the Parisi equation we have used the standard notation in which a dot $\ -$ " denotes the derivative with respect to x while the prime \setminus ⁰" the derivative with respect to y.

The advantage of this equation is that it can be solved num erically without specifying a-priori the form of q(x) and (x). The rst problem one is facing when solving the Parisi equation is that the functional (A1) must be extrem ized over all possible solutions of the Parisi equations, which can be num erically uncom fortable. This, however, can be overcome using the Sommers-Dupont form alism.⁵⁶ The idea is to introduce a di erent functional whose value at the stationary point coincides with the extrem a of the free energy functional (A1) over all possible solutions of the Parisi equations.

This is easily achieved by introducing the Parisi equation into the functional via the Lagrange multiplier P (x;y). The new functional is hence




FIG.15: The num erical order parameter function q(x) for the 2+4 m odel with $_2 = 2$ and $_4 = 3$. The 1-FRSB solution is clearly seen.




FIG.16: Field probability distribution p(x;y) for the 2 + 4 m odel with $_2 = 2$ and $_4 = 3$ evaluated from the numerical resolution of the Parisi-Som m ers-D upont equations at x = 0.4 and x = 0.5. The underlying full curve (barely visible) is the analytic solution given by Eqs. (B9), (B14).

In Figure 15 we show the order parameter function q(x) found solving the equations for the 2+ 4 m odel with $_2 = 2$ and $_4 = 3$. The 1-FRSB structure is clearly seen. In Fig. 16 both the num erical and the analytical solutions for P (x;y) are displayed.

APPENDIX B:SOLUTION OF THE PARISI-SOMMERS-DUPONT EQUATIONS

It is not di cult to write the Parisi-Som m ers-D upont partial di erential equations for the 1-FRSB case, cfr. Ref. [57]. W ith obvious notation, the Parisi-Som m ers-D upont functional with the 1-FRSB ansatz reads

APPENDIX C:THE SPHERICAL s+ p SP IN GLASS MODEL

The spherical s + p spin glass model is the generalization of 2 + p models in which the two-spin interaction is replaced by a s-body spin interaction:

As it happens for the 2+ p m odels the RS solution with $q \in 0$ is unstable, however, at di erence with these, the RS solution with q = 0 is stable everywhere in the $(_{p}; _{s})$ plane since for q = 0 the relevant eigenvalue $_{1}$, eq.(21), is identically equal to one for any s > 2.

For $_p$ and/or $_2$ large enough a therm odynam ically m ore favorable 1R SB solution appears. This solution has $q_0 = 0$ and q_1 given by the saddle point equation (29) [with $q_0 = 0$]. For the static solution the value of m is xed by Eq. (30), or equivalently by Eq. (33), which follows from stationarity of the free energy functional with respect to variations of m. These equations can be solved for any s and p with the help of the CS z-function and one obtains the param etric equations of the static m -lines:

The 1RSB solution never becomes unstable since for s > 2 the eigenvalue ${}_{0}^{(3)}$, Eq. (31), evaluated at $q_0 = 0$ is always positive, and the eigenvalue ${}_{1}^{(1)}$, Eq. (32), remains positive for any ${}_{p}$ 0.




FIG.17: The phase diagram of the $3+4 \mod 1$ model in the ($_3$; $_4$) plane. The thick dashed lines are the m-line with m = 1, i.e. represent the discontinuous transition between the RS and the 1RSB phases.

In Figure 17 we show the phase diagram for the s + p m odel with s > 2 and p > s. In the gure s = 3 and p = 4, how ever any choice of s > 2 and p > s leads to a qualitatively sim ilar phase diagram.

APPENDIX D:THE RSB SOLUTIONS

In this Appendix we show that the spherical 2+ p spin glass m odel adm its only solutions of 1R SB, FR SB or 1-FR SB type. The procedure is the same as that of Appendix 2 of Ref. [2].

The function F (q) is continuous, thus Eq. (D 7) in plies that between any two successive q_r there must be at least two extrem a of F (q). If we denote these by q, then the extrem al condition $F^0(q) = 0$ in plies that




FIG.18: Typical behavior of 1= p (q) as function of q for p > 3.

The left hand side of this equation is a concave function, i.e. with a negative second derivative, since x (q) is not decreasing with q. For the 2+ pm odel (q) = $_2$ + $_p$ (p 1)q^{p 2} so that the right hand side is concave for sm all q, provided p > 3, and convex for large q, see Figure 18. For p = 3 the right hand side is convex.

As a consequence Eq. (D 8) adm its at most two solutions and hence only one step of replica symmetry breaking is possible. Moreover it must be $q_0 = 0$. Indeed, from Eq. (D 6) and from the fact that in absence of external eld F (0) = 0 it follows that

which would imply the presence of at least three extrem a, which is not possible.

Up to this point the conclusions do not di er much from those found for the p-spin model. Here how ever the

presence of a concave part in the right hand side of Eq. (D 8) for p > 3 m akes possible di erent solutions.

Equations (D 6) and (D 7) can be solved by a continuous replica symmetry breaking solution with F(q) = 0 in a given range of q since in this case both equations would be identically valid. For this solution Eq. (D 8) must also be identically valid and this can only be true for

0 q g, where q_0 is the value of q for which 1 = (q) changes concavity, where both sides of the equation are concave function of q. Indeed if Eq. (D 8) were valid also for values of q where the right hand side is convex this would im ply that x (q) is a decreasing function of q, which is not possible since dx (q)=dq is the probability density of the overlaps. For the same reason for p = 3 a continuous replica symmetry breaking solution is not allowed since in this case the right hand side of Eq. (D 8) is purely convex. The sam e applies to the s+ pm odels with s > 2, so that also these m odels adm its only a 1R SB phase.

The possibility of a continuous replica symmetry breaking solution for q q does not rule out the presence of discrete replica breakings with $q_r > q_0$. These additional discrete breakings must satisfy eqs. (D 6) and (D 7). Therefore since the right hand side of Eq. (D 8) is convex for $q > q_0$ arguments similar to those which leaded to the conclusion that for the 2 + 3 m odel only 1R SB solutions are possible show that at most only one m ore discrete break with $q_1 > q_0$ is possible.

No other possible non trivial solutions exist for the spherical 2 + p spin glass model so we conclude that the model adm its only solutions of 1R SB, 1 + FR SB or FR SB type.
