Interface m ediated interactions between particles { a geom etrical approach

Particles bound to an interface interact because they deform its shape. The stresses that result are fully encoded in the geometry and described by a divergence-free surface stress tensor. This stress tensor can be used to express the force on a particle as a line integral along any conveniently chosen closed contour that surrounds the particle. The resulting expression is exact (i.e., free of any \sm allness" assumptions) and independent of the chosen surface parametrization. A dditional surface degrees of freedom, such as vector elds describing lipid tilt, are readily included in this form alism. As an illustration, we derive the exact force for several in portant surface H am iltonians in various symmetric two-particle con gurations in terms of the midplane geometry; its sign is evident in certain interesting limits. Specializing to the linear regime, where the shape can be analytically determ ined, these general expressions yield force-distance relations, several of which have originally been derived by using an energy based approach.

I. IN TRODUCTION

The interaction between spatially separated objects is mediated by the disturbance of the region that surrounds them, described by a eld. In electrom agnetic theory for example the interaction between charged particles is described by the M axwell eld equations. Since they are linear, interactions add. However, more often than not, the eld equations are nonlinear as for example in the case of G eneral R elativity: even though the energy-momentum tensor couples linearly to the curvature, the latter depends in a nonlinear way on the spacetime metric and its derivatives [1, 2, 3]. The source of the nonlinearity lies in the geometric nature of the problem. Not only do interactions fail to add up, even the hum ble two particle problem poses challenges.

\E ective" interactions between m acroscopic degrees of freedom arise in statistical physics when a partial trace is performed in the partition function over unobserved m icroscopic degrees of freedom [4, 5]. The Boltzm ann factor invariably renders these interactions nonlinear. This time, the source of the nonlinearity is the entropy hidden in the degrees of freedom that have been traced out. For example, the e ective interaction between charged colloids in salty water is described (at a m ean- eld level) by the Poisson-Boltzm ann equation [6].

In this paper we will discuss a classical example which belongs to the class of e ective interactions, while owing its nonlinearity to its geometric origin: the interaction between particles mediated by the deformation of a surface to which they are bound. This problem includes the capillary interactions between particles bound to liquid-uid interfaces [7, 8, 9], or the membrane mediated interactions between colloids or proteins adhering to or embedded in lipid bilayer membranes [9, 10, 11, 12, 13, 14, 15, 16]. To approach the problem we require two pieces of inform ation. First, how does the energy of the surface depend on its shape, or in other words, what is the \surface H am iltonian"? Second, how does a bound particle locally deform the surface? W ith this inform ation, we may (in principle) deduce the equilibrium shape m inim izing the energy of the surface for any given placement of the bound particles. K nowing the shape, the energy can be determined by integration, and the forces it in plies follow by di erentiating with respect to appropriate placement variables. In general, how ever, the ground state of the surface is a solution of a nonlinear eld equation (\the shape equation"), thereby thw arting progress by this route at a very early stage.

Som etim es the linearization of a nonlinear theory is adequate. Just as one recovers N ewtonian gravitation as the weak- ekd lim it of G eneral R elativity [1, 2, 3], or D ebye-Huckel theory as the weak- ekd lim it of Poisson-Boltzm ann theory [6], a linear theory for surface m ediated interactions is useful for certain sim ple geom etries, notably weakly perturbed at surfaces. At this level, the approach to interactions based on energy becom es tractable. Yet, linearization is also often inadequate. The full theory m ay display qualitatively new e ects which are absent in the linearized theory: strong gravitational ekds give us black holes [1, 2, 3]; the bare charge of a highly charged colloid gets strongly renorm alized by counterion condensation [17].

There is, how ever, an alternative approach to interactions which was outlined in [18]. By relating the interaction between particles to the equilibrium geometry of the surface, a host of exact nonlinear results is provided. The link is formed by the surface stress tensor, and it can be established without solving the shape equation. Once we know the Ham iltonian, we can express the stress at any point in terms of the local geometry { covariantly and without any approximation. We will brie y revisit the essentials of this construction in Sec. II. Knowing the stresses, the force on a particle is then determ ined by a line integral of the stress tensor along any surface contour enclosing the particle, as we will show in Sec. IV.

Such results might, at rst sight, appear som ew hat form al: without the equilibrium surface shape, they cannot be translated into hard num bers. How ever, the close link between the force and the geom etry, com bined with a very general know ledge one has about the surface shape (e.g., its symmetry) will turn out to provide valuable qualitative insight into the nature of the interaction (e.g., its sign). Even on a completely practical level, this approach scores points against the traditional approach involving energy, providing a signi cantly more e cient way to extract forces from the surface shape determ ined num erically (in whatever way).

W e will illustrate this approach with a selection of exam ples involving di erent sym metries and surface H am iltonians. In Sec. III we demonstrate how its scope extends in a very natural way to include internal degrees of freedom on the membrane { in particular: a vector order parameter which has for instance been used to describe lipid tilt [19, 20, 21, 22, 23, 24]. To make contact with the energy based approach in the literature, and also in order to link the form alism to a more fam iliar setting, we specialize in Sec. V to a M onge parametrization and its linearization. This will permit us in Sec. V I to derive force-distance curves for interactions mediated by surface tension, membrane curvature, and lipid tilt. Various well-known linear results [7, 8, 11] then follow very naturally using the stress tensor approach.

II. ENERGY FROM GEOMETRY

In this paper we want to study the physics of interfaces, which are characterized by a reparam etrization invariant surface H am iltonian. The appropriate language for this is di erential geometry, and in this section we will outline how physical questions can be formulated very e ciently in this language. We rst sum marize the necessary m athem atical basics and introduce our notation (the reader will nd more background material in Refs. [25]). We then de ne the class of H am iltonians we will be considering. The corresponding Euler-Lagrange equations for the interface degrees of freedom will be cast as a conservation law. The most direct way to do this is to implement all geometrical constraints using Lagrange mulipliers; not only does this approach provide a quick derivation of the shape equation, it also provides a transparent physical identi cation of the surface stresses.

A. DierentialGeometry and Notation

We consider a two-dimensional surface embedded in three-dimensional Euclidean space R³, which is described locally by its position X (1 ; 2) 2 R³, where the a are a suitable set of local coordinates on the surface. The embedding functions X induce two geometrical tensors which completely describe the surface: the metric g_{ab} and the extrinsic curvature K $_{ab}$, de ned by

N ote that unlike n , the e_{a} are generally not norm alized.

In the following, r_a denotes the metric-compatible covariant derivative [26] and $= r_a r^a$ the corresponding Laplacian. Surface indices are raised with the inverse metric g^{ab} . The trace of the extrinsic curvature, $K = g^{ab}K_{ab}$, is twice the mean curvature. Using the above sign conventions, a sphere of radius a with outward pointing unit norm allows a positive K = 2=a.

The intrinsic and extrinsic geometries are related by the Gauss-Codazzi-Mainardiequations

where R_{abcd} is the R ism ann tensor constructed with the metric; its contraction over the rst and third index is the Ricci tensor, $R_{bd} = g^{ac}R_{abcd}$, whose further contraction gives the Ricci scalar curvature, $R = g^{bd}R_{bd}$. From Eqn. (3b) we see that the latter satis es $R = K^2 - K^{ab}K_{ab}$. In particular in two dimensions we have that $R = 2K_G$, where $K_G = det(K_a^b)$ is the Gaussian curvature (Gauss' Theorem a Egregium [25]).

B. Surface energy and its variation

W e consider surfaces such as lipid m em branes and soap Im s, characterized by the property that the associated energy is completely determ ined by the surface geom etry and described by a H am iltonian which is an integral of a local H am iltonian density H over the surface:

The in nitesimal area element is $dA = {}^p \overline{g} d^2$, where $g = det(g_{ab})$ is the determ inant of the metric. The density H depends only on scalars constructed from local

surface tensors: the metric, the extrinsic curvature, and its covariant derivatives. In order to nd the equilibrium (i.e., energy minimizing) shape, one is interested in how H responds to a deform ation of the surface described by a change in the embedding functions, X ! X + X. The straightforward (but tedious) way to do this is to track the course of the deform ation on X through g_{ab} , $P \ \overline{g}$, K _{ab}, and any appearing covariant derivatives using the structural relationships (1) and (2).

A lternatively, one can treat g_{ab} , K_{ab} , e_a and n as independent variables, enforcing the structural relations (1) and (2) using Lagrange multiplier functions [27]. One thus introduces the new functional $H_c[g_{ab};K_{ab};:::;X;e_a;n;a^{ab};a^{b};f^{a};a^{c};n]$ given by

The original Ham iltonian H is now treated as a function of the independent variables g_{ab} , K $_{ab}$ and its covariant derivatives; ab , ab , f^{a} , $^{a}_{?}$ and $_{n}$ are Lagrange multipliers xing the constraints (1) and (2). The introduction of auxiliary variables greatly sim pli es the variational problem, because now we do not have to track explicitly how the deformation X propagates through to g_{ab} and K $_{ab}$. As we will see in the following, this approach also provides a very sim ple and direct derivation of the shape equation in which the multiplier f^{a} , which pins the tangent vectors to the surface, is identi ed as the surface stress tensor.

Note that additional physical constraints can be enforced by introducing further Lagrange multipliers (such as a pressure P in the case that a xed volum e is enclosed by the surface).

${\tt C}$. Euler-Lagrange equations and the existence of a $${\tt conserved}$$ current

The Ham iltonian (4) is invariant under translations. As explained in detail in Ref. [28], Noether's theorem then guarantees the existence of an associated conserved current, which we will identify as the surface stress tensor in Sec. IID. In order to see this, let us rst work out the Euler-Lagrange equations for X , e_a , n , g_{ab} and K $_{ab}$:

Note that the W eingarten equations $@an = K_a^b e_b$ have been used in Eqn. (6b); the Gauss equations $r_a e_b =$

The manifestly symmetric tensor T^{ab} is the intrinsic stress tensor associated with the metric g_{ab} . If H does not depend on derivatives of K _{ab}, functional derivatives in the de nition of H ^{ab} and T ^{ab} reduce to ordinary ones.

Equation (6a) reveals the existence of a conservation law for the current f^a . Using the other equations (6c), (6d) and (6e), it is straightforward to elim inate the Lagrange multipliers on the right hand side of Eqn. (6b) to obtain an explicit expression for f^a in terms of the original geometrical variables. From Eqn. (6c) we nd $\frac{a}{2} = r_b^{ab}$ because e_a and n are linearly independent; the Eqns. (6d) and (6e) determ ine a^{ab} and a^{ab} . Thus Eqn. (6b) can be recast as

Once the Hamiltonian density has been specied, Eqn. (8) determines the conserved current f^{a} completely in terms of the geometry. Several representative examples are treated in the Appendix.

Finally, aspointed out in Refs. [27, 28], the norm alprojection of $r_a f^a$ is the Euler-Lagrange derivative E (H) of the original H am iltonian H which vanishes for an equilibrium shape [29]. Using the Gauss equations once more, we obtain the remarkably succinct result

D. Identi cation of the stress tensor

W e will now show that f^{a} can be identied with the surface stress tensor. The variation of the Ham iltonian has a bulk part proportional to the Euler-Lagrange derivative (6) as well as boundary term s: under a change in the embedding functions X ! X + X one gets




FIG.1: Surface with 3 disjoint boundary components ($_{\rm i}$ and an outer limiting boundary ($_{\rm out}$.

A dditional boundary contributions stem from the variations with respect to n, g_{ab} and K $_{ab}$, since these terms do or may contain further derivatives which then need to be rem oved by partial integration. However, the one appearing in Eqn. (10) is the only one that is relevant for identifying the stress tensor: As we will see below, for this we are exclusively interested in translations, for which n, g_{ab} and K $_{ab}$ rem ain unchanged.

Consider, in particular, a surface region in equilibrium (see Fig.1): its boundary @ consists of n disjoint closed components @ $_i$ and an outer lim iting boundary @ $_{out}$. Each of the @ $_i$ is also the closed boundary of a surface patch $_i$. Under a constant translation X = aof @ $_i$ the only non-zero term is

Stokes' theorem has been used to convert the surface integral into a line integral. The vector $l = l_a e^a$ is the outward pointing unit norm alto the boundary on the surface ; by construction it is tangential to . The variable s measures the arc-length along ℓ_i . The boundary integral is thus identied as the external force F $_{ext}^{(i)}$ acting on ℓ_i : dotted into any in nites in altranslation, it yields (m inus) the corresponding change in energy [30].

The external force F $_{\rm ext}$ on the surface patch $_0$ is sin – ply given by ~ F $_{\rm ext}^{(0)}$ due to N ew ton's third law

where l= l and Stokes' theorem was used again.

Recall now that in classical elasticity theory [31] the divergence of the stress tensor at any point in a strained m aterial equals the external force density. Or equivalently, the stress tensor contracted with the norm alvector of a local ctitious area element yields the force per unit area transm itted through this area element. Com – paring this with Eqn. (12) we see that f^a is indeed the surface analog of the stress tensor: $l_a f^a$ is the force per unit length acting on the boundary curve due to the action of surface stresses.

It proves instructive to look at the tangential and norm alprojection of the stress tensor by de ning

Tangential stress acts as a source of normal stress { and vice versa. Both conditions hold irrespective of whether the Euler-Lagrange derivative E actually vanishes. In fact, Eqn. (14a) shows that the shape equation E = 0 is equivalent to $r_a f^a = K_{ab} f^{ab}$, while Eqn. (14b) m erely provides consistency conditions on the stress com – ponents. For instance, the H elfrich H am iltonian H / K² yields f^a / $r^a K$, while f^{ab} is a quadratic in the extrinsic curvature tensor (see Eqn. (A 4)). Hence, Eqn. (14a) immediately reproduces the characteristic form of the Euler-Lagrange derivative: K plus a cubic in the extrinsic curvature.

III. IN TERNAL DEGREES OF FREEDOM

So far we have restricted the discussion to H am iltonians which are exclusively constructed from the geom etry of the underlying surface. How ever, the surface itselfm ay possess internal degrees of freedom which can couple to each other and, more interestingly, also to the geom etry. The simplest example would be a scalar eld on the mem brane, which could describe a local variation in surface tension or lipid com position, and it is readily incorporated into the present form alism [33].

Here we will bok a little more closely at the case of an additional tangential surface vector ekl m^a. Such a ekl has been introduced to describe the tilt degrees of freedom of the molecules within a lipid bilayer, to accom modate the fact that the average orientation of the lipids them selves need not coincide with the local bilayer norm al (see for instance Refs. [19, 20, 21, 22, 23, 24]). M any additional terms for the energy emerge in the presence of a new ekl m^a (for a system atic classi cation see Ref. [21]). How ever our aim here is not to treat the most general case. Instead, we will focus on a simple representative example to illustrate how easily the present form alism generalizes to treat such situations.

Let us de ne the properly sym m etrized covariant tilt-strain tensors M $^{\rm ab}$ and F $^{\rm ab}$ according to

In the spirit of a harm onic theory we construct a H am iltonian density H $_{\rm m}\,$ from the following quadratic invariants:

where $M = g_{ab}M^{ab} = r_am^a$ is the tilt divergence. The rst two terms coincide with the lowest order intrinsic

term s identi ed by N elson and P ow ers [21], provided we restrict to unit vectors m^a [34]. These terms are multiplied by new elastic constants and , playing the analogous role to Lam e-coe cients [35]. If $m^2 \in 1$ a third term (also absent in usual elasticity theory [31]) occurs, the quadratic scalar constructed from the antisymm etrized tilt gradient; its structure is com pletely analogous to the Lagrangian in electrom agnetism [36]. Finally, if the magnitude of m^a is not xed, we may also add a potential V depending on the square $m^2 = m_a m^a$ of the vector eld m^{a} . W it hout loss of generality we assume that V (0) = 0, because any nonvanishing constant is more appropriately absorbed into the surface tension . If V (x) is minimal for x = 0, then m^a 0 will m in im ize the energy, but depending on physical conditions V may favor nonzero values of jn^a j. This is why below the main phase transition temperature of lipid bilayers the lipids can acquire a spontaneous tilt.

This particular choice for H_m is purely intrinsic. Hence, Eqn. (8) shows that the corresponding material stress f_m^a is also purely intrinsic, therefore tangential, and given by $f_m^a = T_m^{ab}e_b$, where $T_m^{ab} = 2^p \overline{g}^{-1}$ ($\overline{g}H_m$) = g_{ab} is the metric material stress. Performing the functional variation (see Appendix) we nd

where $"_{ab} = n$ ($c e_b$) is the antisymmetric epsilontensor [37]. Notice that the metric stress tensor is quadratic in the tilt-strain, not linear. Unlike the stress tensor in elasticity theory, this tensor is not obtained as the derivative of the energy with respect to the strain but rather with respect to the metric, which leaves it quadratic in the strain. The form all analogy alluded to earlier is therefore not complete.

Adding the material stress T_m^{ab} to the tangential geometric stress f^{ab} , we nd with the help of Eqns. (14) the equilibrium conditions

The rst of these equations shows how the material degrees of freedom \add" to the geometric Euler-Lagrange derivative E of the geometric H am iltonian H; this is the modi ed shape equation. The second equation { which before provided consistency conditions on the geometrical stresses { tells us that the material stress tensor is conserved. The equilibrium of the material degrees of freedom involves the vanishing of the Euler-Lagrange derivative with respect to the eld m^a, which is given by

In general, the equilibrium condition $E_{m a} = 0$ implies Eqn. (18b). For a single vector eld m^a the converse also holds so that Eqn. (18b) may be used in place of the equilibrium condition [38].

In equilibrium, we have not only $E_{m a} = 0$, we also have $r^{a}E_{m a} = 0$. U sing the commutation relations for covariant derivatives [39], it is then easy to see that the tilt also satis es the following equation on the surface:

Notice that has dropped out of this equation, which follows from the fact that F^{ab} is invariant under U (1) gauge transform ations [40]. For sm all values of tilt, we can expand the potential as

In the untilted phase we can term inate this expression after the rst term (since then t > 0). If we now restrict to a atmem brane (and thus R 0) Eqn. (20) simplies to a Helm holtz equation for the tilt divergence:

showing that (in low est order) any nonzero M is (essentially) exponentially damped with a decay length of

If t < 0 gets us into the tilted phase, the expansion (21) has to be taken one order higher, leaving instead a non-linear G inzburg-Landau equation to be solved.

We nally remark that even though the system of Euler-Lagrange equations (18) is quite form idable, it still enjoys one nice nontrivial property: The material equation (18b) is purely intrinsic. This is the case because the material stress is tangential, which itself derives from the fact that the material H am iltonian is intrinsic. If we were to add a coupling between tilt and extrinsic curvature, such as the chiral term $"_{ac}K_{b}^{c}m^{a}m^{b}$, this decoupling would no longer hold.

IV. FORCES BETW EEN PARTICLES

Particles bound to an interface can exert indirect forces onto each other. Since these are mediated by the interface, they must be encoded in its geometry. We have seen that the \coding" is done by the surface stress tensor f^a . The problem is to decode this content. In this section we will solve this problem. The strong link between stress and geometry can be easily turned into exact expressions for mediated interactions. The method by which we obtain these results for various different H am iltonians as well as the nal form ulas are one of the major results of this paper.

A . The stress tensor and external forces

Consider a single simply-connected patch $_0$. The external force acting on it is given by Eqn. (12). If there are no external [41] forces acting on $_0$, the integrals appearing in Eqn. (12) will vanish; but even when F _{ext} does not vanish, the stress tensor remains divergence free (Eqn. (6a)) on any part of the surface not externally acted upon. As a result, the contour integral appearing in Eqn. (12) will be independent of the particular closed curve so long as it continues to enclose the source of stress and does not encroach on any other sources.

O bærve now that in general a multi-particle con guration can be stationary only if external forces constrain the particle positions. These are the forces providing the source of stress in Eqn. (12). The force F we are ultim ately interested in is the force on a particle mediated by the interface counteracting this external force; we therefore evidently have $F = F_{ext}$.

B. Force between particles on a uid membrane

Let us now focus on a symmetric uid membrane, described by the surface Hamiltonian

which, up to irrelevant boundary term s, is equivalent to the H am iltonians introduced by C anham [42] and H elfrich [43]. Here, is the bending rigidity and is the lateral tension imposed on the boundary. For typical phospholipid membranes is of the order of a few tens of $k_B T$, where $k_B T$ is the therm all energy. Values for are found to be in a broad range between 0 up to about 10 m N /m [44]. The H am iltonian (24) covers interesting special cases in various lim its: soap lm s on setting = 0 and tensionless membranes on setting = 0. Note that the two elastic constants provide a characteristic length $r = \frac{r}{r}$

separating short length scales over which bending energy dom inates from the large ones over which tension does.

We now need to determ ine the force (12) on a particle for the Ham iltonian described by Eqn. (24). Using Eqns. (A3) and (A4) from the Appendix, we obtain

The elements of the extrinsic curvature tensor with respect to this basis are given by

Note that the integrand has been decomposed with respect to a (right-handed) orthonorm albasis adapted to the contour, fl;t;ng.

C. Two-particle con gurations




FIG.2: Two identical particles bound to an interface. As described in the text, the contour of integration can be deform ed in order to take advantage of available sym m etries.

We are interested in applying the general considerations of Sec. IV A to surface mediated interactions between colloidal particles. In particular, we will consider a sym metrical con guration consisting of two identical particles bound to an asym ptotically at surface, as sketched schematically in Fig. 2.

We label by fx;y;zg the Cartesian basis vectors of three-dimensional Euclidian space R^3 . Remote from the particles, the surface is parallel to the (x;y) plane.

Let us agree that the constraining force xes only the separation between the particles; their height, as well as their orientation with respect to the (x;y) plane are free to adjust and thus to equilibrate. This is also true of the contact line between surface and colloid when it is not pinned. Indeed, K in et al. [15] carefully argue that vertical forces and horizontal torques typically exceed horizontal forces and vertical torques by a signi cant am ount.




FIG. 3: Cross-section of a symmetric (solid line) and an antisymmetric (dotted line) two-particle geometry.

Since the form er can thus be assumed to very quickly equilibrate, they generally do not contribute to the mem - brane mediated interaction.

There are two distinct manifestations of two-particle symmetry in this situation: either a mirror symmetry in the (y;z) plane (the symmetric case) or a twofold symmetry axis, coinciding with the y axis (the antisymmetric case). The former is relevant if the two particles adhere to the same side of the surface, the latter applies if they adhere on opposite sides (see Fig. 3). In these two geometries the line joining corresponding points on the two particles lies along the x-direction.

It is now possible to deform the contour of the line integral (12) to our advantage: as indicated in Fig.2, the contour describing the force on the left hand particle m ay always be pulled open so that the surface is at on three of its four branches (2, 3 and 4). The contributions from branch 2 w ill cancel that from 4; the only m athem atically involved term stems from branch 1. The force on the particle is then given by

Let us now apply this general approach to a surface whose energetics can be described by the Ham iltonian density (24).

D . The force between particles with sym metry

1. Fluid m em branes

Both m irror and two-fold axial symmetry of branch 1 im ply that in Eqn. (30) the tangential term proportional to t vanishes. In the rst case this follows from the fact that branch 1 becomes a line of curvature; hence, the curvature tensor is diagonal in (l;t)-coordinates and thus K_{?k} vanishes. In the second case two-fold axial symmetry forces both K_k as wellas K_? to be zero, since branch 1 becomes a straight line and the prole is antisymmetric. In consequence, K = K_? + K_k = 0. We thereby obtain the rst important simplication of the force from Eqn. (30) on that branch:

W e now exam ine separately the two symmetric geometries (see discussion in Sec. IV C).

a. Symmetric case. Tangent and normal vector on branch 1 lie in the (y;z)-plane, hence l = x. The derivative of K in the direction of l along branch 1, r_? K, is zero due to m irror symmetry. On branch 3 the surface is at and thus the stress tensor is equal to $f_{a;3} = e_a$. W ith this information we can calculate the total force $F_1 + F_3 = F_{sym} x$ on the particle:

where L 0 is the excess length of branch 1 com pared to branch 3. If = 0, we immediately have the im – portant general result that the force is always attractive irrespective of the detailed nature of the source. Unfortunately, the curvature contribution has no evident sign in general. However, for two parallel cylinders adhering to the same side of the interface the overall sign becomes obvious, as long as the particles are long enough such that end e ects can be neglected: the contribution K $_{\rm k}^2$ then vanishes because branch 1 becomes a line. For the same reason L = 0. This leads to the form ula

where L is the length of one cylinder. Thus, the two cylinders repeleach other.

b. Antisymmetric case. Here branch 1 is a twofold symmetry axis and, as we have seen above, $K_k = K_i = 0$. While the sign of $r_i K_k$ is not obvious, the derivative $r_i K_i$ is smaller than zero because K_i changes sign from positive to negative. The prole on the midline is always tilted by the angle ' (s) in the direction indicated in Fig. 3, because any geometry with more than one nodal point in the height function between the particles is expected to possess a higher energy. We a the horizontal separation of the particles and allow other degrees of freedom, such as height or tilt, to equilibrate (see Sec. IV C). The force on the particle is therefore parallel to x, F antisym = F antisym x, and given by

where we have used $x = \cos'$ and $x = \sin'$ at the m idpoint. Note that in this case the tension contribution is repulsive. As before, the sign of the curvature term is not obvious.

If we restrict ourselves to the case of two parallel cylinders adhering to opposite sides of the interface, how - ever, then $r_{?} K_{k}$ vanishes at the midpoint. Furtherm ore, f_{a} j is constant on each of the three free m em brane segments (due to Eqn. (6a)). The stress tensor at branch 1, $f^{?} = f_{a;1}$, must be horizontal to the x axis because vertical components equilibrate to zero as mentioned above. Let us look at the projection of the stress tensor onto 1:

2. M em branes with tilt degree of freedom

In Sec. III we introduced a tangential vector eld m^a on the membrane, thereby modeling the degrees of freedom associated with the tilt of the lipids. The minimal intrinsic H am iltonian density Eqn. (16) already gives rise to a quite form idable additional metric stress, Eqn. (17). Yet, for su ciently symmetric situations the expression for the force simpli es quite dram atically, as we will now illustrate with another striking example.




FIG.4: Two conical inclusions act as sources of a local mem – brane tilt (inset). The tilt- eld-lines are illustrated qualitatively in this symmetric situation.

Let us consider two conicalm embrane inclusions which are inserted with the same orientation into a membrane at some xed distance apart. Each inclusion will, due to its up-down-asymmetry, act as a local source of tilt. Provided the membrane is not in a spontaneously tilted phase, this tilt will decay with some characteristic decay length as described at the end of Sec. III. A typical situation may then look like the one depicted in Fig. 4. W hat can we say about the forces between the two inclusions mediated by the tilt eld?

Following the same reasoning as for the geometrical forces discussed above, and remembering that the tilt vanishes on branch 3 so that its contribution vanishes, we nd

M irror symmetry then inform sus that m^k is an even function along the direction perpendicular to branch 1, while m[?] is an odd function and thus in particular zero everywhere on that branch. It thus follows that both r₂ m^k and r_km[?] vanish everywhere on branch 1. Thus we have

There are two contributions to the force, one stemm ing from gradients of the tilt, the other from the tilt potential V. Remarkably, the tilt gradient contribution from each of the rst two quadratic invariants has the same structural form, thus the Lame coe cients and occur only as a combination in front of the integral. The modulus has dropped out since the corresponding stress vanishes on the mid-curve (see Eqn. (39c)).

The structural similarity of Eqn. (43) to curvature mediated forces { Eqn. (33) { is very striking. Since $\frac{1}{2}$ + > 0 [35], the rst integral states that perpendicular gradients of the perpendicular tilt lead to repulsion, while parallel gradients of the parallel tilt in ply attractions { the same \backslash ?² k² " motif as found in Eqn. (33). Since in the untilted phase V (m 2) 0, the second line shows that the integrated excess potential drives attraction, just as the excess length (som ething like an integrated \surface tilt") drives attraction in Eqn. (33). Unfortunately, the overall sign of the force is not obvious. Looking at the eld lines in Fig. 4, the visual analogy with electrostatic interactions between like charged particles would suggest a repulsion, but the above analysis advises caution (in Sec. VIC we will see that this naive guess is at least borne out on the linearized level). M oreover, we should not forget that tilt does couple to geometry (namely, via the covariant derivative) and that the m em brane by no m eans needs to be at; hence, the contribution due to tension and bending given by Eqn. (33)must be added, the sign of which is equally unclear.

3. Further geom etric H am iltonians

W ithin the fram ework of reparam etrization invariant H am iltonians providing a scalar energy density, a system – atic power series in terms of all available scalars and their covariant derivatives (each multiplying som e phenom enological \modulus") is a form al (and in fact standard) way of obtaining an energy expression of a physical system . In this respect the H am iltonian (24) is no exception, being sim ply the quadratic expansion for an up-down symm etric surface (notice that a term proportional to K would break this symmetry, giving rise to a spontaneous curvature). We hasten to add that a second quadratic term, proportional to the G aussian (or R icci) curvature, exists as well, but this usually plays no role since it only results in a topological invariant (see also the Appendix).

The fact that curvature (a \generalized strain") enters quadratically in the H am iltonian (24) classi es this form of the bending energy as \linear curvature elasticity" (even though the resulting shape equations are highly nonlinear). However, for su ciently strong bending higher than quadratic term s will generally contribute to the energy density, giving rise to genuinely nonlinear curvature elasticity [45]. Nevertheless, such e ects pose no serious problem for the approach we have outlined so far. In fact, they are incorporated very naturally. We would like to illustrate this with two examples.

a. Quartic curvature. Sticking with up-down symmetric surfaces, the next curvature order would be quartic, and this gives rise to three more scalars: K 4 , K $^2{\rm R}$ and R 2 . Let us for simplicity only study the case of a quartic contribution of the form

if two parallel cylinders adhere to the same side of the interface. This term increases the repulsion between cylinders found on the linear elastic level (see Eqn. (34)), provided $_4 > 0$, i.e., provided the quartic term further sti ens the mem brane.

A ssum ing that H₄ perturbs the usual bending H am iltonian $\frac{1}{2}$ K², we can use the two moduli to de ne a characteristic length scale $'_4 \Rightarrow p$ j₄ = . The overall force up to quartic order can then be written as

Notice that the correction term becom es only noticeable once the curvature radius of the membrane is no longer large com – pared to the length scale $'_4$. It appears natural that $'_4$ is related to the membrane thickness, which for phospholipid bilayers is about 5 nm. A ssum ing a (quadratic order) bending sti ness of ' 20 k_BT, we thus expect values for the modulus $_4$ on the order of 10^3 k_BT nm².

b. Curvature gradients. In order length 4 it is possible to also generate scalars which depend on derivatives of the surface curvature. One such term is

for the force between two symmetrically adhering cylinders. It depends on very subtle details of the membrane shape: the curvature is (roughly) a second derivative of the mem brane position, and this we need to square and di erentiate two more times. Unfortunately, the sign of the interaction is not obvious here, as the second derivative of K $_2^2$ with respect to Im ay be either positive or negative. Finally, we can also de ne a characteristic length scale here, $r := j_r := T$. The importance of a perturbation H $_r$ of the usual bending H am iltonian depends on whether or not the curvature changes signi cantly on length scales com parable to r_r .

V. DESCRIPTION OF THE SURFACE IN MONGE PARAMETRIZATION

In the previous section analytical expressions for the force between two attached particles have been derived which link the force to the geometry of the surface at the m idplane between them. It is worthwhile reem phasizing that they are exact, even in the nonlinear regime. In special cases, the sign of the interaction is also revealed.

If one is interested in quantitative results, however, shape equations need to be solved { num erically or analytically. Either way, one needs to pick a surface param etrization. The choice followed in essentially all existing calculations in the literature is \M onge gauge", and for analytical tractability its linearized version. The purpose of this and the following section is to translate the general covariant form alism developed so far into this m ore fam iliar language. To this end we rst rem ind the reader what the basic geom etric objects look like in this gauge. We are then in a position to quantitatively study three di erent exam ples of interface m ediated interactions in Sec. VI.

A. De nition and properties

A ny surface free of \overhangs" can be described in terms of its height h(x;y) above some reference plane, which we take to be the (x;y) plane. Notice that x and y thus become the surface coordinates. The direction of the basis vectors fx;y;zg 2 R³ is as described in Sec. IV C.

The tangent vectors on the surface are then given by $e_x = (1;0;h_x)^>$ and $e_y = (0;1;h_y)^>$, where $h_i = @_ih$ (i;j2 fx;yg). The metric is given by

where $_{ij}$ is the K ronecker symbol. Observe that g_{ij} is not diagonal; even though the coordinates fx; yg refer to an orthonom alcoordinate system on the base plane, this property does not transfer to the surface they parameterize. We also de ne the gradient operator in the base plane, $r := (e_x; e_y)^>$. The metric determ inant can then be written as $g = ig_{ij}j = 1 + (r h)^2$, and the inverse metric is given by $g^{ij} = _{ij} h_i h_j = g$. It is, perhaps, worth emphasizing that the latter, just as Eqn. (49), are not tensor identities. The right-hand side gives the num erical values of the components of the covariant tensors g_{ij} and g^{ij} with respect to the coordinates x and y.

The unit norm alvector is equal to

B. Sm all gradient expansion

In Sec.VI we will be interested in surfaces that deviate only weakly from a at plane. In this situation the gradient r h is small, and it is su cient to consider only the lowest nontrivial order of a small gradient expansion. K and dA can then be written as

W e are now in a position to determ ine the forces between two particles in di erent situations.

VI. EXAMPLES

In this section we will illustrate the general fram ework of geom etry-encoded forces by treating three im portant exam ples in M onge gauge: capillary, curvature m ediated, and tilt-induced interactions. For the rst two, forcedistance curves have previously been derived on the linearized level [7, 8, 11]. The route via the stress tensor reproduces these results with remarkable ease, thereby underscoring its e ciency and also con m ing its validity (at least on the linear level). To illustrate tiltm ediated interactions we restrict to a simplified situation in which we neglect the coupling of mem brane shape and tilt-order. Even if the geometry is \trivial" (a at m em brane), the material stress tensor is not, and forces remain.

Both geometric examples are special cases of the Ham iltonian density (24). W hen the gradients are sm all, the surface energy is given by the quadratic expression:

If = 0 this describes a scap lm; if $\neq 0$ it will describe a uid mem brane.

The approach, traditionally followed in the literature, is to rst determ ine the surface proleh (x;y) which m inim izes the energy Eqn. (57). For this one must solve the linear Euler-Lagrange equation

where ' is the length from Eqn. (25). In a next step, the energy corresponding to this shape is evaluated by reinserting the solution of Eqn. (58) into the functional (57). This energy will depend on the relative positions of the bound objects. Appropriate derivatives of the energy with respect to these positions will yield the forces between the particles. By contrast our approach | sidestepping the need to evaluate the energy | will be to determ ine the force directly from the surface pro le using the line integral expressions for the force, Eqns. (33) and (35).

A. Soap lm s

For a scape lm , = 0 and thus = 0. The relevant Euler-Lagrange equation is therefore the Laplace equation, r²h = 0.

Consider isst the symmetrical conguration consisting of two parallel cylindrical particles which adhere to one side of the scap lm. Eqn. (33) indicates that, if we neglect end e ects, the force between the cylinders is proportional to the excess length on branch 1. The excess length, how ever, is zero because the contact lines are straight. Therefore, the force is also zero. Likewise, in the antisymmetric conguration with adhesion on opposite sides, the scap lm between the cylinders will be at if the vertical particle displacements are allowed to equilibrate. Therefore, '(s) = 0 (see Fig. 3) and Eqn. (35) will yield a zero force exactly as in the symmetric case. In an analogous way one obtains the same result for the case of two spheres.




FIG.5: De nition of the coordinates for a single quadrupole (viewed from above).

The situation is less simple if the lm is pinned to the particle surface. Let us consider two spherical particles of radius a with a contact line that departs only weakly from a circle.

Stam ou et al. [7] have studied this case by using a superposition ansatz in the spirit of N icolson [46]: rst, the height function of one isolated particle is determ ined with the correct boundary conditions. Then, the com – plete height function is assumed to be the sum of the two single-particle elds of each of the two colloids. Strictly speaking, this approach destroys the boundary conditions at the particles' contact lines; it does, how ever, give the correct leading order result for large separation [47].

Using polar coordinates $\$ and $\$, the solution of the shape equation outside a single spherical particle can be written as [7]

with multipole coe cients A $_{\rm m}$ and phase angles $_{\rm m}$;0. The form er can be determ ined as follows: The monopole A₀ vanishes because there is no external force such as gravity pulling on the particle. The dipole coe cient A₁ characterizes the tilt of the contact line relative to the z axis; it also vanishes if there is no external torque acting on the sphere. All higher multipole coe cients can be read o from the Fourier expansion of the contact line at = a. It is intuitively obvious and indeed con m ed by a more careful calculation [7, 8] that the quadrupole dom inates the energy at low est order.

0 ne can therefore restrict the calculation to the singleparticle height function [7]




FIG.6: Two quadrupoles on a soap lm (viewed from above).

Let us now exam ine the same two con gurations using the line integral representation for the force.

a. Symmetric case. The force Eqn. (33) is proportional to the excess length of branch 1 with respect to branch 3. To quadratic order in gradients, this di erence can be written as

However, it would be fair to say that we have gained additional information concerning the nature of this force, missing before. The force is directly proportional to the length added to the mid-curve as it is stretched. A geometrical interpretation has been provided for the force. Recall also that this is a non-perturbative result: it does not depend on the sm all gradient approximation.

b. Antisymmetric case. In this case the horizontal force is given by Eqn. (35) with = 0:

Inserting this into Eqn. (65) yields a force which again agrees with the one obtained in Eqn. (61).

As an example, let us bok at colloids with a radius of 1 m trapped at the air-water interface (' 70 m N = m), which have a pinning quadrupole of 1% of their radius (Q ' 10 nm). At a separation of 3 m they feel an (attractive or repulsive) force of 1 pN, and at a separation of about 16 m their interaction energy is comparable to the therm all energy. These forces are not particularly strong, but they act over an exceptionally long range.

B. Fluid M em branes

To describe a uid membrane, it is necessary to include the bending energy in Eqn. (57). Let us focus on the problem of two parallel adhering cylinders which are su ciently long so that end e ects can be neglected (the uid membrane analogue of the problem exam ined for soap lm s). In this case the height function of the surface depends only on one variable, x. R ecall that for the corresponding soap lm case no interaction occurred (in the absence of pinning), see Sec. VIA.

a. Symmetric case. Using the energy route, Weikl [11] shows that, at lowest order in the small gradient expansion, the energy per unit length of the cylinder is [48]

Here R is the cylinder radius, U is the adhesion energy per unit area, ' is the characteristic length de ned in Eqn. (25), and d is the distance between the two centers of the cylinders. To obtain the force per unit length L of the left cylinder, we di erentiate Eqn. (68) with respect to d [49]:

How big are these forces? As an example, let us look at an actin lam ent (R ' 4 nm) adsorbed onto a m em brane with a typical bending sti ness $1 p^2 \frac{0 k_B T}{p^2}$, where $k_{\rm B}T$ is the therm all energy. Noting that 2U = w ill be the contact curvature at the point where the m em brane detaches from the adsorbing lam ent [50] and that this should not be too much smaller than the bilayer thickness in order for a Helfrich treatment to be permissible, we take $2U R^2 = 1$ as an upper lim it. We then nd that two adsorbed actin laments at a distance d' ' (where approximately sinh cosh 1) feel a force of about 3pN=nm . Alternatively, we can calculate at what 2 distance the interaction energy per persistence length of the lament ($_{p}$ 15 m) is of order k_{B} T. Using a typical value for cell m em branes of ' 50 nm, we obtain a separation of about 0:7 m. This is huge, and should rem ind us of the fact that on this scale a lot of m em brane uctuations will occur which we have neglected. Still, it shows rather vividly that membrane mediated forces can be very signi cant.

C. Lipid tilt

The discussion in Sec. III shows that lipid tilt order, described by the surface vector eld m^a, in uences the shape of the membrane, even if the Ham iltonian density does not contain an explicit coupling of m^a to the extrinsic curvature. The coupled system of di erential equations (18) poses a form idable task, clearly exceeding the already substantial one for the undecorated shape equation alone.

O ur priority is to illustrate the workings of the general form alism, therefore we will lim it the discussion to a simple case where the analytical treatment is rather transparent: we will assume that the mem brane itself remains at, such that the energy density stem s exclusively from lipid tilt (as described by H $_{\rm m}$ from Eqn. (16)). This is not a self-consistent approximation, but should give a good description in the lim it in which the tilt moduli

and are signi cantly \softer" than the bending m odulus. In this case the inclusions we have talked about in Sec. IV D 2 will predom inantly excite tilt and not bend. M ore sophisticated (analytical and num erical) studies of lipid tilt and m ediated interactions exist, which provide better quantitative answers [24].

For at m em branes, the Euler-Lagrange equation (19) reduces to

where m is the 2d tilt vector in the mem brane plane. Focusing rst on one inclusion, the situation acquires cylindrical sym metry. W riting m (r) = m (r)e_r and restricting to the untilted mem brane phase, for which the tilt potential is su ciently well represented by V (m²) = $\frac{1}{2}$ tm² with t > 0, Eqn. (78) reduces to a simple Bessel equation

where r_0 is the radius of the inclusion, m $_0$ the value of the tilt at this point, and K a modi ed Bessel function of the second kind [51]. As anticipated, the tilt decays essentially exponentially with a decay length of r_m .

O btaining the exact tilt eld for two inclusions is very di cult, since satisfying the boundary conditions is troublesom e. However, if we again use the N icolson approxim ation [46] and assume that the total tilt distribution is given by the superposition of two solutions of the kind (80), things become m anageable. The tilt-m ediated force between two symmetric inclusions is then obtained by inserting the appropriate values and derivatives of the tilt eld m (x;y) on the mid-line into Eqn. (43). A fier some

where $m_0 = m_0 = K_1 (r_0 = m)$, d = d=2 m, and d is the separation between the inclusions. As we see, the force is repulsive and decays essentially exponentially with distance over a decay length of m. Integrating it, we get the repulsive interaction potential

Let us try to make a very rough estimate of how big such a force m ight be. For this we need to obtain some plausible values for the num bers entering into Eqn. (81). For twe may use the equipartition theorem and argue that $\frac{1}{2}$ thm ² ia = $\frac{1}{2}$ k_B T, where a is the area per lipid and $k_{\rm B}\,T$ the therm alenergy. A ssum ing that the root-m eansquare uctuations of m are 10 and using the typical value a ' 0.75 nm^2 , we get t ' $40 \text{ k}_B \text{ T} = \text{nm}^2$. Assum ing further a rather conservative tilt decay length of the order of the bilayer thickness, i.e. m' 5 nm, that the inclusion has a radius of r_0 ' 3 nm and imposes there a local tilt of m ' 0:2, we nd that two inclusions at a distance of 10 nm feel a signi cant force of about 17 pN. And at a distance of d 22 nm their mutual potential energy is $1 k_B T$ compared to the separated state. Notice that this is much larger than the Debye length in physiological solution, which is typically only 1 nm . Hence, tilt-m ediated forces can compete with more conventional forces, such as (screened) electrostatic interactions. It should be kept in m ind, however, that if we perm it the m em brane to bend, som e of the tilt strain can be relaxed, thereby low ering the energy.

VII. CONCLUSIONS

We have shown how the stress tensor can be used to relate the forces between particles bound to an interface directly to the interface geom etry. In this approach, the force on a particle is given by a line integral of the stress along any closed contour surrounding the particle. The stress depends only on the local geom etry; thus the force is completely encoded in the surface geom etry in the neighborhood of the curve.

The relationship between the force and the geometry provided by the line integral is exact. In the linear regime, as we have shown for selected examples in the previous section, the force determ ined by evaluating this line integral reproduces the result obtained by the m ore fam iliar energy based approach. Unlike the latter, how ever, our approach perm its us to consider large deform ations. The expression for the line-integral is fully covariant, involving geom etrical tensors; one is not limited to any one particular param etrization of the surface such as the M onge gauge. Indeed, as we have seen the geom etrical origins of the force can get lost in this gauge.

Aswe have emphasized previously, this approach is not a substitute for solving the nonlinear eld equations. To extract numbers, we do need to solve these equations. But even before this is done, the line integral expression can provide valuable qualitative information concerning the nature of the interactions between particles. This is because the geometry along the contour is often insensitive to the precise conditions binding the particle to the interface. This contrasts sharply with the energy based approach; there, one needs to know the entire distribution of energy on the interface before one can say anything about the nature of the interaction. As we have seen in the context of a sym metrical two-particle con guration, it is sometimes relatively easy to identify qualitative properties of the geom etry; it is virtually im possible to make corresponding statem ents about the energy outside the linear regime.

The stress tensor approach also has the virtue of combining seam lessly with any approach we choose, be it analytical or num erical, to determ ine the surface shape. Thus, for instance, one can nd surfaces that minim ize a prescribed surface energy functional using the program \Surface E volver" [53]. The evaluation of the force via a line integral involving the geom etry along the contour is straightforward; in contrast, the evaluation of the energy involves a surface integral, and the forces then follow by a subsequent num erical di erentiation. In other words, the route via the energy requires one more integration but also one more di erentiation. This appears neither econom ical nor num erically robust.

We have illustrated how internal degrees of freedom on the mem brane can be incorporated within this approach using a vector order parameter describing lipid tilt as an example. It is indeed remarkable just how readily nongeometrical degrees of freedom can be accommodated within this geometrical framework. Here again, new exact non-linear expressions for the force between particles mediated by the tilt are obtained which are beyond the scope of the traditional approach to the problem. Various patterns emerge which could not have been guessed from inspection of the Ham iltonian, in particular the existence of a $\langle ? 2 > k^2 > m$ of from mon to the geometrical and tilt mediated forces between symmetrical particles.




FIG. 7: Three-body interactions. The force on one particle can be obtained by integrating the surface stress tensor along a line of integration enclosing that particle. (cf. Eqn. (12)).

We have considered the force between a pair of particles. However, the interaction between more than two particles is generally not expressible as a sum over pairwise interactions; superposition does not hold if the theory is nonlinear (see Ref. [15] for a striking illustration). This, however, poses no di culty for the stress tensor approach, because the underlying relation between surface geom etry and force is independent of whether or not a pair-decom position is possible (see Fig. 7). For certain symmetric situations a clever choice of the contour of integration may again yield expressions for the force

analogous to those obtained in Sec. IV D.

M ultibody e ects becom e particularly relevant when one considers 2D bulk phases as, for instance, in a system consisting of a large number of mutually repulsive particles adhering to one side of an interface. In this case it is possible to identify expressions for state variables such as the lateral pressure by exploiting the approach which has been introduced here.

The interfaces we have considered are asymptotically at and thus support no pressure di erence. At rst glance it m ay appear that our approach fails if there is pressure because the stress tensor is no longer divergence free on the free surface (one has $r_a f^a = Pn$) which would obstruct the deform ation of the contour described in Sec. IV C. As we will show in a forthcom ing publication, how ever, it is possible to adapt our approach to accom m odate such a situation.

The interactions we have exam ined correspond to particles whose orientations are in equilibrium. The additional application of an external torque (e.g. on two dipoles via a magnetic eld) will introduce a bending moment. It is, how ever, possible to treat such a situation with the tools provided in R ef. [28]: Just as translational invariance gives us the stress tensor, rotational invariance gives us a torque tensor. Its contour integrals provide us with the torque acting on the patch one encircles.

F inally, genuine capillary forces involve gravity. The associated energy, how ever, depends not only on the geometry of the surface but also on that of the bulk (it is a volum e force). The results thus di er qualitatively from those presented here. This will be the subject of future work.

Here, $G_{ab} = R_{ab} - \frac{1}{2}Rg_{ab}$ is the E instein tensor, which vanishes identically in two dimensions. In higher dimensions, however, E(R) / G_{ab} is a non-trivial result, and the above seem ingly inelegant (since extrinsic) derivation is after all remarkably econom ical.

e. Vector eld. As a nalexample let us consider Ham iltonians of the kind introduced in Sec. III, which have internal vector degrees of freedom. W ith the symm etric tilt-strain tensor $M^{ab} = \frac{1}{2} (r^{a}m^{b} + r^{b}m^{a})$ we can for instance bok at the quadratic H am iltonian density $H = \frac{1}{2} (r_{a}m^{a})^{2} = \frac{1}{2}M^{2}$, where m^{a} is the (contravariant) surface vector eld and $M = g_{ab}M^{ab}$. This term is purely intrinsic, hence $H^{ab} = 0$. The di cult part is the covariant di erentiation, which acts on a vector eld and is thus dressed with an additional Christo el symbol. Since the latter depends on the metric and its rst partial derivative [26], it will contribute to the variation:

The rst term is once more simplified via Eqn. (A2), while the second term calls for the Palatini identity β]

$$g_{ab}^{c} = \frac{1}{2}g^{cd}r_{b}g_{la} + r_{a}g_{bd}r_{d}g_{ab}$$

Since the g_{ab} are the components of a tensor (they must describe a proper variation of the metric tensor), the variation g^{c}_{ab} is also a tensor, even though the Christo el symbol itself is not. U sing Eqn. (A 16), the second term in Eqn. (A 15) can thus be rewritten as

$$g (\mathfrak{m}_{a}^{a} + a_{ab}^{a} \mathfrak{m}^{b})^{2} = 2M \mathfrak{m}^{b} g_{ab}^{a}$$
$$= M \mathfrak{m}^{b} g^{ad} (\mathfrak{r}_{b} g_{ba} + \mathfrak{r}_{a} g_{bd} \mathfrak{r}_{d} g_{ab})$$
$$= M \mathfrak{m}^{d} g^{ab} (\mathfrak{r}_{d} g_{ab}) : \qquad (A 17)$$

The derivative of q_{ab} is removed by a nalpartial integration. Collecting everything, we thus nd (up to irrelevant boundary term s)

Thus, the metric stress tensor is

Notice that it is directly proportional to the metric; its e ect in the stress tensor will thus be to renorm alize the surface tension.

The second quadratic invariant, $H = M_{ab}M^{ab}$, does not provide any additional di culties com pared to $\frac{1}{2}M^2$, even though the calculation is a bit longer. One nds:

Finally, the third quadratic invariant $H = \frac{1}{4}F_{ab}F^{ab}$ (with $F^{ab} = r^{a}m^{b} r^{b}m^{a}$) can be treated rather easily by noting that $F_{ab} = Q_a m_b - Q_b m_a$ is independent of the connection. A short calculation then shows that

This is nothing but the energy-m om entum tensor from electrodynam ics [36]. In two dimensions it can be further simplified, since any antisymmetric tensor is then proportional to the epsilon-tensor: $F^{ab} = \frac{1}{2} m^{ab} m_{cd} F^{cd}$. Inserting this into Eqn. (A 21) and using the identity $m^{ac} m^{b}_{c} = g^{ab}$
