## C rystal eld states in conducting m agnetic m aterials: N dA $l_2$ , U P d<sub>2</sub>A $l_3$ and Y bR h<sub>2</sub>S $i_2$

The existence of CEF states and the magnetism in conducting compounds  $N dA \downarrow$ ,  $UP d_2A \downarrow$  and  $Y bR h_2 Si_2$  is discussed. We point out that in metallic compounds localized crystal-eld states coexist with conduction electrons. These compounds are physical realization of an anisotropic spin liquid, which in case of the atom ic-like conguration with an odd number of felectrons, is unstable with respect to spin uctuations for T  $\{> 0 \text{ K} \cdot Y bR h_2 Si_2 \text{ is discussed as a compound with the K ramers doublet ground state with a very low magnetic ordering temperature being a reason for the quantum critical point phenomena at low T.$

I. INTRODUCTION AND THE AIM

 $N dA_{2}$ ,  $UP d_{2}A_{3}$  and  $Y bR h_{2}S_{2}$  are all metallic com pounds. The aim of this paper is to study crystal-eld (CEF) e ects in these m etallic com pounds ow ing to the fact that still the concept and the use of the crystal eld approach is questioned, if applied to m etallic com pounds. There are opinions that obtained agreem ents with m any experim ental data within the CEF-based approaches are accidental (for further details of these reproaches see ArX iv/cond-m at/0504199). For us the many-electron CEF approach is obvious and well founded in solid-state physics. The many-electron CEF approach captures the essential physics of transition-m etal com pounds. We think that much of the localized/itinerant controversy is related to m isunderstandings due to a long-lasting lack of the open scienti c discussion that would allow for good, scienti cally clear, formulation of the subject of the controversy. The CEF is a result of an inhom ogeneous charge distribution in a solid. So, it is everywhere. Another problem is its quanti cation. In a crystal due to the translational symmetry and a high point symmetry the CEF potential can be quantied by CEF coe cients that re ect multipolar charge m om ents of the surroundings. A transition-m etal cation with the incom plete 4f/5f shell serves as a probe of this CEF multipolar potential showing the discrete splitting of the localized 4f/5f states. Here we will present this discrete splitting of the localized 4f/5f states in N dA  $\downarrow$ , UP d<sub>2</sub>A  $\downarrow$  and Y bR h<sub>2</sub>S  $\downarrow$ . The shown transition-m etal cations have in these com pounds an odd number of 4f/5f electrons. Thus, they have charge-form ed K ram ers doublet ground state. Due to the presence of the orbitalm om ent all of these com pounds can serve as example of the anisotropic spin lattice, here chosen in a sequence of the lowering ordering tem perature.

### II. FERROMAGNET NdA 12




FIG. 1: Calculated temperature dependence of 10 states (J=9/2) of the ground multiplet of the N d<sup>3+</sup> ion in the paramagnetic and the magnetic state of the ferrom agnet N dA  $\lfloor_2$ . In a magnetic state, below 65 K, the K ram ers degeneracy is lifted and a spin gap is form ed. The spin gap amounts at T = 0 K to 60 K.

 $N dA_{2}$  crystallizes in the cubic  $M qC u_{2}$  structure and orders ferrom agnetically below 65 K [1]. Am ong other papers in Ref. 2 it has been shown that its magnetic and electronic properties are very well described as being predom inantly determ ined by the  $Nd^{3+}$  ion with the  $4f^{2}$ con guration. In Ref. 2 the temperature dependence of the magnetic moment and of the heat capacity have been calculated. Fig. 1, similar to that shown in Ref. [2] - here we use the same parameters, only we derive now more physical quantities, shows a discrete electronic structure of 10 lowest localized states originating from the lowest multiplet J=9/2. The 4f<sup>2</sup> con quration has in total 120 localized states. The localized felectrons coexist with itinerant electrons originating from outer 3 Nd electrons and from outer A lelectrons. It inerant electrons form a band and are responsible for the conductivity. Their contribution to the magnetic moment or to the heat capacity, for instance, is negligible in comparison to that of localized electrons. The crystal- eld splitting amounts to 160 K. Magnetic interactions enlarge this splitting to 350 K. The calculated m agnetic m om ent at 0 K of 2.62  $_{\rm B}$  is in good agreem ent with the experimental datum of 2.5 0.2  $_{\rm B}$  [1]. The calculated total moment is composed from the spin moment  $m_s = 3.35_B$  and orbitalm om ent m $_{o}$  = -0.73  $_{B}$ . For calculations we make use of a single-ion like Hamiltonian for the ground multiplet J=9/2 [2]:

In Equation (1) the rst term is the (cubic) crystal-eld H am iltonian with  $B_4 = -11.48 \text{ mK}$  and  $B_6 = +0.464 \text{ mK}$ . These parameters yield the multipelarm on ent of the N d surroundings  $A_n^m = B_n/(n_r_{4f}^n \text{ of } A_4 = +13.5 \text{ Ka}_0^{-4}$  and  $A_6 = -0.81 \text{ Ka}_0^{-6}$ . In is parespective Stevens factor of the ground multiplet and  $r_{4f}^n$  is the respective power of the 4f radius. The second term takes into account intersite spin-dependent interactions ( $n_{RR} - m$  olecular eld coe cient, magnetic moment  $m = -gJ_B$ , g = 8/11 - L and e factor) - it produces the magnetic order below  $T_c$  what is seen in Fig. 1 as the appearance of the splitting of the K ram ers doublets and in experiment as the -peak in the heat capacity at  $T_c$ .

# III. HEAVY FERM ION SUPERCONDUCTOR ANT IFERROM AGNET UP $d_2A\ l_3$




FIG. 2: Calculated energy level scheme of three stronglycorrelated f electrons, the  $5\vec{f}$  con guration of the U<sup>3+</sup> ion, in UPd<sub>2</sub>Al<sub>2</sub>. A rrows indicate transitions which we have attributed to excitations observed by inelastic-neutronscattering experiments of K rimmelet al. [9]. A fter [6].

UPd<sub>2</sub>A  $\downarrow_3$  exhibits supercoductivity below 2 K coexisting with antiferrom agnetism that appears below 14 K [3,4]. A controversy is related to description of f electrons, it inerant or localized in a number of 2 or 3. In our Refs. [5] and [6], in contrary to authors of Refs [7,8] claiming the 5f<sup>2</sup> con guration, we have interpreted the excitations observed by K rim melet al. [9] as related to the energy level scheme: 0, 7 m eV (81 K), 10 m eV (116 K) and 23.4 m eV (271 K) of the f<sup>3</sup> (U<sup>3+</sup>) con guration. The ne electronic structure of the f<sup>3</sup> (U<sup>3+</sup>) consists of ve K ram ers doublets split by multipolar charge interac-

tions (CEF interactions). The ne electronic structure

originates from the lowest multiplet  ${}^{4}I_{9=2}$ , higher multiplets are at least 0.2 eV above and do not a ect practically the ground-multiplet properties. These 5 doublets are further split in the antiferrom agnetic state, i.e. below  $T_N$  of 14 K as is shown in Fig. 2. For calculations we make use the same Ham iltonian as for the Nd ion in NdAb. A derived set of CEF parameters of the hexagonalsym m etry:  $B_2^0 = +5.3 \text{ K}$ ,  $B_4^0 = +40 \text{ m} \text{ K}$ ,  $B_6^0 = -0.02 \text{ m} \text{ K}$ and  $B_6^6$  = + 26 mK yields states at 81 K, 120 K, 270 K and 460 K, energies of which are in perfect agreement with the experim entally observed excitations. The highest state was not observed in INS experiment. This electronic structure accounts also surprisingly well for the overall tem perature dependence of the heat capacity, the substantial uranium magnetic moment and its direction [6].




FIG.3: Tem perature dependence of the excitation energy to the K ram ers conjugate state of the f<sup>3</sup> (U<sup>3+</sup>) con guration in UPd<sub>2</sub>A  $l_3$ . This energy is obtained as the di erence between energies of two lowest states seen in Fig. 2, taken from Ref. [6]. Both the value of the energy and its tem perature dependence is in close agreement to a low-energy excitation of 1.7 m eV at T = 0 K observed by Sato et al. [8] and attributed by them to a magnetic exciton.

In Fig. 3 we present temperature dependence of the splitting energy between two conjugate K ram ers ground state. Surprisingly, both the value of the energy and its temperature dependence is in close agreement to a low-energy excitation of 1.7 m eV at T = 0 K observed by Sato et al. [8] which has been attributed by them to a m agnetic exciton. We are convinced that the 5 $f^{2}$  (U<sup>3+</sup>) scheme provides a physical explanation for the 1.7 m eV excitation (m agnetic exciton) - this excitation is associated to the rem oval of the K ram ers-doublet ground state degeneracy in the antiferrom agnetic state.

#### IV. HEAVY-FERM ION METALYbRh2Si2

 $Y bRh_2Si_2$  is one of a hallmark heavy-ferm ion com – pound with a K ondo tem perature  $T_K$  of 25-30 K. It becomes recently of great scienti c in portance after the discovery in Prof. F. Steglich group [10] of the well-de ned Electrons Spin Resonance (ESR) signal at tem perature

so low as 1.5 K sim ilar to the ESR signal observed in conventional diluted Y b alloys with the Y b<sup>3+</sup> ion. A coording to the K ondo m odel below T<sub>K</sub> there should not be discrete states. The derived g tensor is very anisotropic:  $g_{?} = 3.561$  and  $g_{k} = 0.17$  at 5 K. At 2 K  $g_{?}$  decreases to 3.50. In Ref. [11] we have derived two sets of CEF parameters that yield two K ramers doublet ground-state eigenfunctions,  $\frac{1}{6}$  or  $\frac{1}{7}$ , that reproduce this g tensor at 5 K:

In Ref. [12] we have proposed a physical experiment in order to distinguish these two ground states. We have calculated temperature dependence of the quadrupolar interactions for these two states. As it is very dierent for these two ground states the Mossbauer experiment should easily distinguish them. For perfect reproduction of the g tensor within the fully-localized crystal-

eld model it was necessary to introduce the CEF  $B_2^2$  term. It indicates low ering of the tetragonal sym metry of Y bR h<sub>2</sub>Si<sub>2</sub> at low temperatures to the orthorhom bic sym metry. The increase of this distortion with low ering temperature is, according to us, the reason for temperature variation of the g tensor.

# V. SOM E REM ARKS ON THE CRYSTAL-FIELD APPROACH

A success in description of  $N dA l_2$  within the atom icbased CEF approach is related to a fact that there is only one crystallographic N d site up to low est tem peratures. D ue to the K ram ers doublet ground state being not susceptible to the charge surroundings and due to relatively large separation to the rst excited statem echanism s leading to a lowering symmetry are not e ective as by them the system cannot gain energy. NdA  $l_2$  being ferrom agnet assures conditions for all Nd m om ents to have the same m agnetic interactions. It causes that all Nd ions equally contribute to the m acroscopic m agnetization and therm odynam ical properties. As a consequence, the m acroscopic m olar values are obtained from the atom ic-scale properties by simple multiplication by the Avogadro number.

We advocate by years for the importance of the crystaleld approach in 4f/5f compounds, also in those exhibiting heavy-ferm ion phenomena. Of course, we do not claim that CEF explains everything (surely CEF itself cannot explain the form ation of a magnetic ordering, for which in Eq. 1 we add the second term), but surely the atom ic-like 4f/5f/3d cation is the source of the magnetism of a whole solid. The atom ic-scale magnetic mom ent is determined by locale ects known as crystal eld and spin-orbit interactions as well as very strong electron correlations. These strong electron correlations are predom inantly of the intra-atom ic origin and taking into account, in the rst approximation, via on-site H und's rules. These strong correlations lead to many-electron version of the CEF approach.

Finally, we use a name "f electrons", as offen is used in literature. O focurse, f electrons are not special electrons but it means electrons in f states. f states have well de ned characteristics, like the orbital quantum number l. By identifying states in a solid we can identi ed f electrons, in particular their number.

### VI. CONCLUSIONS

O wing to a debate on the form ation and a role of localized crystal- eld states in conducting magnetic materials we point out that in metallic compounds localized crystal- eld states coexist with conduction electrons. The form er are predom inantly responsible for magnetic and low-energy spectroscopic properties, the latter for the conduction.

In N dA  $\frac{1}{2}$  and UP d<sub>2</sub>A  $\frac{1}{3}$  we illustrate the physical realization of the anisotropic spin liquid (lattice of K ram ers ions with an odd number of electrons), that is unstable with respect to spin uctuations for T {> 0 K. In these three compounds the magnetic ordering temperature decreases from 65 K via 14 K to 0.07 K only in case of Y bR h<sub>2</sub>Si<sub>2</sub>. The di culty in the removal of the K ram ers degeneracy in case of Y bR h<sub>2</sub>Si<sub>2</sub> is, according to us, the reason for the quantum critical point phenom ena observed at ultra-low temperatures.

In our atom ic-start approach to 3d-/4f-/5f-atom containing compounds we take into account crystal eld and spin-orbit interactions as well as very strong electron correlations, predom inantly of the intra-atom ic origin.
