Spin-density-functional theory: som e open problem s and application to inhom ogeneous H eisenberg m odels

A bstract

Spin-density-functional theory (SD FT) is them ost widely in plem ented and applied form ulation of density-functional theory. However, it is still nding novel applications, and occasionally encounters unexpected problem s. In this paper were storie y describe a few of the latter, related to issues such as nonuniqueness, noncollinearity, and currents. In the main part we then turn to an example of the former, namely SD FT for the Heisenberg model. It is shown that time-honored concepts of C oulom b D FT, such as the local-density approximation, can be applied to this (and other) model H am iltonians, too, once the concept of 'density' has been suitably reinterpreted. Local-density-type approximations for the inhom ogeneous Heisenberg model are constructed. Numerical applications to

nite-size and impurity systems demonstrate that DFT is a computationally e cient and reasonably accurate alternative to conventional methods of statistical mechanics for the Heisenberg model.

1 Introduction

Density-functional theory (DFT) is widely recognized as a versatile and powerful tool for practical calculations of the electronic structure of matter, on scales ranging from single atom s to extended solids. Its relatively low computational cost m akes it attractive as a tool for answ ering m aterial-speci c questions in elds as diverse as quantum chem istry, materials science, and many-body physics [1]. In practice, DFT is most commonly used in its spin-dependent self-consistent-eld formulation as Kohn-Sham spin-density-functional theory (SDFT) [2, 3]. A Itemative form ulations that use other variables in addition to (or instead of) the spin densities, or that proceed without invocation of K ohn-Sham -type equations, are, how ever, occasionally useful. Som e such alternative form ulations are described in this contribution. Section 2 gives a brief overview of three recent developm ents of this type in SDFT, relating to currents, noncollinear spin states and nonuniqueness. In each case a surprising feature of the respective extension of DFT will be highlighted. Section 3 contains a more detailed description of a recent application of SDFT to model Ham iltonians of the Heisenberg type, where results can be obtained without solving K ohn-Sham equations.

2 Som e recent developm ents in spin-density-functional theory

From a practical point of view, among the most important tasks remaining in the development of SDFT are to obtain everbetter approximations for the exchangecorrelation (xc) functional, and to learn how to calculate further quantities of physical and chemical interest from the output quantities of SDFT, the spinresolved charge densities. While total energies and related quantities are readily accessible in terms of these densities, many other interesting quantities are not.

2.1 Electronic currents

E lectronic currents are one example. Such currents are functionals of the charge density, but cannot be calculated as such because this functional is unknown. The current calculated from the Kohn-Sham (KS) orbitals of SDFT is that of the auxiliary noninteracting system, and not guaranteed by the basic theorem s of SDFT to be the correct current. The full physical (gauge invariant) current is $j(r) = j_b(r) + (e=m c)n(r)A(r)$, where A (r) is the vector potential and $j_b(r)$ is the so-called param agnetic current. The param agnetic current calculated from the KS orbitals of SDFT is

Current-density functional theory (CDFT) [4,5] provides a way to calculate the true equilibrium currents by obtaining the orbitals from a modi ed KS equation

that features an xc vector potential A $_{\rm xc}$ (r), chosen such that in terms of these orbitals the above inequality becomes an equality. To achieve this, approximate xc functionals of CDFT m ust depend on the current density, in addition to the charge and spin densities. This dependence is a complicating factor both in the construction of approximate functionals and in their implementation. In spite of these complications, di erent ways of constructing CDFT functionals and solving the CDFT KS equations have been explored for atom s, m olecules and solids [4, 5, 6, 7, 8, 9, 10, 11]. As an alternative to solving the full CDFT equations, usable when current-dependent e ects are expected to be small, it has been proposed to cast the CDFT KS equations in the form of SDFT KS equations plus a remainder depending on the xc vector potential A $_{\rm xc}$ (r), which is then treated perturbatively [12].

An unexpected feature of CDFT is that, although SDFT and CDFT are independent formulations of DFT for magnetic systems, there is a, somewhat obscure, link between CDFT and SDFT, which may be used to extract information on functionals of one from the other. In Ref. [13] this link is obtained mathematically, but its physical origin is simple to understand: the existence of spin currents of the form $j_s = r m$, where m is the spin magnetization, im – plies a connection between the form alism sofSDFT and CDFT, because being a manifestation of the spin degrees of freedom these currents must be describable via SDFT, while as currents they can also be built into the form al fram ework ofCDFT. Some consequences of the resulting connections and consistency relations between SDFT and CDFT are explored in [13]. Form ore details on CDFT we refer to Refs. [4, 5, 6, 7, 8, 9, 10, 11, 12, 13].

2.2 Noncollinear magnetism

The standard spin-up spin-down form ulation of SD FT is incapable of describing spin con gurations that are eigenstates of the square of the total spin operator \hat{S}^2 , but not its z component, \hat{S}_z . Such noncollinear con gurations can arise, e.g., in the presence of spin-orbit coupling, dom ain walls, external noncollinear elds, or from spontaneous symmetry breaking. Noncollinear ground states are found, e.g., in rare-earth based magnetic system s. In magnetic excitations, noncollinearity is ubiquitious. Consequently, noncollinear form ulations both of static [14, 15, 16] and tim e-dependent [17] D FT have been proposed, but applications are limited to the local-spin-density approximation (LSDA). In trying to describe noncollinear spin states with generalized-gradient approximations (G G A s) or other beyond-LSDA functionals an interesting problem arises.

Due to its origin in the electron liquid, the exchange-correlation energy in the LSDA depends only on the modulus of the spin magnetization m (r). The corresponding conjugate eld, the xc magnetic eld

is then always parallel to m. Beyond the LSDA, however, the xc m agnetic eld ceases to be parallel to the spin m agnetization. M athem atically this oc-

curs because the existence of spatial derivatives of any component of m in the functional leads to additional terms in the derivative that are not parallel to m [18, 19]. Intuitively this can be understood because the existence of spatial gradients of the spin density introduces another preferred direction into the problem. In general, the xcm agnetic eld can thus be decomposed as

where the second contribution is locally perpendicular to the spin m agnetization m (r). This perpendicular xcm agnetic eld exerts an xc torque / m (r) $B_{\rm xc}$ (r) on the spin distribution. In the time-dependent case some consequences of this torque were described in [18], but it is present even in the ground state as soon as noncollinearity appears and is treated beyond the LSDA. This subtle e ect is little explored in present-day SDFT.

Standard in plem entations of noncollinear SDFT assume parallelity between $B_{\rm xc}$ and m (r), and can thus not be used consistently with GGA type functionals. W hat the best way is to treat noncollinearity beyond LSDA is an open question at present. As an alternative to form ulations in terms of the spin m agnetization, it has been proposed, e.g., to employ the spin-o diagonal element of the density matrix (the so called 'staggered density' [20]), but this requires the construction of functionals of this new variable, and the solution of more complicated KS equations [21].

2.3 Nonuniqueness

At rst sight m one rem ote from num erical applications are fundam ental issues of SD FT, such as the recently discussed question of nonuniqueness of the SD FT potentials. The question to what extent the elective potentials of SD FT (and other generalized D FT s) are uniquely determ ined by the densities arises because contrary to what is sometimes claimed in the literature, the standard proofs of the H ohenberg K ohn theorem (by contradiction [22] and by constrained search [23]) guarantee only the existence of a one-on-one mapping between densities and wave functions, not densities and potentials. The extension of the mapping to potentials requires, as an additional step, inversion of Schrödinger's equation to express the potential in terms of the universal operators \hat{T} and \hat{U} and the wave function [23, 24]. For charge-only DFT one has simply

which shows that the ground-state wave function $_0$ (which is known to be a functional of the density) determ ines the potential V uniquely up to an additive constant (here the ground-state energy, E_0). Since one always has an additive constant free in the de nition of a potential, this shows that the physically relevant part of \hat{V} , in particular its variation in space, is fully determined by $_0$ and hence by n (r). A lready in the early literature on noncollinear SDFT it was pointed out that this inversion is problem atic if one works with 2-component

spinors and has four potential components $(v; B_x; B_y; B_z)$ to determ ine. Von Barth and Hedin gave an explicit example of the resulting nonuniqueness of the SDFT e ective potentials, albeit one that only works for a single electron [25].

Recently, examples have been given that show that nonuniqueness is not a pathological feature of single-electron system s, or limited to SDFT, but a general phenom enon, expected to occur whenever one works with more than one density variable [26, 27]. In Ref. [27] it was shown how a large class of nonunique potentials is related to the existence of certain types of constants of motion (system atic nonuniqueness) while others arise from special features of the ground state (accidental nonuniqueness). A few simple examples from collinear SDFT were given, illustrating the main features of both types of nonuniqueness. The sim plicity of these examples notwithstanding, their existence shows that there cannot be a unique m apping between densities and potentials in generalized DFTs, in addition to the one between densities and wave functions. M ore complex examples of nonuniqueness were found to be possible in noncollinear situations [26, 28], on lattices [29] or in CDFT [30]. The implications of nonuniqueness for practicalSDFT calculations are still under study [26, 28, 29, 31, 32]. One conclusion that has emerged from this body of work is that the additional mapping between density and potentialm ust be regarded as a special feature of spin unpolarized (charge-only) DFT. Surprisingly, the HK theorem of unpolarized (charge-only) DFT is thus considerably stronger than its counterparts in, e.g., SDFT and CDFT.

3 Spin density-functional theory for the H eisenberg m odel

Open problems, such as the best way to deal with currents, noncollinearity and nonuniqueness, provide fascinating challenges, but they have never stoped DFT from advancing on the practical side. In a typical application of DFT one deals with the ab initio many-electron H am iltonian comprising kinetic, potential, and (Coulomb) interaction term s. By means of the Hohenberg-Kohn (HK) theorem and the Kohn-Sham construction this many-body problem is mapped on an auxiliary noninteracting one. The search for good approxim ations for the exchange-correlation potential appearing in the auxiliary KS Ham iltonian is one of the most active elds of DFT. However, the HK and KS techniques are not restricted to the ab initio Ham iltonian. We can simply regard them as e cient tools form apping som em any-body problem on a simple one-body problem . In m any areas of science, m ost notably perhaps in statistical physics and m any-body physics, but occasionally also in quantum chem istry, the fundam ental Ham iltonian is replaced by a simpler model Ham iltonian before embarking on any num erical calculation. The list of such simplied Ham iltonians is long, and comprises important models such as those of Ising, Heisenberg and Hubbard. This section is devoted to a description of a recent reform ulation and application of SDFT to model H am iltonians of the H eisenberg type [33, 34].

3.1 The Heisenberg model

Introduced in 1928 by D irac and H eisenberg [35, 36] and discussed in som e detail as a model for ferrom agnetic solids in 1932 by van V leck [37], the H eisenberg model is the paradigmatic model for the magnetism of local magnetic moments S_i . In quantum chemistry it has, e.g., been used in the description of the magnetic properties and spin states of conjugated hydrocarbons [38, 39] and a large variety of metallic and organom etallic compounds [40, 41, 42, 43].

In its sim plest form the Heisenberg model reads

where the \hat{S}_i are angularmomentum vector operators satisfying $\hat{S}^2 \not \exists m i = h^2 S (S + 1) \not \exists m i$. In accordance with common term inology we refer to the expectation values of \hat{S}_i , the magnetic moments S_i , as spins, although they may also have an orbital contribution. The sum s run over nearest neighbours among the N sites of a lattice of, in principle, arbitrary geometry, and J parametrizes the nearest-neighbor interactions. We see qualitatively that a parallel (ferromagnetic) or antiparallel (antiferrom agnetic) alignment of S_i and S_j is favored according to whether J is negative or positive.

In the presence of an external magnetic eld B $_{i}$ the model takes the form

If B_i and S_i = $h\hat{S}_i$ i are the sam e everywhere, the model is hom ogeneous, i.e., all its sites are equivalent. In all other cases it is inhom ogeneous. Note that even for B_i = 0 (no external ed) inhom ogeneous states are possible. Such solutions may arise because the self-consistent many-body ground state need not preserve all sym metries of the H am iltonian, or because the H am iltonian itself comprises inequivalent lattice sites. The latter is the case, e.g., in system s with impurities, or, more generally, with of di erent types of magnetic atom s.

In spite of its form al sim plicity, exact analytical results for the H eisenberg m odel are known only for hom ogeneous linear chains with S = 1=2, by m eans of the B ethe ansatz [44, 45]. For higher spin, higher dim ension, or inhom ogeneous situations, exact solutions are known only num erically, for sm all system s (less than 40 sites), where the m odel can be diagonalized exactly by Lanczos techniques. In the presence of inhom ogeneities, such as one substitutional spin of value $S^0 \notin S$, no analytical solution is known.

The simplest approximation to the H am iltonian (5) is the mean-eld (H artreelike) approximation, in which the vector operators \hat{S} are substituted by classical vector spins S. The mean-eld ground-state energy per spin, in units of J, is thus easily obtained for a hom ogeneous in nite system of spins S in d dimensions (with periodic boundary conditions):

where d is the dimensionality of the linear (d = 1), square (d = 2) or cubic (d = 3) lattice. O ther lattice geometries can be dealt with in the same way. An improvement on the mean-eld estimate for e_0 (S;d) is obtained from spin-wave theory [46], according to which

Here we used the scaling hypothesis conjectured in Ref. [33], which accounts for the numerical spin-wave results to three decimal places, to write the results in di erent dimensionalities in closed form, as a function of d. Beyond spin-wave theory, sophisticated numerical many-body techniques, such as the density-matrix renormalization group (DMRG) [47] or Quantum Monte Carlo simulations [48], have been employed to further improve the ground-state energy.

The resulting expressions for E_0 , however, su er from a major limitation, namely, they are applicable only to hom ogeneous systems, in which all lattice sites are equivalent. This limitation is restrictive, because in real problems it is very common to nd inhom ogeneities, induced for instance by external non-uniform magnetic elds, anisotropic crystal-elds, nite-size e ects, boundary conditions, local impurities, lattice defects, etc. These rather common situations introduce very signi cant di culties in traditional approaches like Bethe ansatz, DMRG, spin-wave theory or even M onte Carlo, by breaking translational symmetry. In order to make progress in dealing with inhom ogeneous H eisenberg m odels we need a many-body technique capable of handling spatial inhom ogeneity in large systems. Density-functional theory is our rst choice in this regard.

3.2 Spin-distribution functionals and local-spin approximation

Density-functional theory [1, 24] o ers, with the local-density approximation (LDA), a simple prescription for obtaining ground-state properties of an inhomogeneous system, based on the knowledge of a related homogeneous system. While in ab initio applications of DFT this homogeneous system is the electron liquid, in our context it is the homogeneous H eisenberg model, in which all sites are equivalent.

Ref. [33] show sthat the basic ingredients of DFT (in particular the H ohenberg-K ohn theorem [22]) still hold for H am iltonians of the form (6), provided one uses instead of the ground-state density n (r) the ground-state expectation value of the spin vectors, $S_i = h \ \beta_i \ j$ i. The H eisenberg-m odel H ohenberg-K ohn theorem then states that the ground-state expectation value of any observable \hat{O} is a functional of the distribution S_i , i.e., $O[S_i] = h \ [S_i] \hat{D} \ j \ [S_i] i$. In this H eisenberg-m odel DFT the above m ean-eld expressions take the place of the H artree term in C oulom b DFT, and the correlation energy $e_c(S)$ is de ned as the di erence $e_0(S) = e_0^{M-F}(S)$, where $e_0(S)$ is the full ground-state energy. From

the above, the spin-wave approximation for $e_{\rm c}~(\!S\,)$ is thus

The H eisenberg-m odel H ohenberg-K ohn theorem , proved in [33], guarantees that in inhom ogeneous systems the total energy is a functional of the spatial distribution of the classical vectors S_i . Hence

Since the mean-eld term is already a functional of S_i , we just need an approximation for the functional $E_c[S_i]$. This is obtained using a local-spin approximation (LSA), patterned after the conventional LDA of C oulom b DFT. The LSA consists in replacing locally the variable S by S_i in $e_c(S)$:

U sing the above spin-wave approximation for e_c (S) we obtain, e.g.,

$$E_{c}^{LSA SW} [S_{i};d;J] = d^{1=5}J - \frac{2}{-} 1 \frac{X^{N}}{5}_{i}j; \qquad (12)$$

and thus the ground-state energy functional in this approximation is

$$E_{0}^{LSA SW} [S_{i};d;J] = J S_{i} S_{i} S_{i} + d^{1=5} J - 1 J_{i}^{2} S_{i}^{j};$$

M ore sophisticated expressions, based on fully numerical evaluation of e_0 (S) are also available [33], but in rst applications the simple approximation (13) turned out to be already reasonably accurate [34].

As always in dealing with LDA-type functionals one must distinguish two sources of error. One is the LDA itself, the other the quality of the description of the underlying hom ogeneous reference system. In C oulom b DFT several alternative param etrizations of the LDA are available [25, 49], which di er considerably in form, and slightly in results. In the present context, too, one can construct various LSA functionals, depending on the level of sophistication employed in solving the uniform H eisenberg model. For example, for an in nite linear chain of spin S = 1=2 we have from the above spin-wave based LSA $e_0 = (JN) = 0.25 \quad 0.181690 = 0.431690$, which is 2.6% from the exact B ethe ansatz value 0.443147. Interestingly, we nd this sam em argin of deviation also when the LSA is used for inhom ogeneous situations (see below). This seem s to indicate that the LSA concept as such is quite reliable for H eisenberg m odels.

From the above, it should have become clear that the form alism of DFT for the Heisenberg model is built in complete parallelity to that of Coulomb DFT

(or that for the Hubbard model [50]). One interesting di erence is that within spin-wave theory the dimension dependence of the functional is approximately known. This is very di erent from the ab initio case, in which nothing is known about this dependence. In general, how ever, one may expect that LSA for the Heisenberg model shares the virtues and defects of its close cousin, the LDA for the Coulom b problem : e cient access to large and inhom ogeneous system s on one side, o set by moderate accuracy on the other. In the next subsection we demonstrate these aspects by analysing two interesting inhom ogeneous models within LSA. (O ther applications of the above functionals can be found in Ref. [34].)

3.3 Applications to inhom ogeneous Heisenberg models: boundaries and impurities

The usualDFT prescription for obtaining ground-state energies is to solve K ohn-Sham equations. These equations, however, were originally [2] introduced to deal with the kinetic-energy term in the C oulomb H am iltonian. The H eisenberg model does not have such a term, and direct m inimization of the energy functional is much simpler than indirect m inimization via self-consistency (K ohn-Sham) equations. In practice we just need to minimize the total energy of the system, written as a functional of the spin distribution, with respect to S_i . This already represents a considerable improvement over the mean-eld approximation with no extra computational cost; minimization of E_0^{LSA-SW} [S_i] is no more complicated than that of E_0^{M-F} [S_i].




Figure 1: Per-site ground-state energy of a ring of N = 16 spin S = 1=2 sites as a function of the impurity spin S_I. The LSA results, based on spin-wave theory, (dashed line) deviate from the exact ones (circles) by about 3%. The mean eld approximation (continuous line) deviates by up to 50%. The inset illustrates the geometry under study, for the case of N = 10.

Lets rst consider a nite ring of N = 16 spins S = 1=2, with periodic boundary conditions. The mean eld approximation yields $e_0 = 0.25$, while the LSA SW approximation gives $e_0 = 0.43169$, about 3% from the exact value 0:44639 obtained by direct diagonalization. Let us now replace any spin of the ring by an impurity spin S_I. This slight modi cation is enought to challenge any analytical approach, but since the ring is not too big, it is still possible to num erically diagonalize \hat{H} in order to get the exact ground state. Figure 1 show show the ground-state energy depends on SI, and com pares the values obtained by mean-eld and LSA-SW calculations with the num erically exact ones. Up to $S_I = 2.5$ the deviation from the exact values are of order 3%. Above this value the deviation increases, showing that the LSA approximation is not good for large in purity spin (corresponding to a very rapid variation of local m agnetic properties). For impurity spins up to $S_T = 5=2$, on the other hand, LSA-SW is seen to provide a substantial in provement on the mean-eld approximation. Unlike the exact calculations, LSA-SW can easily be extended to system s with m ore impurities and m ore sites. It m ay thus provide a convenient way of estimating (and improving on) the error of the mean-eld approximation in more complicated systems.

Next we consider 4 4 square lattices with an impurity of spin S_I at the corner, at one side, or in the interior of the lattice. Here we use open boundary condition and thus even without impurity the system s are inhom ogeneous. Results are collected in Tab. 1. The rst column is for $S_I = 1=2$, i.e., for the uniform

system, and the value listed di ers 6:6% from the exact value $e_0 = 0.574325$ obtained from numerical diagonalization; we believe the values for other in purity spins are within this accuracy, although no exact values are available, as far as we know. Besides the obvious energetic tendency of higher in purity-spin to prefer the interior of the lattice to its surface, which is already visible in the mean-eld results, these data also incorporate less trivial correlation e ects: In m ean-eld theory, for exam ple, a spin 3/2 at the corner of the square is degenerate with a spin 1 in the interior of the lattice ($e_0^{M-F} = 0.4375$ in both cases). This degeneracy between a spin 5/2 at one side and a spin 2 in the interior ($e_0^{M-F} = 0.5625$ for both cases). A gain this degeneracy is rem oved by including correlations.

4 Summary

K ohn-Sham spin-density functional theory is doubtlessly the most widely used form ulation of density-functional theory. However, in spite of its great popularity and usefulness some interesting fundam ental questions still remain open. The existence of spin currents, providing a link between SDFT and CDFT; the existence of an exchange-correlation torque appearing in noncollinear spin con gurations; and the nonuniqueness of the potentials of SDFT and other generalized DFTs are examples of the kind of surprise the SDFT form alism still holds.

Such open questions notwithstanding, the utility of (S)DFT is extending even into areas remote from ab initio calculations. Recognition that the basic tools and concepts of DFT | such as the Hohenberg-Kohn theorem, and the local-density approximation are not restricted to the original C oulom b problem allows one to apply these tools and concepts also to many other interesting inhom ogeneous model Ham iltonians. In particular, density-functional theory together with results from mean-eld and spin-wave theory provide a simple manner to obtain estimates of the ground-state energy for spin distributions described by the inhom openeous Heisenberg model. This is here illustrated by results for a nite ring and a 4 4 lattice, both with substitutional impurity spins $S_I = 1;3=2;2$ or 5/2. W hile ring calculations may nd applications in m odelling the spin states of hydrocarbons, the square-lattice data illustrate a way in which LSA can be useful in nanom agnetism : To predict the structure of self-assembled magnetic nanostructures it is clearly important to know which lattice sites are degenerate in m ean-eld theory, and which of these degeneracies are rem oved by correlations.
