Bosonization solution of the Falicov-K im ball model

Abstract

We use a novel approach to analyze the one-dimensional spinless Falicov-K imball model. We derive a simple elective model for the occupation of the localized orbitals which clearly reveals the origin of the known ordering. Our study is extended to a quantum model with hybridization between the localized and itinerant states: we not a crossover between the well-known weak-and strong-coupling behaviour. The existence of electronic polarons at intermediate coupling is con rmed. A phase diagram is presented and discussed in detail.

The Falicov-K imball model (FKM) is one of the simplest yet most versatile models of strongly correlated electron systems. It describes a band of conduction (c-) electrons interacting via a repulsive contact potential G with localized f-electrons of energy f. O riginally conceived of as a model for valence transitions (VTs) [1], the FKM is today usually regarded as a simple model of a binary alloy, the so-called crystallization problem (CP) [2]. The CP assumes xed c- and f-electron populations, examining the diagonal LRO (or \crystalline order") adopted by the f-electrons in the ground state. In spite of detailed numerical maps of the one-dimensional (ID) FKM 's phase diagram [3], its behaviour is only rigorously understood at weak-[4] and strong-coupling [5].

A c-f hybridization term is usually added to the FKM in order to model mixed-valence systems [6]. The presence of quantum valence uctuations makes this a fundamentally dierent problem to the FKM: it is referred to as the extended or quantum Falicov-K imball Model (QFKM). In contrast to the FKM, the QFKM's behaviour remains largely unknown. A lithough there is no consensus on the nature of the ground state [7,8], excitonic elects are expected to dominate the physics and so this remains an important open question in the theory of optical properties of strongly correlated electron systems.

U sing the well-known non-perturbative technique of bosonization, we obtain for the rst time a complete theoretical description of the 1D FKM below half-lling. This analysis reveals the role of the c-electrons in generating the observed f-electron order; all aspects of the CP results are naturally explained within our approach. We derive an elective Hamiltonian for the f-orbital occupancy which accurately predicts the FKM 's phase diagram. For a small hybridization potential our approach is also suitable for the QFKM. We present a phase diagram that interpolates between the well-known weak- and strong-coupling limits; our work rigorously establishes the relevance of electronic polaron elects.

The FKM for spinless ferm ions has the Hamiltonian

We consider only repulsive potentials, G > 0. The concentration of electrons is xed at $n=\frac{1}{N}^P_jfn_j^f+n_j^cg<1 \text{ where }N \text{ is the number of sites. In our study of the QFKM, we adopt the standard on-site hybridization potential H _hyb}=V^P_jff_j^yc_j+H _cg.$

Proceeding with our bosonization solution, we linearize the c-electron spectrum about the two Ferm i points and de ne left- and right-moving Ferm ion elds c_{j} , = L(), R(+)

respectively as subscript (otherwise). The chiral density operators $(k) = \sum_{k=0}^{P} c_{k+1}^{y} c_{k+1}^{y}$ obey the standard Luttinger commutators [(k); $\circ (k^0)$] = $, \circ k, k^0$ kL=2 for a system a, the lattice constant. The dual Bose elds are constructed in terms of the of size L (k) [9]:

(k) appearing in Eq. (2) and Eq. (3) satis es the conditions The cut-o function for kj < - and (k) 0 otherwise. (k) enforces the niteminimum wavelength > a of the bosonic density uctuations (k): taking into account this wavelength lim it is essential for preserving the lattice structure of the FKM [10]. Since the Bose elds cannot 'resolve' distances less than , we nd that the usual eld com m utators are 'sm eared' over this length scale:

Here sgn (x) and (x) are the -smeared sign and Dirac delta functions respectively [11]. The chiral Ferm ions are represented in terms of the Bose elds by the Mandelstram identity $c_j = Aa = \hat{F} \exp(i [(x_j)])$. The dim ensionless normalization constant A is dependent upon the form of (k); the K lein factors \hat{F} are \ladder operators" between subspaces of di ering c-electron number. The bosonic form of the number operators is given by

The rst term on the RHS, n_0^c , is the non-interacting c-electron concentration; the second term is the forward-scattering density uctuation; the third term is the rst order backscattering correction. Higher order corrections are usually neglected.

Our bosonization analysis requires that $n_0^c \in 0$. For the sake of brevity, here we assum e the symmetric case with equal c- and f-populations in the non-interacting limit, ie. $n_0^c = n_0^f = \frac{1}{2}n$. For the VT problem, this pins the Fermi level at $f = n_0^c$ $k_{\rm F}$ = n=2a is the Fermim omentum (note that $_{\rm f}$ is irrelevant to the CP). Using the electron concentration condition we also re-write the Coulomb interaction up to a constant: $G^{P}_{j}n_{j}^{c}n_{j}^{f}=G^{P}_{j}n_{j}^{c}$ n_{j}^{f} $\frac{1}{2}$ $\frac{1}{2}G^{P}_{j}n_{j}^{f}$. It is now a simple matter to obtain the bosonized form of the Hamiltonian by substituting these identities into Eq. (1).

We apply a shift transformation on the c-electron bosonic elds $\hat{U} = \exp^n i \frac{Ga}{v_F}^p (n_j^f = \frac{1}{2}) (x_j)^p$ where $v_F = 2ta\sin(k_Fa)$ is the c-electron Fermi velocity. This transformation rotates the basis of the Hilbert space so that the c-electrons are explicitly coupled to the f-orbitals. Introducing a pseudospin- $\frac{1}{2}$ representation for the f-electron occupation at site j, $n_j^f = \frac{1}{2} = \frac{z}{j}$, we write the transformed Hamiltonian

S (x_j) is a measure of the short-range behaviour of the pseudospins, subtracting the z within to the left of x_j from the z within to the right; L (x_j) probes the long-range behaviour, subtracting the z m one than to the left of z from the z m one than to the right [12]. Note that we retain all terms produced by the canonical transform in Eq. (7).

The rem ovalof the forward-scattering Coulomb interaction introduces the important new term

The physical origin of this interaction is the delocalization of the c-electrons below scales less than > a. A c-electron spread over more than a single lattice site carries the same charge over these sites: due to the C oulom b interaction G, this will favour empty underlying f-orbitals. Although such \segregation" is known to occur in the CP [3, 5], the derivation of the responsible elective interaction is a new achievement in the history of the model. The -smeared -function in Eq. (8) makes it clear that the interaction is short-ranged; we may therefore approximate the interaction as nearest-neighbour only, H int $J^P_{j=j=j+1}$, $J^P_{j=j+1}$,

The other terms in Eq. (7) involving the pseudospins are a constant and a site-dependent longitudinal eld. The former is important only in the VT: together with the rst term in Eq. (7) this determines the distribution of the total electron population across the two

orbitals. The site-dependent eld arises from the $2k_F$ -backscattering of the c-electrons o the f-orbitals. This is responsible for the observed LRO phases, in close analogy to the Peierls state [4]. It is clear from Eq. (7) that the LRO dom inates the segregation at weak-coupling G $\,$ t; increasing G , however, Eq. (8) eventually causes the system to segregate (the SEG phase).

The competition between the SEG and LRO phases can be simply studied within the fram ework of our bosonization approach: since the only coupling in Eq. (7) between the Bose elds and the -pseudospins is in the backscattering term, by replacing with a suitably chosen expectation value we obtain an elective Hamiltonian H_e for the f-occupation only. Exact diagonalization calculations on 3200-site chains reveals that within the SEG phase the c-electrons are at their Luttinger liquid xed point for all G [13]. The choice h $(x_j)i=0$ is therefore valid across the phase diagram [10]. Substituting this into Eq. (7), we not

Below we present a detailed analysis of H_e.

Since the c- and f-populations are xed in the CP, Eq. (9) by itself fully describes the system close to the SEG-LRO boundary. To determ ine this line the site-dependence of the longitudinal eld must be known; in particular, we exam ine S (x_j) and L (x_j) . W ithin the SEG phase, the f-electrons are arranged into a single block [5]. The magnitude of L (x_j) reaches a maximum at the edge of this block, increasingly linearly as the edge is approached from either side. In contrast, S (x_j) vanishes everywhere except in the vicinity of this edge. The longitudinal eld thus has the general form $h_j^z / \cos(!j+)$, ! and constants.




FIG. 1: Ground-state phase diagram for the symmetric FKM below half-lling for the CP (dashed line) and VT problem (solid line). The numerical data points (circles for VT, plus sign for CP) are due to Gajek et al. [3]. Inset: the phase diagram for the QFKM. Phases are as described in text.

The periodicity (!) of h_j^z determ ines the critical Ising coupling [14]: for G — twe nd the critical line $G_c a = v_F$ $\frac{1}{2}$ $A = -\frac{1}{2}$ (a). The f-electron con guration acts as an applied scattering potential $G_c h_j^z i$ for the c-electrons [13]. Below the average interparticle separation k_F^{-1} the c-electrons scatter independently: for $G_c h_z^z i$ (x) = $G_c h_z^z i$ (x) in the continuum limit (m is the bare electron mass). From elementary quantum mechanics we not plane wave solutions over unoccupied orbitals ($h_z^z i = -\frac{1}{2}$) and exponentially decaying solutions with

characteristic length / t=G over occupied orbitals (h $_x^z i = \frac{1}{2}$) [15]. clearly corresponds to in the boson theory; for small G_c Taylor-expanding (a) in the critical line equation gives $G_c a=v_F = \frac{p}{2^2 A}$ (1 + $a^2=2^2+\dots$), implying a linear relationship between $G_c a=v_F$ and G_c . This is con rmed by exam ining the numerical data of $G_c a=v_F$ giving $A_c = 1=32^2$, $A_c = a=2^p \frac{p}{G_c}$, and a critical line $G_c = t=0.5 \sin{(n-2)} = (1-\sin{(n-2)})$ as plotted in Fig. (1). This is the rst analytic expression for the SEG-LRO boundary valid at weak coupling.

M oving on to the VT problem, it is clear from Eq. (7) that the Coulomb interaction will shift the f-level downwards, emptying the c-band. The depletion of the c-electron population causes segregation to occur at a smaller value of G than in the CP; the new boundary can be calculated self-consistently from the available numerical results [3]. Using the same curve—thing technique as for the CP, we not excellent agreement with the data for $G_c = t = 0.35 \sin{(n - 2)} = [1 \sin{(n - 2)}]$ (A $1.55 + 10^3$, $0.418a = \frac{p}{G_c}$), see Fig. (1). Further increasing G above the critical value $G = t = 4(1 \cos{(n - 2)}) = (1 - n)$ the f-level lies below the c-electron band edge and so all electrons have f-character. The absence of c-electrons to mediate the segregating interaction in plies that here any f-con guration is the ground state.

We extend our analysis to the physically interesting $\lim it V = t$ of the QFKM. Bosonizing and carrying out the canonical transform, the hybridization adds the term

to the e ective pseudospin H am iltonian Eq. (9). We have used a generalized Jordan-W igner transform ation to combine the f-electron operators and the K lein factors into pseudospins $_{j}^{+} = f_{j}^{y} \hat{F} e^{i x_{j}=2a} \exp i \frac{i}{2} \int_{0}^{p} sgn(x_{j}^{0} x_{j}) n_{j0}^{f} \frac{1}{2}$. The resulting e ective pseudospin H am iltonian is easily recognized as the Ising model in site-dependent longitudinal (h_{j}^{z}) and transverse (h_{j}^{x}) elds.

Although we are not aware of any system atic study of this Ham iltonian, we can nevertheless deduce important aspects of its physical behaviour. The two extreme limits G t and G t are easiest to discuss. In the former case the presence of V G does not radically modify the VT physics. Where the longitudinal eld dominates, we can discard the Ising interaction so that the pseudospins track the longitudinal and transverse elds; clearly the transverse eld will only be important where the longitudinal eld is small. This will

\sm ear" the crystalline arrangement, but leaves the basic picture of a density wave intact.

Where the Ising interaction dominates, the hybridization will stabilize the SEG phase as quantum uctuations maintain a non-zero c-electron population.

For G the quantum uctuations produced by the hybridization dominate, fundamentally altering the behaviour of the system. Discarding the Ising interaction which is irrelevant form ost of this regime, we arrive at the same trivial model of pseudospins tracking longitudinal and transverse elds as in the G term that the pseudospins will be mostly ordered along the x-axis with $h_j^x i = \frac{1}{2} \mathrm{sgn}(h_j^x)$. In terms of the f-occupation, this implies that $hf_j^y c_j i \in 0$, with intermediate occupation of each f-orbital $0 < hh_j^f i = \frac{1}{2} \mathrm{n}$. The longitudinal eld produces only small deviations from this homogeneous distribution of electron density. This is clearly a mixed-valence state (MVS).

Our pseudospin model allows us to connect these two extreme limits for the rst time: for V=0.05t we present the QFKM's phase diagram as the inset in Fig. (1). Close to half-lling the Ising interaction is never dominant so the model of -pseudospins tracking the longitudinal and transverse elds is valid for any G. In Fig. (1) we do not an MVS-LRO boundary by equating the magnitude of the transverse and longitudinal elds. For small n, however, the longitudinal eld is negligible; discarding this term from H_e we not a transverse eld Ising model (TFIM) describes the f-orbital occupation. Although the TFIM has an order-disorder transition [16], the shifting of the f-level lifts the system from criticality and so there is a crossover regime (CR) between the SEG and MVS phases.

The details of the CR physics are controlled by the site-dependence of the transverse eld Eq. (10). Near the SEG phase we can use the same values for S (x_j) and L (x_j) as in the CP analysis; for M V S behaviour both these objects vanish. We thus assume a periodic transverse eld within the CR. In general, the periodicity is incommensurate with the lattice: numerical studies [17] reveal this to be qualitatively identical to a random variation of the transverse eld. The random TFIM has been studied in depth by Fisher [18] using a real-space renormalization group treatment. Lowering G from the SEG phase, the CR is reached at $J_{cl} = m \text{ ax } h_j^x j$; for $J < J_{cl}$ the Ising coupling is not greater than the magnitude of the transverse eld everywhere on the lattice. The rare regions where $h_j^x j > J$ breaks the SEG ground state up into random by distributed large clusters of zero and full f-occupancy. The system nevertheless retains the character of the SEG phase so long as $J > J_{c2} = h_j^x j$ the average value of $h_j^x j$ across the lattice. This is rejected by the mean f from formulations $h_j^x h_{j+x}^x i$ which decay exponentially to $(h_j^x)^2 > (h_j^x)^2$ with correlation length expf $2[\ln (J_z - J_z)]^2 g$.

Decreasing J below J_{c2} , the character of the CR reverses, as here $J < h_j^x j$ over most of the lattice. Of the SEG state, only rare clusters remain, embedded in a valence—uctuating background. This MVS—like region of the CR is characterized by a dierent functional form for the correlation length $[\ln(J_2=J)]^2$; the correlation functions decay exponentially to $(h_0^f)^2$. The CR persists until J becomes comparable to the longitudinal eld in Eq. (9): the system is then best described by the small-G MVS. The distinguishing feature of the CR are the random by distributed clusters of integral f-valence. These clusters occur where the local c-electron density departs from the MVS average, determ ining the occupation of the underlying f-orbitals via the forward-scattering Coulomb interaction [i.e. Eq. (8)]. This coupling of the c- and f-electron densities is recognizable as a Toyozawa electronic polaron [19]. Electronic polarons in the QFKM were studied by Liu, who proposed that they appear intermediate between mixed- and integral-valence phases [7]. Since bosonization treats the forward-scattering exactly [9], our calculation rigorously con rms Liu's scenario.

In sum mary, we have presented the results of a novel theoretical study of the 1D FKM. Using a non-perturbative approach, we have uncovered the physical mechanisms responsible for the known f-electron ordering. We derive an electron.
