# Universal aspects of non-equilibrium currents in a quantum dot

W e study the electric current in the non-equilibrium K ondo m odel at zero m agnetic eld, using realtim e perturbation theory in the Schwinger-Keldysh form ulation. We show that the perturbative coe cients to all orders have a nite limit at large switch-on time (t  $_{0}$  ! 1), and we give a prescription for general operators to give nite coe cients in this limit. We explain how this is related to the fact that the leads play the role of them al baths and allow relaxation to occur and the steady state to form . This proves perturbatively that a steady state is reached in the Schwinger-K eldysh form ulation, and speci es which operators correspond to quantities that have a well-de ned value in the steady state. Then, we show that the steady state can be described by a special type of density matrix (related to Hersh eld's conjecture for the particular example of the non-equilibrium Kondo model.) In the second part of the paper we perform a renorm alization-group analysis of the perturbative series. We give a general argum ent that strongly suggests that the perturbative series of any average in the steady state satis es the equilibrium Callan-Sym anzik equations, and show in detail how it works to one-loop order for the electric current operator inside any average. We nally compute to two bops order the average of the electric current in the steady state, and perform a renorm alization-group improvement. From this, we give a universal prescription, valid in the perturbative regime, for comparing the elect of the electric current to that of the tem perature on the \K ondo cloud".

# I. INTRODUCTION AND DISCUSSION

The description of an out-of-equilibrium strongly correlated system is a long standing problem. Even in the simplest case where the system is in a steady state and its properties no longer change with time, the usual form alism of quantum statistical mechanics is inadequate. Theoretical understanding of such system s became all the more pressing with the recent spectacular progress in nanotechnology, which has made it possible to study the K ondo in purity, one of the best understood strongly correlated systems, in out-of-equilibrium conditions.

The K ondo impurity was realized experimentally as a quantum dot, a tiny island of electron liquid, attached via two tunnel junctions to leads (baths or reservoirs of electrons) held at dierent electric (or chemical) potentials. This set-up allows an electric current to ow across the dot, and measurements of the current were carried out as a function of the potential dierence V, the tem perature T and the magnetic eld B [1].

W hen the dot carries a net spin in the C oulom b blockade regime, it can be modeled by a K ondo H am iltonian with two channels = 1;2, corresponding to the two leads, to which the spin of the dot, S, couples [2]. The resonant tunneling through the dot (elastic co-tunneling) allows the electrons from each bath to jump on the dot and back to the same bath, leading to the form ation of K ondo resonance around the Ferm i level in each lead. Further, electrons from one bath can jump on the dot and onto the other bath, giving  $\circ$  -diagonal coupling" of the two channels to each other. W ith the matrix of couplings J;  $\circ$  and at zero magnetic eld, the H am iltonian is

Here a denotes the spin index a = 1=2, and S is in the spin-1/2 representation.

The process corresponding to o -diagonal coupling induces a current when the baths are held at nonzero potential di erence, V = 2 1. The development of the K ondo resonance as tem perature is low ered enables




FIG.1: (Coloronline) (A) The system . (B) The system unfolded.

the system to overcome the C oulom b blockade, producing a signicant increase of the conductance. The unitarity limit is reached as T ! 0; V ! 0.

A swe are interested in the universal properties of the system, we shall consider the model in the range T;V D, where D = D are the bandwidths of the leads, each lead being considered a very large conductor (the bandwidths can be assumed to be the same for both channels). We are allowed therefore to carry out the standard steps (linearizing around the Ferm i level, keeping only the s-wave component in the expansion of c<sub>iRia</sub> in spherical modes), to obtain a representation of each lead as a free electron gas on the half line consisting of left and right movers <sub>iL</sub> (x); <sub>iR</sub> (x); x 0, interacting with the impurity localized at x = 0. It will be convenient for us to \unfold" the baths, making left and right movers on the half line into right movers on the full line (de ning <sub>iR</sub> (x) = <sub>iL</sub> (x); x 0). See Figure 1.

The eld-theoretic Ham iltonian is then:

The coupling of the baths to the quantum dot is parametrized by the Hermitian matrix

where  $_d$  and are real (the factor is introduced for later convenience). It is possible to diagonalize the matrix of coupling J ;  $_0$  by a change of basis in the channel space. In the simple situation of a single level quantum dot, described by the Anderson model, coupled to identical leads one naturally nds the relation  $_d = .$  This makes the matrix of coupling constants degenerate, one of the eigenvalues being zero. A fiter diagonalizing it, the term s representing the interaction with S become that of a decoupled free ferm ion and a one-channel K ondo model. M ore generally, for  $_d \notin$ , diagonalizing the matrix of couplings gives the interaction term of the usual 2-channel K ondo m odel. O ut of equilibrium, for V  $\notin$  0, diagonalizing the matrix of couplings does not lead to

a simpli cation of the problem, since the out-of-equilibrium term  $V H_z$  induces extra coupling between the new ferm ion elds: it is not invariant under change of basis. We will not perform this diagonalization here, in order to keep the term  $V H_z$  simple. Also, we will consider the general case  $d \in C$ .

In this paper, we are interested in studying the electric current as function of voltage and temperature in the steady state of this model. As in the usual Schwinger-K eldysh formulation of a non-equilibrium steady state [15, 16], we will imagine coupling the dot to the leads at some time  $t_0$  in the past when the system is in a therm al equilibrium state, then allowing the system to evolve till t = 0 when the current is evaluated. One expects that after a transitory regime, as  $t_0 ! 1$ , the system will relax into a steady state with a constant current owing through the dot.

M any questions arise concerning this form ulation. Probably the most obvious one is: Is the model su cient to describe the establishment of a steady state current? Or does one have to contemplate additional relaxation mechanisms (certainly present in actual experiments) to absorb the continuous ow of energy of the electrons moving from the higher Ferm i-level lead to the lower one? In the framework of real-time perturbation theory, a related (but not equivalent) question that one can answer is whether or not the \infrared" lim it  $t_0$ ! 1 exists for the integrals representing the perturbative coe cients in an expansion in and d. We develop the real-time K eldysh perturbation theory (in some ways sim ilar to [3] and [17]), and use it to establish the convergence of every term of the perturbative series as the sw itch-on time  $t_0$  is sent to minus in nity.

This result is highly non-trivial. Real-time perturbation theory offen gives divergences as the switch-on time is sent to m inus in nity, unless a good relaxation phenom enon is included in the model. In equilibrium, this issue can be easily overcome: an infrared-divergent real-time perturbation theory for a system in equilibrium only m eans that the particularm odel we are considering does not have the proper relaxation mechanism. But with an additional interaction, how ever sm all, representing a proper relaxation mechanism, the system will have infrared convergent real-time perturbation theory. Then, for equilibrium models, this can be equivalently described by the always-infrared-convergent \in aginary time" perturbation theory (where the integrals in imaginary time are on a nite interval) coming from the description of the model using its equilibrium density matrix. There, the additional interaction representing relaxation can be sent to zero from the beginning.

Out of equilibrium, however, there is no a priori steady-state density matrix description of steady quantities. Thus, if the real-tim e perturbation theory is infrared divergent, there is no simple way to describe steady state physics. This is very natural: in contrast to the equilibrium case, the relaxation mechanism is used not only to reach the steady state, but also to form it, since we need a continuous absorption of energy. Hence, such infrared divergences are farm ore pathological. If the lim it of large negative switch-on tim e exists order by order, this super cially seems a good indication that the steady state is reached and that the model indeed describes the steady state (although, strictly speaking, one would still have to analyse the possible non-perturbative contributions if the perturbative series is asymptotic). But if no such limit exists, certainly more questions arise: does the model reach a steady state non-perturbatively (that is, divergences are an artifact of perturbation theory), or are other interactions necessary? These questions of course appeared in the literature before (see for instance [12, 13]). An interesting example is the case studied in [12], where it was shown that when the model we are discussing is put into a magnetic eld, the limit  $t_0$  ! 1 and ; d ! 0 do not commute, leading to divergencies in the perturbation theory as  $t_0$ ! 1 . A ssum ing that a steady state exists in the m odel, the correct result as  $t_0$  ! 1 should then be non-perturbative, and it was partially evaluated under this assumption (the \zeroth order" was evaluated), without external therm al reservoir coupled to the dot.

But the convergence of the perturbative series or the technical \way around" its divergencies as just described above do not guarantee that the results are describing the correct physical steady state. Indeed, if the model is believed to have a steady state, perturbatively or not, two questions should still be answered: Is there an element in the model playing the role of a good therm al reservoir to sustain the correct steady state in the model? And if not, is there a guarantee that a coupling to an external reservoir would not have an important e ect?

These last two questions have more bearing than it may seem. In the usual Schwinger-Keldysh formulation, one does not assume any exchange with a therm albath while the system is evolved: one starts with a therm all equilibrium state, then turns on the coupling to the dot and lets the system evolve without therm albath. This is certainly not the true physical situation; in fact, understanding how a therm al bath a ects the evolution of a quantum system was amongst the main points of the study of Caldeira and Leggett [4]. We carry out

the real-time perturbation theory both in equilibrium (that is, in the case V = 0; note that the real-time form alism includes a transitory non-equilibrium region where the system relaxes to equilibrium ) and out of equilibrium (V 6 0), and show that it is the same phenom enon that makes the perturbative series infrared convergent in equilibrium and out of equilibrium. This phenom enon is a factorization at large time separation of the correlation functions involved in the perturbative coe cients; interpreting the integrals over time de ning these coe cients in terms of physical processes, this signals a decoherence in time induced by the leads and suggests that the leads are good therm al baths. The convergent expression in equilibrium is indeed the right equilibrium density matrix, con ming that the leads them selves play the role of therm al baths for the dot degrees of freedom. The convergent expression out of equilibrium should then be \the right" steady state. Note that the factorization signaling decoherence in time occurs because the Ham iltonian for the leads is conformally invariant: indeed, in conform al eld theory, a large tim e separation is a large distance separation, which, by locality, gives rise to factorization. Physically, this occurs because the separation between the energy levels of the baths is much smaller than all other scales in the problem and essentially energy-independent (although, as will become clear from our investigation, these two conditions may not be su cient). Note that these ideas are not entirely new: in [5] the results of Caldeira and Leggett for constructing a therm al bath coupled to a quantum mechanical system were re-interpreted as coupling a bulk conformal eld theory in a disk to degrees of freedom on the boundary. Our results generalize this to the behavior of the impurity in the K ondo m odel. We are currently investigating how this can be further generalized (for example, what the general properties of the conform al eld theory should be).

O ur proof also allows us to describe the steady-state physics in terms of a \steady state density matrix," as conjectured by Hersh eld [6]. The essential di erence between the usual density matrix and the steady-state density matrix can be seen as a non-locality in the latter which captures the build-up of the steady state.

Note that a proof of convergence to all order was developed in [3] for a non-equilibrium free boson model with boundary interactions, but the arguments there were very model-dependent (and do not apply to the non-equilibrium K ondo model) and quite di erent from ours. In particular, our arguments have a much deeper physical meaning and scope, as explained above.

Let us stress here that it is quite important to know that no external bath is required for reaching a nonequilibrium steady state in an impurity model. Indeed, this means that we can use the real-time form alism without addition of a coupling to an external bath in order to 1) study the perturbative scaling properties of the model as we did in this paper for the K ondo model (see below), 2) construct more or less explicitly, without strong assumption, the steady state as an eigenstate of the H am iltonian, for instance using the the form alism of the \steady-state density matrix"; this eventually can give access to the infrared behavior of the model and to the integrability properties of the steady state (work in progress). The real-time form alism might not be the easiest way of trying to obtain this understanding, but it is probably the clearest, as it is the most closely related to the actual experimental situation.

O ther questions that need to be addressed in the study of this out-of-equilibrium steady state are: How will the K ondo e ect, the quenching of the impurity spin as the tem perature is low ered below the K ondo scale  $T_{K}$ , evolve in the presence of a current? Will new scales make their appearance? Which quantities are universal? To what extent the powerful ideas of the Renorm alization G roup (RG) apply there? M any interesting attempts were carried out, mainly perturbatively, to understand the ow of couplings as the cut-o (band width) D is reduced [7, 8, 9, 10, 11, 12, 14]. We shallpursue a dierent track and study a question related to the universality features of the model, namely: does a limit D ! 1 exist? In this limit all results are universal. We shall establish that such a limit exists by running the RG equations \backwards", referring to them in the eld theoretic context, in the usual way, as the Callan-Sym anzik equations. We shall deduce an out-of-equilibrium -function carrying out the calculation directly in the steady state and will show that it is the same as the equilibrium -function. This may not be too surprising since the singularity structure of the system usually does not depend on the state in which they are evaluated, so that the ground state and the highly excited steady state produce the same singularities. The nite parts of course are dierent. We show that only one scale arises, the Kondo tem perature,  $T_{K}$ , and the current can be written in a universal form as a function of the ratios  $T = T_{K}$ ;  $V = T_{K}$ ; C, with C an additional dimensionless parameter characterizing the asymmetry between and d (in other words, specifying the RG trajectory). We carry out the computation of the current to two-loop order and verify these statem ents explicitly. We then use the RG argum ents to re-sum the leading logarithm s. Our results are valid in the regime where both the bias voltage and the tem perature are smaller than the band width, and where the bias voltage or the tem perature is larger than the K ondo scale: V; T D, and  $T_K$  V or  $T_K$ T.In

particular, we verify that there are no divergencies at T=V ! 0 in the perturbative results. This means that to two-bop order, the voltage plays the role of a good infrared cuto . From the RG analysis, we give a universal prescription, valid in this regime, for comparing the electric current to the electric current to the electric of the temperature on the destruction of the K ondo cloud.

We also exam ined the e ect of a local magnetic eld on the dot but, as expected, were unable to show that the perturbation series converges in this case. We will come back to a discussion of this case, in relation with the results of [12], in the last section of this paper.

II. FORM ULATION OF THE PROBLEM AND GENERAL CONSIDERATIONS

The Schwinger-Keldysh form ulation [15, 16].

First form ulation.

We shall be interested in the electric current that passes from lead 2 to lead 1 across the quantum dot under the action of the potential di ence V. It can be calculated by evaluating the average of the current operator J with respect to a density matrix that has evolved over su ciently long time from the initial non-interacting density matrix

The operationalm eaning of this form ulation is the follow ing. The non-interacting leads are initially, say at time  $t_0$ , brought to therm aland chem ical equilibrium at zero potential di erence exchanging energy and particles with a common external reservoir at xed tem perature and chem ical potential. The energy levels of lead 1 and lead 2 are led up to the same energy (with therm aland particle uctuations).

Just after time  $t_0$ , they are separated from the external reservoir, then a potential di erence V is applied and the interaction is turned on. The application of the potential V just after time  $t_0$ , as usual, causes a raising of the energy levels of lead 2 with respect to those of lead 1. For the clarity of the discussion below, it is worth being m ore precise here. One should in agine both leads having a continuum of available states from the bottom of their bandwidths with increasing energies (the energies grow in a continuous way for in nite leads, of course, so one should think about densities of states). At time  $t_0$ , the available states of the leads are led up to equal energies. Then, just after time  $t_0$ , when the potential is applied, one shifts the energies of all states of lead 2 by, say, V=2 (tow ands higher energies), and the energies of those of lead 1 by V=2, without changing the occupations of the states. Hence, the levels of lead 2 are now led up to a higher energy than those of lead 1. Since the reservoir is disconnected and the interaction is turned on, there is a current. The steady state current is obtained after an in nite time, which we will take to be time 0 (that is, we will take  $t_0$  ! 1).

In the equation (4), the raising of the energy levels and the turning on of the interaction strength seem instantaneous and simultaneous. But one can multiply both term sVH<sub>z</sub> and H<sub>I</sub> by a factor that sm oothly increases from 0 at time  $t_0 = 1$  to 1 at time 0, for instance the factor e<sup>-t</sup>, in order to implement a simultaneous adiabatic increase of both the potential and the interaction strength. Sending ! 0 (the adiabatic increase occurring far in the past) gives the steady state. This is really what is understood in this form ulation.

It is not obvious, a priori, that this form ulation represents adequately the usual experimental situation, where the leads and the quantum dot are always connected to a common thermal reservoir (but not a reservoir of electrons), even while the steady state is being reached. However, it is natural to think that the leads can them selves play the role of thermal reservoirs. As discussed in the introduction, this is indeed the case, and will be made more precise below.

The average of an operator 0 in the steady state is then given by

The operators act in the Hilbert space for  $H_0$  (which is a tensor product of the two-channel free massless ferm ion Hilbert space and of the impurity space) obtained by imposing asymptotically vanishing conditions for the ferm ion elds (correlation functions of ferm ion elds vanish at in nite distance from each other and from the dot). To be more accurate, we could start by taking the ferm ion elds on a line segment of length L containing the dot, with some free boundary conditions; for instance, (L) = (L) (this corresponds to the usual free boundary conditions when ferm ions are folded back on the half line), then send L to in nity. The steady state would be obtained in the region

where the energy scale of switch-on,  $\mathbf{j}_0 \mathbf{j}^{-1}$ , su ces to sm ear out the energy level spacing L <sup>-1</sup>.

Second form ulation.

A nother form ulation can be given. The initial idea of this second form ulation is that the current can be created not only by a shift of the energies of the states of leads 1 and 2 (coming from the application of an electric potential), but also by putting additional electrons in lead 2 and taking away electrons from lead 1. In order to implement this, one starts again, at time  $t_0$ , with the uninteracting leads, both connected to a common therm al and particle reservoir, and in them al and chemical equilibrium; but now the chemical equilibrium is not at potential di erence 0, but rather at a potential di erence V. The initial density matrix is then

This potential di erence shifts towards lower energies the states of lead 2 with respect to those of lead 1 by an amount V. But since there is equilibrium, the states of lead 1 and lead 2 are still led up to the same energy. Note that then, as compared to the rst form ulation at time  $t_0$ , there are more available sates of lead 2 and less of lead 1 that are led.

Just after time  $t_0$ , the reservoirs are disconnected, then the potential is set to 0 and the interaction is turned on. The density matrix  $\sim_0$  then evolves with the evolution operator at zero bias voltage S ( $t_1$ ; $t_2$ ),

Putting the potential to 0 has the e ect of raising the energy levels of lead 2 with respect to those of lead 1 by an amount V, the same e ect that occurs in the rst formulation just after time  $t_0$  when the potential is applied. W ith the interaction on and the reservoir disconnected, a current is created. Again, after an in nite time, the steady state should be reached. The current is then given by

(for m ore general operators 0, see (32)).

If the size of the bandwidth can be sent to in nity (when evaluating quantum averages of operators that give nite results in this limit), then the operational description above for the second formulation is equivalent to that of the rst formulation, since then only the Ferm i energies of leads 1 and 2 m atter. In particular, raising the energy levels or lling states with electrons are exactly the same operation in this case.

However, there is another di erence between both form ulations. In the second form ulation, we can now think about putting a factor e <sup>t</sup> for adiabatically increasing the interaction strength, but there is no such possibility

simultaneously increased adiabatically.

W e will show below that both form ulations are equivalent.

Sym m etry currents. The Ham iltonian  $H_0$  is conformally invariant and has a large algebra of sym m etries associated with it. It is a W ZW \current algebra" of the sym m etry currents (not to be confused with the physical current J) and it will be convenient to carry out m any of the calculations in terms of sym m etry currents. Introduce the following operators,

The electric current. We now turn to discuss in more detail the current across the quantum dot (we set the electric charge e = 1), and express it also in terms of the symmetry currents. The electric current J is given by the operator measuring the di erence between the ferm ion density on, say, the second channel just before hitting the impurity and the ferm ion density on the same channel just after hitting it:

It is easy to see that the two de nitions coincide. We rewrite the rst de nition using \impurity conditions" - operator relation inherited from boundary conditions. Boundary conditions, in general, are part of the equations of motion and lead to operator relations valid on the full H ilbert space of a boundary quantum eld theory. They are offen derived from the action of the model in the same way as one derives the equations of motion. From our view point, after \unfolding" the K ondo model, we have a model with an impurity instead of a boundary. A swith boundaries, in purities give rise to \impurity conditions" which are part of the equations of motion and are operator relations valid on the full H ilbert space. In operator language (which is more convenient for our purposes), the impurity condition associated to a local operator O (x) can be written

Consider the in purity condition associated to the operator  $J_z(x)$  with the model with Hamiltonian H (2),

On the left-hand side, only the free part H<sub>0</sub> of the H am iltonian is involved, because the operator  $J_z(x)$  is never at the site x = 0 (and H<sub>z</sub> commutes with  $J_z(x)$ ). Using the fact that with the free H am iltonian H<sub>0</sub>,  $J_z(x)$  is a right-moving operator  $[H_0; J_z(x)] = i \frac{d}{dx} J_z(x)$ , and using the asymptotic conditions  $J_z(1) = J_z(1)$ , we have

Having now discussed the system and the various operators describing it we turn to discuss in more detail the nature of non-equilibrium in the system .

# III. EQUILIBRIUM VS.NON-EQUILIBRIUM

Our model, a quantum impurity coupled to leads at dierent chemical potentials, describes a non-equilibrium situation { a current is owing from one lead to another. W hat is the the precise meaning of this statement?

In this section we show in what sense an out-of-equilibrium model di ers from an equilibrium model. We begin by showing how the Keldysh formulation leads, when the system is in equilibrium, to the usual equilibrium density matrix description. We prove, in other words, the following:

as an equation to hold when evaluated inside traces with insertion of any number of local operators at xed positions.

A local operator is, by de nition, an operator depending on the position x (in the sense that its commutator with the momentum operator is a derivative with respect to x), such that its commutator with the ham iltonian density at position y is zero for  $x \in y$ . Note that local charges, for instance conserved charges of the H am iltonian, are integrals of local operators, and are not local operators them selves. Hence, the lim it (15) does not hold with insertion of local charges. This makes physical sense, since conserved charges are not expected to relax to

their equilibrium values. Technically, one must remember that the density matrix is an operator with in nitely many matrix elements, hence any limit applied to it cannot be expected to converge to an object having the same properties (or to converge at all) independently from which subset of matrix elements we are looking at.

This derivation is important for what follows, so we present it in some detail. Recall that  $S(t_1;t_2)$ , Eq. (7), is the evolution operator at zero voltage. We now establish some useful identities. In the interaction picture with respect to H<sub>0</sub> we have,

In (15) and in the last two expressions of (16), the symbol P indicates path-ordering in time: the operators are positioned from left to right with their time argument going from the lower integral limit to the upper integral limit. In the rst occurrence in (16), integrals are ordered from 0 on the left to  $t_0$  on the right. In the second, the integration contour is from i on the left to  $t_0$  i on the right. On the other hand, we have,

The last equality is valid perturbatively if the integration from  $t_0$  is negligible at every order in perturbation theory.

Note that the last equality involves taking  $j_0$  jm uch greater than . At zero tem perature, when ! 1, this condition cannot hold, and since the correlation functions then m ay have algebraic decay with power 1 at large distances, our proofs below (at equilibrium and in the steady state) do not apply. Nevertheless, as will be seen, our two-loop perturbative results for the non-equilibrium current have nite zero-tem perature limit; this will be discussed further in the last section.

To show the last equality in (18) we evaluate the expectation value of a local operator (or product of any local operators at xed positions) O, inserted at the right-hand side of the rst equation of (18). Denoting by

All correlation functions involved are correlation functions where the H $_{\rm I}$  (t)'s are connected to 0. Connected correlation functions are de ned, in the usualway, by subtracting from correlation function appropriate products of expectation values. In Appendix A we recall their precise de nition and main properties. Only connected

correlation functions occur, because in (20) we divide by the correlation function of the operator where all the H  $_{\rm I}$  (t)'s are involved.

In Appendix B we show that correlation functions of the type

The last step of (18) follows from the factorization property. Due to this property, connected correlation functions of the type




FIG.2: (Color online) Deriving the equilibrium formulation starting from realtine (Keldysh) formulation. (A) The Keldysh integration contour on the complex time plane; the directions of the arrows indicate the ordering of operators from left to right. (B) Adding the segment  $(t_0; t_0 \quad i)$  is allowed by the factorization property (this step is not allowed when the system is out of equilibrium). (C) The equilibrium contour.

vanish exponentially whenever any subset of consecutive time variables  $ft_i;t_{i+1};:::;t_jg$  (corresponding to a subset of time-ordered operators  $H_I$  (t)'s) goes to negative in nity simultaneously. This implies that order by order in perturbation theory of (20), all integrands vanish exponentially in any large-time region, in particular in the segment  $t_0$  i, which then factorizes and cancels between numerator and denom inator. Hence, in the limit where  $t_0$ ! 1 the last step of [18) is exact order by order in perturbation theory, and we have (15), as claim ed. See Figure 2.

W e wish to note that our argument in Appendix B relied on the fact that H<sub>I</sub>(t) is a local, right-moving operator, and that it couples to the external degree of freedom S (the in purity) in an SU (2)-invariant way. For electronic degrees of freedom large time means large distance, and at large distances, correlation functions of local elds factorize. Combined with SU (2) invariance, this implies the factorization of correlation functions of H<sub>I</sub>(t)'s at large j.j.

The implications of the well-de ned limit  $t_0 = ! 1$ , and in particular of the factorization at large time separation of the correlation functions involved in the perturbative coe cients, are important. It was not necessary to invoke any external relaxation mechanism : the factorization signals a decoherence in time and suggests that  $H_0$  represents a good therm all bath, and this bath by itself provides such a mechanism. As in Caldeira-Leggett models,  $H_0$  can be seen as an in nity of free oscillators with an appropriate frequency distribution in order to represent a therm all bath. The loss of time-reversal symmetry associated with this relaxation mechanism occurs when taking the limit  $t_0 \neq ! 1$ .

The same derivation can be carried out for more general unitary conformal eld theories perturbed by an interaction H $_{\rm I}$  at one point, or de ned on a nite region of space. Inferring from our derivation, the interaction can be due to an external degree of freedom coupled to any linear combination of elds that factorize into right- and left-m overs, and the coupling has to be invariant with respect to a symmetry group acting on the full con guration space.

The steady state current. The derivation fails when out of equilibrium, V  $\notin$  0. The step that becomes incorrect, if we start with expression (5) for the steady-state average, is the shifting of the integration limits  $t_0$  i !  $t_0$ . Indeed, the correlation functions involving V H<sub>z</sub><sup>(0)</sup> (t) = V H<sub>z</sub> are not suppressed at large negative times since H<sub>z</sub> is a conserved charge of the Ham iltonian H<sub>0</sub>. Moreover, due to quantum uctuations involving H<sub>z</sub> are not zero. These two conditions are at the origin of the appearance of a non-equilibrium situation. In physical term s, the rst condition is that the bath represented by H<sub>0</sub> does not provide a relaxation m echanism for reaching B oltzm ann's distribution of states associated to the energy H<sub>0</sub> + V H<sub>z</sub> + H<sub>1</sub>; the second condition is that nevertheless, H<sub>z</sub> is subject to quantum uctuations and evolves with time. In this case then the K eldysh form ulation does not reduce to an equilibrium description.

O ur analysis, how ever, has not yet established that a steady state occurs. We shall present below a full proof to this e ect. To motivate the proof we begin with a physical argument, based on the rst form ulation described around Eqs. (4) and (5), by considering the respective ground states of H $_0$  and H (instead of the associated

therm aldensity m atrices) and showing that they are far enough and that the evolution of H<sub>z</sub> is show enough in the lim it L ! 1 so that a steady state is established. Under other circum stances, we m ight expect some oscillating behavior.

That the ground state of H is far enough, and the evolution of H<sub>z</sub> is slow enough, can be made more precise in the following way. To begin with, consider the ground state  $\mathfrak{P}i$  of H<sub>0</sub> and the ground state  $\mathfrak{P}i$  of the Ham iltonian H<sub>0</sub> + V H<sub>z</sub>. Later we shall consider the e ect of the couplings and d. The ground state  $\mathfrak{P}i$  can be obtained in the following way. Consider the operator

The last exponential factor is a real number, scaling with the system size L (it could be absorbed into the de nition of U  $_{\rm V}$ , at the price of losing its unitarity). Hence, the operator U  $_{\rm V}$  takes H  $_0$  to H  $_0$  + V H  $_z$ , up to an additive number, and the ground state of H  $_0$  + V H  $_z$  can be obtained by

In particular, U  $_{\rm V}$  has the e ect, in the in nite-L limit, of changing the asymptotic conditions to J<sub>z</sub> (1) =

V=2.W e discussed the ground state of  $H_0 + V H_z$ . However, the actual ground state of H yields corrections to the expectation values that are of higher order in the couplings with a nite limit as L ! 1, and our conclusion therefore apply to the full H am iltonian.

W hile the expectation values are in nitely distant in an in nite system, the rate of change of  $H_z$  i as the interaction is switched on is nite since the operator  $H_I$  giving rise to the current is local. This will be seen explicitly in the perturbative calculations of the current J below (recall that  $J = i[H; H_z]$ ).

Hence, as L ! 1, it would take more and more time to get from jD to jV i. Here we assume that the average of H<sub>z</sub> would decrease monotonically. This is expected for L large enough and elapsed time large enough, though not in nite. More precisely in the region (6), we expect the expectation variue of H<sub>z</sub> to decrease steadily; this is the steady state. In other words, we expect a steady state to occur because H<sub>z</sub> scales with the length of the system, whereas its variation does not. For a nite L, it does not decrease monotonically at all times, and we might eventually see an oscillating behavior of period characterized by L.

We proceed now to the main result of this section: we show that to all orders in perturbation theory the lim it of very large negative times,  $t_0 = ! 1$  in 5), is well de ned for any local operator, 0, supported at a point or on a nite interval. This shows that there is indeed a steady state: the current operator J acquires a well-de ned expectation value.

U sing the interaction picture with respect to H  $_0$  + V H  $_z$ , we can write the steady-state average of any operator 0 as

The exact form of  $H_{I}$  is actually not in portant; note only that it is a linear combination of local operators evolved in interaction-picture time. Again using the fact that only connected correlation functions (where  $H_{I}^{(V)}$  (t) and  $H_{I}^{(V)}$  (t) are connected to 0 ) occur order by order in perturbation theory, and the fact that correlation functions involving  $H_{I}^{(V)}$  (t) and  $H_{I}^{(V)}$  (t) factorize at large times t, one can see that all integrals are convergent in the limit  $t_{0}$ = ! 1 order by order in perturbation theory.

P hysically, this means that the bath represented by H $_0$  provides the same mechanism for the steady state to occur as the mechanism it provides for the system to reach equilibrium in the case V = 0.

We now cast the expression for the steady state averages in another suggestive form and derive the alternative form ulation, expressed in (8), with the steady state obtained by coupling the dot (i.e. turning on the couplings ;  $_{\rm d}$ ) to leads initially equilibrated at temperature T and at potential difference V.

O beerve that the operators with superscript (V) form the same current algebra, Eq. (10), as those without superscript since they are obtained by the unitary transform ation  $U_V$  (21):

U sing the operator  $U_V$  in a manner similar to the one above, it is a simple matter to obtain (36) from (37) and the result then is the same as the one obtained from the form ulation (34).

A lternative description of the Steady State. W hat replaces the density matrix e <sup>H</sup> description of equilibrium? We could translate the proof establishing equilibrium when (V = 0) to the proof establishing steady state when  $(V \notin 0)$  by means of the current algebra of symmetries. By similar means we shall show that a new operator will play for the system in its steady state a similar role to the one played by the density matrix in equilibrium. Such a steady-state density matrix can be obtained from simplemanipulations, now that we have established the convergence of the integrals.

Consider the formulation (36) of the steady-state problem, with 0 in (33) an operator supported on a nite interval in the theory  $H_0$ . Bringing e  $H_0$  completely to the left, the right-hand side of (36) can be written as follows:

Note that the lim it (38) cannot be expected to exist as an operator (recall that we are dealing with operators with in nitely many matrix elements), but only when inserted into appropriate traces (or only when appropriate matrix elements are considered). More precisely, we have only proven that (38) is a well-dened operator when it is evaluated in expressions like (39), and that the result is the steady-state average of the local operators inserted. This is a statement solely about a smallpart of the matrix elements of the operator (38). The meaning of Eq. (39) is that one must rest evaluate the traces and their ratio with the expression (38) at nite  $t_0$  = , then take the lim it indicated in (38) on the result. The properties of Y as an operator acting in a H ilbert space will be discussed elsewhere.

Observe, however, that in all situations where the operator Y is well de ned (that is, when we consider the appropriatem atrix elements), then it is a conserved charge. Indeed, when it is well de ned, then the lim it  $t_0 = !$

That is, averages in the steady-state can be obtained by tracing with an appropriate density matrix [20].

W hat di erence is there between the equilibrium and the steady state? Consider a quantum mechanical system described by a Ham iltonian H. Put the system at equilibrium with a bath where there can be exchange of heat and of any quantity Q that is conserved by the dynam ics H. The average of observables is then described by the density matrix  $e^{(H + Q)}$  where is the chem ical potential associated to Q: the energy brought to the system by increasing Q by one unit. In expression (40), the average of a local operator O in the steady state is a trace with a density matrix of exactly the same form. The main di erence is that the operator Y is a non-local conserved charge. A local operator at the impurity site, with possible non-trivial in purity-space components. The operator Y (38) cannot be written in that way. To see this, we can write it as follow s:

The charge density has a local bulk part, but the term at the impurity is not a local eld of the theory H  $j_{J=0}$ : it is the time integral of the current, and the current is not the time derivative of a local eld.

The non-locality of Y is the main di erence between the description of a steady state and of an equilibrium state. In the formulation (40), only a restricted set of operators 0 have well-de ned average: those that have stationary expectation values. All local operators are of this type, but, for instance, it is simple to see that the operator H<sub>z</sub> does not have a well-de ned steady-state value.

Note also that the operator Y gives in principle a description of the asymptotic state that one can use in order to describe the steady state: quantities in the steady state can be evaluated as averages in an appropriate asymptotic state. Further analysis in this direction will be presented in our future works.

W e wish to rem ark that som etim e ago H ersh eld [6] has considered steady-state ow and has argued that under som e assumptions concerning the relaxation of correlation function an expression (40) would govern the steadystate current. He gave then implicit equations to determ ine Y. It appears to us that our explicit expressions for the operator Y satis es his implicit equations, and should hence correspond to the same operator (although we have not thoroughly ascertained the con uence of the two approaches). W e must stress, how ever, that no assumptions were made in our derivation.

### IV . RG-IM PROVED REAL-TIME PERTURBATION THEORY

The perturbative expansion. We now turn to real-time perturbation theory for the current (8). We take the form ulation where the system is initially brought to equilibrium with a nonzero bias voltage, then disconnected from the external bath before the voltage is turned o and the interaction is turned on. It will be convenient to consider adiabatically turning on the interaction in the in nite past: we introduce a large-time exponential cuto , e  ${}^{t}H_{I}$ , with a positive scale with dimension of energy, and take the limit  $t_0 = ! 1$  in  $\beta$ ). The quantity will be sent to 0 at the end of the calculations. This means, physically, that the two leads are slow ly brought towards the dot after the voltage has been turned o . Our proof that there are no divergencies as  $t_0 = ! 1$  in the previous section shows that there are no divergencies as ! 0. The current can then be written

The integrals in this expansion are plaqued with ultraviolet divergencies which we have to regularize. This can be done in several ways. For our purposes, it will be convenient to modify the operators  $J_d(x)$ ;  $J_x(x)$ ;  $J_y(x)$  in order to render their correlation functions regular at coinciding points. More precisely, we choose the regularization scheme where all operators (in the H am iltonian and in correlation functions) at the impurity site are regularized, whereas all operators away from it are una ected. Since the interaction is only at the impurity site, this is

The nite contributions are much more complicated, and are reported in Appendix F. Let us only notice that the limit  $T=V \ ! \ 0$  of these contributions is nite, as in the one-loop results. This indicates that the voltage

V plays the role of a good infrared cuto for the perturbative calculation of the current to two loops: the tem perature may be set to zero without divergences to this order.

Sum m arizing, the zero-, one- and two-loop nite and divergent contributions to the current are,

The R enorm alization G roup equation (The C allan-Sym anzik equation). In systems at equilibrium, W ilson's renorm alization group ideas allow us to understand how physical quantities can have universal forms (independent of the precise form of the interactions at the m icroscopic level) when all physical energy scales (tem perature, voltage, etc.) are much lower than the m icroscopic scales (band width, inverse lattice spacing, etc.). Out of equilibrium, it is not obvious that W ilson's renorm alization group ideas still apply.

A di erent, but equivalent, way to bok at universality is to study the limit where the cut-o is increased and sent to in nity, while the couplings dependence on the cut-o is again governed by an RG equation, valid at very large cut-o. If such a limit exists then all quantities tend to their universal form.

W e will argue that the steady-state average of the current operator (or of any operator having a well-de ned average in the steady state) satis es the Callan-Sym anzik equation with the same beta function and anom alous dimension as they occur in any average evaluated at equilibrium. M ore precisely, we will argue that

where and <sub>d</sub> are the beta functions of the anisotropic two-channelK ondo model. Note that the anom alous dimension term does not occur: the current operator J has zero anom alous dimension (this is natural from a physical perspective, as the current is a physical object which should not change with a change of scales; we will verify this explicitly to one loop, and indirectly to two loops, below).

We should note that the Callan-Sym anzik equations with one-loop beta functions and zero anom alous dimension was written in [17] for the steady-state average of the current, from physical arguments[22]. Here we present a quantum eld theoretic argument that applies to all orders (and allmatrix elements), and in the next section we explicitly verify this argument and calculate the beta functions and anom alous dimension in a universal fashion (so that it automatically applies to the steady state) to one-loop order.

The Callan-Sym anzik equation em bodies W ilson's renorm alization group ideas: it tells us how a change of cuto

(for instance, the band width) can be compensated by a change of few relevant coupling constant, as long as all physical energy scales are much lower than . Solving the Callan-Sym anzik equations (this is done below for the current in the steady state) allow s us to describe the low energy behavior of the steady-state current in term s of the ratios  $V=T_K$  and  $T=T_K$ , where  $T_K$  is an integration constant, as well as of one extra parameter (invariant under the RG ow) characterizing the asymmetry between the couplings d and ; we will denote this parameter by C. The integration constant  $T_K$  and the extra parameter C characterize the quantum eld theory; when they are xed, all averages can be evaluated unam biguously. These parameters are not universal: di erent m icroscopic theories have low-energy behaviors described by di erent values for them. Up to these non-universal quantities, the quantum eld theory description is universal, independent of the precise choice of the cuto procedure (precise structure of the band, for instance) and of irrelevant couplings (interactions that give vanishing contributions at low energies). The integration constant  $T_K$  is the K ondo temperature: the tem perature above which the \K ondo cloud" gets destroyed by the therm all energy. It is related to the m icroscopic values of the couplings and d (the values when is chosen to be of the order of the real band width), and it decreases if the couplings are decreased. At zero couplings, the K ondo tem perature is zero and all scales of the low -energy physics disappear: this is a quantum critical point. The quantum eld theory with nite ratios  $V=T_K$  and  $T=T_K$  describes the situation  $T_K$ : the couplings are sent to zero at the same time

as the voltage and tem perature are made much smaller than . This is the scaling limit, describing the region around the quantum critical point  $=_{d} = 0$ . In particular, one nds that the perturbative expansion is valid in the region  $T_K$  V or  $T_K$  T.

W e will see that in the steady state, it will be more convenient to introduce a scale M  $_{\rm K}$  characterizing both the e ects of the therm alrenergy and of the electric potential driving the current on the K ondo cloud. W e will then be able to compare these e ects, using a comparison parameter that is exact in one-loop perturbation theory.

It is natural that the Callan-Sym anzik equation is still valid in the steady state, since the steady state can be understood as an appropriate asym ptotic state, characterized by a scale V, and since averages of operators in asym ptotic states satisfy the Callan-Sym anzik equation. In particular, V should ow trivially with the renorm alization group. However, it is instructive to see explicitly how this works in real-time perturbation theory.

W e will argue that Eq. (83) holds simply from the fact that the Callan-Sym anzik equation is satis ed for any average in equilibrium. The main observation is the following. Consider the Hilbert space H  $_{\rm V}$  associated to the Ham iltonian H $_0$  VH<sub>z</sub>. It is not formed of vectors that are in the Hilbert space H $_0$  associated to the Ham iltonian H $_0$ . In particular, its ground state j V i can be form ally de ned as

This de nition indeed makes sense for any nite length of the system, and in fact allows to calculate matrix elements of any operators also at in nite length, but it does not give a vector in H<sub>0</sub> at in nite length. The scaling lim it of the current. We now evaluate the current as function of the voltage and of the tem perature. For the expression of the current, our analysis will make use solely of the one-loop results (77).

Expression (77) is the perturbative expansion in the limit T;V of the model. The couplings d; take their \microscopic" values: the actual values for the physical process represented by the interaction term s, and the cut-o is of the scale of the band width. Of course, since we neglected term s vanishing as ! 1, this is not an exact expression for nite . However, it allows us to have an exact expression in the scaling limit.

A s explained earlier, we expect universality for T;V . It is convenient therefore to consider the limit where is sent to in nity with the couplings becoming cut-o dependent: they are modiled so as to keep the physics unchanged when the cut-o is increased. Again, the solution to the RG ow (109) should be described solely as a function of  $M = T_K$  and of the RG invariant C (107), instead of and the initial conditions  $_d$  and . Once  $T_K$  is de ned, one need only solve the RG ow (109) (a numerical solution is easy to obtain with good precision, for instance), and one obtains the scaling limit in its perturbative region. The actual values of  $_d$ ; and of the band width should be such that the theory is near to the scaling limit if we want the system to be meaningfully described by quantum eld theory.

The perturbative region of the scaling limit is  $T_K = \frac{P}{V^2 + T^2}$ , for any value of C. Hence, in order to de ne  $T_K$  in perturbation theory, we need to bok at the expansion as  $M = T_K$ ! 1 of the solution to the RG ow (109). This expansion, and the value of  $T_K$ , have di erent forms depending on C. We will consider here two cases:

taking C = 1 then  $M = T_K ! 1$ ; and keeping C nite then taking  $M = T_K ! 1$ . The rst case corresponds to d = . In fact, it is true to all orders that if d = . then  $\frac{r}{d} = \frac{r}{r}$  for all scales M. In this case, the equilibrium H am iltonian H  $\frac{1}{y} = 0$  is in fact a one-channel K ondo m odel plus a decoupled free m assless ferm ion. The case C nite corresponds naturally to  $C \frac{2}{d}$  in the scaling limit (as will become clear below).

In the case where  $_{d} =$ , the RG equations lead to the following large-(M =T\_K) expansion of the running couplings:

The coe cient a can be changed by a change of the scale (the integration constant) T<sub>K</sub>; making the replacement  $T_K$  7 xT<sub>K</sub> is equivalent to doing a 7 a + ln(x). Note also that a change of scale  $T_K$  7 xT<sub>K</sub> corresponds simply to a perturbative change of the running coupling constants that keeps the beta functions invariant. Fixing the value of a is making a choice of de nition for  $T_K$ , which is one more condition necessary to totally specify the renorm alization procedure. Of course, di erent de nitions of  $T_K$  reproduce the same scaling limit. For arbitrary a, in term s of the coupling  $_d$  = and of the scale of the band width ,  $T_K$  has the form

A standard de nition for the K ondo temperature is to make the term in  $1 = \ln^2 (M = T_K)$  vanish (a = 0), giving:

where the dots (:::) mean 0 (ln  ${}^{3}(M = T_{K})$ ) for  ${}^{r}_{d}$ , and 0 (ln  ${}^{4}(M = T_{K})$ ) for  ${}^{r}$ . Note that in general, C will not appear only as a norm alization of ; this is an artifact of the limited perturbative order which we consider. A lso, note that C must be positive for  ${}^{r}$  to be positive. Again, a variation of  $T_{K}$  has the e ect of changing a: making the replacement  $T_{K}$  7 x $T_{K}$  is equivalent to doing a 7 a + ln(x). For arbitrary a, we can use the rst or the second equation of (114) in order to determ ine  $T_{K}$  in term softhe couplings d; and of the scale of the band width . This gives two equivalent forms:

Recall that from (107), we indeed have that  $/ \frac{2}{d}$  in the scaling limit, so that the second equality above is correct. A more standard way of writing the K ondo temperature can be obtained by considering the linear combination  $\frac{r}{d} + \frac{r}{r}$ . This gives, again for the same object  $T_K$  (a),

Four comments are now in order.

First, note that taking C ! 1 in (114) does not give (112). This is expected, since the form er corresponds to taking rst  $M = T_K$  ! 1 then C ! 1 in the solution to the RG equations, whereas the latter corresponds to

:

taking rst C ! 1 then  $M = T_K$  ! 1, and these two limits do not commute. In particular, one would have obtained still di erent expressions taking simultaneously C ! 1 and  $M = T_K$  ! 1, with a prescribed ratio between them, for instance (it is a simple matter to evaluate in this case, or in any other case, the expansion as  $M = T_K$  ! 1 of the solutions to the RG equations). The expressions (114) and (112) should not be regarded as describing all solutions to the RG equation; they are rather particular limits of the solutions, as described above, and are used here solely for the purpose of de ning the K ondo tem perature purely using perturbation theory (the perturbative regime is, again, the regime M  $T_K$ , for any C taken to in nity or not, simultaneously or not with  $M = T_K$ ). The expansion (114) o ers a way of de ning  $T_K$  in the regime with C nite, whereas the expansion (112) o ers a way of de ning it in the regime with C = 1. O ther de nitions would have been possible, but we only need these two de nitions of the K ondo tem perature here.

Second, it is important to recall that the cases C = 1 and C < 1 do exhaust all possible scaling regimes, even though the expressions (112) and (114) do not exhaust all possible behavior of the running couplings as  $M = T_K ! 1$ . However, there are many ways of reaching any given scaling regime. In particular, the relations = d and  $C_{d}^{2}$  (naturally associated to, respectively, the scale de nitions (113) and (115)) do not exhaust all possible ways the sam e scaling lim it can be reached. In order to understand what this means, rst recall that the full RG - in proved perturbation theory reproduces the divergent and nite part of the full bare perturbation theory, so that we can talk about the RG trajectory for the bare couplings before taking the scaling limit. Then, from this view point, one can take the scaling limit by xing a trajectory C, and by sending ! 1  $C_{d}^{2}$ , whereas for C = 1, this while keeping d and on the trajectory at scale . For nite C, this gives gives = d. But one could also take the scaling lim it by changing the value of C (changing the shape of the trajectory) while ! 1, always keeping d and on the trajectory de ned by C. For instance, this is what happens if one takes =  $q_d$  for some xed  $q \in 1$  when sending d; ! 0; then one must simultaneously take C ! 1 in order to keep and d on the RG trajectory. The resulting value of  $T_K$  in terms of such couplings is di erent from (113) and (115). But in this example, when the scaling lim it is reached we have C = 1, so that the quantum eld theory is the same as the one obtained by taking = d and sending them to 0; in particular, in the scaling limit, we still have  $r = \frac{1}{4}$ , and we can still de neal scale  $T_K$  using (112). Since we are only interested in the scaling regimes, we do not need to look at all possible ways a given regime can be reached.

Third, it is in portant to note that the leading behavior of the current at large  $M = T_K$  is very dimensional event if C = 1 or if C < 1 (again, we only look at the two cases mentionned above). In the rst case, it is given by

Note that since the RG invariant C appears as a coe cient, the leading behavior in this case is non-universal; this is a property of the regime C nite.

Finally, the parameter can be seen as parametrizing a family of choices of infrared cutos for our theory. For instance, at = 0, the temperature is the infrared cuto, whereas at = =2, the voltage solely plays the role of an infrared cuto. It is important to note that the voltage is a good infrared cuto for the average of the current operator to two-loop order. Indeed, the lim it T=V ! 0 of our one-loop and two-loop bare perturbative results is nite; equivalently, the lim it ! =2 of the renormalized perturbative results is nite. We should remark how ever that this need not be the case when other quanties are considered, see [7].

U niversal ratios. From the view point of the interpretation of the measurement of non-equilibrium quantities, the K ondo tem perature, as de ned for instance in (113), is not very convenient, since the tem perature T and the bias voltage V have a di erent in uence on the K ondo screening cloud, and we would like a de nition that embodies this di erence. Hence, it seems appropriate to de ne a continuum of scales, M  $_{\rm K}$  ( ), depending on the angle on the V T plane. Consider rst the case  $_{\rm d}$  = . A possible de nition of M  $_{\rm K}$  ( ) is the requirement that the average current J in the steady state does not have a term of the form M =  $\ln^3$  (M =M  $_{\rm K}$  ( )) in its expansion at large M =M  $_{\rm K}$  ( ):

As particular cases, we can now de ne the \decoherence" K ondo scale, M  $_{\rm K}$  (=2), as the voltage at T = 0 at which the K ondo cloud is destroyed by the electrons passing through, and the \therm al" K ondo scale M  $_{\rm K}$  (0). We nd that their ratio, which is universal and does not receive corrections from the two-loop (or higher-loop) contributions to the beta function (nor from higher order contributions to the current), is

In the case  $_{d} \in$  (that is, for C < 1), a similar de nition of M  $_{K}$  () can be made: requiring that the current does not have a term of the form  $M = \ln^{4} (M = M_{K} ())$ . Constructing again the ratio M  $_{K} (=2)=M_{K} (0)$  gives exactly the same number: this ratio is indeed universal, independent of both  $T_{K}$  and C. It is important that the current possess an infrared-convergent (convergence at large switch-on times) perturbative expansion to one loop for these universal ratios to have a meaning. Further, that they have the usual one-loop logarithm ic accuracy near to the scaling limit is a consequence of the infrared convergence of the two-loop perturbation theory.

The scale M  $_{\rm K}$  ( ) de ned above is characteristic of the current; other physical quantities would give di erent functions M  $_{\rm K}$  ( ), and di erent ratios. For instance, the same analysis can be applied on the di erential conductance

### V. PERSPECTIVES

R eaching the steady-state. We showed that the bath of free massless fermions su ces to allow the system to reach equilibrium at temperature T in the case of zero bias voltage, and to allow it to reach steady state when the bias voltage is non-zero. No other relaxation process has to be assumed; the in nite bath of free m assless ferm ions plays the role of a therm all bath and is able to absorb the energy necessary for relaxation to occur, as well as for the steady state to exist. This is in close connection with the study of C aldeira and Leggett [4]: they constructed a model where an in nite number of oscillators provides an explicit dissipation in order to study, from inst principles, the elect of dissipation on quantum tunneling. It turns out [5] that their construction is simply related to models of eld theory that are conformal in the bulk (in general, with non-conform alboundary conditions), as recall in the Introduction. It would be interesting to see to what extent our proof can be generalized to the study of more general models of quantum kinetics with therm all dissipation, and to see whether similar arguments can be applied to other in purity models out of equilibrium. A principle to follow, as can be extracted from our derivation, is the fact that the orbit of a global symmetry of the model should cover the possible values of the boundary degrees of freedom.

Related to the latter point, another question is: W hat is the e ect of a magnetic eld on the steady state in the quantum dot? Our proof of factorization in Appendix B does not hold anym ore when a magnetic eld is present, since it uses heavily the invariance of the correlation functions under SU (2) transformations. Hence, the real-time perturbation series is no longer expected to be convergent as the switch-on time is sent to m inus in nity. This is simple to understand physically: at small couplings, both the current through the dot and its interaction with the leads are weak, that is, both the non-equilibrating e ect and the thermalization e ect are weak. At zero magnetic eld, since all states of the isolated dot have the same energy, the thermalization e ect is more e cient and still stronger. At non-zero magnetic eld, how ever, as the couplings are sent to zero, we cannot expect that the dot sm oothly reaches its thermal equilibrium energy distribution when no other thermal bath is coupled to it. The real-time perturbation theory should describe this situation, but obviously its zeroth order cannot give anything else than the thermal equilibrium value of any quantity under study. Hence, in non-zero magnetic eld, we can expect some e strong non-analyticity in the couplings and we must not large-time (IR) divergences in the perturbative coe cients. This clearly indicates that the real-time e perturbative series does not properly describe the approach to the steady state, neither the steady state itself, of the model in magnetic eld without external thermal bath.

Questions remain, as raised in the Introduction: Does the quantum eld theory still (non-perturbatively) reach a steady state, or does it show other behaviors at large times, like oscillations (of the dot magnetization, for instance)? If it reaches a steady state, is it a good description of realistic systems, where the dot is coupled to an external thermal bath at all times (without exchange of particles), independently of its coupling to the leads?

The form erquestion was partially answered, in [12]: it was assumed on physical grounds that the non-equilibrium K ondo model reaches a steady state, and mainly from this assumption, it was explained how to obtain the zeroth order of perturbation theory for the dot magnetization. Indeed, strong non-analyticity is obtained. In a sense, one should start with a density matrix that already contains a non-therm all distribution of the in purity spin states; this density matrix can be obtained by requiring that the perturbative series be convergent at large times. A sexplained clearly there, this is equivalent to solving a quantum Boltzm ann equation in order to determ ine the non-therm all dot occupation numbers. This should answer partly, in some sense still perturbatively, the question of describing the steady state of the quantum eld theory (the non-equilibrium K ondo model with magnetic eld) { although the results really start with the assumption of a steady state, and do not establish its existence. However, this does not address the question as to whether the leads correctly play the role of therm all baths, or whether a coupling to an external therm all bath would have important e ects.

In relation to the latter question, our argument suggests that, at least at small couplings (or at temperatures much greater than the K ondo temperature), the model does not describe the true steady state of the non-equilibrium K ondo dot in contact with a therm all environment. Indeed, from a physical interpretation of the perturbative series, the leads do not provide a strong enough therm alisation to absorb the energy necessary for the steady state to occur, and it is possible that it cannot be trusted to sustain the correct steady state. That it does not provide the therm alisation for the steady state to occur is certainly in agreement with [12]: there it was one of the main points that the large-time divergences are due to the absence of a proper therm all bath, and that one needs to put \by hand" a therm albath connected to the dot. This was done, essentially, by putting a small in aginary part on the evolution time, which was then set to zero before taking small couplings

; d (that is, it was obtained a steady state where the coupling to the therm albath is much smaller than the couplings ; d). The most delicate question, however, concerns the fact that the steady state itself may be a ected non-trivially by a therm albath. It is probable (but this should be veried) that other, more realistic, representations of a therm albath give the same results as [12] in the lim it of small coupling with the therm al

bath. However, as the couplings ; d are sent to zero, due to the therm ale ect of the environment, the average dot magnetization, for instance, should smoothly reach its therm all equilibrium value, and this may well be a universal cross-over behavior (since it occurs at small couplings, hence near to a second order phase transition). In order to assess this, it would be important to have a more adequate description of a therm albath, and the theory of C aldeira and Leggett surely provides the most promising avenue.

The steady-state density matrix. Our proof that the real-time perturbation theory describes a steady state was immediately adapted to the proof that the steady state can be described by a density matrix (40), almost as in an equilibrium state. As mentioned, a steady-state density matrix was also introduced in [6] for generic models under the assumption that a relaxation time was present. Our derivation is slightly dierent, and does not make further assumptions, since we showed that relaxation does occur in the non-equilibrium density matrices, is that it is de ned by coupling a non-boal conserved charge Y to the voltage V, instead of coupling a local conserved charge Y to the steady state that the operator Y describes the build-up of the steady state, or, in some sense, the asymptotic state that characterizes the steady state. The properties of this asymptotic states and other consequences of this description are still to be explored.

R enorm alized real-tim e perturbation theory. We developed the two-loop renorm alized real-tim e perturbation theory. We gave an argument for the validity of the Callan-Sym anzik equation in the steady state (with the same beta functions as the equilibrium ones), and veried this to one loop for the current operator inside any correlation function. It is tempting to relate the validity of the Callan-Sym anzik equation to the fact that the operator Y appearing in the steady-state density matrix is a conserved charge. In particular, the fact that the voltage does not ow is obvious from such consideration, as it is coupled to a conserved charge. How ever, since Y is non-local, it is hard to make this connection more precise.

The quantum eld theory gives physical quantities in the scaling limit (the universal region) V; T; T<sub>K</sub> D, where T<sub>K</sub> is the K ondo temperature, which is a non-universal quantity related to the microscopic values of the couplings. Our renormalized perturbative results give the current in the region T<sub>K</sub>  $V^2 + T^2$  D. This includes the part of the universal region where the system is strongly out of equilibrium. In this perturbative region, we de ned a continuous family of K ondo scales M () depending on the ratio V=T = tan(). By comparing the scale at = =2 (T=V ! 0) with that at = 0 (V=T ! 0), we obtained a universal measure of the e ect of the voltage on the K ondo cloud, as compared to the e ect of the temperature. W e noted that such a universal measure was correct since to two-loop order, the voltage plays the role of a good infrared cuto for the current, so that no divergencies appear to that order as T=T<sub>K</sub> ! 0 (with xed V=T<sub>K</sub>).

In connection to the latter point, it has sometimes been suggested in the literature that at  $T = T_{K} = 0$ , the system should be in a \strong coupling regime" (see for instance [18]), and as such, the perturbation theory should not be valid and should show infrared divergencies (divergencies as  $T=T_K ! 0$ ) in higher-loop calculations. In particular, it is clear that this occurs in the calculation of any therm odynam ical quantities, which can indeed be deem ed \in a strong coupling regin e" (at the IR xed point) at zero tem perature. In [8,9], for instance, one sees logarithm ic divergences as  $T = T_K$  ! 0 for any xed  $V = T_K$  at the one-loop order of perturbation theory for the spin susceptibility, pointing to the fact that for describing the lim it  $T = T_K ! 0$  of that therm odynam ical quantity, one needs to know about the IR xed point [23] (the perturbation theory only describes the theory around its UV xed point). Our point, though, is that this might not be so for all quantities. Our two-loop results suggest that in a sense, the current is really a dynam ical quantity, ruled by the scale V. For comparison, this is much like a correlation function of two local elds is ruled by the distance between the points in equilibrium quantum eld theory, even at zero tem perature (the short distance behavior is described, for instance, by the UV xed point of the theory, up to a norm alization if the elds are not conserved currents, and up to the one-point functions of the operators appearing in the operator product expansion of the elds). Then, the region V Τĸ should really be, for the current, a weak-coupling, UV situation, even at zero tem perature; this is at least what we see at two-loop order. Notwithstanding the fact that infrared divergencies may signal that the steady state is not reached, as discussed above, possible divergencies in the perturbative expansion of the current at higher orders m ay correspond to simple power-like non-analyticity in the couplings at zero tem perature, with sm aller contributions than those of the two-bop results (as in the usual situation of correlation functions in equilibrium quantum eld theory).

F in ally, it would be very interesting to fully verify the validity of the Callan-Sym anzik equation with a magnetic

eld. It is easy to check for instance that the one-loop, nite-m agnetic- eld results of [8, 9, 11] satisfy the one-loop C allan-Sym anzik equations in the universal regime. A blough we did not cover the case with a nite m agnetic eld (and see the discussion above for the subtleties involved), we expect that our general arguments for the validity of the C allan-Sym anzik equations to allorder still hold since in the universal regime, the m agnetic

eki is a low-energy scale as compared to the band width. It may be useful to note that the usual perturbative renormalization was modiled in [8, 9] in order to correctly incorporate the structure of logarithm ic divergencies in the region V > D (where D is the bandwidth) of the one-loop calculation of the current and of the in purity magnetization at nite magnetic eld; more precisely, energy-dependent coupling constants were introduced. We want to stress that this region may be non-universal (that is, results may depend on the precise structure of the band), as is the region T > D or  $T_K > D$ . Then, naturally, it cannot be universally described by a nite number of coupling constants (or, more precisely, by a nite number of RG invariants). In order to recover \scaling", one needs to use exact RG or similar methods, and the usual Callan-Sym anzik equation does not hold; but this is not in disagreement with our results, which only deal with the universal regime V;T;T<sub>K</sub> D.

The connected correlation functions, where the  $H_{I}$  (t)'s are \connected" to 0, can then naturally be de ned by saying that

This recursive de nition does not involve integrations over the time parameters  $t_i$ 's, so that it is in fact a general de nition for correlation functions where a set of arbitrary operators H<sub>I</sub>( $t_i$ )'s parametrized by i = 1; ...; n are connected to 0.

The main property of connected correlation functions is the following. Consider a xed set of  $t_i$ 's for i = 1; :::;n and a xed subset  $t_i; :::;t_m$  for m < n. Consider correlation functions of  $H_I$  ( $t_i$ )'s with and without insertion of 0.0 ne can observe that if the operators  $H_I$  ( $t_i$ )'s factorize out of all such correlation functions (for instance:

C onnected correlation functions also occur in m ore general situations:

On the right-hand side, the operators H  $_{_{\rm I}}^{(1)}$  (t<sub>i</sub>)'s, H  $_{_{\rm I}}^{(2)}$  (t<sub>i</sub>)'s, ..., H  $_{_{\rm I}}^{(N)}$  (t<sub>i</sub>)'s are all connected to O.

APPENDIX B: PROOF OF FACTORIZATION

The operator H<sub>I</sub> is a linear combinations of operators of the type J S. The operators J are right-moving elds. Hence when H<sub>I</sub> is evolved in time with H<sub>0</sub> for a time t, it becomes a linear combinations of J S's at position

t. This shows the factorization of juxtaposed  $H_{I}^{(0)}$  (t)'s as jj! 1 when they are evaluated inside a trace with operators at xed time and position on the right. The same proof applies if such operator insertion is put on the left of juxtaposed  $H_{\tau}^{(0)}$  (t)'s. This completes the proof.

### APPENDIX C:CALLAN-SYMANZIK EQUATION FOR MATRIX ELEMENTS

In this appendix, we will justify equation (87). Consider the nite-tem perature average, in the theory described by H  $j_{r=0}$ , of the regularized current operator  $J = (J_x)$  (0) S with insertions of creation and an initiation operators of the H am iltonian:  $A_i^y(p)$  and  $A_i(p)$ . M ore precisely these are creation and annihilation operators for eigenstates of H  $j_{r=0}$  with energy p, corresponding to the massless particles \naturally" associated to the local operator  $J_i(x)$ , where  $J_i$  is any of the ten operators  $J_d$ ,  $J_x$ ,  $J_y$ ,  $J_z$ . Thus consider,

Since the creation and annihilation operators are eigenoperators of the H am iltonian, the quantity (1) satis es the Callan-Sym anzik equation (83) (that is, in (83) we can replace the steady-state average of the current by this quantity).

But we showed that the interacting density matrix  $e^{-H_{ij=0}}$  can be obtained from the free one  $e^{-H_0}$  by evolving it for an in nite time (15). In much the same way, the interacting creation and annihilation operators can be heuristically written in terms of the mode operators associated to the current algebra operators:

Indeed, the operators  $A_i^y(p)$  and  $A_i(p)$  written in this way heuristically satisfy the canonical commutation relations amongst them, and the appropriate commutation relations with H amiltonian H  $\dot{y}_{z=0}$ , written as  $S(0; 1)H_0S(1; 0)$  (they are eigneoperators of H  $\dot{y}_{z=0}$ ). Hence, the quantity (1) can be written

In fact, to be more precise, when going more from (2) to (1), one needs to modify slightly (2). First, the mode operators  $J_i^y(p)$ ,  $J_i(p)$ ,  $J_i(p)$  should be replaced by appropriate wave packets  $J_i^y(p)$ ,  $J_i(p)$ , obtained by integrating

the associated currents  $J_i(x)$  (times the oscillating exponential  $e^{-ipx}$ ) over space with a kernel vanishing (exponentially, say) as  $\dot{x}_j$  | for som e wave-packet extent 1. Then, the evolution operator S (1;0) should be replaced by S ( $t_0$ ;0) and S (0;1) by S (0; $t_0^0$ ), and these two evolution operators should be put into the trace in the denom inator as well, in the order in which they appear in the num erator. By using argum ents involving the vanishing of connected correlation functions, it should be observed that the limits  $f_0 j_1 j_1$ ; and  $f_0 j_1 j_2$ ; exist independently. Bringing both evolution operators around the density matrix  $e^{-H_0}$ , one should then use the steps involved in proving (15). The result, up to vanishing contributions as  $t_0; t_0^0$  l; , is (1), with operators  $A_i^{y}$  (p) and  $A_i$  (p) replaced respectively by

### APPENDIX D: ASYMPTOTIC BEHAVIOR OF THE FUNCTION P (w)

In this appendix we evaluate the asymptotic behavior of the function P (w) (74). The large w behavior is easy to obtain; the rst term inside the parenthesis (on the right-hand side of the second equation in (74)) disappears, (p 1)=( $e^{(p-1)}$  1) becomes (p 1) (p < 1): it is non-zero only for p < 1. Taking and the second term these contributions into account as well as the last term  $e^{p^2}$ , the result is:

The rst integral can be evaluated by expanding the integrand in sm allw. In order to obtain the divergent part in w, we need only consider the second integral, and we can forget about the term e  $p^2$ . Make the transform ation of variable p ! p=w :

As usual, in any explicit evaluation, the traces are regularized using a regularisation that respects cyclicity. The resulting expression is well de ned with insertion of local operators only and the lim it in plied in the de nition of the operator Y should be taken simultaneously in the num erator and the denom inator.
