## D ressed Feshbach m olecules in the BEC-BCS crossover

W e present the RPA theory of the BEC-BCS crossover in an atom ic Femmigas near a Feshbach resonance that includes the relevant two-body atom ic physics exactly. This allows us to determ ine the probability Z for the dressed molecules in the Bose-Einstein condensate to be in the closed channel of the Feshbach resonance and to compare with the recent experiments of Partridge et al. [cond-m at/0505353] with <sup>6</sup>Li. W e determ ine for this extrem ely broad resonance also the condensate density of the dressed molecules throughout the BEC-BCS crossover.

Introduction. | The super uid phase in an atom ic Ferm i gas near a Feshbach resonance realizes a fundamentally new state of matter, which shows a macroscopic coherence between atom pairs and molecules that is controlled by the applied magnetic eld. As a result, such a gas o ers the exciting possibility to study in great detail the crossover between the Bose-E instein condensation (BEC) of diatom ic molecules and the Bose-E instein condensation of atom ic Cooper pairs, i.e., the Bardeen-Cooper-Schrie er (BCS) transition [1, 2, 3, 4]. In fact, the BEC-BCS crossover region is presently already actively being explored by a number of experim ental groups around the world [5, 6, 7, 8, 9, 10].

In more detail the physics of the BEC-BCS crossover occurring near a Feshbach resonance can be understood as follows: The super uid phase of the gas is always associated with a Bose-Einstein condensate of pairs, but the wave function of the pairs or dressed molecules is given by the linear superposition

In the BEC lim it the applied magnetic eld is taken such that the bare molecular energy level lies far below the threshold of the two-atom continuum and we have Z ' 1. In that case we are dealing with a Bose-E instein condensate of tightly-bound diatom ic m olecules and the spatial part of the pair wave function is equal to the bare molecular wave function m (r). The spin part of the pair wave function is then equal to 'closedi, i.e., the spin state of the closed channel that causes the Feshbach resonance [11]. In the BCS lim it the bare molecular energy level lies far above the threshold of the two-atom continuum and can be adiabatically elim insted. We then have that Z ' 0 and the spatial part of the pair wave function equals the usual BCS wave function for atom ic Cooper pairs <sub>aa</sub> (r). This Cooper-pair wave function depends also on the magnetic eld, because the e ective attraction between the atom safter the adiabatic elim ination of the bare molecular state depends on the energy of that state. The spin state of the Cooper pairs is, how ever, always equal to the spin state ppeni of the open channel of the Feshbach problem .

The probability Z plays therefore a crucial role in the

description of the BEC-BCS crossover since it quanti es the amount of coherence between the atom pairs and the bare molecules in the gas. Unfortunately, however, the various theories [12, 13, 14, 15, 16, 17, 18, 19, 20] that are presently being used to understand the outcom e of the experim ents are unable to accurately determ ine this quantity. This com es about because, either Z is assum ed to be zero from the outset, the many-body theory does not incorporate the two-body Feshbach physics exactly, or the theory is able to determ ine only the total num ber of bare molecules in the gas and thus requires an additional assumption about the total number of dressed molecules to extract Z. This situation is particularly unsettling because of the recent <sup>6</sup>Liexperim ents of Partridge et al. [10], which have used the photodissociation rate to measure the value of Z throughout the crossover regime. In view of the above situation it is pressing to develop an ab initio many-body theory for the calculation of Z. How that may be achieved is the main topic of this Letter.

BEC-BCS crossover theory. | Introducing creation and annihilation operators for the bare molecules and atoms, the e ective grand-canonical ham iltonian of the gas with chem ical potential becomes [11, 21, 22]

where the two hyper ne states of the atoms are denoted by j "i and j #i, and the magnetic-moment difference m ag between the hyper ne states jclosedi and j #"i) = 2 gives the so-called detunjopeni (j "#i ing from resonance m ag **(**B  $B_0$ ). Note that = the atom -m olecule coupling constant g and the background scattering length abg depend on the magnetic eld B in such a manner that the total scattering length  $m q^2 = 4 \sim^2$  agrees with the Feshbach reso $a = a_{bq}$ 

nance of interest. This is especially important for the broad Feshbach resonance near 834 G auss that is used in all  $^{6}$ Li experiments up to date [23, 24].

From now on we consider only the most interesting region close to resonance, where  $a_{bq}$ a and the e ective interaction between the atom s is dom inated by the resonant part  $\hat{g}$  = . This suggests that the last term in the right-hand side of Eq. (1) can be neglected altogether. This is, how ever, not true because we can neglect this term only after we have included its e ect on the atom -m olecule coupling [25]. Physically, the reason for this subtlety is that the above H am iltonian is an e ective Ham iltonian that is only valid for low energies. However, to properly account for the two-body physics near a Feshbach resonance also high-energy states are needed. The main e ect of these high-energy states is to renorm alize the atom -m olecule coupling to q(k) $q=(1 + ika_{ba})$ , where k is the relative m om entum of the atom s involved in the coupling [11, 25]. Only after having perform ed this substitution are we allowed to neglect the background interaction between the atom s.

W ithout the background interaction the atom ic part of the Ham iltonian is quadratic. U sing standard functional m ethods the ferm ionic elds can thus be integrated out exactly. This leads to an e ective action for the molecules that at su ciently low temperatures has a minimum at a nonzero value of h m (x)i  $Z n_{m c}$ , where we introduced the dressed m olecular condensate density  $n_{m\,c}$ . Neglecting uctuations at this point leads to a mean-eld theory of the BEC-BCS crossover. As mentioned in the introduction, however, this mean-eld theory is unable to calculate the probability Z since it only determines the bare molecular condensate density  $f_{m}(x)$  if. We therefore also consider the quadratic uctuations around the minimum of the e ective molecular action, i.e., we consider the Bogoliubov theory of the bare molecules.

As expected with a spontaneously broken U (1) sym m etry associated with the presence of a Bose-E instein condensate, the gaussian uctuations are determ ined by norm aland anom alous selfenergies of the bare m olecules, which at zero tem perature reduce to

Here we have also introduced the BCS dispersion  $\sim !_{a}(k) = \int_{0}^{p} \frac{1}{(k)} \frac{3}{2} + \frac{1}{2} \frac$

Finally, we also need the equation of state, which we for consistency reasons [11] obtain by di erentiating the therm odynam ic potential with respect to the chem ical potential. Including the e ect of the uctuations we obtain for the total density of atom s

where  $G_a$  and  $G_m$  are the N am bu (2 2)-m atrix G reen's functions of the bare atom s and m olecules, respectively.

For a given density and m agnetic eld the last two equations determ ine only the bare m olecular condensate density and the chem ical potential. Hence, we need a third equation to determ ine also Z.

D ressed m olecules. Before we derive this m issing equation, let us rst discuss in some more detail the physics behind the maybe som ewhat unexpected equation of state in Eq. (4). The st two terms represent the mean-eld theory without uctuations that is most often used in the recent literature [14, 15, 16, 18]. Because of the absence of uctuations all the molecules are Bose-Einstein condensed and there is no depletion. The third term precisely corresponds to this depletion. Finally, the fourth term physically describes the dressing of the bare atoms and molecules. This can be made m ore clear by reform ulation the equation of state in term s of dressed atom s and m olecules, instead of bare atom s and molecules. Since every dressed molecule contains two atoms, we expect the contribution  $2n_{\rm m\,c}$  from the condensate of dressed molecules. Indeed, in the BEC limit it can be shown explicitly that the atom ic density  $Tr[G_a] = 2 dk j v_a (k) f = (2)^3$  contains exactly the expected contribution 2(1  $\odot$  ) $n_{mc}$  of paired atom s in




FIG.1: Spectral functions of the bare  ${}^{6}Li_{2}$  m olecules with zero m om entum a) in the BEC lim it at 571 G auss and b) in the BCS lim it at 892 G auss of the crossover occurring near the broad Feshbach resonance of  ${}^{6}Liat$  834 G auss. The Ferm i energy of the gas is 380 nK.

the Bose-E instein condensate of dressed molecules. The atom ic density does, however, not contain the paired atom s associated with the dressed molecules that are not in the Bose-E instein condensate. This om ission is repaired by the uctuation corrections which contain both the associated changes in the atom ic density and twice the total density of dressed molecules that are not Bose-E instein condensed, i.e., twice the dressed molecular depletion.

We are now in a position to determ ine Z. In principle it is equal to the residue of the pole of  $G_{m;11}(0;i!)$  at ! = 0. To understand the physics of that result better it is useful to consider the spectral function of the bare molecules with zero momentum, i.e., m(0;!) =

Im  $[G_{m;11}(0; ! + i0)] =$ . This spectral function is closely related to the density of states of the molecules at zero momentum and thus gives detailed information on the dressed m olecular content of the gas. M ost im portantly for our purposed, the Bose-E instein condensate of dressed molecules gives rise to a delta-function in the spectral function exactly at zero frequency. The strength of this delta function is precisely Z, because this is the probability to take a bare m olecule out of the Bose-E instein condensate of dressed molecules. Besides this bound-state contribution, the spectral function contains also a contribution from the continuum of atom ic scattering states. In the BEC lim it of the crossover the continuum contribution only occurs at positive frequency and starts at a frequency of  $2 = 2 - \pi d$  as shown in Fig. 1a. In the BCS lim it the continuum contribution occurs both at positive and negative frequencies, which start at a frequency of about  $2\dot{g} \ \overline{Z} n_{mc} = \sim$ , respectively, due to the gap that exists for the creation of an atom ic quasiparticlequasihole pair. This is shown in Fig. 1b. The negative frequency part of the spectral function is especially in -

portant, because it determ ines the depletion of the Bose-E instein condensate of dressed molecules. Physically it represents the dressed molecules that are stabilized by the Ferm i sea [26]. Making use of the above physical picture, we nally obtain the desired result,

At nonzero m om enta the spectral function is similar but now contains two delta functions at the frequencies  $!_m(k)$ , which have the strength  $Z j \mu_m(k) f$  and  $Z j \mu_m(k) f$ , respectively, with  $j \mu_m(k) f$   $j \mu_m(k) f = 1$ . This shows explicitly how at long wavelengths our theory leads to a Bogoliubov-like theory for dressed molecules with a wave function renormalization factor Z. Moreover, in agreement with the Goldstone theorem, the quasiparticle dispersion  $!_m(k)$  always turns out to be linear at long wavelengths. In the following we therefore determ ine also the associated speed of (second) sound throughout the BEC-BCS crossover region.




FIG. 2: The solid curve shows the probability Z and the dashed curve the fraction  $2Z n_{m c}$ =n as a function of magnetic eld. The Ferm i energy  ${}^{2}k_{F}$ =2m of the gas is 380 nK. The data points are from the experim ent of Partridge et al. [10]. In the inset the solid line shows the Bose-E instein condensate fraction of dressed m olecules  $2n_{m c}$ =n and the dashed line the contribution of the uctuations to the total atom ic density. The vertical lines indicate them agnetic elds where k jaj= 1.

Results and discussion. | In Fig. 2 we show our results for Z and compare with the experimental data of Partridge et al. [10]. In general the agreement is satisfactory. This is particularly true at relatively low magnetic elds where Z is determined by two-body physics, which is exactly incorporated into our theory. At higher magnetic elds the theoretical values of Z are somewhat higher than the experimental ones. We believe that the reasons for this are twofold. First, the experiment is performed in an optical trap. As a result the experimental data involves an appropriate average over the density pro le of the gas, which lowers the observed value of Z. Second, the photodissociation laser used in the experiment has a width which is much larger than the Ferm i energy of the gas. The laser, therefore, has not su cient resolution to probe only the Bose-E instein condensate of dressed molecules, and probes also the dressed molecules which are not Bose-E instein condensed. This second e lect should be especially in portant at high m agnetic elds. To disentangle these di erent e lects, however, goes beyond the scope of the present Letter and is left for further investigation.

We also show in Fig. 2 the Bose-Einstein condensate fraction of dressed molecules  $2n_m = n$  throughout the BEC-BCS crossover. In qualitative agreem ent with the poor m an's approach of Ref. [12], the latter fraction is always substantial below the Feshbach resonance and becom es negligible only su ciently far above the Feshbach resonance when  $k_F jaj < 1$ . This is an important observation, because in our theoretical description of the experim ent of Partridge et al. the molecular probe couples directly to the dressed molecules, which act as distinct entities in the gas since the atom -m olecule coupling is much larger than the coupling of the probe laser to the bare molecules. In this manner it is most easy to understand the experim ental observation that there is initially an exponential (one-body) decay of a large part of the total atom ic density with a rate that is much smaller than the bare m olecular photodissociation rate.




FIG.3: The speed of sound as a function of magnetic eld. The Ferm i energy of the gas is  $\frac{380 \text{ nK}}{2 \text{ an}_{m}}$ . The dashed curves show the Bogoliubov result ~  $\frac{1}{2} \text{ an}_{m}$  and the speed of sound ~k<sub>F</sub> = 3 m v<sub>F</sub> = 3 of the A nderson-B ogoliubov m ode.

For completeness we give in Fig. 2 also the Bose-Einstein condensate fraction of bare molecules  $2Z n_{m c}$ =n and the uctuation corrections to the total atom ic density. As expected the uctuation corrections are very important in the crossover region and become small far away from the Feshbach resonance, where mean-eld theory applies. From the uctuations we also extract the speed of sound of the gas, which is shown in Fig. 3. Note

that in the BCS lim it the Anderson-Bogoliubov mode is recovered. In combination with the presence of the sharp peaks in the spectral function in Fig.1b, this shows that also the decoupling of the amplitude and phase

uctuations of the Bose-E instein condensate of dressed m olecules that occurs in the BCS lim it is correctly incorporated. We therefore conclude that the RPA-like atom -m olecule theory developed here gives an excellent account of the subtle interplay between two-body and m any-body physics taking place at the crossover near a Feshbach resonance.
