Square root relaxation: two possible mechanisms

A bstract

M agnetic relaxation in large spin m olecular param agnets is often found to behave as M (t) T at short times t. This behaviour was explained by P roko ev & Stam p as arising from dipole interactions between m olecular spins. However, as observed by M iyashita & Saito, the same behaviour can arise from a di erent m echanism which, in the present work, is related to hyper ne interactions. The M iyashita-Saito scheme is found to be possible at short times if the nuclear longitudinal spin relaxation is very slow. In the case of m oderately slow nuclear spin relaxation, the electronic m agnetization variation M (t) is initially proportional to t, then to T and nally to exp(t=). This behaviour may be mostly expected in dilute system s.

Synthetic m olecular nanom agnets[1] provide reproducible m icroscopic systems with a large m agnetic m om ent which m ay have m acroscopic properties. The m ost widely studied m aterials are, in the usual term inology, M $n_{12}ac$ (with a relaxation time of 2 m onths for the m agnetization at 2 K) and Fe₈, whose faster relaxation allows easier experiments.

M agnetic relaxation of these m aterials at low temperature is a challenging problem. The m aterial is initially m agnetized by a strong m agnetic eld H in the easy m agnetization direction z. At t = 0, the external eld is suddenly given the value H_{ext}, also in the z direction. One m easures the m agnetization M_z(t) = M_z(0) + M_z(t). At low enough temperature, the following behaviour is observed for short times in Fe₈ [2, 3] and M n₁₂ [4, 5].

where A is a positive constant. This square root behaviour is in contrast with usual relaxation which is exponential, and therefore linear for short times, $M_z(t) = M_z(0)A^0t$.

The square root behaviour (1) was predicted theoretically by Proko ev & Stamp [6] for the demagnetization of a saturated sample. The molecule of interest can be modelled by a 'molecular' spin S, of electronic nature, whose modulus s is large (s = 10 for $M n_{12}$ and Fe_8). This spin is subject to an anisotropy ham iltonian which, in $M n_{12}$, may be written as a rst approximation as

where the constant K is positive.

Relaxation is slow because positive and negative values of S_z form two different potential wells separated by a barrier of height K s². At temperatures and elds of interest ($k_B T$ K s² and g $_B SH_{ext}$ K s² where $_B$ is the Bohr magneton and g the Lande factor), therm all activation by phonon absorption is not possible and magnetic relaxation takes place by spin tunneling through the barrier under the e ect of additional terms of the Ham iltonian which do not commute with S_z . Such a ham iltonian, adequate for Fe₈, is $H = H_0 + H_1 = KS_z^2 + g_B H_z S_z + BS_x^2$, where the magnetic eld H has been introduced.

If H were constant, spin tunneling would be a periodic oscillation of S_z between s and s, which could be analyzed by diagonalization of the ham iltonian. In the relaxation mechanism, the environment plays an essential part. It will be m in icked for each molecular spin by a time-dependent magnetic eld $H_z(t) = H_{ext} + H_z(t)$. The additional component $H_z(t)$ is produced partly by the dipole interaction with the other molecular spins, and partly by the hyper ne' interaction with the nuclear spins. The transverse components H_x and H_y , which slightly modulate the tunnel splitting $2h!_T$, will be neglected. The z-component H_z , though not larger, is very in portant. Indeed, spin tunneling is only possible between two eigenstates of (2) which have nearly the same energy. This occurs if, and only if the local longitudinal eld H_z is close to 0 or to particular values (or 'resonances') which depend on K. Attention will be focussed on one of these values which will be called H_1 . Roughly speaking, the condition for tunneling is that H_z satis es g $_B s H_z$ $H_1 j < h!_T$.

Proko ev & Stam p [6] have shown that the dipole interaction with the other molecular spins leads to square root relaxation, form ula (1). In their theory, this is related to the r³ behaviour of dipole interactions. It was later suggested by M iyashita & Saito [7] that square root relaxation may follow from another, com – pletely di erent mechanism which may be equivalently term ed W iener process', Yandom walk', or di usion'.

In the present note, interactions between molecular spins are ignored. The square root law (1) is shown to arise from hyper ne interactions only if nuclear spin relaxation is very slow. If it is not so slow, our results are di erent from those of M iyashita & Saito.

A simplied model will be used. The assumptions are the following.

1) Interactions between m olecular spins are neglected, H $_{\rm z}$ (t) is the hyperne eld.

2) The hyper ne eld H $_z$ (t) is a sum of independent random components H $_i^z$ (t) which can take (2I $_i$ + 1) di erent values with a de nite probability per

unit time of jumping from one value to the other. The index i labels the various nuclear spins.

3) The number of nuclear spins interacting with a given molecular spin S is large.

4) Each molecular spin has a probability per unit time to relax when the local eld $H_z(t) = H_{ext} + H_z(t)$ acting on this spin is comprised between H_1 and $H_1 +$, where ' $h!_T = (g_B s)$, otherwise there is no relaxation. The value of is expected to depend on the tunnel splitting, hyper ne eld and nuclear spin dynamics.

An extrem e case is when a molecular spin has completely relaxed at time t if, and only if, the local eld H_z(t) = H_{ext} + H_z(t) acting on this spin has been equal to H₁ at some time t⁰ between 0 and t. This limiting case will be called 'very slow nuclear relaxation'.

A ssum ption (1) is not claim ed to be a good approximation, but a simplication consistent with our purpose, to investigate t relaxation arising from hyper ne interactions only.

A ssumption (2) implies that quantum coherence is lost after a short time. It is an oversimplication with respect to the realmechanism of nuclear relaxation. In M n_{12} below about 0.1K, this mechanism seems to be complex, involving inhomogeneities of the crystal [8].

A ssum ption (3) is physically realistic since dipole interactions are long ranged.

A ssum ption (4) is appropriate when $H_1 \in 0$, so a spin can tunnel from the low est state of its initial well to an excited state of the other well, where it deexcites with phonon emission. In the case $H_1 = 0$, tunnelling takes place between the low est states of each well and phonons have no e ect. Then assumption (4) must be reform ulated. This will be done in a separate section

1 Analogy with a random walk

A coording to assumption (4) the magnetization at timet depends on the probability p(h;t) that the hyper ne eld H ^z (t⁰) has taken the value H₁ for $0 < t^{0} < t$ if the initial eld was H ^z (0) = h. The eld H ^z is the sum of contributions H ^z_i of m any nuclei. A coording to assumption (2), these nuclei ip by random, uncorrelated jumps. Thus, they are similar to the steps of a random walker In the simplest case, the random walker has the same probability to go forward or backward. Then, the probability¹ (h;h⁰;t) that a random walker is at H _z = h⁰ at time t if he started from h at time 0 satis es the di usion equation

where D is related to the relaxation time of nuclear spins. It will generally be assumed to be independent of h^0 . Then the solution of (3) is




Figure 1: The thick curve shows the hyper ne eld distribution g(H $_z$). The thin curve shows a possible evolution with time to f the hyper ne eld H $_z$ on a particular molecular spin S.

Form ulae (3) and (4) are not valid for long times. Indeed the eld distribution $g(H_z)$ has a nite width H (Fig. 1), so that the random walker cannot reach elds higher than H. This can be accounted for by a force f (h⁰). The di usion equation is thus replaced by the Fokker-P lanck equation

which describes an O mstein-U hlenbeck process[7]. The force is easy to calculate by writing the equilibrium condition $(h;h^0;1) = g(h^0)$. It follows

If g(h) is a gaussian, g(h) = (2) $^{1=2}$ H 1 exp[h^2 =(2 H 2)] then f(h) = h = H 2 .

For short times, formulae (3) and (4) are still correct in the presence of the force f(h). Indeed, the displacement of the random walker is the sum of a random part, of the order of D t, and a drift part D f (h)t' D ht= H². The form er dom inates the latter for short times.

2 Very slow nuclear spin relaxation

The resonance condition $j_{H_z}(t) = H_1 j < is$ satisfied during a time of the order of $^2=D$. The ipping probability of a molecular spin during this time is $^2=D$. If this quantity is of order unity or larger, the nuclear relaxation will be said to be very slow'. In that case, the proportion n (t) of relaxed spins at time t is

where $p(h_1;h;h^0;t)$ is the probability that the random walker, who started from h at time 0, is at h^0 at time t and has reached $h_1 = H_1$ H_{ext} at some time t⁰ between 0 and t. It is related to $(h;h^0;t)$ by

Relation (8 a) is obvious and (8 b) can easily be derived, or found in textbooks[9].

 p^{T} he integrand in (7) is very small unless h h_{1} and h^{0} h_{1} are of the order of p of D t or smaller. In that domain the integrand is of the order of 1 = D t. It follows that M (t) D t in agreem ent with (1). The detailed calculation, based on (7), (8) and (4), yields

There is no relaxation if $h_1 j > H$ (if resonances other than at H $_1$ are excluded). The maximum value of A (obtained for $h_1 = 0$) is of the order of $1 = {p \over H} W$ here

is the longitudinal nuclear spin relaxation time. The notation T_1 has been avoided because it usually designates the spin-lattice relaxation time, related to spin-phonon interactions, which is extremely long at low temperature. The notation T_2 has also been avoided because it usually designates the transverse nuclear spin relaxation time.

3 M oderately slow nuclear spin relaxation

The nuclear spin relaxation will be called moderately slow when the relaxation of a molecular, electronic spin requires that $(H_1 H_z)$ vanishes several times, but is already almost complete (at resonance, i.e. $h_1 = 0$) at $t = _H$.

A qualitative description will be given in the case $h_1 = H_1$ $H_{ext} = 0$. As seen from (4), the random walker explores in the time t a eld interval h(t) ' D t. The proportion of eld values which have been explored at time t is thus

This quantity p(t) is also the proportion of molecular spins which have a chance to relax during the time t. For such a spin, tunneling is allowed during a time p

For a spin whose local eld lies in the explored region h(t), the relative magnetization change, for short times, is t_{eff} , and this evaluation is correct if $t_{eff} < 1$. The total relative magnetization change is for such times

This form ula is di erent from that written by M iyashita & Saito, who assume $h = h_1$ at t = 0, so that p(t) is replaced by 1 in (13). Therefore, they predict

 $M_z(t)$ ^p t at short time instead of $M_z(t)_p$ t as obtained in (13). The quantity they calculate is actually t_{eff} ' t=D, which is given by their formula (3.9) as $h^2!_T^2$ t=D where is a constant. Since ' $h!_T = (g_B s)$, identication of the two results yields

where x is a constant time (related to). Thus, M iyashita & Saito nd that is independent of D and H. This suprising result is based on the assumption of a fairly fast nuclear spin relaxation, and on the statem ent that \the velocity of the eld is proportional to \overline{D} . This point will not be discussed here.

When t becomes so large that $t_{eff} > 1$, the depolarization for an explored'eld value is almost total and the average relative dem agnetisation is $M_z(t) = M_z(1) = p(t)'$ $D t = H = t_H$ as in the case of very slow nuclear relaxation. This result holds if h_1 j is appreciably sm aller than $H \cdot W$ hen h_1 j approaches H, the rate of change of the m agnetisation can easily be shown to decrease to 0.

4 Long tim es

For timest $_{\rm H}$, the random walker has lost the mem ory of its initial position h. Thus, to quote M iyashita & Saito, \the number of crossings" [of H $_{\rm z}$ (t) with H $_1$ per unit time] \ is ... constant in time, which causes a constant rate relaxation, i.e., the exponential relaxation." Two remarks should be added. First, the electronic spin relaxation time obviously depends on h_1 = H_1 H_{\rm ext}. M iyashita & Saito made detailed numerical studies, but only in the case of an external eld tuned at resonance, h_1 = 0. When h_1 $\stackrel{6}{\leftarrow}$ 0 becomes larger than the width H, obviously goes to 1. The second remark is that, in the case of very slow orm oderately slow nuclear spin resonance, which is addressed in the present note, the electronic spin relaxation is already very strong at t = $_{\rm H}$, i.e. M ($_{\rm H}$) = M (1) is of order unity. This im plies that the exponentially relaxing part is small.

5 The case $H_1 = 0$

In most of the experiments done so far, $H_1 = 0$, i.e. tunnelling takes place between the lowest state of each well. This case is peculiar. 1) The main feature is that (if phonons are completely ignored) the system of electronic and nuclear spins ignore the temperature T of the crystal, and relax to an equilibrium state which generally corresponds to another temperature T_{eff} . Indeed, only a part of the Zeem an energy of the molecular spins can be transferred to nuclear degrees of freedom . Only for $H_{ext} = 0$, when the Zeem an energy vanishes, $T_{eff} = T \cdot 2$) If nuclear spin relaxation is not very slow, the above treatment is still acceptable for short times, because spin reversal and relaxation are nearly the same thing. 3) Let the case of very slow nuclear spin relaxation be discussed. Then, when the hyper ne eld H _z crosses the value H_{ext} , S_z follows the eld adiabatically and changes sign. Thus, if $S_z(0) = s$ then $S_z(t) = s$ if $(h \ h_1)$ and $(h^0 \ h_1)$ have the same sign, while $S_z(t) = s$ if they have a di erent sign. Thus, the spin never best the memory of its initial state, which is quite unusual in a relaxation processs. For short times, form ula (1) can then be derived from an argument similar, but not identical to the above one, and A turns out to be given by (9) again. For long times, the hyper ne eld distribution is probably a ected by relaxation and depends on time.

6 Validity of the very slow nuclear relaxation scheme

For a spin able to tunnel between two localized states j i and j+i, the wave function x (t) j+i+y (t) j i satis es

where the unperturbed energies E () (t) satisfy E () (t) E (+) (t) = 2g B [H z (t) H 1]s.

Equation simplies if one introduces the notations $u(t) = (1-h) \frac{R_t}{t_0} dt^0 E^{(+)}(t^0)$, $w(t) = \frac{1}{h} \frac{R_t}{t_0} dt^0 E^{(-)}(t^0)$, $x(t) = \exp[iu(t)]X(t)$, and $y(t) = \exp[iw(t)]Y(t)$. Moreover, the initial condition X(0) = 1 will be assumed, and the time will be assumed so short that X(t) may be approximated by X(0) = 1. Then (15) yields $Y_{-}(t) = i!_T \exp[iU(t)]$ where

Let the initial value of the local eld be tuned so as to allow tunnelling. If the tunnelling window remains open until a time of the order of the tunnel period 1=!_T, nuclear relaxation is very slow in the sense de ned above. The condition for very slow relaxation is thus U (1=!_T) < 1. A coording to (16), U (t) can be roughly evaluated as the product of (2g _B s=h) by D t = H t = H and a factor t because of the integration. The condition for very slow relaxation reads

The hyper ne width H is never smaller than 0.001 Tesla. Thus, (17) requires large values of $_{\rm H}$ and $!_{\rm T}$. For instance, a nuclear relaxation time $_{\rm H} = 1 \, {\rm sim} \, {\rm plies} \, !_{\rm T}$ 10 s⁻¹.

An additional condition is $!_{T H} > 1$, but condition (17) is probably stronger. U sual nuclear spin-lattice relaxation is expected to be extremely slow at low temperature. However, measurements by Morello et al. [8] in $Mn_{12}ac$ reveal that $_{\rm H}$ does not increase beyond about 0.01 second. The zero eld tunnel splitting of the ground doublet does not seem to satisfy the requirement $!_{\rm T}$ $_{\rm H}$ > 1 (Barbara, private communication). Thus, nuclear spin relaxation is not very slow and therefore the hyper ne eld is not expected to give rise to t relaxation in zero external eld in M n₁₂ ac, but rather to exponential relaxation.

It is of interest to recall that square root relaxation has been observed in Fe_8 on times of the order of a minute. The nuclear spin lattice relaxation times T_1 which have been reported (for instance when observing negative spin temperatures[10]) are of the same order of magnitude, but it is not clear whether so long nuclear longitudinal relaxation times can be reached in molecular nanomagnets.

7 Real system s: e ect of dipole interactions

In real systems, dipole interactions between molecular spins are present and contribute to the local eld by an amount which will be called bipole eld'. This contribution adds to the hyper ne eld addressed above. Total magnetic relaxation requires that the dipole eld, as well as the hyper ne eld, explores the whole allowed region. In Fe₃, the dipole eld created by electronic spins is about 10 tim es as large as the hyper ne eld, and therefore 90% of the relaxation cannot be explained by the M iyashita-Saito mechanism described above, but only by the P roko ev-Stam p mechanism.

8 Conclusion

In the present work it is shown that the ^p t behaviour can in principle arise from hyper ne interactions alone. This can happen for any value of the external eld and for any initial state provided it is not the equilibrium state. However, very slow nuclear spin relaxation is necessary. In the case of moderately slow nuclear spin relaxation, the decay is found to be linear at short times, in contrast with the statements of M iyashita & Saito. This discrepancy occurs because M iyashita & Saito assumed the initial condition $h = h_1$ which is not fulled by nuclear spins. A fler some time the decay crosses over to the ^t behaviour and nally becomes exponential at long times. The constant A of formula (1), and the relaxation rate 1= which describes the long time behaviour, go to 0 when the tuning parameter (H_{ext} H₁) becomes large with respect to the hyper new idth H.

W hen $H_1 = 0$ and H_{ext} ' 0, spin relaxation has remarkable features when the spin-lattice relaxation time is very long. The spin tem perature can then be quite di erent from the lattice tem perature.

The present work contains several shortcom ings. The possibility of simultaneous reversal of the electronic spin and a few nuclear spins has been disregarded. Such processes have been treated by Proko ev & Stamp[11] in the case of superparam agnetic grains. They might be less crucial for molecular nanom agnets since each molecular spin interacts in a signi cantway with a restricted number of nuclear spins. On the other hand, the possible dependence of D and with respect to the local eld has also been ignored (as in the work of M iyashita & Saito). Such a dependence would modify the value (9) of the coe cient A.

The present theory m ay be relevant, for instance, in two cases. i) $M n_{12}ac$ if a transverse eld is applied in order to increase !_T and to full the condition (17) of very slow nuclear spin relaxation. ii) D iluted samples of Fe₈, where the dipole interaction between m olecular spins is sm aller than the hyper ne eld.
