A pseudo-potential analog for zero-range photoassociation and Feshbach resonance

A zero-range approach to atom -m olecule coupling is developed in analogy to the Ferm i-H uang pseudo-potential treatm ent of atom -atom interactions. It is shown by explicit comparison to an exactly-solvable nite-range model that replacing the molecular bound-state wavefunction with a regularized delta-function can reproduce the exact scattering am plitude in the long-wavelength lim it. U sing this approach we nd an analytical solution to the two-channel Feshbach resonance problem for two atoms in a spherical harm onic trap.

Coupling between atoms and molecules in quantum degenerate gases is an ever-present aspect of ultracold atom ic physics. Feshbach resonances (FR) [1] are now routinely used for control over atom ic interactions [2] and the formation of molecular Bose-Einstein condensates [3, 4, 5, 6]. Laser-induced photoassociation (PA) is also widely employed [7,8], having the advantage of control over the coupling strength [9]. W hile a zero-range approach to atom - atom collisions has long been a cornerstone of BEC theory, an analog to the Ferm iH uang pseudo-potential approach [10] has yet to be form ulated to treat multichannel free-bound coupling in ultra-cold atom ic gases.

In the long-wavelength lim it, the energy-dependence of the scattering phase-shift for atom ic collisions takes a universal form, with all inform ation about the details of the interaction potential contained in a single param eter, the scattering length. As a result, the full interaction potential can be replaced by a regularized deltafunction pseudo-potential, which yields the correct scattering amplitude up to a third-order correction in the ratio of the e ective range to the incident wavelength. In this Letter we form ulate an analogous approach to atom molecule coupling, by replacing the bound-state wavefunction with the zero-range object which correctly reproduces the long-wavelength scattering am plitude. The resulting m odel contains no divergences and does not require a momentum cut-o . It is likely that this model will play an important role in understanding the role played by atom -atom correlations in FR and PA physics, particularly in the strong-coupling regime, where such e ects play a dom inant role.

The rst zero-range model for BEC atom -molecule coupling, proposed by Heinzen and coworkers, replaced the bound-state wavefunction with a delta-function [11]. This approach was shown by Holland and coworkers to contain a UV divergence when pair correlations were taken into account [12], thus lim iting its applicability. Holland and coworkers demonstrated that this divergence could be removed via a momentum cut-o and re-norm alized detuning. As we will see, this approach fails in the presence of a background scattering length.

We begin our analysis by considering a pair of atom s described by a relative wavefunction $i_{j}(r;t)$, where j =

1;2 corresponds to an internal spin state. The eigenstates of this system obey the Schrodinger equation,

where E is the energy eigenvalue, is the reduced mass and V_{jk} (r) is the inter-atom potential. For our model system we assume that the rst channel sees a at potential, $V_{11}(r) = 0$. The second channel sees a spherical-well potential of depth $V_{0}\,$ and radius w, V_{22} (r) = U_0 $V_0 U$ (w r), where U_0 is the continuum threshold energy and U (x) is the unit-step function. In the absence of coupling term s, i.e. for $V_{12}(r) = 0$, the spectrum of the second channel consists of a continuum of states above the threshold energy, U_0 , and a discrete set of bound states with energies between U_0 and U_0 Vo. The bound-states are all of the form

where a_b and k_b satisfy the equations $\frac{h^2}{2} k_b^2 + 1 = a_b^2 =$ V_0 and $\cot(k_b w) = 1 = (k_b a_b)$, and N_b is determined by norm alization. The bound state energies are $E_b = U_0$ $h^2 = (2 a_{\rm b}^2)$.

We proceed by rst expanding the second channel wavefunction, $_2$ (r), onto its bare eigenstates under the simplifying assumptions that only a single bound state is near-resonantly coupled to the st channel so that all other states m ay be neglected. W e assume the interaction potential has the form V_{12} (r;t) $\frac{h^2G}{2}e^{i!t}$. Taking $E = h^2 k^2 = (2)$ then leads to an eigenvalue problem for a continuum coupled to a single bound state,

where c is the probability amplitude for the atom pair to be in the bound state, and $= \frac{1}{h^2} (U_0)$!) is the detuning away from the atom -m olecule resonance at k = 0. The coupling constant G will depend on the details of the atom -m olecule coupling scheme.

Our goal is now to solve this eigenvalue problem , under the boundary conditions

in order to determ ine the scattering amplitude f = f(k). The solution can be obtained via the ansatz

This ansatz explicitly satis es (3), as well as the boundary conditions (5-6). Equation (4), together with the continuity equations $_1(w^+) = _1(w)$ and $r_{-1}(w^+) = r_{-1}(w)$ can then be used to determ ine the three unknowns f, c, and . These equations are linear in the three unknowns, and can be thus solved in a straightforward m anner.

The long-wavelength lim it requires that 1=k be large compared to the size of the bound-state. As the size of the bound-state is w + a_b , this is equivalent to the lim its kw 1 and ka_b 1. For our model potential the condition $K_b > 1$ =w is always satised, so that k=K b is a small parameter as well. Expanding the scattering amplitude f (k) in terms of these small parameters then yields

The important point here is that all of the details of the potential can be absorbed into e ective detuning and coupling constants.

We now consider a zero-range model in which the bound-state wavefunction $_{\rm b}(r)$ in (3) is replaced by a regularized delta-function, G $_{\rm b}(r)$! $^{3}(r)\frac{\theta}{\theta}r$. In addition, the detuning is replaced by the light-shifted detuning and the coupling constant G is replaced by the electric coupling constant $\$. The Schrödinger equation for this model is given by

This problem can be solved by making use of the ansazt $_{1}(\mathbf{r}) = \frac{e^{-ikr}}{r} + f \frac{e^{ikr}}{r}$ and the identity $r^{2} \frac{1}{r} = 4^{-3} (\mathbf{r})$. The scattering amplitude is readily found to be

which agrees with the result (8) up to a correction of third-order in the small parameters kw, ka_b , and $k=K_b$. Thus the zero-range model (11-12) will reproduce correctly the long-wavelength atom -m olecule quantum - dynamics of our model potential.

Second quantization of this model yields the H am iltonian

where (r) is the annihilation operator for an atom of mass m = 2, and (r) is the annihilation operator for a molecule of mass 2m. The system of equations (11-12) can be derived from this H am iltonian via the 2-atom quantum state

where (R) is an arbitrary center-offm asswavefunction and jDi is the vacuum state. The H am iltonian (14) should form the basis of any eld-theoretical description of zerorange atom -m olecule coupling.

As an example, we now solve the problem of two bosonic atoms in a spherical harmonic oscillator (with frequency $!_{trap}$) with both swave collisions and coupling to a bound state in a second channel. With $E = h!_{trap}(_n + 3=2)$, $!h!_{trap}$, and using harmonic oscillator units, the tim e-independent Schrödinger equation can be written as

where n is an integer label for each quantum level (the lowest energy level corresponding to n = 0), a is the

background scattering length, is the harm onic oscillator length of the trap, and $= 2^{3=4}$. The norm alized eigenfunctions are found to be [13]

where (;x) = 1 $2x [\frac{1}{2}] = [\frac{+1}{2}]$, U (a;b;z) is the con uent hypergeom etric function and (z) is the polygamma function [14]. The eigenvalues f_ng are determ ined by the characteristic equation

where there is an apparently non-trivial relation $j_n \ j = d_n = d_$. It is straightforward to show that the spectrum of eigenvalues will agree exactly with those of a single-channel system with the energy-dependent e ective scattering length

which is the familiar Feshbach Resonance result. The only di erence between the true atom molecule eigenstates and the equivalent single-channel states with scattering length a_{eff} , is the presence of the barem olecule population, $j_n \hat{f}$. From a series expansion of (18) the 1=r part of $_n$ (r) is found to be $\frac{2^{1-4}}{2^{1-4}} \frac{c_n}{r} \cdot Only$ for a = 0 is this term independent of $_n$, so that it can be rem oved via a renorm alized detuning [12].

On resonance we have $_n =$ and $j_{eff} j ! 1$. A careful analysis shows that this requires $_n = 2n - 1$ and $c_n \in 0$. Thus the eigenvalues are driven to odd-integer or 'ferm ionized' values, for which the regular part of $_n$ (r) vanishes at r = 0. Inserting this result into Eq. (19) gives an analytic expression for the on-resonance m olecular fraction,

where $n = \frac{(2n)!!}{(2n-1)!!} = 2$. For the low lying levels we have 0 = = 2, 1 = and 2 = 4 = 3.

The energy-dependence in the elective scattering length is critical to understanding the cross-overbetwisen the weak-coupling and strong coupling regimes. The requirement for a signi cant deviation from the bare-trap spectrum is $a_{eff} = 1$. Obtaining this condition via Feshbach resonance requires $= \gamma_{h} \frac{1}{2} = 2$. If this width is smaller than the level spacing, only a single level can be near-resonant for a given detuning. In this weak-coupling regime, 2 1, the spectrum consists of a series




FIG.1: The eigenvalue spectrum as a function of the detuning for the case a = 3 and = 2, illustrating a sequence of avoided crossings in the weak-coupling regime. The dashed lines correspond to the uncoupled eigenvalues




FIG.2: The eigenvalue spectrum as a function of the detuning for the case a = 0 and = 10, illustrating the 'ferm ionization' of the low lying levels in strong-coupling regime (in the vicinity of = 0). The dashed lines correspond to the odd-integer values $_n = 2n - 1$.

of avoided crossings between the bare molecular level and the uncoupled eigenstates of the 'open' channel. At each avoided crossing there will be strong mixing between a single trap level and the molecular state. Sweeping the detuning can select which trap level is resonantly coupled to the molecular state. This is illustrated in Figure 1, where we have plotted the eigenvalue spectrum as a function of the detuning for the case a = :3 and = :2. The dotted lines show the uncoupled (= 0) eigenvalues. The shifts in the asymptotic values of the energy levels from the bare trap spectrum ($_n = 2n$) are due to the presence of swave collisions. The asymptotic state at :7 is the bound state of the 'open' channel, which is an eigenstate of the trap plus pseudo-potential system.

In the strong coupling regime, de ned as 2 1, the width of the resonance is much larger than the trap level-spacing, hence many levels can be resonant simultaneously. Thus the low-lying levels all lie very close




FIG. 3: E ective scattering length, a_{eff} , (solid line) and m olecular fraction, $j_h \int_{-1}^{2}$, (dashed line) as the detuning, , is swept across resonance. Figures 3a and 3b show the cases n = 1 and n = 2, respectively, for the case = 2 and a = 3. Figures 3c and 3d show n = 0 and n = 1 for = 1 and a = 0, while gures 3e and 3f show n = 0 and n = 1 for the case = 10 and a = 0. The vertical dotted lines mark the location of the resonance, while the horizontal dotted lines correspond to the analytical result for $j_h \int_{-1}^{2}$ given by Eq. (22).

to their on-resonance values of n = 2n - 1. This is illustrated in Figure 2, which shows the eigenvalue spectrum as a function of detuning for the case = 10 and a = 0. In this regime Eq. (22) is a good estimate for the molecular fraction, showing that the molecular am plitude decreases dramatically with increasing coupling strength. To understand this e ect, we simply make the reasonable assumption that in the strong-coupling limit all quasi-resonant levels are mixed with equal am - plitudes. For ² 1, the num ber of near resonant levels is N_{levels} ². If we equate the probability for any given bare-state to the total probability divided by the approximate number of levels we arrive at jcf 1= ², which agrees well with Eq. (22).

In Figure 3 we plot a_{eff} and $j_{c_n} f$ versus detuning for several cases of interest. In Figs 3a and 3b we show the weak-coupling case = 2 and a = 3 for levels n = 1 and n = 2 respectively. The n = 1 case shows a sweep (right to left) from the lowest 'unbound' state into the bound state in the bpen' channel. The n = 2 case shows a transfer from one 'unbound' state to another. As the level is swept through resonance we see a broad feature in the molecular fraction $\dot{r}_{\rm p}f$, whose maximum value is slightly larger than the on-resonance value (22) and occurs to the right of the resonance. Figures 3c and 3d show the interm ediate case = 1 and a = 0 for levels n = 0 and n = 1. We see in the n = 1 case that the molecular fraction is signi cantly reduced compared to the weak-coupling regime. Lastly, in Figures 3e and 3fwe see the strong-coupling case = 10 and a = 0, for levels n = 0 and n = 1. We see that in the strong coupling regime, the scattering length can be tuned from 1 to +1, with a negligible bare-m olecular component.

In conclusion, we see that the e ects of paircorrelations play a major role in atom -molecule coupling, resulting in the appearance of a 1=r singularity in the relative wavefunction together with a corresponding decrease in the bare-molecule population. This suggests that form olecule form ation it is best to have a weak coupling, while form an ipulation of atom ic interactions, e.g. for BCS pairing of ferm ions [15, 16], a strong coupling will rem ove the corresponding bare-molecule population. In FR the free-space coupling strength is predeterm ined by atom ic properties, hence can only be increased by decreasing the trap size. In PA, however, the coupling strength is readily increased by increasing the laser intensity. This suggests that laser-induced photoassociation m ay have a signi cant advantage over Feshbach Resonance for tuning atom -atom interactions.
