# Anyons in an exactly solved model and beyond

#### Abstract

A spin 1=2 system on a honeycom b lattice is studied. The interactions between nearest neighbors are of XX, YY or ZZ type, depending on the direction of the link; di erent types of interactions m ay di er in strength. The m odel is solved exactly by a reduction to free ferm ions in a static  $Z_2$  gauge eld. A phase diagram in the parameter space is obtained. O ne of the phases has an energy gap and carries excitations that are Abelian anyons. The other phase is gapless, but acquires a gap in the presence of m agnetic eld. In the latter case excitations are non-Abelian anyons whose braiding rules coincide with those of conform al blocks for the Ising m odel. We also consider a general theory of free ferm ions with a gapped spectrum, which is characterized by a spectral Chem number . The Abelian and non-Abelian phases of the original m odel correspond to = 0 and = 1, respectively. The anyonic properties of excitation depend on m od 16, whereas itself governs edge therm al transport. The paper also provides m athem atical background on anyons as well as an elem entary theory of Chem number for quasidiagonal m atrices.

#### Com m ents to the contents: W hat is this paper about?

Certainly, the main result of the paper is an exact solution of a particular two-dimensional quantum model. However, I was sitting on that result for too long, trying to perfect it, derive some properties of the model, and put them into a more general framework. Thus many ram i cations have come along. Some of them stem from the desire to avoid the use of conform al

eld theory, which is more relevant to edge excitations rather than the bulk physics. This program has been partially successful, but some rudiments of conformal eld theory (namely, the topological spin  $_{a} = e^{2 i(h_{a} \ h_{a})}$  and the chiral central charge c = c  $\bar{c}$ ) are still used.

The paper is self-contained and provides an introduction into the subject. For most readers, a good strategy is to follow the exposition through the beginning of Sec. 8, Nonabelian anyons and take a glance at the rest of that section, where things become more technical. But the mathematically inclined reader may be interested in those details, as well as some of the appendices. I have tried to make the paper modular so that some parts of it can be understood without detailed reading of the other. This has caused some redundancy though.

A ppendix E, A lgebraic theory of anyons is an elementary introduction into unitary modular categories, which generalizes the discussion in Sec. 8.

Appendix C, Quasidiagonal matrices is also mostly expository but some of the arguments may be new. It begins with a simplied treatment of \operator ow " and \noncommutative Chem number" (the latter has been used to prove the quantization of Hall conductivity in disordered systems [1]), but the main goal is to explain \unpaired M ajorana modes", a certain parity phenomenon related to the Chem number.

Appendix D on the chiral central charge and Appendix F on weak sym m etry breaking contain som e raw ideas that m ight eventually develop into interesting theories.

# Introduction

O verview of the subject. Anyons are particles with unusual statistics (neither Bose nor Ferm i), which can only occur in two dimensions. Quantum statistics may be understood as a special kind of interaction: when two particles interchange along some speci ed trajectories, the overall quantum state is multiplied by  $e^{i'}$ . In three dimensions, there is only one topologically distinct way to swap two particles. Two swaps are equivalent to the identity transform ation, hence  $e^{i'} = 1$ . On the contrary, in two dimensions the double swap corresponds to one particle making a full turn around the other; this process is topologically nontrivial. Therefore the exchange phase ' can, in principle, have any value | hence the name \anyon". (However, a stability consideration requires that ' be a rational multiple of 2 .) Of course, the real question is whether such particles exist in nature or can be built somehow, but we will follow the historic path, approaching the problem from the mathem atical end.

The study of anyons was initiated by W ilczek [2, 3] in early 1980's. He proposed a simple but rather abstract model, which was based on (2 + 1)-dimensional electrodynamics. This theory has integer electric charges and vortices carrying magnetic ux (which is a real number de ned up to an integer). Considered separately, both kinds of particles are bosons. But when a charge q goes around a vortex v, it picks up the phase 2 qv, known as the A haronov-B ohm phase. Thus, charges and vortices have nontrivialm utual statistics and therefore must be called anyons when considered together. Moreover, composite objects (q;v) consisting of a charge and a vortex are anyons by them selves because they have nontrivial exchange phase  $'_{(q;v)} = 2$  qv.

A general way to describe quantum statistics is to consider particle worldlines in the (2+1)dimensional space-time. Such worldlines form a braid, therefore the statistics is characterized by a representation of the braid group. In the preceding discussion we assumed that braiding is characterized just by phase factors, i.e., that the representation is one-dimensional. The corresponding anyons are called Abelian. But one can also consider multidimensional representations of the braid group; in this case the anyons are called non-Abelian. A ctually, it may not be so important how the braid group acts, but the very existence of a multidimensional space associated with several particles is a key feature. Vectors in this space are quantum states that have alm ost the same energy (see discussion of topological quantum computation below).

H istorically, the theory of non-A belian anyons emerged from conform altheory (CFT). How – ever, only topological and algebraic structure in CFT is relevant to anyons. D i erent pieces of this structure were discovered in a colossal work of many people, culm inating in the paper by M oore and Seiberg [4]. W itten's work on quantum Chem-Sim ons theory [5] was also very in uential. A m ore abstract approach (based on local eld theory) was developed by Fredenhagen, R ehren, and Schroer [6] and by Frohlich and G abbiani [7].

The most am azing thing about anyons is that they actually exist as excitations in some condensed matter systems. Such systems also have highly nontrivial ground states that are described as possessing topological order. The best studied example (both theoretically and experimentally) is the Laughlin state [8] in the fractional quantum Hall system at the lling factor = 1=3. It carries A belian anyons with exchange phase ' = =3 and electric charge

1=3. It is the fractional value of the charge that was predicted in original Laughlin's paper and con m ed by several methods, in particular by a shot noise measurem ent [9, 10]. The statistical phase is a subtler property which is deduced theoretically [11, 12]; a nontrivial experimental test has been performed recently using quasiparticle tunneling [13].

A di erent kind of state is observed at the lling factor = 5=2, though it is more fragile and less studied experimentally. There is much evidence suggesting that this system is described by a beautiful theory proposed by M oore and Read [14, 15]. The M oore-Read state adm its non-A belian anyons with charge 1=4. If 2n such particles are present, the associated H ilbert space has dimension  $2^{n-1}$ . (The non-A belian anyons studied in this paper have sim ilar properties, though there is no electric charge.)

The notion of anyons assumes that the underlying state has an energy gap (at least for topologically nontrivial quasiparticles). O there is excitations are not localizable and braiding may not be de ned. Note that if all excitations are gapped, then all equal-time correlators decay exponentially with distance [16].

An example of anyons in a spin-1=2 system originates from the theory of resonating valence bond (RVB). The idea of RVB was put forward by Anderson [17] and used later as a model of the undoped insulating phase in high-T<sub>c</sub> cuprate superconductors [18]. W ithout electrically charged holes, the problem seem s to be described adequately by a H eisenberg-like H am iltonian, but its solution has proved very di cult. Several variants of an RVB state have been proposed, both gapless and gapped. Here we discuss a particular gapped RVB phase, namely the one which is realized on the triangular lattice [19], but which apparently exists on the square lattice as well. This phase adm its quasiparticles of four types: trivial excitations (such as spin waves), spinons (spin-1=2 ferm ions, which are conserved m odub 2),  $Z_2$ -vortices (spinless bosons, also




Figure 1: A classical vortex (a) distorted by uctuations (b).

called visons), and spinon-vison composites [20]. The mutual statistics of spinons and visons is characterized by the Aharonov-Bohm factor 1, therefore the composite particles are bosons. Note that the relevance of this theory to cuprate superconductors is under debate. Senthil and F isher proposed an interesting way to detect visons in these materials [21], but the experiment gave a negative result [22]. However, some kind of RVB state is likely to realize in a di erent material,  $C s_2 C u C l_4$ . This conclusion is drawn from neutron-scattering experiments that have shown the presence of spin-1=2 excitations [23].

A nyonic particles are best viewed as a kind of topological defects that reveal non-trivial properties of the ground state. Thus anyons carry some topological quantum numbers which make them stable: a single particle cannot be annihilated locally but only through the fusion with an antiparticle. An intuitive way to picture an anyon is to imagine a vortex in a medium with a local order parameter (see Fig. 1a). Now suppose that quantum uctuations are so strong that the order parameter is completely washed out and only the topology remains (see Fig.1b). O fcourse, that is only a rough illustration. It resembles the K osterlitz-T houless phase with power-law correlation decay, while in anyonic system s correlations decay exponentially due to the energy gap.

A real example can be constructed with spins on the edges of a square lattice. Basis states of the spins are described by the variables  $s_j = 1$ , which m ay be regarded as a  $Z_2$  gauge eld (i.e., \vector potential"), whereas the \m agnetic eld intensity" on plaquette p is given by

We say that there is a vortex on plaquette p if  $w_p = 1$ . Now we may de ne the vortex-free state: x

(c is a norm alization factor). The state with a single vortex on a given plaquette is de ned sim ilarly. It is clear that the vortex can be detected by measuring the observable  $\int_{j^{21}}^{z} for$  any enclosing path l, though no local order parameter exists.

The state (2) can be represented as the ground state of the following Ham iltonian with

four-body interaction [24]:

Its elementary excitations are  $\rm Z_2$ -charges with energy  $\rm 2J_e$  and vortices with energy  $\rm 2J_m$ . Certain essential features of thism odel are stable to small local perturbations (such as external magnetic

eld or H eisenberg interaction between neighboring spins). Note that the robust characteristic of excitations is not the energy or the property of being elem entary, but rather superselection sector. It is de ned as a class of states that can be transform ed one to another by local operators. This particular m odel has the vacuum sector 1, the charge sector e, the vortex sector m, and a charge-vortex composite ". Particles of type e and m are bosons with nontrivial mutual statistics, whereas " is a ferm ion. Thus, the m odel represents a universality class of topological order | actually, the same class as RVB.

A nyonic superselection sectors may or may not be linked to conventional quantum num – bers, like spin or electric charge. Most studies have been focused on the case where anyons carry fractional electric charge or half-integer spin. Such anyons are potentially easier to nd experimentally because they contribute to collective elects (in particular, electric current) or have characteristic selection rules for spin-dependent scattering. Chargeless and spinless quasiparticles are generally harder to identify. But anyons, by virtue of their topological stability, must have some observable signatures. For example, anyons can be trapped by in purities and stay there for su ciently long time, modifying the spectrum of localmodes (magnons, excitons, etc.). However, elective methods to observe anyons are yet to be found.

Thus, the hunt for anyons and topological order is a di cult endeavor. W hy do we care? First, because these are conceptually important phenomena, breaking some paradigms. In particular, consider these principles (which work well and provide important guidance in many cases):

- 1. Conservation laws come from symmetries (by Noether's theorem or its quantum analogue);
- 2. Sym m etnies are initially present in the H am iltonian (or Lagrangian), but m ay be spontaneously broken.

Let us lim it our discussion to the case of gauge symmetries and local conservation laws, which are described by fusion rules between superselection sectors. A profound understanding of the rst principle and its underlying assumptions is due to D oplicher and R oberts [25, 26]. They proved that any consistent system of fusion rules for bosons is equivalent to the multiplication rules for irreducible representations of some compact group. Fermions also t into this fram e-work. However, anyonic fusion rules are not generally described by a group! As far as the second principle is concerned, topological order does not require any preexisting symmetry but leads to new conservation laws. Thus, the form ation of topological order is exactly the opposite of symmetry breaking!

Topological quantum computation. A more practical reason to look for anyons is their potential use in quantum computing. In Ref. [24] I suggested that topologically ordered states can serve as a physical analogue of error-correcting quantum codes. Thus, anyonic systems

provide a realization of quantum memory that is protected from decoherence. Some quantum gates can be implemented by braiding; this implementation is exact and does not require explicit error correction. Freedman, Larsen, and W ang [27] proved that for certain types of non-Abelian anyons braiding enables one to perform universal quantum computation. This scheme is usually referred to as topological quantum computation (TQC).

Let us outline some basic principles of TQC. First, topologically ordered systems have degenerate ground states under certain circum stances. In particular, the existence of A belian anyons implies the ground state degeneracy on the torus [28]. Indeed, consider a process in which a particle-antiparticle pair is created, one of the particles winds around the torus, and the pair is annihilated. Such a process corresponds to an operator acting on the ground state. If A and B are such operators corresponding to two basic bops on the torus, then ABA <sup>1</sup>B <sup>1</sup> describes a process in which none of the particles e ectively crosses the torus, but one of them winds around the other. If the Aharonov-Bohm phase is nontrivial, then A and B do not commute. Therefore they act on a multidim ensional space.

A ctually, the degeneracy is not absolute but very precise. It is lifted due to virtual particle tunneling across the torus, but this process is exponentially suppressed. Therefore the distance between ground energy levels is proportional to exp(L=), where L the linear size of the torus and is some characteristic length, which is related to the gap in the excitation spectrum.

In non-A belian systems, degeneracy occurs even in the planar geometry when several anyons are localized in some places far apart from each other (it is this space of quantum states the braid group acts on). The underlying elementary property may be described as follows: two given non-Abelian particles can fuse in several ways (like multi-dimensional representations of a non-Abelian group). For example, the non-Abelian phase studied in this paper has the following fusion rules:

where 1 is the vacuum sector, and " and are some other superselection sectors. The last rule is especially interesting: it means that two -particles may either annihilate or fuse into an "-particle. But when the -particles stay apart, 1 and " correspond to two quantum states, j<sub>1</sub> i and j<sub>1</sub> i. These states are persistent. For example, if we create j<sub>1</sub> i by splitting an " into two 's, wait some time, and fuse the -particles back, we will still get an "-particle.

Here is a subtler property: the fusion states  $j_1$  i and  $j_*$  i are practically indistinguishable and have almost the same energy. In fact, a natural process that \distinguishes" them by multiplying by di erent factors is tunneling of a virtual "-particle between the xed -particles (which is possible since "= ). However, "-particles are gapped, therefore this process is exponentially suppressed. Of course, this explanation depends on m any details, but it is a general principle that di erent fusion states can only be distinguished by transporting a quasi-particle. Such processes are unlikely even in the presence of them all bath and external noise, as long as the tem perature and the noise frequency are much smaller than the gap.




Figure 2: Four ways to initialize an anyonic qubit.

In the above example, the two-particle fusion states  $j_1$  i and  $j_n$  i cannot form coherent superpositions because they belong to di erent superselection sectors (1 and ", resp.). In order to implement a qubit, one needs four -particles. A logical jDi is represented by the quantum state  $j_1$  i that is obtained by creating the pairs (1;2) and (3;4) from the vacuum (see Fig.2). A logical jLi is encoded by the complementary state  $j_n$ : we rst create a pair of "-particles, and then split each of them into a -pair. Note that both states belong to the vacuum sector and

therefore can form superpositions. Also shown in Fig. 2 are two alternative ways to initialize the qubit,  $j_1i$  and  $j_ri$ . The detailed analysis presented in Secs. 8.4 and 8.5 in plies that

Therefore we can perform the following gedanken experiment. We create the state  $j_1i$  and then measure the qubit in the  $j_1i$ ;  $j_i$  ig-basis by fusing the pairs (1;3) and (2;4). With probability 1=2 both pairs annihilate, and with probability 1=2 we get two "-particles. One can also think of a simple robustness test for quantum states: if there is no decoherence, then both  $j_1i$  and  $j_1i$  are persistent.

As already mentioned, braiding is described by operators that are exact (up to virtual quasiparticle tunneling). Indeed, the operators of counterclockw ise exchange between two particles (R-matrices) are related to the fusion rules by so-called hexagon equations and pentagon equation. We will see on concrete exapt les that these equations have only a nite number of solutions and therefore do not admit sm all deform ations. In general, it is a nontrivial theorem known as O cneanu rigidity [29, 30], see Sec. E.6.

Thus, we have allessential elements of a quantum computer in plemented in a robust fashion: an initial state is made by creating pairs and/or by splitting particles, unitary gates are realized by braiding, and measurements are performed by fusion. This \purely topological" scheme is universal for su ciently complicated phases such as the k = 3 parafermion state [31], lattice models based on some nite groups (e.g.  $S_5$  [24],  $A_5$  [32, 33] and  $S_3$  [34]), and double Chem-Simons models [35, 36, 37]. Unfortunately, the model studied in this paper is not universal in this sense. One can, however, combine a topologically protected quantum memory with a nontopological realization of gates (using explicit error correction). Note that some weak form of topological protection is possible even in one-dimensional Josephson junction arrays [38], which is due to the build-in U (1)-symmetry. Several other schemes of Josephson junctionbased topological quantum memory have been proposed recently [39, 40, 41].

Unlike many other quantum computation proposals, TQC should not have serious scalability issues. W hat is usually considered an initial step, i.e., im plementing a single gate, may actually be close to the solution of the whole problem. It is an extremely challenging task, though. It demands the ability to control individual quasiparticles, which is beyond the reach of present technology. One should however keep in m ind that the ultimate goal is to build a practical quantum computer, which will contain at least a few hundred logical qubits and involve error-correcting coding: either in software (with considerable overhead) or by topological protection or maybe by some other means. At any rate, that is a task for the technology of the future.

But for the meantime, nding and studying topological phases seems to be a very reasonable goal, also attractive from the fundamental science perspective.

C om parison with earlier work and a sum mary of the results. In this paper we study a particular exactly solvable spin model on a two-dimensional lattice. It only involves two-body interactions and therefore is simpler than H am iltonian (3) considered in [24], but the solution is less trivial. It is not clear how to realize this model in solid state, but an optical lattice implementation has been proposed [42].

The model has two phases (denoted by A and B) which occur at di erent values of parameters. The exact solution is obtained by a reduction to free real fermions. Thus quasiparticles in the system m ay be characterized as fermions and  $Z_2$ -vortices. Vortices and fermions interact by the Aharonov-Bohm factor equal to 1. In phase A the fermions have an energy gap, and the vortices are bosons that fall into two distinct superselection sectors. (Interestingly enough, the two types of vortices have identical physical properties and are related to each other by a lattice translation.) The overall particle classi cation, fusion rules, and statistics are the same e as in the model (2) or RVB. In phase B the fermions are gapless and there is only one type of vortices with unde ned statistics. Adding a magnetic eld to the H am iltonian opens a gap in the fermionic spectrum, and the vortices become non-Abelian anyons. The di erence between the vortex statistics in phase A and phase B with the magnetic eld m ay be attributed to di erent topology of fermionic pairing.

Topological properties of Ferm i-system swere rst studied in the theory of integer quantum Halle ect [43, 44]. Let us outline the main result. To begin with, the Hall conductivity of noninteracting electrons in a periodic potential (e.g., in the Hofstadter model with m = n ux quanta perplaquette) is expressed in term sofa single-electron Ham iltonian in the Fourier basis. Such a Ham iltonian is an n n matrix that depends on the momentum q. For each value of q one can de ne a subspace L (q)  $C^n$  that is associated with negative-energy states, i.e., ones that are occupied by electrons. Thus, a vector bundle over the momentum space is de ned. The quantized Hall conductivity is proportional to the Chem num ber of this bundle. Bellissard at al [1] have generalized this theory to disordered system s by using a powerful mathem atical theory called noncom mutative geom etry [45].

Even m ore interesting topological phenom ena occur when the number of particles is not conserved (due to the presence of terms like  $a_j^y a_k^y$ , as in the mean-eld description of superconductors). In this case the single-electron H am iltonian is replaced by a more general object, the Bogolyubov-N am bu matrix. It also has an associated Chem number , which is twice the number de ned above when the previous de nition is applicable. But in general is an arbitrary integer. The rst physical example of this kind, the <sup>3</sup>H e-A lm, was studied by Volovik [46]. Volovik and Yakovenko [47] showed that the Chem number in this system determ ines the statistics of solitons. M ore recently, R ead and G reen [48] considered BCS pairing of spinless particles with angular momentum l = 1. They identied a \strong pairing phase" with zero Chem number and a \weak pairing phase" with = 1. The latter is closely related to the M oore-R ead state and has non-A belian vortices and chiral edge m odes.

In the present paper, these results are generalized to an arbitrary Ferm i-system described by a quadratic H am iltonian on a two-dimensional lattice. We show that  $Z_2$ -vortices are A belian particles when the C hern number is even and non-A belian anyons when is odd. The non-A belian statistics is due to unpaired M a prana modes associated with vortices. Our method relies on a quasidiagonal matrix formalism (see Appendix C), which is similar to, but more elementary than, noncommutative geometry. It can also be applied to disordered systems.

Furtherm ore, we nd that there are actually 16 (8 Abelian and 8 non-Abelian) types of vortex-ferm ion statistics, which correspond to di erent values of m od 16.0 nly three of them (for = 0; 1) are realized in the original spin m odel. We give a complete algebraic description of all 16 cases, see tables on pages 30, 41, and 42.

# 1 Themodel




Figure 3: Three types of links in the honeycom b lattice.

W e study a spin-1=2 system in which spins are located at the vertices of a honeycomb lattice, see Fig. 3a. This lattice consists of two equivalent simple sublattices, referred to as \even" and

\odd" (they are shown by empty and full circles in the gure). A unit cell of the lattice contains one vertex of each kind. Links are divided into three types, depending on their direction (see Fig. 3b); we call them \x-links", \y-links", and \z-links". The Ham iltonian is as follows:

where  $J_x$ ,  $J_y$ ,  $J_z$  are model parameters.

Let us introduce a special notation for the individual term s in the Ham iltonian:

Remarkably, all operators K  $_{jk}$  commute with the following operators W  $_{p}$ , which are associated to lattice plaquettes (i.e., hexagons):

Here p is a label of the plaquette. Note that di erent operators W  $_{\rm p}$  commute with each other.

Thus H am iltonian (4) has the set of \integrals of motion "W  $_{\rm p}$ , which greatly simplies the problem. In order to nd eigenstates of the H am iltonian, we rst divide the total H ilbert space L into sectors | eigenspaces of W  $_{\rm p}$ , which are also invariant subspaces of H. This can be written as follows: M

where m is the number of plaquettes. Each operator W  $_{p}$  has eigenvalues + 1 and 1, therefore each sector corresponds to a choice of w  $_{p}$  = 1 for each plaquette p. Then we need to solve for the eigenvalues of the H am iltonian restricted to a particular sector  $L_{w_{1},...,w_{m}}$ .

The honeycomb lattice has 1=2 plaquette per vertex, therefore m n=2, where n is the number of vertices. It follows that the dimension of each sector is  $2^n = 2^m$   $2^{n-2}$  (we will in fact see that all these dimensions are equal). Thus splitting into sectors does not solve the problem yet. Fortunately, it turns out that the degrees of freedom within each sector can be described as real (M a jorana) ferm ions, and the restricted H am iltonian is simply a quadratic form in M a jorana operators. This makes an exact solution possible.

# 2 Representing spins by Majorana operators

#### 2.1 A general spin-ferm ion transform ation

Let us remind the reader some general formalism pertaining to Ferm i system s. A system with n ferm ionic modes is usually described by the annihilation and creation operators  $a_k$ ,  $a_k^y$  (k = 1; :::;n). Instead, one can use their linear combinations,

which are called M a jorana operators. The operators  $c_j$  (j = 1;:::;2n) are H erm itian and obey the following relations:

Note that all operators c<sub>j</sub> can be treated on equal basis.

We now describe a representation of a spin by two ferm ionic modes, i.e., by four M a jorana operators. Let us denote these operators by  $b^x$ ,  $b^y$ ,  $b^z$ , and c (instead of  $c_1$ ,  $c_2$ ,  $c_3$ ,  $c_4$ ). The M a jorana operators act on the 4-dimensional Fock space  $M^{f}$ , whereas the H ilbert space of a spin is identified with a two-dimensional subspace M  $M^{f}$  defined by this condition:

W e call M and  $\mathbb{M}^{f}$  the physical subspace and the extended space, respectively; the operator D may be thought of as a gauge transform ation for the group  $\mathbb{Z}_{2}$ .

The Pauli operator x, y, z can be represented by som e operators  $e^x$ ,  $e^y$ ,  $e^z$  acting on the extended space. Such a representation must satisfy two conditions: (1)  $e^x$ ,  $e^y$ ,  $e^z$  preserve

the subspace M ; (2) when restricted to M , the operators  $e^x$ ,  $e^y$ ,  $e^z$  obey the same algebraic relations as  $x^x$ ,  $y^y$ ,  $z^z$ . We will use the following particular representation:

(W e have associated the M a jorana operators with four dots for a reason that will be clear later.) This representation is correct since e ( = x;y;z) commutes with D (so that M is preserved), (e)<sup>y</sup> = e, (e)<sup>2</sup> = 1, and

The last equation is consistent with the formula x y z = i because D acts as the identity operator on the subspace M .

A multi-spin system is described by four M a prana operators per spin. The corresponding operators  $e^{-j}$ ,  $D_{-j}$  and the physical subspace L  $\perp$  f are dened as follow s:

Any spin Ham iltonian H f  $_{j}$  g can be replaced by the ferm ionic Ham iltonian IP fb<sub>j</sub>; c<sub>j</sub>g = H fe  $^{j}$ g the action of which is restricted to the physical subspace. (The resulting Ham iltonian IP is rather special; in particular, it commutes with the operators D  $_{j}$ .)

R em ark 2.1. The substitution j?  $e_j = ib_j c_j$  is gauge-equivalent to a more fam iliar one (see [49] and references therein):

Thus one can represent a spin by only 3M a jorana operators without in posing gauge constraints. However, this is not su cient for our purposes.

#### 2.2 Application to the concrete m odel

Let us apply the general procedure to the the spin Ham iltonian (4). Each term  $K_{jk} = j_k$  becomes  $\mathbb{R}^{e}_{jk} = (ib_j c_j)(ib_k c_k) = i(ib_j b_k)c_j c_k$ . The operator in parentheses,  $\hat{u}_{jk} = ib_j b_k$ , is Herm itian; we associated it with the link (j;k). (The index takes values x, y or z depending on the direction of the link, i.e.,  $= j_k$ .) Thus we get:




Figure 4: Graphic representation of Hamiltonian (13).

Note that each pair of connected sites is counted twice, and  $\hat{u}_{kj} = \hat{u}_{jk}$ . The structure of this Ham iltonian is shown in Fig. 4.

Remarkably, the operators  $\hat{u}_{jk}$  commute with the Hamiltonian and with each other. Therefore the Hilbert space  $\mathbb{F}$  splits into common eigenspaces of  $\hat{u}_{jk}$ , which are indexed by the corresponding eigenvalues  $u_{jk} = 1$ . Similarly to  $\langle r \rangle$  we may write  $\mathbb{F} = \begin{bmatrix} & & \\ & & & \\ & & \\ & & \\ & & & \\ & & \\ & & & \\ & & \\ & & & \\ & & & \\ & & & \\ & & & \\ & & & \\ & & & \\ & & & \\ & &$ 

Note, however, that the subspace  $\mathbf{F}_u$  is not gauge-invariant: applying the gauge operator  $D_j$  changes the values of  $u_{jk}$  on the links connecting the vertex j w ith three adjacent vertices k. Therefore the state  $j^e{}_u$  i does not belong to the physical subspace. To obtain a physical space we must symmetrize over all gauge transformations. Specifically, we construct the following state:

Here w denotes the equivalence class of u under the gauge transform ations. For the planar lattice (but not on the torus) w is characterized by numbers  $w_p = 1$  de ned as products of  $u_{jk}$  around hexagons. To avoid ambiguity (due to the relation  $u_{kj} = u_{jk}$ ), we choose a particular direction for each link:

The corresponding operator  $\hat{W}_{p} = {}^{Q} \hat{u}_{jk} \mod m$  utes with the gauge transform ations as well as the H am iltonian. The restriction of this operator to the physical subspace coincides with the integral of m otion W <sub>p</sub> de ned earlier (see (6)).

N otation change: From now on, we will not make distinction between operators acting in the extended space and their restrictions to the physical subspace e.g.,  $\mathbf{M}_p$  versus  $\mathbf{W}_p$ . The tilde mark will be used for other purposes.

#### 2.3 Path and loop operators

One may think of the variables  $u_{kj}$  as a  $Z_2$  gauge eld. The number  $w_p$  is interpreted as the magnetic ux through the plaquette p. If  $w_p = 1$ , we say that the plaquette carries a vortex.

The product of  $\hat{u}_{jk}$  along an arbitrary path corresponds to the transfer of a ferm ion between the initial and the nalpoint. However, this product is not gauge-invariant. One can de ne an invariant ferm ionic path operator in terms of spins or in terms of ferm ions:

where K  $_{jk}$  is given by (5). If the path is closed, i.e.,  $j_h = j_0$ , the factors  $c_h$  and  $c_0$  cancel each other. In this case the path operator is called the W ilson bop; it generalizes the notion of magnetic ux.

On the honeycomb lattice all loops have even length, and form ula (16) agrees with the sign convention based on the partition into the even and odd sublattice. However, the spin model can be generalized to any trivalent graph, in which case the loop length is arbitrary. For an odd loop 1 the operator W (1) has eigenvalues  $w_1 = -i$ . This is not just an artifact of the de nition: odd loops are special in that they cause spontaneous breaking of the time-reversal symmetry.

The time-reversal operator is a conjugate-linear unitary operator T such that

(The rst equation is a physical requirement; the other two represent the action of T in the extended space.) Therefore T commutes with the Hamiltonian (4) and the W ilson bop. Multiplying the equation  $W_1 j i = w_1 j i$  by T, we get  $W_1 T j i = w_1 T j i$ . Thus the time-reversal operator changes  $w_1$  to  $w_1$ . For a bipartite graph  $w_1 = w_1$  for all bops, therefore xing the variables  $w_1$  does not break the time-reversal symmetry. On the contrary, for a similar model on a non-bipartite graph (e.g., a lattice containing triangles) the operator T does not preserve the eld con guration, which is de ned by the values of  $w_1$  on all bops. But T is a symmetry operator, therefore all Hamiltonian eigenstates are (at least) two-fold degenerate.

# 3 Quadratic H am iltonians

In the previous section we transform ed the spin m odel (4) to a quadratic ferm ionic H am iltonian of the general form

where A is a real skew-symmetric matrix of size n = 2m. Let us brie y state some general properties of such Ham iltonians and x the term inology.

First, we comment on the normalization factor 1=4 in Eq. (18). It is chosen so that

Thus the Lie algebra of quadratic operators iH(A) (acting on the  $2^n$ -dimensional Fock space) is identied with so (2m). Operators of the form  $e^{iH(A)}$  constitute the Lie group Spin (2m).

The center of this group consists of phase factors 1 (e.g.,  $e^{c_1 c_2} = 1$ ). The quotient group Spin (2m)=f+1; 1g = SO (2m) describes the action of  $e^{iH}$  (A) on M a jorana operators by conjugation:

(Q is a real orthogonal matrix with determ inant 1).

Note that the sum in Eq. (20) corresponds to them ultiplication of the row vector  $(c_1; :::; c_{2m})$ by the matrix Q. On the other hand, when we consider a linear combination of Majorana operators,

we prefer to view x as a column vector. If the coe cients  $x_i$  are real, we call F (x) (or x itself) a Majorana mode.

To nd the ground state of the H am iltonian (18), one needs to reduce it to a canonical form

where  $b_k^0$ ,  $b_k^0$  are norm alm odes, and  $a_k^Y = \frac{1}{2} (b_k^0 - i b_k^0)$ ,  $a_k = \frac{1}{2} (b_k^0 + i b_k^0)$  are the corresponding creation and annihilation operators. The ground state of H canonical is characterized by the condition  $a_k j i = 0$  for all k. The reduction to the canonical form is achieved by the transform ation

The numbers  $\prod_{k}$  constitute the spectrum of the Hermitian matrix iA, whereas odd (even) columns of Q are equal to the real (resp., in aginary) part of the eigenvectors. The ground state of the Majorana system has energy

where the function j jacts on the eigenvalues, the eigenvectors being xed. (In fact, any function of a real variable can be applied to Herm itian m atrices.)

Note that di erent quadratic Ham iltonians may give rise to the same ground state. The latter actually depends on

(W e assume that A is not degenerate.) The matrix B is real skew-symmetric and satisfies  $B^2 = 1$ . It determines the ground state through the condition

Loosely speaking, B corresponds to a pairing<sup>1</sup> between M a jorana m odes. The operators  $b^0 = F(x^0)$  and  $b^0 = F(x^0)$  are paired if  $x^0 = Bx^0$ .

The matrix P in Eq. (27) is called the spectral projector. It projects the 2m -dimensional complex space C<sup>2m</sup> onto the m-dimensional subspace L spanned by the eigenvectors of iA corresponding to negative eigenvalues. For any vector z 2 L the corresponding operator F (z) annihilates the ground state, so we may call L the space of annihilation operators. Note that if  $z_i z^0 2$  L then  $\int_j z_j z_j^0 = 0$ . The choice of an m-dimensional subspace L  $C^{2m}$  satisfying this condition is equivalent to the choice of matrix B.

The ground state of a quadratic H am iltonian can also be characterized by correlation functions. The second-order correlator is h  $j_{2j}q_{kj}j i = 2P_{kj}$ ; higher-order correlators can be found using W ick's formula.

# 4 The spectrum of ferm ions and the phase diagram

We now study the system of M a jorana ferm ions on the honeycomb lattice. It is described by the quadratic H am iltonian H<sub>u</sub> = H (A), where  $A_{jk} = 2J_{jk}u_{jk}$ ,  $u_{jk} = 1$ . A lthough the H am iltonian is parametrized by  $u_{jk}$ , the corresponding gauge-invariant state (or the state of the spin system) actually depends on the variables  $w_p$ , see (15).

First, we remark that the global ground state energy does not depend on the signs of the exchange constants  $J_x$ ,  $J_y$ ,  $J_z$  since changing the signs can be compensated by changing the corresponding variables  $u_{jk}$ . We further notice that the ground state energy for  $H_u$  does not depend on these signs even if u is xed. Suppose, for instance, that we replace  $J_z$  by  $J_z$ . Such a change is equivalent to altering  $u_{jk}$  for all z-links. But the gauge-invariant quantities  $w_p$  remain constant, so we may apply a gauge transform ation that returns  $u_{jk}$  to their original values. The net e ect is that the M a jorana operators at som e sites are transform ed as  $c_j$ ? G. Speci cally, the transform ation acts on the set of sites  $_z$  that lie in the shaded area in the picture below. In terms of spins, this action is induced by the unitary operator

So, for the purpose of nding the ground state energy and the excitation spectrum, the signs of exchange constants do not matter (but other physical quantities may depend on them).

<sup>&</sup>lt;sup>1</sup>N ote the nonstandard use of term inology: in our sense, electron half-modes in an insulator are paired as well as in a superconductor. The only di erence is that the insulating pairing commutes with the number of electrons while the superconducting one doesn't. This distinction is irrelevant to our model because the Ham iltonian doesn't preserve any integral charge, and the number of ferm ions is only conserved modulo 2.

Them ost interesting choice of  $u_{jk}$  is the one that m inim izes the ground state energy. It turns out that the energy m inimum is achieved by the vortex-free eld con guration, i.e.,  $w_p = 1$ for all plaquettes p. This statement follows from a beautiful theorem proved by Lieb [50]. (N ot knowing about Lieb's result, I did some numerical study suggesting the same answer, see Appendix A.) Thus we may assume that  $u_{jk} = 1$  for all links (j;k), where j belongs to the even sublattice, and k belongs to the odd sublattice. This eld con guration (denoted by  $u_{jk}^{std}$ ) possesses a translational symmetry, therefore the fermionic spectrum can be found analytically using the Fourier transform.

The general procedure is as follows. Let us represent the site index j as (s; ), where s refers to a unit cell, and to a position type inside the cell (we choose the unit cell as shown in the gure accompanying Eq. (32)). The Ham iltonian becomes  $H = (i=4)_{s; t; t}^{s} A_{s,t} c_{s} c_{t}$ , where  $A_{s,t}$  actually depends on , , and t s. Then we pass to the momentum representation:

where N is the total number of the unit cells. (Here and on, operators in the momentum representation are marked with tilde.) Note that  $a_{q}^{y} = a_{q}$ , and  $a_{p}$ ,  $a_{q}^{y} + a_{q}^{y}$ ,  $a_{p}$ ,  $= p_{q}$ . The spectrum "(q) is given by the eigenvalues of the matrix if (q). One may call it a \double spectrum "because of its redundancy: "(q) = "(q). The \single spectrum " can be obtained by taking only positive eigenvalues (if none of the eigenvalues is zero).

W e now apply this procedure to the concrete H am iltonian

where  $n_1 = (\frac{1}{2}; \frac{p}{2}; \frac{q}{2})$ ,  $n_2 = (\frac{1}{2}; \frac{p}{2}; \frac{q}{2})$  in the standard xy-coordinates.

An important property of the spectrum is whether it is gapless, i.e., whether "(q) is zero for some q. The equation  $J_x e^{i(q;n_1)} + J_y e^{i(q;n_2)} + J_z = 0$  has solutions if and only if  $jJ_x j_y j_y j_z$  jsatisfy the triangle inequalities:




Figure 5: Phase diagram of the model. The triangle is the section of the positive octant  $(J_x; J_y; J_z > 0)$  by the plane  $J_x + J_y + J_z = 1$ . The diagram s for the other octants are sim ilar.

If the inequalities are strict (< " instead of 6 "), there are exactly 2 solutions: q = q. The region de ned by inequalities (33) is marked by B in Fig. 5; this phase is gapless. The


gapped phases,  $A_x$ ,  $A_y$ , and  $A_z$ , are algebraically distinct, though related to each other by rotational symmetry. They dier in the way lattice translations act on anyonic states (see Section 5.2). Therefore a continuous transition from one gapped phase to another is in possible, even if we introduce new terms in the H am iltonian. On the other hand, the 8 copies of each phase (corresponding to di erent sign combinations of  $J_x$ ,  $J_y$ ,  $J_z$ ) have the same translational properties. It is unknown whether the 8 copies of the gapless phase are algebraically di erent.

We now consider the zeros of the spectrum that exist in the gapless phase. The momentum q is dened modulo the reciprocal lattice, i.e., it belongs to a torus. We represent the momentum space by the parallelogram spanned by  $(q_1;q_2)$  the basis dual to  $(n_1;n_2)$ . In the symmetric case  $(J_x = J_y = J_z)$  the zeros of the spectrum are given by

If  $jJ_x j$  and  $jJ_y j$  decrease while  $jJ_z j$  remains constant, q and q move toward each other (within the parallelogram) until they fuse and disappear. This happens when  $jJ_x j + jJ_y j = jJ_z j$ . The points q and q can also e ectively fuse at opposite sides of the parallelogram. (Note that the equation q = q has three nonzero solutions on the torus).

At the points q the spectrum has conic singularities (assuming that  $q \in q$ ):



# 5 Properties of the gapped phases

In a gapped phase, spin correlations decay exponentially with distance, therefore spatially separated quasiparticles cannot interact directly. That is, a small displacement or another boal action on one particle does not in uence the other. However, the particles can interact topologically if they move around each other. This phenomenon is described by braiding rules. (We refer to braids that are formed by particle worklines in the 3-dimensional space-time.) In our case the particles are vortices and fermions. When a fermion moves around a vortex, the overall quantum state is multiplied by 1. As mentioned in the introduction, such particles (with braiding characterized simply by phase factors) are called Abelian anyons.

The description of anyons begins with identifying superselection sectors, i.e., excitation types de ned up to local operations. (An \excitation" is assumed to be localized in space, but it may have uncertain energy or be composed of several unbound particles.) The trivial superselection sector is that of the vacuum; it also contains all excitations that can be obtained from the vacuum by the action of local operators.

At rst sight, each gapped phase in our model has three superselection sectors: a ferm ion, a vortex and the vacuum. However, we will see that there are actually two types of vortices that live on di erent subsets of plaquettes. They have the same energy and other physical characteristics, yet they belong to di erent superselection sectors: to transform one type of vortex into the other one has to create or annihilate a ferm ion.

To understand the particle types and other algebraic properties of the gapped phases, we will map our model to an already known one [24]. Let us focus on the phase  $A_z$ , which occurs when  $jJ_x j+ jJ_y j < jJ_z j$ . Since we are only interested in discrete characteristics of the phase, we may set  $jJ_x j$ ,  $jJ_y j = jJ_z$  and apply the perturbation theory.

## 5.1 Perturbation theory study

The H am iltonian is  $H = H_0 + V$ , where  $H_0$  is the main part and V is the perturbation:

Let us assume that  $J_z > 0$  (the opposite case is studied analogously).




Figure 6: Reduction of the model. Strong links in the original model (a) become e ective spins (b), which are associated with the links of a new lattice (c).

We rst set  $J_x = J_y = 0$  and nd the ground state. It is highly degenerate: each two spins connected by a z-link are aligned ("" or ##), but their common direction is not xed. We regard each such pair as an elective spin. The transition from physical spins to elective spins is shown in Fig. 6a,b. The ground state energy is  $E_0 = N J_z$ , where N is the number of unit cells, i.e., half the number of spins.

Our goal is to nd an elective H am iltonian that would act in the space of elective spins  $L_e$ . One way to solve the problem is to choose a basis in  $L_e$  and compute the matrix elements

However, we will use the more general G reen function form alism .

m = #. The eigenvalues of the \e ective H am iltonian" (if one exists) are supposed to be the energy levels of H that originate from ground states of H<sub>0</sub>. These levels can be unam biguously de ned as poles of the G reen function G (E) =  ${}^{y}$  (E H)<sup>1</sup>, which is an operator acting on L<sub>e</sub> and depending on the parameter E. The G reen function is conventionally expressed as E E<sub>0</sub> (E)  ${}^{1}$ , where (E) is called self-energy, so the energy levels in question are the values of E for which the operator E E<sub>0</sub> (E) is degenerate. Neglecting the the dependence of (E) on E (for E E<sub>0</sub>), we denote the elective H am iltonian as H<sub>e</sub> = E<sub>0</sub> + (E<sub>0</sub>).

The self-energy is computed by the standard method. Let  $G_0^0(E) = (E - H_0)^{1-0}$  be the unperturbed G reen function for exited states of  $H_0$ . The <sup>0</sup> sign indicates that the operator  $(E - H_0)^{1-0}$  acts on excited states in the natural way but vanishes on ground states. Then

We set  $E = E_0$  and compute  $H_e = E_0 + in$  the zeroth order ( $H_e^{(0)} = E_0$ ), rst order, second order, and on, until we nd a nonconstant term.<sup>2</sup> The calculation follows.

#### 5.2 Abelian anyons

Ham iltonian (37) already lends itself to direct analysis. However, let us not reduce it to the more familiar form (3). We construct a new lattice <sup>0</sup> so that the elective spins lie on its links (see Fig. 6c). This is a sublattice of index 2 in the original lattice (here \lattice" means \translational group"). The basis vectors of <sup>0</sup> are  $m_1 = n_1$   $n_2$  and  $m_2 = n_1 + n_2$ . The plaquettes of the elective spin lattice become plaquettes and vertices of the new lattice, so the Ham iltonian can be written as follows:

where  $A_s$  and  $B_p$  are de ned in Eq. (3). (Caution: transform ation (38) breaks the translational sym m etry of the original m odel.)

The last H am iltonian has been studied in detail [24]. Its key properties are that all the term  $s A_s$ ,  $B_p$  commute, and that the ground state m in in izes each term separately. Thus the ground state satisfies these conditions:

Excited states can be obtained by replacing the + sign to a sign for a few vertices and plaquettes. Those vertices and plaquettes are the locations of anyons. We call them \electric charges" and \m agnetic vortices", or e-particles and m -particles, respectively. W hen an e-particle m oves around a m -particle, the overall state of the system is multiplied by 1. This property is stable with respect to sm all local perturbations of the H am iltonian. (A local operator is a sum of term s each of which acts on a sm all num ber of neighboring spins.) It is also a robust property that the num ber of particles of each type is conserved m odulo 2.

The model has 4 superselection sectors: 1 (the vacuum), e, m, and " = e m. The latter expression denotes a composite object consisting of an \electric charge" and a \m agnetic vortex". These are the fusion rules:

(In general, fusion rules must be supplemented by associativity relations, or 6j-symbols, but they are trivial in our case.)

Let us discuss the braiding rules. One special case has been m entioned: m oving an e-particle around an m -particle yields 1. This fact can be represented pictorially:

It is easy to show that e-particles are bosons with respect to them selves (though they clearly do not behave like bosons with respect to m-particles); m-particles are also bosons. However "-particles are ferm ions. To see this, consider two processes. In the rst process two ""-pairs are created, two of the four "-objects are exchanged by a 180 counterclockwise rotation, then the pairs are annihilated. (Each "-object is represented by e and m, so there are 8 elementary particles involved.) In the second process the two pairs are annihilated immediately. It does not matter how exactly we create and annihilate the pairs, but we should do it the same way in both cases. For example, we may use this de nition:

Now we compare the two processes. Each one e ects the multiplication of the ground state by a number, but the two numbers dier by 1:

Indeed, in the left diagram the dashed line is linked with the solid line. This corresponds to an e-particle going around an m particle, which yields the minus sign.




Figure 7: Weak breaking of the translational symmetry: e-vortices and m-vortices live on alternating rows of hexagons.

Braiding an "-particle with an e-orm -particle also gives 1. This completes the description of braiding rules.

It remains to interpret these properties in terms of vortices and fermions in the original model. Tracing sites and plaquettes of the reduced model (3) back to the original model, we conclude that e-particles and m-particles are vortices that live on alternating rows of hexagons, see Fig. 7. Note that the two types of vortices have the same energy and other physical properties, yet they cannot be transformed one to another without creating or absorbing a fermion. A general view on this kind of phenomenon is given in Appendix F.

The ferm ions in the original model belong to the superselection sector ", although they are not composed of e and m. In the perturbation-theoretic lim it, the energy of a ferm ion is about  $2jJ_z jw$  hereas an em-pair has energy  $4J_e = jJ_z j$ . The ferm ions are stable due to the conservation of W<sub>p</sub> (and also due to the conservation of energy). However, they will decay into e and m if we let the spins interact with a zero-tem perature bath, i.e., another system that can absorb the energy released in the decay.

# 6 Phase B acquires a gap in the presence of m agnetic eld

# 6.1 The conic singularity and the tim e-reversal sym m etry

Phase B (cf. Fig. 5) carries gapped vortices and gapless fem ions. Note that vortices in this phase do not have well-de ned statistics, i.e., the e ect of transporting one vortex around the other depends on details of the process. Indeed, a pair of vortices separated by distance L is strongly coupled to fem ionic modes near the singularity of the spectrum, jq qj  $L^1$ . This coupling results in e ective interaction between the vortices that is proportional to "(q)  $L^1$  and oscillates with characteristic wavevector 2q. W hen one vortex moves around the other, the quantum state picks up a nonuniversal phase '  $L^1t$ , where t is the duration of the process. Since the vortex velocity v = L = t must be small to ensure adiabaticity (or, at least, to prevent the em ission of ferm ionic pairs), the nonuniversal phase ' is always large.

The conic singularity in the spectrum is, in fact, a robust feature that is related to timereversal symmetry. As discussed in the end of Section 2, this symmetry is not broken by xing the gauge sector (i.e., the variables  $w_p$ ) since the honeycomb lattice is bipartite. Let us show that a sm all perturbation commuting with the time-reversal operator T can not open a spectral gap.

We may perform the perturbation theory expansion relative to the gauge sector of the ground state (i.e., any term that changes the eld con guration is taken into account in the second and higher orders). This procedure yields an elective Ham illonian which acts in the xed gauge sector and therefore can be represented in terms of  $c_j$  and  $\hat{u}_{jk}$ . The operator T de ned by (17) changes the sign of  $\hat{u}_{jk} = ib_j^{jk} b_k^{jk}$ , but this change can be compensated by a gauge transform ation. Thus we get a physically equivalent operator T<sup>0</sup> such that

A T<sup>0</sup>-invariant perturbation to the ferm ionic H am iltonian (31) (corresponding to a xed gauge) can not contain terms like  $ic_jq_k$ , where j and k belong to the same sublattice. Thus the perturbed m atrix  $\hat{R}(q)$  in Eq. (32) still has zeros on the diagonal, though the exact form of the function f (q) m ay be di erent. However, a zero of a com plex-valued function in two real variables is a topological feature, therefore it survives the perturbation.

## 6.2 Derivation of an e ective H am iltonian

W hat if the perturbation does not respect the tim e-reversal sym m etry? W e will now show that the sim plest perturbation of this kind,

does open a spectral gap. (Physically, the vector  $h = (h_x; h_y; h_z)$  is an external magnetic eld acting on all spins.) For simplicity we will assume that  $J_x = J_y = J_z = J$ .

Let us use the perturbation theory to construct an elective H am iltonian H  $_{\rm e}$  acting on the vortex-free sector. One can easily see that H  $_{\rm e}^{(1)}$  = 0. A lthough the second-order term H  $_{\rm e}^{(2)}$  does not vanish, it preserves the time-reversal symmetry. Therefore we must consider the third-order term, which can be written as follows:

where  $_{0}$  is the projector onto the vortex-free sector, and  $G_{0}^{0}$  is the unperturbed G reen function with the vortex-free sector excluded. In principle<sub>R</sub> the G reen function can be computed for each gauge sector using the form ula  $G_{0}(E) = i_{0}^{1} e^{i(E - H_{0} + i)t} dt$  (where is an in nitely small number). For xed values of the eld variables  $u_{jk}$  the unperturbed H am iltonian m ay be represented in the form (18) and exponentiated in plicitly by exponentiating the corresponding m atrix A; the nalresult m ay be written as a norm al-ordered expansion up to the second order. However, it is a rather di cult calculation, so we will use a qualitative argum ent instead.


Let us assume that all intermediate states involved in the calculation have energy E jJj above the ground state. (A ctually, E 0.27jJj for the lowest energy state with two adjacent vortices, see Appendix A.) Then  $G_0^0(E_0)$  can be replaced by  $(1 _0)=jJj$ . The elective Ham iltonian becomes

Here (-) is just another notation for  $u^{std}$ , i.e., the matrix whose entry  $(-)_{jk}$  is equal to 1 if there is a solid arrow from k to j in the gure, 1 if an arrow goes from j to k, and 0 otherwise. (--) is de ned similarly.

### 6.3 The spectrum and the Chern number

The ferm ionic spectrum "(q) of the H am iltonian (48) is given by the eigenvalues of a m odi ed matrix  $i\mathcal{R}$ (q) (cf. Eq. (32)):

which determ ines the energy gap. The conic singularities are resolved as follows:

R em ark 6.1. The magnetic eld also gives nontrivial dispersion to vortices. Indeed, the operators W  $_{\rm p}$  are no longer conserved, therefore a vortex can hop to an adjacent hexagon. Thus the vortex energy depends on the momentum. This e ect is linear in h, but it is not so important as the change in the ferm ionic spectrum.

Let us also nd the ferm ionic spectral projector, which determ ines the ground state. The global spectral projector P is de ned by Eq. (27); we now consider its Fourier component:

The function m maps the torus to the unit sphere. If > 0, then this map has degree 1. Indeed, the neighborhood of q is mapped onto the lower hem isphere, the neighborhood of q is mapped onto the upper hem isphere; in both cases the orientation is preserved. (The rest of the torus is mapped onto the equator.) For negative the map has degree 1.

An important topological quantity characterizing a two-dimensional system of noninteracting (or weakly interacting) ferm ions with an energy gap is the spectral Chern number. It plays a central role in the theory of the integer quantum Halle ect [43, 44, 1]. In our model there is no analogue of Hall conductivity (because the number of ferm ions is not conserved), but the Chern number determ ines the edge mode chirality and anyonic properties of vortices (cf. [48]).

The spectral Chem number is de ned as follows. For each value of the momentum q we consider the space  $\hat{E}(q)$  of annihilation operators, i.e., ferm ionic modes with negative energy; this is the subspace the matrix  $\hat{F}(q)$  projects onto. Thus we obtain a complex vector bundle over the momentum space. (In our case  $\hat{E}(q)$  is a one-dimensional subspace of  $C^2$ , so the bundle is one-dimensional.) The rst Chem number of this bundle is denoted by and can be expressed as follows (cf. [44]):

We will use the notation B (where = 1) to designate phase B in the magnetic eld. In the Abelian phases  $A_x$ ,  $A_y$ ,  $A_z$  the Chern number is zero.

# 7 Edge modes and therm altransport




Figure 8: Chiral edge modes: left-moving (a) and right-moving (b).

R em arkably, any system with nonzero C hem num ber possesses gapless edge m odes. Such m odes were rst discovered in the integer quantum H alle ect [51]; they are chiral, i.e., propagate only in one direction (see Fig. 8). In fact, left-m oving and right-m oving m odes m ay coexist, but the follow ing relation holds [52]:

In the absence of special symmetry, counterpropagating modes usually cancel each other, so the surviving modes have the same chirality. A calculation of the edge spectrum in phases B (for some special coundary conditions) and a simple proof of Eq. (56) are given in Appendix B. More rigorous and general results, which even apply to disordered systems, can be found in Refs. [53, 54].

It is important to note that the analogy to the quantum Halle ect is not exact. In our model (like in two-dimensional super uid and superconducting systems [55, 48]) edge modes are described by real fermions, as contrasted to complex fermions in the quantum Halle ect. Therefore each quantum Hallmode is equivalent to two modes in our system.

Chiral edge modes can carry energy, leading to potentially measurable therm al transport. (The temperature T is assumed to be much smaller than the energy gap in the bulk, so that the e ect of bulk excitations is negligible.) For quantum Hall systems, this phenomenon was discussed in Refs. [56, 57]. The energy current along the edge in the left (counterclockwise) direction is given by the following formula:

where c is some realnum ber. (The factor =12 is introduced to make a connection to conform all eld theory, see below.) It is remarkable that c does not depend on particular conditions at the edge, but rather on the bulk state. Indeed, the energy current is conserved, therefore it remains constant even if some conditions change along the edge. The e ect is invariant with respect to time rescaling. Since the energy current has dimension (time)<sup>2</sup>, it must be proportional to  $T^2$ . But the value of the dimensionless proportionality coe cient cannot be found using such simple arguments.

There are two standard ways to calculate the coe cient c . They both rely on certain assumptions but can be applied to our model, yielding this result:

The rst argument [58] (adapted to real fermions) assumes translational invariance and the absence of interaction. Each edge mode is described by a free ferm ion with an energy spectrum "(q) such that "(q) = "(q) and "(q) ! 1 as q ! 1. The signs in the last two expressions agree if the mode propagates in the direction of positive q (for simplicity we may assume that "(q) > 0 when q is positive and "(q) < 0 when q is negative). Thus the Ham iltonian has the form

If "(q) > 0, then  $a_q$  is an annihilation operator and  $a_q = a_q^y$  is the corresponding creation operator. The mode propagates with group velocity v(q) = d"=dq, and the occupation number n(q) is given by the Ferm i distribution. The energy ow due to each mode propagating in the positive direction can be calculated as follow s:

Each mode propagating in the opposite direction contributes I, therefore  $I = \frac{1}{24} T^2$ .

The second derivation [57] is based on the assumption that the edge modes can be described by a conformal eld theory (CFT). In this case,

where c and c are the V irasoro central charges. Thus, c is called the chiral central charge. Leftm oving ferm ions have  $(c; \bar{c}) = \frac{1}{2}; 0$  whereas right-m oving ferm ions have  $(c; \bar{c}) = 0; \frac{1}{2}$ , which implies Eq. (58). More generally, c and c are some rational numbers, and so is c. The chiral central charge parametrizes a two-dimensional gravitational anomaly [59] of the corresponding CFT; it can also be identied with the coeccient in front of the gravitational Chern-Sim ons action in a three-dimensional theory [5]. Volovik [60] suggested that for <sup>3</sup>He-A lm s, the role of gravitational eld is played by the order parameter interacting with ferm ions. However, it is not obvious how to de ne a \gravitational eld" for lattice models.

It remains a bit mysterious how the chiral central charge is related to the ground state and spin correlators in the bulk. This question is partially answered in Appendix D, but the obtained expression for c is not easy to use, nor can we demonstrate that c is rational. Note that there is a beautiful relation between the chiral central charge and algebraic properties of anyons [7, 61], which does in ply the rationality of c . We discuss that relation in Appendix E (see Eq. (172) on page 66), though it is unclear how to deduce it only considering the bulk. The only known argument is to assume that edge modes are described by a CFT, then one can use modular invariance [62]. In fact, the modular invariance alone would su ce. In Appendix D we try to derive it from general principles, but again, encounter a problem.

# 8 Non-Abelian anyons

We continue the study of phase B in the magnetic eld. Now that all bulk excitations are gapped, their braiding rules must be well-de ned. Of course, this is only true if the particles are separated by distances that are much larger than the correlation length associated with the spectrum (51). The correlation length may be de ned as follows:  $= jIm qj^1$ , where q is a complex solution to the equation "(q) = 0. Thus

The braiding rules for vortices depend on the spectral Chem number . Although is actually equal to +1 or 1 (depending on the direction of the magnetic eld), one may form ally consider a model with an arbitrary gapped fermionic spectrum, in which case may take any




Figure 9: The space-time coordinates (a) and particle worldlines (b).

integer value. We will see that vortices behave as non-Abelian anyons for any odd value of  $\,$ , but their exact statistics depends on  $\,$  m od 16.

The properties of the anyons are summarized in Table 1 on page 30. The notation and underlying concepts are explained below; see also Appendix E. Let us is show a quick way of deriving those properties from conformal led theory (CFT) in the most important case, = 1. (For a general reference on CFT, see §3].) Then we will give an alternative derivation, which uses only rudimentary CFT and refers to the operational meaning of braiding and fusion.

## 8.1 Bulk-edge correspondence

The properties listed in Table 1 form the same type of algebraic structure that was described by M oore and Seiberg [4] in the CFT context. However, the actual connection to CFT is indirect: anyons are related to edge m odes, which in turn can be described by a eld theory in 1 + 1 dimensions. M ore concretely, the space-time m ay be represented as a cylinder (see Fig. 9). It is convenient to use the imaginary time form alism (t = i, where 2 R), so that we have a two-dimensional Euclidean eld theory on the side surface of the cylinder. The surface m ay be parametrized by a complex variable z = + ix, where x is the spatial coordinate.

The two-dimensional eld theory describes the physics of the edge, which is generally richer than that of the bulk. The theory possesses both local and nonlocal elds. The insertion of a nonlocal eld ( + ix) corresponds to an anyonic particle en erging on the edge or sinking into the bulk at point ( ;x). The correlation function of several nonlocal elds has nontrivial m onodrom y which coincides with the anyonic braiding. Speci cally, the counterclockwise exchange of anyons in the bulk is equivalent to m oving the elds counterclockwise on surface (if we look at the cylinder from outside). M oreover, the value of the correlator is not a num ber, but rather an operator transform ing the initial anyonic state (on the bottom of the cylinder) into the nalone (on the top of the cylinder). For non-Abelian anyons, the space of such operators is multidim ensional.

The anyon-CFT correspondence has been successfully used in the study of quantum Hall systems [14, 15, 31]. The correspondence is well-understood if all boundary elds are either holom orphic or antiholom orphic, which is the case for our model. We have seen that the edge carries a left-moving (holom orphic) ferm ion for = 1, or a right-moving (antiholom orphic)




Table 1: A lgebraic properties of anyons in non-A belian phases ( is odd).

ferm ion for = 1. A vortex emerging on the surface corresponds to a twist eld . The correlation functions for such elds are given by holom orphic (resp. antiholom orphic) conform al blocks for the Ising m odel.

A partial bulk-edge correspondence can be established at a more elementary level. Let = 1. A particularly important parameter of the edge theory is the conform alweight of the twist eld, (h; $\overline{h}$ ) =  $\frac{1}{16}$ ;0. The related bulk parameter is the topological spin of a vortex, ; it corresponds to the counterclockwise rotation by angle 2. Since the rotations in the bulk

and on the surface must agree, the following equation holds for an arbitrary eld a:

In the general case, there are j j = 2n + 1 species of the free ferm ion; the twist eld also comes with some multiplicity.<sup>3</sup> One may argue that the conform alweight of the twist eld is proportional to the number of ferm ionic species. #### 8.2 Unpaired M ajorana m odes

We now begin a rather lengthy derivation of the properties listed in Table 1, dealing only with anyons in the bulk. First, we give a crude description of vortices by M a jorana operators and nd the fusion rules. The braiding rules and so-called associativity relations (also known as crossing symmetry, or 6j-symbols) are determined up to several free parameters; we discuss what combinations of these parameters have invariant meaning. Solving the so-called pentagon and hexagon equations, we reduce the continuum of possibilities down to eight consistent theories. The right theory is selected using Eq. (62).

The starting point is this: if is odd, then each vortex carries an unpaired M ajorana m ode. A su ciently rigorous proof of this statem ent can be found in Appendix C. Here we give a rough explanation based on the quantum H all analogy.

It is known that the quantized Hall conductivity for noninteracting electrons (in units of  $e^2=h$ ) is equal to the Chern number of the projector onto the occupied electron states [44]. The essential di erence from our case is that electrons are ordinary ferm ions, not M a jorana ferm ions. However, we can concoct an analogue of an electron system from two copies of the M a jorana system, which may be pictured as two layers. The Ham iltonian is as follows:

(We forget about the original spin model for the purpose of this construction.) Note that the Ham iltonian possesses a global O (2) sym metry that consists of orthogonal linear transformations  $c_j^0$  7  $c_j^0 + c_j^0$ ,  $c_j^0$  7  $c_j^0 + c_j^0$ . The rotational subgroup U (1) = SO (2) O (2) corresponds to the conservation of electric charge, whereas relations (i.e., transformations with determinant 1) change the sign of the charge.

A ssum ing that the Ferm i energy is zero, the projector onto the occupied electron states coincides with the spectral projector for the M a prana system . Thus the H all conductivity of the electron system is  $\$ .

A vortex piercing both M a jorana layers corresponds to half-integer magnetic ux. Such a vortex carries excessive charge q = -2 + n, where n is an arbitrary integer. In particular, if

is odd, a state with q = 1=2 exist. By an O (2) re ection, it is related to a q = 1=2 state with the same energy. The doublet of states with unit charge di erence m ay be attributed to a zero-energy electron m ode that can be empty or occupied. This m ode can be represented by two M a jorana m odes. Since the layers are independent, we conclude that each layer contains one zero-energy M a jorana m ode.

It has been previously shown that zero-energy M a prana modes exist in some exotic onedimensional systems [64] as well as vortices in two-dimensional p-wave superconductors [48, 65]. A pair of M a prana modes at two vortices constitutes a full fermionic mode with a twodimensional Fock space. The quantum state of such a pair is virtually inaccessible to measurements or perturbations as long as the vortices stay far apart from each other. A system of 2n vortices possesses a protected space of dimensionality  $2^n$  (or  $2^{n-1}$ , if we require that the whole system have even fermionic parity).

#### 8.3 Fusion and braiding rules

...

In our model a vortex carrying an unpaired M a jorana mode is just one of the superselection sectors, denoted by . The other sectors are 1 (the vacuum) and " (a ferm ion). If two vortices fuse, they either annihilate completely or leave a ferm ion behind: = 1 + ". The actual fusion outcome depends on the initial quantum state. Hence the protected space of the vortex pair has two basis vectors:  $j_1$  i and  $j_r$  i. (The upper indices indicate the particle types before the fusion whereas the subscript indicates the resulting particle.) The complete set of fusion rules is as follows:

plus trivial rules of the form 1 = x. Read backwards, these relations are understood as splitting rules: for example, an "-particle can split into two -particles. However, these rules do not capture more subtle aspects of fusion and splitting, which will be discussed later.

B raiding rules for M a jorana half-vortices in a spin-triplet superconductor have been derived by D. Ivanov [65]. Here we follow the main idea of Ivanov's work. We should, however, keep in mind one in portant dierence between his setting and ourm odel. A spin-triplet superconductor has a locally measurable vector order parameter, which contributes to vortex-vortex interaction and can interact with in purities. One vortex making a full turn around another may pick up a nonuniversal phase, hence the non-A belian statistics is de ned up to arbitrary phase factors. That is not the case for ourm odel (or for spinless superconductors [48]), so additional arguments are required to not the Abelian part of the vortex statistics.


Once again, we use the fact that each vortex p carries an unpaired M a jorana mode  $C_p$ , which is a linear combination of the operators  $c_j$  on neighboring sites. The operators  $c_j$  do not commute with gauge transform ations and therefore should be used with care. The gauge can be xed in a neighborhood of each vortex, so constructing the linear combination is not a problem. However, the overall sign of  $C_p$  does not have invariant meaning. This ambiguity

is avoided if we consider ferm ionic path operators (16), which are gauge-invariant. A suitable linear combination of elementary paths constitutes a path that begins or ends at a vortex.

Let us choose some reference path  $l_p$  connecting each vortex p = 1;2::: to a reference point 0. W e will assume that the vortices lie on the horizontal axis whereas the reference point 0 is located in the lower half-plane. Fixing the gauge along the paths, we may write

Let us exchange vortices 1 and 2 by moving them counterclockwise. The exchange process is described by a unitary operator R acting on the physical Hilbert space. It also acts on operators by conjugation: X 7 RX R<sup>Y</sup>. C learly,



(W e have used the fact that W  $(l_2^0) = W$  (1). Indeed, the paths  $l_2^0$  and  $l_1$  di er by a loop enclosing a vortex; transporting a ferm ion around the vortex gives rise to the m inus sign.) Hence

where is a phase factor. (We will see that is actually the topological spin of a vortex; for now it is just an unknown parameter).

At rst sight, it is not clear whether the number has an invariant meaning. Indeed, the operator that moves a vortex along a given path may be dened up to an arbitrary phase. However, the ambiguity can be avoided by a careful denition of the particle exchange process. The following argument is completely general; it is not based on adiabaticity or translational invariance.

Let us consider a vortex path operator W (1) that is composed of elementary steps, i.e., displacements of the vortex from hexagon to hexagon.<sup>4</sup> Each elementary displacement is dened up to a phase, but the path operator satisfies these equations:

Here l denotes the reverse path, whereas  $l_1 l_2$  is the composite path (the vortex goes along  $l_1$  and then along  $l_2$ ). Remarkably, two vortices can be exchanged in such a way that the arbitrary phases cancel each other, see Fig. 10. The vortices move along the indicated lines; each line segment is passed by a vortex in both directions.

As mentioned above, the vortex pair has two states corresponding to the possible fusion outcomes,  $j_1$  i and  $j_*$  i. They should be identied with the eigenvectors of  $C_1C_2$ , but we do not know which is which. We can only write:

where = 1 is unknown. Thus the braiding operator R acts as follows:

R em ark 8.1. One may wonder why form ula (67) contains the m inus sign in front of  $C_1$ , but not in front of  $C_2$ . This is, in fact, a consequence of the convention that the reference point 0 lies in the lower half-plane. If we move it to the upper half-plane, the signs will change, will turn into , and the signs in front of in Eq. (70) will change too. The num bers  $R_1$ ,  $R_m$ and are invariant though.

## 8.4 A ssociativity relations

The fusion rules only indicate what fusion and splitting events are possible. Nontrivial relations arise if we consider a sequence of such events.

8.4.1 Relations based on the anticommutativity of ferm ionic operators. Let us consider the splitting of a -particle into ", , and ". This can be done in two di erent ways, depending on the order the two "-particles are created. Let us suppose that the -particle is located at point 2 in the middle; the "-particles will appear at points 1 and 3 on the left and on the right, respectively. The particles (or their future locations) are connected by the paths  $l_{12}$  and  $l_{23}$ .

The -particle is described by the associated M a prana mode  $C_2$ . The "-particles can be created from the vacuum by operators  $a_1^y$  and  $a_3^y$ . However, these operators are not physical by them selves. To actually split the nst "-particle o the -particle, one needs to apply a ferm ionic path operator  $W(l_{12})$ , which equals  $a_1^yC_2$  in a suitable gauge. The second "-particle is created by the operator  $W(l_{23}) = a_3^yC_2$ . Since  $W(l_{12})W(l_{23}) = W(l_{13})W(l_{12})$ , we obtain the following associativity relation between the two splitting processes:

Similarly, we can consider the splitting of one "-particle into three. For this, we use two conventions:<sup>5</sup> (i) moving an "-particle from place j to place k is described by the operator  $a_k^y a_j$ ;

(ii) creating a ferm ionic pair from the vacuum is described by  $a_j^y a_k^y$ , where j is located left of k. Thus we get:

because  $(a_1^y a_2^y)(a_3^y a_2) = (a_2^y a_3^y)(a_1^y a_2)$ . (In these graphs the \up" direction is time. The intermediate state of the middle particle is shown in all cases, but lines corresponding to label 1, i.e., the vacuum superselection sector, are suppressed.)

8.4.2 Some generalities. The analysis of other splitting processes (e.g., ! ) is more complicated. Ideally, we would use the vortex path operator, but its exact form is unknown. Therefore we have to rely on more abstract arguments. Before we proceed, let us clarify some points pertaining to anyons in general.

- Speaking about anyons, we are interested in particle types (i.e., superselection sectors) and topology of the particle worldlines (braids, trees, etc.). An actual particle is also characterized by position and local degrees of freedom; for example, an "-particle m ay be \elementary" or consist of two adjacent vortices. We generally ignore such details though.
- 2. In the study of splitting and fusion, we consider particles located on the horizontal axis. In this case, we only care about the order of the particles on the line, but not about their positions. All con gurations with the same particle types and order can be identied with each other. Unlike in the two-dimensional case, cycling through several con gurations has triviale ect on the quantum state.<sup>6</sup>
- 3. \Q uantum state of a particle" is a rather subtle notion. It may be understood as a projector that enforces certain spin correlations in some neighborhood of the supposed particle location. (The neighborhood radius must be much larger than the correlation length). Such an object has no \overall phase". Superpositions of states from di erent superselection sectors cannot be constructed either.
- 4. In spite of that, the state  $j_1$  i has a well-de ned phase if we consider it relative to the vacuum . A similar argument holds for an arbitrary state  $j_z^{xy}i$ , which describes particles x and y with total \anyonic charge" z. For a general anyonic system, the xy-pairm ay have several distinct states that belongs to the same superselection sector z; in other words, there m ay be several ways to split z into x and y. Such states form a nite-dimensional H ilbert space  $V_z^{xy}$ , which is called fusion space.<sup>7</sup> In our model, all such spaces have dimension one or zero. For example,  $j_1$  i is a unit vector in the one-dimensional space  $V_1$ .

To move a particle z from one place to another, we apply a path operator  $W_z$  (r; r<sup>0</sup>), which acts on the spins in some neighborhood of the interval [r; r<sup>0</sup>]. These operators are defined in such a way that it does not matter whether the particle is moved at once or in several steps (cf. Eq. (68)). When several particles are present, we do not let them pass through each other, which imposes a certain restriction on the sequence of operators applied. All such sequences are actually equivalent since the path operators for nonoverlapping intervals commute.

For a more rigorous de nition of the space  $V_z^{xy}$ , consider the splitting of z into x and y by an operator L that acts on the spins in some xed nite region . (We call such operators local.) Let us also x a quantum state j<sub>z</sub> i that has a z-particle at a given place and no other particles in or within the correlation length from . Finally, we consider the set of local operators L for which the state L j<sub>z</sub> i has an x-particle and an y-particle at the required places. By de nition, these are all possible states of the xy-pair that can be obtained from z. On the other hand, such states are in one-to-one correspondence with equivalence classes of operators L : we say that L and L<sup>0</sup> are equivalent if L j<sub>z</sub> i = L<sup>0</sup> j<sub>z</sub> i. For local operators, the equivalence relation does not depend on the choice of j<sub>z</sub> i. Thus we arrive at the follow ing de nition:

Each vertex in a splitting graph (as in Eqs. (71), (72) above) designates an equivalence class of local operators. For example,  $\int_{\sigma}^{\sigma} = j " i 2 V "$ . To illustrate the physicalm eaning of the structural parameters, let us return to the gedanken experiment considered in the introduction. Suppose we create two pairs of -particles from the vacuum. Then we take one particle from each pair and fuse them. W ith probability  $j_{a_{11}} j$  they will annihilate, and with probability  $j_{a_{11}} j$  they will fuse into an "-particle. (W e will see that  $j_{a_{11}} j = j_{a_{11}} j = 1=2$ .)


## 8.5 Algebraic consistency

All the previous arguments were based on the result that vortices carry unpaired M a prana modes. Not surprisingly, this property alone is not su cient to fully characterize the fusion and braiding of anyons. We now invoke some additional principles. The rst one is consistency: successive fusion and braiding events must commute with each other in certain cases. A more careful statement of this requirement amounts to the formulation of an algebraic theory of anyons.


A nyons may be described in the fram ework of topological quantum eld theory (TQFT), which originates from W itten's paper on quantum Chem-Simons elds [5] and the work of M oore and Seiberg on conform al eld theory [4]. Important m athem atical studies in this area were done by Reshetikhin and Turaev [66] and W alker [67]. For our purposes, it su ces to use a construction called unitary modular category (UMC), which constitutes the algebraic core of TQFT [68]. This construction will be outlined in Appendix E. A ctually, the full theory is not necessary to understand the calculations below. On the contrary, one may use these calculations to motivate some of the UMC axiom s.

One of the axiom s is known as the pentagon equation, see Fig. 17a on page 69. It deals with the veways to split a particle u into x, y, z, w, or verepresentation of the space  $V_u^{xyzw}$ . The arrows in the gure may be regarded as equality signs, therefore the diagram must commute. For example, consider the splitting process ! " via intermediate states q = 1 and p =.

The upper path across the diagram looks like this:



whereas the lower path is as follows:

O verall, there are 23 spaces  $V_u^{xyzw}$  with nontrivial upper indices. Thus we obtain 23 pentagon equations, 5 of which are satis ed autom atically. The remaining 18 equations in ply the following relations between the structural parameters:

Equations (82(85) have only two solutions satisfying the convention that  $_1 = _2 = _1 = 1$ :

R em ark 8.2. However this symmetry generally involves nontrivial phase factors, so we not the brute-force calculation a safer approach.

Let us now exam ine consistency between fusion and braiding. Braiding is fully characterized by the action of the counterclockwise rotation on fusion spaces:  $\mathbb{R}_z^{xy} : V_z^{xy} : V_z^{yx}$ . Since in our case the spaces  $V_z^{xy}$  and  $V_z^{yx}$  are one-dimensional, the linear map  $\mathbb{R}_z^{xy}$  is given by a single matrix element.<sup>8</sup>

N ontrivial relations arise if we consider the action of braiding operators on the fusion space of three particles. These relations can be expressed by two commutative diagrams called the hexagon equations, see Fig. 20 on page 81. The arrows in those diagrams may be understood as equalities of vectors in the space  $V_u^{yzx}$ . Let us consider the following example of the rst equation (the rst line below corresponds to the upper path across the hexagon, the second to the lower path):




Table 3: Properties of anyons for 2 (m od 4).

## 9 The sixteen-fold way

Let us again consider the theory with  $Z_2$ -vortices and free ferm ions whose spectrum is gapped and characterized by the Chern number . The properties of anyons in this model depend on

m od 16. In the previous section we studied the case of odd ; now we assume that is even. For even , the vortices do not carry unpaired M a prana m odes (see Appendix C), therefore a vortex cannot absorb a ferm ion while remaining in the same superselection sector. Thus, there are actually two types of vortices, which are transformed one to another by adding a ferm ion. Two vortices of the same type m ay either annihilate or fuse into a ferm ion. In the rst case the vortices are denoted by e and m; they obey the fusion rules (41). In the second case, we denote the vortices by a and a; the fusion rules are as follow s:

Both sets of rules are Abelian, i.e., they do not contain \+ " on the right-hand side.

The associativity relations can be found along the same lines as in the non-Abelian case. First, the ferm ions must obey the trivial relation (72). The argument used in the derivation of Eq. (71) remains valid, but we obtain two relations instead of one. Note that they are not invariant individually; for example, the sign in both relations may be changed to + ". Finally, we solve the pentagon equation. The fusion rules with e and m admit two nonequivalent solutions, one of which is trivial; see Table 2. Both solutions are invariant under the transform ation

In the case of a and a, there is only one solution, which doesn't adm it any nontrivial sym m etry; see Table 3.

The braiding rules are found by solving the hexagon equations in conjunction with the requirement that  $R_1'' = 1$  and that transporting a ferm ion around a vortex is described by the multiplication by 1. Then we compute the topological spin of the vortex and identify each solution with a particular value of mod 16. The results are summarized in Tables 2 and 3. (We have eliminated redundant solutions that can be obtained by the transformation (98)).

Let us mention a couple of interesting properties of these Abelian theories. For 8 (m od 16), all three nontrivial particles (e, m, and ") are fermions. For 4 (m od 16), the particles e and m are semions with trivial mutual braiding. (In comparison, the well-known K alm eyer-Laughlin state [69] has one semionic species.)

# 10 Odds and ends

W hat follows are some open questions, as well as thoughts of how the present results can be extended.

- D uan, D em ler, and Lukin [42] proposed an optical lattice im plem entation of the H am iltonian (4). It would be interesting to nd a solid state realization as well. For example, the anisotropic exchange could be simulated by interaction of both lattice spins with a spin-1 atom coupled to a crystal eld.
- 2. The weak translational symmetry breaking in the Abelian phase has some interesting consequences. A particularly unusual phenomenon takes place when the lattice has a dislocation. A particle winding around the dislocation changes its type: e \$ m. Since m = e ", the ferm ionic parity appears not to be conserved. To restore the conservation law, we must assume that the dislocation carries an unpaired M a jorana mode. Therefore, A belian phases can also be used for the implementation of quantum memory.
- 3. Chiralphases ( 60) require that the time-reversal symmetry be broken. In the present model, this is achieved by applying a magnetic eld. However, a spontaneous breaking of time-reversal symmetry occurs in the presence of odd cycles in the lattice. For example, one can replace each vertex of the honeycomb lattice by a triangle. In this case, a gapped
  - = 1 phase is realized without external magnetic eld [0].

- 4. The representation of a spin by four M a jorana ferm ions might be useful for other m odels, even though it does not lead to an exact solution. In particular, one can consider a variational mean-eld state in which c<sub>j</sub> are decoupled from b<sub>j</sub>. It is unclear whether this type of states occur in H eisenberg antiferrom agnets. On the triangular lattice, such a state has larger energy than the 120 N eel-type state. It would be interesting if the form er could be stabilized by additional interactions and quantum uctuations.
- 5. Topological phases with free ferm ions coupled to an elective  $Z_2$  gauge eld have been classified by mod 16. However, this analysis does not include multilayer systems. One can argue that if the interaction between the layers is weak enough, topological particles cannot tunnel between the layers. Thus, each layer is described by one of the 16 theories studied above. In mathematical terms, we have the direct product of several unitary modular categories (UM C s). Strongly interacting layers are roughly described by n ferm ionic species interacting with  $(Z_2)^n$ -vortices, but a complete classification of such phases is yet to be found.
- 6. In addition to the particle classi cation, the chiral central charge c = =2 is an important robust characteristic, though its topological meaning is not so clear. It appears that in multilayer systems the total value of is shared between the layers, i.e., increasing by 16 in one layer while decreasing it in another does make a di erent topological phase. More generally, a topological phase is characterized by a UMC and a real number c satisfying the relation (172). To prove or disprove this statement, a mathematical notion of equivalence between topological phases is necessary. It may be based on local (or quasilocal) isom orphisms between operator algebras.
- 7. A related question is whether the space-time boundary of an arbitrary topological phase can be described by a two-dimensional conformal eld theory (CFT) and when two such theories have the same topological content. Two CFTs may be considered topologically equivalent if there is a consistent theory for a one-dimensional boundary between them. Conjecturally, this is the case if and only if both CFTs have the same chiral central charge c = c \_ c and correspond to the same UMC.
- 8. Another topic to study is Bose-condensation of vortices, which occurs when a vortex energy becomes negative due to some parameter change. The condensation of e-particles in the = 0 phase is equivalent to the connement of m and "-particles. Thus, the topological order is destroyed. In the = 16 system, this process produces a phase without anyons or fermions, but with the chiral central charge c = 8. Under special circum stances, the boundary of this phase is described by the E<sub>8</sub> CFT at level 1, though a generic (nonconform al) perturbation drives it into a state with 8 chiral bosons propagating with di erent velocities.
- 9. The condensation of ""-pairs in two adjacent = 1 layers leads to the binding of singlelayer vortices into pairs, which are equivalent to a or a in the = 2 phase. Thus the direct product of two = 1 theories is related to the = 2 theory. It would be interesting to have a generalm athem atical characterization of such relations. The notion of lax tensor functor (see R em ark E 26 on page 101) can be useful in this regard.

# Appendix A: Numerical results on the stability of the vortex-free phase

The goal of this study is to compare the energy of the vortex-free phase with that of other phases. The case  $J_x = J_y = J_z = 1$  has been investigated most carefully. The energy of the vortex-free phase equals  $E_0$  1:5746 per unit cell (i.e., per two sites, or one hexagon). The actual computation was done for toriwith periodic or antiperiodic boundary conditions in each direction. The vortex-free phase and other periodic phases with small period are computationally very simple, so dealing with large tori is not a problem. However, the energy calculation for an arbitrary vortex con guration requires noting the singular values of an N N m atrix, where N is the number of unit cells. With our setup (MATLAB on a PC) we could handle m atrices of size N 6 2500, which corresponds to system s of linear size  $L = \frac{1}{N} = \frac{1}{6} = 50$ . A though these numbers are pretty large, nite-size e ects are still appreciable due to the gapless nature of the spectrum (see Section 4).




Figure 11: Finite size e ects in the vortex-free phase.

Let us not discuss the nite-size e ects in the vortex-free phase. From now on, we consider the relative energy, i.e., we subtract N E<sub>0</sub> from actual results. The plot in Fig. 11a shows the relative energy as a function of size for symmetric L L tori. The oscillatory behavior with period 3 is due the fact that "(q) vanishes at q = q (see (34)). O nem ay argue that each period r of the torus contributes  $jrj^1 \cos(2(q;r))$  to the total energy (there are in nitely m any such terms since the periods form a lattice). Interestingly enough, these contributions alm ost cancel each other for periodic boundary conditions on the torus with basis (Ln<sub>1</sub>; Ln<sub>2</sub> + n<sub>1</sub>), where n<sub>1</sub> and n<sub>2</sub> are the basis vectors of the lattice (see gure in Eq. (32)). The corresponding plot is shown in Fig. 11b.




Figure 12: Extrapolation to in nite size: 4 equally spaced vortices on the torus with basis  $(2Ln_1; 2(Ln_2 + n_1))$ .

The energy of an isolated vortex is  $E_{vortex}$  0:1536 above the ground state? The calculation was done for toriwith basis  $(Ln_1; Ln_2 + n_1)$  for  $L = 9; \dots; 32$ . (We actually put 4 vortices on the torus of twice this size because the number of vortices must be even). Then the results were extrapolated to L = 1 by thing the curve  $E(L) = E_{vortex} + a_1L^{-1} + a_2L^{-2}$  to the data, separately for L = 3k, L = 3k + 1, and L = 3k + 2 (see Fig. 12).

The energy of a vortex pair is smaller than  $2E_{vortex}$  if the vortices are close to each other: by 0.04 for nearest neighbors and by 0.07 for next-nearest neighbors. (W e didn't try to compensate the nite size e ects, so the precision is poor). These numbers suggest that inter-vortex interaction is rather strong and could, in principle, result in some con gurations having negative energy. However, our further calculations give evidence for the contrary.


We have checked all periodic phases with unit cell containing 1, 2, 3 or 4 hexagons, see Table 4. (As mentioned above, this computation requires much less computer resources than the study of separate vortices or vortex pairs). In all these cases the energy is positive and increases as more vortices are added. The smallest energy per vortex is achieved by phases 1 and 5  $\mid$  0.067 and 0.078, respectively.

A ll14 phases have positive energies (relative to the vortex-free phase) for all nonzero values of  $J_x$ ,  $J_y$ ,  $J_z$ .


# Appendix B: Edge modes in phases B

It is understood that the edge spectrum depends strongly on particular conditions at the edge. The calculations below are only meant to illustrate the universal feature of the spectrum | the existence of a chiral gapless mode.

Let us suppose that the honeycom b lattice lls the lower half-plane and is cut as follows:



Row 0 consists of the M ajorana operators  $b_j^z$ , which would be decoupled from the rest of the system if not for the magnetic eld. Performing the Fourier transform in the horizontal direction, we compute elective couplings between the rows as functions of  $q_x$ :



Let us not not edge modes ignoring the operators  $b_j^z$ , i.e., the not row and column in the above matrix. If = 0, then for 2 = 3 <  $q_z$  < 4 = 3 the matrix has a null vector with elements (2j) = 0 and (2j + 1) =  $2\cos\frac{q_z}{2}^{j}$ , which corresponds to a zero-energy state localized near the edge. If is not zero but still small, we get this spectrum :




Figure 13: Schematic form of the edge spectrum in the simplest case (a) and with the operators  $b_i^2$  taken into account (b). The shaded area represents the bulk spectrum.

It is shown in Fig. 13a, assuming that > 0, i.e., = +1. The point where the energy curve crosses zero,  $q_k = -1$ , corresponds to a left-m oving gapless mode.

Now we take the operators  $b_j^2$  into account. If = 0, then a zero mode exists for  $q_k 2 = 3; 2 = 3$ , whereas for  $q_k 2 = 3; 4 = 3$ ] there are two modes with energies

The spectrum for > 0 is shown schematically in Fig.13b. In this case a left-moving gapless mode occurs at  $q_k = 0$ .

In conclusion, let us give a simple (but not completely rigorous) proof of Eq. (56). The idea is due to Laughlin [71]: we put the system on a cylinder and run magnetic ux through it. For simplicity, we consider a cylinder of the smallest radius, which is equal to the lattice period divided by 2 . Thus the Ham iltonian is given by the matrix  $iA(q_k)$ ; the variable  $q_k$  plays the role of the magnetic ux.

(These transform ations are valid because each trace is represented by a nite sum.) The last expression in Eq. (106) may be calculated using the spectral projector for the bulk. In the nalpart of the proof, we take into account the periodicity of the bulk spectral projector, representing the site index j as (s; ). # Appendix C: Quasidiagonal matrices

The goal of this appendix is to provide a form alargum ent for the existence of unpaired M a jorana m odes on vortices for odd values of the Chern number  $\cdot$  However, the developed form alism m ay be interesting on its own right. It suggests a rather e cient approach to problem s like quantization of H all conductivity in disordered systems without the use of excessively heavy tools. Some of results (in particular, the ones concerning the ow of a matrix and the Chern number) are actually poor m an's variants of known m athem atical theorem s.<sup>11</sup> A powerful theory, called noncommutative geom etry [45] was used by B ellissard at al [1] to prove rigorously that the H all conductivity is quantized provided the electron are localized (see [72, 73] for




Figure 14: Cutting a Majorana chain: M (B) = 1 in cases (a) and (c) whereas M (B) = 1 in case (b). The dashed lines in (c) show a possible way to reconnect the broken pairs.

another proof). We will use similar ideas, but focus mainly on providing the intuition rather than mathematical rigor.

A physical example of a quasidiagonal matrix is an electron hopping matrix  $T = (t_{jk})$  on a d-dimensional lattice. It is a Hermitian matrix with the property that  $t_{jk}$  is bounded in magnitude and vanishes if the distance jj kjbetween the sites j and k is greater that some constant L. Furtherm ore, if T has a spectral gap, i.e., if the eigenvalues are bounded away from zero, then the corresponding spectral projector  $P = \frac{1}{2} \ 1 \ \text{sgn } T$  is also quasidiagonal. M ore speci cally, the matrix elements  $P_{jk}$  decay exponentially with distance.<sup>12</sup>

In general, a quasidiagonal matrix is a lattice-indexed matrix  $A = (A_{jk})$  with su ciently rapidly decaying o -diagonal elements. Technically, one requires that

where c and are some constants, and d is the dimension of the space. Note that \lattice" is simply a way to impose coarse R<sup>d</sup> geometry at large distances. We may think about the problem in these terms: matrices are operators acting in some H ilbert space, and lattice points are basis vectors. But the choice of the basis need not be xed. One may safely replace the basis vector corresponding to a given lattice point by a linear combination of nearby points. One may also use some kind of coarse-graining, replacing the basis by a decomposition into orthogonal subspaces corresponding to groups of points, or regions in R<sup>d</sup>.

Let us outline the main results. We rst consider quasidiagonal unitary matrices in one dimension and de nean integral topological characteristic called ow. Then we study projection matrices in two dimensions. The Chern number (P) of a quasidiagonal projection matrix P is expressed directly in term softher matrix elements  $P_{jk}$ , see Eqs. (124) and (122). This de nition does not rely on translational invariance, but in the translationally invariant case we reproduce Eq. (54).

A fler those prelim inaries, we switch to questions related to M a jorana ferm ions (all necessary background is given in Section 3). From the mathematical point of view, we study quasidiagonal real skew-symmetric matrices B satisfying the condition  $B^2 = 1$ . In one dimension, such a matrix is assigned a cutting obstruction M (B) = 1 with respect to an arbitrary cut dividing the chain into two parts. Let us explain the physical meaning of this number. The matrix B de ness a pairing of M a jorana modes (in the exact sense stated right after Eq. (27), but we will use a cartoon description for illustration). If we cut the chain, the resulting pieces may carry unpaired boundary modes [64]. This happens when an odd number of pairs is broken, as




Figure 15: A map from two to one dimension: annular regions around the vortex (a) are collapsed into points on a ray (b).

in Fig. 14b; otherwise one can modify the matrix near the cut so that to avoid broken pairs, see Fig. 14c. More formally, let us consider quasidiagonal real skew-symmetric matrices B<sup>0</sup> that agree with B at in nity but have no nonzero elements across the cut. We prove that if M (B) = 1, then no such B<sup>0</sup> exists that satisfies the equation  $(B^{0})^{2} = 1$ . Note that while M (B) depends on the cut, the relative M ajorana number of two matrices on the same chain, M (A; B) = M (A)M (B) is invariant.

The concept of M a prana number is also applicable in two dimensions. Let  $B^2 =$ 1, and let us construct another matrix  $B^0$  by inserting a  $Z_2$ -vortex at the origin. More exactly,  $B_{jk}$ , where the minus sign occurs when the link (j;k) crosses some xed ray r (an  $B_{ik}^{0} =$ analogue of the D irac string). Note that the condition  $(B^0)^2 = 1$  is only true asymptotically (i.e., far away from the origin); it may or may not be possible to satisfy this equation by altering the matrix elements near the vortex. In fact, the presence of an unpaired Majorana mode at the vortex is de ned as locally unrepairable failure of the equation  $(B^{0})^{2} = 1$ . Such a mode is detected by an absolute M a prana num ber M ( $B^{0}$ ). For its construction, let us regard B and B<sup>0</sup> as one-dimensional by keeping track of the radial direction only: we divide the plane into concentric rings and m ap all sites in each ring to a single location on a ray (see Fig. 15). To simplify the calculation, we cut out the interior of a su ciently large circle ; let j jbe the number of sites removed. The presence or absence of an unpaired mode in this case is given by M ( $B^{0}$ ), which is de ned using some annular neighborhood of . Extrapolating to j j= 0, we get M (B<sup>0</sup>) =  $(1)^{j} M$  (B<sup>0</sup>) = M (B; B<sup>0</sup>). The last number only depends on the matrix elements of B in some neighborhood of the intersection point between and r. Finally, we show that M (B; B<sup>0</sup>) =  $(1)^{(P)}$ , where (P) is the Chern num ber associated with the projector iB). Thus, vortices carry unpaired M a prana modes if and only if (P) is odd.  $P = \frac{1}{2} (1)$ 

## C.1 The ow of a unitary matrix

C.1.1 De nition. Let us consider an arbitrary (possibly in nite) unitary matrix  $U = (U_{jk})$ . We refer to the values of j and k as \sites" and de ne a \current" ow ing from k to j:

(Caution: In the last expression, the order of operations is in portant: we rst compute the matrix =  $U^{y}U$ , and then its trace,  $_{j jj}$ . It is not possible to use the cyclic property of the trace, TrAB = TrBA, since it is only valid if one of the matrices has a nite number of nonzero elements or, more generally, if the sum involved in the calculation of the trace converges absolutely.)

Note that the matrices and U  $^{y}$  U are orthogonal projectors. If they were nite, their traces would be integers, and the di erence would also be an integer. In the in nite case, one may refer to the general notion of the relative index of two projectors [73, 74]. However, we will proceed in a more pedestrian fashion and simply truncate the matrices.

Let  $= U^{y}U$ . It is clear that the matrix element <sub>jk</sub> vanishes if jjjor jkj is greater than L, so is not changed by the truncation to the interval [L;L]. Hence

In equation (112), the projector may be replaced by another operator with the same asymptotics at in nity. (In other words, we can \blur" the boundary between the left and the right half-line.) Indeed, the expression  $Tr(U^{Y}AU = A)$  vanishes if the cyclic property of the trace is true, i.e., if the elements of A decay at in nity fast enough. Adding such a matrix A to will not change the result. Thus

C.1.3 Translationally-invariant case. The ow can be easily calculated if U possesses a translational symmetry. Let us group the sites by unit cells and index them as (s; ), where s is the number of the cell, and refers to a position type inside the cell. We assume that  $U_{s,t}$  depends only on t s, and . In this case, we can express F (U) in terms of the trace per unit cell (denoted by tr) and a position operator X :

### C.2 General setting

The result about the ow quantization can be extended to m atrices satisfying condition (109), which guarantees that the sum in Eq. (110) converges absolutely.

A nother generalization is coarse-graining, which means to allow multiple states per site. The sites are now described by orthogonal subspaces of the total H ibert space. This generalization is useful if want to treat a two-dimensional system as one-dimensional.

Finally, we may try to apply the notion of ow to nite systems. Let us assume that the unitarity condition,  ${}_{j}U_{jl}U_{jk} = {}_{j}U_{lj}U_{kj} = {}_{lk}$ , is approximate and holds only if j and k belong to some interval. In this case, one needs to restrict the sum (110) to the same interval, and the result will not be an exact integer. But one can actually give an upper bound for the deviation from the closest integer.

Setting the last generalization aside, let us put the integrality theorem into a rigorous form . (The reader m ay safely skip this form alism and proceed to the next subsection.)

Theorem C.1. Let U be a unitary operator acting in the Hilbert space  $H = \prod_{j=1}^{L} H_j$  and represented by a matrix whose entries  $U_{jk}$  are linear maps from  $H_k$  to  $H_j$ . Suppose that the o-diagonal entries are Hilbert-Schm idt operators satisfying the condition

One can show that the operator  $= U^{Y}U$  is quasi-trace-class. A lso, the operators  $P(L) = {[L;L]}U^{Y}U {[L;L]}$  are almost projectors, in the sense that  $\lim_{L \ge 1} (P(L)^{2} P(L)) = 0$  with respect to the quasi-trace norm. Hence P(L) can be approximated by a projector, which has an integer trace.

W e om it the details and proceed to higher dimensions. Generally, our style will not be very rigorous, but one can hopefully elaborate the results using the following de nition.

Denition C.2. Let a positive integer d (the dimension) and a real number > d be xed. A matrix ( $A_{jk}$ : j;k 2 Z<sup>d</sup>) with operator entries is called quasidiagonal if all its o -diagonal entries are H ilbert-Schm idt, and there are some constants c and c<sup>0</sup> such that



This sum converges absolutely. On the other hand, its value does not change if one reassigns any site from one sector to another (due to Eq. (123)). Therefore (P) is a topological invariant: it is constant, provided that A, B, C are arranged in the counterclockw is order. We will see that

(P) is actually an integer, and its value agrees with Eq. 64) in the translationally invariant case.

C.3.2 Some properties and the translationally invariant case. Let us rewrite Eq. (124) in an operator form using the relation A + B + C = 1, where the symbols A, B, C designate the projectors on the corresponding sectors:

Note that the value of (P;A;B) will not change if we add arbitrary nite matrices to A and B. Moreover, the commutator [PAP;PBP] is nonzero only in the region where the supports of A, B, and C = 1 A B touch each other, hence we can make arbitrary changes away from the triple contact point. Thus the operators A, B, C do not have to be projectors or even commute with each other; it is only important that they are supported by regions with the particular topological con guration (possibly with some overlap along the boundaries and triple overlap at the center).

This freedom in the choice of A and B is very useful. As one application, we show that (P) is additive. Let  $P_1$  and  $P_2$  be projectors onto orthogonal subspaces (i.e.,  $P_1P_2 = P_2P_1 = 0$ ) and let  $P_3 = 1$   $P_1$   $P_2$ . We may replace A, B, and C = 1 A B with

The speci c assumptions are as follows: (i) B and B<sup>0</sup> are real skew-symmetric quasidiagonal matrices in two dimensions; (ii) B and B<sup>0</sup> coincide, except that  $B_{jk}^{0} = B_{jk}$  for those links which cross the ray r; (iii) B<sup>2</sup> = 1 (therefore  $(B^{0})^{2} = 1$  far away from the vortex). Note that M (B) and M (B<sup>0</sup>) may be dened for a su ciently large loop enclosing the vortex. Let j jbe the number of sites inside the loop. Then the absolute M ajorana numbers M (B)  $\stackrel{def}{=}$  (  $1j^{j}$  M (B) and M (B<sup>0</sup>)  $\stackrel{def}{=}$  (  $1j^{j}$  M (B<sup>0</sup>) do not depend on and indicate the presence of unpaired M ajorana modes in B and B<sup>0</sup>, respectively. ## Appendix D: Som e rem arks on the chiral central charge

This appendix is an attempt to understand the physical and m athem atical meaning of the chiral central charge beyond the CFT fram ework. Recall that chiral central charge is just the coe cient c in the edge energy current form ula (57). This de nition will be re ned in Sec. D 1.

It turns out that the edge energy current is a property of the bulk ground state. The edge current is related to a bulk 2-current. A lthough the theory is in its embryonic stage, it boks like a second-quantized version of the Chern number for quasidiagonal matrices (cf. Sec. C.3).

In Sec. D 2 we discuss modular transformations of the partition function on a space-time torus. In particular, the phase factor  $e^{2 \text{ ic}} = 24$  appears in the description of the Dehn twist along a time circle. However, other modular transformations are discult to de ne because space and time are not physically equivalent.

#### D.1 The edge energy current and a bulk 2-current

D.1.1 Energy current in the H am iltonian form alism . Let us represent the H am iltonian as a sum of local term s:  $\chi$

M icroscopic energy current can be de ned for any system with H am iltonian (150) at nite tem perature. It is convenient to x the tem perature at T = 1 and vary the H am iltonian instead. The therm all average of an operator X is de ned in the standard way:



By de nition, the chiral central charge is 12= times the total energy current in the negative x-direction.

D.1.2 Representing the ground state by local constraints. At this point, we have encountered a technical di culty: the energy current does not necessarily vanish in the bulk. The problem can be avoided if we describe the ground state by a set of local constraints. (A local constraint is a local operator that annihilates the ground state.) Ham iltonians that are explicitly written as sum s of local constraints, e.g., the Rokhsar-K ivelson m odel [76, 19], have provided a lot of insight into properties of quantum m any-body system s.

For our purposes, we can actually use an arbitrary gapped H am iltonian  $X = \int_{j}^{P} X_{j} m$  ade up of local constraints for the given state j i. It turns out that the chiral central charge depends only on the ground state. Indeed, one can interpolate between di erent sets of local constraints for the same state. Consider the situation where the constrains are  $X_{j}$  in close proximity of the edge, gradually changing to  $X_{j}^{0}$  deeper in the bulk. No energy current is associated with the transition between X and X<sup>0</sup>.

A s an aside, we conjecture that there is a set of local constraints  $Y_j$  such that the H am iltonian  $Y = \int_{j} Y_j^{y} Y_j$  is gapped. Thus excitations can be e-ciently detected locally, by coupling each

 $Y_j$  to an external indicator:  $H_{detector} = {}^{r}_{j} Y_j$  jlih0j<sub>j</sub> +  $Y_j^{y}$  j0ih1j<sub>j</sub>. A stronger version of this conjecture asserts that the original H am iltonian H can be represented as  ${}^{p}_{j}Y_j^{y}Y_j$ , where  $Y_j$  are local constraints. This is true for the quadratic ferm ionic H am iltonian (18), which needs to be o set by its sm allest eigenvalue (25) so that the ground state energy becomes zero. (In this formulation, changes from 1 to 0.) Note that usual symmetry-related phase transitions are not a problem because H () is not required to be symmetric. Rather, we should worry about a transition from a topological phase to a non-topological one. However, in two dimensions the long-range topological order in the ground state is destroyed at any nite tem – perature. Indeed, all topological excitations are point-like and not con ned, therefore they have a nite density at any non-zero tem perature. This argument does not apply to threedimensional systems, where string-like excitations are possible.

Let us give an explicit formula for g. For any two operators A and B, we de ne the M atsubara time-ordered average, as well as its  $\truncated$  version:<sup>15</sup>

#### D.2 M odular transform ations beyond CFT

The modular invariance [62] is usually formulated in the CFT framework. In this section, we demonstrate some modular properties of the partition function of edge excitations, not assuming conformal, rotational, or any other symmetry. First, let us generalize the transformation of the vacuum character<sup>16</sup> under the Dehn twist:

 $<sup>^{16}</sup>$ Som e care should be taken to make a proper connection between the physics of edge modes and the the CFT formalism. If all edge modes have the same chirality, characters correspond to representations of some chiralalgebra (as is usual in CFT). In general, the vacuum character  $_1$  is de ned as a sum over all elds with trivial monodrom y whereas  $_a$  includes all elds that occur in the two-dimensional theory when an anyon of type a emerges on the surface (see Fig. 9b on page 29).

where w is the modulus of the torus and the subscript 1 refers to the vacuum sector.

In fact, the derivation of Eq. (166) does not require much more than the know ledge of the energy-momentum tensor, or just its x-component, which is exactly the energy current I. (We use in aginary time, = it.) In the therm oblight is in the coordinate transform ation<sup>17</sup> (x; ) ! (x; + (x)) induces the action change  $S = iI \frac{d}{dx} dx d$ . If the imaginary time is cyclic, then twisting it by a full circle results in the action change  $S = \frac{1}{12}c$  and the multiplication of the partition function by  $e^{S} = e^{2 i c} = 2^{4}$ . We now describe a particular setting in which this result is applicable.

Let us consider the partition function  $Z = Tre^{H=T}$  of a spin system on a disk. As is usual, we think of the evolution over the time period 1=T, making the edge into a torus and the disk itself into the three-dimensional manifold  $M = D^2$   $S^1$ . Let us suppose that the temperature T is much smaller than the energy gap in the bulk, so that Z is mostly determined by edge excitations. In fact, the partition function depends on full detail of the edge H am iltonian as well as some conditions in the bulk. For example, we may place an anyon of type a som ewhere in the disk, which slightly changes the edge excitation spectrum. In other words, we insert a particle worldline ' into the manifold M, or act by the time-like W ilson loop operator W<sub>a</sub> ('). Thus a partition function  $Z_a$  is de ned. If all edge modes propagate with the same velocity v and can be described by a CFT, then  $Z_a = _a( 1=w)$ , where w = iLT=v. In the limit w ! 1,

Note that the nite-size quantization of edge modes might a ect the energy current. We therefore assume that the disk circum ference L is much larger than the edge correlation length  $l_{edge}$  v=T, where v is the maximum group velocity of any excitation in the system <sup>18</sup>. Sm all corrections proportional to exp(L= $l_{edge}$ ) are expected. Thus, Eq. (168) and its estimated precision are in perfect agreement with the CFT formulas (166) and (167).

This equation is indeed similar to (169) with one important di erence: unlike  $_{a}(w)$  and  $_{a}(1=w)$ , the numbers  $\mathscr{F}_{a}$  and  $Z_{a}$  are not obtained by evaluating the same function. Another problem is that the Dehn twist can only be performed along a time circle. It is therefore not clear whether the full modular invariance can be established without conform along metry, or at least a 90 -rotation symmetry of the space-time manifold.

# Appendix E: A lgebraic theory of anyons

This appendix is an attempt to present an existing but di cult and somewhat obscure theory in an accessible form, especially for the reader without extensive eld theory knowledge. (But we do assume some mathematical background and the willingness to follow abstract arguments.) The presently available resources may be divided into three categories: the original eld-theoretic papers where the relevant mathematical structure was discovered [4, 5], local eld theory theory papers [6, 7] (see H aag's book [78] for a general reference on this subject), and purely mathematical expositions [68, 79, 80]. Unfortunately, all these texts have di erent focus and/or are di cult to read. A nice elementary introduction can be found in Preskill's lecture notes on quantum computation [81], but more detail is needed for our purposes.

The theory described below is applicable to two-dimensionalm any-body system swith shortrange interactions and an energy gap. Using some intuition about local excitations in such system s, we characterize the properties of anyons by a set of axiom s and derive some corollaries. This approach is somewhat similar to what has been done rigorously in local eld theory. However, we avoid many di culties by keeping the discussion at the physical level until all essential properties are cast into a nite algebraic form, at which point we enter the realm of m athem atics.

M ore speci cally, we claim that nite-energy excitations are classied by superselection sectors: each sector consists of states that can be transformed one to another by local operations. (W e do not care about rigorous de nition here.) It is assumed that the full classic cation can be established by considering a small neighborhood of an arbitrary point (of size compared to the correlation length). A nother assumption is that local excitations can be moved from one place to another by applying an operator along an arbitrary path. Note that the quasiparticle transport need not be adiabatic, nor we require translational symmetry. Topological properties, such as braiding rules, have invariant meaning independent of possible disorder, cf. Fig. 10




Figure 16: Som e \obvious" identities.

on page 34. Using some additional arguments, we will arrive at a theory that may be called unitary braided fusion category (UBFC) (= unitary ribbon category) in abstract language.<sup>19</sup>

W ith this approach, we get a weaker set of axiom s com pared to an analogous algebraic structure in conform all eld theory. Therefore som e \obvious" properties require a proof. (A similar situation occurs in local eld theory, but our exposition is di erent in som e details and hopefully simpler.) For nonrelativistic quantum -m echanical models, the space and time are not equivalent even if we use the in aginary time form alism. Thus the notion of an antiparticle being a particle propagating back in time emust be applied with caution. The identity in Fig.16a illustrates a standard use of this notion. (Shown in the gure are space-time diagram s; time goes up.) On the left-hand side of the identity a particle a annihilates with its antiparticle a that was created as part of an aa pair. If space and time were related by a rotational symmetry, then the zigzag on the particle worldline could simply be removed. In our form alism, this equation is satis ed by a suitable choice of norm alization factors for the creation and annihilation operators of particle-antiparticle pairs. However, the relation in Fig.16b is a nontrivial theorem; it follows from the positivity of Herm itian inner product, see Section E 2. (In the categorical language, this result reads: \Any unitary fusion category adm its a pivotal structure".)

Having form ulated fusion and braiding axiom s, we will touch upon another question: W hat UBFCs can be realized by a Ham iltonian with given symmetry properties? The simplest case is where there is no built-in symmetry or associated conservation laws. That is, we assume that the system consists of spins (or other bosonic degrees of freedom) and the Ham iltonian is in generic position. (Fermions are excluded because their number is always conserved modulo 2.) Thus, any elective conservation law for quasiparticles must have topological nature. In Sec. E.5 we form ulate this condition as a certain nondegeneracy property of the braiding rules. Theories satisfying this axiom are called unitary modular categories (UMC).<sup>20</sup>

Unfortunately, UM C does not capture one important robust characteristic of the physical system, namely the chiral central charge c . However, there is a beautiful relation [7, 61] that xes c mod 8:

M ore generally, one can construct a so-called m odular functor and a topological quantum eld theory [67, 68, 79] (but we do not cover these topics).

 $d_a$  is the quantum dimension of the superselection sector a (see Sec.E 2) and a is the topological spin (see Sec.E 3). The left-hand side of Eq. (172) is denoted by ; its algebraic meaning will be explained in Sec.E 5. Roughly, = S<sup>-1</sup>TSTST, where S is a so-called topological S-matrix and T is the diagonal matrix with entries a. We will see that is a root of unity, hence Eq. (172) in plies that c is rational.

The standard proof of Eq. (172) is based on the assumption that the system admits conform ally invariant edge modes under suitable boundary conditions. Then one can employ the modular invariance of the partition function on a space-time torus, which is established in the CFT framework [62]. It is not known whether the conform ality hypothesis is true in general. One may, however, hope to nd a proof that would not depend on conform al symmetry. In Sec. D 2 we made partial progress toward this goal. Specifically, we showed that the matrix  $T = e^{2 i c} = 2^{4}T$  corresponds to the Dehn twist along a time circle. While S can also be regarded as a modular transform ation in a suitable mathematical theory, it is not clear whether that theory is applicable in the same context as the expression for T.

In the remaining part of the appendix we do not discuss the chiral central charge. Our primary goal is to de nea unitary braided fusion category (UBFC) and its special case, unitary modular category (UMC). The de nition is rather long, so we break it into several parts. Each part contains some physical motivation, form all axioms in terms of basic data and equations, as well as some corollaries. Note that our formulation of the axioms does not involve the mathematical notion of category, so we call the corresponding objects \theories" (e.g., \fusion theory" instead of \fusion category"). Only later do we introduce the powerful but heavy language of categories and functors (also known as \abstract nonsense"). It is surely overkill for most of the problem s considered in this paper, but the concept of tensor functor may actually be useful in the study of phase transitions in anyonic systems, e.g., Bose-condensation of spinless particle and weak symmetry breaking. (The last topic is considered in Appendix F.)

#### E.1 Fusion theory

In this section we consider anyons on a line (though the physical system is two-dimensional). The motivation for the de nitions has been provided in Sec. 8.4 (esp. in 8.4.2). Each particle is characterized by a superselection sector label (describing its \anyonic charge"). The position and local degrees of freedom may be ignored, but the order of particles is in portant. The main element of the the fusion theory is the space  $V_c^{ab}$  | the state space of particles a and b restricted to have total anyonic charge c. M ore exactly, vectors in this space correspond to di erent ways of splitting c into a and b, or equivalence classes of local operators that e ect the splitting.

E.1.1 Splitting and fusion operators. While  $V_c^{ab}$  may be called \splitting space", the corresponding fusion space is denoted by  $V_{ab}^{c}$ . If  $2 V_c^{ab}$  is a splitting operator, then  ${}^{y} 2 V_{ab}^{c}$  is a fusion operator:

Similarly, one can de ne splitting and fusion of multiple particles. The most general process is one transforming particles  $b_1$ ;:::; $b_m$  into  $a_1$ ;:::; $a_k$ . It can be performed in two steps: rst, fusing all the particles into one, and then splitting it as required. Therefore

The description of splitting and fusion will be complete when we understand relations between di erent spaces  $V_c^{a_1 ::: a_k}$ . That is the topic of the following subsection.

E.1.2 Basic data and equations. The basic data include a set of superselection sectors, fusion rules, and associativity relations. The latter satisfy so-called pentagon and triangle equations. An additional condition (requiring the nondegeneracy of certain operators) will be formulated in Sec. E 2.

Superselection sectors (also called \particle types", or \labels"): They form a nite set M .

Fusion rules: For any combination of a; b; c 2 M there is a xed nite-dimensional H ibert space  $V_c^{ab}$ . The numbers  $N_{ab}^{c} = \dim V_{ab}^{c} = \dim V_c^{ab}$  are called fusion multiplicities. The choice of a special element 1 2 M (the vacuum sector) is also considered part of the fusion rules.

A ssociativity relations: For each a;b;c;d 2 M there is a canonical unitary isom orphism between two Hilbert spaces:

Note that both spaces in question are simply dimensional representation of the same physical space  $V_u^{abc}|$  that of the particles a, b, and c restricted to have total anyonic charge u. Therefore one may regard the isomorphism  $F_u^{abc}$  as equality. This view is formally justimed by the pentagon




Figure 17: The pentagon equation (a) and a  $\qquad$  and a  $\qquad$  autom atically.) (The latter is satisfied autom atically.)


equation and MacLane's coherence theorem, which will be formulated later. At a cruder, combinatorial level associativity may be expressed as follows:  ${}_{e}N{}_{ab}^{e}N{}_{ec}^{u} = {}_{f}N{}_{af}^{u}N{}_{bc}^{f}$ .

From the physical perspective, splitting o (or fusing with) the vacuum sector is trivial. In any splitting diagram all lines labeled by 1 m ay be simply erased. To guarantee the consistency of this procedure, we require that the spaces  $V_a^{a1}$  and  $V_a^{1a}$  are not only one-dimensional, but canonically isomorphic to C. In other words, these spaces are endowed with xed unit vectors  $j_ai2 V_a^{a1}$  and  $j_ai2 V_a^{1a}$ . The canonical isom orphism s are given by the form ulas

where z 2 C. These isom orphism s must satisfy so-called triangle equations (see below).

Pentagon equation: The graphic representation of this axiom is shown in Fig. 17a. Its exact meaning is this: for any  $x_iy_iz_iw_iu \ge M$  the following diagram commutes:



A rrow labels are abbreviated: for example, the arrow on the left (labeled by  $F_q^{xyz}$ ) actually designates the map  ${}_{q}F_q^{xyz}$  id  ${}_{u_q^{qw}}$ , where id  ${}_{V_u^{qw}}$  is the unit operator on  $V_u^{qw}$ .

A coording to M acLane's coherence theorem [82], any sequence of F-m oves between two given trees results in the same isom orphism between the corresponding spaces: the equality of all such isom orphisms follows from the pentagon equation. (A ctually, the theorem is a bit m ore general and also includes - and -m oves, but we ignore them for the moment.) This result




Figure 18: The graph of F-m oves between binary planar trees with n = 5 leaves (a) and the procedure used to assign coordinates  $x_1; :::; x_{n-1}$  to each tree (b).

m ay be regarded as a combinatorial statement. Indeed, let us consider the graph  $_{n}$  whose vertices are binary planar trees with n leaves and whose edges correspond to F-m oves. (The graph  $_{5}$  is shown in Fig.18a.) Then the theorem says that any cycle in the graph can be lled with pentagons and quadrilaterals. The latter correspond to the obvious fact that independent F-m oves commute; such m oves can be nested as in Fig.17b or occur in disjoint branches. M acLane actually shows that any two directed paths between the same pair of vertices can be transformed one to the other using the pentagon and quadrilateral equations; the proof is by induction on a suitable parameter.

Let us also mention a beautiful geometric proof of the coherence theorem : the graph  $_{n}$  together with the set of 2-cells (i.e., the pentagons and quadrilaterals) can be realized by the vertices, edges, and 2-faces of some convex polytope K  $_{n}$  of dimension n 2. This polytope appeared in the work of Stashe [83] and now bears his name; it is also called associahedron. M ore exactly, this term refers to a certain combinatorial type of a polytope while its exact shape m ay vary. The faces of K  $_{n}$  in all dimensions are associated with general (not necessarily binary) planar trees. In particular, the edges correspond to trees with one degree-3 vertex, the quadrilaterals correspond to trees with two degree-3 vertices, and the pentagons correspond to trees with one degree-4 vertex. D escribed in Fig. 18b is a concrete geometric realization of K  $_{n}$  (cf. R ef. [84]). It is fairly easy to show that the convex hull of the points (x<sub>1</sub>; :::;x<sub>n</sub> 1) 2 R<sup>n 1</sup> obtained this way is characterized by one equation and  $\frac{n(n-1)}{2}$  1 inequalities:





Figure 19: The fundam ental triangle equation (a) and its corollaries (b and c).

Triangle equations: The three equations in Fig. 19 guarantee that adding or removing trivial lines commutes with F-m oves. Let us write the rst equation in a more conventional form :


P roof. Let x = u and w = 1. Then st and the third triangle equations coincide, except that the right arrow is  $_1$  in Fig. 19a and  $_1$  in Fig. 19c. But the right arrow is the composition of the other two, therefore it is the same in both cases.

Lem m a E 2 (cf. [80], Lem m a X I22). The rst triangle equation (together with the pentagon and quadrilaterals) implies the second and the third.


The statem ent of the lemm a refers to form altree calculus. Moves between trees are bidirectional (therefore we may represent them by lines rather then arrows). The quadrilaterals express the commutativity of disjoint F -, -, and -m oves.

Proof. Let us prove the equation in Fig. 19b.

First, we join an additional trivial branch to the trunk of each tree and show that the resulting equation is equivalent to the original one. In the diagram on the right, the old and the new equation constitute the top and the bottom of a triangular prism, respectively. The sides of the prism are commutative quadrilateral, therefore the top triangle commutes if and only if the bottom one does.



We now consider the bottom of the prism, which may be identied with triangle 4-7-5 in the new diagram. In this part of the argument it is not important that the leftmost branch of each tree is trivial, so we represent it by a solid line. The outline of the diagram corresponds to the pentagon equation. Triangles 3-1-6 and 4-2-5 are instances of the equation in F ig. 19a, which is true by hypothesis. The quadrilaterals 1-2-4-3 and 6-3-4-7 also commute. Thus the required triangle 4-7-5 commutes as well.



The equation in Fig. 19c is proved analogously.

E.1.3 Examples. Several concrete theories have been presented in the main text, see tables on pages 30, 41, 42. Let us now describe some general constructions leading to in nite series of examples.

- 1. Let the label set M be a nite group and the fusion rules correspond to the group multiplication. That is, the space  $V_z^{x,y}$  is one-dimensional (with a basis vector  $\frac{x,y}{z}$ ) if z = xy, otherwise  $V_z^{x,y} = 0$ . The associativity relations are trivial. Note that if the group M is non-Abelian, this fusion theory does not admit braiding.
- 2. The associativity constraints in the above example can be deform ed as follows:

where the vertices of the trees correspond to basis vectors and f(x;y;z) are some phase factors. In this case the pentagon equation reads:

This is a cocycle equation, i.e., f is a 3-cocycle on M with values in U (1). One can show that the triangle equations do not put any additional restriction on f but rather de ne and :



The right-hand side of this equation is the coboundary of the 2-cochain u, i.e., g and f belong to the same cohom ology class f. Thus, the associativity relations are classi ed by H<sup>3</sup> (M ;U (1)).

For a concrete example, let  $M = Z_2 = f1$ ; ag. It is known that  $H^3(Z_2; U(1)) = Z_2$ , i.e., Eq. (183) has one trivial and one nontrivial solution. The nontrivial solution is given by f(a;a;a) = 1, the other seven values being equal to 1. This particular fusion theory adm its two braidings: the counterclockwise exchange of two a-particles is characterized by either + i or i. Such particles are called sem ions. Recall that Case 2 in the table on page 41 represents two independent species of sem ions.

- 3. Let M be the set of irreducible representations of a nite group G and let  $V_c^{ab} = H \operatorname{om}_{C[G]}(c; a b)$ . In other words, elements of  $V_c^{ab}$  are intertwiners between c and a b, i.e., linear maps that commute with the group action. The associativity relations are given by 6j-symbols. This theory admits trivial braiding.
- 4. Examples 3 and 1 (with M = G) can be combined in what is called representation theory of D rinfeld's quantum double [85, 80]. M odels with anyons described by this theory were proposed in [86] (gauge-symmetric Lagrangian) and in [24] (lattice H am iltonian not constrained by an external symmetry). This construction can be deformed by an arbitrary cohom ology class € 2 H<sup>3</sup> (G; U (1)), see Refs. [87, 88].
- 5. A very interesting set of fusion theories is based on a Temperley-Lieb category, see e.g. Chapter X II in book [68]. These theories are also known as \representations of quantum SU (2)".

E.1.4 Calculations with planar graphs. The rules we have described allow us to work not only with trees but with arbitrary oriented planar graphs. In particular, loops can be rem oved using Eq. (174). If we encounter a subgraph like shown in Eq. (174) but with di erent labels at the top and at the bottom (say,  $c^0$  and  $c^{00}$ ), then its value is zero. Let us illustrate that by a concrete example, using the fusion theory from Table 1 on page 30 for { = +1:



In general, we consider planar graphs that satisfy the following conditions.

- 1. Vertices are associated with fusion/splitting spaces  $V_{l_1,...,l_r}^{u_1,...,u_s}$ ; the indices are represented by prongs. There may also be external labels (term inals) at the bottom and the top of the graph. Bottom term inals and upper indices are called sources, lower indices and top term inals are called targets.
- 2. Each edge connects a source to an identically labeled target. (In pictures we use a single label for the whole edge.)
- 3. The edges are transversal to the horizontal direction and oriented upwards. (W e do not show the orientation in drawing because it is obvious.)

To each vertex we also assign an element of the corresponding space  $V_{l_1;...;l_r}^{u_1,...;u_s}$ . Using associativity relations and Eqs. (174), (176), we can compute the value of the graph, X 2  $V_{b_1;...;b_m}^{a_1,...;a_k}$ , where  $a_1;...;a_k$  and  $b_1;...;b_m$  are the external labels. Note that we may freely add or remove edges labeled with 1, thanks to the triangle equations.

A general calculation strategy is based on the idea that X can be represented by a set of maps  $X_c : V_c^{b_1; \dots; b_m} ! V_c^{a_1; \dots; a_k}$  for each label c; this representation is closely related to the decomposition of identity (176). Thus we apply Eq. (176) rst, and then start shrinking and removing loops as illustrated above. For example:

W e will see that for theories with particle antiparticle duality, condition 3 can be dispensed with. The form alism will be revised so that edges can bend, changing their direction from upward to downward and back, and vertices can rotate by 360 as in Fig. 16b.

#### E.2 Particle-antiparticle duality

In this section we complement the fusion theory by the following condition.

Duality axiom . For each label a there is some label a and vectors ji2  $V_1^{aa}\mbox{, ji2}~V_1^{aa}$  such that

Note that the matrix element in question corresponds to a physical process in which the aparticle from an aa-pair annihilates with a di erent copy of a:

(The dotted lines and the associated labels, i.e., 1, a, a may be ignored.)

Let  $h_a$   $f_a^{aaa}j_a i = u$ , assuming that j i and j i are unit vectors. We will see that the spaces  $V_1^{aa}$  and  $V_1^{aa}$  are one-dimensional, therefore juj is uniquely dened. The number  $d_a = j_{\mu}j^1$ , called quantum dimension, plays an important role in the theory. In particular,  $d_a = 1$  for A belian particles (i.e., such that a = 1), otherwise d > 1. If a = a, then we may set j i = j i so that u itself has an invariant meaning. Speci cally,

where { a is a uniquely de ned phase, which is actually equal to 1 (see below). This num ber is called Frobenius-Schur indicator; in the present context it was introduced by Fredenhagen, Rehren, and Schroer [89].

E.2.1 Physicalm otivation for the duality axiom. The existence of antiparticles follows from a locality principle mentioned at the beginning of this appendix: a quasiparticle can be moved from one place to another by applying an operator that acts on spins along a path connecting the given points. (We are still considering anyons on a line, therefore the path is unique.) The action on di erent spins can be performed at once or in any particular order. For example, to move a particle from point 3 to point 1 on its left, it may be natural to move it rst to some middle point 2, and then to the naldestination. But it is also possible to act on the interval [1;2] before [2;3]. The interm ediate state must be a particle-antiparticle pair.

For a slightly m one rigorous argum ent, let X be an operator that m oves a particle of type a from 3 to 1, acting on spins along the interval. W e can represent it as follows:

where  $Y_k$  and  $Z_k$  act on disjoint sets of spins in som e regions around [1;2] and [2;3], respectively. Let  $x_{[s]}$  (s = 1;2;3) be the projector onto states having particle x at point s; such operators can be realized locally (to act in the gray circles in the above picture) if we only allow states that are not excited away from the given three points. Finally, we de ne new versions of X,  $Y_k$ , and  $Z_k$ :

The operator X <sup>0</sup> still m oves a from 2 to 3, but  $Y_k^0$  and  $Z_k^0$  overlap geom etrically and therefore no longer commute. It is clear that each operator  $Y_k^0$  creates an a-particle at point 1 and som e particle at point 2, whereas  $Z_k^0$  removes the second particle as well as the original particle at point 3. Thus each product  $Z_k^0 Y_k^0$  e ects the process shown in Eq. (186), up to an overall factor. This factor is nonzero for at least one value of k.


#### E.2.2 Som e properties and norm alization conventions.

Let us now set new normalization conventions. In the denition of  $d_a$  we assumed that j i and j i are unit vectors, i.e.,  $y = y = id_1$ . However, it is more convenient to multiply and by  $\overline{d_a}$  (and some suitable phase factors) so that the zigzag on the left-hand side of equation (186) could be simply removed. The so normalized operators for the creation of particle-antiparticle pairs will be represented as smooth \cups" with a triangle mark at the bottom. The adjoint operators are \caps" obtained by ipping the pictures about a horizontal line.<sup>21</sup>

Now we are in a position to relax the requirem ent that edges are transversal to the horizontal direction.

De nition-Proposition E.5. A line is an alternating sequence of 2n cups and caps without triangle marks. It may be open or closed. Such an object has a canonical norm alization given by n triangles pointing forward and n triangles pointing backward (relative to a chosen path direction). All such decorations are equivalent.

W hen computing either type of inner product, we stack two trees with branches touching each other and connect the roots by a bop. Stacking the trees root to root might produce a di erent result, but it turns out to be the same since we can actually rotate vertices by 360, see below.



### E.3 Braiding and topological spin

B raiding is an additional piece of algebraic structure characterizing anyons. It is de ned by a set of elements  $R_{ab} 2 V_{ab}^{ba}$  that represent transposition of two particles:

M ore generally, a line can slide over or under an arbitrary vertex. It is su cient to postulate this property for three prong vertices representing splitting and fusion and for lines tilted left and right. Furtherm ore, splitting and fusion are related by the decom position of the identity (196), whereas changing the slope of the intersecting line is equivalent to replacing R with R<sup>1</sup>. Thus the num ber of independent conditions is reduced to two:

The description of braiding in terms of basic data amounts to specifying the action of  $R_{ab}$  on splitting spaces:





Figure 20: The hexagon equations.

These include F -m oves as well as R -m oves | absorbing a line crossing by a vertex. Thus we obtain the diagram s in F ig. 20; the bottom m ost arrow in each of them combines an R -m ove with the rst or the second equation in question. W e m ay now forget about the topological meaning of braiding and only keep track of the linear maps involved:



These commutative diagrams are known as hexagon equations. They actually look nicer in the tensor category formalism, see Eqs. (274) and (275).

Note that braiding with label 1 is trivial:

R em ark E.9. Eq. (215) provides a simple physical interpretation for the Frobenius-Schur indicator { a. Suppose that the system is rotationally invariant, so that not only the topological spin but also the usual spin  $s_a$  has physical meaning. Of course,  $s_a$  may take di erent values subject to the constraint  $e^{2 i s_a} = a$ . Let us consider a pair of identical particles with trivial total topological charge. W hat values does the total angular momentum of this composite object take? This question may be answered as follows. A ssum ing that both particles are in the same spin state  $s_a$  and barring additional \isospin" degrees of freedom, the 180 rotation is characterized by the phase factor  $e^{i s_a} e^{i s_a} R_1^{aa} = \{a, Thus, the total angular momentum is even if <math>\{a = 1 \text{ and odd if } \{a = 1.$ 

It is interesting that the e ect of moving one particle around another is fully characterized by the topological spin:

In this section we investigate some properties of fusion, based on the axioms stated above. First, let as consider a fusion theory with particle-antiparticle duality, but without braiding. The Verlinde algebra is an associative -algebra spanned by elements g:a 2 M which satisfy the following relations:

Since  $\mathbb{N}^p(a) = \mathbb{N}^p(a)^y$ , the algebra operation y corresponds to taking the adjoint matrix. Therefore Ver is actually a nite-dimensional C -algebra. Equation (201) says that the linear map Ver ! C :  $e_a \ 7 \ d_a$  is a hom on orphism.

If braiding is de ned, then  $N_{ab}^{c} = N_{ba}^{c}$ , therefore the Verlinde algebra is commutative. A nite-dimensional commutative C -algebra splits into several copies of C. Therefore we have M jdistinct hom on orphisms from Ver to C, which we refer to as fusion characters:



#### E.5 Braiding nondegeneracy = m odularity

Let us recall the de nition of a superselection sector: it is a class of states that can be transform ed one to another by local operators. From the physical perspective, the operators we use m ust respect any unbroken symmetry present in the Ham iltonian, e.g., the U (1) symmetry associated with the conservation of electric charge. A nother example is the number of fermions m odub 2, if that number is not conserved as an integer. (Here we speak about actual fermions forming the system rather than electric M a jorana modes obtained by a nonlocal transform ation.) However, in the model studied in this paper the superselection sectors are stable with respect to all local operators. More generally, we may consider an arbitrary system built of spins or other bosonic degrees of freedom, and ask for properties that are stable to a generic perturbation. In this case, the superselection sectors have purely topological nature: some signature of a nontrivial excitation  $x \in 1$  will be preserved even if we cut out a piece of material containing the quasiparticle. It is quite reasonable to assume that the presence of such an excitation can actually be detected by an A haronov-B ohm measurement, i.e., by moving a test particle a around x. Thus we arrive at the condition that the braiding is nondegenerate, which must be true for any anyonic system not complicated by external symmetries.

De nition E.11. Braiding is said to be nondegenerate if for each label x  $\neq$  1 there is some label a such that the operator  $R_{ax}R_{xa}$  is not identity.

Theorem E.12. In a theory with nondegenerate braiding, the following operator  $S_z$  acting in the space  $L_z = \int_{b} V_b^{bz}$  is unitary:

Theories with a unitary S-m atrix are often called modular due to their relation to the group of dieom orphisms of the two-dimensional torus considered up to topological equivalence (namely, isotopy). Let us discuss this subject at a speculative level. The rst thing to note is that a system of spins or electrons can in principle be put on a torus whether or not the braiding is nondegenerate. However, as indicated earlier, degeneracy generally occurs due to some external symmetry. If it is a gauge symmetry, then putting the system on the torus involves som e choice. For example, in the case of U (1) symmetry, one may run an arbitrary magnetic ux through each basic circle of the torus. Those uxes can be detected by A haronov-Bohm measurements, but they cannot be changed by intrinsic operations, which include splitting, fusion, and moving particles around the torus. M athem atically, such operations form a so-called skein algebra, which may be de ned in terms of graphs on the torus up to equivalence transform ations. (Recall that a planar graph without external lines can be transformed to a number, therefore the skein algebra of the plane is simply C.) The skein algebra is a nite-dimensional C -algebra; in general it is a direct sum of several blocks, each block being isom orphic to the algebra of operators on some nite-dimensional Hilbert space. Physically, di erent blocks correspond to di erent values of external param eters such as the magnetic uxes. Modular theories are special in that there is only one block. In other words, the torus is characterized by a single nite-dimensional space.

The H ilbert space of the torus is actually  $M = C^{M}$ . A basis in this space m ay be associated with e ective anyonic charge that is detected by an Aharonov-Bohm m easurement along some circle. D i erent circles correspond to di erent bases. The S-m atrix e ects a transition between two bases. O ther important m atrices are  $C = (_{ab} : a; b 2 M )$  (which corresponds to a 180 - degree rotation) and  $T = (_{a \ ab} : a; b 2 M )$  (which corresponds to a Dehn twist). We will justify this description by showing that S, C, and T obey the modular relations up to a phase factor :

#### E.6 Gauge freedom and O cneanu rigidity

In the preceding sections, we de ned a theory of anyons as a solution to a certain system of algebraic equations for  $F_u^{abc}$ , a, a, and  $R_c^{ab}$ . Speci cally, these are the pentagon equation, the triangle and hexagon equations as well as unitarity conditions. (The unitarity conditions are algebraic in the real and in aginary part of the corresponding matrices.) The set of solutions is some real algebraic variety. This description, however, does not take into account a gauge degree of freedom. Indeed, two solutions are physically equivalent if they are related to each other by a simultaneous basis change in the spaces  $V_c^{ab}$ . In the examples studied in this paper, quotienting over such transform ations makes the set of solutions discrete. In other words, the algebraic structure is rigid, with the physical consequence that the properties of anyons are stable to small perturbations of the H am iltonian. Is it true in general? The a mative answer was obtained by 0 cneanu, but he did not publish his proof. The only written proof I know of is due to E tingof, N ikshych, and 0 strik [30], but it is more general and hence com plex; in particular, it does not depend on the unitarity or the pivotal property. M eanwhile, the proof of 0 cneanu rigidity for unitary theories is not very di cult and may be interesting to a mathem atical physicist.

To prove that a solution to an equation system is rigid, one needs to study in nitesimal deformations. Let us call a deformation of F, , , R permissible if it satisfies the equations in the rst order of Taylor expansion. The deformation is called trivial if it can be obtained by a change of basis, also in the rst order. (By restricting our attention to the rst order, we potentially make the space of permissible deformations larger and the space of trivial deformation smaller.) Our goal is to calculate the quotient, permissible modulo trivial, and show that it vanishes. The analysis consists of several steps.

First, we only consider F and the pentagon equation. The resulting deform ation problem resembles the de nition of H  $^3$  (G;R) for a group G. In fact, it is exactly that in example 2 on page 72. A speciated with an arbitrary fusion theory is a cochain complex de ned by C rane and Y etter [91] and independently by D avydov [92]. It is a sequence of real spaces and linear maps

will use the term  $\text{tangent cohom ology}^{24}$  proposed by D avydov.

It is well known that any nite group has trivial real cohom ology in all dimensions n > 1. Likew ise, the tangent cohom ology vanishes for an arbitrary unitary fusion theory (actually, any fusion theory). The proof of this statement is based on the same idea as the corresponding proof for groups. In the latter case, one uses averaging over the group, which is well-de ned because the group is nite. For a unitary fusion theory, one needs to take the quantum trace (actually, a partial quantum trace) and average it over the label set with weight  $d_n = D^2$ .

The next step is to include , and to consider the triangle equations. This is just a technical detail that involves trivial changes to the deform ation theory [93]. (The argument is quite general and applicable even if the label set is in nite, in which case the cohom obgy may not vanish.) The rigidity of braiding follows from the vanishing of H  $^2$  (C) in conjunction with Vafa's theorem (see Theorem E 10).

E.6.1 Gauge freedom in the description of anyons. An isomorphism between two fusion theories, A and A<sup>0</sup> is given by a bijection between the label sets (we simply assume that they are equal) and a collection of unitary maps<sup>25</sup>  $_{c}^{ab}$ : (V<sup>0</sup>) $_{c}^{ab}$ ! V $_{c}^{ab}$ ; these data are enough to relate one system of associativity constraints to the other:

For example, let A<sup>0</sup> be obtained from A by changing left and right, i.e.,  $(V^{0})_{c}^{ab} = V^{ba}$  and  $(F^{0})_{u}^{abc} = (F_{u}^{cba})^{1}$ . If theory A has braiding R, then  $_{c}^{ab} = (R_{c}^{ab})^{1}$  is an isom orphism (for a quick demonstration, apply the Yang-Baxter braid (205) to both trees above). However, we will be mostly interested in the case where  $(V^{0})_{c}^{ab} = V_{c}^{ab}$  so that  $_{c}^{ab}$  may be called \basis change"; examples can be found in Sections 8.4 and 9.

By analogy with Eq. (239), one can write similar equations for a vs.  $a^{0}$  and a vs.  $a^{0}$ . However, the physical meaning of and is rather elusive, so it is not clear whether we obtain the most general form of equivalence this way. A reasonable notion of isom orphism between two theories, namely tensor functor arises naturally in the categorical form alism (see Sec. E.7.3). To state it in concrete term s, we just need to supplement the basis change with an overall phase factor so that

where  $h_x$  are arbitrary phase factors. In the categorical language, the tensor functors de ned by (; ) and by (;') are isomorphic.

Thus we have entities of dimension 0, 1, and 2: theories of anyons, 1-isom orphism s (i.e., isom orphism sbetween theories), and 2-isom orphism s (i.e., isom orphism sbetween 1-isom orphism s). Let us de ne three sets indexed by a complementary dimension:

- 1.2-autom orphism sh of a given 1-isom orphism (;);
- 2. Equivalence classes of 1-autom orphism s (; ) of a given theory A up to 2-isom orphism s;
- 3. Equivalence classes of theories with given fusion multiplicities up to 1-isom orphism s.

The rst set is an Abelian group, the second is a group (see Appendix F), the third does not have any special structure.

E.6.2 In nitesim aldeform ations and the vanishing of tangent cohom ology. Let us de ne in nitesim alanalogues of sets 1, 2, 3; we will eventually prove that they are trivial. The constructions involved are typical to cohom ology theory, following a pattern that may already be recognized by studying set 1. We are eventually interested in set 3, which classi es solutions of the pentagon equation up to a basis change. In this subsection we ignore braiding and all attributes of the vacuum sector (i.e., , , , , and the triangle equations); these things will be considered later.

For a xed fusion theory with associativity constraints  $F_{u}^{abc}$ , let



E.6.3 Technicalities related to the unit and braiding. Let us now take into account additional structure that was neglected in the above analysis. We will get more variables and more equations, but the old equations will not change. The new degrees of freedom are characterized by in nitely small real numbers g,  $A_a$ ,  $B_a$  and Herm itian operators  $W_c^{ab}$  which are de ned as follows:

(Recall that is part of the de nition of a 1-isom orphism .) It has been previously shown that any in nitesimal deformation of the associativity constraints F can be compensated by a suitable basis change . Furthermore, any in nitesimal basis change not a ecting F has the form (242), hence , , or R are not altered either. The only parameter to tune is 1 iq.

Let us st show that any perm issible deform ation of and is trivial, where \perm issible" m eans satisfying the triangle equations and \trivial" m eans satisfying Eq. (240). Taken to an in nitesim al form, the st triangle equation (see Fig. 19a) and Eq. (240) read:

Thus we may assume that the whole fusion theory, i.e., F, , and are xed. Instead of using the hexagon equations directly, we will rely on the fact that braiding deformation of the mean isomorphism between the given fusion theory A and the theory A<sup>0</sup> in which left and right are changed. #### E.7 Categorical form alism (aside)

C ategories and functors are the language used by m athem aticians to describe fusion, braiding, and related concepts. I originally tried to write an exposition of the theory of anyons using this form alism, but found it too awkward. I still think that functors are necessary for the understanding of phase transitions and other advanced properties of anyonic system s, but m ost things can be explained in m ore elementary term s. This section is a remainder of the abandoned plan. P lease be warned that these notes are very incom plete, e.g., there is no discussion of duality and related concepts: rigid, pivotal, and spherical categories (not to mention that we focus on sem isim ple categories | this restriction is natural for the intended applications).

Let us outline the main elements of the theory. An abstraction called tensor category generalizes the notion of fusion theory. W hile anyonic fusion has a compact description in terms of basic data, a category is a huge collection of \objects" related by \m orphism s". However, these relations form a regular structure that does not have much freedom of choice. A rather trivial example is the category H ib, whose objects are all possible nite-dimensional H ilbert spaces and the m orphism s are all linear m aps. A more interesting category Rep (G) is de ned as follows: the objects are nite-dimensional unitary representations of a compact group G and the m orphism s are intertwiners. W em ay also think of a fusion theory as a category: the objects are nite sequences of particle labels, and the m orphism s between (b\_1;:::;b\_m) and (a\_1;:::;a\_k) are fusion/splitting operators, i.e., elements of the space  $V_{b_1::b_m}^{a_1:::a_k}$ . A nother way to turn a fusion theory into a category will be described later.

By de nition, a tensor category is equipped with an operation 2 that is analogous to fusion. The role of the vacuum sector is played by a special object 1. In the categories H ib and Rep (G), the operation 2 is the usual tensor product and 1 is the set of complex numbers C regarded as a one-dimensional space or the trivial representation of G.

Yet another example: the matrix category  $M at_{m,m}$ . In this category,<sup>27</sup> objects are m matrices whose entries are nite-dimensional complex linear spaces, morphisms between matrices are entrywise linear maps, and

(If the matrix entries are nite-dimensional H ilbert spaces, we use the notation  $M at_{m,m}^{y}$  because in this case each morphism has a Herm itian adjoint.) Note that (A 2 B) 2 C = A 2 (B 2 C) and A 2 1 = A = 1 2 A; tensor categories with this property are called strict. In general, the equalities are replaced by isomorphism s F, , and satisfying the pentagon and triangle equations.

A tensor functor is a map from one tensor category to another, a classic example being the embedding Rep(G) ! Hilb. Tensor functors have some physical applications, such as transformations of particles by global symmetries (see Appendix F). They are also related to the gauge freedom in the description of anyonic fusion, cf. Eqs. (239), (240), and (242). However, our main goal is to understand the status of the isom orphisms F, , . To this end, we will nd an embedding of an arbitrary tensor category into a strict one by a tensor functor that preserves distinction between m orphisms s (such functors are called faithful). In particular, any unitary fusion theory with label set M embeds into the matrix category M at  $_{M,M}^{Y}$ . The embedding theorem in plies

M acLane's coherence theorem : Allmorphisms composed of F , , and having the same source and target are equal.

Indeed, in the strict category the source and the target are the same object, and any composition of F, , and is the identity morphism (i.e., equality). Thus all such compositions in the

original category are mapped to the same morphism. Since the functor preserves distinction between morphisms, the original morphisms are also equal.

E.7.1 The basics of category theory. A category is a collection of objects and morphism s. The set of morphism s from A to B in a category C is denoted by C(A;B).

M orphism s are anything that can be composed: if f : A ! B and g : B ! C, then gf : A ! C. It is only required that (hg)f = h(gf) and that every object A has an identity morphism  $id_A$  such that  $fid_A = id_B f = f$  for any f : A ! B. (Example: objects are vertices of a given graph, morphism s are paths of arbitrary length, identity morphism s are paths of length 0.)

A morphism f : A ! B is called an isomorphism if there is a morphism  $f^1 : B ! A$  such that  $f^1 f = id_A$  and  $ff^1 = id_B$ . Notation for isomorphic objects: A = B.

For applications in quantum mechanics, the basic example is the category H ib of nitedimensional H ibert spaces. Among its objects are the set of complex numbers C and the onedimensional space corresponding to the rst level of a harmonic oscillator. These two spaces are isomorphic but dierent. (The isomorphism maps the complex number 1 to a normalized wavefunction , but this map is not canonical because there is no reason to prefer over .) So, it does not generally make sense to ask whether two given objects are equal (unless they are the same by de nition). M orphism s between two given objects may be compared for equality though. For two objects, X and Y, a reasonable question is whether  $X = Y \cdot Of$  course, two spaces are isomorphic if and only if they have the same dimension. But we also want to keep track of isomorphism s, for they may not commute: a sequence of isomorphism s may result in a nontrivial automorphism u : X ! X, u field<sub>X</sub>. (For H ilbert spaces, it is natural to consider unitary isom orphism s.)

The next example has motivation in superselection theory. Let us consider an in nite spin system which is almost in the ground state, with excitations being allowed only in some nite region. Quantum states of such a system are classified by superselection sectors. For each sector a the state belongs to some nite-dimensional Hilbert space X<sub>a</sub>, which depends on speci c constraints on the excitations. We are going to consider different sets of constraints (called \objects") and transform ations from one object to another (called \m orphism s").

De nition E.17. Let M be some set. The category  $Ve_{M}^{\chi}$  is de ned as follows.

An object X 2 Ve $\chi$  is a collection of nite-dimensional Hilbert spaces (X<sub>a</sub>: a 2 M), of which only nitely many are nonzero.

A morphism f:X ! Y is a collection of linear maps  $f:X_a ! Y_a$  (for each a 2 M). The identity morphism  $id_X : X ! X$  consists of the unit operators acting in  $X_a$ .

Additional structure: The set  $V \in M^{\circ}(X;Y)$  of m orphisms from X to Y is a complex linear space. For any f:X ! Y we de ne the adjoint m orphism  $f^{Y}:Y ! X$  such that  $(f^{Y})_{a} = (f_{a})^{Y}$ .

A unitary isomorphism is an isomorphism f such that  $f^{1} = f^{y}$ .

An simplied version of this construction is the category  $Vec_M$ : we use complex linear spaces instead of H ilbert spaces and do not consider adjoint morphism s.

For each a 2 M we de ne the object [a] such that  $[a]_a = C$  and  $[a]_b = 0$  for  $b \in a.0b$  jects isom orphic to [a] are called simple. For any object Y,

From the physical perspective, simple objects correspond to quantum states (e.g., a particle pinned to a point), whereas [a] is a reference state in the given superselection sector. For a more form all example, consider the category Rep (G) whose objects are nite-dimensional unitary representations of a compact group G and whose morphism s are intertwiners. Let M be the set of irreps considered up to isom orphism, and let [a] be a particular irrep in the given isom orphism class. Then we may identify the category A = Rep (G) with  $Vec_M^Y$  this way:  $Y_a \stackrel{\text{def}}{=} A$  ([a];Y.

R em ark E .18. Our de nition of  $Vec_M$  and  $Vec_M^Y$  resembles the construction of a vector space using coordinates. An invariant characterization is also possible, though som ew hat com plicated. W hen the label set M is unspecied,  $Vec_M$  is called a sem isim ple C -linear category, and  $Vec_M^Y$  is called a unitary category.

The concepts of functor and natural morphism are central in category theory. They are extrem ely general and therefore hard to grasp. W e will try to illustrate them by sim ple exam ples, which are still rather abstract. M ore meaningful (though less direct) exam ples can be found in the next subsection.

De nition E.19. A functor F : A ! B maps each object A of the category A to an object F (A) of the category B and each morphism  $f : A ! A^0$  to a morphism  $F (f) : F (A) ! F (A^0)$  such that

We have already mentioned one example of a functor, namely the embedding F: Rep (G)! H ib. A cting on morphism s, it maps the set of intertwiners to the set of all linear maps between two representation spaces. A natural morphism h: F! F may be constructed as follows:  $h_A$ is the action of some xed group element on the representation space of A. Indeed, for this particular choice of the functors F = G the commutative diagram (258) simply says that F (f) is an intertwiner.

Example E.20. Let H be a nite-dimensional Hilbert space. We de ne a unitary functor H : H ib ! H ib by tensoring with H on the left (notation: H = [H ]):

The functor H = [H] has some special properties, namely the map f 7 H (f) is linear and H (f<sup>Y</sup>) = (H (f))<sup>Y</sup>. Such functors are called unitary.

   [H] for some space H, namely H = F (C). This isom orphism is unitary.
- 2. Any natural morphism U: [G]! [H] has the form [u], where u = U.

P roof. The idea is very simple: any space is a direct sum of one-dimensional spaces, any onedimensional space is isomorphic to C, therefore F and U are completely characterized by their action on C. Let us go through the detail to see how the form alism works.

1. Let A be an arbitrary nite-dimensional H ilbert space. E lements of A may be associated with morphism s C ! A. An orthonormal basis corresponds to a set of morphism s  $_j$ : C ! A such that  $_{k}^{y} = _{kj}id_{c}$  and  $_{j}^{y} = id_{A}$ . Since F is a unitary functor,

Adding another level of abstraction, we can reform ulate Proposition E 21 as follows: The category Fun<sup>y</sup> (Hib; Hib) of unitary functors from Hib to Hib is isom orphic to the category Hib. (One may replace Hib by the category of nite-dimensional complex linear spaces, om it-ting the unitarity condition.) By analogy, we obtain the following result.

P roposition E .22. The category  $\operatorname{Fun}^{Y}(\operatorname{Vec}_{M}^{Y};\operatorname{Vec}_{N}^{Y})$  is isomorphic to the category  $\operatorname{Mat}_{N,M}^{Y}$  whose objects are N M matrices of nite-dimensional H ibert spaces with a nite number of nonzero entries in each column and whose morphisms are entrywise linear maps between such matrices. (If M is nite, then  $\operatorname{Mat}_{N,M}^{Y} = \operatorname{Vec}_{N,M}^{Y}$ .)

E.7.2 Fusion in categorical terms. Fusion theory may be formulated as additional structure on the category  $C = Vec_M^Y$ . Let us assume that the the label set M contains a special element 1 and that  $V_c^{ab}$ ,  $F_u^{abc}$ , a, are de ned and satisfy the pentagon and triangle equations as well as unitarity conditions. If in addition M is nite and the duality axiom on page 74 holds, then the resulting construction is called unitary fusion category. (For a general de nition of fusion category see Ref. [30].)

The use of categorical form alism has m athem atical as well as physical m otivation. Let A and B be spatially con ned excitations such that A is located on the left of B. Each excitation m ay be described by an object in the category C. If we consider both excitations together, we will obtain a new object, A 2 B, which m ay be called \physical tensor product". If A and B do not have local degrees of freedom, i.e., A = [a], B = [b], then  $(A 2 B)_c = V_c^{ab}$ . A nice property of the physical tensor product is that (A 2 B) 2 C = A 2 (B 2 C) (provided A, B, and C are arranged on the line in that particular order). M athem atically, the operation 2 is only associative up to a canonical isom orphism, but we will nd some abstract representation of objects in which the isom orphism becomes an equality.

The tensor product of two objects, A; B 2 C is de ned by the equation

P roposition E .23. The functor property (260) and the naturality (263) imply all quadrilateral identities of the tree calculus.

Indeed, there are two kinds of such identities. In the example shown in Fig. 17b, one of the commuting moves occurs inside a subtree descending from the other. The innermove plays the role of f in the naturality condition. If both moves occur in disjoint subtrees, one should use the functor property.

For an elem entary but in portant example, let the label types and fusion spaces be xed but the associativity constraints vary. G iven two sets of associativity constraints, we may ask whether they are equivalent up to a basis change, cf. Eqs. (239) and (240). This type of equivalence is a special case of tensor functor. Note that two basis transform ations may di er by trivial factors, cf. Eq. (242); the corresponding tensor functors are said to be naturally isom orphic.



The tensor category  $\hat{C}$  is called strict if  $F_{A,B,C}$ ,  $_A$ ,  $_A$  are equalities. It is called sem isimple if the base category C is  $Vec_M$ . It is called unitary if  $C = Vec_M^Y$ , the functor 2 is unitary, and the isom orphism s F, , are unitary.

Sem is in ple tensor categories adm it a compact description in terms of basic data", which is just slightly more general than that of a fusion theory. Indeed, by analogy with Propositions E 21 and E 22 one can show that any functor of two arguments,  $2 : \text{Vec}_M \quad \text{Vec}_M \quad \text{Vec}_M$  is given by a set of nite-dimensional spaces  $V_c^{ab}$ . However, the unit object is not necessarily simple, an example being the category  $M \text{ at}_M \xrightarrow{M} 0$  or  $M \text{ at}_M^Y \xrightarrow{M} W$  if the multiplication rule and the unit (256). (Note that these tensor categories are strict.) In physical terms, the nonsimplicity of the unit means that the vacuum is not unique; thus simple objects in  $M \text{ at}_M^Y$  are boundaries between vacua.

R em ark E 26. A lax tensor functor is de ned likewise, but  $_{A,B}$  and  $_{A,B}$  are not required to be isom orphism s. In physics, this construction describes a situation in which theory  $\hat{C}$  is obtained from  $\hat{C}^0$  as a result of B ose-condensation, cf. note 9 on page 44.

De nition E.27. A morphism between two tensor functors,  $\hat{G} = (G; ;)$  and  $\hat{H} = (H; ;')$  is a natural morphism h: G ! H satisfying these additional commutation relations:

Let us see how these de nitions work for fusion theories. Let C and C<sup>0</sup> have label sets M and M <sup>0</sup>, respectively. W e already know that an arbitrary functor G : C ! C<sup>0</sup> is described by som e m atrix ( $G_{a^0}^a$  : a 2 M ; a<sup>0</sup> 2 M <sup>0</sup>) of nite-dimensional H ilbert spaces. Then the supplementary components of the tensor functor, and are characterized by som e unitary linear m aps

Note that since the original (the map form  $1^0$  to G(1)) is an isom orphism,  $G_{a^0}^1 = 0$  if  $a^0 \notin 1^0$ . Eqs. (268) and (269) in pose certain algebraic relations on  $_{c^0}^{ab}$  and . A unitary isom orphism between two tensor functors is described by a set of unitary maps  $h_{a^0}^a : G_{a^0}^a !$  H  $_{a^0}^a$  satisfying the equations that follow from Eq. (270).

Returning to the example of basis transform ations, let  $C = C^0$ ,  $2 = 2^0$ , but possibly  $F \in F^0$ ,  $^0 \in , ^0 \in$ . Thus we x the label types and fusion spaces while allowing di erent associativity relations. Let us further assume that G is the identity functor, i.e.,  $G_a^a = C$  and  $G_{a^0}^a = 0$  if  $a^0 \in a$ . In this case,  $a^{ab}_{c}$  is just a unitary operator acting in the space  $V_c^{ab} = (V^0)_c^{ab}$ , and is a phase factor. Then Eqs. (268) and (269) become (239) and (240), respectively. In this setting, an isomorphism between two tensor functors is described by unital complex numbers  $h_a$  satisfying Eq. (242).

E.7.4 The embedding theorem. Now, we will see the \abstract nonsense" in action. While we manipulate with de nitions, som e combinatorial magic happens behind the scenes. Basically, we turn pentagons into rectangles; this process may be viewed as a proof that the 2-skeleton of the Stashe polytope is simply connected.

Theorem E.28. For any tensor category  $\hat{C} = (C;2;1;F;;)$  there exists a strict tensor category  $\hat{C}^0 = (C^0;2^0;1^0)$  and a faithful tensor functor  $\hat{G} = (G;;)$  from  $\hat{C}$  to  $\hat{C}^0$  (where \faithful" means that the images of distinct morphisms are also distinct).

P roof (borrowed from Ref. [94]). Let  $C^0$  be the category of functors from C to itself,  $2^0$  the operation of composing two functors (usually denoted by ), and  $\hat{1}$  the identity functor. W e assume that functors act on the left, i.e.,  $(X Y)(W) \stackrel{\text{def}}{=} X (Y (W))$ . For any object X we set G(X) = [X 2], i.e.,  $G(X)(W) \stackrel{\text{def}}{=} X 2 W$ . The isomorphism  $X_{Y}$  between two functors may also be de ned in terms of its action on a test object W :

Now we simply rewrite Eqs. (268) and (269), applying them to W :

These are the conditions we need to check. But the rst and the second of them are identical to Eqs. (264) and (265), respectively. The third condition is a di erent type of triangle equation, which is shown in Fig. 19b. It follows from the standard one by Lemma E 2.

To see that the functor G is faithful, we set W = 1 and observe that a morphism h: X ! Y is mapped to G (h) (1) =  $h 2 id_1 : X 2 1 ! Y 2 1$ . Thus,



Denition E.30. A braided tensor functor is a tensor functor that commutes with braiding. More exactly, let  $\hat{C} = (C;2;1;F;;)$  and  $\hat{C}^0 = (C^0;2^0;1^0;F^0;^0;^0)$  be tensor categories furnished with braidings R and R<sup>0</sup>, respectively. A tensor functor  $\hat{G} = (G;;)$  from  $\hat{C}$  to  $\hat{C}^0$  is called braided if the following diagram commutes:

Then the identity functor  $G = id_C$  supplemented with  $A_{B} = R_{A_{B}}^{1}$  and  $A_{B} = id_1$  is a braided tensor functor from  $\hat{C}$  to  $\hat{C}^0$ . (We om it the proof.)

## Appendix F: W eak sym m etry breaking

A complete, yet to be discovered description of topological quantum order must include fusion and braiding rules (characterized by a unitary braided fusion category (UBFC), see Appendix E) as well as sym metries of the underlying microscopic H am iltonian. The no-sym metry case was considered in Sec. E.5. On the other hand, in our study of A belian anyons in the honeycom b lattice model (see Sec. 5.2) we observed a rather strange property: the translation by a lattice vector interchanges two superselection sectors. This phenom enon may be called a \weak breaking" of the translational sym metry.

Let us now consider an arbitrary two-dimensional many-body system with a symmetry group G. For simplicity, we assume that the system consists of spins (or other bosonic degrees of freedom) rather than fermions. There are several ways in which the ground state can break the symmetry that is present in the H am iltonian. First, the symmetry may be spontaneously broken in the usual sense, i.e., there may be a local order parameter. If such an order parameter does not exist, we may look for ner signs of symmetry breaking, in particular, for nontrivial action of G on superselection sectors. Such an action is described by a hom om orphism  $!_1:G!_1$ , where  $_1$  is some nite group de ned below.

But even if G does not permute the superselection sectors, there is still possibility for subtle sym m etry-breaking properties, som e of which were studied by W en [95, 96] under the rubric of \projective sym m etry groups" (PSG). W hile W en's approach is rather indirect, one m ay instead investigate the action of sym m etry transform ations on superselection sectors. For a sim ple exam ple, let us consider the H am iltonian (3) with  $J_m < 0$  (note the analogy with W en's model [96]). The ground state of this H am iltonian m ay be obtained from the  $J_m > 0$  state by putting an m-particle on every plaquette (so that any m issing m-particle would now be regarded as an excitation). Therefore an e-particle picks up the phase factor 1 when it winds around a plaquette. It follows that the translations by two basis lattice vectors com m ute up to a m inus sign when we consider their action on the nontrivial superselection sector e.

M athem atically, the up-to-sign commutation means that the translational group G = Z = Z is replaced by a central extension  $G_e$  ! G with kernel  $Z_2$ . If general, central extensions are classified by the cohomology group H<sup>2</sup>(G;U(1)). For each superselection sector a we get an extension  $G_a$ . The whole collection of extensions is characterized by a cohomology class  $!_2 2 H^2$ (G;  $!_2$ ), where  $!_2$  is some nite Abelian group (see below).

However, this is not the end of the story. Even without anyonic excitations (or if anyons exist but do not complicate the group action in any way), the system may have nontrivial properties such as the integer quantum Halle ect. The latter is described by a Chem-Sim ons term in the electron for the electrom agnetic eld. Difkgraaf and W itten [97] showed that a general topological action for a gauge eld in 2 + 1 dimensions is characterized by an element of the cohomology group H<sup>4</sup> (BG;Z), where BG is the classifying space of G. (The group G is assumed to be compact.) An analogue of the Chem-Sim ons action exists even for nite groups. In this case, BG = K (G;1) (where K (G;n) is the Eilenberg-M acLane space) and H<sup>4</sup> (BG;Z) = H<sup>3</sup> (G;U(1)) (where the rst H refers to the topological cohomology and the second to the group cohomology).

The four-level classi cation of sym m etry-breaking phenom ena is sum m arized in Table 6. It has the avor of topological obstruction theory (see e.g. [98]). One may hypothesize that there is a somehow relevant topological space Y such that  $_1(Y) = _1, _2(Y) = _2, _3(Y) = 0$ ,  $_4(Y) = Z$ , and all higher hom otopy groups vanish. We now argue that the analogy with obstruction theory has precise m athem atical meaning in dimensions 1 and 2.

Suppose that the symmetry remains unbroken in dimension 0, but can be removed (if so is desired) by introducing a small perturbation to the Ham iltonian. That is obviously possible if the system consists of spins, while the  $Z_2$  symmetry associated with fermions can never be

rem oved. The properties that survive the perturbation are described by a unitary modular category (UMC) A and a chiral central charge c, but we ignore the latter.

The action of the symmetry group G on superselection sectors can be described algebraically as well as topologically. To begin with algebra, consider the 2-groupoid = Aut(A). It has a single object, the morphism s are invertible unitary braided tensor functors A ! A, and the 2-morphism s are natural isomorphism s between such functors.<sup>29</sup> If the functors are considered up to isomorphism s, we obtain the group  $_1$  that was mentioned above. The Abelian group  $_2$ consists of all automorphism s of the identity functor. Note that  $_1$  may act on  $_2$  in a nontrivial way. The 2-groupoid is characterized by this action and a cohomology class h 2 H <sup>3</sup> ( $_1$ ;  $_2$ ).

On the topological side, one can consider the classifying space X = B, which is a topological space with a basepoint. I claim that X is connected,  $_1(X) = _1, _2(X) = _2$ , and all higher hom otopy groups vanish. Furtherm ore, the action of G on superselection sectors is described by a continuous map f:BG ! X de ned up to a hom otopy (som e explanation is given below). One may ask if f is hom otopic to a constant map. The rst obstruction to such a hom otopy is given by a hom otopy class of maps  $!_1 : BG ! K ( _1;1)$ ; such classes are in one-to-one correspondence with group hom om orphism sG ! \_1. If this obstruction vanishes, one can de ne  $!_2 2 H^2 (BG; _2) = H^2 (G; _2)$ . If  $!_2 = 0$ , then f is hom otopic to identity, or equivalently, the action of G on A is trivial.

Note that X can be represented as a bration with base K ( $_1$ ;1) and ber K ( $_2$ ;2). Its structure is characterized by the element h 2 H<sup>3</sup>( $_1$ ;  $_2$ ). If h  $\stackrel{<}{\leftarrow}$  0, then the bration does not have a cross section. In this case, the hom on orphism  $!_1 : G ! __1$  must satisfy a certain constraint, namely the inverse image of h by  $!_1$  must vanish. Thus, some seem ingly possible types of symmetry breaking in dimension 1 m ay be forbidden due to an obstruction in dimension 2.

In conclusion, I conjecture a \physical" interpretation of the space X and the map f. Speci cally, X parametrizes quantum states in the universality class described by the unitary modular category A. Each point of X is associated with a set of states that dier from each other locally; thus all nite-energy excitations of a given gapped Ham iltonian are represented by the same point. The original unperturbed system corresponds to some  $x_0 \ge X$ . To de ne the map BG ! X, let us assume that G is a compact Lie group which acts on each spin independently according to a faithful representation G ! U (m). The Hilbert space of the spin,  $C^m$  may be embedded in a large space  $C^M$ . Each embedding u has an associated state g (u) 2 X. The space E of embeddings is contractible in the lim it M ! 1, therefore its quotient with respect to the natural G-action may be regarded as a model of BG. Furtherm ore, since  $x_0$  is symmetric, the map g : E ! X factors through BG. Thus the map f : BG ! X is de ned.

R em ark F.1. It is not clear how to de ne the \extended classifying space" Y that has nontrivial hom otopy in dimension 4.0 nem ay conjecture that Y = X = K (Z;4), but this de nition seem s contrived. It may well be the case that the very idea to classify the Chem-Sim ons action as symmetry breaking in dimension 4 is wrong. Indeed, the Chem-Sim ons action is not fully described by hom otopy theory because the fundam ental hom ology class of the source (physical) manifold is involved.
