A phenom enologicalm odel of the Resonance peak in High T_c Superconductors

A notable aspect of high-tem perature superconductivity in the copper oxides is the unconventional nature of the underlying paired-electron states. The appearance of a resonance peak, observed in inelastic neutron spectroscopy in the superconducting state of the H igh T_c cuprates, its apparent linear correlation with the critical superconducting tem perature of each of the com pounds and its disappearance in the norm alstate are rather intriguing. It may well be that this peak is the signature of the singlet to triplet excitation, and is an unique characteristic of a d-wave superconductor. We develop a simple criterion for the resonance peak which is based on the concept of twist sti ness and its disappearance at $T = T_c$.

The most notable feature of the unconventional nature of the H igh T_c cuprates besides its near-neighbor singlet ground state, is its superconducting gap ; unlike conventionalB C S behavior, where , the ampltude of the gap goes up as T_c goes up, the measured as revealed by angular resolved photoem ission spectroscopy¹ goes dow n as T_c goes up! This had led som e authors² to postulate that the energy scale governing T_c is phase sti ness of the orderparam eteror the super uid density rather than the modulus of where is the superconducting condensate density. Inelastic neutron scattering in High T_c cuprate com pounds has been of im m ense help to enhance our understanding of the magnetic aspects underlying physics of H igh T_{c} .³ It told us right away without any am biguity that there are at least two clear signatures of the unconventional superconductivity: spin gap and resonance frequency. Som e general features em erge from all the compunds so far studied:

(a) Local antiferrom agnetic or singlet correlations in the norm al and superconducting states are observed , as evidenced by an incoherent background of spin excitation, S (q;!), particularly at wave vector q =; & frequency !.

(b) On the low energy side , an excitation energy gap , called spin gap E_g opens up in the superconducting state, which tends to zero at the critical hole concentration where superconductivity rst appears and is a maximum at optimum doping⁴.

(c) The most unexpected feature of the inelastic neutron spectroscopy is the emergence of an extrem ely intense and narrow peak only in the superconducting state at the resonance energy $!_r$; at q = ; that is a hallmark of each superconducting compound. (Y B a₂C u₃O_{7 x}, ⁵ B i₂S r₂C aC u₂O₈₊ 6 , L a_{2 x} S r_xC uO₄⁷). This resonance is a collective spin excitation mode where the m agnetic excitation spectrum condenses into a peak at a well dened energy. It generally disappears when T_c goes to zero and is a generic feature of all the cuprates. The striking characteristic of the resonance peak is its linear scaling with T_c; as m easured for a variety of dopings⁸.

Our main objective in this communication is to convey an underlying universality relating to the resonance peak; the simplicity of the model and its connection to underlying symmetries is its appealing feature. We assume to start with that the superconducting ground state is a d-wave singlet. In order to bring out the underlying sym metry elements of the superconducting and the norm all state, let us introduce the well known concept of superconducting phase sti ness (related to charge sti ness)⁹, spin sti ness¹⁰ as well as that of twist sti ness which is of particular relevance to near neighbor singlets and is associated with chirality. Each of these three sti nesses are associated with a distinct sym metry operation and expresses the energy increase of the system as each sym metry operation is applied. Let us consider a spinor on site i

Here the $c_{i^{"}}^{y}$ are the electron creation operator on site i in a spin state " and sim ilarly for the other spin #. There are three sets of transform ation that we can consider on the spinors, one in the charge sector, one in the spin sector and one in the twist sector.

(a) In the charge sector it is given by

where e is the electron's charge causing a rotation by an angle ' $_{\rm i}$, in the electrom agnetic gauge space. This is the one param eter transform ation of sym m etry group U (1). In any superconducting ground state, the U (1) sym m etry will be broken signifying blocking of the phase ' of the superconducting order param eter and hence a non zero superconducting phase sti ness D $_{\rm s}$.¹¹

(b) We can also rotate the spinor in the spin sector by rotating the spin through an angle i around the spin axis so that

where is the Pauli spin matrix. The group symmetry is SO (3) or SU (2). We note that if the ground state is a superconducting d spin singlet S = 0; the ground state energy will be una ected by rotation of the spin axis , whatever the Ham iltonian is and as a result the spin sti ness D , is necessarily zero : (c) The twist sti ness is best understood by introducing the chirality where we write

here the chirality operator 5^{12} transcribes the fact that the spin rotation i on site i is exactly equal and opposite to that on the near neighbor site j whence i = j = 2: This gives

If the site i and j belong to sublattice A and B; then the chiral rotation twists one sublattice around another by a rigid angle : The symmetry of the operation because of two sites is SU (2) SU (2) which is in the same hom otopy class as SO (4): If the ground state is a near neighbor singlet, the twist rotation mixes the singlet with the triplet and hence leads to increase of the ground state energy. This will be clear if we consider the four basis pair states on near neighbor sites i & j written as¹³

Here $jbi = b^y j0i \& jt i = t^y j0i$: jbi is a S = 0 singlet while the three jt i are S = 1; triplets and the four states constitute the symmetry SO (4). E ect of chiral rotation on site i& j w ith these basis wave functions. w ill give 4 4 m atrix

The twist has mixed up singlets and triplets. This makes the twist sti ness D_t \in 0 (the twist operation is nonunitary in this ground state). The Lie algebra of SO (4) is closed by the three generators that connect t am ongst them selves by pure spin axis rotation, expression (3) and by the other three generators that connect b with the three t's through the twist rotation (5). As for illustration let us a take a model ham iltonian t J ham iltonian¹⁴

Here the rst term is the electron hopping between sites i and j; t being the hopping integral while the last term is a H eisenberg antiferrom agnetic exchange interaction J between rst near neighbor spins S₁ and S_j on site i and jD oest J ham iltonian have a superconducting ground state? The rst of the gauge transform ation (expression 2) has been used to show that its sibling, the Hubbard ham iltonian (in the large U lim it) has a superconducting ground state with a nonzero phase sti ness D_s at T = 0^{15} : W hat about the twist sti ness of the H am iltonian (8)? In order to calculate the twist sti ness, we apply uniform twist ; between near neighbor sites i & j of sublattice A and B. It is convenient to transform H_o in terms of singlet and triplet pair operators using the pair representation of the spin operators 13 which we write as

Here is the chem ical potential assumed same over all space. This term is una ected by twist and we assume that the sum $b^2 + t^2$ over near neighbor pairs which is = N_{electron} is conserved. In the lim it of sm all twist the Ham iltonian gets modi ed

where j_{ij} is the spin current operator and T_{ij} is the kinetic energy operator. They are given respectively by

 $D_{\rm t}~(!~=~0)$ is the twist sti ness (in two dimensions it has the dimension of energy). It is formally given by

In the absence of the hopping term and of the spin current term, the energy increase per electron is precisely J which is the bare twist sti ness. The rst term of D $_{\rm t}$ (!)

is the diam agnetic current contribution to sti ness due to the average value of the kinetic energy while the second term rejects second order contribution of param agnetic spin current conductivity" t(!) although hj i = 0. The energy levels n are the triplet excited states for a momentum transfer ; (which has a gap E_g as measured by inelastic neutron spectroscopy). The spin current in the twisted frame is the response to a \twist vector potential" (engendered by local twist) just as the charge current is response to an electrom agnetic vector potential. The linear coe cient of the total response is the corresponding twist sti ness. We can rewrite the expression (14) more conveniently in analogy to the missing area sum rule¹⁶ of the missing D rude weight as

Here the second term on the right re ects the exhaustion of twist rigidity through incoherent spin excitation where t(!) is Im $_{?}$ (!); the trasverse spin susceptibility. From the experimental neutron data⁸, we know that Im_{2} (!) is very large at the critical hole concentration \mathcal{Q}_{h}^{c} at which $T_{c} = 0$ while Im _? (!) monotonically decreases (integrated spectral weight) in the superconducting state as optimum doping e_{h}^{opt} is approached so that we can reasonably conclude that $D_t = 0$ at $Q_h = Q_h^c$ while D_t ought to be a maximum at $\mathcal{Q}_h = \mathcal{Q}_h^{opt}$: In otherwords D_t is a correct indicator of d-wave superconductivity. The non-zero phase sti ness in conventionals wave superconductor results from broken U (1) electrom agnetic gauge symmetry. The non-zero spin stiness in a system with long range magnetic order is associated with a broken SO (3) symmetry of the rotational invariance of the spin space and D goes to zero at $T = T_N$ when the invariance is restored. W hat sym m etry or sym m etries are broken when the phase coherent singlet d-wave ground state em erges? W e m ay think of the d wave superconducting state as a state where SO (4) sym m etry is explicitly broken as well as U (1). The norm al state is then a state with zero twist sti ness where the broken SO (4) symm etry pertaining to singlet and the three triplets has been restored. If now we accept the prem ise that at T_{c} , twist stiness D_t goes to zero, then one makes the simple statem ent that kT_c is equal to the value of twist sti ness at T = 0 (strictly speaking one should use renorm alised sti ness due to triplet excitations) and we have

The expression relating spin stiness to some characteristic frequency (which we shall baptise resonance frequency $!_r$) can be written as¹⁷¹⁸

The resonance frequency $!_r$ is a small amplitude harmonic twist oscillation or rigid precession of sublattice A with respect to sublattice B: Here $_2$ (T) is the transverse spin ip magnetic susceptibility, which has its largest value at Q = ; . The transverse static susceptibility $_2$ (T) in the High T_c cuprates (as measured by N M R $\frac{1}{T_{2\,c}}$ spin -spin relaxation rate) can be parametrised as 19

where A is a phenom enogical constant. That this form of the static susceptibility in the norm alstate at T $$T_c$$ is appropriate can be checked from the imaginary part of susceptibility

which is of a form universally observed for small $\frac{1}{T}^{20}$. This behavior in the normal state probably points to proximity to a quantum critical point for spin excitation. In a temperature range above T_c the spin correlations have a rapid decay in space but a slow decay in time due to a large density of S = 1 excited states. Real part of the dynamical susceptibility $_{?}$ (q;!) would not show a narrow peak around a speci c ordering vector but Im $_{?}$ (T;!) will exhibit considerable weight at low frequency. Using expression (17) and (18) ,we obtain

This is our central result. It corroborates a posteri-




FIG. 1: Resonance frequency vs. superconducting critical tem perature T_c , extracted from references [5,6,8,21].

ori the central assumption that the coherent part of the spectral weight is very simply related to twist sti ness and emerges as coherent resonance peak; and whose intensity relates the incoherent spin excitations that have disappeared from the energy range 0 ! E_g in accordance with the sum rule (15). Superconductivity can only arise as the d wave singletsmanage to shake the triplets from the normal state soup of singlets triplets, as a result of the opening up of the spin gap E_g (;).

The expression (23) is plotted in gure (1), with neutron and $ARPES^{21}$ data superim posed. The proportionality constant a measured from g 1 gives the number 0:42 m e = K. If we are at the critical hole doping concentration \mathbb{Q}_{h}^{c} at which both T_{N} , the Neelten perature & T_{c} ; the superconducting critical tem perature are both zero, then we must have D = 0 and $D_t = 0$; signifying no long range m agnetic order and no long range super uid order; it is a quantum critical point. It is well known that Z n doping destroys T_c: It is seen by neutrons that doping with Zn introduces large low energy spin uctuations (integrated spectral weight increase, the spin gap E_{q} (;) rapidly goes to zero), that will drive D_{t} to zero suppressing ! r and killing superconductivity. The norm alstate can be de ned as a spin liquid (by de nition has no sublattice m agnetisation) w here we have considerable low energy spin excitation. W e also require that translational invariance be unbroken for the system to qualify as a liquid. Thus it describes a gapless spin liquid more in conform ity with the original suggestion of the long range RVB liquid²² In its loss of twist sti ness the spin liquid behaves like any conventional liquid loosing shear rigidity at the melting transition. The concept of twist sti ness is based on infinitesim ally sm all twist as is custom ary in these de nitions; beyond T T_c; the restored dynam ical SO (4) symmetry implies b () t pair uctuation in the spin liquid phase costing no energy around the untwisted singlet. If this symmetry persists for all twist angles then we will be in the frustrated \Henley lim \pm^{n23} of in nite classical spin degeneracy where one sublattice A will twist freely around the other sublattice B and the two sublattices are totally decoupled. Or else the system may develop a region where D_t (T $_{\rm C}$) may become negative for large twist angles generating large singlet-triplet excursions and hence may go spontaneously to a distorted or twisted ground state²⁴. A lthough twist sti ness and superconducting phase sti ness are di erent at T = 0; their sim ultaneous disappearance at T = T_c is indicated by the A rpes results²¹ of the hum p and dip structure in the electronic spectral weight and point to strong coupling of triplet and phase uctuation as T_c is approached.

Several theoretical models exist²⁵ that explain the resonance peak. Our objective in this paper has been relatively simple: can we understand the resonance peak without a detailed model and does it have some predictive ability as to the underlying symmetry nature of the norm al and superconducting state? I think the arguments given in this paper will throw some new light on these issues.
