## M ulti-species grandcanonical models for networks with reciprocity

Reciprocity is a second-order correlation that has been recently detected in all real directed networks and shown to have a cruciale ect on the dynam ical processes taking place on them. How ever, no current theoretical model generates networks with this nontrivial property. Here we propose a grandcanonical class of models reproducing the observed patterns of reciprocity by regarding single and double links as Ferm i particles of di erent 'them ical species' governed by the corresponding chem ical potentials. Within this fram ework we ind interesting special cases such as the extensions of random graphs, the con guration model and hidden-variable models. Our theoretical predictions are also in excellent agreem ent with the empirical results for networks with well studied reciprocity.

The topological properties of networks are known to a ect crucially the outcom es of dynam ical processes taking place on them [1,2]. A particularly in portant role is played by the (second-order) correlations between vertex degrees, which have strong e ects on m any processes including percolation and epidem ic spreading [2]. D irected networks have been recently shown [3] to display an additional type of second-order correlation: the nonrandom presence of m utual links between vertices, or reciprocity. Nontrivial reciprocity is found in all real networks, and provides new insights into their topology [3]. Moreover, reciprocity was recently shown to change dram atically the properties of percolation [4] and epidem ic spreading [5], and that these unexpected dynam ical properties are triggered even by a small fraction of bidirectional links [4]. However, despite its ubiquity and relevance, reciprocity is currently not reproduced by any model.

In this Letter we introduce a general theory for networks displaying nontrivial reciprocity by extending various in portant models (including random graphs [1,2], the con guration model [6{8] and the whole class of hiddenvariable models [9,10]). Since all these models can be obtained as particular cases of the general class of exponential models' [11], a unifying approach is to extend the latter to include reciprocity, so that all the particular cases are autom atically modi ed accordingly. Therefore we rst reform ulate the standard results for the exponential model de ned by the 'graph H am iltonian' [11]

where  $a_{ij} = 1$  if a link from i to j is there (and 0 otherwise), and  $_{ij}$  is the energy' (or bost') of such a link. The grand partition function and grand potential read

where is the chemical potential and

We note that is not considered explicitly in the literature [11] since its role can be played by an additional constant term in H. However, since in what follows we shall introduce more them ical species', we prefer to adopt the inverse strategy to keep and reabsorbe any constant energy term into it (this point will be made clearer below). This also allows us to obtain many expected topological properties as derivatives of with respect to . For instance, the probability p<sub>ij</sub> of a directed link from i to j and the expected number hL i of directed links read

M any static models can be recovered as particular cases of this form alism [11]. For instance, the case  $_{ij}$  = is the directed version of the random graph model:

where we have reabsorbed in a rede nition of . Another interesting case is the additive one  $_{ij} = _i + _j$ , which corresponds to the grandcanonical version [8] of the directed con guration model [6,7]:

where we have introduced the 'figacity' z = and the 'tness values'  $x_i = e^{-i}$ ,  $y_j = e^{-j}$ . We nally note that, while the above case corresponds to the choice  $i_{j} =$ 

ln  $(x_iy_j)$ , the general form  $i_j = (x_i;y_j)$  is equivalent to the whole class of (directed) hidden-variable models [9,10] de ned by the corresponding thess-dependent probability  $p(x_i;y_j)$ . Therefore all the most relevant static network models can be recovered as particular cases of eq.(1). However, in all such cases the expected reciprocity is trivial, since the probability of having a link from i to j is independent on the probability of having the reciprocal link from j to i  $\beta$ ]. In other words, if we write the reciprocity r and its random value  $r_{rand}$   $\beta$ ] as

(where  $L^{\$}$   $r_{i6j}a_{ij}a_{ji}$  is the number of reciprocated links), all the above models display the trivial expected value hri = hr<sub>rand</sub>i. The only way to have a nontrivial value of hri is adding an extra term to eq.(1):

This choice de nes the reciprocity model rst proposed in ref. [12] and recently studied analytically by Park and Newman [11] in the case  $_{ij}$  = by treating H<sup>0</sup> as a perturbation. They found that in this particular case the perturbation expansion can be resummed to all orders to give an exact expression for Z [11]. In our notation with absorbed in the nal expression for Fri in

and hri? hr<sub>rand</sub> i whenever ? 0 [11]. Therefore the reciprocity of this model can be tuned to any desired value, how ever other fundam ental topological properties (such as scale-free behaviour) discovered more recently are not reproduced. Moreover, the perturbative approach is analytically complicated and yields exact results only in the particular case described above.

A non-perturbative theoretical model which reproduces all the relevant topological properties including the reciprocity is therefore missing. We now de ne a general class of such models by regarding reciprocated and non-reciprocated links as di erent 'them ical species', each governed by the corresponding chem ical potential. In particular, we consider each pair of vertices i, j only once (say, with i < j) and regard a non-reciprocated link from i to j as a 'particle' of the chem ical species labeled by the symbol (!), a non-reciprocated link from j to i as a particle of species ( ), and two mutual links between i and j as a single particle of type (\$ ). We denote the num bers of particles of such chem ical species by  $n^{!}$  , n and n<sup>\$</sup> respectively, and the corresponding chem ical potentials by  ${}^!$  , and  ${}^{\$}$  . The num ber of reciprocated links is therefore  $L^{\,\varsigma}~=~2n^{\,\varsigma}$  , and the num ber of non-reciprocated links is  $L L^{\$} = n^{!} + n$ , so that  $L = n^{!} + n + 2n^{\$}$ . Our form alism corresponds to the decom position of any directed graph with adjacency matrix a<sub>ij</sub> into three distinct graphs, with adjacency matri $cesa_{ij}^!$   $a_{ij}$  (1  $a_{ji}$ ),  $a_{ij}$   $a_{ji}$  (1  $a_{ij}$ ) and  $a_{ij}^{s}$ a<sub>ij</sub>a<sub>ji</sub>. W e can now generalize the H am iltonian de ned in eq.(1) to the case with three chem ical species:

The grand partition function is now

where we have de ned the vertex-pair partition function

$$Z_{ij} = 1 + e^{(i_{ij})} + e^{(i_{ij})} + e^{(i_{ij})} + e^{(i_{ij})}$$

Note that, when exchanging sums and products in eq.(12), we have replaced the sum over the con gurations  $fa_{ij}^{!}g;fa_{ij}g;fa_{ij}^{s}g$  with a sum over the allowed states  $(a_{ij}^{!};a_{ij};a_{ij}^{s}) = f(0;0;0);(0;0;1);(0;1;0);(1;0;0)g$ , nonzero adjacency matrix elements being mutually excluding. The grand potential is

where  $_{ij}$  ln Z  $_{ij}$ . Our model is completely dened. For each unrepeated pair of vertices i < j, the probabilities of having a non-reciprocated link from i to j, a non-reciprocated link from j to i, two reciprocated links between i and j, or no link at all are given by

respectively. Note that form ally eqs.(15-18) are undened for i > j. However, since (!) and () are actually the same chem ical species which has been 'split' in order to consider each pair of vertices only once, we require  $p_{ij}^{!} = p_{ji}$  for i > j. Sim ilarly, we require  $p_{ij}^{\$} = p_{ji}^{\$}$  and  $p_{ij}^{=} = p_{ji}^{=}$ . This is realized by setting  $! = , !_{ij} = _{ji}$  and  $_{ij}^{\$} = _{ji}^{\$}$  for i > j. Thus it is enough to specify  $p_{ij}^{!}$  and  $p_{ij}^{\$}$  to de ne the model completely. We can write the ordinary (unconditional) probability  $p_{ij}$  and the conditional probability  $r_{ij}$  introduced in ref. [3] explicitly as

and the expected values hri and  $hr_{rand}i$  can be obtained [3] either as the average values  $hr_{rand}i = \frac{1}{16 \text{ j}}p_{ij}=N$  (N 1) and hri =  $\frac{1}{16 \text{ j}}r_{ij}=N$  (N 1) or from

Note that hri =  $hr_{rand}i$  if  $r_{ij} = p_{ij}$ . Unlike the model de ned in eq.(9), in our multi-species formalism all the terms of the Ham iltonian are equally important, with no perturbations'. As a consequence, our results are obtained in a non-perturbative way and are exact for all choices of H. This remarkable advantage allows to perform otherwise complicated analytical calculations in a very simple and direct way.

Now we consider various special cases of our model. The simplest choice  $\frac{1}{11} = \frac{1}{11}$  and  $\frac{5}{11} = \frac{5}{11}$  yields

which is the reciprocity model de ned by eq.(9) in the case  $_{ij} = w$  ith the identication  $! = and {}^{\$} = 2$ . After ! and  ${}^{\$}$  are reabsorbed in ! and  ${}^{\$}$ , this identication becomes  $! = and {}^{\$} = 2 +$ , or

and we expect to recover eq.(10) through it. We nd

and eq.(25) is indeed equivalent to eq.(10) through eq.(23). Therefore we recover the results by Park and Newm an [11] much more directly, and we can also generalize them immediately to more realistic Ham iltonians.

A nother case is the additive choice  $\stackrel{!}{_{ij}} = _{i} + _{j}$ ,  $\stackrel{\$}{_{ij}} = _{i} + _{j}$ . If we de ne the non-reciprocated out- and indegrees  $k_i^!$ ,  $k_i$  and the reciprocated degree  $k_i^{\$}$  [4,5] as

then we can rewrite the H am iltonian as

Equation (27) should be compared with eq.(7). W hile in the brdinary' con guration m odel [6,7] the degree sequences fking, fkioutg appear in H and are preserved while higher-order properties are random ized, here the sam e happens for the three degree sequences  $fk_i^{\dagger}$  g,  $fk_i^{\dagger}$  g and  $fk_i^s$  g. We can therefore denote this case as the con quration model with reciprocity. The di erence in term s of the statistical weight of graphs in the ensem ble is shown in  $\,$  g.1. The graphs G  $_1$  and G  $_2$  have the same  $fk_i^{in}g$  and  $fk_i^{out}g$  and the same  $fk_i^{!}g$ ,  $fk_i^{}g$  and  $fk_i^s$  g, and are equiprobable in both models. The same occurs for G<sub>3</sub> and G<sub>4</sub>. By contrast, G<sub>5</sub> and G<sub>6</sub> have the sam e fk<sub>i</sub><sup>in</sup> g, fk<sub>i</sub><sup>out</sup>g but di erent fk<sub>i</sub><sup>!</sup> g, fk<sub>i</sub> g and fk<sub>i</sub><sup>\$</sup> g. Therefore in the ordinary con guration model they are equiprobable, while in our model they are not. Transform  $ing G_1$  into  $G_2$  and  $G_3$  into  $G_4$  (but not  $G_5$  into  $G_6$ )




FIG.1. Possible pairs of graphs in the statistical ensemble.

can also be considered as the allowed generalizations of the local rew iring algorithm '[7] random izing a network to detect higher-order correlations. Here the reciprocity is preserved while random izing the network. This is possible since we have two fugacities  $z^{!} = e^{!}, z^{\$} = e^{\$}$ and three tness variables  $x_{1} = e^{!}, y_{1} = e^{!}, w_{1}$  $e^{!}$  determ ining the probabilities

and governing separately the various expected degrees

$$hk_{i}^{!} i = p_{ij}^{!} hk_{i} i = p_{ij} hk_{i}^{s} i = p_{ij}^{*} hk_{i}^{s} i = p_{ij}^{s}$$

The possibility to control the above degrees independently of each other is a remarkable advantage of our model. Even if all real directed networks display a nontrivial reciprocity structure [3], the modeling of dynam ical processes is mostly performed on purely directed or purely undirected networks [1,2]. However, it has been recently shown that the dynam ics of percolation [4] and epidem ic spreading [5] crucially depends on the degree sequencies  $fk_i^{!}$  g,  $fk_i^{!}$  g and  $fk_i^{s}$  g, its general properties being dierent from the simpler behaviour studied on purely undirected networks (where  $k_i^! = k_i = 0.8i$ ) or purely directed networks (where  $k_i^s = 0.8i$ ). It has also been shown that on scale-free networks bidirectional links act as percolation catalysts' [4], since even an in nitely small fraction of them determ ines a phase transition with the onset of a giant strongly connected com ponent. Thus our model provides a way to generate random networks with an explicit reciprocity structure, where dynamical processes can be studied m ore realistically.

Them ost general case with arbitrary tness-dependent probabilities  $p_{ij}^! = p^! (x_i; y_j), p_{ij}^s = p^s (w_i; w_j)$  represents the hidden variable model with reciprocity. Each vertex is now characterized by three quantities x, y, z determ ining its expected degrees through eqs.(31). As a rst example, we consider  $x_i = y_i = w_i$  8i and

where  $z^{!}$  and  $z^{\$}$  are de ned as above. This model reproduces perfectly all the topological properties of the W orld Trade W eb (W TW), where  $x_i$  is idential ed with the total G ross D on estic P roduct of each country i [3,13,14]. To see this, note that in this case the conditional probability (20) turns out to be constant and equal to the reciprocity r of the network, which is an empirical property observed in each snapshot of the real W TW [3,14]:

Then note that if we regard the network as undirected by drawing an undirected link between two vertices i and j if they are connected by at least one directed link in any direction, the probability of such an undirected link is

$$q_{ij} = p_{ij}^{!} + p_{ij} + p_{ij}^{\$} = \frac{(2z^{!} + z^{\$})x_{i}x_{j}}{1 + (2z^{!} + z^{\$})x_{i}x_{j}}$$

and the above expression is exactly the one which in ref. [13] we showed to reproduce all the topological properties of the undirected W TW. In other words, eqs.(32) describe completely the topology of the W TW, including its reciprocity. We recall that, having the form of a Ferm i function,  $q_{ij}$  1 for large  $x_i x_j$ , which im plies the quantum e ect' [8] that the W TW is not scale-free even if x is empirically found to be power-law distributed [13]. Note that this model can also be obtained from eq.(27) setting i = i = i and introducing the undirected degree  $k_i$  measured on the undirected version of the graph:

Our second example concerns shareholding networks (SN). In ref. [15] it has been shown that the brdinary' hidden-variable model successfully reproduces the properties of SN if the unconditional probability has the form  $p_{ij} = p(x_i; y_j) = y_j f(x_i)$  where  $y_j$  is the wealth invested by the agent j and  $x_i$  is the inform ation associated to the asset i. On the other hand, in ref. [3] we showed that the SN for NY SE and NA SDAQ have no reciprocated links, a property not reproduced by the above form for  $p_{ij}$ . Our m odel reproduces all these properties by setting

$$p_{ij}^{!} = y_{j} f(x_{i}) \qquad p_{ij}^{s} = 0$$

W e recall that, unlike the W TW, SN are in the classical lim it' where the empirical power-law distribution of y is re ected in a scale-free degree distribution [15].

We nally propose an interpretation of eq.(23) in terms of a them ical reaction' converting the chem ical species (!), () and (\$) into each other. Let us rst consider our system when = 0. Since in this case the graphs G<sub>5</sub> and G<sub>6</sub> in g.1 have the same statistical weight, their particles' must be connected through the follow-ing chem ical reaction which is at equilibrium :

## $(A \ \ B) + (C \ \ D) = (A \ \ B) + (B \ \ D) + (A \ \ C)$ (37)

The condition for equilibrium is obtained by replacing in the above expression each chemical species with its chemical potential, which gives \$ = 2 !, consistently with eq.(23) since = 0. When  $\clubsuit$  0 the graphs G<sub>5</sub> and G<sub>6</sub> have di erent statistical weights, meaning that the above chemical reaction occurs with the release of an additional energy' such that \$ = 2 ! + as in eq.(23). When > 0 the reaction is esotherm ic' and the production of reciprocated links is energetically favoured, while when < 0 the reaction is endotherm ic' and the production of reciprocated links is suppressed.

We have introduced the rst theoretical model reproducing the nontrivial properties of real networks including their reciprocity. Our results provide an improved characterization of the network topology and a basis for the investigation of the e ects of reciprocity on network dynam ics. These ideas, inspired by the Ferm i statistics of multispecies systems, can be directly generalized to networks with di erent types of links (in preparation).
