Convergence and Re nem ent of the W ang-Landau A lgorithm

Recently, W ang and Landau proposed a new random walk algorithm that can be very e ciently applied to many problem s. Subsequently, there has been numerous studies on the algorithm itself and many proposals for improvements were put forward. However, fundamental questions such as what determines the rate of convergence has not been answered. To understand the mechanism behind the W ang-Landau method, we did an error analysis and found that a steady state is reached where the uctuations in the accumulated energy histogram saturate at values proportional to $[\log (f)]^{1=2}$. This value is closely related to the error corrections to the W ang-Landau method. W e also study the rate of convergence using di erent \tuning" parameters in the algorithm.

I. IN TRODUCTION

C om putationalm ethods have been used extensively for solving com plex problem s in the past decades. In particular, in statistical physics equilibrium quantities of a system with m any degrees of freedom are m easured. The fram ew ork of statistical physics is form alized such that all equilibrium quantities can be derived from the partition function,

is the state of the system, E is the energy corresponding to $,k_{\text{B}}$ is the Boltzm ann constant and T is the tem perature. The sum mation is over all possible states and the number of possible states is a colossal number which cannot be enumerated. Nevertheless, computational methods such as M onte C arb techniques [1] are used to sample the partition function; in particular, M etropolis importance sampling [2] has achieved considerable success. However, new techniques are emerging and are replacing the M etropolis importance sampling especially near phase transition boundaries where the M etropolis importance sampling becomes ine cient. A class of new techniques, called the generalized ensemble methods, such as the multicanonical method [3, 4], the broad histogram method [5] and the at histogram method [6, 7], were developed based on re-writing the partition function as a sum over energies

where the partition function is reduced from a sum over all states to a sum over N energy levels. The partition function would be tractable if the energy density of states g (E) could be calculated.

Recently, a system atic, iterative, random walk m ethod [8, 9, 10] has been proposed as one of the generalized ensemble m ethods. Now generally known as the W ang-Landau algorithm, it has received much attention in literature and has been applied to a wide range of problem s [11, 12, 13, 14]. There have also been num erous proposed in provem ents and studies of the e ciency of this m ethod [15, 16, 17, 18, 19, 20, 21, 22, 23]; how ever, there are still m any unanswered questions, e.g. what determ ines the rate of convergence to the true density of states and is there any universality behavior related to this algorithm? In this paper, we attempt to quantify the mechanism behind the W ang-Landau m ethod and study the e ects of using di erent \tuning" param eters.

The W ang-Landau algorithm [8, 9, 10] is an iterative process in which the density of states g (E) is modi ed by a factor $f_k > 1$, and the renew ent of the density of states is assured with monotonically decreasing modication factors, e.g. $f_{k+1} = \frac{F}{f_k}$. For each time the energy level E is visited, g (E) is multiplied by $f_k > 1$, and a histogram of energy is accum ulated concurrently. It was proposed that the modi cation factor be decreased when the accum ulated histogram satis es a certain atness condition which we call the stopping condition. In this paper we study the e ects of di erent m odi cation factors and stopping conditions, and derive an expression for the error term in the W ang-Landau m ethod based on generalizations of the modi cation factors and stopping conditions. We shall consider arbitrary sequences of modi cation factors, f > > 1 and arbitrary sequences of corresponding stopping conditions _k ≵ f_{k+1} m ay or m ay not be the histogram atness condition; other stopping 1; 2; . The stopping conditions; 2; conditions could be used, for example, stopping after som e predeterm ined maximum num ber of M onte Carlo steps, or stopping after som e num ber of tim es the random walker reaches the minim um energy state. This generalization is needed for theoretical error analysis in the next section.

II. THEORETICAL ERROR ANALYSIS

In the W ang-Landau algorithm, for each visit to an energy level E, the density of states at that energy level increases by a factor $f_k > 1$, and the corresponding histogram increases by one. A sum e that initially the unknown density of states were set to 1, i.e. g_0 (E) = 18 E. The density of states at the end of the nth iteration is given by

$$\log g_{n} (E) = \prod_{k=1}^{X^{n}} H_{k} (E) \log (f_{k})$$

where $H_k(E)$ is the accumulated histogram and f_k is the modil cation factor for the kth iteration. At this point, it is important to realize that the relative values of g(E) are su cient for calculating therm odynamics quantities. Hence, a constant factor can be extracted from $g_n(E)$, without losing any information, by a change of variable on the histogram s,

where m in_E fH $_{\rm k}$ (E) g is the m inim um value of the accumulated histogram for the kth iteration. Then Eq. (3) becomes

$$\log g_n(\mathbf{E}) = \prod_{k=1}^{X^n} \mathbf{H}_k(\mathbf{E}) \log (\mathbf{f}_k) + \text{ constant of energy:}$$

The second term in Eq. (5) is independent of energy, and from here onwards we shall refer to g_n (E) as the density of states without the second term in Eq. (5), i.e.

To lay the foundation for deriving an expression for the error of the W ang-Landau m ethod, we use the conjecture that the m ethod converges to the true density of states with proper choice of parameters.

C on jecture 1 Let the W ang-Landau algorithm be carried out with a sequence of modi cation factors, $_k \neq f_{k+1} > _1 \neq 1$. There exists a sequence of stopping conditions $_1;_2;_1$ such that,

where g_n (E) is the density of states calculated up to the nth iteration and g (E) is the true density of states.

This conjecture does not give any error bounds on the density of states; it only says that, in the limit of an in nite number of iterations the W ang-Landau estimate converges to the true density of states. In addition, no constraint is imposed on the stopping conditions in the conjecture. The error term up to the nth iteration can be de ned as

An intuitive view of Eq. (8) is that, if an in nite number of iterations were performed, the exact answer would be obtained. When n iterations were done instead, the error of g_n (E) will be the sum of all the rest of the iterations that were not carried out explicitly. De ne

where H_k is a measure of uctuations in H_k (E). By the assumption of convergence series (in plied by Conjecture 1), the order of sum mations in Eq. (8) can be rearranged. Then, Eq. (8) becomes

Eq. (10) shows that, assuming appropriate stopping conditions, n depends only on the uctuation in the histogram and the sequence of modi cation factors f_k . When the values of f_k are predetermined (e.g. $f_{k+1} = \frac{p}{f_k}$), H_k becomes the only determining factor for n.




FIG.1: H $_{\rm k}$ versus M onte C arlo steps per site for 16 16 ferrom agnetic Ising m odel for various log(f) values. From left to right, top to bottom, log(f) values are 10 2 , 10 3 , 10 4 and 10 5 .

III. RESULTS

W e investigate the M onte C arb tim e dependence of H_k for each iteration with the W ang-Landau m ethod, where the subscript k denotes the kth iteration. Simulations were performed on the ferrom agnetic Ising m odel and on the fully frustrated Ising m odel with various system sizes. The H am iltonian is

$$H = J_{ij \ i \ j} \tag{11}$$

where the sum is over nearest neighbors on a two dimensional square grid and $_{i}$ takes the values 1. $J_{ij} = 1$ for the ferrom agnetic Ising model, and for the fully frustrated Ising model, J_{ij} takes the value 1 for every alternate horizontal nearest neighbors bonds and +1 otherwise.

Fig. 1 shows the time dependence of H_k for several values of $\log(f)$; $\log(f) = 10^2$; 10^3 ; 10^4 and 10^5 from left to right, top to bottom respectively. We used the sequence of correction factors $\log(f_{k+1}) = \log(f_k)=1:78$ with $\log(f_1) = 0:1$, this sequence is chosen so that $\log(f_{k+4}) = \log(f_k)=10$. These graphs were generated by performing the W ang-Landau algorithm on a 16 16 ferror agnetic Ising model with numerical values averaged over 128 independent sin ulations. The M onte C arb steps per spin, the horizontal axis of Fig. 1, are measured from the time when we decrease $\log(f)$. H_k increases initially and eventually saturates, and for smaller $\log(f)$ values, saturation values are greater and number of M onte C arb steps required to reach saturation are larger. Because the error term given by Eq. (10) depends only on H_k , any computational e ort after H_k become saturated does not improve the accuracy of the nal density of states q(E). On the other hand, stopping the random walk before H_k become essaturated would make the simulation less e cient because insu cient statistics are accumulated in the kth iteration and m uch m ore statistics would have to be accumulated with smaller $\log(f)$ values for subsequent iterations. An optimal algorithm is to stop the simulation as soon as H_k becomes saturated. The W ang-Landau algorithm in the original paper [8] suggested using the histogram atness condition as a stopping condition, but this does not guarantee optimal e ciency.

It is di cult to predict the saturation value of H_k for k = 1; . As shown in Fig. 1, we perform ed a set of simulations with m ore M onte C arb steps than required for H_k to reach saturation. In this way, we could measure




FIG.2: Plots of saturation H $_{\rm k}$ versus log(f) for 8 8 ferrom agnetic Ising m odel (led circles), 8 8 fully frustrated Ising m odel (empty circles), 16 16 ferrom agnetic Ising m odel (led triangles) and 16 16 fully frustrated Ising m odel (empty triangles). 128 independent simulations were performed for each data point and error bars were sm aller than the size of the symbols.

the saturation values accurately. Fig. 2 shows a plot of saturation values versus log(f) for ferrom agnetic Ising m odel (FM M) and fully frustrated Ising m odel (FFM). In double log scale, the data points fallon a straight line with the values of the slopes equal to 0.491 0.004 for 8 8 FM M, 0.501 0.004 for 8 8 FFM, 0.496 0.006 for 16 16 FM M and 0.502 0.008 for 16 16 FFM. To within error bars, the slopes seem to have an universal behavior

as predicted by Zhou and Bhatt [19]. Our results suggest that the values of the slope is generic to the W ang-Landau algorithm and does not depend on system sizes and m odels. Certainly m any m ore simulations on di erent m odels are needed to con m the universality of the slope.

IV. EFFECTS OF M OD IF ICATION FACTORS

We also boked at how the W ang-Landau algorithm performs with di erent sequences of modi cation factors. In the extreme case, we studied the elects of taking the limit of f = 1 only after a few iterations. A ssuming n iterations were performed with large modi cation factors, and on the (n + 1)th iteration, the modi cation factor is set to 1. The background for implementation is as follows: Eq. (2) uses the Boltzm ann weights (B (E;T) = exp(E=k_BT)) and the resulting energy distribution is,

$$P (E) = g (E)B (E;T)=Z = g (E)exp(E=k_{B}T)=Z$$

where g (E) is the true density of states. In general other weights can be used in sum m ing the partition function. If one chooses B (E;T) = $1=g_n$ (E), then the probability distribution of E for the (n + 1)th iteration P_{n+1} (E) will be given by,

$$P_{n+1}(E) = g(E) = g_n(E)Z$$

where $g_n \in J$ is the density of states calculated by the nth iteration. Z is is an undeterm ined norm alization constant. The true density of states can then be estimated by the accumulated histogram of the (n + 1)th iteration.

$$g_{n+1}(E) = H_{n+1}(E)g_n(E)$$




FIG. 3: C on parison of accuracy of the W ang-Landau m ethod with two modi cation sequences. D at a points were generated with the sequence $f_{k+1} = \frac{1}{f_k}$ (empty circles) and with the sequence where the limiting value of f = 1 is used after 14 iterations (led squares). Lattice size is 32 32 with energy range $E = N_E 2$ [1:55; 1:35].

This is analogous to the iteration process employed in Lee's entropic sampling [4], but we used the fast di usion of the W ang-Landau algorithm in the early stage. Fig. 3 compares the accuracy of the W ang-Landau method with two di erent modi cation sequences for the 32 32 ferror agnetic Ising model. The energy range was $E = \frac{1}{2}$ [1:55; 1:35] where $N_E = 1024$ is the total number of lattice sites. The vertical axis is the error of density of states de ned by,

$$= \frac{1}{m} \sum_{E}^{X^{n}} 1 \frac{g_{n+1}(E)}{g(E)}^{2}$$

where g (E) is the exact density of states calculated from a M AT HEM AT IC A program provided by B cale [24]. g_{n+1} (E) is the calculated density of states and m is the total num ber of energy levels in the sum mation over this energy range. We plot for dienerst sequences of modication factors. Empty circles were generated with modication factors $f_{k+1} = \frac{1}{f_k}$ (with $f_0 = \exp(1)$) and stopping when the condition $(H_{max} - H_{min}) = (H_{max} + H_{min})$ of is satisfied. Where H_{max} and H_{min} are the maximum and minimum histogram counts respectively. Filled squares were obtained with a sequence of modication factors where the limiting value of f = 1 was used after 14 iterations. The arrow indicates the location which the modication factor was set to 1. We measure the errors (led squares) at several M onte C arlo steps per site after we set f = 1. Error bars were obtained by averaging over several independent simulations. A couracy increases rapidly in mediately after setting f = 1, but in the long run, the limiting case becomes only about twice as accurate as the other sequence.

V. CONCLUSION

We derived an expression for the error term of the W ang-Landau algorithm . W ith this, we showed that the uctuation of the accumulated histogram H_k plays a central role in the accuracy of the W ang-Landau m ethod. We have also proposed that stopping each iteration as soon as H_k becomes saturated would be optimal. The dependence of the saturation values on the modil cation factor was also investigated and it was found that for the ferrorm agnetic Ising model, m axf $H_kg / \log(f_k)^{1=2}$. W ith this equation, the saturation values of

 H_k for small modi cation factors can be predicted from values obtained with larger modi cation factors. Perhaps, a more e cient algorithm can be developed. We also studied the e ects of using di erent sequences of modi cation

factors (re nement), in which we presented the limiting case where the modi cation factor is set to 1 after 14 iterations. There are signi cant in provem ents of e ciency for short simulations and improvem ents become less for longer runs.
