# A ntiferrom agnetism and singlet form ation <br> in underdoped h igh- T c cuprates: <br> Im plications for superconducting pairing

#### Abstract

The extended $t \quad \mathrm{~J}$ m odel is theoretically studied, in the context of hole underdoped cuprates. $B$ ased on results obtained by recent num erical studies, we identify the $m$ ean eld state having both the antiferrom agnetic and staggered ux resonating valence bond orders. T he random -phase approxim ation is em ployed to analyze all the possible collective $m$ odes in this $m$ ean eld state. In the static (Bardeen Cooper Schrie er) lim it justi ed in the weak coupling regim e, we obtain the e ective superconducting interaction betw een the doped holes at the sm all pockets located around $\mathrm{k}=(\quad=2 ;=2)$. In contrast to the spin-bag theory, which takes into account only the antiferrom agnetic order, this e ective force is pair breaking for the pairing w ithout the nodes in each of the sm all hole pocket, and is canceled out to be very sm all for the $d_{x^{2}} \quad y^{2}$ pairing $w$ ith nodes which is realized in the real cuprates. Therefore we conclude that no superconducting instability can occur when only the $m$ agnetic $m$ echanism is considered. The relations of our work with other approaches are also discussed.


## I. INTRODUCTION

Since the discovery of high tem perature superconducting cuprates it it has been established that the strong Coulomb repulsion betw feen electrons plays an essential role in the physics there and the $m$ agnetic $m$ echanism of the superconductivity has been studied intensively. There are two stream s of thoughts; one is the antiferrom agnetic (AF) spin uctuation exchange based on the (nearly) AF ordered state, while the other is the resonating valence bond (RVB) mechanism with the focus being put on the spin singlet form ation by the kinetic exchange interaction $J$. Ther representative of the for$m$ er is the spin-bag theory $y^{3 \prime 2} 4$ where the doped carriens into the spin density wave (SDW) state form sm all hole pockets, and exchange the AF spin uctuation to result in the $d_{x y}$ superconductivity. The $z$-com ponent of the spin uctuation, i.e., ${ }^{z z}$, gives the dom inant contribution. The RVB picture, on the other hand, puts m ore weight on the spin singlet form ation and takes into account the order param eterde ned on the bond but usually does not consider the antiferrom agnetic long range ordering (AFLRO) ${ }_{5}^{5}$ These two scenarios have been studied rather separately thus far, and the relation betw een them rem ains unclear. H su was the rst to take into account both the AFLRO and the RVB correlation at half- lling in term s of the G utzw iller approxim ation ${ }^{6}$ $H$ is picture is that the AFLRO occurs on top of the dwave RVB or equivalently the ux state. It is also supported by the variationalM onte C arlo study on H eisenberg m odel, which show s that the G utzw iller-pro jected wavefunction RVB+SDW starting from the coexisting $d-$ $w$ ave RVB and SDW m ean eld state gives an excellent agreem ent $w$ th the exact diagonalization conceming the
ground state energy and staggered m om ent ${ }^{77_{1}^{\prime \prime}}$ T he variational wavefunction projecting the simple SDW state, on the other hand, gives higher energy. These results $m$ ean that both aspects, i.e., SDW and RVB, coexist in the $M$ ott insulator. At nite hole doping concentration $x$, the AFLRO is rapidly suppressed and the superconductivity em erges. H ere an im portant question still re$m$ ains, nam ely short range AF uctuation dom inates or the RVB correlation is $m$ ore im portant. B ecause there is no AFLRO and no distinction between ${ }^{z z}$ and ,this question $m$ ight appear an academ ic one $w$ th the reality being som ew here inbetw een. $W$ ell-know $n$ results from the variationalM onte C arlo studies are that the variational wavefunction RVB+SDW has the low est energy therefore RV B (superconductivity) and SDW coexist also at sm all doping leveliq From the view point of the particle-hole SU (2) sym $m$ etry, this $m$ eans that the degeneracy, i.e., the SU (2) gauge sym $m$ etry, betw een $d-w$ ave pairing and

- ux state is lifted at nite $x$, and the form er has lower energy.

H owever this accepted view has been challenged by recent studies based on the exact, diagonalization and variational M onte Carlo method These works found that the energetically $m$ ost favorable state $w$ th $s m$ all pockets at small hole doping levels is not superconducting. This nonsuperconducting state is consistent with the doped SDW + - ux state $w$ ith the hole pockets near $k=(=2 ;=2)$. Thism eans that the $m$ ean eld picture is not so reliable at sm allx because the phase uctuation of the superconductivity is huge at sm all $x$ where the charge density, which is the canonical con jugate operator to the phase, is suppressed. O nce the superconductivity is destroyed by this quantum uctuation, the only order surviving is the AFLRO, and the system rem ains nonsuperconducting. C onsidering that the AFLRO state at
$x=0$ is well described by the SDW + (d-w ave RVB or - ux) state, the relevant $m$ ean eld state at $s m$ all but nite $x$ is $S D W+-u x$ state $w$ ith $s m$ all hole pockets.
From the experim ental side, recent ARPES datas on $\mathrm{Na}-\mathrm{CCOC}$ found the small "Ferm i arc" near $\mathrm{k}=$ ( $=2$; $=2$ ), and the $k$-dependence of the "pseudo-gap" is quite di erent from that of $\left(\operatorname{cosk}_{\mathrm{x}} \quad \operatorname{cosk}_{\mathrm{y}}\right)$ expected for the $d_{x^{2}} \quad y^{2}$ pairing ${ }^{4} d_{111}^{11} T$ his result strongly suggests that the pseudo-gap is distinct from the superconducting gap, and the superconductivity com es from some other interaction (s) di erent from J. A though only the "arc" is observed experim entally, the Ferm i surface can not term inate at som e $k$-points inside of the $B$ rillouin zone ( $B Z$ ). C onsidering that the Ferm i surface disappears $w$ th a large pseudogap at the anti-nodaldirection, i.e., near $\mathrm{k}=(; 0)$ and $(0 ;)$, it is natural to assum e that the sm all hole pocket is form ed, along half of which the intensity is sm all and/or too broad to be observed experim entally ${ }^{122}$ T hen the question of the pairing sym $m$ etry arises because $d_{x^{2}} y^{2}$ requires the nodes at the sm all hole pockets, which usually reduces the condensation energy and is energetically unfavorable. T he natural sym $m$ etry appears to be $d_{x y} w$ thout the nodes at the hole pockets $r_{\text {, }}$ as has been claim ed by the original spinbag scenario $\frac{3}{2} \mathbf{L}^{1424}$

In this paper, we study the superconductivity of the doped SDW + - ux state for sm allx. This state inchides both the RVB correlation and the AFLRO.T here are two im portante ects of this RVB correlation; one is to introduce the parity anom aly to the nodal D irac ferm ions at $k=(=2 ; \quad 2)$ and the other is to enhance the transverse spin-spin correlation com pared w ith the longitudinal ${ }^{z z}$. These two aspects $m$ ight have crutial in $u-$ ence on the superconductivity in the underdoped region. W e have em ployed the $1=\mathrm{N}$-expansion, or random -phase approxim ation (RPA), to derive the e ective interaction betw een the quasi-particles along the sm all hole pockets and the pairing force derived from it.

The plan of this paper follow s. In Section II, we discuss the m odel, form ulation, and its m ean eld treat$m$ ent. The Gaussian (second order) uctuation around the $m$ ean eld saddle point is treated and the e ective interactions betw een the quasi-particles are studied in Section ', chusions.

## II. M ODELAND MEAN FIELD THEORY

A. Form ulation of the $m$ icroscopic m odel

In term $s$ of this form,alism, the double occupancy of each site is excluded ${ }^{1} 1_{1}^{1} 12 a$. The operators $f^{y}$, $f$ are the ferm_ippic ones while $\mathrm{b}^{\mathrm{y}}$, b are bosonic ones (slave bosons) 211222 In all w hat follow s we w ill exclusively work at zero tem perature, and all the slave bosons w ill be assum ed to be condensed. (In actual calculation, we take an extrem ely low tem perature by technical reason. T he results, how ever, are saturated and can be regarded as those at zero tem perature.)

W e consider the follow ing H am iltonian on a square lattioe w th the lattice constant put to be unity and containing $N_{s}$ sites
where hi, hi ${ }^{0}$, hi ${ }^{00}$ denote nearest neighbor, second nearest neighbor and third nearest neighbor pair, respectively. W e assum e that the hopping contribution is uniform: $t_{i j}=t, t_{i j}^{0}=t^{0}, t_{i j}^{00}=t^{00}$. For $t^{0}<0 ; t^{\infty}>0$ the previous H am iltonian deals w ith hole doped ( p -type) cuprates, while the case $t^{0}>0 ; t^{\infty}<0$ concems electron doped ( $n$-type) cuprates. The unity of energy is: $t=0: 4 \mathrm{eV}=1$, and we w ill only study the hole doped case. Follow ing R ef. 1 the extended hopping term $s$, and $J=0: 3$ for the $H$ eisenberg interaction. W e have checked that slight variations in the num erical values of these param eters do not induce any signi cant m odi cation of our results, as discussed in Section'IIIC.'.

W e construct the mean eld theory to study this H am iltonian. It has been recognized that the validity of the mean eld theory is much less trivial in the theory w th constraint. The sim ple com parison of energy does not o er the criterion because the $m$ ean eld theory violates the constraint, and hence can low er the energy in the physically forbidden $H$ ibert space. Therefore the choice of the $m$ ean eld theory requires a physical intuition, and we em ploy the nonsuperconducting saddle point according to the reasons explained in the Introduction. In order to study sim ultaneously the in uences of antiferrom agnetism and ux in the resonating valence bond state, we introduce the two $m$ ean eld param eters. $T$ he rst one is a staggered $m$ agnetization

In the previous expressions a param eter has been introduced to divide the H eisenberg exchange interaction into AF part and ux part. H ere, the value of is determ ined so as to reproduce the optim ized result by the G utzw iller variational m ethod at half- lling ${ }_{2}^{\prime 6} \mathrm{H}$ ence should be regarded as a variational param eter, but we w ill keep it constant ( $=0: 301127$, as explained in Section 'IIC.' ${ }^{\prime}$ ) independently of the doping. B . Saddle point hypothesis and derivation of the $m$ ean eld $H$ am iltonian

To identify the saddle point solution we consider the follow ing assum ptions. As we work at zero tem perature, all the holons are supposed to be condensed, i.e., $\left(b_{i}\right)_{0}=b_{0} w$ ith $\left(b_{0}\right)^{2}=\mathrm{x}$ where x is the hole doping concentration. Therefore the $f$ operators can be sim ply view ed as the renorm alized electron operators. T he Lagrange $\mathrm{m} u l t i p l i e r s$ are considered independent of the sites, which signi es that the constraint is im posed on average at the $m$ ean eld level

W e have solved num erically these equations by discretizing the reduced B Z in 2 m illions ofpoints, providing us a precision on the obtained values better than $10{ }^{5}$. In particular at half- lling $(x=0)$ we have found

This assum $p-$ tion $m$ eans that the weight assigned to each of the decoupling term $s$ of the $H$ eisenberg exchange interaction is kept constant as a function of the doping. This assum $p-$ tion does not change the essential features of our results presented below.

W e present the num erically obtained values of the $m$ ean eld param eters as a function of the doping $x$ in
 a very sm all value of the doping, typically $1.5 \%$, which is in agreem ent $w$ ith the experim ental phase diagram of hole doped cuprates. This is in sharp contrast to the previous studies of the $t \mathrm{~J}$ model, which found that the A F-state could rem ain until doping values of around 15 \% .1. The ux decreases relatively linearly from at
half- 1 ling, and reaches $\quad 2$ for a doping of $10 \%$; th is result is sim ilar to the data obtained by H su et all ${ }^{32}$

We also show the shape of the Ferm i surface for three doping cases: $x=0: 01 ; 0: 05 ; 0: 1 \mathrm{in} F$ ig. ${ }^{2} \mathbf{1} \mathbf{1}$, w here the Ferm i surface is com posed of arcs which delim it the hole pockets located around the four nodes $\mathrm{k}=$ ( $=2$; $=2$ ).

In the next section we will consider the quantum uctuation around this $m$ ean eld solution. The second order Gaussian uctuation cornesppnds to the RPA. We will calculate the \a la BCS N term $s$ of the exchange of these uctuations, to see the $e$ ects of the coexistence of antiferrom agnetism and the staggered ux on the pairing force in underdoped region.

> III. GAUSSIAN FLUCTUATION AND BCS PA $\mathbb{R} \mathbb{N} G$ INTERACTION BETW EEN QUASIPARTICLES
A. Second order action and correlation functions

In this Section w e expand the action $w$ ith respect to the uctuations of the m ean eld param eters up to second order starting from the saddle point solution for the $t \quad J$

linked via the uctuation-dissipation theorem $\left.{ }^{-1}{ }^{-1}{ }^{-1}\right)$ betw een those elds.

In a path-integralform alism, the second order term of thee ective action gives easy access to the di erent correlation functions betw een bosonic elds renorm alized at a RPA levelㄹ․

The behaviour of the obtained transverse spin-spin correlation function is in agreem ent with well-known results conceming the $H$ eisenberg antiferrom agnets, as discussed in A ppendix ivi.

## B. D erivation of the e ective action

W e can now explicitly calculate the "a la B C S "In pairing potential exchanging all the collective modes descriged in the previous section. Follow ing Schrie er et al: $\boldsymbol{r}^{3,4} \mathbf{4}$ we adapt their approach to the fram ew ork of thet J m odel. $W$ e neglect,-ther, retardation e ects speci c to the E liashberg theory ${ }^{34} \mathbf{1}^{371}$. and build a pairing potentialby assum ing the static lim it ( $i!=0$ ). Therefore the frequency dependence will not be mentioned from now on. This is justi ed in the weak coupling region, where the adiabatic approxim ation $k_{B} T_{C} ; \quad S C<\sim!_{D}$ is satis ed ( $T_{C}$ : transition tem perature, $s C$ : superconducting order param eter, $!_{D}$ : frequency of the exchanging bosons). This approach is not su cient to describe the superconducting state in underdoped cuprates where the features of-the strong coupling e ect are observed experim entaly 138 H ow ever, as w ill be show $n$ below, the $m$ agnetic $m$ echanism based on the generalized spin-bag theory gives only a very sm all pairing force or is pair breaking. Therefore this weak coupling approxim ation is justi ed a posteriori, even though it does not describe the real cuprates.

xed position $\mathrm{k}=(\quad=2 ; \quad=2)$, while the other one is at $k \mathrm{~m}$ oving inside the m agnetic BZ . The intensities of the e ective interactions are plotted as a function of $k^{0}$ : for exam ple the values given for $\mathrm{k}^{0}=(=2 ;=2)$ corres-

pond to a wavevector $q_{d}=k^{0} \quad k=(;)$. As we assume the static lim it ( $\mathrm{i}!,=0$ ), the pairing potentials take real values. The dark color region $m$ eans the repulsive interaction $\left(\mathrm{V}\left(\mathrm{k} ; \mathrm{k}^{0}\right)>0\right)$, while the light region displays the attractive interaction ( $\mathrm{V}\left(\mathrm{k} ; \mathrm{k}^{0}\right.$ ) < 0). An interesting feature we can observe in $F$ igs. id and is that the total pairing potential $\mathrm{V}_{\mathrm{B}} \mathrm{c}$ s is alm ost completely driven by the $z z$ (i.e. longitudinal or "spin-bag") contribution, w ithout any $m$ ajor $m$ odication introduced by the (i.e. transverse or "RV B ") correlation. A sm entioned in Section IIA, the results displayed in $F$ igs ${ }_{80}{ }^{\prime} \overline{6}$ and 17, have been o.btained by assum ing $t=0: 3, t=0: 2$, and $J=0: 3 . W$ e have also considered several additional sets of num erical values for the param eters in the range:
$0: 35 \quad t^{0} \quad 0: 3,0: 2 \quad t^{00} \quad 0: 25,0: 3 \quad \mathrm{~J} \quad 0: 35$. W e do not have observed any signi cant m odi cation of the results. The robustness of these results $w$ th respect to slight variations of the param eter values can be explained as followed. In the present approach, the ferm ion spectrum contains tw o D irac ferm ions and associated sm all hole pockets at the nodal points. The appearance of $D$ irac ferm ions $m$ eans that a topologically nontrivial feature is introduced, which does not exist in the previous spin bag theory. Such a property gives qualitatively speci c characteristics to the system which are independent
ofslight variations of the param eter values, and therefore can explain the robustness of the results. In the next section, we will discuss the im plications of the interaction $V_{B C s}$ on the possible superconductivity in this model.

## IV . D ISC U SSION AND CONCLUSION S

In previous sections, we have calculated the e ective interactions betw een the tw o holes in the background of the AF and RVB orders. There are four half-pockets of holes in the reduced rst BZ as shown in Fig. 7, or the tw o hole pockets in the shifted B Z. T hese sm all hole pockets around $\mathrm{k}=(\quad=2$; $=2)$ are di erent from those of the sim pule,SDW state as assum ed in the originalspin-
 gnetic state includes the singlet form ation via the RVB order param eter in addition to the N eelorder, and correspondingly the wavefiunctions of the doped holes are distinct from the SD W state. A lready there opens the gap near $k=(\quad ; 0) ;(0 ;)$ due to the staggered ux, and the superconducting pairings near these points are irrelevant. H ow ever the pairing force is still dom inated by the zz-com ponent of the spin susceptibility, and is repulsive for the $m$ om entum transfer $q_{d}=(;) . W$ hen the su-
perconducting gaps at $k=(\quad ; 0) ;(0 ;)$ are dom inant, this lead.s to the $\mathrm{d}_{\mathrm{x}^{2}} \mathrm{y}^{2}$ pairing as discussed by several authors ${ }^{411}$ - since the sign of the order param eter is opposite between $k=(\quad ; 0)$ and $k=(0 ;)$. However in the present case, only the states near $k=(\quad=2$; $=2)$ could contribute to the pairing. O ne of the $m$ ain predictions of the spin-bag theory $1^{3 / 24}$ is that the superconductivty occurs through the pairing of holes in the sm allpockets, which are delim ited by the Ferm i surface as we can see in $F$ ig . ing potential $V_{B C s}$ is clearly repulsive, or pair breaking, on allthe range ofdoping for a w avevector $q_{d}$ in the $(0 ; 0)$, ( $; 0$ ) and $(0 ;)$ areas of the $m$ agnetic BZ.An attractive behaviour is also found when the $m$ om entum transfer is around ( ; ). It corresponds to relatively large values of $\mathrm{q}_{\mathrm{d}} . \mathrm{N}$ am ely, the repulsive interaction (dark contribution) near $k=(=2 ; \quad=2)$ is dom inating over the attractive (light) region with large $\mathrm{q}_{\mathrm{d}}$. Therefore as long as one considers the pairing form which is constant over each of the sm all hole pocket, there occurs no superconducting instability because the intra-pocket pair breaking force is larger than the inter-pocket foroe independently of the relative sign of the order param eters betw een di erent pockets.

O n the other hand, one can consider the pairing with the nodes in the sm all hole pockets as, in the case of $\mathrm{d}_{\mathrm{x}^{2}} \mathrm{y}^{2}$ pairing realized in real cuprates $39{ }^{\prime} 401$ In this case, how ever, $m$ ost of the interaction cancels $w$ ith in the sm all pocket due to the sign change of the order param eter. W e could not determ ine the sign of the residual pairing interaction, but we can safely conclude that it is very weak even though pair creating. Therefore we conclude that the doped staggered ux state is stable against the superconducting instability when only the m agnetic m echanism is considered. Th is is in accordance w th the recent exact djagonalization studies on the J m odelat sm all doping? Furtherm ore this suggests that the other m echanism of superconductivity is active in cuprates at least for sm allhole doping region. A-lso a related w ork has been done by Singh and Tesanovic $I^{A 21}$ w here the quantum correction to the spin-bag $m$ ean eld theory is studied up to one loop level and also the doped case is considered. T his is along the sam e line as the present study, and they also obtained the repulsive interaction betw een two holes. The new aspect introduced in our study is the RV B correlation represented by the ux order param eter. C om bining these tw o works, the pair breaking nature of the $m$ agnetic interactions seem $s$ to be rather robust in the low hole doping lim it.

There are two possible routes leading to the superconductivity. O ne possibility is that the starting $m$ ean eld ansatz becom es inappropriate for optim al doping case. A ccording to the SU (2) form ulation of the RVB state, the staggered ux state is the quantum $m$ echanicalm ixture of the ux state we discussed above and the $d_{x^{2}} \quad y^{2}$ pairing state, and the latter one is $m$ ore and $m$ ore weighted as the doping proceeds. Therefore our form u-
lation is valid only for the sm all doping region and can not capture the crossover to the superconducting state since it is based on the perturbative $m$ ethod around the AF + ux state. On the other hand, starting from the dw ave superconducting state in the $S U$ (2) form, alism, the staggered ux uctuation has been studied $\mathbf{I}^{431,44} \mathrm{~T}$ his is another language describing the instability tow ards the A F ordering, which is represented by the chiralsym $m$ etry breaking in the gauge theory. It is also found the selfenergy due to the staggered ux uctuation leads to the quasi-particle dam ping strongly anisotropic in the $\mathrm{mo-}$ $m$ entum space $1^{4 \prime \prime} T$ hese works are the approach from the superconducting side, and are com plem entary to ours.

Taking the view that the $m$ agnetic interaction is pair breaking in the low hole doping lim it, we should look for other forces which are active in the cuprates. O ne of the $m$ ost prom ising-candidates for this is the electronphonon interaction $t^{4514}-w$ wich already $m$ an ifests, itself in the angle-resolved photoem ission spectroscopy ${ }^{471 .} \mathrm{H}$ ow ever, $m$ uch m ore work is needed to establish th is scenario. Especially the interplay between the strong correlation and the electron-phonon interaction rem ains an im portant issue to be studied.

In conclusion, we have studied the extended spin-bag scenario taking into account the staggered ux resonating valence bond order in addition to the antiferrom agnetic order. T he pairing potentialbetw een the quasi-particles has been calculated at the G aussian level, and it is found that the $m$ agnetically $m$ ediated interaction is pair breaking or very weak at the sm all hole doping lim it, suggesting the other $m$ echanism $s$ such as electron-phonon interaction are active.

The behaviour of the second order action conceming the $x$ and $y$ directions of the $m$ agnetization im plies that the transverse spin-spin correlation function contains a gapless pole.
