R heology of surface granular ow s

Surface granular ow, comprising granular material owing on the surface of a heap of the same material, occurs in several industrial and natural systems. The rheology of such ow is investigated by means of measurements of velocity and number density proles in a quasi-two-dimensional rotating cylinder, half-led with a model granular material – mono-size spherical stainless steel particles. The measurements are made at the center of the cylinder, where the ow is fully-developed, using streak line photography and image analysis. The stress prole is computed from the number density prole using a force balance which takes into account wall friction. Mean velocity and root mean square (rm.s.) velocity proles are reported for dilerent particle sizes and cylinder rotation speeds. The proles for the mean velocity superimpose when distance is scaled by the particle diameter (d) and the velocity by a characteristic shear rate ($_{\rm LC} = [g \sin (m_{\rm c})]$

 $_{\rm s}$)=d cos $_{\rm s}$]¹⁼²) and the particle diam eter where $_{\rm m}$ is the static angle of friction and $_{\rm s}$ is the sliding angle of friction. The scaling is also found to work for the rm s. velocity pro les. The mean velocity is found to decay exponentially with depth in the bed with a decay length of = 1:1d. The rm s. velocity shows similar behaviour but with = 1:7d. The rm s. velocity pro le shows two regimes: near the free surface the rm s. velocity is nearly constant and below a transition point it decays linearly with depth. The shear rate, obtained by num erical di erentiation of the velocity pro le, is not constant anywhere in the layer and shows a maximum which occurs at the same depth as the transition in the rm s. velocity pro le. Above the transition point the velocity distributions are G aussian and below the transition point the velocity distributions gradually approach a Poisson distribution. The shear stress increases roughly linearly with depth. However, the variation of the apparent viscosity () with rm s. velocity (u) shows a relatively sharp transition at the shear rate m axim um, and in the region below this point the apparent u^{1:5}. The measurements indicate that the ow comprises two viscosity varies as layers: an upper low viscosity layer with a nearly constant rm s. velocity and a lower layer of increasing viscosity with a decreasing rm s.velocity. The thickness of the upper layer depends on the local ow rate and is independent of particle diam eter while the reverse if found to hold for low er layer thickness. The experim ental data is com pared to predictions of three models for granular ow.

1. Introduction

Surface ows of granular materials comprise a shallow layer of particles owing on a xed bed of the same particles. Such ows are encountered in several industrial operations as well as in nature. Industrial examples appear in the processing of material in systems such as rotary kilns (Peray 1986) and tum bling mixers (Perry & Green 1997), in the formation of heaps for storage and in the feeding and discharge of hoppers and silos (Nedderm an 1992). Natural examples are the formation of sand dunes (Andreotti, C laudin & D ouady 2002a, b; W ang & Zheng 2004), avalanches (H utter, K och & Savage 1995; H utter 1997) and transport of sedim ent in rivers (B ounhoure et al. 2002).

Surface granular ows have one unique feature that di erentiates them from other granular shear ows. The boundary' between the owing particles and the xed bed is determined by the owitself. A consequence is that interchange of particles between the owing layer and the bed is possible, and the local surface angle and the local layer thickness vary with the local ow. A lthough it is reasonable to picture the ow in terms of two distinct regions (owing layer and xed bed) separated by a sharp interface, in fact the boundary is di use and the ow decays to zero exponentially with depth. Thus a hom ogeneous and responsive boundary exists at the base of the ow which is quite di erent in qualitative terms from a ow on an inclined rough surface. Several studies have been carried out to understand the physics of surface granular ows and a review of previous work is given below.

R otating cylinders and heaps have been the prim ary system s used for the experim ental study of surface granular ows. In both systems, the major component of the velocity is parallel to the surface and the velocity pro le is found to be broadly linear across the layer (Nakagawa et al. 1993; Rajphenbach et al. 1995; Bonam y et al. 2002a; Jain et al. 2002; Longo & Lamberti 2002; Taberlet et al. 2003; Orpe & Khakhar 2004). Kom atsu et al. (2001) showed the decay of the velocity to be exponential with depth and this has been con med in several subsequent studies (Jain et al. 2002; Bonamy et al. 2002a; Longo & Lamberti 2002; Taberlet et al. 2003; O ppe & K hakhar 2004). The region of exponential decay is relatively small and there has been some focus on the velocity gradient corresponding to the linear part. Som e studies show that the shear rate is nearly constant and independent of the local mass ow rate, particularly for low mass ow rates and near 2d system s (Rajchenbach et al. 1995; Khakhar et al. 2001a; Bonam y et al. 2002a). In other cases the shear rate is found to increase with ow rate (O ppe & Khakhar 2001; Jain et al. 2002). The bulk density is nearly constant across the layer and approaches close packing (Rajchenbach et al. 1995; Bonam y et al. 2002a; Jain et al. 2002; Orpe & Khakhar 2004), indicating the highly dissipative nature of the ow.

The surface angle () is found to increase with mass ow rate in the layer (Khakhar et al. 2001a; O ppe & K hakhar 2001), how ever, in these and sim ilar studies the m easurements are made near a wall. Recently Taberlet et al. (2003) have shown a systematic e ect of the wall on the surface angle. They found that the measured increase in angle with ow rate in heap ow experiments could be accounted for by considering the elect of wall friction in a force balance. The analysis yields $\tan = \frac{1}{1} + \frac{1}{10} = 0$, where is the layer thickness, b is the gap width, $_{i}$ is the elective coellising of friction and the coe cient of friction between the particles and wall. Thus for su ciently wide gaps (=b>> 1) a constant surface angle should be obtained. This was indeed observed by Jop et al. (2005) in a system atic experimental study of the elect of gap width on heap ow. They found that the gap width between side walls also a ects the mean velocity and the depth of the owing layer. As the gap width is increased the surface angle decreases, the m ean velocity decreases and the depth of the owing layer increases. The rate of increase of surface angle with ow rate reduces with gap width, and at the highest gap width considered (570 particle diam eters) the surface angle is nearly independent of the ow rate. D ow n-channel velocity pro les measured at the free surface indicate that the range of the \walle ect" to extends to a greater distance from each wall with increasing gap width, even when the lengths are scaled by the gap width. This, how ever, may be a re ection of the fact the ow rate varies signi cantly across the gap. Courrech du Pont et al. (2005) m easured the instantaneous velocity pro les during an avalanche in a rotating cylinder. The pro les obtained at di erent tim es at the centre of the cylinder are self-sim ilar and

have an exponential dependence on the depth. The linear part of the prole, found for steady ows, is not seen. Jain et al. (2002) have reported measurements of the granular temperature, which is an important input in some models for the ow. The qualitative features of the ow remain unchanged even when the particles are completely immersed in a liquid (Jain, Ottino & Lueptow 2004).

The simplest models for surface ow comprise a depth averaged mass balance equation in the owing layer with a phenom enological equation for the ux from the bed to the layer assumed to be determined by the local angle of the surface (Bouchaud et al. 1994; Mehta 1994; Boutreux & de Gennes 1996; Boutreux et al. 1998). More detailed depth averaged continuum models also yield similar equations (K hakhar et al. 1997; D ouady et al. 1999; K hakharet al. 2001a) and agree wellwith experimental results (K hakharet al. 2001a,b). The main di erence in these models is the stress constitutive equation used. One approach is to assume the shear rate to be a known constant which elim inates the need for the stress constitutive equation (D ouady et al. 1999; M akse 1999). R a jthenbach (2003) gave a physical justi cation for a constant shear rate based on an assum ption that a single collision entirely dissipates the mom entum of both colliding particles. This yields $(g \sin = d)^{1=2}$, where is the local surface angle an estimate for the shear rate as _ of ow, d is the particle diam eter and g is acceleration due to gravity. Such an approach gives good predictions of experim ental results for rotating cylinder ow at low rotational speeds (M akse 1999). A phenom enological equation for the stress based on frictional and collisional contributions (K hakhar et al. 1997; O rpe & K hakhar 2001; K hakhar et al. 2001a) gives a som ew hat di erent expression for the shear rate

where $_{\rm m}$ is the angle of static friction, $_{\rm s}$ is the static angle of repose (angle of dynamic friction) and c is a constant. From the analysis it can be shown that the free surface angle for a steady fully developed ow with no interchange is equal to $_{\rm m}$. The continuum m odel based on the phenom enological stress equation gives good predictions of the layer thickness pro le and shear rate for both heap ow s (K hakhar et al. 2001a) and rotating cylinder ow s (O rpe & K hakhar 2001). The m odel predicts a nearly constant shear rate at low ow rates (K hakhar et al. 2001b).

M ore detailed rheologicalm odels for the dense granular ow, typical of surface ows, have also been proposed based on di erent approaches. Savage (1998) developed a kinetic theory based on strain-rate uctuations which were related to the granular tem perature. The resulting governing equations contain a viscosity term that shows a decrease with an increase in the granular tem perature, sim ilar to that for a liquid. B ocquet et al. (2001) modied granular kinetic theory equations to give a sharper increase in the granular viscosity with solids volume fraction. The model gave good predictions of the velocity pro le in a Couette ow. A two phase solid-liquid model was proposed by Aranson & T sim ring (2002), with the fraction of solid phase present locally determ ined by an order parameter. This model is described in more detail in section 3.4 and predictions are com pared to experim ental results. Josserand et al. (2004) have proposed a continuum m odel based on stress constitutive equations which depend on the local volum e fraction. The model gives a reasonable qualitative description of surface ows. Dense granular ow shave also been described by C osserat type constitutive m odels in which local couple stresses due to particle rotations are taken into account. A Cosserat m odel was proposed by M ohan et al. (2002) and predictions of the m odel for the velocity pro le were shown in good agreem ent with m easurem ents in a vertical channel ow and dense C ouette ow.

Recently Pouliquen and coworkers (M iD i2004; Jop, Forterre & Pouliquen 2005) proposed that the local shear stress in a granular ow may be expressed in terms of a shear rate (_) dependent e ective friction coe cient of the following form

where $I = d_{p} = (p_{p} = P)^{1=2}$ is the dimensionless shear rate, p_{p} the particle density and P the granular pressure. s_{p} , 2 and I_{0} are model parameters. The model is found to work well for ow on a rough inclined plane and heap ow (Jop, Forterre & Pouliquen 2005). We compare our experimental reults to this model as well.

All the models discussed above are based on a local stress constitutive equation. The high density of the ow results in multi-particle contacts and thus there is a distinct possibility of non-local transfer of stresses. Several theories have explored such ideas. Pouliquen, Forterre & Le Dizes (2001) considered the stress transfer by uctuations in the bed. The uctuations decay with distance from their point of origin. The model gives good predictions of data for dense ows in verical and inclined channels. M ills, Loggia & T ixier (1999) and B onamy & M ills (2003) have considered dense shear ows in which near vertical particle chains are formed due to gravity forces. The model gives good predictions of measured velocity pro les. P redictions of this model are also compared to our experimental data below.

The rheology of surface granular ows has not been experimentally explored in detail as yet and is the focus of this work. The objective of the present work is to carry out an experimental study and analysis of the ow and rheology of a steady, fully-developed surface granular ow. A quasi-2-dimensional rotating cylinder system (gap width 5-10 particle diameters) is used and the measurements are made in the region near the cylinder axis where the ow is fully developed and steady. Experiments are carried out over a range of particle sizes and rotational speeds, and the data are analyzed by scaling, and comparison to existing models. Section 2 gives the details of the experimental system and methods used. The results are discussed in section 3 followed by conclusions of the work in section 4.

2. Experim ental details

We rst describe the experim ental system used for this work. The experim entalm ethod based on digital photography is discussed next, follow ed by a description of the technique used for analyzing the digital im ages.

2.1. System

Experiments are carried out in quasi-2-dimensional alum inium cylinders (length b = 1 or 2 or) of radius 16 or . The end walls are made of glass for visualizing the particle motion. A computer controlled stepper motor with a su ciently small step is used to rotate the cylinders. Stainless steel (SS) balls of three di erent sizes with diameters (d) 1, 2, and 3 mm are used in the experiments. A few experiments are also carried out using 2 mm brass balls to investigate the e ect of material characteristics. B rass is a relatively heavier and softerm aterial as compared to SS. The properties of all the particles used are listed in table 1. All the particles used in the experiments are highly spherical in shape (the SS balls are used for manufacturing ball bearings). The surface of all the particles is smooth and re ective which facilitates the image analysis method used in this work.

Experiments are carried out at different rotational speeds $(! = 2 \quad 9 \text{ ppm})$ such that the ow is always in the rolling regime. The typical ow pattern, comprising a surface

owing layer of varying thickness ((x)) and the bed rotating at the angular speed of the drum (!), is shown schematically in gure 1. The particles are heavy enough and conductive so that static charge e ects are negligible. All the experiments are carried out with the cylinder half-full of particles (i.e., a ll fraction of 50%).

22. Experim entalm ethod

The measurements in the owing layer are made near the center of the cylinder (x = 0, in gure 1), where the layer thickness is maximum and the ow is nearly unidirectional and non-accelerating (velocity is nearly invariant in the x-direction). The images are taken keeping the camera close to the face plate of the cylinder and framing a small region of ow . The size of the recorded region is 2560 1920 pixels, with one pixel corresponding to 0.016 0.03 mm depending on the distance of the camera from the cylinder. A point source of light is directed nearly parallel to the face plate of the cylinder so as to illum in the polished surface of the particles, a well-de ned rejust parallel to the speed of the camera. Figure 2 shows a typical image with streaks of di erent lengths in the owing layer. The velocity of each particle is determined from the length and the orientation of the streak form ed; the analysis method is explained in 2.3. This method of velocity determination is similar to that used by R a jthenbach et al. (1995).

Im ages are taken for a range of cam era shutter speeds (1=15 1=1000 s) so as to account

for the varying velocity across the owing layer. A bout one hundred in ages are taken for each shutter speed with an overall of thousand in ages combined over dierent shutter speeds. Each experiment is carried out for about 500 revolutions with two in ages taken per revolution. Thus the ow is sampled over a considerable time period (3 h). The images are analyzed to determ ine the velocity and the number density proles across the layer.

2.3. Im age analysis

The image analysis technique involves identication of the streaks in the front layer followed by determ ination of the length and the orientation of each identied streak. Computer codes have been written to manipulate and analyze the digital images. Details are given below.

Each in age is rst converted to black and white by putting intensity values of pixels greater than a threshold to white and the rest to black. The threshold is chosen so that the streaks from the front layer are converted to white and the streaks in the back layers, which are less illum inated, to black. All the photographs are taken with a black background so as to make the thresholding easier. The thresholded image is scanned row by row to identify clusters of contiguous white pixels. Clusters smaller than a speci ed

size (75 pixels) are due to re ection of the light from the periphery of the particle surface and are elim inated.C lusters larger than this size are taken to be streaks.F igure 3a shows three m agni ed streaks in the front layer and a number of faint streaks from the back layers.F igure 3b shows the thresholded in age with faint streaks elim inated.

In the next stage of the analysis, the position, length and angle of each streak is determined by tting a parameterized intensity function to the intensity values of the streak pixels (and an immediate neighbourhood) in the original image. An intensity function of the following form is used

where $x = (X \quad X_c)\cos + (Y \quad)\sin , y = (Y \quad Y_c)\cos \quad (X \quad X_c)\sin , 21$ is the nom inal length of the streak, 2w is the nom inal width of the streak, is the orientation of the streak with the horizontal and C is the maximum intensity value obtained at the centroid of the streak. (X_c;Y_c) is the position of the centroid of the streak in laboratory coordinates (Fig. 3c).

Initial estimates of the position (X_c ; Y_c), length (21), width (2w) and orientation angle () are rst obtained for an identi ed streak from the thresholded image. The values are rened by minimizing the following function for each streak using Powell's method (Press et al. 1994)

where $I_{im age}$ is the intensity value for a pixel in the original in age at that point (gure 3a). The sum mation in (2.2) is carried over all the pixels of the streak together with six layers of pixels added to the cluster. Figure 3c shows the computed intensity values plotted on the original in age using the tted parameters.

The velocity magnitude is v = 2L = t, where t is the time interval corresponding to the shutter speed set in the camera, and the velocity components are calculated from the orientation angle, L = L(l;w) is the distance moved by the particle in the time interval t and is obtained as a function of the streak length and width using calibration experiments described below. The position corresponding to this velocity vector is taken to be the centroid of the streak ($X_c; Y_c$). A similar procedure is applied for every streak identieed in an image. Only streaks with lengths in the range 20 70 pixels are considered for analysis. This is because streaks longer than 70 pixels tend to overlap with other streaks, while those shorter than 20 pixels result in an inaccurate determ ination of the orientation angle (). The use of di erent shutter speeds gives streaks with lengths within this range at each depth in the layer. Streaks which are cut o at the edges of an image are not considered for velocity calculation.

The analysis results from all the in ages are combined and the coordinate positions for all the selected streaks are rotated by angle $_{avg}$. This angle is determ ined by averaging the angle of orientation () for all the streaks in the selected region of the owing layer, and represents the orientation of the owing layer with the horizontal. The components of the instantaneous velocity parallel (c_x) and perpendicular (c_y) to the ow direction are determined for every streak from its orientation angle. The region shown in gure 2 is then divided into bins of depth equal to the particle diameter and length 20 mm parallel to the owing layer. The pro less of the averaged parallel (v_x) and perpendicular (v_y) components of velocity are then generated by averaging the instantaneous velocities ($c_x; c_y$) over all streaks in each bin.

In a typical measured velocity prole, the average x-velocity (v_x) decreases and then

starts to increase with depth in the owing layer from the free surface. This is because velocity decreases and eventually becomes negative (due to bed rotation) with decreasing y. However, our technique cannot give the direction of the velocity vector. Hence we assume all velocities below the minimum velocity point to be negative.

The root mean square (r.m.s.) velocity and its components in x and y direction are calculated from the instantaneous velocities using following equations

where () represents an average over all streaks in a bin corresponding to a y-coordinate. The num ber density proles are obtained from a separate set of in ages at a high shutter speed (1=2000 s). Im ages taken at such high shutter speeds ensure that all streaks are short (30 pixels) and do not overlap so that all streaks in an in age can be used for analysis. This is required to get an accurate num ber count. Im ages are analyzed in the sam e m anner as mentioned above, but only the centroid positions are noted. The num ber density for any y is determined by counting the num ber of particles in each bin. A source of inaccuracy is that particles from back layers may also be counted which leads to an overestim ate of the num ber densities. This is particularly the case for the low num ber density region near the free surface. Further, the measurements represent the densities near the wall which are di erent from those in the bulk.

Experiments are carried out to calibrate the analysis technique. A single particle is glued to the face plate of the cylinder from the inner side at a position close to the periphery of the cylinder. The radial position of the particle is accurately determ ined from which the velocity of the particle can be obtained since the angular speed of the cylinder is known. The cylinder is rotated at di erent angular speeds and im ages of this particle are taken at di erent cam era shutter speeds (1=30 s - 1=500 s). The size of the recorded region and the lighting conditions are the same as those used for the m easurem ents in the owing layer. Further, the rotational speed of the cylinder and the shutter speeds are adjusted so as to generate streaks of three di erent lengths. The maximum and the minimum lengths of the streaks span the entire range of streak lengths considered for velocity measurements in the owing layer. The experiments are carried out for all the particles used in the experim ents. The length (21), width (2w), position $(X_c;Y_c)$ and orientation () of this single streak are determined in each case using the sam e analysis procedure as described earlier. The actual distance traveled by the particle at radial distance r (L = !rt) is known from the linear velocity of the particle (!r) and the shutter speed used (t). A linear relation of the following form is assumed to hold between the actual length (L) and m easured length (l) and width (w) of each streak

The constants a_1 and a_2 are determined by a least-squares t to the experimental data combined for particles of dierent sizes and materials. The typelds $a_1 = 2.05$ and $a_2 = 1.36$ with the standard error of about 1.1 pixels. Figure 4 shows a comparison of the measured and tted streaks. The experimental data are well correlated by (2.4) and indicate that the actual distance traveled by a particle depends on both the length and width parameters of the intensity function. The error in calculating L is less than 3%

(gure 4) and represents the typical error in measurements of velocities in the owing layer.

The dynam ic angle of repose ($_{\rm m}$) is taken to be the angle by which the data is rotated ($_{\rm avg}$) to obtain $v_{\rm y} = 0$. The static angle of repose ($_{\rm s}$) is taken to be the angle of the stationary free surface when the rotation of the cylinder, operating under steady ow conditions, is stopped. The values of $_{\rm m}$ and $_{\rm s}$ (averaged over six in ages) are reported in table 2 for all the cases studied. We also checked that the ow was fully developed by measuring the velocity prole at two additional locations: one 10 mm upstream and one 10 mm downstream of the layer midpoint (x = 0). Figure 5 shows the proles of the mean velocity at the three locations for one case (2 mm particles in the cylinder rotated at 3 mm). The proles are identical within experimental error, verifying the the ow is fully-developed.

3. Results and discussion

We rst present the experimental results obtained for varying system parameters. Scaling and the analysis of the experimental proles are presented next. The rheology of the ow is discussed in 3.3. Finally, we compare our experimental velocity proles with predictions of the models of Bonamy & Mills (2003), A ranson & T sim ring (2002) and Pouliquen and coworkers (Jop, Forterre & Pouliquen 2005; MiD i 2004).

3.1. Base data

The prim ary parameters varied in the experiments are the cylinder rotational speed (!) and the particle diameter (d), and the results presented below are in terms of these parameters. There is, however, a direct relation between the cylinder rotational speed and the local volumetric ow rate per unit gap width (q). A mass balance for a half-full cylinder, assuming that the bulk density in the bed and the layer are the same, yields $q = !R^2=2$, and calculated values are given in table 2. Increasing the rotational speed is thus equivalent to increasing the local ow rate.

The variation of the x component of the mean velocity (v_x) with depth (y) in the layer is shown in gure 6 for di erent rotational speeds, particle sizes and materials studied. The error bars denote the standard deviation over ten di erent data sets. All the measured quantities are plotted from y = 0 at the free surface of the ow down to about 3-4 particle diameters below the point corresponding to the minimum absolute velocity. The free surface is taken to be the point at which the measured number density is close to zero (n < 10⁻³ mm⁻²). The pro-less are linear over most of the layer depth for all the cases studied, with an exponential decay near the base of the owing layer. The negative velocities correspond to the particles in the rotating bed which move in a direction opposite to that of the owing layer. Further, the pro-less tend to atten out near the free surface. This is a low density region comprising saltating particles. The ballistic trajectories in this region are clearly seen in gure 7, which is an in age of the ow taken at a low shutter speed.

The magnitude of the maximum velocity and the depth of the layer increase with the rotational speed for a xed particle size (gure 6a). The length of central linear region of the velocity prole increases with increasing rotational speed, while the length of the exponential region near the bottom of the layer is nearly constant for all the cases. The shear rate ($_{=}$ dv_x=dy) corresponding to the linear portion increases with rotational speed. The proles for SS and brass particles are close to each other indicating that particle material parameters like coe cient of restitution and particle roughness have a

m inor e ect on the ow. This is in agreement with our earlier work (O rpe & K hakhar 2001) and that of Jain et al. (2002) in rotating cylinders. The maximum velocity decreases and the depth of owing layer increases with increasing particle diameter (gure 6b). The shear rate, thus, decreases with increasing particle size.

Q ualitatively sim ilar velocity pro les have been reported in the literature for di erent experim ental system s.A linear and an exponential region of velocity pro le was observed in rotating cylinders for various rotational speeds studied (B onam y et al. 2002a; Longo & Lam berti 2002; Zanuttigh & Lam berti 2002). The trends obtained in gure 6b for varying particle size are sim ilar to those reported by Jain et al. (2002). The system size used in all these cases is com parable to our experim ental system . The velocity pro le in the low er

halfofthe layer resembles the proles obtained by M ueth et al. (2000) and B ocquet et al. (2001) for C ouette ows. In some of the studies mentioned above (R ajthenbach et al. 1995; B onamy et al. 2002a), the attened upper low density region was not obtained.

The magnitude of the y-component of the mean velocity (v_y) is close to zero throughout the depth of the layer for all the cases (gure 8). This con m s that the ow is nearly unidirectional (invariant in the x direction) in the region of measurement. The project of the projected area fraction of the particles = n d²=4A, where n is the number of particles counted per bin and A is the area of the bin are shown in gure 9. The area fraction is nearly constant over the entire layer for all the particles with a rapid drop

near the free surface. No appreciable change in the magnitude is observed for di erent rotational speeds and m aterials. The area fractions are signi cantly sm aller than the hexagonal close packed limit ($_{\rm c}$ = 0.866). Nearly constant surface densities across the owing layer were also observed by Rajchenbach et al. (1995), Bonam y et al. (2001) and Jain et al. (2002).

The components of the rm s. velocities (u_x, u_y) across the owing layer are shown in gures 10 and 11. In both cases, the rm .s. velocity pro les are nearly linear over a large portion of the layer with a attening near the free surface and an exponential decay near the base of the owing layer. The sizes of the attened region as well as the region of exponential decay are larger for the rm s. velocity pro les than the corresponding regions for the mean velocity pro les. The rm s. velocities are smaller by nearly an order of magnitude as compared to the mean velocities. The relative error is thus larger in

this case as compared to the case of mean velocities, as indicated by the error bars. The rm s. velocities increase with rotational speed for a xed particle size. The slope of the linear region in each case is nearly independent of the rotational speed, but increases with particle diameter (i.e., $du_x = dy; du_y = dy$ decrease). The rm s. velocities for the brass balls are quite close to those for steel which again indicates that the ow behaviour is nearly independent of the rm s. velocities is clearly evident from the graphs and the rm s. velocity component in the ow direction is larger by about 50% than that normal to the ow direction. A linear and a attened region in the rm s. velocity pro les was also obtained by Jain et al. (2002) in their experiments in rotating cylinders but they found the rm s. velocities to be about 1=3rd of the mean velocity near the free surface. These values are significantly larger than the rm s. velocities obtained here.

The degree of anisotropy in the rm s. velocities across the owing layer for all the cases studied is shown in gure 12. The ratio $u_x=u_y$ (15) is nearly constant across the owing layer and independent of rotational speed, while it decreases slightly with an increase in the particle diam eter. The data for brass and SS balls is nearly the same. A zanza, Chevoir & M oucheront (1999) found the ratio of the rm s. velocity components to be 1.45 for 2-dimensional chute ows, while a ratio of 1.3 was obtained by B ocquet et al. (2001) for C ouette ows. A nisotropy in the rm s. velocity components was also observed by Jain et al. (2002) for the experiments in rotating cylinders.

We obtain the stress proles in the owing layer from a stress balance taking into account the contribution of wall friction. A ssum ing the ow to be steady and fully developed, the Cauchy equations averaged across the gap width (b) are

In the above equations $_{\rm b}$ is taken to be the constant value near the base of the $\,$ owing layer (gure 9). The bulk density in the rotating bed is obtained as $_{\rm b} = 1=2 \,({\rm m}_{\rm b}={\rm R}^2{\rm b})$, from the m easured m ass of particles in the half-led cylinder, m $_{\rm b}$, and results are given in table 1. Equation (3.4) is identical to one obtained by Taberlet et al. (2003) if $_{e}$ is replaced by the measured layer thickness (). Here we obtain $_{e}$ by numerical intergration of the experimental proles to avoid the ambiguity in dening the location of the free surface.

Equation (3.4) allows the estimation of the wall friction coecient from experimental data. Figure 13 shows a plot of the measured values of tan $_{\rm m}$ versus $_{\rm e}$ =b for all the cases studied. All the data at 3 rpm (open symols), corresponding to a xed ow rate, fall on a straight line which yields a wall friction coecient of $_{\rm w}$ = 0.09, which is a reasonable value for steel beads on a smooth surface. The data for higher rotational speeds (led symbols), which correspond to signi cantly higher ow rates, deviate from the tted straight line. This seems to imply that the elective coecient of friction ($_{\rm i}$) may be velocity dependent, as suggested by D ouady et al. (1999). In the data reported here we correct the shear stress using a wall friction coecient of $_{\rm w}$ = 0.09 in all cases.

The proles for the shear stress are shown in gure 14. The stresses are linear across most of the layer with a slight curvature near the free surface and a deviation from linearity deeper in the layer due to wall friction. The linear variation results from the nearly constant area fraction () over most of the layer. The shear stress increases with the angular speed (gure 14a), while the norm all stress shows the opposite trend. This is because m increases with angular speed. The shear stress prole is nearly independent of the particle size (d) and the material type (gure 14b).

particles for every y-coordinate and is the nearly constant layer density. The proles of the stream ing component of the shear stress norm alized by the total shear stress are shown in gure 15. Very similar proles are obtained for the normal stresses. Stream ing stresses are a signi cant component of the total stress near the free surface, and are more than 20% of the total stress in the region corresponding roughly to the attened portion in rm s. velocity proles. Deeper in the bed the stream ing stresses become negligibly small. This behaviour is consistent with the observed particle trajectories (gure 7) and the density prole (gure 9).

3.2. Scaling and analysis

We rescale the velocity procless using a characteristic velocity $v_c = cd$, with the characteristic shear rate given $c = [g \sin ((m_j)=d \cos s)]^{1-2}$ based on (1.1), and use the particle diam eter (d) as the characteristic length. A fler rescaling, the dimensionless prokes are shifted in the y direction so as to superimpose the procles. The resulting procles are shown in gure 16a. All the procless for dimensionless the variation of the mean velocity procles with particle diam eter and local ow rate quite well. Figure 16b shows the same e data but rescaled by the characteristic velocity based on the shear rate proposed by Rajhenbach (2003), $R = (g \sin m = d)^{1-2}$. The scaled procless in the y direction. From the data available it is di cult to distinguish between the two relations for the shear rate.

The rm s. velocity proles scaled using the characteristic shear rate $_{c}$ and shifted by the same distance as that for the mean velocity proles are shown in gure 17a. The scaled proles collapse to a single curve overmost of the layer except for the region near the free surface, though the relative scatter in this case is greater as compared to the mean velocity prole.

We de ne an average shear rate for a velocity pro le, _a, as the velocity gradient obtained by tting a straight line to the linear portion of the velocity pro le. An example of such a t is shown in gure 6a. We note that the magnitude of the shear rate varies depending on the number of points included in the tting. This variation is, how ever, less than 10% when the number of points that are assumed to lie in the \linear" portion are varied. Figure 18 shows a comparison between the measured shear rates and the characteristic shear rate _c . A lthough there is scatter in the data, there is reasonable agreement between the model predictions and experiment. A least squares t gives c = 0.56 which is diment from the value estimated by 0 mpe & K hakhar (2001) (c 1.5). The latter value was based on shear rates calculated assuming a linear velocity pro le across the entire owing layer. The velocity pro les are linear only in the central region of the layer and the shear rates are lower near the free surface and the bed. The shear rates

calculated by 0 rpe & K hakhar (2001) are, thus, lower than the values corresponding to the central linear part, which results in a higher value for c.

The average shear rate $(_a)$ is also proportional to the shear rate proposed by Rajhenbach (2003) $(__R)$, as shown in gure 18b. However, a linear t gives a signi cant negative intercept, with $_a = 1.26(__R 16.9)$. This comparison indicates that $__C$ may give a better description of the ow than $__R$.

A sem i-log plot of the velocity pro le indicates that the exponential region of the velocity pro le spans 3-4 particle diam eters (gure 19).We t straight lines to this data to obtain the characteristic decay length, , de ned by

where v_0 is a constant of proportionality. The variation of the characteristic length with the particle diam eter (d) for the di erent cases studied is shown in gure 20a. The values of depend on the particle size (d), but are nearly independent of rotational speed and material type. A linear t to the data yields =d = 1:1 0.2. This result indicates a relatively sharp decay of the velocity with depth in the bed since the characteristic length is just a little more than one particle diam eter. A linear variation of the characteristic decay length with particle diam eterw as obtained by K om atsu et al. (2001) for exponential region in heap ow. A signi cantly larger characteristic length (10d) was obtained by M ohan et al. (1997) for dense ows in a vertical channel.

An exponential decay is also found for the portion of the rm s. velocities near the base of the layer. A plot of the characteristic length with the particle diam eter obtained from ts to the rm s.velocity (u) is shown in gure 20b. A linear t to the data yields =d = 1.7 0.3. Thus the rm s.velocity decays slightly slower with depth than the m ean velocity.

3.3. Rheology

The variation of the measured quantities with depth in the layer for one case are shown side-by-side in gure 21 to give an overall qualitative view of the rheology. The shear rate prole, obtained by numerical di erentiation of them can velocity prole $(_(y) = dv_x = dy)$, is shown in gure 21d. For all the cases studied, the shear rate increases to a maximum with increasing depth and then decreases as the xed bed is approached. We note that a relatively sm ooth curve is obtained as a result of the averaging with the bin size equal to the particle diam eter. An oscillating shear rate prole is obtained, as reported in previous works (M ueth et al. 2000; M ueth 2003; H ill et al. 2003), if a sm aller bin size is used. The uctuations in the shear rate prole arise from the magnication of errors as a result of taking a derivative of the velocity prole data. The uctuations are larger for higher rotational speeds and sm aller particles. The results indicate that the velocity prole is not linear anywhere in the owing layer, although the region around the maximum may be approximated to be linear. The shear rate decreases to a sm all value near the free surface.

The graphs in gure 21 indicate that on the basis of rheological behaviour, the layer can be considered to comprise two regions with di erent ow characteristics. Above a critical depth, y_c , corresponding to the depth of the shear rate maximum, the shear stress increases with shear rate. How ever, in the region below y_c , the trend is reversed and the shear stress increases while the shear rate decreases. There also appears to be a transition in the rm s. velocity at y_c : above y_c the prometer is nearly at, whereas it decreases with depth below y_c . Similar results are obtained for all cases studied.

Figure 22 shows a comparison of proles for 2 mm particles and di erent cylinder rotational speeds. All graphs for a particular rotational speed are shifted along the y axis so that the area fraction proles superim pose on each other. This ensures that the free surface in all cases is located at the same y position so that depths may be compared.

The transition in the ow is seen in all the cases and the data indicate that y_c increases with rotational speed. Figure 23 shows a comparison of pro les for di erent diam eter particles rotated at 3 rpm . In this case the depth is rescaled by the particle diam eter before shifting the graphs to superim pose the area fraction pro les. The results indicate that the scaled depth decreases with increasing particle diam eter. Finally, gure 24 shows data for 3 mm particles for two di erent gap widths (b). A lthough the mean velocity and rm s. velocity pro les are slightly di erent for the two gaps, the transition depth does not depend on the gap width.

Evidence for transition in the ow is also seen in the velocity distributions. Figure 25 shows the velocity distributions at di erent locations in the layer for 2 mm particles rotated at 3 pm . The distributions vary signi cantly with depth in the layer. The c_v distribution is G aussian for all points above the transition point (y y_c) (gure 25b). Below the transition point ($y < y_c$) it gradually evolves to a Poisson distribution with increasing

depth in the layer (gure 25d). The c_x distribution is G aussian above the transition point (gure 25a). However, at and below the transition point the behaviour is complex and bim odal distributions are obtained at varying locations in the layer (gure 25c). Sim ilar behaviour is obtained for all the cases studied. The c_y distributions below the transition point are qualitatively sim ilar to the distributions obtained by M ueth (2003) for dense C ouette ow.

In the region below the transition depth (y_c) , the decrease in shear rate with depth, accompanied by an increase in shear stress with depth, in plies a sharp increase in the apparent viscosity, de ned as $= y_x =$. Figure 26 shows the variation of the apparent viscosity () with the rm s. velocity (u). The granular temperature is $T = u^2$, thus gure 26 m ay be considered to be analogous to the variation of viscosity with temperature in m olecular uids. The viscosity varies by m one than three orders of m agnitude and all the data show qualitatively sim ilar behaviour. Near the free surface the viscosity is low

and increases at constant u, essentially due to the increase in the volume fraction of solids. Below the transition point there is a gradual increase in viscosity with depth corresponding to a decreasing u. The variation of with u in the region just below the transition in all cases is power law with an exponent of about 1:5. At lower values of u the curves turn upward and rate of increase of appears to become higher.

Figure 27 shows the variation of the rm s. velocity (u) with shear rate (_). There is a power law dependence between the two in the region below the transition corresponding the high density region. The exponent () is independent of the particle diam eter (gure 27a), but appears to decrease system atically with increasing pm, ranging from = 1 for low rotational speeds to = 0.5 for 9 pm. How ever, data over a wider range are required to verify these results. Power law variation between the rm s. velocity and the shear rate have been obtained previously by B ocquet et al. (2001) and M ueth (2003) for dense C ouette ow s. The value of the exponent reported by them is around = 0.5. A zanza et al. (1999) found = 1 for rapid ow s.

The above results indicate the presence of two regimes in the owing layer with a sharp transition point. In the upper region near the free surface, the behaviour is uidlike and the velocity distributions are M axwellian. Below the transition point them aterial appears to be an am orphous soft solid, increasing in strength with depth in the layer. The transition to this solid-like regime occurs at a relatively large rm s. velocity (0:1

m /s). Qualitatively sim ilar behaviour is obtained for di erent particles and operating speeds.

W e conjecture that the sharp transition occurs because of the form ation of a percolated network of particles in extended contact with each other. This is in contrast to the uid-like regime where the particles interact through collisions. The contact network coexists with uid-like dom ains and the fraction of particles which are part of the network increase with depth. This picture for the region below the transition point is broadly consistent with recent measurements of Bonam y et al. (2002b) in which the owing clusters were identied, as well as with non-local models based on the coexistence of particle chains and uid-like material (Mills et al. 1999; Bonam y & Mills 2003).

Table 3 gives the thickness of the uid-like ($_{\rm f}$) and the solid-like ($_{\rm s}$) regions obtained from the data in gures 22 and 23. The data indicates that the thickness of the uid-like layer is independent of the particle diam eter but depends on the rotational speed (i.e., the local ow rate, q). In contrast, the thickness of the solid-like region is independent of rpm but proportional to the particle diam eter. The latter result is consistent with the nding that the characteristic length for exponential decay of the velocity () is proportional to diam eter but independent of rotational speed.

3.4. Comparison to theory

Bonamy & M ills (2003) proposed a non-local model for the surface ow of granular material, based on an earlier work by M ills et al. (1999). The model assumes the owing granular medium as a network of transient particle chains, immersed in an assembly of particles behaving as a viscous New tonian uid. The stresses are then propagated through these chains in a non-local manner. The total stress is expressed as a linear combination of C oulom bic frictional stresses, viscous stresses and the stresses due to the embedded chains.

The model equations, simplied for the case of surface ows in rotating cylinders for low rotational speeds (!), when inertial stresses can be neglected, yield an analytical expression for the velocity (v_x) pro le (Bonamy & M ills (2003))

where is a function of the characteristic correlation length of the transient chains. The shear rate (_) and the characteristic length () are parameters of the model. Using the mass balance equation at the centre of the cylinder, gives the following expression for the layer thickness

Equations (3.7) and (3.8) are used to calculate the velocity proles across the owing layer. The shear rate in each case is taken to be the value obtained by tting a straight line to the linear part of the experimental prole (_a, gure 18). The values of the correlation length are found to be related to the particle diameter as =d = 4 for all the cases.

The predicted and the experim entalpro les are shown in gure 28. The model predicts the exponential and the linear part of the velocity very well for all rotational speeds and particle sizes, but does not predict the attening of the pro le near the free surface. For the case of of 3 mm balls, the layer thickness calculated from (3.8) overpredicts the

experimental layer thickness resulting in the shift of the predicted prole (dashed line in gure 28b). The reason for this m ismatch is the experimental diculty in correctly identifying the location of the free surface. If, for this case we use the layer thickness value obtained from the experimental velocity prole, a good t is obtained.

A ranson & T sim ring (2002) proposed an order parameter description for the uidization transition in granular ows. The order parameter speci es the fraction of the solid and uid parts of the stress tensor, and is related to the number of particles in contact with a given particle on the average (coordination number). The dynamics of the order parameter (p) are assumed to be governed by the G inzburg-Landau equation which reduces in the case of a steady, fully-developed unidirectional ow to

Volfson, T sim ring & A ranson (2003) found p = 0.6, A = 25 and = 0.26 from two-dimensional discrete element simulations for D = 2. where is the viscosity. Simulations for 2d system s indicate = 12. In the above equations (3.9 - 3.11), all quantities are m ade dimensionless using appropriate combinations of m, g and d.

W e obtain the prole of the order parameter in the layer by numerical solution of (3.9) using a shooting method with the experimentally obtained prole for the local friction coecient ((y)) as an input. The free surface is assumed to be a noux boundary for the order parameter (D dp=dy = 0 at y = 0) and a pure solid (p = 1) is assumed far

from the free surface (y = A >> 1). The proles are independent of the domain depth (A) when it is large enough. The shear rate $(= dv_x = dy)$ proke is then calculated from (3.11a) using the experim entally obtained shear stress pro le.

The computed shear rate pro les are compared to experim entally measured pro les in qure 29. This is a more stringent test as compared to matching the model to the m easured velocity pro les. P redictions of the shear rate pro le using the param eters from 2d simulations give qualitative agreement with experimental proles. One such calculation for 2 mm particles rotated at 3 rpm is shown in gure 29 (long dashed line) using the values given above for A, D and , but taking = 0:4. The latterwas necessary since no solution satisfying the boundary conditions was obtained for = 0.26 for the particular experimental pro le for (y) used. We found excellent quantitative agreement between the model and experimental results using A = 5 and D = 2 for four of the cases and A = 10 and D = 2 for one case, as shown in the gure 29. However, di erent values of are required to get a good t and these are given in table 4.W e found and that essentially determ ines the depth of the layer and thus was adjusted to match the experimental and theoretical depths. The viscosity () is a proportionality factor and we calculated it as the ratio of the maximum computed shear rate to the maximum experimental shear rate for each prole. Once A and D are xed, the calculated values of

and are thus uniquely determ ined. The parameter A did not signi cantly a ect the shape of the pro lesw hen varied over a signi cant range (A 2 (5;25)), but determ ined the for which solutions satisfying the boundary conditions could be obtained. range of Similarly, changing D over narrow ranges close to D = 2 did not change the proles signi cantly, but strongly a ected the range of for which solutions could be obtained. The graph of the order parameter variation with depth for all the cases is shown in gure 30. Note that according to the model, the material is not a pure uid (p > 0) at the free surface (y = 0).

The values of the param eter correlate well with the elective friction coecient $(_{i})$, also given in table 4. Thus depends on the frictional characteristics of the material as may be expected. The viscosity is nearly constant for di erent particle sizes and increases with rotational speed. The latter may be expected given the increase in the granular tem perature with rotational speed.

Finally, we compare the experimental results obtained to the rheological model of Pouliquen (12). A direct comparison is possible in this case since and I can be estimated from experimental data. Figure 31a shows the variation of the local coe cient of friction () with the scaled shear rate (I) for the dimensional sets. The data sets are truncated and only the points in the dense ow region below the shear rate maximum are shown. The data for the lower rotational speeds are all clustered to egther while the values of

for the higher rotational speeds are signi cantly higher. This follows from the higher values of $_{1}$ for the higher rpm data seen in gure 13. We take $_{s}$ to the value of (I) extrapolated to I = 0. The range of $_{s}$ for the low rpm data corresponds to angles ranging from 17 to 20 deg., which re ects the error in estimation of . The values are in reasonable agreem ent with the results of Jop et al. (2005). Figure 31b shows the variation of ($_{s}$) with the scaled shear rate (I) for 2 mm particles and for di erent cyinder rotational speeds (3, 6 and 9 rpm). The collapse of data is reasonable, and the solid line is a t to all the sets combined. The tyields = ($_{2}$ $_{s}$) = 0.29 and I₀ = 0.49. The values reported by Jop et al. (2005) are = 0.261 and I₀ = 0.279, and a plot of the m odel using these values is shown in gure 31b (dashed line). The di erence between the two is not very large considering the the di erent m aterials used here. Fits of the m odel gave slightly di erent m odel param eter values for 1 mm particles (= 0.18, I₀ = 0.48)

and 3 mm particles (= 0.20, $I_0 = 0.43$), but only one set of data was available for thing in each case.

4. Conclusions

A n experim ental study of surface ow in quasi-2d rotating cylinders is carried out using streak line photography. Experiments are performed for a wide range of rotational speeds and particle sizes. The mean velocity proles are linear overmost of the layer depth for all the cases with an exponential decay near the base of the owing layer and a attened region near the free surface. The rm s. velocities are nearly constant in a region near the free surface followed by a linear decrease over part of the layer and an exponential decay into the bed. Further, the rm s. velocities show a distinct anisotropy, with the component in the ow direction larger by a factor of about 1:5 than that perpendicular to the ow direction. The number densities are nearly constant across the owing layer with a sharp decrease near the free surface. The shear and the normal stresses increase linearly with the depth of the owing layer initially, but the shear stress deviates from near the free surface. The experimental velocity pro les reported here are broadly similar to those in previous works, however, a wider range of system parameters is explored in this work.

The experim ental data is analyzed in several ways. A simple scaling is found to work very well. The mean velocity proles for dilement cases scaled using the shear rate from 0 mpe & Khakhar (2001) and the particle diameter collapse to a single curve. A similar scaling works well for the rm s. velocity except for the region near the free surface. The shear rate obtained from a least square t of the linear portion of the mean velocity prole is reasonably predicted by the model shear rate (1.1) but with a dilement value for the empirical constant (c). The mean velocity and rm s. velocity proles near the base of the layer are well described by an exponential function of the form exp(y=), and the characteristic decay length () is proportional to the particle diameter (d) in

both cases, with 1:1d for the mean velocity and 1:7d for the rm s. velocity. Thus the rm s. velocity decays more slow ly than the mean velocity.

The shear rate prole obtained by numerically dimentiating the mean velocity prole data indicates that the shear rate is not constant anywhere in the layer but increases to a maximum and then decreases to zero with depth in the layer. A transition in the rms. prole occurs at the same depth as the shear rate maximum : above the transition depth the rms. velocity is nearly constant whereas below the transition depth it decreases with depth. Evidence of a transition is also seen in the variation of the velocity distributions with depth: A bove the transition point the distributions are G aussian and below the transition point the velocity distributions.

The rheology of the ow is characterized in terms of the variation of the apparent viscosity with rm s. velocity. The curves indicate a relatively shap transition at the shear rate maximum, and in the region below this point the apparent viscosity varies as $u^{1:5}$. The transition observed in the measurements appears to be a percolation type of transition, in which there is an increasing fraction of particles below the transition depth which are conned, due to form ation of a network of particles in extended contact with each other. From the view point of rheology, the ow comprises two layers: an upper low viscosity with a nearly constant rm s. velocity and a lower layer of increasing viscosity with a decreasing rm s. velocity. The thickness of the upper layer depends on the local ow rate but is independent of the particle diameter. In contrast, the lower layer thickness depends of the particle diameter but is independent of ow rate. Thus after establishment of the lower layer any further increase in the local ow rate results in the material passing through the upper layer. The rheological characteristics of the two layers are di erent.

P redictions of both m odels for the m ean velocity m atch the experim ental velocity proles reasonably well. The m odel of B onam y & M ills (2003) requires only two param eters : the shear rate, which can be independently obtained and the characteristic length which is found to be related in a simple way to the particle diam eter (= 4d). Thism odel, how ever, does not describe the low density region near the free surface. The m odel of A ranson & T sim ring (2002) describes the entire velocity prole, how ever, experim ental m ethods for independently estimating the param eter values need to be devised. A comparison of the predictions of the rheological m odel proposed by Pouliquen (Jop et al. 2005) to experimental data also show s reasonable agreement when the increase in friction coe cient with shear rate is considered. How ever, the coe cient of friction is found to be significantly higher at high local ow rates (corresponding to high rotational speeds) which is not in agreement with the m odel. The m odels considered show prom ise for prediction of the m ean velocity prole and e ective friction coe cient. M ore detailed rheological m odels are required for predicting rm s. velocities and velocity distributions which are important for transport.

The results presented in this paper give a reasonably detailed picture of the rheology of surface granular ows in quasi-two-dimensional systems. Although the results may be expected to to valid in qualitative terms for 3d systems, wall elects cause signi cant quantitative dimensional systems. The walls impose two elects: one is side wall friction, which is accounted for approximately in this work, and the second is ordering by the steric elects of the side walls. The measurements of Courrech du Pont et al. (2005) indicate that wall friction results in the velocity at the side wallbeing about 20-30% lower than that at the middle of the gap. Our preliminary results indicate that the elects of ordering may be larger: the mean velocity in long cylinders is about half of that for a comparable quasitwo-dimensional system. Thus the ordering appears to reduce the elective viscosity of the system. Modelling such wall elects remains a challenge.
