Quantum transitions induced by the third cumulant of current uctuations

W e investigate the transitions induced by non-G aussian external uctuations on a sm all quantum system. The rates for the transitions between the energy states are calculated using the real-time K eldysh form alism for the density m atrix evolution. We detail the elects of the third cum ulant of current uctuations coupled to a quantum system with a discrete level spectrum and propose a setup for detecting the frequency-dependent third cum ulant through the transitions it induces. We especially discuss a scheme where the uctuations are coupled to a Josephson ux qubit.

The study of uctuations has been in the center of interest in physics for decades. The relevance of noise and uctuations is underlined by the fundamental relation between uctuations and dissipation in physical systems. One very concrete example of uctuations is the current noise in electric circuits. At equilibrium, it obeys the uctuation-dissipation theorem which relates the magnitude of uctuations to the temperature and the impedance of the circuit. For a quantum system with a nite number of levels interacting with an environment, the magnitude of these uctuations in the environment then determines the steady state of the system, along with the rate with which this steady state is approached.

During the past decade, the theory of electric uctuations in mesoscopic systems has been signi cantly developed to characterize them also out of equilibrium $r^{1,2}$ where a nite average current leads to shot noise. The study yields inform ation about the m icroscopic physical phenom ena inside electric conductors and the e ects of the electrom agnetic environm ent on m esoscopic circuits. In large wires the current statistics is G aussian and fully characterized by the average current and the noise power. The experim ental developm ent in m anufacturing sm aller circuits has enabled the study of the non-G aussian character of uctuations in mesoscopic samples.^{3,4} In principle, the know ledge of these uctuations allows for an im proved characterization of the conductors,¹ or the study of the e ect their non-G aussian character causes on other m esoscopic system s.^{5,6,7,8}

W ith a nonvanishing average current, the probability distribution of current uctuations no longer needs to be sym m etric around the average current. In particular, the third cum ulant of uctuations describing the skewness of the current distribution m ay be nite. It is also the low est cum ulant indicating a non-G aussian distribution. D espite the strong theoreticale ort describing the nature of the higher-order cum ulants,¹ m easuring even the third cum ulant with conventional techniques has turned out to be di cult and so far its only m easurem ents exist for the case of a tunnel junction.³ The attention is thus turning tow ards using other m esoscopic systems as uctuation detectors.^{5,6,9,10,11}

In this P aper we analyze the transitions caused by external uctuations on a probe quantum system. First, we present a formula correcting the G olden Rule transition rates by taking into account the next order e ects that are dependent on the third cum ulant. This is essential in developing generic methods for detecting non-G aussian uctuations. We can establish conditions imposed to suitable probes of third-cum ulant induced excitations. A lthough we concentrate on current uctuations, our general analysis is independent of the physical system as long as the uctuations are linearly coupled to the probe system. To demonstrate the results, we consider a quantum two-state system (qubit) as a probe candidate and propose a setup form easuring the e ects of the frequency-dependent third cum ulant of current uctuations by a Josephson ux qubit.^{12,13} This can be viewed as a generalization of using qubits as spectrom eters of the quantum noise power,¹¹ a method which has already been experimentally demonstrated.¹⁴

Our starting point is the Ham iltonian

where H_{ext} and H_s describe the environment where the current uctuates and the quantum system we use as a probe for the uctuations, respectively, and H int is the interaction H am iltonian between the environm ent and the probe. M otivated by the case of a current-biased Josephson junction and the magnetic interaction between two circuits considered below, we study the bilinear coupling of the form H int = g I . Here I is the current uctuation operator acting on the environm ent, is an operator acting on the probe system and g is the coupling constant of the interaction. We assume that the quantum system is described by a set of energy eigenstates finig and the average current e ect ghli is included in H_s. Treating H $_{\rm int}$ as a perturbation, the Ferm iG olden Rule predicts the transition rate $\binom{(2)}{n! n^0} = \frac{2 q^2}{r^2} j_{n n^0} f S_{I} \left(\frac{E_n E_{n^0}}{r} \right)$ between the eigenstates of the probe system .¹¹ The matrix element is de ped as $n n^0 = \ln j jn^0 i$ and the noise power $S_{I}(!) = \frac{1}{2} \int_{1}^{K_{I}} e^{i!t} h I(t) I(0) dt$. The low est-order estimate ⁽²⁾ is thus proportional to the second cum ulant of current uctuations. The correlator in the above expression is calculated with respect to the environm ent $\operatorname{H}\operatorname{am}$ iltonian $\operatorname{H}\operatorname{_{ext}}$ as if the probe system did not exist. Below, we correct the transition rate (2) by calculating the next order contribution ⁽³⁾, depending on the third cum ulant.

W e solve the density matrix evolution using the realtime K eldysh m ethod, as outlined in Refs. 15,16, which is

a natural form alism for studying a sm all subsystem in a larger environm ent. W e are interested in the dynam ics of the probe system in particular, so we study the reduced density operator $(t) = Tr_{ext tot}(t)$ where tot is the density operator for the system and the environment. The trace goes over a com plete set of environm ent states. The idea is to solve the tem poral evolution of a diagonal elem ent of the reduced density matrix $n^{0}n^{0}$ (t) = $hn^{0}j$ (t) $\dot{n}^{0}i$ with the initial condition $nn(t_0) = 1$ ($n \in n^0$). In the long-time lim it $n \circ n \circ (t)$ is proportional to the total evolution time t to, the coe cient being the transition rate $n! n^{\circ}$. We calculate the rates between wellspecied states of the reduced system . Therefore, without loss of generality, we use an initial state of the form $tot (t_0) = ext (t_0)$ (t_0), where $ext(t_0)$ describes the initial state of the environm ent.




FIG.1: Six diagram s contributing to $\binom{(3)}{n! n^0}$. Each diagram represents tem poral evolution from the initial state jnihn j to the nalstate jn^0ihn^0j . The dots represent interaction vertices g I and the horizontal lines forward and backward propagation in time.

As the lowest-order contribution to $n! n^{\circ}$ is the well-known G olden-Rule result $\binom{(2)}{n! n^{\circ}}$, we concentrate on the next order contribution $\binom{(3)}{n! n^{\circ}}$. The total rate is then given by $n! n^{\circ} = \binom{(2)}{n! n^{\circ}} + \binom{(3)}{n! n^{\circ}}$. Treating H int = g I as a perturbation and using the graphical rules derived in Ref. 15, we nd six di erent diagram s contributing to $\binom{(3)}{n! n^{\circ}}$, see Fig. 1.

To present the result in a compact way we de ne a correlator

where f denotes the anti-tim e-ordering operator. The tim e-dependent correlator is calculated with respect to the free external H am iltonian H_{ext} with the density operator $_{ext}(t_0)$. We assume H_{ext} to be independent of time and $_{ext}(t_0)$ to describe a stationary state with respect to H_{ext}. Our results can be also stated with the help of the Fourier transform of h I (t_0)T [I(t_0)]i, which is the complex conjugate of the previous correlator, so it is a matter of choice which one to use. Our de nition of the frequency-dependent third cum ulant (2) di ers from the one studied in Ref. 17, which consists of the sum of all possible K eldysh orderings. W hereas that de nition

is relevant in studying the evolution of the o -diagonal density matrix dynamics, transition rates cannot be obtained from that form. If the state of the environment is invariant under time reversal as usually in equilibrium at low magnetic elds, the correlator (2) vanishes.

Evaluating and summing the di erent contributions shown in Fig. 1, we obtain the result

The sum m ation is extended over all the eigenstates of H_s and denotes a positive in nitesim alquantity. W ith the help of the identity $\frac{1}{x x_0} = P \frac{1}{x x_0}$ i (x x), where P stands for a principle value integral, we can write (3) in the form

Even without the knowledge of ${}^{3}I(!_{1};!_{2})$, the general results (3,4) contain som e inform ation about the requirements made for the meter designed to detect the thirdcumulant e ects. The structure of the product of the matrix elements n_{inj} restricts the possible physical realizations used in detecting the transitions induced by the third cumulant. Generally the operator should either couple several states of the system, or both matrix elements n_{in+1} should be nite.

Next we turn to study the case where the probe system is a qubit. The system H am iltonian can be written as $H_s = \frac{1}{2}B_z \ z \ \frac{1}{2}B_x \ x$ and the interaction term as $H_{int} = g \ I_z$. The system H am iltonian has the eigenstates $E_1 i = j'' i + j \# i, E_0 i = j'' i + j \# i$ and the eigenenergies $E_1 = \frac{1}{2} B_x^2 + B_z^2$, $E_0 = \frac{1}{2} B_x^2 + B_z^2$. The coe cients can be parametrized as $= \cos \frac{1}{2}$ and

= $\sin \frac{1}{2}$, where = $\arctan(\frac{B_x}{B_z})$. We denote the energy dimension between the two eigenstates as $E = \frac{1}{B_x^2 + B_z^2}$. Using the above conventions and the general result (4), we can express the corrections to the transition rates as

The function F $(!\)$ contains the information about the third cumulant and is de ned as

C om paring the result (5) with the G olden Rule rates

one notices that the function F (!) plays a similar role in $^{(3)}$ as the noise power in $^{(2)}$.

Supposing we can control the e ective magnetic elds B_x and B_z , we can optimize the parameters and to produce the maximum e ect from ⁽³⁾. The absolute value of the expression ()² (²) is maximized by choosing = 0.89 and = 0.46 or vice versa, i.e., $B_x = 1.4B_{px} \frac{\text{or } B_z = 1.4B_x}{B_x^2 + B_z^2}$ but keeping $B_x = B_z$ xed, one can probe F (!) as a function of frequency.

A physicalqubit always has some intrinsic noise mechanism, in solid-state realizations produced by the electrom agnetic environment, which cannot be neglected (we consider the external uctuation circuit as an additional environment). To be measurable, the external current uctuation e ects have to be signi cant compared to transitions due to the intrinsic noise.




FIG.2: Josephson ux qubit inductively coupled to an external circuit producing current uctuations. The elds B $_z$; B $_x$ can be tuned by controlling uxes $_1$; $_2$ to maxim ize the elds of $^{(3)}$.

A possible physical realization for the system considered above is a Josephson ux qubit^{12,13} coupled inductively to the external circuit, see F ig. 2. The interaction H am iltonian is of the form H int = $\frac{M}{2L_{gb}}$ I _z, where M is the mutual inductance between the qubit and the extemal circuit, is the ux di erence between the two states of the ux qubit and L_{qb} is the inductance of the qubit. We choose h Ii = 0, since the elects of the nite average external current can be included in rede ning B z or eliminated by a ux control. The e ective magnetic elds can be controlled by external uxes through the loops so the qubit can be biased to the optim alpoint for detecting ⁽³⁾. The transition rates follow from Eqs. (5) and (7) after the identi cation $g = \frac{M}{2L_{gb}}$. We assume that the energy gap to the higher states is large com pared to any other energy scales in the system, allowing us to make the two-state approximation and to neglect the elective interaction terms nonlinear in I.

Let us estimate ⁽³⁾ in a ux qubit for a specic setup. Suppose that the external circuit consists of a scatterer with resistance R and loop inductance L. We assume that the third cumulant of current uctuations in the scatterer is frequency independent in the frequency scale of the circuit, $!_{\rm L}$ R=L. This is generally the case provided that the voltage eV over and the Thouless energy E_T of the scatterer, de ned as the inverse time of ight through it, satisfy eV;E_T ~!_L.^{17,18} Then the frequency dependence of the correlator (2) arises solely from the classical e ect of the inductance L modifying the noise. In this lim it Eq. (2) can be approximated by

where I is the average current in the circuit and F_3 is a scatterer-speci c proportionality constant ("Fano factor") between the third cum ulant and the current.

In deriving (8), we assumed $L_{qb}L_{qb}^2$ $L I^2$ where I_{qb} is the current in the qubit, allowing us to neglect the backaction of the qubit on these uctuations. This leads to the rates $\binom{3}{E_0!}E_1 = \binom{3}{E_1!}E_0$ (3) given by

where A 32 $F_3e^2Ig^3()^2(^2)^2$. The noise power for the setup can be written as

where F_2 is the Fano factor for the second cum ulant and (x) is the H eaviside step function. This form ula includes the quantum uctuations (last term) and is valid for our case provided that the tem perature T is low, $k_B T = E$. In the limit eV E we get from Eqs. with $g = \frac{M}{-L_{qb}} e$. For the optim alparameters and mentioned above, ² ² = 0.58. The phase di erence of the two ux states can be of order $_0=4$ = h=8e, so we may estimate $g = \frac{2}{8L_{qb}}$. Consequently, it can be made of order unity or greater by an element inductive coupling and a large external inductance L. The factor $F_3=F_2$ depends solely on the nature of noise produced by the scatterer.¹⁹ For realistic parameters $!_L = (2) =$ 10 G H z and E = h = 1 G H z the last factor is about 2.5%. Optimizing the setup one could expect a relative elect $\frac{(3)}{(2)}$ up to roughly 10 %, which shows that the third cum ulant elect can be significant.

Now suppose that the intrinsic relaxation of the qubit is caused by an independent zero-averaged uctuating G aussian eld. Then the second-order rate should be replaced by the sum of rates caused by the eld and the external circuit, the third-order rate remaining unchanged. In the case of a zero-tem perature environment, this intrinsic relaxation rate int can be quantiled by the Q-factor, int = E = -Q. In this case, its ratio to the rate ⁽²⁾ is

O ne possibility to detect ⁽³⁾ is to let the qubit reach the stationary state and then determ ine the probabilities P_{E_0} and $P_{E_1} = 1$ P_{E_0} of the states $\pm_0 i$ and $\pm_1 i$. This can be achieved by repeated measurements of the qubit. From detailed balance we get




FIG. 3: (Color online) Dierence p p^0 in the qubit polarizations at dierent directions of the current for dierent magnitudes of intrinsic relaxation, Q = 10 (blue solid line), Q = 1 (red dashed line), and Q = 0:1 (green dash-dotted line). Inset shows the corresponding total polarization vs. voltage V = RI. Note that the behavior in the region eV E relies on the approximations made to obtain Eq. (11). These curves have been calculated with = 0:89, = 0:46, g = F_2 = F_3 = 1, ~!_L = 2 E and R = 0.2R Q.

 $\binom{(2)}{E_0! E_1} = \binom{(2)}{E_0! E_1}$. Now inverting the external current I, $^{(3)}$ changes sign and we get p^0 $P_{E_1}^0 = P_{E_2}^0 = (1)$ 3). From the above relations one can $_{3})=(1 + _{Q})$ solve $(3)_{E_1!E_0}^{(3)}$ and $(3)_{E_0!E_1}^{(3)}$ provided that the probabilities, int and $i^{(2)}$ are known. One can evaluate by applying Eq. (7) or the rates can be determ ined experimentally. From Eqs. (5) and (7) we see that when = , $^{(3)}$ vanishes but $^{(2)}_{i}$ remains nite. By keeping E xed but setting B $_z = 0$ it is possible to measure $_i^{(2)}$ independently. Figure 3 shows the asymmetry p pin the change of polarization with respect to the current in the source as a function of the magnitude of the current (bias voltage V = RI).

In conclusion, we have studied the transitions induced by the third cumulant of current uctuations on a probe quantum system. We have calculated a general form ula for the transition rates and propose a scheme to measure the predicted results using a Josephson ux qubit. We have shown that the third-order transition rates are govemed by the variant of the third cumulant which to our know ledge has not been studied before.
