## Quasiparticles near quantum phase transition in heavy ferm ion metals

## A bstract

We have shown that the Landau paradigm based upon both the quasiparticle concept and the notion of the order parameter can be used to explain the anomalous behavior of heavy ferm ion metals. Exploiting this paradigm and the ferm ion condensation quantum phase transition (FCQPT) we show that this anomalous behavior is universal and can be used to capture the essential aspects of recent experiments on the heavy-ferm ion metals at low temperatures. Behind FCQPT a tunneling conductivity between a heavy ferm ion metal and a simple metallic point can be noticeably dissymmetrical with respect to the change of voltage bias. We show that at T = 0 and beyond FCQPT the Hall coecient undergoes a jump upon magnetic—eld tuning HF metals.

Experim ents on heavy-ferm ion (HF) metals explore mainly their therm odynamic properties which proved to be quite di erent from that of ordinary metals described by the Landau Ferm i liquid (LFL) theory. In the LFL theory, considered as the main instrument when investigating quantum many electron physics, the e ective m ass M of quasiparticle excitations controlling the density of states determ ines the therm odynam ic properties of electronic system s. It is possible to explain m any of the observed properties of the HF m etalson the basis of FCQPT which is in harm ony with the Landau paradigm resting upon both the quasiparticle concept and the notion of the order param eter. In contrast to the conventional Landau quasiparticles, these are characterized by the e ective m ass which strongly depends on tem perature T, applied m agnetic eld B and the number density x of the heavy electron liquid ofHF m etal.

To study the universal behavior of the HF m etals at low temperatures we use a heavy electron liquid

m odel in order to get rid of the speci c peculiarities of HF m etals. Since we consider processes related to the power-low divergency of the e ective m ass, this divergency is determined by small momenta transferred as compared to momenta of the order of the reciprocal lattice, and the contribution coming from the lattice can be ignored. We start with the well-known Landau equation determining M  $\,$  (T;B)

For brevity, we om it spin variables. Here  $Y=(p_F\,p_1)=p_F^3$ ,  $F(p_F\,;p_1)$  is the Landau amplitude depending on the momenta  $p,\,p_F$  is the Fermi momentum, M is the bare mass of an electron, and  $n(p_1;T;B)$  is the quasiparticle distribution function. Applying Eq. (1) at T=0 and B=0, we obtain the standard result  $M(x)=M=(1-N_0F^1(p_F;p_F)=3)$ : Here  $N_0$  is the density of states of the free Fermi gas and  $F^1(p_F;p_F)$  is the p-wave component of the Landau interaction. Since in the LFL theory  $x=p_F^3=3^2$ , the Landau amplitude can be written as  $F^1(p_F;p_F)=F^1(x)$ . Assume that at some critical point  $x_F$ 0 the

denom inator (1  $\,$  N  $_0\,F^{\,1}$  (x)=3) tends to zero, and one obtains that M  $\,$  (x) behaves as M  $\,$  (x)=M  $\,/$  1=r.Here r = (x  $\,$  x $_{F\,C}$ ) is the \distance" from the QCP of FCQPT taking place at x $_{F\,C}$ .

Atr! 0 and T < T (B  $B_{c0}$ ) / (B  $B_{c0}$ ), the system has the LFL behavior and a qualitative analysis of Eq. (1) shows that M (B) / (B  $B_{c0}$ )  $^{2=3}$ : Here,  $B_{c0}$  is the critical magnetic eld which drives both a HF m etal to its m agnetic eld tuned QCP and the corresponding N eel tem perature  $T_N$  ! 0 [1]. At elevated tem peratures the system demonstrates two types of the non-Ferm i liquid behavior (NFL): at T T<sub>p</sub>(B) M (T) / T  $^{2=3}$ ; and T > T (B) M (T) /  $1=^{P}\overline{T}$ : These m entioned regim es can be observed in m easurem ents of the resistivity, (T) = 0 + .H ere, 0 is=  $A(B)T^2$ , and A(B) / the residual resistivity,  $(M)^2$ . The rst LFL regime is represented by  $_1$  /  $T^2 = (B B_{c0})^{4=3} / T^2$ ; the second NFL one is characterized by  $_2$  /  $T^2$ = $(T^{2-3})^2$  /  $T^{2-3}\dot{p}$  and the third NFL one is represented by  $_3$  /  $T^2$ = $(\dot{T})^2$  / T.A ll these regim es were observed in recent measurements on the HF metals, see e.g. [2]. Considering the ratio  $_{2}$ =  $_{1}$  / ((B B  $_{c0}$ )=T) $^{4=3}$ , we conclude that the ratio is a function of only the variable (B representing the scaling behavior. This result is in excellent agreem ent with experim ental facts [2].

Beyond the critical point  $x_{F\ C}$  the distance r becom es negative m aking the e ective m ass negative. To escape the possibility of being in unstable and meaningless states with the negative e ective mass, the system is to undergo FCQPT quantum phase transition at the critical point  $x = x_{FC}$  [1]. At  $x < x_{FC}$  the quasiparticle distribution is determined by the standard equation to search the minimum of a functional  $E[n(p)] = n(p;T = 0) = "(p) = ;p_i$ This equation determines the quasiparticle distribution function  $n_0$  (p) which delivers the m in im um value to the ground state energy E . no (p) does not coincide with the step function in the region (pf  $\,$  pi), so that  $0 < n_0$  (p) < 1, while  $p_i < p_F < p_f$ . This special behavior of  $n_0$  (p) determ ines the behavior of system at  $T < T_f$ , with  $T_f$  being the tem perature at which he in uence FCQPT vanishes. At T = 0, the relevant grder param eter is the superconducting-like, (p) = $n_0$  (p) (1  $n_0$  (p)), with the entropy S = 0 [1]. At 0 <T <  $T_{f_0}$ , the entropy can be approximated as S (T) '  $S_0 + a^T = T_f$ , a is a constant. This tem perature independent term  $S_0$  determ ines the specic NFL behavior of the system . For example, the therm alexpansion coe cient (T) determ ined by the contribution com ing from  $S_0$  becomes constant at T ! 0 while the specic heat C  $= a^p \frac{T - T_f}{T - T_f}$ . As a result, the G runeisen ratio diverges  $= -C / 1 = \frac{p}{T}$ . Then, at  $T < T_f$ , a tunneling conductivity between a heavy ferm ion metal and a simple m etallic point can be noticeably dissymmetrical w ith respect to the change of voltage bias \$\beta]. At T < T (B B\_{c0}) / B B\_{c0}, the application ofm agnetic eld B restores the LFL behavior, the e ective m ass becomes M (B) / 1= B B\_{c0}, and the coecient A / 1=(B B\_{c0}) [1]. At T = 0, the application of the critical magnetic eld B\_{c0} suppressing the antiferrom agnetic state (AF) (w ith the Fermi momentum  $p_{A\,F}$  '  $p_F$ ) restores the LFL w ith the Fermi momentum  $p_{A\,F}$  '  $p_F$ ). Both AF and LFL have the same ground state energy being degenerated at B = B\_{c0}. Thus, at T = 0 and B = B\_{c0}, the in nitesimal change in the magnetic eld B leads to the nite jump in the Fermi momentum. In response the Hall coecient R\_H / 1=x undergoes the corresponding sudden jump.




Fig. 1. Line separating AF and the NFL state is a guide to the eye, line separating the NFL and the LFL phases T (B B  $_{c0}$ ) /  $\overline{\rm B}$   $\overline{\rm B}$   $_{c0}$  [1].

As an illustration of the above consider the T B phase digram for Y bR  $h_2$  Si $_2$  [4] (Fig.1). Taking into account that the behavior of Y bR  $h_2$  Si $_2$  strongly resembles the behavior of Y bR  $h_2$  (Si $_2$ :95 Ge):05) $_2$  [5], we can conclude that both the above described T B diagram and the behavior of the Hallcoe cient R Hare in good agreement with experimental facts [4,5].
