# Multi-avor bosonic Hubbard models in the stexcited Bloch band of an optical lattice

We propose that by exciting ultra cold atoms from the zeroth to the rst Bloch band in an optical lattice, novel multi- avor bosonic Hubbard Ham iltonians can be realized in a new way. In these systems, each avor hops in a separate direction and on-site exchange terms allow pairwise conversion between di erent avors. U sing band structure calculations, we determ ine the param eters entering these Ham iltonians and derive the mean eld ground state phase diagram for two e ective Ham iltonians (2D, two- avors and 3D, three avors). Further, we estimate the stability of atoms in the rst band using second order perturbation theory and nd lifetim es that can be considerably (10-100 tim es) longer than the relevant time scale associated with inter-site hopping dynamics, suggesting that quasi-equilibrium can be achieved in these meta-stable states.

I. IN TRODUCTION

The possibility to trap and manipulate the atom s in a Bose-E instein Condensate using standing wave laser beam s [1, 2, 3, 4, 5, 6] has led to a renewal of the interest in basic solid state models. In such system s, the atom s experience a periodic potential from an optical lattice leading to form ation of band structure in the energy spectrum. These bands have been investigated in experim ents [7].

In the spectroscopy experiments in Ref. [7], the atom s experienced a periodic potential in only one direction, being free to m ove on a m uch larger length scale in the other directions. This implied that interactions between atom s could be ignored. If the atoms are con ned to reside on the sites of a lattice in three dimensions, interactions become important. As a result, it was shown theoretically [3], and subsequently also experimentally [5], that a system of interacting cold atoms, residing in the lowest Bloch band of the periodic potential, maps onto a bosonic Hubbard model. This model is of great theoretical interest since it exhibits a quantum phase transition [8, 9, 10, 11] between ground states where the atom s are localized (M ott-Insulator) and where they are delocalized (super uid) as the strength of the hopping relative to the inter-atom ic interaction is varied. The dynam ics of particles under the in uence of changes in the Ham iltonian (such as lattice tilts or rapid changes in the particle interaction strength) has also proved interesting [4, 5, 6, 12, 13].

A nother development is an interest in the idea of mixing bosonic atoms of dierent avors in the lattice [14, 15, 16, 17, 18, 19]. Severalways of achieving multiple avorshave been suggested including using atom s of dierent species and exploiting dierent internal atom ic states.

So far, experiments on strongly interacting atoms in three dimensional optical lattices have been restricted to atoms in the lowest (zeroth) Bloch band. Recently Scarola and DasSarm a considered the possibility of novel supersolid phases within the rst excited B loch band of an optical lattice. [20]

In this paper, the theory of atom s in the two lowest (zeroth and rst) B loch bands of a three dimensional optical lattice is considered. We show here, that due to the lack of available phase space for the decay products, such excited states can (in some parameter ranges) have life times much longer than the characteristic time scales for inter-site hopping. Thus it should be possible to establish quasi-equilibrium within the manifold of these m etastable states.




FIG.1: (Coloronline) On-site W annierwave functions in the Ham onic oscillator approxim ation. The localized wave functions are to a good approximation described by harm onic oscillator wave functions localized in each well. A bove is drawn the wave functions  $_{(0;0;0)}$  (r) (plotted in the plane z = 0) form ed by the zeroth band B loch functions and the wave function  $_{(1;0;0)}$  (r) form ed by the zeroth band B loch functions in the y- and z- directions and the Bloch functions from the rst band in the x-direction. These are approximately harm onic oscillator states,  $_{(0;0;0)}$  (r)  $(x^{2} + y^{2} + z^{2})],$ exp [  $(x^{2} + y^{2} + z^{2})]$  where the parameter and (1;0;0) (r) x exp[ is determ ined by the curvature of the optical lattice potential near its minima. Similarly <sub>(0;1;0)</sub> (r)  $y_{(0;0;0)}$  (r) and (0;0;1) (r) z (0;0;0) (r).

We nd that it is possible in this way to realize novel effective multi-species bosonic Hubbard Ham iltonians. Depending on the choice of lattice depths the number of degenerate bands varies and we nd e ective models involving n avors of bosons, where n can be 1, 2, or 3. These avors correspond to the three di erent possible nodal planes in the excited state wave function such as the one illustrated in Fig. (1). Wewill show that a characteristic of these H am iltonians is that (to a good approximation) each avor can only hop in one direction (i.e., X (nodal plane) particles can only hop in the x direction, etc.). Neglecting interactions we would then have n interpenetrating one-dim ensional free bose gases, one for each column (or row) in the lattice. Allowing intra-species interactions converts these one-dim ensional gases into Luttinger liquids (or, if the interactions are strong enough, and the m ean particle num ber per site is an integer, into M ott insulators). We show below that, besides intra-species interactions, the full interaction also includes on-site inter-species conversion term s that allow atom s to change avor in pairs. Thus for example, two X particles constrained to move along a single x colum n can collide, turn into Y particles and move away along a y column. Such processes lead to novel quantum dynam ics for this coupled set of interpenetrating Luttinger liquids.

As will be seen, the anisotropic nature of the hopping in conjunction with the pairw is conversion leads to H am iltonians with an in nite but subextensive set of  $Z_2$ -

gauge sym m etries interm ediate between local and global. Such in nite sym m etries have been found in certain frustrated spin m odels [21, 22, 23, 24] and in a bose m etal' m odel [25] and are known to cause dimensional reduction in some cases. [21, 22, 24] W e will see below how this dimensional reduction appears in a simple way in this system.

A related global  $Z_2$  sym m etry and associated Ising order parameter appear in problem s involving boson pairing due to attractive interactions m ediated by Feshbach resonances. In that case the sym m etry appears due to a conversion term that connects pairs of bosons w ith a distinct m olecular eld. This can lead to exotic states in which pairs of bosons are condensed but single bosons are not and in which half vortices are perm itted [26, 27]

Further, due to strong interatom ic repulsion, the ground state in 3D (three avors) breaks a kind of chiral sym m etry and displays an additional accidental ground state degeneracy at the m ean eld level. A sim ilar situation occurs for special param eter values in frustrated X Y -m odels, where parallel zero energy dom ain walls can be inserted [28]. The outline of this paper is as follow s: In section II the appropriate generalization of the bosonic H ubbard m odel is introduced along w ith num er-

ical values of the param eters entering the H am iltonians obtained from band-structure calculations for various lattice depths. Then, in section III, the aforem entioned e ective H am iltonians for atom s in the rst band are derived for three particular choices of relative lattice depths in the xyz directions. U sing sim ple m ean-eld theory we sketch the ground state phase-diagram s in section IV and in section V we discuss how the super uid phases are re ected in the interference pattern in an experim ental situation. Finally, in section V I, treating the interaction perturbatively to second order, we estim ate the lifetim e of a population inverted state (all atom s residing entirely in the rst excited band).

# II. GENERAL LATTICE HAM ILTONIAN

The starting point is the H am iltonian for weakly interacting bosons of m ass m in an external potential [29]

where  $a_s$  is the s-wave scattering length. The external potential has two contributions  $V_0$  and  $V_T$  corresponding to the lattice potential and the magnetic trapping potential. Denoting the wavelength of the lasers by 2a, a being the lattice spacing, the form er can be written

The positional dependence of the magnetic trapping potential  $V_T = \frac{1}{2}m$   ${}_{1}^{2}x_{1}^{2}$ ; is much weaker than that  ${}_{1}^{i=x;y;z}$  of the lattice, i.e.  ${}_{1}$   ${}_{2}^{m}$   $\frac{q}{\frac{2V_{01}}{m}}$  and will be ignored in the remainder of this paper. One should be aware though, that this term has been shown to in uence for instance the phase diagram of the single avor bosonic Hubbard model [30, 31].

For the cubic lattices considered here, the W annier functions corresponding to the noninteracting part of the H am iltonian in Eq. (1) can be written

Here the bold face vectors n and m are integer triplets  $(n_x;n_y;n_z)$  and  $(m_x;m_y;m_z)$  which represent band indices and lattice sites respectively, i.e.

These functions are to a good approximation described by localized harm onic oscillator wave functions sketched in Fig. 1. The completeness of the W annier functions allows the eld operators to be expanded as

The operators  $\hat{d}_n^y$  (m ) and  $\hat{d}_n$  (m ), which are the cre-

ation and annihilation operators of bosons at site m and with band index n, obey Bose commutation relations  $[\hat{d}_n(m); \hat{d}_n^{y_0}(m^0)] = \lim_{n \neq n} \lim_{m \neq m} 0$ : Ignoring all hopping other than nearest neighbor hopping and all interactions other than on-site interactions, the H am iltonian in Eq. (1) can be written

Here, the on-site interaction energies are de ned as

N ote that the energies  $t_n^{(i)}$  for hopping in the  $x_i$ -direction depend only on the lattice depth  $V_{0\,i}$  in the corresponding direction and the ith component  $n_i$  of the band index n. The notation hm ;m  $^0i_i$  in Eq. (2) indicates that the sum should be carried out over nearest neighbor sites m and m  $^0$  in the  $x_i$ -direction. O ne could for instance write,

It is straight forward to numerically solve the noninteracting Schrödinger equation and nd the energies in expressions (3)-(5) above. In doing so, it is convenient to rst switch to dimensionless units. Thus, we measure length in units of the inverse wave vector and potential depth in units of the recoil energy  $E_R$ , i.e., i  $\frac{2}{2}$ -x<sub>i</sub> and  $v_{0i} = V_{0i} = E_R$ , with  $E_R = \frac{h^2}{2m} = \frac{2}{2}$ :




FIG.2: Hopping energies  $t_1^{(\rm i)}$  and  $t_0^{(\rm i)}$  in units of the recoil energy as functions of lattice depth  $V_{0\,i}$  in the hopping direction. The upper line is the hopping energy  $t_1^{(\rm i)}$  for atom s in the rst Bloch band hopping between nearest neighbor wells while the lower line,  $t_0^{(\rm i)}$ , corresponds to atom s in the zeroth band.

The hopping energies for the two lowest bands, obtained from band-structure calculations, are shown in Fig. 2 as functions of lattice depth. To get the on-site interaction (Eq. 3) in a suitable form to use later on in the paper we de ne dimensionless overlap integrals

have been introduced. The dependence on v in these functions is parametric, i.e.  $_n$  (vE $_{\rm R}$ ; =2 ) is the W annier function corresponding to the one-dimensional non-interacting problem with potential depth vE $_{\rm R}$ . The variable n denotes the band index.


A pproximating the W annier functions with harmonic oscillator wave functions corresponding to the curvature at the bottom of each well, one nds approximate values for the overlap integrals

A comparison between these values for the overlap integrals and those obtained from band-structure calculations is shown in Fig. 3.

## III. EFFECTIVE HAM ILTON IANS FOR ATOM S IN THE FIRST EXCITED BAND.

In this section we will focus on the meta-stable situation having all atoms in the rst Bloch band (s) of the lattice. It is quite easy to achieve such a situation, i.e. consider an initial moment of time when the optical lattice has been baded with atoms in the lowest Bloch band, n = (0;0;0). The anharm onicity of the lattice well potential allows one to treat the vibrational degree of freedom as a two level system. If one singles out, say, the x-direction, then, by applying an appropriate

vibrational -pulse, i.e. \shaking" the lattice in this direction with a frequency on resonance with the transition  $h! = E_{(1;0;0)} \quad E_{(0;0;0)}$ , the state can be inverted and the atom s excited to states with band index n = (1;0;0). A strong -pulse can achieve this inversion in a time short com pared to the inter-well hopping time so that the dispersion of the upper band is not an issue in the inversion process. The simplest starting state would be the M ott insulator state with one boson per site in the low est band. In a typical experimental setup, the parabolic con ning potential will cause the population of each well to vary and the system will be in a state with regions of M ott insulators with di erent lling factors. It is how ever easy to con m (by direct simulation) that even in this case, taking interactions into account, a pulse shape can be tailored that will invert the population simultaneously for regions with di erent lling factors provided a deep enough lattice is used.

A nother way of preparing the initial state is to use the m ethod recently demonstrated by B row aeys et al. [32]. By loading a condensate into a moving 1D lattice and applying a subsequent acceleration the condensate can be prepared in the lowest energy state (quasimom entum k = -a) in the rst B loch band. The situation desired in this paper can then be obtained by ramping up the lattice in the two remaining (perpendicular) directions adiabatically. The natural question regarding the lifetime

of the resulting m eta-stable state will be considered in Sec.VI.

The subsequent dynam ics of atom s in the rst band (s) is then predom inantly governed by some subset of the term s in Eq. (2). This relevant subset will be referred to as the e ective H am iltonian. W e will treat three di erent regim es of values for the lattice potentials  $V_{0i}$  which lead to e ective H am iltonians with one, two, and three avors respectively. The three scenarios are:

- 1.  $V_{0x} = V_{0y}$ ;  $V_{0z}$  (1D, single avor).
- $2.V_{0x} = V_{0y}$   $V_{0z}$  (2D, two avors).
- $3.V_{0x} = V_{0y} = V_{0z}$  (3D, three avors).

A sindicated, the num ber of particle avors as well as the dimensionalities in the elective H am iltonians vary.

The reason for the di erent numbers of avors becomes clear if one considers the restrictions on the nal states into which two atoms may scatter due to the interatom ic interaction; The presence or absence of such states can be inferred from the presence or absence of degenerate, or nearly degenerate, levels in the energy spectrum of the noninteracting system. Take, for example the second scenario above with  $V_{0x} = V_{0y}$   $V_{0z}$  and all atoms initially in a state with index n = (1;0;0), then, due to the on-site inter-atom ic interaction these atoms can scatter elastically into a state with index n = (0;1;0) through

a rst order process the connecting di erent degenerate states. Further, it is easy to show that scattering resulting in states with other indices, for instance n = (0;0;1), is only possible through higher order processes if energy (and also parity) is to be conserved and can safely be ignored if the gas is dilute. Hence, the atoms can, at a form al level, be divided into two avors: an X avor corresponding to atom s in n = (1;0;0) and a Y avor in n = (0;1;0). By the same argument one can see how the one- and three- avor situations arise.

A part from having di erent number of avors the dimensionalities of the e ective Hamiltonians di er. To understand this consider again the second case above,  $V_{0z}$ , with particles in the excited bands  $V_{0x} = V_{0y}$ n = (1;0;0) and n = (0;1;0) corresponding to X - and Y avors. For the X avor, hopping in the x-direction has a matrix element  $t_1^{(x)}$  (V<sub>0x</sub>) while hopping in the y-and z-direction have matrix elements  $t_0^{(y)}$  (V<sub>0x</sub>) and  $t_0^{(z)}$  (V<sub>0z</sub>) respectively. Looking at Fig. 2 it is then clear that, to a good approximation, the X particles can only hop in the x-direction while hopping in the y-and z-directions is strongly (exponentially) suppressed. Sim ilarly the Y particles can only hop in the y-direction and all hopping occurs only in the x y plane, hence the 2D character. A sim ilar argum ent holds for the three avor case where in addition to the X and Y particles, there are Z-particles hopping in the z-direction.

The elective H am iltonians also contain terms arising from the on-site interaction. A part from the terms that repelatoms from each other, the symmetry of the on-site interaction allows, say, two X particles moving in the xdirection to collide and convert into two Y particles which thereafter move o in the y-direction. The time reversed process can of course also occur. Thus, the number of particles of each avor is not conserved and there is a pairwise exchange of particles of dilerent avors.




FIG. 4: (a) The H am iltonian in Eq. (11) describes a 2D system where atom s, which can form ally be thought of as having two di erent avors (same type of atom s but in di erent localized on-site orbitals), hop around subject to on-site repulsive interactions. One avor, the X - avor, can only hop in the x-direction whereas the other, Y - avor, can only hop in the y-direction. (b) C onversion process. The conversion term in Eq. (11) takes two X -atom s on the same lattice site and turns them into two Y -atom s or vice versa.

The anisotropy of hopping and the avor conversion process is schematically depicted for the 2D (two avors) case in Fig. 4. Particles of X avor are shown in gray while the Y avor is drawn in black.

Below, we give the e ective H am iltonians for all three di erent cases listed above.

A. 1D Ham iltonian, single avor, 
$$(V_{0x} = V_{0y})$$

The rst case to be considered is when  $V_{0x} = V_{0z}$  and only states with band index n = (1;0;0) (and possibly some residual atoms in n = (0;0;0)) are occupied. In anticipation of the other elective H am iltonians it is convenient to introduce for the X avor the creation and destruction operators  $\hat{X}^{y}$  and  $\hat{X}$ , i.e.:

The e ective Ham iltonian is then essentially that of a quasione-dimensional bosonic Hubbard model

The energies t  $t_1^{(x)}$ ,  $U_{0x}$ , and  $U_{xx}$  arise from the interwell tunneling and the inter-atom ic interaction respectively. The presence of atom s residing in the lowest band leads to an additional elective on-site energy and can be absorbed in the on-site energies  $E_x$  (m), (s = x;y;z). A lthough this single- avor m odel is equivalent to a singleavor m odel in the zeroth B loch band, the additional random on-site potential resulting from residual atom s could be exploited in the study of the disordered B ose-H ubbard system .

The parameters entering the Hamiltonian (9) are conveniently expressed as

B. 2D H am iltonian, two avors, ( $V_{0x} = V_{0y} - V_{0z}$ )

To simplify the notation for the case  $V_{0x} = V_{0y} - V_{0z}$ , we introduce new letters for the creation/annihilation

operators  $\hat{Y}_m$   $\hat{d}_{(0;1;0)}$  (m),  $\hat{n}_m^{(y)}$   $\hat{Y}_m^{y} \hat{Y}_m$ . Then, the Ham iltonian governing atoms in the excited bands becomes

Again, the energy  $U_{xy}$  arises from the interatom ic interaction and depends on the lattice depth. Note that this two avor bosonic Hubbard Ham iltonian di ers in an important aspect from previously studied two avor system s: the presence of the last term that m ixes the two avors. Hence, the inter-atom ic interaction leads to a \Josephson term " that allows for the conversion of two X -atom s into two Y -atom s and vice versa. The coe - cients  $U_{yy} = U_{xx}$  are given by the sam e expression as in the 1D case while

Figure 4 illustrates the dynam ics in the 2D (two avors) situation.

## C. 3D H am iltonian, three $% V_{0x}=V_{0y}=V_{0z}$ avors, $(V_{0x}=V_{0y}=V_{0z})$

The generalization of the above H am iltonian to the case when  $V_{0x}$  =  $V_{0y}$  =  $V_{0z}$  is straight forward. Introducing a third avor  $\hat{Z_m}$   $\hat{d}_{(0;0;1)}$  (m),  $\hat{n}_m^{(z)}$   $\hat{Z_m}^y \, \hat{Z_m}$ , one may write an elective H am iltonian as

Here  $U_{ss^0} = {}_{ss^0}U_{xx} + (1 {}_{ss^0})U_{xy}$  with  $U_{xx}$  and  $U_{xy}$  given by (9) and (12) with  $v_{0x} = v_{0y} = v_{0z}$ .

#### D. Z<sub>2</sub> Gauge sym m etry

Because of overall number conservation the H am iltonian has the usual global U (1) sym m etry. However, because the avor conversion occurs pairwise and locally (i.e., on site), the H am iltonians described above also exhibit an in nite number of  $Z_2$  gauge sym m etries corresponding to conservation m odulo 2 of the number of X

particles in any given column of the lattice running in the x-direction (and similarly for Y and Z particles). These symmetries correspond to invariance under each of the transform ations

where the integer pair  $(m_i; m_j)$  in the superscript of each U determ ine the location of a column. The rst transformation for example takes  $X_{(m_x, m_y, m_z)}$ !  $X_{(m_x, m_y, m_z)}$ for all m  $_{\rm x}$  in the column specied by m  $_{\rm y}$  and m  $_{\rm z}$  . Since  $\hat{X}^{y}$  and  $\hat{X}^{y}$  operators always appear pairwise, the H am iltonian is invariant under this class of Z<sub>2</sub> transform ations. These Z<sub>2</sub> sym m etries are in a sense interm ediate between local and global. W hile the num ber of such sym m etries is in nite (in the therm odynam ic lim it) it is of course sub extensive and thus not large enough to fully constrain the system (or to make it integrable for example). As mentioned in the introduction, such symmetries have been found in certain frustrated spin models [21, 22, 23, 24] and in a bose m etal' m odel [25] and are known to cause dimensional reduction in some cases. [21, 22, 24] Because introducing a defect across which the sign of the Z<sub>2</sub> order parameter changes along any given single colum n costs only nite energy, the system will, like the 1D Ising model, disorder at any nite tem perature thereby restoring the Z<sub>2</sub> symmetry. We will see below how this reduced dimensionality physics appears in a simple way in this system .

# IV . M EAN FIELD THEORY PHASE D IAGRAM S FOR THE EFFECTIVE HAM ILTON IAN S

H aving derived e ective H am iltonians in one, two, and three dimensions, we turn now to the investigation of their ground states. The 1D, single avor H am iltonian has been extensively studied (see for instance R ef. [33] and references therein) and needs no further discussion here. The other two H am iltonians in Eqs. (11) and (13) deserve som e attention though.

#### A. Phase diagram 2D, two avors

The 2D Ham iltonian (11) is a two avorbosonic Hubbard Ham iltonian, a system that has recently received much attention and shown to have a rich phase diagram [14, 15, 16, 17, 18, 34]. In this section we will investigate the ground state of the Ham iltonian in Eq. (11) using simple mean eld theory. The Ham iltonian (11) di ers from those previously studied in two aspects: the presence of pairwise inter avorm ixing and the anisotropic tunneling.

W e follow here the m ethod suggested in Ref. [35] (see also Refs. [9, 10]). We consider the possibility that the global U (1) and colum nar  $Z_2$ -sym m etries discussed in section IIID are spontaneously broken by introducing complex scalar colum nar order parameter elds  $_x (m_y)$ and  $_y (m_x)$ , i.e. one for each x-colum n and one for each y-colum n. These elds should then satisfy the self consistency conditions

for all  $m_x$  in the x-column specied by  $m_y$ , and,

for each m  $_{\rm y}$  in the y-column speci ed by m  $_{\rm x}$ . For sim – plicity we om it in this discussion of the 2D (two avors) case the z component m  $_z$  of the position vector m . The possibility that uctuations restore the symmetry will be discussed further below .

M ean eld theory results from decoupling sites in the same column by neglecting uctuations in the kinetic energy. For instance, for the x-column specified by a particular value of  $m_y$  one has

Thus the sites along each column decouple. Doing the same for the Y is and writing the H am iltonian in dimensionless form where all energies are scaled by  $U_{xx}$ , i.e.,  $h_{2d} = H_{2D} = U_{xx}$ ,  $t = U_{xx}$  and  $\tilde{U}_{xy} = U_{xx}$ , we obtain  $h_{2D} = h_{2d}^{MF}$  (m; x (m $_y$ ); y (m $_x$ )): Here, the on-site mean eld H am iltonians are given by

for two arbitrary com plex elds. An eigenstate of the full mean eld ham iltonian can be written as a product state of such eigenstates

where the elds satisfy the self consistency conditions in Eqs. (14)-(15). The mean eld ground state is obtained by globally m inim izing the energy

with respect to the elds and the set of eigenstates  $fn_m$  g. This is most easily done by num erical diagonalization in

a truncated H ilbert space where each site can hold at most a total of N  $_{\rm m\,ax}$  atom s. Since

it is enough to m inim ize the ground state energy of a single site with respect to the elds and then nd the largest manifold of states compatible with having colum nar order parameters elds. Carrying out this scheme reveals two di erent scenarios for the minimum of each on-site energy n(x; y); either x = y = 0 and  $n_x + n_y$  is integer (incompressible), or, j = j = j = 0 (compressible). The former case corresponds to a M ott insulating state while the latter suggests a super uid phase.




FIG. 5: Columnar phase ordering in 2d super uid phase. The directions of the arrows correspond to the phase angles  $_{x} (m_{y})$  and  $_{y} (m_{x})$  of the order parameter elds  $_{x} (m_{y}) = j_{x} (m_{y}) \dot{p}^{i_{x} (m_{y})}$  and  $_{y} (m_{x}) = j_{y} (m_{x}) \dot{p}^{i_{y} (m_{x})}$ . Solid arrows correspond to  $_{x}$  and dashed to  $_{y}$ .

D ue to the positivity of  $U_{xy}$  the last term in the mean eld H am iltonian is minimal whenever x and y, on the same site, have a phase di erence of =2. For the (m ean eld) ground state manifold we must have in this phase  $j_x (m_y) j = j_y (m_x) j$  for all x and y column order parameters. Requiring the phases of all x in each x and all y in the y columns to be the same while xing the relative phase between x and y to =2 results in congurations as the one shown in Fig.5.

Here the phases of  $_x$  and  $_y$  are shown represented as arrows (planar spins). The direction of the arrows de ning the angle. C learly, this phase shows a breaking of the global U (1) symmetry. The meaning of the quasi-local nature of the Z<sub>2</sub> symmetries discussed above becomes clear. A though the phases of  $_x$  in each x column are the same there is no energy cost associated with ipping all the spins x-spins in a single column or all the y-spins in a y-column. The ordering between di erent columns is thus nem atic.

O ne should note here, that since the only energy cost associated with ipping a single spin, say an x-spin in an x column, is given by the states of the neighboring x spins in the column, the situation is essentially that of a 1D Ising model along each column. Hence, at any nite temperature, domains of ipped spins will proliferate and the Z<sub>2</sub> symmetries will be restored. This essentially one dimensional behavior is an example of the dimensional reduction mentioned above.

The model under consideration is highly anisotropic. Mainly since X particles can only hop in the x-direction, it seems to be impossible to develop phase coherence among X particles in di erent x-columns (and sim ilarly for the other avors). Suppose how ever that, as discussed above, the avor exchange interaction term causes the relative phase of two avors, say X and Y, to lock to-

gether so that  $\hat{Y}^y \hat{X}$  condenses

In this case the mean eld decom position of the exchange interaction yields term s of the form

which perm it individual particles to change avor and hence phase coherence can freely propagate in all directions throughout the lattice via a kind of Andreev' process (i.e. self-energy o -diagonal in avor index) in which an X particle can turn into a Y particle when it needs to travel in the y direction.

To understand this isotropic super uid phase, it is convenient to consider a phase only representation with compact phase variables on each site  $\hat{X_m}$  ! e  ${}^{i' \frac{x}{m}}$  and  $\hat{Y_m}$  ! e  ${}^{i' \frac{y}{m}}$ . The avor exchange (Josephson') term then becomes (for the 2D (two avors) case)

A ssum ing that the relative phase of the condensates is locked together by this Josephson term is equivalent to assum ing that (for  $U_{xy} > 0$ ) the uctuations of ' away from the ground state value =2 (or its equivalent =2 under the  $Z_2$  gauge symmetry) are massive and can be ignored. Thus we obtain  ${'}_m^{(x;y)} = {'}_m^+ = 2 = -4$ : The continuum limit of the anisotropic kinetic energy  $T = (@_x{'}^x)^2 + (@_y{'}^y)^2$  then becomes  $T = (@_x{'}^*)^2 + (@_y{'}^*)^2$  and we immediately see that the anisotropy has electively disappeared at long wavelengths and we have a super uid.




FIG.6: (color online) Phase con guration for  $_{\rm x}$  (black solid arrows) and  $_{\rm y}$  (red dashed arrows) containing a half vortex. Notice the branch cuts indicated by the long solid black and dashed red lines. The Z<sub>2</sub> symmetry means that these branch cuts have zero String tension' and contribute only a nite core energy to the vortex. The half winding number can be seen by going around a loop A-B-C-D-A and calculating the total phase twist  $\,$ . This twist is calculated by summing the changes in ' <sup>y</sup> when going vertically and ' <sup>x</sup> when going horizontally.

A vortex con guration in ' + can be viewed as a bound state of two half vortices in the 'x and 'y elds. The colum nar $\mathbb{Z}_2$  symmetry allows the x eld to have a phase jump of across a cut parallel to the x axis and sim ilarly for v. Thus half vortices are permitted. If the two order param eter phases are locked together (' uctuations are massive) then the two half vortices are con ned to each other as shown in Fig. (6). Such a vortex has an energy which scales (as usual) only logarithm ically with system size, despite the sem i-in nite branch cut ( phase jump) of x running horizontally out to the right from the vortex center and of the similar branch cut in vrunning vertically out above the vortex center. To see that such a vortex is topologically well de ned despite the  $Z_2$  symmetry one can consider a loop around the vortex core as shown in Fig. (6). In going around the loop we add up the phase twist and m ap onto the com plex plane. To calculate along the loop the changes in 'has to be added when going vertically and the changes in 'x when going horizontally. The net results is that

going once around the vortex core the phase winds by . If one applies a -ip in all the '  $^{\rm x}$  ('  $^{\rm y})$  phases in any row (column) the mapping onto the complex plane will remain invariant.

The M ott insulating states, having integer number of atom s in each well, are best characterized by the t = 0 eigenstates. These are product states




FIG.7: M ean eld ground state phase diagram for the 2D (two avors) H am iltonian in Eq.16 in the plane of ~, the scaled chem ical potential  $=U_{xx}$ , and  $t = t=U_{xx}$ , the scaled hopping energy. Here calculated for the experimentally relevant ratio  $U_{xy}$   $U_{xy}=U_{xx}$  = 1=3 using a truncated H ilbert space with at most 10 particles per site. Lobes of M ottinsulating states, of successively increasing integer lling factor with increasing chem ical potential ~, are surrounded by a super uid phase. The super uid phase is characterized by column ar order parameter elds  $x (m_y)$  and  $y (m_x)$ , one for each x-and y-column respectively. All x and y have equal, nonzero, m agnitudes while their relative phases are either 0 or . (see Fig.5).

In Fig.7 the mean eld phase diagram has been drawn for the physically relevant value  $U_{xy} = 1=3$  which is characteristic for the proposed setup. The lobes marked M I correspond to incom pressible M ott insulating phases with integer lling factors. The remaining part of the diagram, marked SF, corresponds to a super uid phase with the

colum nar nem atic ordering (see Fig. 5) discussed above. Considering the t = 0 eigenstates above two things become clear. Trivially, if  $U_{xy}$  ! 0 the lowest lobe, and all other odd lling lobes, vanish and the model reduces to two noninteracting single avor models as expected. Secondly, at  $U_{xy}$  = 0.5 there is a level crossing between j<sub>20</sub>i and j<sub>21</sub>i. It follows that the size of the lowest odd lling lobes increases with increasing values of  $U_{xy}$  up until  $U_{xy}$  = 0.5 after which it starts to decrease again.

By considering uctuation e ects higher order in the tunneling am plitude, we can demonstrate that the permutational symmetry between the X - and Y - avors can be broken in the M ott insulator phase. In the absence of tunneling, the single-particle states  $j_{10}i$  and  $j_{11}i$  are degenerate. Taking tunneling into account breaks this degeneracy and to second order in t (using for instance the Schrie er-W ol transformation [36]) an elective (pseudo) spin $\frac{1}{2}$  H am iltonian for the interaction between neighboring sites can be found

The up- and down-states of the pseudo spin operators  $^{(z)}_{m}$  correspond to the site m being occupied by one X - atom or one Y -atom respectively. The elective magnetic




FIG. 8: (Color online) Phase ordering in 3d super uid phase. The directions of the arrows correspond to the phase angles  $_{x} (m_{y}; m_{z}), _{y} (m_{x}; m_{z})$  and  $_{z} (m_{x}; m_{y})$  of the order parameter elds  $_{x} (m_{y}; m_{z}) = j_{x} (m_{y}; m_{z}); p^{i_{x}(m_{y}; m_{z})}, _{y} (m_{x}; m_{z}) = j_{y} (m_{x}; m_{z}) = j_{x} (m_{y}; m_{z}); p^{i_{x}(m_{y}; m_{z})}, _{y} (m_{x}; m_{y}); p^{i_{y}(m_{x}; m_{z})}$ . As in the 2D (two avors) case the underlying symmetry of the Ham iltonian allows for ipping say all the  $_{x}$  along any x-column by to obtain another ground state con guration. In addition to the ground state degeneracy obtained from such operations, an accidental degeneracy associated with parallel planes of di erent chirality is present. In this gure the middle x z plane has a di erent chirality than the other two x z planes.

interaction is

$$J_{eff} = \frac{t^2 (U_{xy}^2 + 2U_{xy} - 1)}{U_{xy} (1 - U_{xy}^2)};$$

There is a critical value of the inter avor interaction  $U_{xy}^c = 2$  1 0.414 for which  $J_{ff}$  vanishes. For  $U_{xy} > U_{xy}^c$ , the system is ferrom agnetic and spontaneously favors one avor over the other. For  $U_{xy} < U_{xy}^c$  the system is anti-ferrom agnetic and favors an ordering with X - and Y -atom s on alternating sites. Thus, we conclude that at integer lling factor the permutational sym metry between X and Y avors, (or equivalently, the cubic sym m etry of the underlying lattice) is always broken in the mean eld ground state. Further, in the anti-ferrom agnetic state, sublattice (i.e. translation) sym metry is broken as well.

#### B. Phase diagram 3D, three avors




FIG.9: M ean eld ground state phase diagram for the 3D (three avors) H am iltonian.

U sing the same type of mean eld theory as for the 2D (two avors) case, the 3D (three avors) case can be treated as well. The resulting phase diagram for  $U_{xy} = 1=3$  is shown in Fig. 9. Again, M ott-lobes with integer lling factors are seen surrounded by a super uid phase

where all order parameters  $x_{iyiz}$  have equal m agnitude, i.e.,  $j_x j = j_y j = j_z j \in 0$ . Due to the positivity of the coe cient U  $x_{iy}$  in the Josephson term in Eq. (13) the

relative phases of the three condensates are fustrated. Thus, writing  $s = j_s je^{i_s}$ , s = x;y;z one nds xy = y z = z x = 2 = 3. An interesting e ect here is that the on site fustrated phase con gurations come in two di erent thiralities' that cannot be converted into each other by shifting any one of the phases by the shift allowed by the  $Z_2$  gauge symmetry. To see this one may consider the current owing between the condensates of di erent a-vors on a given site. The current owing between the X and Y condensates on a particular site is determined by sin(2[x y]). In a right handed con guration with, say, x = 0; y = 2 = 3; z = 4 = 3 there is an on-site current owing from

The situation is different in a left handed con guration with x = 0; y = 4 = 3; z = 2 = 3, where the current is now owing in the opposite direction, i.e.

X Y Z X:

Adding an arbitrary phase of (i.e. invoking the  $Z_2$  symmetry) to any of the phases does not a ect these currents.

Starting from a ground state with the same chirality throughout the system one can choose a set of parallel planes and change the chirality of each plane individually. Such changing of chirality of a plane requires that the whole plane has the same chirality. This additional ground state degeneracy is not associated with any symmetry of the H am iltonian but is an accidental one. A similar situation occurs for special parameter values in frustrated XY -m odels, where parallel zero energy dom ain walls can be inserted [28]. One should note that such accidental degeneracies at the mean eld levelm ay be lifted by uctuation e ects associated with collective m odes such as spin waves.




FIG.10: (Color online) Example of broken permutational symmetry. If one increases the interspecies interaction  $U_{xy}$  beyond 1=3, super uid phases with broken permutational symmetry can be achieved. Shown here are the order parameters sorted according to magnitude, 1 = max(x; y; z), 3 = min(x; y; z) for an interspecies interaction  $U_{xy}$  = 0.8 as a function of t. The total number of particles is shown as a dashed line.

As in the 2D (two avors) case, the sm aller M ott-bbes, corresponding to integer lling factors not divisible by the dimensionality of the system, are degenerate in the t = 0 lim it. This degeneracy is lifted due to tunneling, leading to (pseudo) m agnetic ordering like that demonstrated for the 2D (two avors) case. To fully lift the degeneracy one has to employ fourth order perturbation theory. The resulting H am iltonian will include term s acting simultaneously on three and four sites. How ever, such fourth order corrections are very sm all and m ay be difficult to observe in the proposed experimental situation. They can how ever lead to novel physics and can be intentionally generated [37, 38].

Before leaving this section, we comment on the possibility of breaking the permutational symmetry among the avors in the super uid phase. As is wellknown, large interspecies interaction strength in the two avor bosonic Hubbard model leads to phase separation. A phenomena occurring also here if  $U_{xy}$  0.5. However, due to the positive constant in front of the 'Josephson' (avor changing) term, another phenomenon can take place in the 3D (three avors) model.

As an example consider Fig. 10. Here  $\sim = 0.27$  and  $U_{xy} = 0.8$ . As can be seen for smallt the system is in a M ott insulating state with lling factor 2. As t increases the system becomes super uid. This occurs in two steps. First, mean eld theory predicts a second order transition to a state with only one avor super uid and then a rst order transition to a state with two nonzero super-uid order parameters of equal magnitude. Increasing the hopping strength further does not seem to make the

third avor super uid. We attribute this to the large energy cost associated with having the phases of the three order parameters in a frustrated con guration.

# V. IN TERFERENCE PATTERNS AND DENSITY CORRELATIONS

The traditionalway of detecting super uidity is by releasing the trap and looking at the density distribution of the expanding cloud. Provided that the cloud expands many times its initial diameter, the nal position of a particle is determined by its momentum rather than its initial position. Hence this expanded real-space density distribution provides a direct picture of the momentum space distribution of the trapped system. More precisely, the density distribution a time t after trap release is related to the momentum density of the trapped state j i as

where Q (r) = m r=(ht). It is useful to think of this spatial distribution as resulting from interference of matter waves radiated by the di erent lattice sites when the trap is released. The one-dimensional character of the  $Z_2$  gauge symmetry means that thermal uctuations can destroy the long range order phase order by allowing the phase on an arbitrary site to ip by . If the system disorders in this way, any interference pattern in the radiated matter waves will be destroyed as well. In this case, further information about the correlations in the system can be obtained by looking at the density uctuations (noise) in the released cloud [39, 40, 41] in a H anbury-B rown T wiss like statistical measurement.

W e begin this section by looking at the zero tem perature m om entum distribution and then consider the density uctuations of the expanded cloud around its m ean.

### A. Interference patterns

A lthough any real experiment is conducted at nite temperature, the zero temperature columnar phase ordering may prevail for a nite system at low enough tem peratures. The zero temperature momentum distribution is thus of interest and we will estimate it by using a single macroscopically occupied wave function corresponding to the super uid states in the two- and three- avor cases. The details of the calculations can be found in the Appendix and we here only state the main results.

We begin by considering a single 2D plane with N  $\sim$  N sites at zero temperature in the two-avor system and model the super uid state with a macroscopically occupied wavefunction

The subscriptsm and n denote the coordinates, rows and columns, in the lattice while and are phase factors (j j = j j = 1) determining the phase of the wavefunction on a given site. At zero temperature the phases of X - particles are ordered along rows while the phases of Y -particles are ordered along columns, i.e., mn = m and mn = n (cf. Fig. 5 and Fig. 17). For a macroscopic occupation M the observed density distribution in a single shot in the x y plane after expansion is proportional to the momentum distribution h j  $^{y}_{Q}$  g j i: A s shown in the appendix we have for a single 2D plane in the two- avor system




FIG.11: Calculated momentum distribution for a 40x40 lattice. The momentum distribution was calculated by num erically sum ming the contributions to the distribution function.

The functions  $\stackrel{\sim x}{_0}$  and  $\stackrel{\sim y}{_0}$  are the Fourier transforms of the on-site W annier functions and  $f_1(Q_v; m)$  and  $f_1(Q_x; m)$  are 2 = a-periodic random functions with typicalm agnitude of order unity which depend on which of the degenerate ground states is observed (see Fig. 18 and the Appendix for details). From the above equations the interference pattern from a single 2D plane in the twoavor system can bee seen to be a grid like structure as shown in Fig. 11 where the interference pattern has been calculated num erically for a 40x40 lattice. The appearance of lines, rather than points as in a single avor 2D system, stem s from the one-dimensional character of the super uid state with phases only being aligned along rows (columns) but random ly distributed between rows (columns). The random ness in the distribution between the rows (columns) show up as the random interference pattern along grid lines.

In an experiment one typically does not probe a single plane but it is the integrated density of a large number of planes that is in aged. For in aging in the plane parallel to the 2D planes the integrated column density (intensity in the absorption in age) is for a N N N lattice with M atom s in each 2D plane




FIG. 12: (color online) (a) The random function  $f_2(Q_y; Q_z; _{n_0}^*)$  for a 40 40 lattice for a speci c realization of  $_{n_0}^{\times}$  Note that  $f_2$  is symmetric under inversion. (b) The random function  $g_2^y(Q_x; Q_z; _{n_0}^y; _m)$  for a 40 40 lattice for a speci c realization of  $_{n_0}^y$  and  $_m$ . Note that  $g_2$  is not symmetric under inversion.

1 (see Appendix) the random interferences seen in Fig.11 will be averaged out and a grid of sm ooth lines, void of interference, will be seen. A nother source of sm oothing out the random interferences comes from limited detector precision. For a large system, the random oscillations becomes increasingly rapid and only an average over nearby momenta can be probed.

In the 3D (i.e. three avors) case, the situation is very similar. Special care have to be taken with accidental symmetry breaking of the ground state giving rise to planes of dierent chirality. If we assume that planes with uniform chirality have normals in the x direction

A gain, since long range order is only aligned along 1D strips, the released cloud will be a set of intersecting perpendicular planes with intersections at positions corresponding to odd momenta  $Q_{x,y,z} = (2n + 1) = a$ . The planes in each direction will have a random intensity modulation speci ed by the random functions  $f_2$ ,  $g_2^y$  and  $g_2^z$  (see Appendix for details). Examples of these distribution functions  $f_2$ , and  $g_2$  are shown in Fig. 12. The last three terms in Eq.18 random lym odulate the distribution along the intersections of the planes.

If a single shot measurement is made, the integrated column density will show a pattern of grid lines sim ilar to that in Fig. 11, the grid lines showing random interference patterns. Between the lines a periodic random distribution (of lesser intensity than the lines) will be present. This latter distribution will be either  $f_2$  or  $g_2$  depending on the orientation of the planes with uniform chirality. Thus if the absorbtion in age is taken in the same plane as the planes with uniform chirality this background modulation will be symmetric under space inversion (cf. Fig 12(a)) whereas if it is taken perpendicular there will be no such symmetry in the random modulation (cf. Fig 12(b)).

#### B. Density-density correlations

As pointed out above, the dimensional reduction present in the system means that nite temperatures can destroy the 1D Ising-like ordering of phases along columns and that the individual phases at any one site can be ipped , i.e., the  $Z_2$  gauge symmetry is restored. In this case there will be no visible interference pattern although atoms are delocalized, i.e. the delta peaks will be sm eared and a random density distribution will be seen each shot.

To illustrate the usefulness of correlation measurements we consider a single N N 2D plane in the twoavor system at unit lling (M = N<sup>2</sup>). If the temperature is nite, not only may the Z<sub>2</sub> symmetry in the super uid state be restored but it is also possible for the unit lling M ott state to be disordered. There are then four di erent possible states the system can be in

- 1. Super uid with restored Z<sub>2</sub> sym m etry.
- 2. Ferrom agnetic M ott insulator (all atom s of the sam e avor).
- 3. Anti-ferrom agnetic M ott insulator (alternating a-vors on alternating sites).
- 4. D isorder M ott insulator (each site having one atom but with random avor).

If one m akes multiple single shot m easurements and averages the density distribution obtained in each shot, one obtains a m easure of the average m om entum distribution (see A ppendix)

which is the same for each of the four states 1-4. We will henceforth refer to averages h i as disorder averages. To distinguish the four states one can instead measure the HBT-like density-density correlations of the expanding cloud [39, 40, 41],

Here hn (r)i<sub>t</sub> is the density of atom s at point r a time t after the trap has been switched o averaged over many experimental realizations (see Appendix). To measure  $\ln (r)n (r^0)i_t$  one calculates the product of the observed densities n (r)n (r<sup>0</sup>) in each shot and averages over several experimental runs. Just as for the density distribution, the correlation function G provides a measure of the momentum correlations

To get a qualitative understanding of how the superuid state can be detected by correlation m easurements we rst return to the T = 0 result in the previous section and look at the periodic function  $f_1(Q_y)$ . This random modulation arose because phases of Y is were uncorrelated between rows. Since the relative phases of the Y is in rows is this function is even in Q and along any given grid line the quantity  $ln_Q n_Q \circ i$  is thus strongly correlated when  $Q_y + Q_y^0 = 2m$  =a. A veraging over m any realizations one sees that (along a grid line of constant  $Q_x = 2n$  =a)

In the thermally disordered super uid state the phase on any site is allowed to ip by (restoring  $Z_2$  sym - metry). This destroys the delta peaks in  $j_{(x,y)}^{2} f$  and

gives instead a random modulation given by the function  $f_2(Q_x;Q_y)$ . Since only - ips are allowed this modulation is symmetric  $f_2(Q_x;Q_y) = f_2(Q_x;Q_y)$  and we get strong correlations in  $hn_0 n_0 \circ i$

where  $G_n$  is a reciprocal lattice vector. On a technical level (see Appendix) this can be seen to arise since the disorder averaged propagator for single particles is necessarily short-ranged due to the random phase changes at nite temperature, while the disorder averaged propagators for pairs of particles can still be long-ranged.

In Appendix we have calculated G (Q (r); Q<sup>0</sup>(r<sup>0</sup>)) for the four scenarios for a single plane in the two- avor system and we here give the qualitative results. The superuid state is, con m ing the qualitative discussion above, characterized by peaks at Q  $Q^0 = G_n$  (see Eq. (63)) while the ferrom agnetic M ott state and the disordered M ott state has peaks only at Q  $Q^0 = G_n$  (see Eqs. (67) and (82)). The correlation function in these M ott states are distinguished by having di erent background intensities between peaks and di erent peak strengths. The antiferrom agnetic M ott state has peaks at half reciprocal lattice vectors Q  $Q^0 = G_n = 2$  (see Eq. (74)).

In the three avor system the situation is similar to the two avor scenario discussed above. In the presence of therm all disordering of the super und state the interference patterns of the M ott state and the super und states become e indistinguishable. Again, in the three avor case the pair propagators will be nonzero in the disordered super und state and G (Q (r);Q<sup>0</sup>(r<sup>0</sup>)) will have peaks at  $Q = Q^0 = G_n$  (see Eq. (93))

W hile there should be no problem to measure the correlation functions for a system with three avors, the two-avor system poses a problem of technical nature since in an experiment several uncorrelated 2D planes will be created. Suppose one has N uncorrelated planes. If one detects one atom at position r and another at  $r^0$  in a single experiment the atom s could have come from either the same plane or di erent planes. Measuring the product of densities in each shot and averaging over several experiments one will for the case with N 2D planes actually measure

## VI. LIFETIM E ESTIMATE 1D

In the previous sections, e ective H am iltonians for atom s in the rst band (s) of the optical lattice were introduced and the mean eld ground state phase diagram s 14

drawn. In doing so, it was assumed that the interaction terms in the original Ham iltonian (2) responsible for scattering particles between bands could be ignored. In this section, these interactions are taken into account perturbatively and the lifetime of atom s in the rst band is estimated. The obtained (inverse) lifetime should be compared to other energy scales in the problem, most im portantly the smallest one, the hopping energy. If the lifetime turns out to be long compared to the time scale of hopping, the novel states described in the previous sections should be possible to realize in experiment.

To simplify matters, the discussion will be restricted to the 1D-case. The ensuing results are expected to agree well, both qualitatively as well as quantitatively, with the 2D and 3D cases to lowest order in perturbation theory. This follows from taking parity considerations into account when determining the allowed transitions. Thus, ignoring tunneling in the y z directions and measuring distance in units of the lattice spacing (see section II) the 1D Ham iltonian can be written  $\hat{H} = \hat{H}_0 + \hat{V}$  with

A part from the eld operators  $\hat{n}()$  it is convenient to de ne boson operators in two other bases. First, we have the basis of B bch functions  $u_{nk}()$  with band index n and lattice momentum k. These functions satisfy  $\hat{H}_0 u_{nk}() = {}_n(k)u_{nk}()$  and are associated with the eld operators  $\hat{a}_{nk}$ ;  $\hat{a}_{nk}^{Y}$ . Second, we have the W annierfunctions  $\hat{n}(m)$  de ned in section II. In this section we will denote the corresponding eld operators by  $\hat{a}_n(m)$ ;  $\hat{a}_n^{Y}(m)$ . Note that these de nitions depart from the conventions in previous sections and that operators corresponding to B loch functions and W annier functions are distinguished in the number of subscripts.

#### A. W ide-band lim it

Begin by looking at the case when the second term  $\hat{V}$  in eq.(19) is small compared to  $\hat{H_0}$  and consider an initial state where all N atom s reside in the lowest lying B loch state of the rst band,




FIG.13: (Solid line) Inverse of the coe cient w occurring in Eq.(20) for the rst order decay rate calculated in the wideband lim it. In this lim it, there are no available energy states for the rst-order decay provided  $19 < v_{0x}$ .(D ashed line) The dashed line shows the maximum value of the ratio  $a_s = a$  for which the wide-band analysis is valid.

In Fig. 13 w (v) obtained from numerical calculation is shown. For convenience the inverse of w has been plotted. As can be seen, the lifetime goes to zero for small and large v. This is a result of the diverging density of states at the band edges. Above v 19 the rst order process is no longer energetically possible and higher order perturbation theory has to be applied.

The validity of the wide-band calculation relies upon the assumption that the inequality  $_1U < t$  is satis ed. This condition can be used to obtain an upper bound on the ratio  $a_s=a$  by assuming the lattice depth to be the same in all directions, i.e.  $v_{0x} = v_{0y} = v_{0z} = v_0$ , which yields

An alternative starting point is when  $_1U$  twhile the lling factors for the zeroth and the second band are small, i.e.,  $_0$ ;  $_2$  1. Keeping term soforder  $_1U$ , the relevant unperturbed Ham iltonian to start from is in this case one where tunneling events in the two lowest bands are com pletely ignored whereas interactions between atom s is only considered for atom s interacting with particles in the rst band. Hence, one nds,

This state is not an exact eigenstate of the unperturbed H am iltonian in Eq. (21) but an approximate one. The correction to the B loch wave functions for n > 1, which will later occur in the overlap integrals, is however only of the order  $U = v_{0x}$  1 and can thus be ignored. W hat is more important is the associated energy shift since this a ects the position of the band edges of the n: th band. This, in turn, can have impact on the lifetime since it a ects the naldensity of states. Hence, one can replace the two last terms in the unperturbed H am iltonian (21) by a term diagonal in the band index n;

Here, the rst order (Hartree) shift  $_{nk}$  in energy due to interactions between an atom in the n : th B loch band and the atom s in the rst band have been incorporated.




FIG.14: Typical initial state jii for the lifetime estimate in the narrow band limit. All atoms are residing in the rst band, localized in the wells. In this particular case the lling factors are  $_0 = 0$ ,  $_1 = 1$  and  $_{n>1} = 0$ .

To present a comprehensive num erical analysis of this decay rate is prohibitive due to the large number of param eters entering expression Eq. (23). Thus, for sake of illustration, we will here restrict the discussion to unit lling factor in the second band, i.e.  $_1 = 1$ . Further, we use  $(a_s=a) = 1=100$  which is a reasonable value from an experim entalpoint of view. The lattice depths in the transverse directions will be chosen slightly larger than in the x-direction, i.e. chose  $v_{0y} = v_{0z} = v_{0x} + 1$ :

The results of the calculation, using wave functions obtained from band-structure calculations, are shown in F ig. 15 which plots the ratio between the hopping rate and decay rate,  $t_1 = (hw)$ . The di erent solid lines correspond to di erent number of particles initially in the well. The cases  $n_r = 2;3;4;5$  are shown,  $n_r = 2$  having the longest lifetime and  $n_r = 5$  having the shortest.




FIG.15: (Color online) First order lifetime w<sup>1</sup> for a 1D system with lling factor  $_1 = 1$  and  $(a_s=a) = 1=100$  in the narrow-band lim it according to Eq. (23). The solid lines show the ratio between the lifetime and the time scale for hopping  $(ht_1^{-1})$  for  $n_r$  particles in well r. From top to bottom; (blue)  $n_r = 2$ ; (green)  $n_r = 3$ ; (red)  $n_r = 4$ ; (black)  $n_r = 5$ . The dashed line shows the ratio  $t_1 = 10$  which should be less than unity for perturbation theory to be valid. The dot-dashed line shows the result obtain by using the wide-band form ula in Eq. (20) using the same parameters.

The dashed line shows the ratio  $t_1 = (_1U)$  which should be less than unity for the expression to be valid. As a comparison, the resulting lifetime obtained in the wideband lim it Eq. (20) is also shown as the dash-dotted line.

The most interesting part of the result shown in Fig. (15) is the sudden decay of the lifetime. This is, as was the case in the wide-band limit, a result of the diverging density of states  $(_2 \ k)$ ) near the band edge. For lattice potentials deeper than  $v_{0x}$  20, there is no phase space (no available nall energy levels for the excited particle), available for the rst order decay. To nd out the lifetime for larger values of  $v_{0x}$ , second order perturbation theory is needed.

Consider again the same initial state jii as above. A dhering to energy conservation arguments, there are three di erent, mutually orthogonal, nal states reachable through a second order process,




FIG.16: (C obr online) Second order lifetime  $w_1^{-1}$  for a 1D system with lling factor  $_1 = 1$  and  $(a_s=a) = 1=100$  in the narrow-band limit according to Eq. (23). The solid lines show the ratio between the lifetime and the time scale for hopping  $(ht_1^{-1})$  for  $n_r$  particles in well r. From top to bottom; (green)  $n_r = 3$ ; (red)  $n_r = 4$ .

N um erical evaluations of the decay rates reveal that the dom inant contribution to the total decay rate  $w_{tot} = w_1 + w_2 + w_3$  comes from  $w_1$ . The reason for this is easily understood; the contribution from  $w_2$  is small due to destructive interference of time reversed processes while the smallness of  $w_3$ , is due to smallness of overlap integrals, which in turn can be understood from parity considerations.

The decay rate  $w_1$  is shown in Fig. 16. As can be seen, it is possible to achieve lifetim es considerably larger than the inverse of the hopping energy, thus justifying the validity of the H am iltonians in eqs. (11) and (13).

#### VII. CONCLUSIONS

By extending the usual mapping to the bosonic Hubbard model of ultra cold atoms in an optical lattice to incorporate higher Bloch bands, e ective Ham iltonians governing the dynamics of atoms in the rst Bloch band (s) have been obtained. These Ham iltonians resem – ble previously studied bosonic Hubbard Ham iltonian but di er in two im portant respects:

> Atom s in the rst excited band are labelled by three possible avors X;Y;Z. The dynam ics is such that X particles can (to a good approximation) move only in the x direction, etc.

F lavor changing collisions of atom s on the same site leading to conversion of the form X X ! Y Y, etc. occur.

By appropriate choices of the lattice depths in the different directions the number of avors and the e ective dimensionality (equal to the number of avors) of the system can be changed. To obtain values of the relevant parameters, such as hopping energy and interaction energies, entering these e ective H am iltonians we have solved the time independent Schrodinger equation (M athieu equation).

The elective H am iltonians in two and three dimensions also show, apart from the usual global U (1) gauge symmetry, a set of  $Z_2$ -gauge symmetries intermediate between local and global. The ground state in the 3D (three avors) case also displays a chiral symmetry breaking and an additional accidental ground state degeneracy associated with di erent planar chiral ordering.

The phase diagram s for two particular cases relevant for experiment have been sketched using mean eld theory, indicating quantum phase transitions between M ottinsulating and super uid states.

U sing time dependent perturbation theory up to second order in the interatom ic interactions the lifetim e of the atoms in the excited bands have been estimated. The results show that life tim es considerably longer (orders of m agnitude) than relevant dynam ical tim e scales can obtain. This suggests that it may be possible to realize quasi-equilibrium in the subspaces of meta stable states spanned by the e ective Hamiltonians. Finally, we would like to stress that the mean eld theory used to draw the phase diagram is only able to describe the most simple scenario with a transition from a Mott-state to a super uid state with order parameter hX i 6 0. It is well known [14, 15, 16, 17, 18] that otherm ulti- avorbosonic Hubbard models such as the 2species Bose-Hubbard model shows a rich phase diagram with phases which cannot be described in this simple approximation. The present model, already rich at the m ean-eld level warrants further study. In particular, we have pointed out potential connections to certain classes of models of frustrated spins [21, 22, 23, 24] and bose metals [25] that also have an in nite but subextensive num ber of  $\rm Z_2$  gauge sym m etries and as a result exhibit dim ensional reduction and exotic phases. W ith the microscopic H am iltonian developed here, these connections can and should now be pursued in detail.

#### APPENDIX

Here we provide a detailed derivation of the density distribution one expects to observe in the various phases and the di erent ways of measuring the density density correlations in the released cloud of atom s.




FIG.17: Sample con guration of phases and the elds  $m^{x}$  and  $\frac{y}{n}$  for a plane in the two- avor system at zero tem perature.




FIG.18: Example of the random function  $f_1 \left( Q_y \right; {\stackrel{x}{_m}} \right)$  de ned in Eq.(37) .

The sum over  $m_2$  can also be viewed as a random walk for each value of  $o_2$  but in the complex plane. Each step being of unit length in any of the four directions 2 =3 and

4 =3. Sum ming over  $n_1$  and  $m_2$  thus yields, for each  $(o_1; o_2)$  a random term of magnitude N with a completely random phase. Thus the interference terms in Eq. (38) (the other two terms can be treated sim ilarly) give rise to a three dimensional grid of lines in the released cloud where the density along any given line is random by distributed. If the density is averaged over several shots, with dimensional ground states we have no contribution from the interference terms since  $\frac{1}{2} e^{-y} = 0$ .

# 3. Density averages and correlations , T $^{>}$ 0

If T is large enough for them al uctuations to restore  $Z_2$  sym m etry but still sm all enough to preserve the distinction between the M ott state and the super uid state, m easuring the density distribution alone does not su ce since the delta-peaks will be sm eared. Instead correlations can be m easured. To this end, assum e we have a single physical system .At nite T this system undergoes

transitions in a manifold of N states. Denote this manifold by the states fj  $_{i}ig_{i=1}^{N}$ . In a single shot a single one of these states will be probed. In an in nite series of experiments each of these states will be probed an innite number of times and one can thereby measure the quantity

Here we have ignored the Boltzm ann factors since the manifold we are looking at is nearly degenerate. In reality only a nite sequence of M experiments can be carried out and the uctuations in h  $j\hat{O}ji$  is of concern. There are two sources uctuations; First, for each state  $j_{ii}$  there is quantum shot noise. Second, since not all of the N states will be probed there will be deviations due to not sampling the entire distribution.

If the manifold of states probed are super uid states then N = O ( $[2d]^{N d}$ ) with d being the dimensionality of the system. Since super uid states are to a good approximation macroscopically occupied single particle states, uctuations due to shot noise are reduced. The remaining uctuations are classical and expected to scale as M<sup>1=2</sup> and h i  $\hat{O}$  i i cheuld in principle here particle to macro

and h j $\hat{O}$  j i should in principle be possible to measure. On the other hand, if the state measured is a M ott state the manifold fj  $_{i}ig_{i=1}^{N}$  consists typically of only a few states in which case multiple measurements reduces the quantum shot noise since each quantum state will be probed many times. We thus conclude, that by making repeated measurements and averaging the results, one can measure  $h j \hat{O} j i$ .
