Critical dynamics and elective exponents of magnets with extended impurities

We investigate the asymptotic and elective static and dynamic critical behavior of (d = 3)-dimensional magnets with quenched extended defects, correlated in "d dimensions (which can be considered as the dimensionality of the defects) and random by distributed in the remaining d "d dimensions. The eld-theoretical renormalization group perturbative expansions being evaluated naively do not allow for the reliable numerical data. We apply the Chisholm-Borel resummation technique to restore convergence of the two-loop expansions and report the numerical values of the asymptotic critical exponents for the model A dynamics. We discuss dierent scenarios for static and dynamic elective critical behavior and give values for corresponding non-universal exponents.

I. INTRODUCTION

Critical properties of structurally disordered magnets remain a problem of great interest in condensed matter physics, since real magnetic crystals are usually non ideal. A simple and natural case of disorder is implemented via the point-like uncorrelated quenched nonmagnetic impurities and is experimentally realized as substitutional disorder in uniaxial [1] as well as in Heisenberg [2, 3] magnets. Examples are given by substitute alloys $M n_x Z n_1 x F_2$, $Fe_x Z n_1 x F_2$ for the uniaxial (Ising) m agnets [4], and by am orphous magnets $Fe_{90+x}Zr_{10}$ x, $Fe_{90} v M v Zr_{10}$ (M = Co; Mn; Ni) [5, 6], transition-m etal based magnetic glasses [7, 8] as well as disordered crystalline materials $Fe_{100 x} Pt_x$ [9], $Fe_{70}Ni_{30}$ [8] and Euchalcogenide solid solutions [10] for the Heisenberg magnets. The question of a great interest arising here is: does the disorder change critical properties of the system s? The answer is given by the fam ous Harris criterion [11]. It states, that disorder changes the critical exponents, if the critical exponent p of the pure system is positive: $_{p}$ = 2 d $_{p}$ > 0. Here, $_{p}$ is the critical exponent governing the divergence of correlation length of the corresponding pure system and d is the space dimension.

On the base of this inequality, one can estimate the marginal value m $_{\rm c}$ for the spin m -vector model of magnetic systems, such that for m > m $_{\rm c}$ the critical exponents remain unchanged by point-like defects whereas for m < m $_{\rm c}$ they cross over to new values. The present estimates form $_{\rm c}$ in three dimensions denitely in ply m $_{\rm c} < 2$: m $_{\rm c} = 1.942$ 0.026 [12] and m $_{\rm c} = 1.912$ 0.004 [13] and thus only the pure Ising model (m = 1) is a ected by weak point-like uncorrelated disorder at criticality.

But in real magnets one encounters non-idealities of structure, which can not be modelled by simple point-like uncorrelated in purities. Indeed, magnetic crystals often contain defects of a more complex structure: linear dislocations, disclinations, complexes of non-magnetic in purities, embedded in the matrix of the original crystal [14]. Theoretical studies of critical behavior of magnets containing such \extended" (macroscopic) defects have attracted considerable interest [15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26], however, a systematic experimental analysis still remains to be performed.

One of the possible ways to treat defects that extend through the system being random ly distributed in space but oriented in the same direction is to consider them as quenched "d-dimensional nonmagnetic impurities of parallel orientation. This was proposed in the work of Dorogovtsev [15]. The case "d = 0 is associated with point-like defects, and extended parallel linear (planar) defects are described by "d = 1(2). To give an interpretation to the non-integer values of "d, one may consider patterns of extended defects like aggregation clusters, and treat "d as the fractal dimension of these clusters [19]. However, relation of analytically continued non-integer Euclidean dimension to the fractal dimension is not straightforward [27].




FIG. 1: The phase diagram of d=3-dimensional m-vector magnets in the presence of "d-dimensional impurities. Marginal value m c ("d) separates regions of dierent universality classes. Disorder is relevant in the "d-m plane below the m c curve. Filled squares: results of calculations, based on six-loop renormalization group data [28] for the correlation length critical exponent, dotted line: estimate based on resummed ";"d-expansion for m c, Eq. (30). Only the physical region "d > 0 is shown. See Section IV for a whole description.

It was shown [16], that presence of extended in purities leads to a generalized H arris criterion, namely, in this case disorder alters the critical behavior of the pure system, if $\mathbf{I}_d > d$ 2 = p. If one considers the point-like disorder with $\mathbf{I}_d = 0$, the generalized H arris criterion turns to ordinary one cited above. A gain, this inequality de nes for each value of \mathbf{I}_d the critical value \mathbf{I}_d , below which the extended disorder alters the universality class. But now the disorder induced critical behavior of $\mathbf{I}_d = 0$ system sholds not only for the Ising magnets $\mathbf{I}_d = 0$ but for $\mathbf{I}_d = 0$ as well, as shown in Fig. 1 (region denoted as \D iluted $\mathbf{I}_d = 0$) in the gure). Therefore, the class of magnets where the new critical behavior may be found is not restricted to the uniaxial ones $\mathbf{I}_d = 0$, but include easyplane $\mathbf{I}_d = 0$ and H eisenberg $\mathbf{I}_d = 0$ system s. Thus

predicted phenomena of a new universal behavior may be experimentally checked for a wider class of magnets.

A nother interesting feature of systems with parallel extended defects is that due to the spatial anisotropy they are described by two correlation lengths, one perpendicular, $_2$, and one parallel, $_{jj}$, to the extended in purities direction [15]. As the critical temperature T_c is approached, their divergences are characterized by corresponding critical exponents $_2$, $_{jj}$:

where t is the reduced distance to the critical tem perature t= $(T - T_c)=T_c$. A nisotropic scaling holds also for the spin-spin pair correlation function at T_c and is governed by exponents $_?$ and $_{jj}$. Whereas the magnetic susceptibility is isotropic, as far as all order parameter components interact with defects in a similar way. However, the dynamic critical behavior is modied, two times of relaxation in directions perpendicular and parallel to the extended in purities $_?$ and $_{jj}$ behave correspondingly as:

with dynamical exponents z_2 and z_{ii} .

Therefore, magnets with quenched extended defects of parallel orientation constitute a large class of systems with a bulk of unusual phenomena worth to be analyzed. Their asym ptotic critical behavior was a subject of

the eld-theoretical renormalization group (RG) analyses [15, 16, 17, 20, 21]. In particular, a double expansion in both "= 4 d, "d was suggested and RG functions were calculated [15] to order ", "d; qualitatively, the crossover to a new universality class in the presence of extended defects was supported. These calculations were extended to the second order in Refs. [16, 18]. However, these divergent RG expansion did not give a reliable num erical estim ate for the critical exponents - the goal highly desirable both for experim ental and simulational purposes. Num erical estimates for the exponents describing static critical behavior of d = 3 m agnets with parallel extended im purities were obtained only recently [20, 21] by applying special resummation technique to the two-loop RG functions of Refs. [16, 18]. Currently, no estimates of sim ilar accuracy exist for the dynam ic exponents describing critical slow ing down in the magnets under consideration. The theoretical investigation of critical dynamics of system with parallel extended defects was performed in the one-loop approximation [17] for the simple models with non-conserved order parameter (model A) and conserved order parameter (model B). Then the RG study of model A critical dynamics was extended to the twoloop order [18]. But again, the convergence properties of the series obtained did not allow num erical evaluations. Recently, the short-time critical dynamics of the model A was considered in Ref. [22].

The goal of this paper is to apply the state-of-the-art analysis of the divergent RG perturbation theory series to get num erical estimates of the exponents describing m odel A dynam ics of d = 3 m agnets with extended im purities for a wide region of impurity dimension "d and for di erent values of m . C om plem enting existing estim ates of the static exponents [20, 21], our results will give com prehensive values for the critical exponents of systems with extended in purities and, in this way, will facilitate their experim ental analysis. Moreover, since both in experim ents and in Monte Carlo (MC) simulations often the asymptotic region is not reached and e ective exponents are observed [29], we will calculate these as well. By these estimates we will predict the possible scenarios of approaching the critical point. These are important to perform corresponding experimental checks, as it was shown recently by theoretical [30] and experim ental [31] studies of the d = 3 disordered Heisenberg magnets with point-like defects.

The setup of the paper is as follows. In the next section we present the model; in section III the renormalization procedure is discussed. In section IV we apply the resummation techniques to analyze the renormalization group functions in two-loop approximation and present the quantitative estimates for the asymptotic dynamical critical exponents. Section V gives description of possible scenarios for the ective critical behavior and section V I concludes our study.

II. THE MODEL

The starting point is the e ective H am iltonian of the model of an m-vector magnet with "d-dimensional defects, extending throughout the system along the coordinate directions symbolized as \mathbf{x}_{jj} and randomly distributed in perpendicular directions $\mathbf{x}_{?}$ [16, 18]:

Here, $\tilde{}$ is an m-component vector eld: $\tilde{}$ = f 1 mg, $_0$ and u_0 are the bare mass and the coupling, a_0 is the bare anisotropy constant, r_{jj} and $r_?$ denote dierentiation in the coordinates x_{jj} and $x_?$ and the impurity potential V (x) is introduced. The probability distribution of defects has zero mean and variance given by:

Here, this idenotes the averaging over the distribution of defects, $(\neg v_0)$ is a positive coupling constant, which is proportional to the concentration of impurities. The constant a_0 parameterizes the anisotropy, arising in the system due to the presence of extended defects.

We consider critical dynamics of the model (9) for the case of a non-conserved order parameter. For this case the dynamics can be expressed in the Langevin equation form [32]:

The brackets h::i m ean an average w ith respect to the therm alnoise.

W ithin the eld theory approach it is convenient to use the Bausch-Janssen-W agner formulation [33] which is given by the Lagrangian:

Here, $^{\sim i}$ are components of an auxiliary response eld introduced to average over the thermal noise. Then correlation and response functions are computed with the help of a weight function W $= e^{\text{L} \left[\begin{array}{c} \cdot \\ \cdot \end{array} \right]}$.

It is known that studying dynam ical properties of disordered systems averaging over random impurities can be applied directly to dynam ical weight function W. As it is established in Ref. [34], the congurational averaging can be performed avoiding replica trick [35]. However it leads to the same perturbative expansions for the RG functions as those obtained with replica formalism. Therefore both approaches giving equivalent results are possible for dynamics. However the above alternative does not exist when the static critical behavior is analyzed (see e.g. [1, 2]). As far as both static and dynamic criticality is addressed in this paper, we use the replica trick, representing the logarithm of a weight function in the following form:

Finally it leads to study of properties of replicated Lagrangian L [~;~] [36]:

here, the sum m ation over G reek indices spans from 1 to n denoting the di erent replicas and the Latin indices go from 1 to m denoting the components of the order parameter. To study behavior of this model (9) in the vicinity of the critical point we apply the minimal subtraction scheme within eld-theoretical RG. The description of this approach is given in the next section.

III. RG STUDY

The description of the long-distance properties of the model (9) near the second order phase transition point is performed using the eld-theoretical RG method [37]. Let us present the renormalization algorithm, developed for Lagrangian eld theory. It is well known, that such a theory encounters with ultraviolet divergences, the re-

m oval of which is achieved within an appropriate renormalization procedure by a controlled rearangement of the perturbation theory series. The change of bare couplings u_0 ; v_0 and of the anisotropy constant a_0 under renormalization is described by the RG functions:

Here, u;v;a are the renormalized couplings and anisotropy constant, respectively, is the rescaling parameter, the notation j indicates di erentiation at xed bare parameters. The bare elds , $^{\sim}$, the mass $_0$ and the 0 nsager kinetic coe cient $_0$ are related to the renormalized ones', $^{\sim}$ and by:

where Z-factors are dimensionless functions of renormalized parameters m;u;v;a. Their ows are dened by corresponding RG functions:

Functions and \sim are connected by the relation: = $(\sim)=2$.

The xed points (FPs) u ; v of the RG transform ation are de ned as common zeroes of the -functions:

A FP is stable, if the eigenvalues of the stability m atrix, de ned as: B $_{ij}$ = 0 $_{u_i}$ (u ;v)=0 $_{u_j}$ (u ;v); u_i = fu;vg have positive real parts. In the case when the stable FP is physically accessible, i.e. can be reached starting from the initial values of the renormalized couplings (in our case, u > 0, v < 0), corresponds to the critical point of the system . The RG functions (12)–(15) taken at this point give the critical exponents of magnetic susceptibility, correlation length and relaxation time:

Note, that the following relations between the exponents describing the parallel and perpendicular correla-

tion length and relaxation times hold [15]:

To obtain the quantitative characteristics of the dynam ical critical behavior of magnetic systems with extended in purities, we turn our attention to the RG functions derived in Ref. [18] in two-loop approximation:

Here, " = 4 d and the replica $\lim it n = 0$ has been assumed. Putting in Eqs. (20)-(23), (25) "_d = 0 one regains the RG functions of the m-vector magnet with point-like defects [38, 39, 40].

The description of the critical behavior of magnets with extended impurities carried out in Refs. [15, 16, 18, 19] was based on the double expansion in two param eters ", "d, considering both to be of the same order of magnitude. Being quite clear technically, such a statement causes however certain cautions. Indeed, taking the "as a small parameter is due to the fact that it deviates from the upper critical dimension, where the 4 theory becomes asymptotically free [37], whereas "d is the dim ension of defect itself and obviously has a di erent physical origin. Therefore, it is desirable to search for an alternative way to analyze the RG functions (20)-(25). Fortunately, such an alternative exists and it is exploited in the eld-theoretical approach to critical phenomena [41]. Namely, it consists in the analysis of minimal subtraction RG functions directly at dimension of space of interest, xing " and solving the FP equations num erically [41] (the so-called xed dimension scheme). It was

proposed [20, 21] to extend the approach of direct evaluation to the RG functions of the present model, i.e. to treat them directly at d=3 (" = 1) for di erent xed values of the (non-integer) defect dimensionality " $_d$. In our calculations (see Section IV), we will make use of both possibilities, exploiting ", " $_d$ expansion as well as working within the xed dimension scheme.

In the eld-theoretical RG approach the series expansions of the RG functions in powers of the coupling appear to be divergent; m oreover, they are characterized by a factorial growth of the coe cients in plying a zero radius of convergence [37]. To take into account the higher order contributions, the application of special tools of resum m ation is required [42]. In our previous paper [21], analyzing static critical behavior we applied the Chisholm -Borel resum mation technique. Here, the Borel im age of the initial function is extrapolated by a rational Chisholm [43] approximant [K = L](x;y). One constructs this ratio of two polynomials of order K and L such that its truncated Taylor expansion is equal to that of the Borelim age of the initial function. The resum med function is then calculated by an inverse Borel transform of this approximant. The details can be found in [44].

IV. THE RESULTS

The critical behavior of the model (9) is in uenced by the presence of the following FPs: the Gaussian FPG (u=v=0), the O (m)-symmetric FP of a pure magnet P (u 60;v = 0) and the random FPR (u 60;v 60) that governs disorder-induced critical behavior. A polymer FP with u=0;v>0 is not reachable from the initial values of couplings and therefore is out of interest for our study. Depending on the values of global parameters d;" $_d$; $_m$ one of the above FPs is stable and in the asymptotic limit governs the criticality. However, as we will show in the section V an approach to the asymptotic limit and hence the elective critical behavior is in uenced by all the FPs.

For the d = 3 magnets considered here, it is the crossover between FPsP and R that corresponds to the change of the universal properties of an m-vector magnet upon dilution by "d-dimensional defects. According to the generalized Harris criterion, this crossover occurs at certain marginal value m_c ($^{"}_d$). At $m > m_c$, the FP P is stable, indicating no change in critical behavior, whereas for m < mc one nds the stability of the FP R, displaying the fact of relevance of disorder. From the generalized Harris criterion one can obtain the marginal value $\mathbf{m}_{\mathrm{d}}^{\mathrm{marg}}$ as function of m . Using the six-loop results [28] for the correlation length critical exponent p (m) of the pure m -vector m agnet, one obtains: $\mathbf{u}^{\text{m}}_{d} \text{ arg} \text{ (m = 1)} = 0:173; \mathbf{u}^{\text{m}}_{d} \text{ (m = 2)} = 0:016;$ $\mathbf{m}^{\text{m arg}}$ (m = 3) = 0:172; $\mathbf{m}^{\text{m arg}}$ (m = 4) = 0:300. These estim ates are shown in Fig. 1 by lled squares connected by a solid line. The qure may serve as a phase diagram of an m -vector m agnet with extended im purities: the new

critical behavior is expected in the region of $\textbf{\textit{"}}_d$ $\,$ m plane denoted as \D iluted". In the region denoted \P ure" the asym ptotic critical behavior does not indicate presence of defects, however the e ective critical behavior does. Below, we will perform an analysis of the critical dynamics for both regions of the phase diagram .

A. Fixed d = 3 schem e

We start from the RG —functions (20), (21): xing the value " = 1 (i.e. d = 3) and treating " $_{\rm d}$ as a varying param eter, we look for the common zeros of the resummed functions $_{\rm u}$ and $_{\rm v}$. The numerical values of the stable FP coordinates obtained for the three-dimensional m-component magnets with m = 1;2;3;4 can be found in our previous paper [21].

To calculate the values of the critical exponents z_2 we substitute Eq. (25) for in Eq. (18), apply the resummation procedure for the resulting series, and, nally, estimate them at the stable FP.Note, that because the function is not symmetric in variables u and v (namely, it does not contain term linear in u) the Chisholm approximant chosen for its analytic continuation diers from those chosen for the —functions. The value of critical exponent z_{jj} is obtained using the relation (19).

In Table I we give the obtained results for critical exponents z_{jj} , $z_{?}$ of three-dim ensional m-component m agnets. The case $\mathbf{m}_{d}=0$ corresponds to point-like defects. As it was already noted in the Introduction, for this case only the Ising model (m = 1) is in uenced by disorder, and thus for systems with m > 1 the values of the critical exponents are not altered by disorder. Here, one can compare our result with the dynamic exponent of the pure and diluted Ising models, as shown in Tables II, III. When \mathbf{m}_{d} increases, for m = 2;3;4 the critical exponents

rem ain constant and equal to the corresponding exponents of the pure model, until m becomes m_c for given $^{\prime\prime}_{\rm d}$ and for m > m_c the values of exponents start to increase because they take their new values belonging to the disordered universality class.

An interesting feature of the data shown in Table I is that for each $\,$ xed $\,^{\prime\prime}_{\rm d}$ the relation $z_{\rm jj} < z_{\rm ?}$ holds. One can give the following physical interpretation to this fact. As it has been noted for isotropic systems §2], the dynam ical critical exponent z is proportional to the pair

correlation function critical exponents:

For the systems we consider here the critical exponents $_{?}$ and $_{jj}$, that characterize the behavior of the pair spin-spin correlation function in the directions, perpendicular and parallel to the extended defects, are distinguished [15]. As far as the extended defects cut interacting bonds of spins perpendicular to the extended-defect direction, in the parallel direction the uctuations are stronger and therefore $_{jj}$ < $_{?}$ and thus, by Eq. (26) with z_{jj} , $z_{?}$ we obtain the con mation to our results. However, in the anisotropic case the coe cient c in Eq. (26) is also direction dependent. Thus the above argumentation is rather of qualitative nature to give a hint to physical interpretation of the observed relation z_{ij} < $z_{?}$.

In our previous papers [20, 21] we have also touched the question of existence of an upper marginal value for the defect dim ensionality "d. In our analysis, we observe the disappearance of a stable reachable FP for "d slightly above 1. The following physical interpretation was proposed: extended defects of large dim ension (e.g. parallel planar defects with $\mathbf{u}_d = 2$), m ay divide the system into non-interacting regions and thus inhibit ferrom agnetic order. Recently in Refs. [45] the Ising magnet with spin interaction bonds, correlated in 2 dimensions and random ly distributed in the perpendicular direction, was studied. A lthough such a system diers from those considered here, both models possesses a number of common features. In particular, the sm earing of a phase transition due to the presence of planar defects was predicted and explained by the existence - although rare - of in nite spatial regions, which are free of defects and therefore m ay be locally in the ordered phase.

To con m the obtained results, we have also tried to apply the Pade-Borel resum m ation to estimate the values for z_2 , z_{jj} . In this procedure, one rewrites the two-variable series (20), (21) in terms of a resolvent series [59] of one variable and then applies a Pade approximant for its analytic continuation. We do not present the results obtained, they give rather close numbers to those in Table III and reproduce the same behavior.

B. ";"d-expansion

A nother possibility to obtain estimates for dynamic critical exponents of the m-vectorm agnet with extended defects is to resum the double ";" $_{\rm d}$ expansions obtained in the two-loop approximation in Ref. [18]. Form < m $_{\rm c}$, the random FP R is stable and the expression for $z_{\rm c}$ and anisotropy function for m \in 1 read [18]:

W hereas for $m > m_{\text{c}}$, the pure FP P is stable. Therefore the critical behavior is isotropic and the dynam ic exponent z reads:

As it is known [60], due to degeneracy of the functions of the weakly diluted Ising model with point-like defects, the usual "-expansion for critical exponents turns into the $\overline{}$ -expansion. The same holds for the extended defects: indeed, the case m=1 is to be analyzed separately as far as expressions (27), (28) contain poles at m=1, and one arrives [18] at the $\overline{}$ -expansion for

the critical exponents. In particular, the corresponding expressions for z can be given only to the lowest non-trivial order. M oreover, the $\overline{}$ -expansion does not allow for a reliable numerical estimate [40]. Therefore, for the disordered Ising model, the xed dimension scheme considered in the subsection IV A remains the only way to get numerical estimates.

To get the num erical estim ate for m $_{\rm c}$ in the fram es of ";" $_{\rm d}$ -expansion we substitute into the modi ed H arris criterion the ve-loop " - expansion for the correlation length critical exponent $_{\rm p}$ for pure m -com ponent m odel, given in [61] and obtain the following expansion:

Putting here "=" (i.e $"_d=0$) one recovers the "-expansion for m_c of the model with point-like uncorrelated defects [13].

To estim ate m $_{\rm C}$ num erically for di erent xed values of d;"d, one should apply a resum m ation. As it is known [13,62] already simple Pade-analysis gives convergent results for m arginal dimensions. In the Pade analysis [63], it is known that the best convergence is achieved along the main diagonal of a Pade table, therefore we make use of the diagonal [2/2] Pade-approximant. In the three-dimensional case (" = 1) it gives: m $_{\rm C}$ (" $_{\rm d}$ = 0) = 1:92 (which is in a good agreement with the known six-loop results for the point-like disorder m $_{\rm C}$ = 1:942 0:026 [12] and m $_{\rm C}$ = 1:912 0:004 [13]), m $_{\rm C}$ (" $_{\rm d}$ = 0:1) = 2:48, m $_{\rm C}$ (" $_{\rm d}$ = 0:2) = 3:10, m $_{\rm C}$ (" $_{\rm d}$ = 0:3) = 3:77, m $_{\rm C}$ (" $_{\rm d}$ = 0:4) = 4:54. The results obtained are plotted by the dotted line in Fig. 1.

To estim ate dynam ical critical exponents in the FP R we applied the Chisholm Borel resummation technique to the functions (27), (28) treating them as series in two variables ";"_d and using the Chisholm approximant. In the corresponding two-loop approximation the dynamical critical exponents in the pure FP P is given by Eq. (29) and the expression is too short to be resummed. Therefore it has been estimated at " = 1 and dierentm by a direct substitution. The results are presented in Table IV. They qualitatively con m our conclusions made on the basis of xed dimension technique in subsection IV A (see Table III). The discrepancy between the data of the two techniques may serve also as an estimate for accuracy of the perturbation schemes applied.

Let us note, that currently the three-loop series for the exponent ${\bf z}$ of the pure ${\bf m}$ -vector ${\bf m}$ agnet ${\bf m}$ odel ${\bf A}$

dynam ics is available. The expression found in [64] reads:

Substituting into (31) the "-expansion for [61], one gets:

Numerical estimates of this series based on the Pade-Borel resummation are given in the Table I for m=1 and compared with values found by other approaches.

V. EFFECTIVE CRITICAL BEHAVIOR

The previous discussion concerns the asym ptotic critical dynam ics of the model (9). Here we discuss the elective critical behavior which is observed in approaching the critical point $T_{\rm c}$ [29]. This behavior is characterized by elective critical exponents governing scaling laws when $T_{\rm c}$ still is not reached. The calculation of elective critical exponents for models with extended in purities was not considered so far in dynamics as well as in the statics. However these exponents are mainly observed in numerical and real experiments, which may be outside the asymptotic region.

The e ective critical exponents are de ned as logarithmic derivatives of the appropriate quantities of interest with respect to the reduced temperature t=jT $T_cj=T_c$ [29]. For instance, e ective critical exponent for perpen-

dicular correlation length is de ned as:

In the limit T ! T_c the e ective exponent coincides with the asymptotic one $\frac{e}{2} = \frac{1}{2}$. Within the eld—theoretical RG approach e ective exponents are calculated using the values of couplings (solution of ow equation) depending on the ow parameter '. For instance, e ective exponents for correlation length and relaxation time perpendicular to the extended in purities direction are defined as:

The ow parameter 'is related to the temperature distance to the critical point via the inverse correlation length. Therefore the dependence of the elective exponents on the ow parameter corresponds to a dependence on the reduced temperature [65]. In (34) and (35) the parts denoted by dots come from the change of the amplitude part of the perpendicular correlation length and critical relaxation time correspondingly. In the subsequent calculations we will neglect this part, since the contribution of the amplitude function to the crossover seems to be small [66].

Solving the ow equation for dierent initial conditions we can obtain dierent ows in the space of couplings. We choose these condition near the Gaussian FP (G), expecting that couplings are small in the background region. In ow equations (10) we use the —function (20), (21) at xed dresum med by the Chisholm—Borelm ethod. This allow sus to investigate also the case of Ising systems (m = 1), for which the p—function are degenerated on the one-loop level and the $\overline{}^{\overline{}}$ -expansion does not allow for numerical estimates [40].




FIG. 2: Flows for the case m=1. D ashed lines correspond to the case of uncorrelated point defects, $\mathbf{u}_{\rm d}=0$, while solid lines correspond to system with extended lines of defects, $\mathbf{u}_{\rm d}=1$. The initial values are the same for curves 1 and $\mathbf{1}^0$ (sm all ratio =u) and for 2 and $\mathbf{2}^0$ (large ratio v=u).

The RG ows at m = 1 for the two most interesting cases " $_{\rm d}$ = 0 and " $_{\rm d}$ = 1 are shown in the Fig. 2 (dashed lines for " $_{\rm d}$ = 0 and solid lines for " $_{\rm d}$ = 1). The rst case corresponds to the point defects, whereas the second one corresponds to the lines of defects. We consider the same initial condition for both cases with a small (ows 1 and 1°) and with a large (ows 2 and 2°) value of the ratio v=u. The ratio v=u de nes the degree of disorder, thus

we can observe dierence in the behavior of systems with low and high dilution.




FIG. 3: Behavior of the dynam icale ective exponent z_1^e for m=1 in the case of $\mathbf{r}_d=0$ (dashed lines) and $\mathbf{r}_d=1$ (solid lines). Curves correspond to ows of Fig.2.




FIG. 4: Behavior of e ective critical exponent of perpendicular correlation length $\frac{e}{?}$ for m = 1 in the case of $\textbf{"}_d = 0$ (dashed lines) and $\textbf{"}_d = 1$ (solid lines). Curves correspond to ow s of Fig.2.

Using the ows given in the Fig. 2 we can obtain static and dynamic e ective exponents. Below, we choose to display the exponents $\frac{e}{2}$ and z_2^e . Due to Eq. (19) the parallel e ective exponents e e and ze have qualitatively sim ilar behavior. The deviations of e ective exponents from the mean-eld values z_2^e 2 and e corresponding to ows of Fig. 2 are given in the Fig. 3 and Fig. 4 respectively. First we compare the behavior of the e ective exponents of the uniaxial m = 1 m agnets at $"_d = 0$ and $"_d = 1$. As it can be seen from the Figs. 3 and 4, even a weak dilution by lines of defects leads to a faster crossover to the new universality class (curves 1 in Figs. 3 and 4) and the e ective exponents are not in uenced by the pure FP P. Such a behavior qualitatively diers from that at dilution by point-like im purities, where e ective exponents corresponding to the pure FP P are observed in a relatively wide region (curves 1 in both gures). Note that the dynamical critical exponent z_2^e at $"_d = 1$ approaches its asymptotics from above. Such a nonmonotonic behavior is typical in statics for system with point-like defects [1, 40]. However we do not observe nonmonotonic behavior for $\frac{e}{?}$. It may be a feature of static e ective critical exponents for system with extended in purities or consequence of our approximation.




FIG. 5: Behavior of dynam ical e ective exponent $z_{?}^{\rm e}$ for system with extended in purities with ${\rm u_d}=1$ and dierent m . Initial conditions are the same in all cases (sm all ratio v=u).




FIG.6: Behavior of e ective critical exponent of perpendicular correlation length $\frac{e}{2}$ for system with extended in purities with " $_{\rm d}=1$ and dierent m. Initial conditions are the same in all cases (small ratio v=u).

We also consider static and dynam ice ective behavior for dierent values of order parameter dimension. Fig. 5 and Fig. 6 present the $z_{?}^{\rm e} = 2$ and $\frac{\rm e}{?} = 1$ =2 correspondingly obtained for the same initial conditions and dierent values m = 1; 2; 3; 4. The nonmonotonic character of dependence of exponents on the logarithm of ow parameter is observed only for $z_{?}^{\rm e} = at$ m = 1.

VI. CONCLUSIONS

The present study is dedicated to providing the reliable num erical estimates for the dynamical critical exponents

of m agnetic systems with " $_{\rm d}$ -dimensional non-magnetic impurities of parallel orientation. The presence of such impurities leads to anisotropy in the systems; thus, two correlation lengths, parallel and perpendicular to the extended defects exist, which diverge in the vicinity of critical temperature with dierent exponents. The dynamic

critical behavior is modi ed as well, so that two times of critical relaxation in directions parallel and transverse to extended in purities appear. The former results obtained for such systems are based on the double expansion in parameters ";" $_{\rm d}$ and thus are rather of a qualitative character.

An example of related systems is given by magnets with extended random ly oriented defects: these can be described by the model of Weinrib and Halperin [23]. There, the distribution of defects is characterized by the pair correlation function, falling o with distance for large separations according to a power law. The in uence of such correlated defects on criticality was a subject of several theoretical studies [23, 24] and predicted new universal critical behavior found recently its con rm ation in the MC simulations [25].

We applied the resummation to the RG functions of the model, obtained in the minimal subtraction scheme [16, 18], treating them directly for xed d=3 and xed parameter $\textbf{"}_d$. The case $\textbf{"}_d=0$ describes point-like quenched disorder and reproduces well-known results. For $\textbf{"}_d>0$ it was found, that the relation $z_2>z_{jj}$ holds for every $\textbf{"}_d$ and m , which is connected to the fact, that the extended defects cut interacting paths of spins

perpendicular to the extended-defect direction, so in the parallel direction the uctuations are stronger.

The data of Tables I, IV give num erical values of the dynamical critical exponents for the model A dynamics of the m-vector magnets with extended "d-dimensional defects. Together with possible scenarios of the e ective critical behavior discussed in the Section V it should facilitate experim ental studies of the in uence of extended defects on criticality. As we already noted, the point defects change the universality class at d = 3 only for the Ising magnets (m = 1). Values of the critical exponent z of the pure and the diluted (by point-like im purities) Ising model are given in Tables II, III, respectively. Comparing the data in these tables one sees an increase of the exponent for the diluted model with respect to the pure one. This corresponds to a stronger divergency of the relaxation time (increase of the critical slowing-down e ects). Further, comparing Tables III and I one sees that extended im purities make this e ect m ore pronounced, leading to further increase of both exponents $z_?$; z_{ij} . However this increase (of the order of 8 % if one compares z-exponents for point and line defects) is not dram atic to make M C simulations impossible due to enhanced critical slowing down. On the other hand, the same order of dierence in critical exponents values holds also for the static exponents [20, 21]. Therefore, we expect that the predicted change in the critical behavior of three dim ensional magnets with extended impurities is within current experim ental accuracy. Although it is more dicult to extract dynamical critical exponents from simulations to the same accuracy, it would be worthwhile to look for them (i) in the cases of dierent defect dim ensionality and (ii) in the non-asym ptotic regim e.
