## D irect Observation of C ondon D om ains in Silver by H all P robes

U sing a set of m icro H all probes for the detection of the local induction, the inhom ogeneous C ondon dom ain structure has been directly observed at the surface of a pure silver single crystal under strong Landau quantization in magnetic elds up to 10 T. The inhom ogeneous induction occurs in the theoretically predicted part of the H T C ondon dom ain phase diagram. Inform ation about size, shape and orientation of the dom ains is obtained by analyzing H all probes placed along and across the long sam ple axis and by tilting the sam ple. On a beryllium surface the induction inhom ogeneity is alm ost absent although the expected induction splitting here is at least ten times higher than in silver.

Periodic form ation and disappearance of a phase with diam agnetic and param agnetic dom ainswaspredicted by Condon [1] to occur in a norm ally nonm agnetic m etal in strong m agnetic elds (H) at low tem peratures (T). The domains arise under the condition =  $_0$  @M = @B > 1, where M is the oscillating magnetization of the electrons due to Landau quantization and  $B = _0 (H + M)$  the total induction inside the sample. In this case  $_{0}$ @H = @B = 1 < 0 which implies therm odynamically unstable sections and the multivaluedness of the induction B (H ) within some part of each dHvA oscillation period [2, 3]. For a long rod-like sam ple oriented along H , the instability is avoided by a discontinuous jum  $P = B_2 = B_1$ between two stable values  $B_1$  and  $B_2$  at a given critical eld H<sub>c</sub>. For a plate-like sam ple perpendicular to H, the boundary condition  $B = {}_{0}H$  for a uniform ly magnetized state leads to dom ain form ation with alternating regions of diam agnetic and param agnetic m agnetization for H in the range  $B_1 < _0 H < B_2$  [1]. The proportion of the domains varies with H so that  $B = {}_0H$  is fulled as an average over the sample [3, 4]. The H B diagram is similar to the p V diagram of a van der W aals gas, only with more than one discontinuity interval B, situated periodically on the B axis.

The existence of dom ains has been rstly discovered by C ondon and W alstedt on a single crystal of silver [4]. The dom ains were revealed by a periodic splitting of the NM R line, corresponding to a local eld di erence of about 12 G between the param agnetic and diam agnetic regions in elds of about 9 T. This pioneering result remained the only reference work in the next decades. New experim ental possibilities appeared with the developm ent of m uon spin rotation. C ondon dom ains were observed in beryllium, white tin, alum inum, lead, and indium [5, 6]. By now, no doubt, C ondon dom ains are expected to appear in pure single crystals of all m etals. Therm odynam ic aspects of the C ondon dom ain phase transition have been recently treated theoretically [7]. W hile the state of art in this eld has been recently reviewed [8], som e important questions how ever, concerning dom ain size and topology, dom ain wall energy, and pinning properties can only be solved with a detailed know ledge of the dom ain structure.

The state with C ondon dom ains can be considered as physically similar to the interm ediate state of type I superconductors, where superconducting and normal regions form in an applied magnetic edd. Therefore, domain structures resulting of such dierent phenomena as superconductivity and dH vA e ect may be rather sim – ilar. Unfortunately, the magnetic contrast, that is the ratio of B to  $B_2$ , is not more than 0.1 % for C ondon domains (compared to 100% for the intermediate state). Besides, the magnetic edd itself is here hundred times higher. Thus, methods like magnetic decoration or magneto-optical detection used for intermediate state im aging [9] can not be used for C ondon domains.

In this Letter we present the rst experimental results for direct observation of C ondon domain structures in silver by a system of ten micro H all probes being close to the single crystal surface. In the hom ogeneous state, without domains, all probes show the same dH vA signalB (H), i. e. all  $B_i = B$  (H), where i = 1;2:::10 are the H all probe numbers. In the domain state, the H all voltages di er between the di erent probes in the param agnetic part of the dH vA period. This im plies an inhom ogeneous magnetic eld distribution due to C ondon domains at the sam ple surface. In our measurements the surface of the crystal was either norm alto H direction or slightly tilted (13). By com paring the data of neighboring H all probes, new inform ation about the domain structure has been extracted.




FIG.1: Experim ental con guration with the longitudinal (L) and transverse (T) arrays of H allprobes at distance b = 1 mm (s<sup>2</sup> = 10 10 m<sup>2</sup>; d = 40 m).

Fig.1 show sthe Hallprobe set-up made of a 1 m thick Si doped GaAs layer sandwiched between two 10 nm thick undoped GaAs layers. Two arrays of ve Hall probes (10 10 m $^2$  at 40 m distance) are placed at a distance of b = 1 m m . O ne array, L, is oriented along the long axis of the sam ple; the other, T, transverse to this axis. A DC Hall current of 100 A was applied in series to all ve Hallprobes of an array. The Hallvoltages were read out simultaneously by 5 K eithley multimeters; the arrays L and T were measured one after another. Due to the 3D conducting layer the  $V_i$  (B) characteristics of the Hallprobeswere in good approximation linear up to 10 T even at 1.3 K. The correct calibration of the Hallprobes was tested at tem peratures between 4.2-3.6 K where all Hall probes showed exactly the same dHvA oscillations of the hom ogenous silver sam ple. The detection lim it of the Hallprobes was smaller than 1 G.A high hom ogeneity (better than 10 ppm in 1 cm<sup>3</sup>) 10 T superconducting magnet was used to set a xed o set magnetic eld H $_0$ .




FIG. 2: B (H) trace for silver single crystal with H  $\,k$  [100] showing the splitting B of B $_1$  and B $_5$  of the L-array for three dH vA periods separated by dotted lines. The calibration of B is with respect to the o set eld  $_0$ H $_0$  = 10 T.

The slow ly varying superim posed eld H  $_{\rm V}$  ( 15 m T) was made by a watercooled resistive coil. Thus the total applied magnetic eld was H = H  $_0$  + H  $_{\rm V}$ .

The m easurem ents were performed on a high quality silver single crystal of  $2.4 \ 1.6 \ 1.0 \ mmmode mmm$ 

ighte ect (see references in [11]). The very good quality of the sam ple results in a very low D ingle tem perature, which was estimated from our measurements to be about  $T_D = 0.2 \text{ K}$ . The sam ple was annealed in  $O_2$  (10<sup>2</sup> Pa) at 750 C during 10 hours. It has a residual resistance ratio  $RRR = R_{300K} = R_{4:2K} = 1:6 \ 10^4$ , measured by the contactless Zemov-Sharvin method [12]. For a mirror-like surface, the crystal was slightly repolished by 0.1 m diam ond paste after annealing. The surface before polishing had a roughness of about 20-30 m and no induction splitting due to C ondon dom ains could be observed. The sam ple was glued by narrow strips of cigarette-paper to the set-up frame to x the crystal on the Hall probes in order to avoid dam age or strain of the single crystal upon cooling down. M oreover, the sam ple was slightly pressed by a cotton tampon to hold it reliably in high magnetic eld.




FIG. 3: Maximum induction di erence B as a function of temperature (a) and magnetic eld (b). Solid line in (a) is calculated from [13]. Inset shows the theoretical phase diagram [13] with dotted lines (a) and (b) indicating the two m easuring tracks.

Fig. 2 shows typical B (H) traces of Hall probes  $B_1$ and B<sub>5</sub> of the L-array over three dHvA periods at 10 T and 1.3 K. In each param agnetic part of the dHvA period two di erent inductions are measured at the surface of the sample whereas the induction is hom ogeneous in the diam agnetic part. The m easured traces are reversible for increasing and decreasing magnetic eld. W e ascribe the measured di erence between the induction of neighboring Hall probes to the existence of C ondon dom ains. The maximal induction splitting B in a dHvA period was measured as a function of tem perature at 10 T (see Fig. 3a) and as a function of eld at 1.3 K (see Fig. 3b). At 10 T, the phase boundary is crossed at about 3 K.At 1.3 K, the crossing occurs at about 5 T. The eld and tem perature range for the occurrence of the induction splitting is in agreem ent with the T-H phase diagram for the Condon dom ain state in Ag, as shown in the inset of Fig. 3a for the theoretically calculated phase-diagram of Agwith Dingle tem perature 0.2 K [13]. The solid line in Fig. 3a is the calculated induction splitting B [13] with the phase transition temperature (3 K) and the maximum splitting in silver (12 G) measured by Condon and W alstedt [4] as param eters.

A n anom alous alternating transition order of the H all probes between the diam agnetic and param agnetic phase is shown in F ig. 2. A lthough reproducible, the observed order depends strongly on the experimental conguration. A basically dienent behavior can be seen between the T-and L-probes in, respectively, F igs. 4 and 5. No regular transition order was observed for T-probes. Sometimes, they transit in ascending (1-5) or in descending order, as if the domain lam inae were slightly tilted to the long axis of the sample. Sometimes, as shown in

Fig. 4, a middle T-probe transits the last or the nst, as if the lam inae are bent. In contrast, the order of the L-probes is always 1,2,3,4,5 or reversed as it is shown in Fig. 5a. This implies that the domain structure is approximately lam inar with the lam inae mainly oriented transverse to the long axis of the sample. However, we found that the L-probe sequence changes alternately between dHvA periods which implies that the domain-wall m ovem ent changes direction along the long sample axis between successive dHvA periods.  $B = B_1 \quad B_5$ , shown in Fig. 5b, changes sign alternately during four or ve periods (see Fig. 6a). Then the, what we will call, "pendulum" e ect breaks down during two periods where the transition order is not clear. A fter this the pendulum e ect repeats.

On a slightly tilted sample the pendulum e ect disappears completely. Fig. 6 shows the change of the situation




FIG. 4: Example of successive transitions for ve T-probes between diam agnetic and param agnetic phase. The sweep rate was 0.5 m T/m in.




FIG.5: (a) Example of transitions for two dH vA periods for L-probes. The transition order is always either 1-3-4-5 or opposite.(b) shows the di erence B $_1$  B $_5$  vs H.




FIG. 6: (a) "Pendulum" e ect for sample surface oriented normal to H showing a regular change of sign in the di erence signal  $B = B_1$   $B_5$  during 4 or 5 periods. (b) Same dependence for the 13 tilted sample. In both the temperature was 1.3 K and the o set m agnetic eld was  $_0H_0 = 10T$ .

after tilting the sam ple. A fter rotation around the long sam ple axis by 13 dom ains draw up to a regular lam inar structure oriented always transverse to the long axis. A sim ilar behavior was observed in white tin in the interm ediate state [9, 10] indicating the preference of dom ain walls to align along the sam ple surface. Furtherm ore, the transition order is now the same for all dH vA periods (see Fig. 6b). The rotation of the silver single crystal with respect to the magnetic eld a ects the dH vA frequency spectrum . Only one dH vA frequency ("belly" [2]) rem ains for the 13 tilted sam ple. The beating pattern in the oscillatory dH vA signal of the magnetization for the perpendicular eld orientation m ight play a role in the occurrence of the pendulum e ect. In this respect we

note that the dHvA frequencies (belly orbit at 47300 T and rosette orbit at 19000 T) for the perpendicular eld orientation would be compatible with the observed pendulum e ect of Fig. 6a.

The transitions of the individual H all probes are very sharp compared to the whole eld range of the dom ain state in neighboring H all probes (see Fig. 4). This means that the thickness of the dom ain wall is much smaller than the period of the dom ain structure. We have never seen more than one transition of a H all probe in a period. This im plies that we saw always only one boundary between para- and diam agnetic phases in an array of 5 successive H all probes meaning that the period of the dom ain structure is certainly larger than the distance of

150 m between the edge L-probes. This under lim it for the domain period (p) should be compared with the value obtained from the square-root averaged expression  $p / \frac{1}{wt}$  for a sample with thickness (t) and domain wall thickness (w) [2]. W ith the proposed cyclotron radius for the wall thickness (1 m at 10 T in Ag), one obtains at least a 5 times smaller value ( 30 m) [4]. Therefore, from our experiments we nd a wall thickness of at least 20 m. This is in agreement with the observation that two neighboring middle L-probes at a distance of 40 m show often intermediate but dierent induction values. Therefore, the thickness of a domain wall can not be much smaller than 20 m. As the real domain pattern turns out to be somewhat bigger than expected, we need either a new set-up with better adapted H all-probe distances or a scanning H all probe form ore detailed measurements of the domain structure.

Exactly the same measurements as presented above were perform ed on a beryllium sam ple cut from the sam e single crystal where C ondon dom ain form ation was observed using muon spectroscopy [5]. The sample was prepared with a surface quality comparable to the Ag crystal. Even though the expected B inside the crystal is ten times higher than in silver, we did not nd B > 2 G on the sample surface. The attempt of Condon and W alstedt to nd dom ains in beryllium by NMR was not successful, either [4]. The authors gave explanations related to the quadrupole broadening and the long nuclear therm alization time in beryllium. However, now we believe that the main reason is the absence of induction splitting B at the sample surface. This could be an intrinsic property of beryllium related to its an isotropic magnetostriction [14].

In conclusion, C ondon dom ains in silver with induction splitting up to 10 G were observed by micro H all probes at elds and temperatures which are in agreement with the theoretically estimated phase diagram. A laminar dom ain structure was found with the orientation mainly transverse to the long sample axis. The dom ain transitions are always reversible for increasing and decreasing magnet eld. For a slightly tilted sample the strange pendulum e ect disappears, and the transitions occur in the sam e order for all dH vA periods. The dom ain period is not smaller than 150 m and the dom ain wall thickness m ust be about 20 m. C ondon dom ains in beryllium do not emerge to the surface.
