E ective spin-glass H am iltonian for the anom alous dynam ics of the H M F m odel

W e discuss an e ective spin-glass H am iltonian which can be used to study the glassy-like dynam ics observed in the m etastable states of the H am iltonian M ean Field (HMF) m odel. By m eans of the Replica form alism, we were able to nd a self-consistent equation for the glassy order parameter which reproduces, in a restricted energy region below the phase transition, the m icrocanonical simulations for the polarization order parameter recently introducted in the HMF m odel.

U nderstanding glassy dynam ics is one of the greatest challenges in theoretical physics. M any of the recent developm ents in this eld are based on the analysis of m ean-

eld models[1, 2]. The latter are de ned by Ham iltonians with long-range interactions and seem to capture m any properties of real systems. The rather accurate comparison to numerical simulations [3, 4] and experiments [5, 6, 7] supports the claim that the mechanism in these models is similar to the one responsible for the glass transition and the glassy dynamics in realmaterials.

In this paper we will consider the so-called H am iltonian Mean Field (HMF) model, a system of planar rotators originally introduced in Ref.[8]. This model has been intensively studied in the last years for its extrem e richness and exibility in exploring the connections between dynam ics and therm odynam ics in long-range m any-body system s. In fact, on one hand the model has an exact equilibrium solution, on the other hand, because of the presence of a kinetic energy term in the Hamiltonian, the dynam ics can be studied by means of molecular dynam ics simulations [8, 9, 10, 11]. From these investigations, many new interesting features have em erged which are common to other systems with long-range interactions [12, 13, 14]. One of the most intriguing characteristics of the dynam ics is the existence of quasi-stationary states (QSS), i.e. m etastable dynam ically-created states, whose lifetime diverges with the system size N [15]. In such states, that spontaneously appear in the num erical simulations when the system starts from strong o equilibrium initial conditions, many anom alies have been observed, such as anom alous di usion [10], non-G aussian velocity distributions [15], vanishing Lyapunov exponents [15], weak ergodicity breaking, hierarchical structures [16], slow-decaying correlations and aging [17, 18, 19, 20]. These features have suggested a possible application of T sallis generalized therm odynam ics [15, 21, 22, 23, 24] but also an interesting link with glassy dynam ics.

We have shown in previous papers that, in the QSS regime, the HMF system behaves very similary to a spin-glass system [16, 25, 26]. A ctually, by means of a new order parameter called polarization and inspired

by the Edwards-Anderson spin-glass order parameter [27, 28, 29, 30], it has been possible to characterize the dynam ically generated QSS as a sort of glassy phase of the HMF model, despite the fact that neither quenched disorder nor frustration are present in the interactions. In this paper, by means of a Replica-Symmetry analysis perform ed on an appropriate e ective Ham iltonian, we will show that it is possible to nd out a self-consistent equation for a spin-glass order parameter describing, in the therm odynam ic lim it, the quenched dynam ics observed in the QSS regime. We will also show that the solutions of this equation reproduce well the microcanonical simulations results for the polarization in the energy region where the dynam ical anom alies are more evident, thus strongly suggesting the identi cation of the two order parameters and con ming the interpretation of the lim iting QSS regime as a glassy phase.

I. SPIN-GLASSMODELS

In the last three decades spin-glasses have attracted the attention of experim entalists and theoreticians as glassy prototypical systems showing frustration and quenched disorder [31, 32, 33, 34, 35, 36]. Shortly, spin-glasses are system s with localized electronic magnetic moments whose interactions are characterized by quenched random ness: a given pair of spins have a roughly equal a priori probability of having a ferrom agnetic or an antiferrom agnetic interaction. The prototype material is a dilute m agnetic alloy, with a sm all am ount of m agnetic in purity random ly substituted into the lattice of a nonm agnetic m etallic host. In this situation, the impossibility to m in in ize simultaneously the interaction energies of all the couple of spins leads to a frustration which determ ines a very com plex energetic landscape in phase space. The latter appears as consisting of large valleys separated by high activation energies. Each valley contains many local minim a in which the system, at low temperature, can rem ain trapped for a very long time. This time grows exponentially with the height of the energy barriers, thus the system shows very slow relaxation, strong m em ory effects and aging.

Them odem theory of spin glasses [37] began in 1975 with the work of Edwards and Anderson (EA) [27], who proposed that the essential physics of spin glasses lays not in the details of their m icroscopic interactions but rather in the competition between quenched ferrom agnetic and antiferrom agnetic interactions (i.e. in the frustration). Thus they proposed a short range simplied model for spin-glasses, in which one represents the magnetic im purities with Ising spins $s_i = 1$ placed on the vertices of a three dimensional cubic lattice. The random nature of the interactions are m im icked with rst neighbors random interactions between the spins taken from a Gaussian probability distribution with zero mean and variance $J_{ij}^2 = J^2 = (2z)$ where z is the connectivity of the lattice. The Ham iltonian (in the absence of an external magnetic eld) is

where the vector S encodes the full set of spins in the sample $S = (s_1; s_2; :::; s_N)$ and hiji represents nearest neighbors on the lattice. Shortly after the appearance of the EA model, an in nite-ranged version was proposed by Sherrington and K inkpatrick (SK) [29, 30]. For a system of N Ising spins, and in zero external eld, the SK H am iltonian is

with a G aussian distribution of interactions. Notice that in Eq.2 the sum runs over all pair of spins and the factor 1= \overline{N} allows to consider the therm odynam ic lim it for the free energy and for other therm odynam ic quantities. In ref.[30] SK showed that their model has an equilibrium phase transition to a spin-glass phase below the temperature $T_c = 1$ and for an opportune choice of the parameters J_0 and J, respectively mean and standard deviation of the G aussian distribution of interactions. A mean eld theory, employing the Onsager reaction eld term, was proposed two years later by Thouless, Anderson, and Palmer [38], which indicated that there might be many low-temperature solutions corresponding to dif-

son, and Palmer [38], which indicated that there m ight be m any low tem perature solutions corresponding to different spin-glass phases. But the correct solution for the low tem perature phase of the SK m odel, due to Parisi [39], em ployed a novel ansatz and required severalm ore years before a physical interpretation could be worked out [40]. The picture that nally arose was that of a system w ith an extraordinary new kind of sym m etry breaking, known today as "Replica Sym m etry B reaking", or R SB, after the m athem atical procedures used to derive it. The essential idea is that the low tem perature phase consists not of a single spin-reversed pair of states, but rather of "in nitely m any pure therm odynam ic states" [40], not related by any sim ple sym m etry transform ation. W ithin the original m ean- eld fram ework of the SK model it is possible to observe three di erent phases, namely, paramagnetic (PA), ferromagnetic (FE) and spin glass (SG) phase, depending on the tem perature and the param eters of the Gaussian distribution of the interactions [28]. Each phase is characterized by a di erent m icroscopic behavior and a di erent kind of orientation order, giving rise to a characteristic value of the usualm ean eld order parameter, i.e. the magnetization m (I). Thus it is clear that the magnetization, calculated at one instant of time, vanishes in the SG phase just like in the PA one. Therefore, in order to discrim inate between spin glass disorder and param agnetism , one needs an additional order param eter. Such a param eter was originally proposed in refs. [27, 28]. It is called 'Edwards-Anderson (EA) order parameter' and takes into account the tem poralevolution of each spin. In this way the latter is able to measure the degree of freezing of the system and to distinguish between the PA phase, where it vanishes together with the magnetization, and the SG phase, where it remains nite. A ctually, in its original formulation, the EA order parameter results to be only an approximation (the so-called Replica Symmetry Approximation) of the true spin-glass order param eter proposed by Parisi [39], that has to be de ned in the 'replica space' and results to be a whole function (see also refs.[33, 35] for m ore details). However, we will show that also considering the approximated SK point of view it is possible to shed new light on the already suggested link between glassy dynam ics and the anom alous out-of-equilibrium behavior of the Quasi Stationary States of the HMF model.

II. DYNAM ICAL FRUSTRATION AND POLARIZATION IN THE HMF MODEL

The HMF model describes a system of N fully-coupled classical inertial XY spins with unitary module [8]

For a better visualization these spins can also be im agined as particles rotating on a unit circle. The equations of motion follow from the Ham iltonian

where $_{\rm i}$ (0 < $_{\rm i}$ 2) is the angle and ${\rm p}_{\rm i}$ the conjugate variable representing the rotational velocity of spin i. The equilibrium solution of the model in the canonical ensemble predicts a second order phase transition from a high temperature paramagnetic (PA) phase to a low temperature ferrom agnetic (FE) one [8, 9, 10, 11]. The critical temperature is $T_{\rm c}$ = 0.5 and corresponds to a critical energy per particle $U_{\rm c}$ = $E_{\rm c}$ =N = 0:75. The order param eter of this phase transition is the modulus of the average m agnetization per spin de ned as: M =




FIG.1: In this gure we plot - for N = 100000 - the molecular dynam ics num erical results corresponding to QSS (open squares), compared with both the canonical caloric curve, plotted as solid line, and the zero magnetization (or minimum temperature) line, reported as dot-dashed. The tem - perature is calculated by means of the average kinetic energy K, i.e. T = 2K = N. The QSS follows the latter line only up to U = 0.68, becoming unstable below this limiting value [20, 41].

 $\frac{1}{N}j_{i=1}^{F} \frac{1}{S_{i}}j_{i=1}^{T}$. Above T_{c} , in the PA phase, the spins point in di erent directions and M 0. Below T_{c} , in the FE phase, all the spins are aligned (the rotators are trapped in a single cluster) and M \in 0.

However, as already pointed out in the introduction, m olecular dynamics simulations, at xed energy and for out-of-equilibrium initial conditions, show the presence of long-living quasi-stationary states (QSS) in the subcritical energy density region 0.5 U U_c ([9, 15, 19]). In the thermodynamic limit – when they become estationary and reach a limiting tem perature value T_{QSS} (U) - the QSS can be usefully divided in two subset of states, depending on their magnetization:

-M = 0 QSS (for 0:68 U U_c), i.e. anomalous states living, for N ! 1, over the extension of the high tem perature branch of the caloric curve (see Fig.1) and showing a vanishing m agnetization (M = 0). It should be stressed that, because of the energy density-tem perature relationship ([8]) :

the zero magnetization constraint forces the system to follow the minimum kinetic energy (maximum potential energy) line, i.e. the minimum temperature line (dotdashed in Fig.1);

 $-M \neq 0$ QSS (for 0.5 U < 0.68), i.e. anomalous states with a macroscopic magnetization (M \neq 0), which for

N ! 1 tend to rejoin the canonical equilibrium curve. It has also been shown [20, 41] that the M = 0 QSS fam ily is unstable below the limiting energy density value U 0:68, corresponding to a temperature $T_{QSS} = 0.36$, around which the anom alies are more evident (this is also the reason why, historically, the QSS analysis focused on the value U = 0:69). Below such a value the QSS cannot follow the zero m agnetization (minimum temperature) line and the dynam ical anom alies start to decrease until they completely disappear below U = 0:5.

A ctually, it was just the vanishing magnetization of the M = 0 QSS and the discovery of aging [17] and of dynamical fluctuation [19], i.e. the formation of clusters of particles with power-law size distributions [16] that suggested the interpretation of such a regime in terms of a sort of spin-glass phase characterized by an EA-like order parameter [25].

D uring the Q SS regime, the mean-eld interaction seems s to be broken: in fact, the clusters that compete in trapping the particles on the unitary circle, generate a dynam ically frustrated scenario, in with each particle never fæls all the other particles, but only a restricted number of them. This feature seems to indicate, for nite sizes of the system, a corrugated potential landscape for the single particle. This e ect is very sensitive to the initial conditions [16]. In the therm odynam ic lim it (when the Q SS become stationary), the force between the particles - which depends on M - vanishes and the dynam ics is quenched (apart from the globalm otion in posed by the conservation of totalm om entum).

Therefore, inspired by the physical meaning of the EA order parameter, we proposed [25] a new order parameter for the HMF model, the so-called polarization, in order to measure the degree of freezing of the particles (rotators) in the QSS regime and, thus, to characterize in a quantitative way the emerging glassy-like dynamical fustration.

Polarization is de ned as the following spatial average

where

is the elementary polarization, de ned as the temporal average, integrated over an opportune time interval, of the successive positions of each rotator.

For the typical energy density value U = 0.69 (corresponding to a limiting temperature $T_{QSS} = 0.38$), we showed that, while the magnetization correctly vanishes in the therm odynamic limit, the polarization remains approximatively constant and di erent from zero, thus quantifying the freezing of the rotators in the QSS regime. On the other hand, as shown in ref. [25, 26], for $U > U_c$ the polarization coincides with the magnetization and goes to zero.

In other words, the polarization seems to play here the same role played by the Edwards-Anderson [29, 30] order parameter q_{EA} in the SK model, thus characterizing the anom alous QSS regime, which becomes stable in the therm odynamic limit, as a sort of Spin-glass phase for the HMF model.




FIG. 2: M icrocanonical simulations for the polarization, Eq.(6), performed in the QSS regime of the HMF model (open circles), are compared with the solution of the selfconsistent equation for the spin-glass order parameter q (full line) Eq.(30). Both these quantities are plotted versus the limiting temperature T_{QSS} . In the inset, a plot of the caloric curve and the QSS points for the HMF m odel is reported for comparison. The spin-glass phase region has been framed.

In Fig.2, extending the results reported in ref. [25, 26] for U = 0.69, we plot, as open circles, the values of the polarization order parameter for the range 0.68 < U < $U_{c}(U_{c} = 0.75)$, where the M = 0 Q SS fam ily result to be stable. These points, reported for convenience as a function of the corresponding N ! 1 limiting temperature T_{QSS} (0:36 < T_{QSS} < $T_c = 0:5$) were obtained by means of the usual microcanonical molecular dynamics simulations for N = 1000. The standard "water-bag" initial conditions with initial magnetization M = 1 (all the angles equal and velocities uniform ly distributed according to the available kinetic energy) were considered. As usual, the integration time (= 2000) has been chosen in order to stay inside the QSS plateaux for every N [16, 25, 26]. An average over 25 events was also perform ed. The error bars represent the uctuations of the elementary polarization over the con guration of the N rotators. A spreviously seen for U = 0.69 [16], increasing the size of the system the average polarization remains alm ost constant inside this error along the QSS plateaux. P lease note that for $0.3 < U < U_c$ the system is in the socalled translational regime and its center of mass drifts [8], i.e. the system is always moving with a global resulting motion that can be expressed by the phase of the average magnetization. Then, as done in the previous calculations [25, 26], in order to compute the elementary polarization, one has to subtract this phase from the spin angles. A s expected, the polarization correctly decreases approaching the phase transition, after which, in the hom ogeneous phase (not shown), it vanishes -together with the magnetization - in the therm odynam ic lim it.

In the following sections we give further support to the claim that the glassy-like behavior characterizing the QSS regime corresponds to a 2-vector SK Spin-G lass phase by means of a Replica M ethod form alism applied to an appropriately chosen H am iltonian.

III. THE REPLICA METHOD

Suppose [33] that we have a system characterized by an H am iltonian H_J [s] depending on the con guration [s] of the N spins and on some quenched variables J's changing on a time scale in nitely larger than the 's's. If we also suppose that these control variables are distributed according to a given probability distribution P [J], for each choice of the J's one can calculate the partition function

results to be a task not simple at all. Thus in refs [27, 28] the so called Replica M ethod was proposed. The latter is a trick to simplify the calculation of Eq.(10) and consists in computing the average of the free energy density by some analytic continuation procedure from the average of the partition function of n uncoupled replicas of the initial system [33]. In fact, using the identity

Now, denoting with a the replica index (a = 1; ::n; w ith integer n), we can write the partition function in Eq.(12) as the partition function of n non-interacting replicas of the same system (for the same set of J's)

where the trace T r in the last expression syntethizes the sum s over the spins in all the replicas. Further averaging this quantity over the distribution P [J], the calculation of the averaged free energy density follows straightforward from Eq.(13).

O ur idea is to describe the glassy dynam ics of the M = 0QSS regime of the HMF model by studying the equilibrium properties of an in nite range XY spin-glass e ective H am iltonian

with an opportune choice of the interactions J_{ij} . In Eq.(15) each spin (rotator) is de ned as $\overset{l}{s_i}$ = (cos $_i; sin _i)$, with 0 < $_i$ < 2 and unitary module, while the factor $\frac{1}{2}$ before the sum mation prevents from counting two times the same spin couples. The distribution of the quenched variables J_{ij} has to be chosen such that:

it must take into account the presence of the dynam ically created clusters of particles observed in the QSS regime, which in turn generate dynam ical frustration;

its rstmoment J should be equal to 1=N (being in the HMF model $J_{ij} = 1=N$ 8i; j); in such a way, for N ! 1, Eq.(15) will reduce to the potential term of the HMF model.

Thus, without loss of generality, we can choose a Gaussian distribution:

where the $\;$ rst two m om ents, the m ean J_{\circ} and the variance J^2 , will be set equal to 1=N .

Finally, the inverse temperature = 1=T will be xed by the kinetic term of the HMF model H am iltonian (being T = 2K = N), that we assume to be constant for the For xed J's we expect that the replica m ethod would enable us to nd out a self-consistent equation for the spinglass order parameter of the m odel (15). This equation w illbe obtained using the Replica-Symmetry (RS) ansatz in the context of a 2-vector in nite range spin-glassmodel [30], by imposing the spin-glass extrem alconstraints during the steepest descent procedure. Our nalgoalwillbe to compare such a theoretical prediction with the m olecular dynamics results for the polarization of Eq.(6), in a range of tem peratures corresponding with the N ! 1 limiting tem peratures (T_{QSS}) that characterize the hom ogeneous quasi-stationary states.

Let us start by applying the replica trick to the free energy calculation starting from the elective H am iltonian (15), with quenched couplings J_{ij} following the distribution (16).

U sing som e general properties of the characteristic function of a statistical distribution, and averaging Eq.(14) over the chosen distribution of the J_{ij} , we can write the free energy density expression (13) as a function of only the rst twom oments of the distribution itself

where a;b are replica indexes and i; j are spin indexes in each replica. Thus $s_i^{a} = (\cos_i^{a}; \sin_i^{a})$ represents the ith spin in the ath replica. As seen before, both the param eters J_o and J^2 , respectively m ean and variance of the J's distribution (16), have to be put equal to 1=N. Finally, the notation (i; j) in the sum is equivalent to a sum over all N (N 1)=2 distinct pairs of sites, thus the factor 1=2 disappears behind the sum over i; j.

Because of the latter notation, and after som e rearrangment, we can write the following equivalences

IV. SPIN-GLASS SELF-CONSISTENT EQUATION AND ITS NUMERICAL SOLUTION

At this point we have to impose the following spinglass constraints [30], based on the physical meaning of the two order parameters in the M = 0 QSS regime (that we are considering as an elective spin-glass phase of the HMF model):

1. the rst one refers to the m agnetization, that is
null in the M = 0 Q SS regime, thus im plying

2. the second one refers to the spin-glass order param – eter, which of course does not vanish in the spinglass phase thus quantifying the degree of freezing of the rotators in the M = 0 QSS regime; as usual in standard replica m ethod for glassy systems, it is chosen as proportional to the m odule of the overlap between two di erent replicas at a single site

where the \mathbf{j}^{ab} jare considered equals 8a; b (Replica-Symmetry approximation). The phase of \mathbf{b}^{ab} , being arbitrary, can be set to zero for convenience so that its direction is u_x . Finally, we set also jt ab j= 0.

By incorporating the spin-glass constraints with delta functions one can easily perform the integral in Eq.(23), thus obtaining

Solving num erically this equation, we can imm ediately calculate the expected value of the spin-glass order parameter q as a function of the temperature T =and compare it with the polarization order parameter p of the HMF model. In particular, since we have to consider M = 0 QSS w ith null magnetization, we consider the lim iting tem perature T_{OSS} (i.e. the tem perature for ! 1) and, by varying it in Eq.(30), we obtain Ν the theoretical curve shown in Fig.2 (full line). This curve is compared with the molecular dynamics simulations for the polarization (open circles) performed in the QSS regime of the HMF model for N = 1000 and for di erent tem peratures in the subcritical region. Som e corresponding energy density values are also reported for convenience. A spreviously stressed, these results are independent on N within the error bars [16] and this allow us to extrapolate them to the therm odynam ic lim it.

The theoretical curve predicts, as expected, a phase transition at $T_c = 1=2$ and superim poses on the values of the polarization obtained in the range $0.36 < T_{0SS} < 0.45$, that corresponds (being there $M_{OSS} = 0$) to the energy density range 0:68 < U < 0:72 through the zero m agnetization (m in im um tem perature) line equation $U = \frac{T}{2} + \frac{1}{2}$, see Eq.(5). The simulations points start to disagree with the results of the theoretical curve around $T_{OSS} = 0.45$, ie. for U > 0.72: above these values the QSS points are very close to the correspondent equilibrium temperature values on the caloric curve (as visible in the inset of Fig 2) and the glassy features of the QSS regime tend to disappear. Inverting the previous argum ent, we could also suggest that such a theoretical result allows us to better specify the range of energy densities where the QSS regime can be considered as a spin-glass phase for the HMF model.

V. CONCLUSIONS

W e have discussed the glassy phase of the HMF m odel by means of an e ective spin-glass Ham iltonian and shown that the corresponding order parameter coincides with the polarization in the energy range where HMF exhibits strong dynam ical anom alies and glassy dynam ics. Being a long-range Ham iltonian solvable m odel and showing the existence of a glassy-like relaxation dynam ics along quasi-stationary trajectories, the HMF m odel poses new challenging questions on the origin of its glassy unexpected behavior. In these respects, the m odel m ay be a very useful "laboratory" for studying general trends that can be later tested num erically and experim entally in m ore realistic system s and realm aterials.

These analytical results, obtained within the Replica-Symmetry SK framework and in the thermodynamic lim it, seem to give further support to the interpretation of the QSS regime as a real spin-glass phase. This is true at least in the lim iting temperature region where the glassy features are more evident. In this region the elementary polarization seem s to play the role of the EA order parameter in giving a measure of the num erically observed quenched dynamics.

In conclusion, we do hope that this connection between the HMF m odel and Spin-glass system s could bring new insight on the several comm on features.
