Spin transverse force on spin current in an electric eld

As a relativistic quantum mechanicale ect, it is shown that the electric eld exerting a transverse force on an electron spin 1/2 only if the electron is moving. The spin force, analogue to the Lorentz for on an electron charge in a magnetic eld, is perpendicular to the electric eld and the spin current which spin polarization is projected among the electric eld. This spin-dependent force can be used to understand the zitterbewegung of electron wave packet with spin-orbit coupling and is relevant to the generation of the charge Halle ect driven by the spin current in semiconductors.

Recent years spintronics has became an emerging eld because of its potential application to sem iconductor industry, and more and more attentions are focused on the e ect of spin-orbit coupling in metals and sem iconductors.[1] The spin-orbit coupling is a relativistic e ect describing the interaction of the electron spin, m om entum and electric eld, and provides a route to manipulate and to control the quantum spin states via external elds. [2, 3] It is desirable to understand the motion of electron spin with spin-orbit coupling in an electrom agnetic eld. In electrodynam ics it is known that a magnetic eld would exert a Lorentz force on an electric charge if it is moving. This Lorentz force can generate a lot of fundam ental phenom ena such as the Halle ect in solid.[4] The interaction of the spin in the electrom agnetic eld behaves as if the spin is a gauge charge and the interaction is due to the SU (2) gauge eld.[5] It is essential that the electron spin is an intrinsic quantum variable, not a just classical tiny m agnetic m om ent. The physical meaning of the interaction is closely associated to the Aharonov-Cashere ect and the Berry phase.

In this paper it is found that an electric eld exerts a transverse force on an electron spin if it is moving and the spin is projected along the electric eld. The force is proportional to the square of electric eld, and the spin current projected along the eld, and its direction is always perpendicular to the electric eld and the speed of the spin. The force stems from the spin-orbital coupling which can be derived from the Dirac equation for an electron in a potential in the non-relativistic lim it or the K ane model with the k p coupling between the conduction band and valence band. From an exact solution of a single electron with the spin-orbit coupling it is heuristic to understand that the zitterbewegung of electronic wave packet is driven by the spin transverse force on a moving spin. The role of spin transverse force is also discussed in the spin Halle ect and its reciprocale ect driven by the pure spin current in sem iconductors.

We start with the Dirac equation of an electron in a conning potential V and a vector potential A for a mag-

netic eld, B = r A,

where $_{\rm B}$ = e~=2m c and $V_{\rm eff}$ = V + $\frac{^{^{2}}}{8m^{^{2}}c^{^{2}}}r^{^{2}}V$: In the last step we neglect the higher order terms of expansion. Thus the Dirac equation is reduced to the Schrodinger equation with the spin-orbit coupling. The same form of elective spin-orbit coupling and Zeem an splitting can be also derived from the 8 8 K ane model that takes into account only the k p coupling between the $^{\rm C}_{6}$ conduction band and the $^{\rm V}_{8}$ and $^{\rm V}_{7}$ valence bands, although the elective mass, the elective Landeg-factor, and the elective coupling coelients have to be introduced as material-special caparameters such as means and the second of the color of the special caparameters and the second of the same such as means and the special caparameters and the same such as means and the same suc

In the Heisenberg picture the kinetic velocity is

where $A = \frac{\tilde{a}_{m \text{ ce}}}{4m \text{ ce}}$ r V and comes from the spin-orbit coupling. It indicates clearly that A plays a role of a SU (2) gauge vector potential. The spin dependence of the gauge eld can separates the charged carriers with dierent spins in cyclotron motion experimentally.[7]

Even though we have [p;p]=0 for canonical momentum, the analogous commutators do not vanish for the kinetic velocity

where the total magnetic eld B = B + r A; and r A = \sim (r^2V) (r)rV = (4m ce): Notice that [A; A] = $2\sim^2i$ (rV) @ V = (4m ce)^2: We can derive the quantum mechanical version of the force,

This is the quantum mechanical analogue of Newton's second law. Of course we should notice that this is just an operator equation. The uncertainty relationship tells that the position and m om entum cannot be m easured simultaneously, and there is no concept of force in quantum m echanics. To see the physical meaning of the equation, we take the expectation values of both sides with respect to a Heisenberg state jiwhich does not varies with time. The expectation values of the observable describe the motion of the center of the wave package of electrons. In this sense we have an equation of the force experienced by the m oving electron. Actually the rst term F_h in Eq. (5) is the Lorentz force for a charged particle in a magnetic eld hBiwhich contains the contribution from the SU (2) gauge eld A as well as the conventional electrom agnetic eld. We have recovered the Ehrenfest theorem as one of the examples of the corresponding principle in quantum mechanics. The term, hr ($_{\rm R}$ B)i; results from the non-uniform magnetic eld. Its role was rst realized in the Stem-Gerlach experiment, where a shaped magnet is used to generate a non-uniform magnetic eld to split the beam of silver atom s. In the classical lim it it is written as the interaction between the magnetic momenh B i and magnetic eld. This spin force depends on the spin. Recently it is proposed that the force can generate a pure spin current if we assum e r B $_{
m z}$ is a constant.[8] In the term F_q we can also use to replace the spin. It is non-zero only when the electric and magnetic elds coexist, as suggested by Anandan and others.[5] This term will play an essential role in generating spin Hall current in two-dim ensional Rashba system, which we will discuss it later.

The last term , $F_{\rm f}$, com es from the SU (2) gauge potential or spin-orbital coupling. As the force is related

to the P lanck constant it has no counterpart in classic mechanics and is purely quantum mechanic e ect. The force is irrelevant of the magnetic eld. In the classical lim it we cannot simply use the magnetic momentum to replace the spin in the potential A. O therwise the force vanishes. To see the physical meaning of the force, we write the spin force for a single electron on a quantum state in a compact form,

where the spin current is de ned conventionally, $\frac{\mathcal{E}}{s} = \frac{\tilde{a}}{4} \, \text{hfv}$; $E = \frac{\tilde{b}}{2} \, \text{igi}$; and in the last step the relation fA; E = 0 has been used. This is the main result in this paper. The force is proportional to the square of electric eld E and the spin current which polarization is projected along the eld. It is important to note that an electron in a spin state perpendicular to the electric eld will not experience any force. Comparing with a charged particle in a magnetic eld, $\frac{1}{b}$. B; where $\frac{1}{b}$ is a charge current density, the spin force is nonlinear to the electric eld and depends on the spin state of electron.

We discuss several examples relevant to the spin force. Though the gauge eld A provides a spin-dependent magnetic eld r A, the Lorentz force caused by the eld on the charge will vanish in a uniform electric eld r V = eE: The spin depend force F_g also vanishes in the absence of magnetic eld. Here we consider the motion of an electron con ning in a two-dimensional plane subjected to a perpendicular electric eld,

where = \sim eE=(4m²c²) from Eq.(2). This can be regarded as counterpart of a charged particle in a magnetic eld. On the other hand it has the same form of the Rashba coupling in a semiconductor heterojuction with the structural inversion asymmetry,[9] where the spin-orbit coupling is induced by the o sets of valence bands at the interfaces and the structure inversion asymmetry.[6] A typical value of this coe cient is of order 10 4 c (c the speed of light), and can be adjusted by an external eld.[10] Because of the spin-orbit coupling the electron spin will precess with time,

Since the momentum p is a good quantum number, without loss of generality, we take $p=p_x$; just along the x direction. Correspondingly the wave function in the position space hrj $i=\exp(ip_xx)_s=L$ where $_s$ is the initial spin state. Equivalently the spin-orbit coupling provides an elective magnetic eld along the y direction, $B_{\rm eff}=p_x\hat{y}$. This problem can be solved analytically, and the electron spin precesses in the spin

A sa result the spin transverse force on the spin is always perpendicular to the x direction. Correspondingly the kinetic velocity v_{x} and v_{y} at a time t are

respectively. Though $p_y=0$ the kinetic velocity $hv_y\,i_t$ oscillates with the frequency ! _c while $hv_x\,i_t$ remains constant. The y-component of the position is

If the initial state is polarized along y direction the electron spin does not vary with time as it is an energy eigen state of the system, as discussed by D atta and D as.[2] In this case the spin current hfi carried by the electron is always zero and the spin transverse force is zero. Thus $hv_vi_+ = 0$: If the initial state is along the spin z direction at t = 0, i.e., $h_z i = s = 1$; it is found that $hv_y i_{t:s} = s \sin t_c t$: Dierent spins will move in opposite directions. It can be understood that the spin precession makes the spin current which polarization is projected along the electric eld changes with time such that the spin force along the y direction also oscillates with the frequency $!_c$. This force will generate a nonzero velocity of electron oscillating along the y direction. The amplitude of the oscillation is $\sim=p_x$ and the frequency is $!_c = 2p_x =\sim:$ For a typical two dimensional electron gas the electron density is 10^{12} =cm² and the wave length near the $n_e = 10^{11}$ Ferm i surface $\sim = p_x$ 3 10nm. For a typical Rashba coupling = 10^{4} c, $!_{c} = 0.3$ 1.0 10^{14} s: The rapid oscillation of the electron wave packet is known in literatures as the zitterbewegung of electron as a relativistic e ect, which is usually regarded as a result of admixture of the positron state in electron wave packet as a relativistic e ect.[12] In sem iconductors the Rashba coupling re ects the admixture of the particle and hole states in the conduction and valence bands. Recently Schliem ann et al obtained the solution of the trajectory and proposed that this e ect can be observed in a III-V zincblende sem iconductor quantum wells.[13] In the p-doped sem iconductors described by the Luttinger model there exists also a spin force, and will generate the zitterbewegung as calculated by Jiang et al.[14] Though the spin




FIG. 1: The electric eld exerts opposite forces on electrons with di erent spins polarized along the eld.

transverse force on a moving spin is very analogous to the Lorentz force on a moving charge, because of spin precession, itseect is completely dierent with the motion of a charged particle in a magnetic eld, where the amplitude of the Lorentz force is constant and the charged particle will move in a circle. The zitterbewegung of the electronic wave package near the boundary will cause some edge e ect as shown in recent numerical calculations.[15] The edge e ect is determined by the electron momentum. The smaller the momentum, the larger the edge e ect. The amplitude and frequency of the zitterbewegung satisfy a relation that $(\sim=2p_{\rm x})$ $(2p_{\rm x}=\sim)=$, which is the amplitude of oscillation of the velocity $v_{\rm y}$. In Fig.1 it is illustrated that for two electrons with dierent spins experience opposite forces in an electric eld.

Furtherm ore we consider a two-dimensional electron gas lacking both the bulk and structural inversion symmetries. A D resselhaus term $(p_{x-x}-p_{y-y})$ will be included in the total H am iltonian in Eq. (8).[16] In this model the spin force formula gives[17]

for each moving electron. First of all the force disappears at the sym m etric point of = :At this point the operator x v is a good quantum number an there is no spin ip in the system . For € ; the moving electron will experience a spin-dependent force and the force will change its sign near = . A heuristic picture from this form ula is that when a non-zero spin current j^z goes through this system the spin-orbit coupling exerts the spin transverse force on the spin current, and drives electrons to form a charge Hall current perpendicular to the spin current. The injected spin current can be generated in various ways, such as by the spin force r (and circularly or linearly polarized light in jection. [18, 19] For instance we assume the spin current j_s^z be generated by the linear polarized light in jection which is proportional to the transition rate of from the valence band to the conduction band with nite momentum and the life time of electrons at the excited states. In the relaxation approximation in a steady state the drift velocity

orthogonal to the spin current is hv_y i = $\frac{4m}{c^2}$ (2 2) j_s^z if is not so long, i.e. $2p_x$ 2 + 2 << ~: This nonzero drift velocity will form a Hall current orthogonal to the the spin current. This is the charge Halle ect driven by the spin current. In ferrom agnetic metal or diluted magnetic semiconductors the charge current is spin polarized it can generate the spin polarized Hall current via the spin transverse force. Thus the spin transverse force can be also regarded a driven force of an anomalous Halle ect[20] and the spin-resolved Hall e ect.[17,21] A detailed calculation for this Hall conductance is given by the Kubo formula as a linear response to the eld $B = B \times 2$. This eld will generate a spin $= g_B B z\hat{x}; w hich w ill circulate$ force, r (g B B a spin current along the x direction, and furtherm ore the spin-orbit coupling provides a driving force to generate a transverse charge current, $j_{c;v}$. In the clear \lim it the Hall conductance $xy = j_{Cy} = (g_B B) = 0$ for = and $(e=4)(^2)^2 = ^2$. How ever following Inoue et al and M ishchenko et al[22] the inclusion of impurities scattering will suppress the Hall conductance completely just like the spin Halle ect. On the other hand num ericalcalculation in mesoscopic systems shows the existence of the e ect. [19] A nother example is the two-dimensional p-doped system with the cubic Rashba coupling, [23]

where are spin increasing and decreasing operators, and $p = p_x$ ipy. The spin force on the moving electron in this system is $F_f = (2m \ p = \sim)^2 \left(\frac{T}{k} - 2\right)$: The linear response theory gives the Hall conductance $9e=(2 \sim)$ which is robust against the vertex correction from in-purities scattering. Calculations by means of the Green-Keldysh function technique and linear response theory [8,19] show the existence of charge Halle ect driven by the spin current, and the Onsager relation between the charge Halle ect and its reciprocal. The key features of the numerical results are in good agreement with the picture of spin force qualitatively.

In conclusion, an electric eld exerts a transverse force on a moving spin just like a magnetic eld exerts a Lorentz force on a moving charge. This force is proportional to the square of electric eld and the spin current with spin projected along the eld. This is a purely relativistic quantum mechanicale ect. As the origin of the force the spin current should be also observable physically. From the solution of the motion of a single electron in an electric eld, the zitterbew egung of electronic wave packet in the spin-orbit coupling can be regarded as an explicit consequence of this force. Due to the similarity of this spin transverse force and the Lorentz force, the spin transverse force plays a similar role in the form ation

of the charge Halle ect driven by the spin current and the spin Halle ect driven by the charge current as the Lorentz force does in the Halle ect in a magnetic eld.
