Universal properties of three-dim ensional magnetohydrodynam ic turbulence: D o Alfven waves matter?

Abstract

W e analyse the e ects of the propagating A liven waves, arising due to non-zero mean magnetic elds, on the nonequilibrium steady states of three-dimensional (3d) how ogeneous M agnetohydrodynamic (MHD) turbulence. In particular, the elects of A liven waves on the universal properties of 3dM HD turbulence are studied in a one-loop self-consistent mode-coupling approach. We calculate the kinetic- and magnetic energy-spectra. We nd that even in the presence of a mean magnetic eld the energy spectra are K olm ogorov-like, i.e., scale as k⁵⁼³ in the inertial range where k is a Fourier wavevector belonging to the inertial range. We also elucidate the multiscaling of the structure functions in a log-norm alm odel by evaluating the relevant intermittency exponents, and our results suggest that the multiscaling deviations from the simple K olm ogorov scaling of the structure functions decrease with increasing strength of the mean magnetic eld. Our results com pare favourably with many existing numerical and observational results.

I. IN TRODUCTION

The e ects of propagating waves on the statistical properties of system s out of equilibrium remain an important topic of discussion. In the context of a coupled spin model in one-dimension (d = 1) [1] it has been shown that the presence of such waves leads to weak dynam ic scaling in that model. In contrast, in a coupled Burgers-like model in d = 1 propagating waves do not a ect the scaling properties of the correlation functions at all [2]. So far such issues have been considered only within very simplied one-dimensional nonequilibrium models [2, 3]. Magnetohydrodynamic (3dM HD) turbulence, which is a hydrodynamic description of the coupled evolution of the velocity elds u and the magnetic elds b in a quasi-neutralplasm a, stands as a very good candidate for a natural system with propagating waves in three dimensions as most of its natural realizations have proagating A liven waves arising due to the presence of mean magnetic elds. Examples of such physical situations include solar wind, neutral plasm a in fusion con nem ent devices etc. The presence of the propagating A liven modes, in addition to the usual dissipative modes due to the uid and m agnetic viscosities m akes M HD turbulence a good natural example to study the interplay between the propagating and the dissipative modes in a system and their combined e ects on the scaling properties of the correlation and structure functions, which are important issues from the point of view of nonequilibrium statistical mechanics.

The scaling of magnetic- $\mathbb{E}_{b}(k)$] and kinetic- $\mathbb{E}_{u}(k)$] energy spectra in the inertial range (i.e., wavevector k lies in the region L¹ k $_{D}^{-1}$, L and $_{D}$ being the integral scale given by the system size and the dissipation scale, respectively) in 3dM HD in the presence of A liven waves originating due to a mean magnetic eld B₀ remains controversial till the date. Numerical simulations, due to the lack of su cient resolutions failed to conclusively distinguish between the Kolm ogorov's and Kraichnan's predictions (see below). In this communication, within one-loop self-consistent mode-coupling (SCM C) approximations, we obtain the following results for hom ogeneous but anisotropic (due to the mean magnetic eld) 3dM HD :

The bare A lfven wave speed, proportional to B, renorm alizes to acquire a singular k-dependence to become B_ok ¹⁼³ where k is a Fourier wavevector belonging to the inertial (scaling) range. From this result we are able to conclude that even in the presence of a mean magnetic eld the kinetic- and the magnetic-energy spectra scale

as k $^{5=3}$ in the inertial range, identical with the situation without any mean magnetic eld.

The dimensionless K olm ogorov's constants for the kinetic-and magnetic-energy spectra depends on a dimensionless parameter which we identify as the ratio of the renormalised A lfven wave speed and the renormalised viscosities (see below).

The interm ittency exponents of the E lsasser elds z = u b which approximately and qualitatively characterise the multiscaling properties of the structure functions in a log-norm alm odel depend on the parameter and decrease with increasing .

Thus our results show that A liven waves in 3dM HD do not a ect the scaling properties of the two-point correlation functions. However, the multiscaling properties of the structure functions are shown to be a ected by the mean magnetic elds.

The fam ous K olm ogorov's arguments [4] for uid turbulence can be easily extended to 3dM HD turbulence. In M HD, in the unit where mass density = 1, the kinetic energy dissipation rate per unit mass ($_{\rm K}$) and the magnetic energy dissipation rate per unit mass ($_{\rm M}$) have same physical dimensions. Thus, as in uid turbulence, by claiming that the structure functions of the velocity and magnetic eld di erences in the inertial range must be constructed out of the mean energy dissipation rate per unit mass and the local length scale r (belonging to the inertial range) one obtains for the n-th order structure function [5, 6]

where $=_{K}$ or $_{M}$ and a = u; b for the velocity and the magnetic elds, $_{D}$ is the (sm all) dissipation scale and L is the (large) system size. This yields, for the energy spectra in the inertial range (as a function of wavevector k)

This is known as the K 41 theory in the relevant literature. However, in the presence of a mean magnetic eld B_o, the A liven waves are generated (see below) with the propagation speed B_o. Thus in such a case in addition to the usual K olm ogorov time scale $k^{2=3}$ [7, 8], there exists another time scale constructed out of the mean magnetic eld B_o, known as the K raichnan time scale (B_ok)¹ [9]. K raichnan argued that this time scale would determ ine

the energy cascade process and hence would enter in the expression of the structure function $k^{3=2}$; a = u;b. There has not been any satisfactory resolution of this issue yielding E_a (k) till this date; due to the particularly di cult vectorial nature of the 3dM HD equations (see below) it is rather di cult to achieve high Reynolds num ber in Direct Num erical Solutions (DNS) of the 3dM HD equations. Num erical solutions of an MHD shellm odel in the presence of a sm all mean magnetic eld-like term did not nd any dependence of the multiscaling of the structure functions on the mean magnetic eld [6]. A nalytically, it has been shown within the context of a 1d coupled Burgers-like m odel [2] that the energy spectra are independent of a mean magnetic eld and in case of 1d M HD turbulence it exhibits the Kolm ogorov scaling for the energy spectra. Sim ilar conclusions followed from an analogous one-dimensional m odel [3]. Various phenom enological approaches, including weak turbulence theories and three-wave interaction models, yield, in general, mean magnetic eld dependences of the energy spectra [10, 11, 12, 13] when the mean magnetic eld is strong. However, these theories, despite their predictions are either not directly derivable from the underlying 3dM HD Eqs. of motion or involve additional assumptions on the ow elds. A nalyses starting from the 3dM HD Eqs. in this regard are still lacking. M ost observational results on astrophysical system seem to favour the K 41 results [14]. Simulations of incompressible M HD [15] nd results close to the K 41 result. Simulations of compressible M HD [16], even though in some cases nd energy spectra closer to K 41, in general yields a less clear picture. Recent num erical results of M uller et al [17] suggest that in presence of nite m agnetic helicity structure functions parallel and perpendicular to the mean magnetic elds are a ected di erently by the mean magnetic eld. In this paper, we address some of these issues by starting from the 3dM HD Eqs. without making any further assumptions on the velocity and the magnetic elds, except for the validity of the perturbative approaches. In particular, we show by applying one-bop m ode coupling m ethods on the 3dM HD equations with a m ean m agnetic eld and in the absence of any magnetic helicity that the one-dimensional energy spectra in 3dM HD turbulence are independent of the mean magnetic eld B $_{\circ}$ and scale as k $^{5=3}$ in the inertial range where k is a Fourier wavevector belonging to the inertial range. We then proceed to calculate the Kolm opprov's constants for the kinetic- and the magnetic-energy spectra and show that they depend on B_o. Lastly, we calculate the interm ittency exponents for the velocity and the magnetic elds and nd that they decrease with increasing B_{o} . We do not distinguish between the longitudinal and the transverse structure functions. Even

though for analytical convenience we assume a weak mean magnetic eld, we are able to obtain new and interesting results concerning scaling and multiscaling in 3dM HD in the presence of a mean magnetic eld of small magnitude. In this respect our results can be considered as complementary to some of the existing results [10, 11, 13]. The rest of the paper is organized as follows: In Sec.II we discuss the 3dM HD equations for incompressible uids. In Sec.V we show that for incompressible uids the bare Alfven wave speed Bo renormalizes to pick a correction k $^{1=3}$ in the inertial range. This, as we argue, implies that the energy spectra scale as k $^{5=3}$ in the inertial range even in the presence of a mean magnetic eld. In Sec.VI we calculate the Kolm opporov's constants for the kinetic and the magnetic energy spectra. We introduce a parameter which is the dimensionless ratio of the renorm alised m ean m agnetic eld and renorm alised viscosities and show that the K olm opprov's constants depend on . In Sec.V II we elucidate the multiscaling properties of the structure functions by calculating the interm ittency exponents and show that they decrease with increasing , i.e., with increasing B_{o} . This suggests that a mean magnetic eld tends to reduce multiscaling corrections to the K 41 results for the structure functions. In Sec.V III we sum marize our results.

II. MODEL EQUATIONS

We begin by writing down the 3dM HD equations for the velocity elds u and the magnetic elds b: The velocity eld u is governed by the Navier-Stokes equation modied by the inclusion of the Lorentz force [18]

and the dynamics of the magnetic eld b is governed by the Induction equation [18] constructed out of the 0 hm 's law for a moving fram e and the Ampere's law:

Here, is the mass density, p is the pressure, is the uid viscosity and is the magnetic viscosity (inversely proportional to the electrical conductivity of the uid medium concerned). Functions f and g are external forces needed to maintain a statistical steady state. In the present approach these are taken to be stochastic forces. We assume them to be zero-mean and G aussian distributed with speci ed variances (see below). In addition to Eqs. (3) and (4) we also have r b = 0 (M axwell's equation) and, for incompressible uids r u = 0.

If the magnetic elds b(x;t) are such that $hbi = B_o$ (a constant vector) then replacing $b by b + B_o$ where now hbi = 0, in Eqs. (3) and (4) one obtains additional linear terms proportional to wavevector k leading to wave-like excitations, known as A liven waves. The resulting equations are

with hb (x;t)i = 0. The parameters 1; 2; 3 are kept for book keeping purposes and can be set to unity (see Sec.IV). Note that on dropping the nonlinear and the dissipative term s from Eqs. (5) and (6) the resulting linear coupled partial di erential equations adm it wavelike solutions with dispersion relation linear in wavevector k. These are known as the A lfven waves [19] in the literature which propagate with speed proportional to B_o . In the following sections we would calculate the kinetic and the magnetic energy spectra, the K olm ogorov's constants and the intermittency exponents in the presence of the A lfven waves, i.e., for $B_o \notin 0$.

III. CORRELATION AND STRUCTURE FUNCTIONS IN MHD

In the statistical steady state the time dependent correlation functions of u and b exhibit scaling which are characterized by the roughness exponents $_{u}$ and $_{b}$ respectively, and the dynamic exponent z. In terms of the scaling exponents $_{u}$; $_{b}$ and z the velocity and the magnetic eld correlators have the form (as a function of wavevector k and frequency !)

where f_u and f_b are scaling functions, P_{ij} is the transverse projection operator: $P_{ij} = _{ij} k_i k_j = k^2$ to account for the incom pressibility of the elds. The kinetic- and m agnetic-energy are simply related to the correlation functions: They are just the equal time velocity

and magnetic eld auto correlation functions multiplied by appropriate phasefactors. We now set out to nd whether the A liven waves are relevant perturbations on the system. It should be noted that the correlators (7) are chosen as they would be in the fully isotropic case. In the presence of a mean magnetic eld B_o there would however be additional anisotropic term s in the expression for the correlators above. In the small B_o lim it the lowest order corrections to the expressions (7) are O (B_o)². Neglecting these correction terms s does not a ect our scaling analyses below, and in any case, we are interested to see whether an isotropic 3dM HD as characterised by expressions (7). Therefore, it su ces for us to work with the expressions (7) for our mode-coupling analyses below.

A complete characterisation of the nonequilibrium steady state (NESS) of MHD, however, requires inform ations about, not just the scaling of the energy-spectra, but also of the n-th order equal time structure functions of the velocity and the magnetic elds in the inertial range. These are dened by

which scale as $r^{\frac{n}{n}}$ where r belongs to the inertial range ($_{D}$ r L). A coording to the K olm ogorov theory (K 41) the multiscaling exponents $_{n}^{a} = n=3$; i.e., they are linear in n. Subsequent num erical and observational results for hom ogeneous and isotropic 3dM HD, i.e., without any mean magnetic elds, [20, 21] suggested deviations from the K 41 results which are similar to those of pure uid turbulence [22]. M uch less results for the multiscaling of the structure functions are available when there are mean magnetic elds. Recent num erical simulations of M uller et al [17] suggested that structure functions parallel and perpendicular to the mean magnetic elds are di erently a ected by it when there is a nite magnetic eld B₀ within the context of a log-norm alm odel by evaluating the relevant intermittency exponents which are found to depend explicitly on B₀. In our analyses we ignore the distinction between the structure functions parallel and perpendicular to the direction of the mean magnetic elds are discussible below, our results are signi cantly new.

IV. SYMMETRIES OF THE EQUATIONS OF MOTION

We begin by re-expressing 3dM HD Eqs. (3) and (4) by writing the magnetic elds b as a sum of a space-time dependent part and a constant vector: $b(x;t) + B_{o}$. In terms of these elds and parameters, the 3dM HD Eqs. become

It should be noted that in Eqs. (9) and (10) B_{\circ} is not the mean magnetic eld in general; it would be so only if hb (x;t)i is zero in Eqs. (9) and (10). Note that our above way of splitting the magnetic elds elds does not change the actual mean magnetic eld in the system : It is still given by B_{\circ} + hbi = B_{\circ} . The Eqs. of motion (9) and (10) are invariant under the following continuous transform ations [8, 23]:

The Galilean transformation (TI): $u(x;t) ! u(x + yt;t) + u_0; \frac{e}{et} u_0: r;$ and b ! b[2, 8, 24] with $_1 = _3 = 1$ in Eqs. (5) and (6). This implies non-renormalization of $_1$ [2, 24, 25].

The transform ation $(T \amalg B_0 ! B_0 + _2, b(x;t) ! b(x;t), u! u. This allows$ $one to work with the elective magnetic elds de ned by <math>P_2^{-}$ b such that the coelection of the Lorentz force vertex constructed out of the elective magnetic elds does not renormalize. This, therefore, ensures $_2$ can be set to unity [8, 23] by treating all magnetic elds as elective elds. Here the shift is a vector. A transformation similar to T II above exists in a problem of passive scalar turbulence [26].

The transform ation T II essentially signiles the freedom to split the total magnetic elds as a sum of a constant part and a space time dependent part. It should be noted that the transform ation T II keeps the mean magnetic eld unchanged. In fact, nonrenormalization of $_2$ can be shown in a simpler way: Let us assume that under mode eliminations and rescaling $_2$! $_2$. This scale factor of can now be absorbed by redening the units of the magnetic elds by $^{\rm P}$ b ! b. Therefore, $_2$ can be set to unity if all magnetic elds are considered as elective or rescaled magnetic elds. Since the Induction Eq. (4 is linear in

the magnetic elds b (x;t), such rescaling leaves every conclusion unchanged. O f course, the external force g is also scaled by a factor which does not a ect out analysis here as the assignment of canonical dimensions to various elds and parameters is done after absorbing $_2$ in the denition of b. More specially under the rescaling x ! lx;t ! $l^{z}t;u_{i}$! $l^{u}u_{i}$; b_{i} ! $l^{b}b_{i}$ the bare parameters scale as $_{1;3}$ (l)! $l^{u+z-1}_{1;3}$; $_{2}$ (l)! $l^{2}b^{u+z-1}_{2}$ and B_{\circ} ! 1^{b} $u^{+z} B_{\circ}$. Since there are no uctuation corrections to the nonlinearities 1; 2; 3, which are the consequences of the invariances under the transform ations T I and T II, they can be kept invariant under rescaling of space and time as mentioned above leading to u = b = and + z = 1. Thus, under naive rescaling the bare parameter $B_0 = B_0 l^{z-1}$. Furtherm ore, the invariance under the transform ation T II and the resulting W ard identity ensure that di erent ways of im plem enting one-loop RG by having di erent values for hoi and B_{\circ} in Eqs. (9) and (10) subject to the same bare mean magnetic eld $B_{\circ} = B_{\circ} + hbi$. Since any renormalisation scheme must respect a freedom of choice as represented by the transform ation T II, respective term s must scale the same way under the rescaling of space and time [23]. Hence, due to uctuation corrections $B'_{\circ}(l)$ 1. Furtherm ore, since both ${\tt B}_{\circ}$ and b have the same scaling dimensions given by the exponent $\,$, the physical mean magnetic eld in the system $B_{o} = B_{o} + hb(x;t)i$, if it receives uctuation corrections under mode eliminations, must scale as $B_{o}(l)$ 1, or if there are no uctuation corrections to it due to some special symmetries (as in the one-dimensional Burgers-like model for MHD in Ref.[2]) will be innelevant (in an RG) sense as it will ow to zero as l^{z-1} (since z for fully developed turbulence is less than unity). This clearly suggests the possibility of a renorm alisation of the Alfven wave speed, akin to the renorm alisation of the sound speed in compressible uid turbulence [27]. As we will see below, for 3dM HD there are infra-red singular uctuation corrections to the barem ean magnetic eld leading it to renorm alise in a way consistent with our predictions from the W ard identities above. It should be noted that our analyses above is independent of the strength of the bare value of the mean magnetic eld. A though, in the discussion above we have rescaled space isotropically (i.e., x; y and z coordinates are rescaled the same way) and analyze the scale dependence of the resulting e ective parameters and the elds, it should be noted that such a rescaling does not im ply that the e ective param eters have isotropic structures.

V. ENERGY SPECTRA FOR INCOMPRESSIBLE FLUIDS

We begin by writing down the 3dM HD equations in the incompressible limit (i.e., r = u = 0). We write down the equations of motion in k-space in terms of the Elsasser variables z = u = b. The equations are (we take the mean magnetic eld B_o to be along the \hat{z} direction)

The stochastic forces $_{1}$ are linear combinations of f_{1} ; g_{1} , the tensor P_{1p} is the transverse projection operator which appears due to the divergence-free conditions on u and b, and $^{\circ} =$.

In the absence of any crosscorrelations between the velocity and the magnetic elds, the simplest choice for the noise variances, consistent with the divergence-free conditions on the velocity and the magnetic elds, are

In Eqs.(12) we choose y > 0. In particular, the choice of y = d in d-space dimensions ensures that the energy ux in the inertial range is a constant (up to a weak logarithm ic dependence on wavevector k) which form sthe basis of the K 41 theory [4], and as a result, the parameters D_1 and D_2 pick up dimensions of energy dissipation rate per unit mass. Hence, we will use y = d in our calculations below. In experimental realisations of M HD, external forces act on the large scales. In analytical approaches, such forces are replaced by stochastic forces with variances given by Eqs. (12) for calculational convenience. It should however be noted that in numerical solutions of the N avier-Stokes equation driven by stochastic forces with variances sim ilar to Eqs. (12) structure functions of the velocity elds are shown to exhibit multiscaling sim ilar to the experimental results [28]. O urpreliminary results from the numerical solutions of the isotropic 3dM HD equations (i.e., no mean magnetic elds) yield multiscaling similar to those obtained from the 3dM HD Eqs. driven by large-scale forces [29]. A lthough no such numerical results exist for the case with a mean magnetic eld, it will presum ably be true for such a situation also. In a stochastically driven Langevin description, correlation functions are proportional to the noise correlations and hence it is necessary to force the Induction Eq. (6) stochastically, as is common in the literature (see, e.g., [2, 8] and references therein). For such noises in the absence of any mean magnetic eld (i.e., for the isotropic case) it has been shown by using a one-loop mode coupling theory that the scaling exponents have values = 1=3; z = 2=3 [8].

The Eqs. of motion (11) are coupled even at the linear level leading to a bare propagator matrix for the Eqs. (11) of the form (a 'o' refers to bare quantities)

We use a one-bop mode coupling theory which is conveniently formulated in terms of the self-energy matrix and the correlation functions given by Eqs. (7). The self-energy matrix is dened by $G^{-1} = G_0^{-1}$ where G is the renormalised propagator matrix. In terms of the scaling exponents and z, and the renormalized parameters the self-energy matrix is given by

where B (k) is the renorm alised or the e ective A liven wave speed. If there are diagram m atic corrections to the imaginary parts of (k;!) at frequency ! = 0 which are singular in the infra-red lim it, then B (k) is di erent from B_o, the bare A liven wave speed, else they are the sam e.




FIG.1: O ne-loop diagram s contributing to renorm alization of G_o^+ . A single line refers to a propagator and a line with a lled circle refers to a correlator.

There are two one-loop diagrams which contribute to the uctuation corrections to $_{11}$ (k; ! = 0) = iB (k)k_z + $_{+}$ k^z. These are shown in Fig.(1). These have both real and in aginary parts at frequency ! = 0. Thus there are uctuation corrections to the bare A liven wave speed which are singular in the sm all wavenum ber lim it. We assume, in the spirit ofm ode-coupling methods, B (k) = B k ^s (we assume an isotropic scale dependence for B (k) for simplicity which su ces our purpose of noting the scale dependence of the elective A liven wave speed). C learly, if s + 1 < z, the sm all wavenum ber lim it of the problem is dom inated by underdam ped waves, if s + 1 > z the A liven waves are dam ped out in the sm all wavenum ber lim it. In contrast if s + 1 = z then in the sm all wavenum ber lim it both the propagating and the dissipative modes are present. Our analyses in Sec.IV clearly suggest that if there are uctuation corrections to B_o then the elective scale dependent A liven wave speed B (l) k yielding s = . Furthermore, since + z = 1 we have s + 1 = z leading to the co-existence of the underdam ped A liven waves and the dissipative modes in the large-scale, long-time limit. Note that this situation allows us to de ne a dimensionless parameter B = + where B and + are the renormalised A liven speed and the viscosity respectively.

In the SCM C approach vertex corrections are neglected. Lack of vertex renorm alisations in the zero wavevector limit in 3dM HD allows SCM C to yield exact relations between the scaling exponents and z as in the noisy Burgers/Kardar-Parisi-Zhang equation [25]. In this model the nonlinearities and the noise variances do not renorm alise, thus leading to z = 2=3; = 1=3, satisfying the exponent identity + z = 1. In the present case, due to the singular nature (in the small wavevector limit) of the bare noise correlations (12), they do not pick up any further singular corrections to their scaling; how ever the am plitudes get modied (this is similar to the results in Ref.[3]). We denote the renormalized amplitudes by D and D, respectively. Furtherm ore, for the 3dM HD Eqs. (5) and (6) there are infra-red singular uctuation corrections to B_{o} [see the one-loop diagram s in Fig. (1)] leading to 1 consistent with our arguments above. The SCM C approach involves consistency B (1) in the scaling and the amplitudes of the mode coupling equations. It should be noted that the exponent values z = 2=3; z = 1=3 satisfy the mode coupling integral equations regardless of the strength of the mean magnetic eld. For am plitude consistency the onebop integrals are required to be evaluated. Due their complicated structure, we evaluated them by assuming that the strength of the mean magnetic eld is small. Therefore, only our amplitude relations and not the scaling exponents are a ected by the approximation of smallmean magnetic elds.

D em anding am plitude consistency in the mode coupling equations we obtain,

where $F_1()$ $2^2(1+3^2)(1=d+\frac{1}{d(d+2)},\frac{1}{d(d+2)(d+4)})$; $F_2()$ $2^2(3+2)(1=d+\frac{1}{d(d+2)},\frac{1}{d(d+2)(d+4)})$ are the -dependent parts of the amplitude-ratio. While calculating the amplitude consistency relations we worked in the limit of small $B=_+$ and the renorm alised magnetic P randtl number ($-=\frac{+}{++}$) close to unity. Away from these limits the amplitudes of the underlying one-loop integrals become much more complicated functions of and also of the renorm alised magnetic P randtl number ($-=\frac{+}{++}$) close to unity. Away from the expressions (13) is that in the absence of a bare mean magnetic eld B_0 the elective A liven wave speed is also zero which is a restatement of the fact that if the original theory is isotropic, so will be the renorm alised theory. Moreover the renorm alised A liven speed increases with increasing B_0 . With these results we are now in a position to calculate the energy spectra in the inertial range. We use the form of the elective (scale dependent) viscosity and the A liven wave speed to obtain the equalitin e correlation function of z_i in the long wavelength

lim it. W e de ne (in 3d)

As discussed before, we have on itted anisotropic corrections of $O(B_{0})^{2}$ or of $O(2)^{2}$ to the correlation functions as we are trying to nd out the relevance (in an RG sense) of A liven waves on the scaling of the isotropic correlation functions in the absence of any m ean m agnetic edds. Therefore, the equal time correlation functions have the following form (in d = 3):

Therefore, the equal time autocorrelation functions of z are independent of any mean magnetic eld. This holds true regardless of the scaling of the noise variances. The equal time cross correlation function C_{ij}^+ (k;t = 0) requires more careful considerations. On integrating C_{ij}^+ (k;!) over all frequency ! one obtains (in 3d)

a form which is valid in the inertial range. It is clear from the expression (16) that both the real and the in aginary parts of C_{ij}^+ (k;t = 0) scale as $k^{-3-2=3}$ in the inertial range. Thus the one-dimensional kinetic- and the magnetic-energy spectra (which are simply related to the correlators de ned in Eqs. (14)) scale as $k^{-5=3}$ in the inertial range. The emerging physical picture is as follows: We not from the expression for C_{ij}^+ (k;!) above that this, as a function of frequency !, has maxim a at ! = $B k^{-1=3}k_z$ and the width at half-maxim a $k^{2=3}$. In contrast, the auto correlations of z^+ ; z are maximum at ! = 0 and their widths scale as

 $k^{2=3}$. Thus in the long wavelength limit the width and the location of the maxima of C_{ij}^+ (k;!) scale in the same way leading to the presence of the underdam ped A lfven waves in the hydrodynamic limit. Therefore, it immediately follows that the kinetic- and the magnetic-energy spectra, being linear combinations of the correlators discussed above times appropriate phase factors, scale as $k^{5=3}$ even in the presence of a non-zero mean magnetic eld. It should be noted that we have used a small approximation to arrive at our results for

the self-consistent am plitude relations. For a nite one would require to work with a fully anisotropic form of the correlation functions and obtain self-consistent relations for scaling and anisotropic am plitudes, a task, which is analytically challenging, remains to be done in the future. However, based on our calculations above, the exponent identity + z = 1 and the W and identity suggesting that the renorm alised A lfven wave speed should scale as $k^{1=3}$ with wavevector k being in the inertial range, we argue that even for a nite , i.e., a nite mean m agnetic eld the energy spectra will scale as $k^{5=3}$ in the inertial range, a result supported by m any observational evidences [14]. The self-consistent am plitude equations will then be anisotropic relation matrix will be anisotropic in the hydrodynamic limit; its eigenvalues have di erent am plitudes, but all of them scale the same way. O ur con dence on our result that the scaling of the correlation functions along directions parallel and perpendicular to the direction of the mean magnetic eld is same is derived from the fact that our exponent values z = 2=3; z = 1=3 satisfy the one-loop integral equations regardless of the strength of the mean magnetic eld and are consistent with the W and identity discussed above.

VI. KOLM OGOROV'S CONSTANTS

A coording to the K olm ogorov's hypothesis for uid turbulence [4], in the inertial range energy spectrum E (k) = K_o²⁼³k⁵⁼³, where K_o, a universal constant, is the K olm ogorov's constant and is the energy dissipation rate per unit m ass. Various calculations, based on di erent techniques by di erent groups [7, 30, 31, 32] show that K_o 1:5 in three dimensions. Having noted that the energy spectra, even in the presence of a mean magnetic eld scale as k⁵⁼³ extensions of K olm ogorov's hypothesis for 3dM HD allows one to de ne K olm ogorov's constants for the E lsasser elds: E (k) = K_o²⁼³k⁵⁼³. Since z = u b, we have hz₁⁺ (k;!)z_j⁺ (k; !)i = hz (k;!)z_j (k; !)i and₊ = $_{M HD}$ in absence of any crosscorrelations between the velocity and the magnetic elds, we have K_o⁺ = K_o = K_{M HD}. The noise strength D and the rate of energy dissipation per unit m ass is connected by the N ovikov's theorem [8, 33]: = $2D\frac{S_3}{(2-)^3}$. Noting that the energy spectra E (k) of z in the inertial range is given by

where D is the e ective or renorm alised noise strength, we identify

The notable feature of the expression (18) is that the constant K^{MHD} depends on the dimensionless parameter which we introduced before. For = 0, i.e., for no magnetic elds, we nd $K_{MHD} = K_0 = 1.6$ for pure uid turbulence which is well-within the accepted range of values [31]. Before closing this Sec. we would like to point out that the presence of multiscaling raises questions about K olm ogorov's constant K_{MHD} being universal: A sm all but nite intermittency correction (i.e., multiscaling) over the simple K 41 scaling in plies the presence of an arbitrary scale which may spoil the universality of K_{MHD} . We however refrain ourselves from getting into this question and adopt a point of view that regardless of whether or not K_{MHD} remains universal due to multiscaling, the numerical value of this constant is likely to get a ected by the presence of A liven waves in the system which is re ected by the expression (18).

VII. POSSIBILITIES OF VARIABLE MULTIFRACTALITY

Experiments and numerical sum ulations [20, 34] nd nonlinear multiscaling corrections to the K 41 prediction of $\frac{a}{p} = p=3$ for the structure functions in the inertial range. Until the date, no controlled perturbative calculation for $\frac{a}{p}$ is available. To account for multiscaling in uid turbulence, however, O bukhov [35] and K olm ogorov [36] assumed a log-norm al distribution for dissipation to arrive at

For small, 79. A standard calculation on the random ly stirred model yields interm ittency exponent = 0.2 [32] where = 97, whereas the best possible estimate from experiments is 0.23 [32]. This model, despite having well-known limitations and di culties [38], serves as a qualitative illustration of multiscaling. As in uid turbulence, in M HD the dissipations of the E leaser variables z uctuate in space and time, and as a result one may de ne two intermittency exponents for them. In the present problem $_{+} = _{M H D}$. Below we calculate the exponent $_{M H D}$ in a one-loop expression which will give us an estimate of the A lfven wave speed-dependent deviation of the scaling of the structure functions from their simple-scaling values as predicted by the K 41 theory. We closely follow Ref.[32]. We work with the self-consistent forms for the self-energies and correlation functions given above along with the consistency relations for the amplitude-ratios and . Following Ref.[32], we not the dissipation correlation functions in 3d to be

Thus, which is a universal coe cient in ordinary uid turbulence, varies with the parameter , or with the A lfven wave speed in MHD. Substituting the values of K_{\circ} and we nd

Thus we nd that a decrease in the value of with an increase in , i.e., with increasing mean magnetic eld. Despite the limited applicabilities of log-normal models in characterising multiscaling, we can conclude, from our expression (23) for the intermittency exponent in M HD in the presence of a mean magnetic eld, that the intermittency corrections to the simple K 41 scaling is likely to get a ected (reduced in our calculations) in the presence of A liven waves. Further calculations and/or num erical simulations are needed to not the exact extent of the dependence of multiscaling on the mean magnetic eld and the possibilities of an isotropic multiscaling for the structure functions parallel and perpendicular to the mean magnetic eld as demonstrated recently in R ef.[17]. It should be noted that our conclusions on the multiscaling properties of the structure functions depend on a log-norm alm odel for 3dM HD. Such a description, unfortunately, is unable to distinguish between the structure functions parallel and perpendicular to the direction of the mean magnetic eld in the system. Moreover, the intermittency exponents above [expressions (23)] are evaluated in the lowest order in mean magnetic eld. Therefore, even though from our results we are not able to make im comments on the possibility of parallel and perpendicular structure

functions exhibiting di erent multiscaling, the real importance of our results lie in their elucidation of the multiscaling properties depending on the mean magnetic eld.

VIII. CONCLUSION

In this paper we have considered the e ects of the A liven waves on the statistical properties of the correlation functions of the velocity and the magnetic elds or the E lsasser elds. We considered the case when the velocity elds are incompressible. In a one-bop approximation we nd that the e ective or the renormalised Alfven wave speed scales as k $^{1=3}$ where the wavevector k is in the inertial range. This immediately yields that the energy spectra, even in the presence of a mean magnetic eld, scale as k $^{5=3}$ in the inertial range. We identify a dimensionless parameter which is the ratio of the elective A liven wave speed and the renorm alised viscosity. We obtain self-consistent relations between the amplitude ratio of the correlation functions and . These relations allow us to calculate the dimensionless Kolm opprov's constant and we show that it depends explicitly on or on the mean magnetic ed. Finally, we calculate the interm ittency exponent which in a log-norm alm odel gives a qualitative account of the multiscaling in terms of the deviation from the K 41 scaling for the structure functions. We would like to emphasize that although the one-dimensional Burgerslike m odel of M HD of R ef. [2] and the 3dM HD Eqs. yield energy spectra independent of the A liven waves, the long wavelength physical pictures are di erent. In the form er case, due to the nonrenorm alization of the bare A liven wave speed, A liven waves are overdam ped in the hydrodynam ic lim it; the dom inant process in that lim it is viscous dissipation. In contrast, in 3dM HD, the A liven wave speed picks up a singular correction in the hydrodynam ic limit. leading to the K 41 scaling of the energy spectra and the presence of underdam ped A liven waves in the hydrodynam ic limit. Despite similar mathematical structures these crucial di erences arise principally because the one-dimensional model decouples completely when written in term softhe E leaser variables, allowing to com ove with the waves of each of them separately. As a result correlators of each of them are independent of the Alfven waves and the bare A liven wave speed remains unrenormalised leading to overdam ped A liven waves in the hydrodynam ic lim it. However, the 3dM HD equations do not decouple when written in terms of the E leaser variables and hence oppositely propagating waves cannot be made to vanish by comoving. Despite the limitations of the one-loop methods [7] and the small

approximation to facilitate easier analytical manipulations for the amplitude relations, we obtain results which are signi cantly new and open the intriguing possibilities of MHD multiscaling universality classes being parametrised by the mean magnetic eld. Some of the quantitative details will change if one retains term swhich are higher order in ; how ever, we believe that the qualitative picture will essentially remain the same. As MHD turbulence form s a natural example of a driven nonequilibrium system with A liven waves, our results are the rst of its kind for a natural system. In our log-norm alm odel approach, we did not distinguish between the longitudinal and the transverse structure functions our results cannot be compared directly with those of Ref.[17], where the longitudinal and the transverse structure functions are found to scale di erently with multiscaling exponents which depend on the magnitude of the mean magnetic eld in the presence of a nite magnetic helicity. In contrast our results apply to the multiscaling of the usual structure functions in the absence of any magnetic helicity which are combinations of the transverse and the longitudinal structure functions as considered in Ref. [17] which would also then exhibit a mean magnetic eld dependent scaling. In particular we nd that the usual structure functions multiscale less in presence of an increasingly strong mean magnetic eld which is in qualitative agreem ent with those of R ef. [17]. A though here we have restricted ourselves to the study of A liven waves as relevant perturbations on the amplitude and the scaling of the isotropic correlation functions in the limit of small, our results indicate the possibility of the multiscaling exponents varying with the amplitude of the mean magnetic eld. Our analyses, when extended for nite values of and for full an isotropic structure of the correlation functions, are likely to provide further understanding of and resolve some of the discrepancies between the various phenom enological scenarios available for situations with large m ean m agnetic elds [10, 11, 13]. W e leave this task for the future.

From a broader point of view our results demonstrate the critical role of wave-like excitations in determ ining the statistical properties of 3dM HD. The presence of propagating waves is not con ned to M HD only; they are a generic feature in many other naturally occurring soft-matter systems where such waves can be present in a viscous environment, e.g., active polar gels in cytoskeletal dynamics [39] and in the dynamics of self-propelled particles [40] etc. We believe our results will lead to similar theoretical and experimental studies in relevant nonequilibrium soft-matter system s.
