Stable and unstable vector dark solitons of coupled nonlinear Schrodinger equations. A pplication to two-com ponent Bose $\Psi$ instein condensates

#### Abstract

D ynam ics of vector dark solitons in tw o-com ponent Bose E instein condensates is studied w ith in the fram ew ork of the coupled one-dim ensionalnonlinear Schrodinger ( $\mathbb{N} L S$ ) equations. $W$ e consider the sm allam plitude lim it in which the coupled NLS equations are reduced to the coupled K ortew egde Vries ( $\mathrm{K} d V$ ) equations. For a speci c choice of the param eters the obtained coupled $K d V$ equations are exactly integrable. We nd that there exist two branches of (slow and fast) dark solitons corresponding to the tw o branches of the sound waves. Slow solitons, corresponding to the low er branch of the acoustic w ave appear to be unstable and transform during the evolution into the stable fast solitons (corresponding to the upper branch of the dispersion law ). Vector dark solitons of arbitrary depths are studied num erically. It is show $n$ that e ectively di erent parabolic traps, to which the two com ponents are sub jected, cause instability of the solitons leading to splitting of their com ponents and subsequent decay. Sim ple phenom enological theory, describing oscillations of vector dark solitons in a $m$ agnetic trap is proposed.

## I. IN TRODUCTION

It is well established that in a one-com ponent B oseEinstein condensate (BEC) with a positive scattering length, which has cigar-shaped geom etry, one can generate dark solitons [1] [1]. Experim ental generation of tw ocom ponent BEC's of di erent hyper ne states of rubidium atom $s$ in a $m$ agnetic trap $[1]$ and of sodium atom $s$ in an optical trap [ $\left.{ }_{-1}^{1} 1\right]$ stim ulated theoretical studies devoted to the $m$ ean eld dynam ics of $m$ ulticom ponent condensates. As in the one-com ponent case special attention was devoted to existence of solitary waves in such system s . W hen a condensate is cigar-shaped and has relatively low density, i.e. when the healing lengths of the com ponents are $m$ uch larger than the transverse dim ension of the condensate and $m$ uch less than its longitudinal dim ension, the transverse atom ic distribution is well approxim ated by the $G$ aussian ground state and the system of coupled G ross $P$ itaevskii (GP) equations, describing them ixture (see e.g. [it]), can be reduced to the coupled one-dim ensional (1D ) nonlinear Schrodinger (NLS) equations (see e.g. [6] 1 ) $)$. The respective $m$ odels w ere a sub ject of recent theoreticalstudies. In particular, coupled largeam plitude dark-bright solitons have been reported in [id]; bound dark solitons have been num erically studied in $[\underline{1} 1]$ where it has been found that creation of slow ly m oving ob jects is possible; a diversity of other bound states has been generated num erically in [q]

The present paper aim s further analytical and num eri-

[^0]calstudy ofdark solitons in tw o-com ponent B EC's. M ain distinctions of the situation considered here com pared to the previous research are as follow s. (i) W e consider vector dark solitons, i.e. states where tw o com ponents m ove w ith equal or approxim ately equal velocities. (ii) W e do not im pose the condition ofequality of the nonlinear coefcients, as a necessary condition, allow ing one to reduce the problem to the exactly integrable one $\{$ to the socalled $M$ anakov problem, for which vector dark solitons are known [ vide analytical description of the phenom enon reducing a system of coupled NLS equations to a system of coupled K ortew eg-de V ries ( $K$ dV ) equations, what allow s us to predict existence of two types of vector dark solitons, m oving w ith di erent velocities. (iv) F inally, we study in detail the e ect of the $m$ agnetic trap on the dark soliton dynam ics. W e show that, due to di erence of its e ect on di erent com ponent, a m agnetic trap leads to splitting of the com ponents and subsequent destruction of vector dark solitons.
II. STATEMENTOFTHEPROBLEM AND PHYSICALPARAMETERS

Evolution of a two-com ponent BEC com posed of different hyper ne states is described by the coupled GP equations $(j=1 ; 2)$ [ą

In the case of an elongated trap，when is sm all enough，and when densities of the both com ponents are low enough，one can em ploy the m ultiple－scale expansion $m$ ethod in order to reduce the original3D system（ $\overline{1} 1 \mathbf{1})$ to the hom ogeneous coupled 1D GP equations（for details

Besides asymmetry of the trap and weakness of the two－body interactions，expressed by the sm allness of and ，respectively，our $m$ odel assum es equality of the aspect ratios of the com ponents（ does not depend on j）．M eantim eweem phasize that the linear oscillator fre－ quencies ！ j may be very di erent（say，in the experim ent reported in $R$ ef．［1］d，the relation betw een the frequencies was ！＝$\overline{2}$ ）．As a result，even for in itially equal scat－ tering lengths，the e ective nonlinearities $j$ ，de ned in Eq．（3），becom e di erent because of di erent transverse distributions of the com ponents．

To estim ate a typical value of the param eter we con－ sider a binary condensate of tw o hyper ne states of ru－ bidium atom $s$ in a trap $w$ ith the $m$ ean value of the trans－ verse oscillator frequency $2 \quad 200 \mathrm{~Hz}$ and the aspect ratio
$=10^{4}$（this corresponds to the 1 m and 100 m of the transverse and longitudinal linear oscillator lengths）． Taking $a_{11} \quad 1 \mathrm{~nm}$（here we take into account that the scattering length can be varied by using Feshbach res－ onance）and assum ing the $m$ ean atom ic density to be $\mathrm{n} \quad 10^{2} \mathrm{~cm}^{3}$ we obtain $0: 05$ ．W e also point out here that the respective healing length（for num erical estim ates we assum e that the healing lengths of the both com ponents are approxim ately equal）is estim ated to be of order of 4 m ．

III．SM ALLAMPLITUDE DARK SOLITONS

## A．R escaled system of equations

An initial value problem for system（ $(\underset{\text { L }}{1})$ does not al－ low solution in a generalcase，except in the speciallim it， which is known as the $M$ anakov system and which is dis－ cussed below［see（ $1 \bar{L}_{1}$ ）the respective discussion］．Som e inform ation about possible solutions，is how ever avail－ able in the sm allam plitude lim it，w here the coupled N LS equations are reduced to the coupled K dV equations．

In this approxim ation a dark soliton evolves against a background what m eans that（2，$\left.\underline{2}^{1}\right)$ is considered sub ject to the boundary conditions

where ${ }_{j}^{2}$ are properly norm alized densities of the com－ ponents．Taking this into account as well as a large num－ ber of free param eters of the problem，is convenient to scale out the boundary conditions for the sake of per－ form ing the $s m$ all－am plitude reduction $m$ entioned above． To this end we introduce the total dim ensionless den－ sity ${ }^{2}={ }_{1}^{2}+{ }_{2}^{2}$ ，and rescale the variables as follow S ： $j=\frac{1}{j}{ }_{j}, t={ }^{2} T$ ，and $x=P-X . ## B．Sound propagation

Sm all am plitude dark solitons，which from the phys－ ical point of view represent packets of acoustic waves， forwhich weak nonlinearity and weak dispersion are bal－ anced，propagate against a background w ith a speed close to the group velocity of the sound（see e．g．［12 $\left.1_{1}^{1}, 1_{2}^{2}\right]$ ，as wellas consideration＿below ）．T he background in our case is computed from $(\underline{G})$ and $\left(\underline{V_{1}}\right)$ to be $j=\exp \left(i \mathbb{F}_{j} t\right)$ where

A $n$ interesting feature, relevant to the next consideration, is that the group velocity of the long-length excitations of the low est branch, i.e. $v$, becom es zero at

$T$ hen the $m$ atrix ofe ective nonlinearities is degenerated. $T$ his situation corresponds to the $M$ anakov system, which is an integrable lim it of the coupled N LS equations.

## C. A com m ent on the sm all param eter

Let us now tum to the analysis ofsm allam plitude dank solitons. To this end we em ploy the idea due to Ref. [1] [1] about possibility of the m ultiple-scale reductions betw een NLS and $\mathrm{K} d V$ equation, noticing that the $\mathrm{K} d V$ equation can be obtained as a sm allam plitude lim it of the N LS like equation also in nonintegrable lim it and w ith arbitrary (intensity dependent) nonlinearity [12'].

B efore going into details of calculations we $m$ ake the follow ing observation. D erivation of the dynam icalequation for sm all am plitude waves is based on introduction of the sm all param eter of the problem, which we w ill be designated as " [see (13), (1-5) below ]. T hen the resulting evolution equation (see (181) below) appears in the order " ${ }^{5}$. If we now recall that the 1D reduction of the coupled GP equations is $m$ athem atically justi ed by sm allness of , introduced in (") (4), and that the respective 1D NLS equations (2)) appear in the ${ }^{3}$ order, while term sof order of ${ }^{4}$ are neglected, we conclude that strictly speaking the resulting $K$ dV lim it is not applicable for the description of low-dim ensional BEC's [it would be valid only if one
could provide the inequality "n 1 , what is not feasible for real experim ental situation, w here typical values of are of order of $0: 1 \quad 0: 01$, as it has been $m$ entioned above]. Thus the present section although being interested from the view point of the sm all-am plitude lim it of the coupled NLS equations, cannot be directly interpreted as a theory of sm allam plitude dark BEC solitons (the issue which rem ains to be an open problem). T he signi cance of the results obtained below for the $m$ eaneld theory of the BEC is in the indication on new types of the solutions which cannot be directly obtained from the system ( $\overline{\text { 人 }}$ ) (or (G) ).
$T$ here exists one $m$ ore lim itation for the practical use of the sm allam plitude lim it. It is related to the fact that sm all am plitude solitons are w ide and their w idth m ay be com parablew ith the longitudinalextension of the condensate. Indeed, the characteristic size of a (non-sm allam plitude) dark soliton is of order of a healing length $j$ (as above healing lengths of the both com ponents 1;2 are considered of the sam $e$ order). This $m$ eans that a sm all am plitude soliton has a width of order of $j=" \quad j$. T he sm all am plitude expansion fails at the boundaries of the atom ic cloud, as the density approaches zero in those dom ains. Thus, for the validity of the theory one m ust require the longitudinal size of the condensate (ie. $\left.a_{j}={ }^{-}\right)_{p-}$ to be much bigger than the width of the soliton $a_{j}=-\quad j=\bar{p}$ or in other words one $m$ ust im pose a condition " ${ }^{-}{ }_{j}=a_{j}$. The obtained constrain is, how ever, not as strong as the previous one. In particular, the estim ates provided the end of the Sec. II give now " 0:04.

> D. C oupled K dV equations

Our aim now is to derive evolution equations for $q_{j}(;)$ and ${ }_{j}(;)$, which will describe evolution of the sm all am plitude dark solitons. R espectively, we im pose the boundary conditions

W hile equations of the zero and the rst orders are satis ed identically, it follow sfrom the equations of the $2-n d$ and $3-r d$ orders w th respect to " (see A ppendix A for the details), that the am plitudes and the phases of the excitations of the tw o com ponents are linked by the relations ( $j=1 ; 2$ )

The obtained form ula reveals essential di erence betw een integrable and nonintegrable versions of the coupled N LS equations. In the form er case a zero value of the group velocity of the lowest branch does not allow existence of sm all am plitude solitary pulses. In other words in the integrable case there exists only one branch of dark solitons.

The condition of com patibility of the equations of 4 -th and 5-th orders in the sm all param eter " results in the coupled K dV equations (see A ppendix A ):

As it follows directly from ansatz (19), solutions describing di erent branches correspond to equal distributions of atom ic densities. $M$ eantim e they correspond to di erent phase di erences

## F. N um erical results

A s it has been $m$ entioned above, although solutions of the coupled $K$ dV equations represent a good approxim ation for the exact solutions of the coupled N LS equation in the sm all am plitude lim it, strictly speaking they cannot be considered as satisfactory, when applied to the dynam ics of a two-com ponent BEC in an elongated trap. $M$ eantim e, the obtained vector soliton (191) can be em ployed as an intial condition for num erical generation of dark vector solitons of the coupled N LS equations (G), having sm allbut nite am plitudes. Such num ericalstudy is perform ed in the present section.

Taking into account the existence oftw o kinds of sm all am plitude solitons we address the question about persistence of the excitations at nite, but still sm all, am plitudes, as well as their stability w thing the fram ew ork of system ('َ-1).

An exact vector dark soliton corresponding to the upper branch of the linear spectrum reads

In $F$ ig $\overline{12}_{1}^{1}(a)$ the tra jectories of the centers of vector dark soltons are shown for three di erent in itial conditions: the exact dark soliton (2-5) (line 1), the approxim ate distribution ( $1 \mathbf{1}-1$ ) corresponding to the upper (line 2), and low er (line 3) branches. The centers of the solutions are de ned as coordinates of the absolute $m$ inim a of $j$ j ${ }^{f}$ : they are designated as $x_{m}^{(0)}$ in and $x_{m}^{( }$in for the exact and tw o approxim ate solutions, respectively.

E xact solution (25-1) appears to be stable, and its approxim ate counterpät given by (19응) undergoes sm all (invisible on the scale of $F$ ig (17) deform ation. In the num erical sim ulation with the \approxim ate" intial condition corresponding to ( $1 \underline{1} \underline{1}$ ) the e ective sm all param eter is $0: 1$. T his gives the am plitude di erence $w$ ith the exact solution to be of order of ${ }^{4}=10^{4}$ what explains di erence betw een the lines 1 and 2 in $F$ ig $111($ (b) . T he solution corresponding to the low er branch of the spectrum starts to $m$ ove $w$ ith the velocity $v$, but during initial interval of tim e changes signi cantly: it decays into two localized pulses $m$ oving in opposite directions, as it is show $n$ in $F$ ig'r,". The forw ard $m$ oving part represents the lunstable" dark soliton. Its am plitude continues to change

during the evolution (see Figlolin (b)) and its velocity approaches the group velocity of the upper (stable) branch (see $F$ ig ${ }_{1}^{1} 1(\mathrm{l}(\mathrm{a})$ ).

T he observed instability of the low er branch dark soliton is especially interesting in view of the recent results reported in [13], where it $w$ as found that in the 3D coupled GP equations, describing spinor condensates, there exist subsonic (i.e. having velocities below the sound speed of the lowest branch) solitary wave complexes, $m$ ost of which are suggested to be stable. In our case a subsonic vector dark soliton is unstable, and the stable one has the velocity betw een the two sound speeds: $\mathrm{v}<\mathrm{V}_{0}<\mathrm{V}_{+}$.

In order to understand this phenom enon, let us consider the energy of the system

Let us assum e now that the respective low er and upper branch solitons are characterized by param eters and + , respectively. Let also initially the low branch soliton is excited. Since it does not represent an exact (but only an approxim ate) solution it starts to deform w th time. Such a deform ation has a constrain: the phase di erences ' $j$ are preserved. In the case of a sm all am plitude soliton, given by (1-d), one com putes

Thus what we observed in the num erical sim ulations is the transform ation ofa high energy vector soliton in a low energy vector soliton, accom panied by quasilinearm odes.

## IV. EFFECTOFTHEPARABOLICTRAP

Let us now tum to the situation when the trap is not long enough in the axial direction, such that re ections of a soliton from potentialw alls can happen. In this case the trap potentialm ust be included explicitly in the equations (instead of including it into the norm alized ground states, see e.g. [14] $\mathbb{H}_{1}^{1}$ ) This leads to coupled 1D GP equations (G) as follow s

Here $1_{1}==2$ and $2=!1$ are e ective strengths of parabolic traps. W ithout restriction of generality in what follow s we consider the situation where $1<2$.

In the case of equale ective frequencies, $1=2$, and sub ject to the speci $c$ initial condition $\left(1_{1}=\right.$ const 2$)$, e ectively reducing the system to a single NLS equafion, a vector dark soliton oscillates $w$ ith the frequency
$\overline{2}$ tim es sm aller than the frequency of the parabolic trap $\left.[1]_{1}, 16\right]$. If how ever strength of the parabolic potentials of the two com ponents are di erent, behavior of the sollton changes dram atically. T here exist two com peting factors, which determ ine the dynam ics. On the one hand, each com ponent, a ected by its own parabolic potential, \attem pts" to oscillate $w$ ith its ow $n$ frequency. On the other hand, attractive interaction between the com ponents, described by functional (29), forces them to oscillate $w$ ith the sam e frequency.

The dynam ics em erging from the competition of the factorsm entioned above is shown in F ig ${ }^{2}$. 1 . In the case of su ciently $w$ ide potentials and sm all di erence betw een their strengths ( $F$ ig ${ }_{\underline{N}}^{1}(\mathrm{a})$ ) the rst and second com ponents (thin and thick lines correspondingly) initially oscillate w ith approxim ately equal frequencies.

T he dynam ics observed in the case w hen initial soliton velocities are xed and di erence betw een strengths of the traps is increased is shown in $F$ ig ${ }^{1} \mathbf{N}$ $m$ ore signi cant separation of the com ponents. T he dynam ics, how ever still resem bles periodic m otion. A fter subsequent increase of the initial kinetic energy of the soliton, by $m$ eans of increasing its initial velocity, m ore visible splitting is observed, as it is shown in $\mathrm{Fig}{ }_{\underline{N}}^{1}$ (c) . A fter the rst period the soliton splits and each com ponent starts to oscillate $w$ ith its ow $n$ frequency.

By increasing the frequencies of the $m$ agnetic trap
but keeping constant the ratio betw een them (this corresponds to passage from $F$ ig ${ }^{\prime}$ serves fast splitting the com ponents whose trajectories show rather independent behavior. The second com ponent, which exists in e ectively $m$ ore narrow trap, does not display periodic $m$ otion.

To understand qualitatively the described behavior, we introduce coordinates of the centers ofm ass of the com ponents ( $j=1$; 2 )

W e also de ne the coordinate of the center of $m$ ass of the whole condensate $\mathrm{X}_{+}=\left(\mathrm{N}_{1} \mathrm{X}_{1}+\mathrm{N}_{2} \mathrm{X}_{2}\right)=\mathrm{N}$, where $\mathrm{N}=\mathrm{N}_{1}+\mathrm{N}_{2}$, and the distance betw een the two centers of $m$ asses: $\mathrm{X}=\mathrm{X}_{2} \quad \mathrm{X}_{1}$. We em phasize that, strictly speaking, $X_{1 ; 2}$ do not describe tra jectories of the dark solitons (see the discussion in [1] [1] ). O ne how ever could expect, that when the vector soliton splitting is sm all enough (i.e. when $X \quad$ 1) the relations am ong the frequencies of the two-com ponent problem are approxi$m$ ately the sam e as in the one-com ponent case. T hat is why we concentrate on dynam ics of $X$.

D i erentiating $X_{j}$ w ith respect to tim $e$ and using ( (iG) we com pute

W hile equations ( $\left(3 \overline{4} \overline{4}_{1}\right)$ and $(\overline{3} \overline{3} \overline{5})$ are exact, they are not closed, and in order to $m$ ake use of them we have to $m$ ake som e approxim ation. Below, in Figs. 点 (a), (b) we show that, if the di erence $2 \quad 1$ is sm allenough, the shapes of the com ponents are preserved for relatively long tem poral intervals, even when the splitting is not negligible. B asing on this observation we assum e that the com ponents of the vector soliton preserve their shapes and only change their velocities. This allow s to us describe each com ponent in the vicinity of the soliton by formula (2)흔) where $V_{0} t$ is substituted by $X_{j}(t)$. W e also restrict the consideration (this tim e for the sake of sim plicity only) to zero in itial velocities: $\mathrm{v}_{0}=0$. T hen the integral in

explicitly. It appears to be a function of X only (i.e. independent on $X_{+}$).

In other words $s=\quad{ }^{P} \overline{2}$ is expected to be the $m$ ain frequency of the oscillations of the vector soliton, where we introduce the factor $\overline{2}$ con jecturing that the relation betw een the frequencies of the condensate and the soliton is the same as in the one-com ponent case. To com pare this estim ate $w$ th the direct num erical sim ulations shown in $F$ ig'त्ञ (a), we use the num erical values $N_{1} \quad 12$ and $N_{2} \quad \overline{7}: 1$ and obtain from $(\overline{3} \eta)$ : the frequency s $\quad 0.24$ and the period of oscillations $T_{s} \quad 26: 1$. The num erical value of the period subtracted from $F$ ig'sul (a) is $\mathrm{T}_{\text {num }}$; $26: 3 \mathrm{w}$ hat is in a rem arkable (taking into account the character of the approxim ations) agreem ent w th the theoretical prediction $\mathrm{T}_{\mathrm{s}}$.

In order to analyse the characteristics of the splitting of the soliton, we hold the above assum ptions and rew rite Eq. (3) in the form

Eq. (3 $\overline{3}^{-1}$ ) is nothing but a nonlinear oscillator in a trap $m$ ade up of the parabolic potential ${ }^{2} X^{2}=2$ and of the nonlinear potential $U_{\text {eff }}(X)$ ), driven by the periodic force, $4{ }_{2}^{2} \quad 2_{2}^{2} X+(t)$, originated by the oscillation of the condensate as a whole.

To sim plify the next consideration we take into account that X is relatively sm all [see Fig in (a)] and substitute

U sing the data of $F$ ig'ָㅜㄴ (a) we com pute ~ $0: 59$, what corresponds to the period of m odulation $\mathrm{T}=$ $10: 65$, while the num erical value subtracted from the gure is $\mathrm{T}_{\text {num }}$; $\quad 11: 8$. Thus we again observe good agreem ent betw een the sim ple theoretical estim ates and the num erical results, what show $s$ that the sim ple $m$ odel given by Eqs. (3]) and (3'q) provides adequate description of the vector soliton dynam ics in a parabolic trap whenever the splitting betw een the com ponents is sm all.

Interaction betw een the com ponents of the vector soliton and soliton interaction $w$ ith the con ning potentialin a general case lead to deform ations of the pro les of the soliton com ponents, what is shown in F ig' $t_{f}$ corresponding to the nal tim e of the evolution depicted in $F$ ig $\underset{1}{1} 1$. A lready after few oscillations the vector soliton decays, except in the case when both com ponents oscillate in e ective trapsw ith equalstrengths (i.e. when the vector soliton behaves like a single-com ponent dark soliton []-] $]$ ].

## V. CONCLUSION

To conclude, we have investigated dynam ics of vector dark solitons govemed by one-dim ensional coupled nonlinear Schrodinger equations. In the hom ogeneous case and in the sm allam plitude lim it, when the vector soliton propagates w ith the velocity close to the speeds of the sound, a stable vector soliton has a velocity close to the higher velocity of the sound and exceeding speed of the slow sound. T he respective subsonic (ie. having a velocty lower than the speed of the slow sound) dark vector

soliton is unstable. The both cases are described by the coupled K ortew eg-de V ries equations. W hen the group velocity of the lower branch of the sound dispersion relation becom es zero, what corresponds to the integrable $M$ anakov system, the coupled $K$ ortew eg-de V ries equations obtained in the sm allam plitude lim it are integrable (to the best of authors know ledge, such system has not been reported in the literature, so far).

Including a parabolic trap into consideration changes behavior of vector solitons dram atically, leading in a general case to their decay, what is explained by di erent eigenfrequencies of the two com ponents. If $m$ eantim $e$ the e ective traps for the both com ponents have close frequencies, during initial tim es the dynam ics of the vector soliton can be qualitatively (and also quantitatively, w th rather good accuracy) described by the oscillatory $m$ otion of the soliton center $w$ ith the frequency given by (3-7). R elative dynam ics of the com ponents, when splitting is sm all enough, can be interpreted as an oscillator driven by a periodic force. Large di erence betw een strengths of parabolic traps or large intitial soliton velocities cause instability of dark vector solitons leading to their splitting and subsequent decay, thus preventing possibility of the long-tim e dynam ics.

The last system allow s one to expresses $q_{j 1}$ through other dependent variables, and substitute the result in
equations $(\bar{A} \overline{-} \overline{-})$. In this way one obtains the inhom $0-$ geneous linear algebraic system of equations for @ j1, which determ inant is com puted to be zero. This leads to linear dependence of the equations which are solvable only sub ject to the respective requirem ent im posed on their right hand sides. D i erentiating the $m$ entioned solvability condition $w$ ith respect to and using onem ore tim e the link $\left(1 \bar{T}_{1}\right)$ in order to express the nal result through the dependent variables $q_{j}$ only, one obtains coupled K dV equations (19,
