# Lattice-Boltzm ann M ethod for N on-N ew tonian F luid F low s

# Abstract

We study an ad hoc extension of the Lattice-Boltzm ann method that allows the simulation of non-Newtonian uids described by generalized Newtonian models. We extensively test the accuracy of the method for the case of shear-thinning and shear-thickening truncated power-law uids in the parallel plate geometry, and show that the relative error compared to analytical solutions decays approximately linear with the lattice resolution. Finally, we also tested the method in the reentrant- ow geometry, in which the shear-rate is no-longer a scalar and the presence of two singular points requires high accuracy in order to obtain satisfactory resolution in the local stress near these points. In this geometry, we also found excellent agreement with the solutions obtained by standard nite-element methods, and the agreement in proves with higher lattice resolution.

#### I. IN TRODUCTION

Since its origin, more than 15 years ago, the Lattice Boltzmann Method (LBM) has proved to be a powerful numerical technique for the simulation of single and multi-phase

uid ows in complex geometries. In fact, the LBM has been successfully applied to di erent problem s in uid dynamics and the interest on the method has grown rapidly in recent years. The LBM is particularly suited for complex geometries and interfacial dynamics, and its initial applications included transport in porous media, multiphase and multicom ponent uid ows [1]. It was then adapted by Ladd and others to simulate particle-uid suspensions [2]. It has also been applied to high Reynolds number incompressible ow s and turbulence, and the implementation of therm al and compressible schemes is being actively pursued  $[\beta]$ . One advantage of the LBM is that data communications between nodes is always local, which makes the method extremely e cient for large-scale, massively-parallel computations (see Ref. [4] for an interesting discussion on the LBM capabilities compared to the existing continuum -based computational uid dynam ics m ethods). A nother property of the LBM that has lately attracted considerable attention is the microscopic origin of its mesoscopic kinetic equations, which could therefore readily incorporate molecular level interactions. This makes the LBM very compelling form icroscale uid dynamics in micro uidic devices [5] which typically present non-continuum and surface-dom inated e ects (e.g. high K nudsen number conditions, electrokinetic and wetting phenomena). This microscopic based approach also makes the LBM a good candidate for hybrid, multi-scale simulations of uid ows.

In contrast, the extension of the LBM to non-Newtonian uids has received limited attention so far, in spite of the fact that a reliable extension to the LBM to simulate non-Newtonian ows would be very valuable; for instance, in studies of transport in geological porous media, an area in which the LBM has been extensively applied [6, 7, 8] due to its simple implementation in complex geometries, In addition to geological systems, the ow of non-Newtonian uids is commonly found in many areas of science and technology.

In this work, we study an ad hoc modi cation of the LBM, rst introduced by A haronov and R othm an [9], in which the local value of the viscosity depends on the strain-rate tensor. We show that this modi cation to the LBM accurately describes the ow of truncated powerlaw uids, both shear-thinning and shear-thickening, not only in unidirectional ows (parallel

plates geom etry) but also in two-dimensional owswith simultaneous shear components in more than one direction (reentrant corner geom etry).

## II. LATTICE-BOLTZMANN METHOD

The LBM can be viewed as an implementation of the Boltzmann equation on a discrete lattice and for a discrete set of velocity distribution functions [10],

where  $f_i$  is the particle velocity distribution function along the ith direction, i(f(x;t)) is the collision operator which takes into account the rate of change in the distribution function due to collisions, x and t are the space and time steps discretization, respectively [1]. Then, the density and momentum density u are given by the rst two moments of the distribution functions,

where we assumed that the discretization is consistent with the Boltzm ann equation,  $x + e_i$  corresponding to the nearest neighbors of the point x. Note that in the previous equation, and in the rem inder of the article, all quantities are rendered dimensionless using x and t as the characteristic space and time scales, respectively. A loo note that, as we are concerned with incompressible ows, we do not need to introduce a dimension of mass.

A. BGK Approximation

A ssum ing that the system is close to equilibrium the collision operator is typically linearized about a local equilibrium distribution function,  $f_i^{eq}$ , and assum ing further that the local particle distribution relaxes to equilibrium with a single characteristic (relaxation) time , we arrive at the Bhatnagar, G ross and K rook (BGK) approximation of the LBM [1],

where the relaxation time is directly related to the kinematic viscosity of the uid, =  $(2 \quad 1)=6$ .

#### B. Non-Newtonian ows

The ad hoc extension of the LBM proposed by Aharonov and Rothm an [9] to simulate non-Newtonian uids consists of determining the value of the relaxation time locally, in such a way that the desired local value of the viscosity is recovered. The viscosity is related to the local rate-of-strain through the constitutive equation for the stress tensor. A com m only used m odelofnon-N ew tonian uids is the generalized N ew tonian m odel, in w hich the relation between the stress tensor,  $_{ij}$ , and the rate-of-strain tensor, D  $_{ij}$ , is similar to that for Newtonian uids,  $_{ij} = 2 D_{ij}$ , but with a function of the invariants of the local rate-of-strain tensor, =  $(D_{ij})$ . In particular, we are interested in a widely used model: the power-law expression [11],  $= m_{n-1}^{n-1}$ , where n > 0 is a constant characterizing the uid. The case n < 1 correspond to shear-thinning (pseudoplastic) uids, whereas n > 1correspond to shear-thickening (dilatant) uids, and n = 1 recovers the N ew tonian behavior. Them agnitude of the local shear rate \_is related to the second invariant of the rate-of-strain tensor,  $\_= p \frac{p}{D_{ij}D_{ij}}$ , where the components of the rate-of-strain tensor,  $D_{ij}$ , are computed locally from the velocity eld. In particular, after obtaining the instantaneous velocity eld from the LBM we then compute D<sub>ij</sub> from a rst-order nite-di erence approximation to the bcalderivatives of the velocity.

However, there is an obvious obstacle to a direct in plementation of the power-law uid in the LBM, in that the elective viscosity diverges for zero shear rates (\_= 0) in a shear-thinning uid (n < 1). Analogously, the viscosity becomes zero for a shear-thickening uid at zero shear rates. In previous studies it is not clear how this problem was avoided.

C learly, both lim its are unphysical and, in fact, it is known that m any non-N ew tonian uids exhibit a power-law behavior only in som e range of shear-rates, and a constant viscosity is observed outside that range [11]. Here, we used the simplest m odel of such uids: the truncated power-law m odel,

Using the truncated power-law model has an additional advantage in the LBM. It is well known that the LBM can accurately simulate viscous ows only in a limited range of kinematic viscosities. The method becomes unstable for relaxation times close to > 1=2

[12] (sm all kinem atic viscosities, < 0.001) and its accuracy is very poor for > 1 [13] (relatively large kinem atic viscosities, > 1=6). Therefore, we set the lower and upper saturation values of the kinem atic viscosity in Eq. (4) to  $_{m in} = 0.001$  and  $_{m ax} = 0.1$ . It is clear that the maximum value of the viscosity corresponds to the value at zero shear rate for shear-thinning uids (n < 1), whereas the opposite is true for shear-thickening materials (n > 1). Note that setting the value of the maximum model viscosity to  $_{m ax} = 0.1$  for a given maximum uid viscosity  $_{m ax}^{2}$  and a spatial resolution x simply corresponds to choosing a particular value of the time step in order to satisfy,  $_{m ax}^{2} = _{m ax}$  ( $x^{2} = t$ ) [4]. Since the kinem atic viscosity scales with  $x^{2} = t$ , to keep the dimensionless viscosity constant we shall rescale t according to the previous relationship when we increase the number of lattice nodes N, that is, since x / 1=N then  $t / 1=N^{2}$ . In what follow we use the three-dimensional (face-centered-hypercubic) FCHC-projection model of the LBM with 19 velocities (D 3Q 19 follow ing the notation in Ref. [14]).

### III. FLOW BETW EEN PARALLEL PLATES

We ist test the proposed LBM for non-Newtonian ows in a simple unidirectional ow, the ow between two parallel plates separated a distance b in the z-direction (Hele-Shaw cell) in the presence of a pressure gradient in the x-direction. We use periodic boundary conditions in both x and y directions. The resulting ow eld is unidirectional, with y(z)the only non-zero velocity component, the rate-of-strain is a scalar function of the local velocity, \_=  $jlv_x=dzj$  and the N avier-Stokes equations are greatly simplied [15].

In order to compute the exact solution to the N avier-Stokes equations for a pressure driven ow of a truncated power-law uid in the Hele-Shaw geometry we split the system into (in principle) three di erent regions. We shall describe the regions between z = 0 and z = b=2and the analogous regions for z > b=2 follow by symmetry. The nst region we consider is the high-shear rate region close to the walls, Region H for  $z < z_h$ , in which the shear rate exceeds \_1, and the uid is Newtonian with elective kinematic viscosity  $_1 = m _1^{(n-1)}$ ; the second one is the intermediate region in which the uid behaves as a power law according to Eq. (4), Region I for  $z_h < z < z_1$ ; and the last one is the low-shear rate region close to the center of the channel, Region L for  $z_1 < z < b=2$ , in which the shear rate is lower than \_0 and the uid is again Newtonian, but with kinematic viscosity  $_0 = m _0^{(n-1)}$ . M atching then




FIG.1: Comparison between a Lattice-Boltzm ann sin ulation and the analytical solution for the ow between two parallel plates separated a distance b = 10. The power-law exponent of the uid is n = 0.50 (shear-thinning). The pressure gradient is  $r P = 6 \ 10^{-6}$ , = 1,  $_0 = 0.1$ ,  $_1 = 0.001$ ,  $m = 10^{-3}$ , and N = 400. The circles correspond to the Lattice-Boltzm ann sin ulations. The solid line corresponds to the analytical solution given by Eq. (5). A lso show n, in dashed lines, are the continuation of the New tonian and Power-Law solutions outside their regions of applicability. The vertical, dashed lines correspond to the transition points,  $z_1$  and  $z_1 = b \ z_1$ , between the low shear-rate region L, and the region of interm ediate shear rates, I.

the solution obtained in each region with the conditions of continuity in the velocity and the stress, we obtain the general solution to the problem , in terms of the pressure gradient G = r P,

with the constants  $_1$  and  $_2$  given by,

and the transition points,  $z_h$  and  $z_l$ ,

C learly, the number of regions that coexist will depend on the magnitude of the imposed pressure gradient G. For very small pressure gradients, G 1, both  $z_h$  and  $z_1$  become negative (see the previous equation), which means that shear rates are smaller than \_\_\_\_\_\_ across the entire gap and only Region L exists. As G increases, there is a range of pressure gradients,  $m_{-0}^{n} < (b=2)G < m_{-1}^{n}$ , for which  $z_1 > 0$  but  $z_h < 0$ , and therefore regions L and I coexist. Finally, for  $G > (2=b)m_{-1}^{n}$  we obtain  $z_h > 0$ , and all three regions are present in the ow. Note that for large values of G both transition points converge to the center of the cell,  $z_1; z_h ! b=2$ . Thus, Eq. (7) allows us to choose the appropriate value of G in order to investigate the di erent regimes.




FIG.2: C on parison between a Lattice-Boltzm ann sin ulation and the analytical solution for the ow between two parallel plates separated a distance b = 10. The power-law exponent of the uid is n = 2.00 (shear-thickening). The pressure gradient is r P = 5 10<sup>6</sup>, = 1,  $_0 = 0.001$ ,  $_1 = 0.1$ ,  $m = 10^3$ , and N = 400. The circles correspond to the Lattice-Boltzm ann simulations and the solid line corresponds to the analytical solution given by Eq. (5). The vertical dashed lines correspond to the transition points,  $z_1$  and  $z_1 = b$   $z_1$ , between the low shear-rate region L and the interm ediate shear rates region I.

We performed a large number of simulations for dimensional event values of the power-law exponent n. Specifically, we consider two shear-thinning uids, n = 0.50 and n = 0.75, and two shear-thickening uids, n = 1.25 and n = 2.00. In all cases we performed simulations for two dimensional dimensional dimensional dimensional forcing: one for which the region of low shear rates L is important, that is relatively small pressure gradients for which  $z_1$  b=4; and a second one in which the uid behaves as a power-law uid alm ost in the entire gap, that is z = 2.1 In both cases the shear-rate does not exceeds  $_1$ . In Fig.1 we present a comparison between the Lattice-Boltzm ann results and the analytical solution given in Eq. (5) for a shear-thinning

uid with power-law exponent n = 0.50. The simulation corresponds to a relatively small pressure gradient for which the region of small shear-rates is large,  $z_1$  b=4. Both regions, Region L in which the uid behaves as a Newtonian one, and Region I in which the e ective viscosity is a power-law, are shown. The agreem ent with the analytical solution is excellent, with relative error close to 0.1%. In Fig. 2 we present a similar comparison between the

LBM and the analytical solution, but for a shear-thickening uid (n = 2.00) which behaves as a power-law uid across alm ost the entire channel. A gain the agreem ent is excellent with relative error sm aller than 0.1%.

Finally, for each of these cases we run a series of simulations in which the number of lattice nodes, N, in the direction of the gap was increased from 10 to 400, and computed the relative error of the LBM results compared to the analytical solutions, de ned as  $P_{i=1}^{N}$  (1  $v_i^{\text{LBM}} = v_i^{\text{Anal:}}$ )<sup>2</sup>. In order to obtain the accuracy of the LBM as a function of the number of nodes, we simulated the same physical problem but changed x from 1 to 0:025. In addition,




FIG.3: Relative error of the LBM compared to the analytical solution for the ow between parallel plates, as a function of the number of lattice points used in the simulations. The points correspond to simulations with the LBM for four di erent uids, two shear-thinning uids (n = 0.50 and n = 0.75) and two shear-thickening uids (n = 1.25 and n = 2.00). For all uids we also present results corresponding to two di erent regimes: one at high pressure gradients, in which the low – shear-rates region, region L, is small (Power-Law) and the other one at interm ediate pressure gradients in which both regions L and I are comparable (note that with the exception of n = 0.75 both regimes give alm ost exactly the same relative error and, in fact, the corresponding points overlap alm ost entirely). In all cases, we increased the lattice resolution until the relative error was on the order of 0.1%. The solid line shows the general trend of the data, 1=N.

since the accuracy of the LBM depends on the model viscosity, we also changed taccording to  $t = x^2$ , so that the model viscosity remains the same, independent of the number of nodes. Then, in order to compare the velocity eld always at the same physical time since startup, the number of time steps was increased inversely proportional to t (reaching 10<sup>6</sup>)

In Fig. 3 we present that, in all cases, the relative error decreases, approximately as 1=N, as the number of nodes is increased, and eventually becomes of the order of 0.1% (an arbitrary target accuracy that we set for our simulations). The error was found to be independent of the pressure gradient, or the size of the non-New tonian region I, but strongly depends on the power-law exponent. In particular, the relative error seems to increase as the magnitude of  $(1 \ n)=n$  increases, with the error in the New tonian case (n = 1) decaying faster than 1=N. This is probably related to the rst-order nite-dimensional approximation used to compute the spatial derivatives of the undivelocity which determine the local viscosity through Eq. (4). It would then be possible to improve the accuracy of the method by in plementing a higher order approximation of the local shear-rates.

### IV. REENTRANT CORNER FLOW




FIG. 4: Stream lines in the reentrant ow geometry. The ow direction is shown at the center of the channel. Note the asymmetry due to inertia e ects. The dashed lines show the lines in which we compare the solutions of the LBM method with the solutions obtained by nite-element calculations.

In the previous section we tested the LBM for non-Newtonian uids in a Hele-Shaw geom etry and found excellent agreement with the analytical solutions as the number of nodes was increased. In that case, the ow is unidirectional and therefore the shear-rate is a scalar, which is a rather simple type of ow. In contrast, we shall now test the LBM in a m ore demanding geometry, that is the reentrant corner geometry sketched in Fig. 4. In this case, the shear-rate is no longer a scalar as in the Hele-Shaw geometry and, in addition, the presence of two singular points, located at the entrant and reentrant corners (see Fig. 4), requires high accuracy in order to obtain satisfactory stress resolution near these points (although no analog to the M o att's analysis near the corner is available for non-New tonian

uids, it is believed that not-integrable stress singularities develop in this case, and numerical techniques do not always converge [16]). Motivated by these issues we simulated the ow in the reentrant corner geometry using the LBM for a shear-thinning uid with power-law exponent n = 0.50. In Fig. 4 we present the stream lines corresponding to the computed velocity eld, obtained for a pressure gradient  $r P = 10^5$ , where the recirculation region inside the cavity can be observed (note that the separation between stream lines was chosen for visualization purposes only and it is not related to the local ow rate, since them agnitude of the uid velocity sharply decays inside the cavity). The corresponding R eynolds number is Re = 4, computed with the maximum viscosity,  $_0$ , and the measured mean velocity. In




FIG.5: Contour-plot of the local magnitude of the shear-rate, as computed with the LBM. The low est level of the plot corresponds to  $_{0}$ , that is the uid behaves as New tonian in those regions. High shear-rates, and accordingly high shear-stresses are localized at the entrant and reentrant corners.

fact, the stream lines shown in Fig. 4 are fore-aft asymmetric, due to inertia e ects, which are absent in low-Reynolds-number ows. We also computed the local magnitude of the shear-rate, related to the local stress eld through the constitutive relation given by Eq. (4). In Fig. 5 we present a contour plot of the magnitude of the shear-rate in the reentrant corner geometry with the lowest level in the contour plot corresponding to  $_0$ . It can be seen that the uid is New tonian in small regions at the center of the channel and inside the recirculation region. It is also clear that, as discussed before, both the entrant and reentrant corners are singular points where the shear-rate increases to its highest values in the system.

Finally, in order to perform a more quantitative test of the LBM, we solved the problem




FIG. 6: Velocity component along the channel,  $u_x$ , plotted in a line perpendicular to the ow (dashed line X = 20 in Fig. 4). We compare the results of the nite-element calculations (solid line) with the results of the LBM (points) for di erent lattice resolutions. In the inset we plot the velocity pro le inside the recirculation region.




FIG.7: Velocity component perpendicular to the ow direction,  $u_y$ , plotted in a line parallel to the ow and close to the top wall of the channel (dashed line Y = 16 in Fig. 4). We compare the results of the nite-element calculations (solid line) with the results of the LBM (points) for di erent lattice resolutions.

numerically using the nite-element commercial software FIDAP (Fluent Inc.). In Figs. 6 and 7 we compare the solutions obtained with the LBM for diment resolutions, ranging from N = 40 40 to N = 320 320, with the nite-element results obtained with FIDAP. The comparison is made along two lines, one oriented along the ow direction (dashed line at Y = 16 in Fig. 4) and a second one oriented in the perpendicular direction (dashed line at X = 20 in Fig. 4). In Fig. 6 we compare the velocity along the channel,  $u_x$ , in the line perpendicular to x that is located at the center of the system (X = 20, see Fig. 4). A velocity pro le similar to that in a Hele-Shaw cell is observed for 0 < y < 20, as well as the recirculation ow inside the cavity (see the inset). In Fig. 7 we plot the velocity in the

vertical direction,  $u_y$ , along a horizontal line close to the upper wall of the channel (Y = 16, see Fig. 4). It is clear that there is some uid penetration into the cavity (entrant ow) in the rst half of the channel and some reentrant ow in the second half (note that, as mentioned before, the ow is not symmetric about x = 20 due to inertia e ects). In both cases we found an excellent agreem ent between the two methods, and the agreem ent clearly improved as the number of lattice nodes was increased in the LBM (the number of elements in the nite-element computations was xed to 100 100).

# V. CONCLUSIONS

We have extensively tested an ad hoc modi cation of the Lattice-Boltzm ann M ethod that extends its use to G eneralized N ewtonian uids, in which the non-N ewtonian character of the uids is modelled as an elective viscosity. Speci cally, we calculated the accuracy of the m ethod for Truncated Power-Law uids and showed that the relative error decays (linearly) as the resolution of the lattice (number of lattice points) is increased. The error was computed directly from the analytical solutions of the problem. The same trend was observed for both shear-thinning (n < 1) and shear-thickening (n > 1) uids, as well as for interm ediate and high shear-rates. In all cases the relative error was of the order of 0:1% for the highest resolution employed. Finally, we also tested the m ethod in the reentrant ow geom etry and showed that it is in excellent agreem ent with the solution obtained by m eans

of nite-element calculations. Again, the accuracy of the method was shown to increase with the number of lattice points.
