On the Lim its of Analogy Between Self-A voidance and Topology-D riven Swelling of Polymer Loops

The work addresses the analogy between trivial knotting and excluded volum e in looped polymer chains ofm oderate length, N < N₀, where the elects of knotting are small. A simple expression for the swelling seen in trivially knotted loops is described and shown to agree with simulation data. Contrast between this expression and the well known expression for excluded volum e polymers leads to a graphical mapping of excluded volum e to trivial knots, which may be useful for understanding where the analogy between the two physical forms is valid. The work also includes description of a new method for the computational generation of polymer loops via conditional probability. A lthough computationally intensive, this method generates loops without statistical bias, and thus is preferable to other loop generation routines in the region N < N₀.

I. IN TRODUCTION : FORM ULATION OF THE PROBLEM

The last few years have seen signi cant work addressing the e ects of knotting on boped polymer chains. Of interest to mathematicians and physicists for good part of nineteenth and most of the twentieth centuries, knots were rst seen by W. Thom son as a way to understand the nature of atom s [1], and more recently as the basis for string theory. On the biological front, knots have been observed in, [2, 3], and tied into, [4, 5], strands of DNA. A dditionally, topoisom erases - proteins which act to alter the topological state of DNA - are quite common and play a signi cant role in cellular processes.

The requirem ents a knot im poses on a strand are hard to form ulate in a simple way, as \interactions" between neighboring strands can require highly non-local changes in the coil's conform ation to maintain topological state.

That said, the most obvious e ect knotting has on a loop is in the size, commonly measured in terms of radius of gyration, R_{g}^{2} . For instance, the loop topologically equivalent to a circle, called a trivial or 01 knot in professional parlance, is on average larger than the loop of the sam e length with any other topology. In other words, a trivial bop is larger than the phantom loop, the latter representing topology-blind average over all loops of a certain length: R_g^2 triv > R_g^2 phantom . This topologydriven swelling is operational even for very thin polymers, in the limit when volume exclusion has no e ect on polymer coil size. In this case, the phantom loop's size (which is, once again, average over all topologies) scales as N $^{1=2}$, while the trivial loop is larger not merely because of a larger prefactor, but because of a larger scaling exponent, its size scales as N , where > 1=2. The conjecture, form ulated a long time ago [6], supported by further scaling argum ents [7, 8], and consistent with recent simulation data [9, 10, 11], speci es that the scaling exponent describing topology-driven swelling of a trivial bop is exactly the sam e as the F bry exponent [12], which describes swelling driven by the self-avoidance (or excluded volum e): 0:589 3=5.

Equality of scaling exponents for the two cases re ects the similarity of fractal properties for these systems at very large N 1, because topological constraints result in self-avoidance of blobs on all length scales above a certain threshold [8]. As we understand much about self-avoidance [13], and next to nothing about knots, we would like to exploit the analogy to see if it yields any insights into knots. Speci cally, it is tem pting to look at the dependence of the unknotted loop size, R_{g}^{2} triv, on the num ber of segments, N, not only in the asymptotic scaling regime of very large N, but also the corrections to scaling at not-so-large N . This is particularly important from a practical standpoint, because the asymptotic scaling lim it is barely accessible computationally, and what one really computes is the value of $R_{g}^{2}_{triv}$ at rather m oderate N . System atic com parison of N -dependencies of R_{α}^{2} for (trivial) knots and self-avoiding polymers over the wide range of N is the goal of this paper.

We show that although large N scaling appears to be identical for trivial knots and excluded volum e polymers, their respective approach to the asymptotic regime is different. This points obviously to the limited character of the analogy between the twom echanisms of swelling, due to volume exclusion and due to topological constraints.

The plan of the paper is as follows. We start from a brief sum m ary of the m ain results for self-avoiding polymers. Although these results are widely known, we restate them in the form most suitable for our purposes. Next, we present some heuristic analytical arguments to shed light on why trivial knots may behave di erently then their excluded volume counterparts. With this insight in m ind, we present our detailed com putational data on the N -dependence of $R_{g\ triv}^2$ over the wide range of N. To obtain data with the necessary degree of accuracy, it is necessary to make sure that our m ethod of generating loops is ergodic and unbiased. A 1though this aspect is of decisive in portance, it is purely technical, and thus it is relegated to the Appendix. Up to about section IIC we mostly review the known results, starting from section IID, we present our new ndinas.

II. PRELIM INARY CONSIDERATIONS

A. Swelling driven by self-avoidance: an overview

To make our work self-contained we now o er a brief review of the results for the scaling of excluded volum e polymers (see further details in [13, 14, 15]). We should emphasize from the beginning that the main properties of the excluded volum e polymer are valid also for bops [16]. The simplest model for excluded volume is a system in which N beads, each of volume b, are placed along a bop with mean separation `. All other forms of excluded volume, e.g. freely jointed sti rods, worm-like laments, etc., can be mapped to this simple rod-bead

m odel (see e.g., [14]). There are two scaling regimes, with

In term s of N , the mean squared gyration radius R_g^2 can be written as $R_g^2 = \sqrt{2}N$ (z), where the swelling factor depends on the single variable $z = \frac{p}{N-N}$. For classical polymer applications, the large z regime is most interesting. (z) has a branch point singularity in in n-ity, its large z asymptotics are dominated by the factor z^2 ¹; however, if we write (z) = z^2 ¹ (z), then (z) is analytical in in nity and can be expanded in integer powers of 1=z. A ccordingly, the large N asymptotics of R_g^2 follow :

Conversely, in the region N N, the approximation for R_g^2 is a orded by the fact that (z) is analytical at small z and can be expanded in integer powers of z:

where prefactor A^0 should be equal to unity (which explains why we did not absorb the factor of 1=12 into A^0). Note that the latter result is an interm ediate asym ptotics, which m eans the corresponding region exists only so long as N 1 is large, which m eans excluded volum e is su ciently sm all.

B. Swelling driven by topology: cross-over length

W ith this brief sum m ary of results in m ind we now set forward, intending to system atically compare the computational results for the behavior of trivial knots to the well-understood polymer with excluded volume.

To bok at the analogy between self-avoiding polymers and trivial knots, it is useful to start, [3], by identifying the cross-over length for knots, an analog of N (1), which we call N₀. For knots, it is natural to identify the cross-over value of N with the so-called characteristic length of random knotting, N₀; the latter quantity is known as the characteristic length of the exponential decay of probability, w_{triv} (N), of form ation of a trivial knot upon random closure of the polymer ends [17]: w_{triv} ' exp(N=N₀). Depending on the speci cs of the m odel used, [11, 17, 18], the critical length varies subtly around N₀ 300. It is also clear qualitatively [3] and seen computationally [11] that this N₀ is about the length at which topological e ect on loop swelling crosses over from marginality at N < N₀ to signi cance at N > N₀. In particular, it is at N > N₀ that the trivial knot begins to swell noticeably beyond the size of the phantom polym er [11].

C . Swelling driven by topology: above the cross-over

A number of groups reported observation of the power

3=5 in the scaling of trivial [9, 10, 11, 19] and other topologically simple [9, 10, 11] knots in the region N $\,>\,$ N $_0$.

In the works [9, 10, 20], following the idea suggested in [22], the N dependence of $R_g^2_{triv}$ was tted to the formula similar to equation (2) for self-avoiding polymers. No attempt was made at physical interpretation of the best tvalues of the three coe cients (A, k_1 , k_2) or the region of N where the twas examined. In this sense,

tting with equation (2) was only used as an instrument to nd the scaling exponent , which in these works was found to be strikingly consistent with the expected value of the self-avoidance exponent. A puzzling aspect of the situation is that, particularly in the work [10], the data was t to equation (2) not only in the region N > N₀, but across the crossover, starting from about N₀=3 to about $3N_0$ (see also [20]).

At present we are aware of no studies which provide a detailed com parison of excluded volum e and trivial knotting at modest N < N₀. Seeking to further appraise the analogy between trivial knotting and excluded volume, in the present work we address the two systems in the region below their respective crossovers.

D. Swelling driven by topology: below the cross-over

Formula (3) is the result of perturbation theory [15], in which conform ations with overlapping segments represent a sm allpart of conform ational space and their exclusion is considered a sm all correction to G aussian statistics. It is tempting to try a similar approach for knots. The idea would be to note that at small N $< N_0$, the probability of a non-trivial knot is small, which implies that restricting the loop such that it remains a trivial knot excludes only a small sector of the conformation space which therefore, comprises a small correction to Gaussian statistics.

Let us try to imagine the realization of this idea. We want to nd the swelling ratio of the trivial loop:

We know that the (topology blind) ensem ble average over all knots must, by de nition, yield unity for the swelling ratio:

where P_i and i are, respectively, the probability and swelling ratio of the knot i. Our plan is to consider formula (5) as the equation from which we can determ ine the quantity of interest, 0_1 :

To this point our consideration is exact, but now we switch to hand waving argum ents and guesses justi ed by the simulation data. In the range of sm all N, the ensem ble of loops consists mostly of 01 knots, perturbed slightly by the presence of 3_1 and higher-order or m ore complex knots. We consider then $N = N_0$ as a small parameter: 1. Of course, in the case of excluded volume, N =N ₀ the sim ilar lim it is better justi ed, because N , equation (1), can at least in principle, be arbitrarily large, leaving room for the interm ediate asymptotics 1 Ν N.In the case of knots, N $_{0}$ is as large as about 300, but so far we do not know why it is large, and it seems beyond our control to make it larger. A coordingly, we cannot speak of an interm ediate asymptotics in a mathematically rigorous way [23]. Nevertheless, we assume here that the num erically large value of N $_0$ allows us hope that the asym ptotic argum ent is possible, and so we assum e that




FIG.1: Fractional abundance of 0_1 , 3_1 , and 4_1 knots within the ensemble of all looped polymer chains of xed steplength. The 0_1 abundance follows the well known, β , 17, 18], exponential decay, A exp ($N = N_0$) with decay length $N_0 = 255$ and prefactor A 1:05. Pertinent to the notion of higherorder knots acting as a perturbation is that the abundance of 3_1 and 4_1 knots, seen in the inset, is quite low in the N N₀ region.

 $N = N_0$ is a small parameter. We guess then that higher order knots provide only higher order perturbation corrections with respect to this parameter, and we neglect their contributions, sim plifying the ensemble by accounting for only 0_1 and 3_1 knots. In this case, $P_{0_1} + P_{3_1} / 1$. This is justi ed by the data presented in Figure 1, which shows that higher knots are very rare indeed. Since we know that P_{0_1} ' exp(N=N_0), we can also nd P_{3_1} . G iven that we consider the N = N_0 1 regime, we must also linearize the exponent, which yields:

The next step requires thinking about 31. In principle, we can come up with a chain of equations, not unlike the BBGKI chain in the theory of uids, expressing 3, in terms of higher knots, etc. A more practical course is to note that for the lowest order in perturbation, with respect to the supposedly sm all parameter $N = N_0$, since 3, has already the small ($N = N_0$) coe cient in front of it, it is enough to replace $_{3_1}$ with a constant at N = N $_0$! 0. Thus, to the lowest order in N = N $_0$ 1we get $(N = N_0)_{3_1}$ ' $(N = N_0)c$, where c is a constant. We therefore nally obtain

The di erence between equations (3) and (9) is immediately obvious: the form er is an expansion in powers of N, the latter starts from the rst power of N. The N term does not occur in our expansion for knots. Note that the values of the k_i^0 coe cients in equation (3) are known [15], and this prevents the easy (and incorrect) explanation that $k_1^0 = 0$. As regards the value of coe cient c, we do not have at present an analytical means to calculate it, we will later estim ate it based on the simulation data. Thus, despite identical scaling index at large N, trivially knotted and excluded volum e polym ers exhibit. a very di erent mathematical structure of N-dependence in their respective gyration radii in the region of sm allN .

It is possible that another manifestation of the same di erence is the fact that data in the work [10] were successfully tted to the equation (2) across the crossover region, where this form ula for the self-avoiding polymers is not supposed to work.

Thus, our considerations suggest that there is some fundamental di erence between topology and selfavoidance in terms of their respective e ects on the swelling at moderate N . In what follows, we present computational tests supporting and further developing this conclusion.

III. MODEL AND SIMULATION METHODS

W e modelpolymer bops as a set of N + 1 vertices, x_i , embedded in 3D, where $x_0 = x_N$ implies bop closure. The step between successive vertices, $y_i = x_{i+1}$ x_i is constructed either from steps of xed length, with probability density

or Gaussian distributed, with probability density

Note that ', the \average" steplength, is de ned, $^{3} = P(y)y^{2}d^{3}y$. M any m ethods have been used to generate loops in computer simulation over the past decade. A brief review of the m ethods is available in Appendix A, the details of the m ethod im plem ented in this work are presented in Appendix B.

O noe generated, we asses the loop's size by calculating its radius of gyration

The mean square average radius of gyration seen over all loops is, $R_g^2 = \frac{1}{12} (N +) l^2$, where = 1 for xed steplength loops and = 1=N for loops of gaussian distributed steplength. Noting that the excluded volume constraint is maintained by the condition that pair distances be larger than excluded volume bead diam eter, $r_{ij} = j x_i \quad x_j j r_{ij}$ d, we record the minimum r_{ij} for

swelling beyond average gyration radius of fixed-steplength loops




FIG. 2: Direct comparison of excluded volume and trivial knot swelling, $_{0_1}$, beyond the phantom average size for bops of xed step length. Excluded volume is form ulated in term s of N beads of diameter d, each centered at an universal joint between bop segments. Exclusion is maintained by prohibiting bead overlap, $jx_1 = x_j j$ d for all if j. As discussed in Section IID, and in contrast to the region above their respective crossovers, in the small N < N₀ regime, trivial knots follow a functional form dimension that of excluded volume bops.

each coil, which enables us to ascertain what maximum diam eter of excluded volume, d, the loop corresponds to, [24]. Finally, we calculate the topological state of the loop by computing the A lexander determ inant, (1), and Vassiliev knot invariants of degree 2 and 3, v2 and v3, the implementation of which is described in [25]. As the simulation progresses, averages are accumulated in a matrix, indexed over di erent knot types and minimum pair distances. In the end, we can collect the data to nd the gyration radius for either a particular knot type irrespective of pair distances (i.e., without volum e exclusion), or for a particular excluded volum e value irrespective of topology.

IV. RESULTS

A. On the functional form of N -dependence of the gyration radius in the moderate N regime

Figure 2 provides direct comparison of the computationally determ ined m ean square gyration radius for trivial knots and phantom loops with excluded volum e (averaged over all topologies), in the latter case - for various values of the bead diam eter. Note that in the gure, the gyration radius is expressed with the swelling ratio , as de ned in equation (6). The most striking feature of this gure is the di erently shaped curves of swelling. The region of intermediate N visible in the gure, $1 < N < N_0$, show s the plot of trivial knot swelling passing through all excluded volum e curves. As seen, the very shape of the $_{0_1}$ curve is di erent. Speci cally, all curves for the excluded volum e loops are bent downwards, consistent




FIG. 3: A verage gyration radius data for trivially knotted loops of xed steplength. Loops were generated with the conditional probability method described in the appendix. Swelling of the gyration radius is seen to be linear in the small N regime and can be understood initially as the result of a perturbation.

with the presence of the $\frac{P_{N}}{N}$ terms in equation (3). In contrast, the curve for the topologically restricted trivial loop is very nicely linear. A tof the form

consistent our estimate, equation (9), where N₀ = 255, is shown in Figure 3. Note that deviation from the linear form occurs as N increases. This is entirely expected as the crossover to asymptotic swelling of the gyration radius, N² = N N^{0:19}, must occur as N grows beyond N₀.

B. W hich excluded volume diameter matches most closely the topological swelling of trivial knots?




FIG.4: The excluded volum e bead diam eter which gives the same hR_g^2 is welling as the group of trivially knotted loops. Unlike other gures in the publication, loops here are generated conditionally with gaussian distributed step length. This is done for feasibility reasons, as computationally, gaussian-distributed steps are easier to generate than loops of xed step length. As seen in the image, the excluded volum e diameter seem s to saturate at about d = 0:1625. This saturation is consistent with the notion of the trivial knot gyration radius average approaching the N² asymptotic when N N₀. A lthough not tested, we expect that xed step length loops would exhibit similar saturation at a speci c excluded volum e diameter.

The cross-overpoints between curves of trivially knotted loops and loops with excluded volum e in Figure 2 inspired the idea of plotting the excluded volum e diam – eter at each N whose swelling m atches the swelling of a trivial knot at the same N . As seen in Figure 4 this m apping parameter seems to approach an asymptote at the speci c diameter of d = 0.1625. W hile at present it is not computationally feasible to extend the scale of N to signi cantly larger values, this asymptotic approach of trivial knot swelling to loops with excluded volum e is consistent with the sim ilar asymptotic swelling of N² seen in other work [9, 10, 11].

At the same time, it is interesting to note that although the swelling parameter due to the excluded volume at d 0:16 seems to t the topologically driven swelling, the corresponding characteristic length N (see (1)) is signi cantly larger than N₀. To see this, we note that the excluded volume data in pgure 2 treasonably well to the expression $1 + 1:71 \text{ N} (d=')^3 = 1 + \frac{1}{N} = N$, where, therefore, N = 0:34 (d=')⁶. Here, we determ ined,

excluded volume bead diameter matching trivial knot swelling at given N

based on the t, the numerical coe cient intentionally left undeterm ined in form ula (1). At d = 0:16', we get, therefore, N 20000, which is almost two orders of m agnitude greater than N₀ 255. A lternatively this situation can be seen by nding the excluded volume diameter forwhich crossover length N m atches N₀: N = N₀; the corresponding d equals d 0:33'. It is fairly obvious that this value of excluded volume does not agree well with the data presented in gure 4. This discrepancy possibly points at yet another di erence between swelling driven by topology and excluded volume.

V. CONCLUSIONS

It seems quite clear from our simulation data that the analogy between excluded volume and trivial knotting does not hold at loop sizes smaller than the crossover for knots, N₀. The nature of the swelling function, (N), in this region is yet unknown. A lthough our cursory explanation accounts for the trivial knot data's linear trend in this regime, the similar parameter for the size ofm ore complex knots behaves non-linearly, and we currently have no explanation for this. A more system atic treatment of the problem is badly needed to understand the size behavior of knots.

That said, our data showing the mapping of excluded volume diameter to trivial knot size seems to reinforce the notion that asymptotically, the two classes of objects scale with the same power.

APPENDIX A: A BRIEF REVIEW OF LOOP GENERATION METHODS

A number of methods exist and have been used in the literature for the computational generation of looped polymers. The goal of generation methods is to produce statistically representative and unbiased sets of mutually uncorrelated loops. The generation of a random walk is a simple matter. Steps are chosen with isotropic probability until the desired length is reached. Creating random walks with biased probability, speci cally, walks which return to the origin after a speci ed number of steps, is a more di cult task. A sm any studies of the topological properties of polymer chains have been completed, we do not intend to make an exhaustive sum mary of all work, but rather in broad strokes sum marize the generation methods used in the eld.

A llm ethods used to generate loops can be grouped into two large categories. M ethods of one group start from som e loop con guration which does not pretend to be random, and then transform it in som e way to random ize the set of steps m aking the loop. M ethods of the other group build m ore or less random loops from the very beginning.

O ne of the initial techniques used for the generation of bops is the dimerization method of Chen, [26, 27], in which smaller sets of walks are joined end to end to form larger walks or bops. This \R ing D in erization" accepts the joining of smaller walks with some probability, as self-intersections between the chains are prohibited. In addition, if the generated walk is closed to form a bop, a statistical weight is calculated to account for bop closure. Several groups have used this method, [17, 21], usually in the context of including excluded volume in the topological study.

O ther workers, [9, 19], start with an initial loop conform ation and then modify it by applying a number of \elbow" pivot moves on random ly selected sections of the loop. Speci cally, if the loop is de ned by N vertices, fx_ig , a pivot move is performed by selecting two vertices, x_j and x_k , and then rotating by a random angle the intermediate vertices x_{j+1} through x_{k-1} about the axis made by $x_k = x_j$.

A third m ethod in common use, the so-called $\$ hedgehog" m ethod [10, 28], starts by generating N =2 pairs of m utually opposite bond vectors. The resulting set of N vectors has zero sum, and it is tempting reshue them and then use as bond vectors, thus surely obtaining a closed loop. Unfortunately, such a loop has obviously correlated segments, the most striking manifestation of which is that the loop has self-intersections with a large probability of order unity (in fact, 1=e 0:37, [29]; see also a related scaling argument in [11]). To overcome this, D ykhne [28] suggested in agining all N vectors plotted from the origin and thus forming something like a hedgehog, and then random ly choosing pairs of vectors (hedgehog needles), and rotating the pair by a random angle about their vector sum. This operation does not change the sum of all N vectors, which remains zero, and therefore, upon su ciently many such operations and upon reshu ing all vectors, one can hope to obtain a well random ized loop.

The hedgehog method and elbow moves method are in fact quite similar. Indeed, in both cases the idea is to rotate som e bond vectors around their vector sum ; in the hedgehog m ethod it is done with pairs of vectors before reshuing, in the elbow moves method it is done after reshuing with a set of subsequent bonds, but the idea is the same. In both cases, the evolution of loop shape can be described by Rouse dynamics, known in polymerphysics (see, e.g., [14]). This allows us to make a simple estimate as to how many moves are necessary in order to wash away correlations in posed by the initial loop con guration. Rouse dynamics can be understood as di usive motion of Fourier modes. Since the longest wave Fourierm ode has wavelength which scales as N, the longest relaxation time in R ouse dynam ics scales as N 2 . This estimate is valid for physical dynamics in which all segments move at the same time. Translated into com putational language, this im plies that every m onom er has to make about N 2 m oves, which m eans that we have to m ake about N $^{\rm 3}$ random m oves for proper rem oval of correlations. Unfortunately this point is rarely mentioned in the use of these algorithms, (see how ever, [19]), and the num ber of m oves between sam pling is generally quite small, which puts into question the ergodicity of im plem entations of this algorithm .

To overcom e this problem, we proposed in [11] another m ethod which we call the m ethod of triangles, which does not involve any relaxation. In this m ethod, we generate N = 3 random ly oriented triplets of vectors with zero sum, reshu e them, and connect them head-to-tail, thus obtaining a loop. As we shall explain in another publication, this m ethod produces loops with insigni cant correlations when N is larger than a hundred or so.

Since ourm a jor attention in this article is the range of relatively sm all N, we have to resort to a computationally m ore intensive, but reliably unbiased m ethod based on conditional probabilities. The idea is to generate step number i in the loop of N steps using the conditional probability that the given step arrives to a certain point provided that after N im ore steps the walk will arrive at the origin. This m ethod was suggested and im plem ented for G aussian chains in [30]. Here, we apply it for the loops with xed step length.

Due to the complexity and computational expense of the conditional method, and noting the apparent similarity of the two curves, one might be tempted to substitute the Gaussian formulation, equation (B14), when N is above some threshold, $N > N_c$. Our own experience with this approximation leads us to discourage the intermingling of the two distributions. When included, at even the large $N_c = 30$, a sharp discontinuity in the curve of curve for $_{0_1}$ vs N (Figure (3)) was visible at N_c . We hypothesize that substitution of the Gaussian formulation, equation (B14), for the xed-step formulation, equation (B10), allows for slightly more in ated loop conformations and thus leads to a discontinuity when the approximation is used in the simulation code at $N > N_c$.




FIG. 5: This geometry is used in the implementation of the conditional probability loop generation method.

This means that a walk of N steps remains, which starts at the present location, \mathbf{x}_0 , and nishes at the starting point, \mathbf{x}_N . The probability distribution for the next step, from \mathbf{x}_0 to \mathbf{x}_1 , can then be written,

In principle one could generate new steps with probability isotropic in direction, accepting them with conditional probability de ned by equations (B15) and (B10) or (B14). In this statem ent of norm alization, the function of im portance is f (q), which de nes the way the two probability distributions are made equal.

In principle the problem is now solved. A complete set of probability distributions for walks of xed or gaussian steplength has been de ned, and the the form ula which m aps that distribution to a at, m achine-generated distribution has also been expressed. If the form of equation (B16) is simple enough, m eaning relatively sm all N, the integral equation can be solved directly for f (q). In practice how ever, N > 5 is an interesting regime and a di erent technique must be used to obtain f (q).

For the case of nishing a random walk of xed length steps, ', which is x away from the ending point, and has N steps alloted to get to that point, we use the geom – etry shown in gure (5). In this diagram x_{β} is the new distance away from the endpoint after the present step is

This expression is norm alized to 1 if integrated over appropriate x_p bounds. In most cases, those bounds are $[x \quad ';x + \ ']$, although the physical lim it on the upper bound, $x_p \quad (N \quad 1)$ is necessary to keep the walk from straying too far from the origin. A dditionally, if the walk is very close to the origin, $x < \ '$, the integration bounds, $[' + x; \ x]$, are used.

As Equation (B12) for xed steplength probability is de ned as a polynom ial, integration of that polynom ial, described by Equation (B18), can be performed exactly within simulation computer code, and the resulting equation for f (q) solved num erically. In practice we use the G nu Multiple Precision library to represent the polynom ial coe cients and values as rational num bers. From a computational standpoint this is signi cantly more expensive than representing coe cients as double oating point, but using rationals allows us to represent all outputs of the polynom ial with great accuracy, the goal of this simulation method. At a relatively small number of steps the coe cients become quite small, for example at N = 15, in the region x 2 [13;15], equation (B12) reads, $\frac{(a\ 15)^{\circ}}{40809403514880\,(^{13}d\)}$. W e feel the need in this routine to re- $(d 15)^{3}$ tain accuracy when perform ing operations such as P Ο. where P 1 and Q 1 but (P Q) P;Q. In order to retain the accuracy of the conditional form ulation it was in perative to perform this rational num ber algebra. For the interested reader we provide a table of these polynom ial coe cients as supplem entary m aterials.

I. SUPPLEM ENTARY MATERIALS

A. Polynom ial Description

In the associated work, we derive expressions for the conditional probability of a random walk, $G(d';n)_{fixed}$, with end to end distance d' from n steps of xed length '. In these supplementary materials, we present these probabilities in polynom ial form, making them computationally more accessible.

First, note that the sum indices in Equations B11 and B12 lead to a piece-wise de nition of the functions (this is seen in Equation B13). The function, G (d';n)_{fixed}, is de ned on (n+1)=2 intervals if n is odd, and n=2 intervals if n is even. All intervals span distance in d of 2, with exception of the rst interval for odd n, d 2 [0;1].

Use of a computer algebra system allows for the expansion of equation B10 into the form ,

where the set of ai coe cients are rational num bers. Note

how everthat there will be roughly n=2 such sum s for each n as described in the previous paragraph. Subsequent le elements are the $a_{n,jj,i}$ coe cients, delimited by commas, and provided as rational numbers. Coe cients are listed by a nested iteration, rst by step numbern, then by interval j, nally by polynomial index i. W ere $n_c = 3$, the lewould read:
