## Scaling in critical random Boolean networks

We derive mostly analytically the scaling behavior of the number of nonfrozen and relevant nodes in critical K au man networks (with two inputs per node) in the therm odynamic limit. By dening and analyzing a stochastic process that determines the frozen core we can prove that the mean number of nonfrozen nodes scales with the network size N as N<sup>2=3</sup>, with only N<sup>1=3</sup> nonfrozen nodes having two nonfrozen inputs. We also show the probability distributions for the numbers of these nodes. Using a dimension stochastic process, we determ ine the scaling behavior of the number of relevant nodes. Their mean number increases for large N as N<sup>1=3</sup>, and only a nite number of relevant nodes have two relevant inputs. It follows that all relevant components apart from a nite number are simple loops, and that the mean number and length of attractors increases faster than any power law with network size.

#### 1. IN TRODUCTION

Random Boolean networks are often used as generic m odels for the dynam ics of com plex system s of interacting entities, such as social and econom ic networks, neural networks, and gene or protein interaction networks [1]. The simplest and most widely studied of these models was introduced in 1969 by Kau man [2] as a model for gene regulation. The system consists of N nodes, each of which receives input from K random ly chosen other nodes. The network is updated synchronously, the state of a node at time step t being a Boolean function of the states of the K input nodes at the previous time step, 1. The Boolean updating functions are random ly ast signed to every node in the network, and together with the connectivity pattern they de ne the realization of the network. For any initial condition, the network eventually settles on a periodic attractor. Of special interest are critical networks, which lie at the boundary between a frozen phase and a chaotic phase  $[\beta, 4]$ . In the frozen phase, a perturbation at one node propagates during one tim e step on an average to less than one node, and the attractor lengths remain nite in the limit N ! 1 . In the chaotic phase, the di erence between two almost identical states increases exponentially fast, because a perturbation propagates on an average to more than one node during one time step [5].

The nodes of a critical network can be classi ed according to their dynam ics on an attractor. First, there are nodes that are frozen on the same value on every attractor. Such nodes give a constant input to other nodes and are otherwise irrelevant. They form the frozen core of the network. Second, there are nodes whose outputs go only to irrelevant nodes. Though they may uctuate, they are also classi ed as irrelevant since they act only as slaves to the nodes determ ining the attractor period. Third, the relevant nodes are the nodes whose state is not constant and that control at least one relevant node. These nodes determ ine com pletely the num ber and period of attractors. If only these nodes and the links between them

are considered, these nodes form loops with possibly additional links and chains of relevant nodes within and between loops. The recognition of the relevant elements as the only elements in uencing the asymptotic dynam ics was an important step in understanding the attractors of K au m an networks. The behavior of the frozen core was rst studied by Flyvb jerg [6]. Then, in an analytical study of K = 1 networks Flyvb jerg and K jaer [7] introduced the concept of relevant elements (though without using this name). The de nition of relevant elem ents that we are using here was given by Bastolla and Parisi [8, 9]. They gained insight into the properties of the attractors of the critical networks by using num erical experiments based on the modular structure of the relevant elements. Finally, Socolar and Kauman [10] found num erically that for critical K = 2 networks the mean num ber of nonfrozen nodes scales as N  $^{2=3}$ , and the mean num ber of relevant nodes scales as N<sup>1=3</sup>. The sam e result is hidden in the analytical work on attractor num bers by Samuelsson and Troein [11], as was shown in [12].

In this work, we go a step further by deriving these power laws analytically for a more general class of networks, and by showing the asymptotic probability distribution of nonfrozen and relevant nodes in terms of scaling variables. We also obtain results for the number of nonfrozen nodes with two nonfrozen inputs, and for the num ber of relevant nodes with two relevant inputs. The outline of this paper is the follow ing. In the next section we de ne the class of networks that we are investigating. In Section 3, we introduce a stochastic process that determ ines the frozen core of the network starting from the nodes whose outputs are entirely independent of their inputs. Then, in Section 4, we analyze the Langevin and Fokker-P lanck equations that correspond to this stochastic process and that lead to the scaling behavior of the num ber of nonfrozen nodes. In order to identify the relevant nodes among the nonfrozen ones, we introduce in Section 5 another stochastic process. This process also enables us to nd their scaling behavior. Finally, we discuss in the last section the implications of our results.

TABLE I: The 16 update functions for nodes with 2 inputs. The rst column lists the 4 possible states of the two inputs, the other columns represent one update function each, falling into four classes.

2. CRITICALK = 2NETWORKS

The networks we are studying in this paper are the K = 2 critical networks. In these networks each node has 2 random ly chosen inputs. The 16 possible update functions are shown in table I.

The update functions fall into four classes [5]. In the rst class, denoted by F, are the frozen functions, where the output is xed irrespectively of the input. The class C1 contains those functions that depend only on one of the two inputs, but not on the other one. The class  $C_2$ contains the remaining canalizing functions, where one state of each input xes the output. The class R contains the two reversible update functions, where the output is changed whenever one of the inputs is changed. Critical networks are those where a change in one node propagates to one other node on an average. A change propagates with probability 1=2 to a node that has a canalizing update function  $C_1$  or  $C_2$ , with probability zero to a node that has a frozen update function, and with probability 1 to a node that has a reversible update function. Consequently, if the frozen and reversible update functions are chosen with equal probability, the network is critical. U sually, only those models are considered where all 16 update functions receive equal weight. We here consider the larger set of m odels where the frozen and reversible update functions are chosen with equal (and nonzero) probability, and where the remaining probability is divided between the  $C_1$  and  $C_2$  functions. Those networks that contain only  $C_1$  functions are di erent from the remaining ones. Since all nodes respond only to one input, the link to the second input can be cut, and we are left with a critical K = 1 network, which was already discussed in [7, 12, 13] and will not be discussed here. All the other m odels, where the weight of the  $C_1$  functions is sm aller than 1, fall into the sam e class [12]. The treatm ent presented in the follow ing, is based on the existence of nodes with frozen functions, and it therefore applies to all critical models with a nonzero fraction of frozen functions. Networks with only canalyzing functions have to be discussed separately.

Let N<sub>f</sub> be the number of nodes with a frozen function, N<sub>r</sub> the number of nodes with a reversible function and N<sub>c1</sub> and N<sub>c2</sub> the number of nodes with a C<sub>1</sub> and a C<sub>2</sub> function. We denote the system swe are going to consider

through parameters = N<sub>c1</sub>=N, = N<sub>r</sub>=N = N<sub>f</sub>=N, = N<sub>c2</sub>=N. These parameters give the fraction of each type of nodes in the network. In the next two sections, we determ ine the properties of the frozen core in the large N lim it by starting from the nodes with a frozen function.

# 3. A STOCHASTIC PROCESS THAT LEADS TO THE FROZEN CORE

W e consider the ensemble of all networks of size N and with xed parameters ; ; . All nodes with a frozen update function are certainly part of the frozen core. We now construct the frozen core by determ ining stepwise all those nodes that become frozen due to the in uence of a frozen node. In the language of [10], this process determ ines the \clam ped" nodes. Initially, we place the nodes in four containers labelled F, C1, C2, and R. These containers contain N  $_{\rm f}$  , N  $_{\rm c_1}$  , N  $_{\rm c_2}$  , and N  $_{\rm r}$  nodes initially. Since these numbers change during our stochastic process, we denote the initial values as  $N_{f}^{ini}$ ,  $N_{c_{1}}^{ini}$ ,  $N_{c_{2}}^{ini}$ , and N  $_{r}^{\text{ini}}$ , and the total num ber of nodes as N  $^{\text{ini}}$ . W e treat the nodes in container C1 as nodes with only one input and with the update functions \copy" or \invert". The contents of the containers will change with time. The \time" we are de ning here is not the real time for the dynam ics of the system . Instead, it is the time scale for a stochastic process that we use to determ ine the frozen core. During one time step, we remove one node from the container F and determ ine all those nodes, to which this node is an input. A node in container C1 chooses this node as an input with probability 1=N. It then becomes a frozen node. W e therefore m ove each node of container  $C_1$  with probability 1=N into the container F.A node in container C2 chooses the selected frozen node as an input with probability 2=N.W ith probability 1=2, it then becom es frozen, because the frozen node is with probability 1=2 in the state that xes the output of a  $C_2$ -node. If the  $C_2$ -node does not becom e frozen, it becom es a  $C_1$ -node. W e therefore m ove each node of container  $C_2$  during the

rst time step with probability 1=N into the container F, and with probability 1=N into the container  $C_1$ . Finally, a node in container R chooses the selected frozen node as an input with probability 2=N and becomes a  $C_1$ -node. W e therefore move each node of container R during the rst time step with probability 2=N into the container  $C_1$ . In sum m ary, the total num ber of nodes, N , decreases by one during one time step, since we remove one node from container F, and som e nodes move to a di erent container. The rem oved nodes are those frozen nodes for which we already have determ ined whose input they are. Then, we take the next frozen node out of container F and determ ine its e ect on the other nodes. W e repeat this procedure until we cannot continue because either container F is empty, or because all the other containers are empty. If container F becom es empty, we are left with the nonfrozen nodes. W e shall see below that most of the rem aining nodes are in container C1, with the proportion of nodes left in containers  $C_2$  and R vanishing in the lim it N <sup>in i</sup>! 1 . Then, the nonfrozen nodes can be connected to a network by choosing the input(s) to every node at random from the other remaining nodes. If all containers apart from container F are empty at the end, the entire network becomes frozen. This means that the dynamics of the network go to the same xed point for all initial conditions.

Let us rst describe this process by determ inistic equations that neglect uctuations around the average change of the number of nodes in the di erent containers. As long as all containers contain large numbers of nodes, these uctuations are negligible, and the determ inistic description is appropriate. The average change of the node numbers in the containers during one time step is

The number of nodes in the containers, N, can be used instead of the time variable, since it decreases by one during each step. The equation for N $_{\rm r}$  can then be solved by going from a di erence equation to a di erential equation,

For N  $_{\rm f}^{\rm ini}$  < N  $_{\rm r}^{\rm ini}$ , we obtain N  $_{\rm f}$  = 0 at a nonzero value of N, and the number of nonfrozen nodes is proportional to N  $^{\rm ini}$ . We are in the chaotic phase. For N  $_{\rm f}^{\rm ini}$  > N  $_{\rm r}^{\rm ini}$ , the values N  $_{\rm r}$  and N  $_{\rm C_2}^{\rm C_2}$  will sink below 1 when N becomes of the order  $^{\rm N}$  N  $^{\rm ini}$ . For smaller N, there are only F and C<sub>1</sub> nodes left, and the second term contributing to N  $_{\rm f}$  and N  $_{\rm C_1}$  in (3) can be neglected compared to the rst one. When N  $_{\rm f}$  falls below 1, there remain N  $_{\rm C_1} = \frac{N \frac{\ln i + N \frac{\ln i + 2N r^{\rm ini}}{N \frac{\ln i + N r^{\rm ini}}{N r^{\rm ini}}}$  nodes of type C1. The network is

essentially frozen, with only a nite number of nonfrozen nodes in the limit N  $^{\rm ini}$ ! 1. If we now choose the inputs for these nodes, we obtain simple loops with trees rooted in the loops. This property of the frozen phase was also found in [10].

For the critical networks that this paper focuses on, we have  $N_{f}^{ini} = N_{r}^{ini} = N^{ini}$ , and the stochastic process stops at  $N_{f} = 1 = N^{2} = N^{ini}$ . This means that

The number of nonfrozen nodes would scale with the square root of the network size if the determ inistic approximation to the stochastic process was exact. We shall see below that including uctuations changes the exponent from 1=2 to 2=3. The nal number of C<sub>2</sub>-nodes for the determ inistic process for the critical networks is = , which is independent of network size, and the nal number of R-nodes vanishes due to N<sub>r</sub> = N<sub>f</sub>. We shall see below that the uctuations change these two results to a (N<sup>ini</sup>)<sup>1=3</sup>-dependence.

Introducing  $n = N = N^{ini}$  and  $n_j = N_j = N^{ini}$  for  $j = r; f; c_1; c_2$ , equations (3) simplify to (using  $N_r^{ini} = N_f^{ini}$ )

This means that our stochastic process remains invariant (in the determ inistic approximation) when the initial number of nodes in the containers and the time unit are all multiplied by the same factor. For small n, the majority of nodes are in container  $C_1$ , since  $n_{c_1} = n \quad O(r^2)$ . Now, if we choose a su ciently large N  $^{\rm ini}$ , n reaches any given small value while N  $_{\rm f}$  = N  $_{\rm r}$  =  $n^2 N \, ^{\rm ini}$  is still large enough for a determ inistic description. We can therefore assume that for su ciently large networks N  $_{\rm f}$  = N  $_{\rm f}$  = n becomes small before the e ect of the noise becomes im – portant. This assumption will simplify our calculations below .

### 4. THE EFFECT OF FLUCTUATIONS

The number of nodes in container  $C_1$  that choose a given frozen node as an input is Poisson distributed with a mean  $N_{c_1}=N$  and a variance  $N_{c_1}=N$ . We now assume that n is small at the moment where noise becomes important, i.e., that the variance of the noise  $N_{c_1}=N = n_{c_1}=n = 1$  (2 + )n = 1 O (n) is unity. The number of nodes in containers  $C_2$  and R that choose a given frozen node as an input is Poisson distributed with a mean and a variance  $2(N_{c_2} + N_r)=N$ . The uctuation around the mean can be neglected as this noise term is very small compared to  $N_r$  and  $N_{c_2}$ , the nal values of which are large for su ciently large N <sup>in i</sup>. We

therefore obtain the stochastic version of equations (1)

The random variable has zero mean and unit variance. As long as the  $n_j$  change little during one time step, we can summarize a large number T of time steps into one elective time step, with the noise becoming G aussian distributed with zero mean and variance T. Exactly the same process would result if we summarized T time steps of a process with G aussian noise of unit variance. For this reason, we can choose the random variable to be G aussian distributed with unit variance.

C om pared to the determ inistic case, the equations for N  $_{\rm r}$  and N  $_{\rm C_2}$  are unchanged, and we have again N  $_{\rm r}$  = N  $^2N\,{}_{\rm r}^{\rm in\,i}{=}\,(\!N\,\,^{\rm in\,i})^2$  and N  $_{\rm C_2}$  = N  $^2N\,{}_{\rm C_2}^{\rm in\,i}{=}\,(\!N\,\,^{\rm in\,i})^2$ . Inserting the solution for N  $_{\rm r}$  into the equation for N  $_{\rm f}$ , we obtain

with the step size dN = 1 and  $h^2i = 1$ . (In the continuum limit dN ! 0 the noise correlation becomes  $h(N)(N^0)i = (N N^0)$ ). This is a Langevin-equation, and we will now derive the corresponding Fokker-Planck-equation. Let  $P(N_f;N)$  be the probability that there are  $N_f$  nodes in container R at the moment where there are N nodes in total in the containers. This probability depends on the initial node number  $N_{ini}$ , and on the parameter . The sum

is the probability that the stochastic process is not yet nished, i.e. the probability that N  $_{\rm f}$  has not yet reached the value 0 at the m om ent where the total number of nodes in the containers has decreased to the value N . Since systems that have reached N  $_{\rm f}$  = 0 are removed from the ensemble, we have to impose the absorbing boundary condition P (0;N) = 0. Let g(N  $_{\rm f}$  M  $_{\rm f}$ ;N) denote the probability that N  $_{\rm f}$  decreases by N  $_{\rm f}$  during the next step, given the values of N  $_{\rm f}$  and N .

W e have

The mean change h N fi during one step is h N fi =  $\frac{N_f}{N} + \frac{N}{N^{inl}}$ , and the mean square change is h(N f)<sup>2</sup>i' 1. This gives the Fokker-P lanck equation for our stochastic process




FIG.1: The function W (N) (N <sup>in i</sup> = )<sup>2-3</sup> vs N = (N <sup>in i</sup> = )<sup>2-3</sup> for = 0.25 and N <sup>in i</sup> =  $2^{16}$ ;  $2^{17}$ ;  $2^{18}$ ;  $2^{19}$ ;  $2^{20}$ ;  $2^{21}$ . Furtherm one, the graph contains a curve with = 0.125; N =  $2^{16}$  and a curve with = 0.5; N =  $2^{16}$ . The curves all collapse, conm ing the existence of a scaling function G (y). The dashed line is a power law  $1 = \frac{N}{N}$ .

condition is independent of the param eters of the m odel, and therefore G (y) and f (x;y) are independent of them, too, which justi es our choice of the prefactor in the de – nition of f (x;y). By integrating equation (9) over x from 0 to in nity and by using f (0;y) = f (1;y) = 0 we obtain

which is proportional to (N  $^{\text{in}i} = )^{2=3}$ . We did not succeed in extracting an explicit expression for the function G (y). It can be determined by running the stochastic process described by the equations (5) on the computer. The result is shown in Figure 1, and an almost perfect t to this result is given by

For smally, the data show a power law G (y) / y  $^{1=2}$ . We can obtain this power law analytically by solving the Fokker-P lanck equation (9) in the lim it of small y. In this lim it, the term proportional to  $y^{3=2}$  can be dropped,




FIG.2:  $P(N_f; N) vs N_f = \frac{p}{N}$  for  $N^{ini} = 2^{21}$  and = 1=4 for di erent N. The thick solid line is the theoretical result Eq. (16), which is approached in the limit of small  $N = (N^{ini})^{2=3}$ .

with two constants  $C_1$  and  $C_2$ , and with H denoting the H erm itian functions, and  $_1F_1$  the appropriate hypergeometric functions. We expect f to be analytical in y for smally, which means that = 0;1;2;:::. For su ciently smally, only the term = 0 contributes, and due to the absorbing boundary condition we have  $C_2 = 0$ . We obtain therefore for smally

From our numerical result (13), together with (11), we nd  $c_0 = 0.5$ . Inserting Eq. (16) into Eq. (10), we obtain for sm all N

In Eq. (16), the function f(x;y) is independent of y. This means that for su ciently small N the function P (N<sub>f</sub>;N) depends only on the ratio N<sub>f</sub>  $\stackrel{\text{P}}{=}$  N. This is also con med by our computer simulations (see Fig.2).

We can obtain a set of solutions of Eq. (9) with the Ansatz f(x;y) = y f(z) with  $z = x y^{3=2}$ . The




FIG.3: The function W (N r) (N <sup>ini</sup> = )<sup>1=3</sup> vs N r = (N <sup>ini</sup> = )<sup>2=3</sup> for = 0.5 and = 0.125 and for N <sup>ini</sup> =  $2^{16}; 2^{17}; 2^{18}; 2^{19}; 2^{20}; 2^{21}$ . The 12 curves converge with increasing N towards an asymptotic curve, con rm ing the existence of an asymptotic scaling function F (s). The dashed line show s the function F (s) obtained using the data for G (y) obtained from the same simulation and Eq. (18).

resulting equation for f , is identical to Eq. (15) for f , which was valid for small y. However, an analytical expression for the function G (y) can only be given if an expansion of the initial condition P ( $N_{\rm f}$ ;N) = ( $N_{\rm f}$  N<sup>ini</sup>) in term s of known solutions can be found.

The probability W  $_{\rm r}$  (N  $_{\rm r}$ ) that N  $_{\rm r}$  nodes are left in container R at the moment where container F becomes empty, is obtained from the relation

The mean number of nodes left in in container R is

The number of nodes left in container  $C_2$  is N  $_{\rm C_2}$  = ( = )N  $_{\rm r}$  .

We thus have shown that the number of nonfrozen nodes scales with network size N <sup>ini</sup> as (N <sup>ini</sup>)<sup>2=3</sup>, with

m ost of these nodes receiving only one input from other nonfrozen nodes. The number of nonfrozen nodes receiving two inputs from nonfrozen nodes scales as  $(N^{\text{ in i}})^{1=3}$ . We have found scaling functions that describe the probability distribution for these two types of nodes in the lim it of large network size. Our next task will be to connect these nonfrozen nodes to a network. This is a reduced network, where all frozen nodes have been cut o .

## 5. RELEVANT NODES

Let us start from the result obtained from the stochastic process of the previous two sections. Each time we run this process we obtain N nonfrozen nodes. Out of these, N<sub>r</sub> (N<sub>c<sub>2</sub></sub>) nodes receive input from two other nonfrozen nodes and have a reversible (canalizing C<sub>2</sub>) update function. We de ne the parameter

which has a probability distribution f(a) that is determined from the condition f(a)da = G(y)dy,

f (a) =

Just as G(y), the function f(a) is the exact probability distribution only in the therm odynam ic lim it N <sup>in i</sup>! 1. W e determ ine the relevant nodes by a stochastic process that rem oves iteratively nodes that are not relevant. Each of the N nonfrozen nodes chooses its input(s) at random from the nonfrozen nodes. There are altogether N (1 + a = N) inputs to be chosen, and consequently the nonfrozen nodes have together N (1 + a= N ) outputs. The number of outputs of a node is Poisson distributed with the mean value (1 + a = N). The fraction exp (1  $\dot{a=}$  N) of nodes have no output. They are the leaves of the trees of the network of nonfrozen nodes, and we therefore know that they are not relevant. We put them in container num ber 1. Their num ber will change during the stochastic process that determ ines the relevant nodes. The other nodes are placed in container num ber 2. Their num ber is  $N_1$  (\labelled"), and it will be reduced until only the relevant nodes are left. The total num ber of outputs of the nodes in container 2 is in itially N (1 + a = N), while their total num ber of inputs is N(1+a=N)(1 exp(1 a=N)).Now, we remove onenode from container 1 and connect its input (s) at random to the outputs of the nodes in container 2. The chosen output(s) are cuto . If a node whose output is cuto has no other output left, we move the node from container 2 to container 1. It cannot be a relevant node since relevant nodes in uence other relevant nodes. W e iterate this procedure, until there is no node left in container 1. The nodes remaining in container 2 are the relevant nodes. During the entire process, the number of outputs in container 2 is identical to the number of inputs in container 1 and 2. As long as container 1 is not empty, there are m ore outputs in container 2 than inputs, and only when the process is nished do the two numbers become identical. We can therefore simplify the stochastic process by rem oving container 1 altogether. We simply have to continue cutting of outputs from nodes in container 2 and rem oving nodes with no outputs, until the total number of outputs of the nodes in container 2 has become e identical to their total number of inputs. The remaining nodes are relevant, and we have then  $N_1^{final}$   $N_{rel}$ . These nodes can then be connected to a network by connecting the inputs and outputs pairwise.

In order to derive analytical results, it is useful to run this process backwards. Starting with N nodes with no outputs, adding outputs at random will eventually generate the Poisson distribution of the num ber of outputs per node that we have started with. The reverse stochastic process is therefore de ned by the following rule: Begin with an empty container (form er container 2) and N nodes outside the container. M ost of these nodes have one input, and the fraction a= N have two inputs. Add an output to a random ly chosen node. Put this node in the container. Add another output to a random ly chosen node (choosing every node with equal probability, whether the node is inside or outside the container). If a node from outside the container is chosen, put it in the container. Eventually, the total number of outputs in the container will become larger than the total number of inputs in the container. The container contains the relevant nodes at the m om ent w hen the inputs equal the outputs for the last time.

In order to show that the number of relevant nodes scales with N, we de ne a scaling variable

During one step, an output is added to nodes that are already in the container with probability N  $_1\!=\!N$ . Let N  $_{\rm o}$  count the number of outputs that have been added to nodes in the container, i.e., N  $_{\rm o}$  = (totalnum berofoutputs in the container) N1. Then the average rate of increase of N  $_{\rm o}$  is given for su ciently large N by

or

Let N  $_{\rm i}$  count the num ber of nodes in the container with two inputs. Their rate of increase is




FIG. 4: The function  $C_1$  (t) as obtained by running the stochastic process described in this section. The dotted line corresponds to the function 0.25t, which is a good t to  $C_1$  (t) for small t.

C onsequently, the probability distribution for N  $_{\rm o}\,$  is given by

and the probability distribution for N  $_{\rm i}$  is given by

The stochastic process can be viewed as a random walk that steps to the right with a rate t and to the left with a rate a. It is nished when N<sub>i</sub> = N<sub>o</sub> for the last time, i.e. when the walk leaves the origin for the last time. We determ ined the probability distribution  $C_a$  (t) for this last exit time from the origin by a computer simulation. It is shown in Fig. 4 for a = 1. For small t, it increases linearly in t, because the probability of making a step to the right is proportional to t for small times. For a = 0, we can obtain an analytical result from the relation

Since we were able to write the stochastic process in terms of t and a alone, the probability distribution for the number of relevant nodes depends only on the com - bination N  $_{rel} = \overline{N}$  and on the parameter a,

The relation between N and a is obtained using Eq. (8) and (21):

Taking into account the probability distribution (22) of the parameter a, we obtain the scaling behavior of the




FIG.5: The function P (z) for = = 0 (solid line) and = = 4 (dashed line). The results were obtained by running the two coupled stochastic processes for  $10^7$  sam ples.

num ber of relevant nodes,

The error m ade by taking the upper lim it of the integral to in nity vanishes for N  $^{\rm in\,i}$  ! 1 . We introduce the scaling variable

which has then the following probability distribution

The probability distribution for the number of relevant nodes depends for large N <sup>ini</sup> only on the scaling variable z. We determ ined num erically the function P (z) by combining the two stochastic processes described in this paper. First, we determ ined a value of a using the process of Section 4. Then, we used this value of a to determ ine the last exit time of the stochastic process of this section, giving a value of z. The shape of the curves P (z) depends on the value of = 4, which is the original K au m an m odel, where each update function has the same weight. It is easy to check analytically that

The mean number of relevant nodes is

i.e., it is proportional to (N <sup>ini</sup>)<sup>1=3</sup>. Finally, let us give the probability distribution for the number of relevant nodes with two relevant inputs. Let m denote the number of relevant nodes with two relevant inputs and P'(m;z)dz the probability of having the number of relevant nodes in the interval [N rel(z); N rel(z + dz)], with m of them having two relevant inputs. Using Equations (23) and (24), we can express P' as

As  $P_{\rm o}$  and  $P_{\rm i}$  decay exponentially fast with increasing m , the mean number of relevant nodes with two inputs is nite.

## 6. CONCLUSIONS

In this paper, we have obtained the asym ptotic probability distributions in the lim it of large network size for the num ber of nonfrozen nodes, the num ber of nonfrozen nodes with two nonfrozen inputs, the num ber of relevant nodes, and the num ber of relevant nodes with two relevant inputs. The m ean values of these quantities scale with network size N <sup>in i</sup> as a power law in N <sup>in i</sup>, with the exponent being 2=3, 1=3, 1=3, and 0 respectively. The im plications of the results are manifold.

First, the notion that these networks are \critical" is now corroborated by the existence of power laws and scaling functions. O riginally, it was expected that the quantities that display the scaling behavior should be the attractors of the network [2]. In the meantime, it has become clear that mean attractor numbers do not obey power laws [11]. It is the number of nonfrozen and relevant nodes that show scaling behavior.

Next, let us compare the results to those of critical K = 1 networks. A K = 1 critical network with N nodes corresponds to the nonfrozen part of a critical K = 2 network for a = 0. In this case, the probability distribution of the number of relevant nodes is given by Eq. (26) with a = 0,

<u>The</u> mean number of relevant nodes is proportional to  $\overline{N}$ . When these relevant nodes are connected to a network by pairwise connecting the inputs and outputs, one obtains a set of simple loops. From [13], we know that there is a mean number of  $\ln \frac{P}{N}$  loops and that the number of loops of length 1 in a critical  $K = \frac{P}{N} \frac{net}{N}$  ork is Poisson distributed with a mean 1=1 for 1  $\frac{P}{N}$ . This can be easily explained by considering the process of connecting inputs and outputs: We begin with a given node and draw the node that provides its input from all possible nodes. Then, we draw the node that provides the input to the new ly chosen node, etc., until the rst node is chosen and a loop is form ed. For sm all loop size, the probability that the loop is closed after the addition of the lth node is  $1=N_{rel}$ . Therefore, the probability that a given node is on a loop of size l is  $1=N_{rel}$ , and the m ean number of nodes on loops of size l is 1, and the num ber of loops of length l is Poisson distributed with a m ean 1=1 for su ciently sm all l.

Now, the K = 2 critical networks have of the order of (N  $^{\text{ini}}$ )<sup>1=3</sup> relevant nodes, with only a nite number of them having two relevant inputs. The relevant com ponents are constructed from the relevant nodes by pairw ise connecting inputs and outputs. In the asymptotic lim it of very large N <sup>in i</sup> that we are considering, the probability that a random ly chosen relevant node has two inputs or two outputs vanishes. Let us again construct a com ponent by starting with one node and choosing its input node etc., until the component is nished. If the component is small, it consists almost certainly only of nodes with one input and one output and is therefore a simple loop. There is no di erence between the statistics of the sm all relevant components of a K = 1 critical network, and the num ber of loops of length 1 is Poisson distributed with a mean 1=1. The total number of relevant nodes in bops of size  $l \downarrow w$  ith  $l_c = (N^{ini})^{1-3}$  (w ith a small ) is l, and it is a sm all proportion of all nodes. If there were no nodes with two inputs or outputs, the num ber of com ponents larger than  $l_c$  would be  $(\ln N_{rel} \quad \ln l) = \ln (1 = )$ . The additional links may reduce this number, which is in any case nite. Since these large com ponents contain al-

m ost all nodes, they contain alm ost all relevant nodes with two inputs or outputs.

From these ndings, we can obtain results for the attractors of K = 2 critical networks. The numbers and lengths of attractors are determ ined by the relevant com ponents. W enow argue that them ean num ber and length of attractors increases faster than any power law. If we rem ove the components of size larger than 1- and determ ine the mean number and length of attractors for this reduced relevant network, we have a lower bound to the correct numbers. Now, the reduced relevant network of a K = 2 system is identical to that of a critical K = 1system (where the critical loop size is  $l_c =$ N). In [13], it was proven that the mean number and length of attractors for such a reduced K = 1 system increases faster than any power law with network size. We therefore conclude that the same is true for critical K = 2networks.

Earlier, Sam uelsson and Troein [11] have derived analytically an exact expression for the number of attractors of length L of a critical K = 2 network in the limit of large N <sup>in i</sup>, and they have pointed out that this im plies that the mean number of attractors increases faster than any power law with N <sup>in i</sup>. U sing their calculation, it has recently been shown [12] that there is a close relationship between K = 1 critical networks and the nonfrozen part of K = 2 critical networks, and that the results of [11] can be most naturally interpreted if the relevant components of these two networks look identical for component sizes below the above-given cuto s. This interpretation is placed on a m foundation by the present paper.
