Schwinger Boson approach to the fully screened Kondo model.

We apply the Schwinger boson scheme to the fully screened K ondo model and generalize the method to include antiferrom agnetic interactions between ions. Our approach captures the K ondo crossover from local moment behavior to a Fermi liquid with a non-trivial W ilson ratio. When applied to the two impurity model, the mean-eld theory describes the "Varma Jones" quantum phase transition between a valence bond state and a heavy Fermi liquid.

Recently, there has been a broad growth of interest in the behavior of heavy electron materials at a magnetic quantum critical point[1]. Several observations can not be understood in terms of the established Moriya Hertz theory of quantum phase transitions[2, 3, 4], including the divergence of the heavy electron masses[5], the near linearity of the resistivity [6, 7, 8, 9] and E = T scaling in inelastic neutron spectra [10]. The origins of this failure are linked to the competition between the Kondo e ect and antiferrom agnetism and may indicate the emergence of new kinds of excitation [1, 11, 12, 13]

In this letter, we show how to unify the Arovas A uerbach [15] description of quantum spin systems with the physics of the K ondo m odelby using Luttinger W ard techniques and a Schwinger boson spin representation. Our goal is to develop a large-N expansion that contains the physics of antiferrom agnetism and the K ondo e ect in the leading approximation. Traditional pseudoferm ion [16, 17, 18] representations of the spin are illsuited to a description of local moment magnetism. By contrast, a Schwinger boson scheme works well for magnetism, but to date, has not been successfully applied to the fully screened K ondo model. We use a method coinvented by one of us (OP) [19] in which the Kondo e ect is captured in a large N Schwinger boson scheme using a multichannel K ondo m odel where the number K = kNof screening channels scales extensively with N . By tuning the number  $n_b$  of Schwinger bosons from  $n_b < K$  to  $n_b > K$ , one is able to describe both the overscreened and underscreened K ondo m odels, however, di culties were encountered in the past work that appeared to prevent the treatm ent of the perfectly screened case,  $n_b = K$  . In this letter, we show how these di culties are overcom e.

Consider the multichannel Kondo impurity model,

Here  $c_{\mathtt{k}}^{^{y}}$  creates a conduction electron of m om entum  $\,\mathtt{k}\,$  ,

channel index 2 [1;K], spin index 2 [ j;j], where N=2j+1 is even.  $Y=\frac{1}{N_s}$  k  $c_k^y$  creates an electron in the W annier state at the origin, where  $N_s$  is the number of sites in the lattice. The operator  $b^y$  creates a Schwinger boson with spin index 2 [ j;j]. The local spin operator is represented by  $S=b^yb$  =N and the system is restricted to the physical Hilbert space by requiring that  $n_b=b^yb=2S$ . The nal term in H contains a temperature-dependent chemical potential (T) that implements the constraint  $h_bi=2S$ . We will exam the fully screened case 2S=K, taking the large

We begin by factorizing the interaction in terms of auxilliary G rassman eld ,

Following the steps outlined by us in earlier work [26], we now write the Free energy as a Luttinger W ard [25] functional of the one particle G reen's functions,

where  $Str[A] = Tr[A_B]$   $Tr[A_F]$  is the graded (super) trace over the M atsubara frequencies, internal quantum numbers of the bosonic (B) and ferm ionic (F) components of A.  $G_0$  is the bare propagator and G = D iag  $G_b$ ;  $G_c$ , the fully dressed propagator, where




FIG. 1: Leading contributions to Y [G] in 1=N expansion. Solid, dashed and wavy lines respectively represent G  $_{\text{C}}$ , G and G  $_{\text{D}}$ . Each vertex is associated with a factor i=  $\overline{\text{N}}$ . B racketed term s are dropped in the large N lim it.

(i!  $_n$ ) =  $G_0^{-1}$  G  $_P^1$  denotes the corresponding self-energies.  $G_{c0}$  (i!  $_n$ ) =  $_k^{-1}\frac{1}{i! \, _n^{-k}}$  is the bare conduction electron G reen's function. The quantity Y [G] is the sum of all closed-loop two-particle irreducible skeleton Feynman diagrams. In the large N limit, we take the leading O (N ) contribution to Y (Fig. 1).

The variation of Y with respect to G generates the self-energy Y = G =, which yields  $_c() =$

 $\frac{1}{N}G$  ( )G\_b( ). Since  $_{\text{c}}$  is of order O (1=N) we can use the bare conduction propagator G\_{c0} inside the self-consistent equations for ( ) = G\_b( )G\_{c0}( ) and  $_{\text{b}}$ ( ) = kG ( )G\_{c0}( ). In terms of real frequencies, these expressions become

where G (!) G (! i ) and the primed variables denote the real and imaginary parts of G . We use the notation  $h_{B\,,F}$  (!) =  $\frac{1}{2}$   $n_{B\,,F}$  (!) where  $n_{B\,,F}$  (!) = (e  $^!$  1)  $^1$  are the Bose and Ferm iocgupation numbers. The constraint  $n_b=$  2S now becomes  $\frac{d}{d} \cdot n_B$  ()  $G_b^0$  () =  $\frac{2S}{N}$  .

The original work in [19,20] focussed primarily on the case of the overscreened K ondo model, where K > 2S. The perfectly screened case where K = 2S presented two diculties. First, the phase shift associated with the K ondo model is =N, which vanishes in the large N limit. Second, the requirement that K = 2S appeared extremely stringent, the slightest deviation from this condition apparantly leading to underscreened or overscreened behavior at low temperatures.




FIG. 2: (a) Schem atic variation of occupancy as a functional ofboson chem ical potential in the ground-state. (b) G ap in spinon spectrum develops in the fully screened K ondo state.

There are two new observations that enable us to now avoid these diculties. First, the perfectly screened case where 2S = K is a stable \ lled shell" singlet conguration of the spins. In strong-coupling, this sta-

ble ground-state corresponds to a singlet \rectangular" Young tableau representations of SU (N). [22, 27]. In the gauge theory description of the Kondo model, this stability manifests itself as a gap in the Schwinger boson and ferm ion spectrum. When the chemical potential, lies within this gap, the ground-state Schwinger boson occupancy locks into the value  $n_b = K = 2S$  (Fig. 2a).

The gap in the gauge particle spectrum has the effect of \con ning" these excitations, so that the low energy physics only involves the elastic scattering of the conduction electrons o the K ondo singlet. From this perspective, the fully screened K ondo model is a kind of \spinon insulator", while over and underscreening de-

velop when the spin-chemical potential is in the valence and conduction bands respectively (Fig. 2 (b)). A second aspect to the problem concerns the scattering phase shift. Although the conduction phase shift is =N, its e ect on the therm odynam ics is enhanced by the N spin components and the K scattering channels, producing an order O (N K = N) O(N) e ect in the mean eld theory. Moreoever, we can indentify exact W and identities [26] which give rise to a sum rule relating the scattering phase shift of the conduction electrons  $_{c} = Im ln 1 g_{c0} (0 i)_{c} (0 i))$  to the phase shiff = Im  $\ln{(1+J_K)}$  (0 i )) associated with the ferm ions,  $_{\rm C}$  =  $\frac{1}{N}$  . The con ned nature of the ferm ions means that = in the ground-state, which quarantees that the Friedel sum rule c = -N is satisfied in this Schwinger boson scheme.

In the large N lim it the entropy [26] is given by

(where the frequency labels! in the integrand have been suppressed), and

is the rescaled conduction self-energy. At low temperatures, the gap in the boson and ferm ion spectrum means that only the conduction electron contribution dominates the entropy, and this is the origin of the Ferm i liquid behavior.

W e can also calculate the local magnetic susceptibility

where we have taken the magnetic moment of the local impurity to be M =  $^{\circ}$ b, where  $^{\circ}$  = sign ( ). Note in passing that the dynamic counterpart hS (t)S (0)i vanishes exponentially due to the gap in the bosonic spectral functions, the 1=t² term characteristic of a Fermi liquid only appearing at the next order in 1=N .




FIG. 3: Showing temperature dependence of (a) impurity magnetic susceptibility and (b) specic heat capacity in the fully screened K ondo model for  $k=0.3;\ 0.5;\ 0.7$ . Inset calculated W ilson ratio.

We have numerically solved the self-consistent equations (5) for the self-energy by iteration, imposing the constraint at each temperature. Fig. 3. shows the temperature dependence of the specic heat coecient  $\frac{C_V}{T}=\frac{dS}{dT}$  and the magnetic susceptibility. There is a smooth cross-over from local moment behavior at high temperatures  $n_b\,(1+n_b)$ =T, to Fermi liquid behavior at low temperatures. From a Nozieres-B landin description of the local Fermi liquid [21] (where channel and charge susceptibility vanish), we deduce the Wilson ratio

This form is consistent with Bethe Ansatz results [22]. We may also derive this result by applying Luttinger-Ward techniques [28] to our model. Our large Napproximation reproduces the limiting large Nbehavior of this expression, W=1+k, in other words, the local Fermi liquid is interacting in this particular large N limit.

To see how our method handles magnetic correlations, we have applied it to a two-impurity K ondo model,

where the antiferrom agnetic interaction between the two moments is expressed in terms of the boson pair operator  $B_{12} = -b_1 \ b_2$ . Hois invariant under spin transformations in the symmetry group SP (N) (N-even) [14]. We now factorize the antiferrom agnetic interaction [15],

Boson pairing is associated with the establishment of short-range antiferrom agnetic correlations. Once becomes non-zero, the local gauge symmetry is broken, and the Schwinger bosons propagate from site to site. In this \Higg's phase" the fermions also delocalize, giving rise to the emergence of a mobile charged yet spinless ecitation that is gapped in the Fermiliquid. Loosely speaking, these excitations are mobile K ondo singlets or \holons". Since the paired Schwinger bosons interconvert from particle to hole as they move, they only induce holon motion between the same sublattice. In the special case of two-impurity model, so long as the net coupling between the spins is antiferrom agnetic, the holons will remain localized.

W ith this  $sim\ pli$  cation, we can adapt the  $sin\ pli$  in - purity equations to the two-im purity model by replacing

in the integral equations. We must also impose self-consistency =  $J_H hB_{12}i$ , or




FIG. 4: Phase diagram for the two-impurity K ondo model showing the boundary where boson pairing develops. Color coded contours delineate the entropy around the V arm a Jones xed point. Black line indicates upper maximum in specic heat, blue line, lower maximum in specic heat where crossover into the Fermi liquid takes place. Inset – (a) entropy for various values of  $T_K = J_H$  (b) showing dependence of on  $T_K = J_H$  at a temperature  $T = T_K = 0.02$ .

We have self-consistently solved the integral equations with the modied boson propagator. Using the entropy as a guide, we are able to map out the large N phase diagram for this model (Fig. 4.).

We not that the development of  $\[ \in \]$  0 preserves the linear tem perature dependence of the entropy at low temperatures, indicating Fermi liquid behavior. However, as the  $J_H$  increases, the temperature range of Fermi liquid behavior collapses towards zero, vanishing at a quantum critical point where  $J_H = J_c$ . For  $J_H > J_c$ , Fermi liquid behavior re-emerges, but the phase shift—is found to have jumped from—to zero, inducing a collapse of the Kondo resonance. The entropy develops a nite value at the quantum critical point which is numerically identical to one half the high temperature entropy of a local moment,  $(N=2)[(1+n_b) \ln (1+n_b) - n_b \ln n_b]$ . Similar behavior occurs at the \Varma Jones"—xed point [23, 24, 29]

in the N = 2 two-im purity m odel when the conduction band is particle-hole sym m etric. From our results we are able to identify two maxima in the speci c heat, indicating that as in the N = 2 Varma Jones xed point, the antiferrom agnetic coupling generates a second set of screening channels, leading to a two-stage quenching process.

The survival of the Varm a Jones  $\,$  xed point at large N in the absence of particle hole sym m etry is a consequence of the two in purity Friedel sum  $\,$  rule which tells us that

where are the even and odd parity scattering phase shifts. For N=2, this condition is satis ed with  $_{+}=$  and  $_{=}=0$ , so it is possible, in the presence of particle-hole asymmetry, to cross smoothly from unitary scattering o both impurities, to no scattering o either, while preserving the sum rule. However, for N>2, where  $_{+}+<$ , the sum rule can not be satis ed in the absence of scattering, so the collapse of the K ondo e ect must occur via a critical point.

In conclusion, we have shown that a Schwinger boson approach to the fully screened K ondo model can be naturally extended to incorporate magnetic interac-

tions. One of the interesting aspects of this approach, is the appearance of mobile, yet gapped \holon" excitations in the antiferrom agnetically correlated Ferm i liquid. Future work will exam ine whether these excitations can become gapless at a heavy electron quantum critical point, leading to quantum critical matter with spincharge decoupling [1, 13].
