# Composite ferm ions from the algebraic point of view

### Abstract

C om posite ferm ion wavefuctions have been used to describe electrons in a strong magnetic eld. We show that the polynom ial part of these wavefunctions can be obtained by applying a norm all ordered product of suitably de ned annihilation and creation operators to an even power of the Vanderm onde determ inant, which can been considered as a kind of a non-trivial Ferm i sea. In the case of the harm onic interaction we solve the system exactly in the lowest Landau level. The solution makes explicit the boson-ferm ion correspondence proposed recently.

#### I. IN TRODUCTION

C om posite ferm ionsprovide a uni ed approach to fractional quantum Halle ect  $(FQHE)^1$ and other liquid states of the two-dimensional electron gas<sup>2</sup> in a strong magnetic eld. They have also been used to describe rotating states of quantum dots<sup>3</sup>. The composite ferm ion wavefunctions proposed by Jain<sup>4,5</sup> are obtained in the following manner. First multiply a wavefunction of non-interacting electrons by the Jastrow factor

and then project the product to the lowest Landau level. The ansatz was motivated by a heuristic derivation in which an even number of ux quanta were attached to the electrons and a mean-eld approximation was applied to the resulting state. Numerical studies for nite systems have supported the ansatz. Recently similar numerical studies have provided additional information about quantum dots. In particular, rotating systems of a number of identical particles with repulsive interactions con ned in a trap have been studied. It has been found that the systems form vortices and that the general features of the vortex formation are common to both boson and ferm ion system  $s^{6,7}$ .

In this article we study particles in a harmonic trap using analytical and algebraic means. The physical realization could be a two-dimensional electron gas in a strong magnetic eld or a quantum dot. The mathematical model is basically the same. In particular, we shall utilize the method of spectrum generating algebras, which is reviewed in section II. Composite fermions are considered in section III. Our result is a simple expression for the composite fermion wavefunctions. The polynom ial parts of these wavefunctions are obtained by applying a norm allordered product of suitably de ned annihilation and creation operators to an even power of the Vandermonde determinant, which can been considered as a kind of a non-trivial Ferm i sea. Finally, in section IV we give the exact solution for the harmonic interaction in the lowest Landau level. The LLL spectrum turns out to be qualitatively di erent from that of the complete solution, which is also known for the harmonic interaction<sup>8,9</sup>. Nevertheless, using the exact eigenstates we show that there is a simple correspondence between the boson and ferm ion system s as anticipated by Toreblad et al.<sup>6</sup>.

It often happens in quantum mechanics that energy eigenstates can be obtained from each other by applying suitable ladder operators. We say that K is a ladder operator if the commutator of the Hamiltonian H and K is a multiple of K, that is, [H;K] = K. Then it follows for an energy eigenstate with energy that K is also an energy eigenstate with energy + since

If  $K_1$  and  $K_2$  are ladder operators such that  $[H; K_1] = {}_1K$  and  $[H; K_2] = {}_KK_2$ , then

Hence the ladder operators form a Lie algebra L (H). C learly all the symmetries of the Ham iltonian, that is, the operators commuting with the Ham iltonian, belong to L (H). Loosely speaking, a subalgebra g of L (H) is called a spectrum generating algebra if the physical state space is an irreducible representation of g. Instead of making the de nition precise, we try to illustrate the concept by the following familiar examples.

The best-known example is the harm onic oscillator, the Ham iltonian of which is

where we have chosen the length and energy units to be  $p \rightarrow m!$  and  $\sim!$ , respectively. Here m is the mass of the particles and ! is the angular frequence of the oscillator. In the one-dimensional case all the energy eigenstates can be generated from the unique ground state

using the creation operator

The norm alized eigenfunctions are

We have the commutation relations  $[H; a^y] = a^y$  and [H; a] = a where the annihilation operator

$$a = \frac{1}{\frac{p}{2}} (x + \frac{d}{dx}):$$

In this case the appropriate spectrum generating algebra g is the H eisenberg algebra generated by a and  $a^y$  with the canonical commutation relation  $[a;a^y] = 1$ .

This approach readily generalizes to higher dimensional oscillators; we only need one pair of creation and annihilation operators for each degree of freedom. Interestingly, we can do something slightly diment in the plane. Let us use the standard notation

commute and we can nd a basis of common eigenvectors, which we may express in the following forms:

Hence the generators of the spectrum generating algebra can be chosen to be

with the commutation relations  $[b;b] = [b^y;b^y] = [b;b^y] = [b^y;b] = 0$  and  $[b;b^y] = [b;b^y] = 1$ . This is again the Heisenberg algebra but the advantage is that the algebra is spectrum generating not only for H but also for L.U sing the expression

and equation (2) it is easy to show the necessary commutation relations:




Figure 1: The eigenstates of the two-dimensional harmonic oscillator in the (L,H) plane. The action of the annihilation and creation operators on the eigenstates is also shown graphically.

The eigenstates as well as the action of the above generators on them are shown in Fig. 1.

### III. COMPOSITE FERM IONS

Composite ferm ions<sup>4,5</sup> provide a uni ed approach to fractional quantum Hall e ect  $(FQHE)^1$  and other liquid states of the two-dimensional electron gas<sup>2</sup> in a strong magnetic eld. They have also been used to describe rotating states of quantum dots<sup>3</sup>. Let us consider electrons con ned to the plane and subjected to a magnetic eld H perpendicular to it. A ssum e that the strong magnetic eld makes the electrons e ectively spinless. In the symmetric gauge

the single-body Ham iltonian

takes the form  $H_s = H$  ! L where the angular frequence of the harm onic oscillator is

Note that ! is half the usual cyclotron frequence but this choice complies with the conventions adopted for the harm onic oscillator. Now the common eigenstates  $m_{n}$  of H and L are also the eigenstates of H<sub>s</sub>. However, the eigenenergies change and the ground state becomes in nitely degenerate. All the states

form ing the lowest Landau level (LLL) have zero energy. The Hilbert space of LLL states may be identied with the Bargm ann space

of square-integrable holom orphic functions with respect to the weight function e  $\frac{j \cdot \hat{f}}{j}$  while the entire state space is

$$H = L^2 (C; e^{\frac{jz}{2}} dm (z))$$

Here dm (z) m eans the Lebesgue m easure. Including the exponential factor into the m easure reduces the calculations to polynom ial calculus. This technique was already inherent in Laughlin's work<sup>11</sup>, and was explained by G irvin and Jach<sup>12</sup>.

Let P stand for the projection H ! H  $_0$ . Since the functions

The composite ferm ion trial wavefunctions are obtained in the following manner. First multiply a wavefunction of non-interacting electrons by the Jastrow factor

and then project the product to the LLL. Here k is a positive integer. All indices will run from 1 to the number N of the particles unless otherwise stated. Our goal is to make the calculation of the composite ferm ion wavefunctions more explicit. The wavefunctions of the non-interacting electrons are anti-symmetrized products of the eigenfunctions  $_{m,m}$ . The projection can be done one complex variable at a time. Consider the polynom ial parts of the eigenfunctions without the norm alizing factor

Then  $'_{mn}$  are holom orphic polynom ials and we have to calculate the projection P ( $'_{mn}$ ). Here is the Jastrow factor or more generally an arbitrary holom orphic polynom ial considered as a function of one variable only. We have

In general, an N-particle state of non-interacting electrons is an antisymmetrized product = A  $\begin{bmatrix} 1 & 1 & 1 & 1 \end{bmatrix}$  of the single-particle wave-functions. Here the antisymmetrization operator is defined as

where the sum m ation is over all the permutations of the indices 1; :::; N. The above calculation easily generalizes to several variables. We can express the result using the multi-index notation

where  $j j = 1 + \frac{1}{N}$ . The composite ferm ion wavefunction corresponding to and Jastrow factor D<sup>k</sup> is given up to norm alization by

The form ula is analogous to the equations (1) and (3) in the sense that all the states can be created by applying the multiplication and partial derivative operators to the given ground states, Jastrow factors. Consequently, it seems natural to search for spectrum generating algebras even for interacting ferm ions. However, to proceed further we have to choose the actual form of the interaction.

# IV. EXACT RESULTS FOR THE HARMONIC INTERACTION

It was already known for the nuclear physicists of the flies that the harm onic interaction potential

in a harm onic trap is exactly diagonalizable<sup>9</sup>. The model has also been applied to quantum  $dots^{10}$ . A complete set of eigenfunctions is di cult to write down due to the degeneracy problem s but the eigenenergies and their degeneracies are known<sup>8</sup>. The general solution has no restrictions with respect to the angular momentum, whereas the composite ferm ion wavefunctions are by de nition restricted to the lowest Landau level. The LLL approxim ation is usually justified by physical considerations related either to the strong magnetic eld or to the rotational state. We shall not the exact solutions of the projected H am iltonian in the lowest Landau level. O ur result generalizes the observation by G irvin and Jach<sup>12,13</sup>, who noticed that Laughlin's functions

for an odd integer m are exact energy eigenstates for V. Comparison with the complete solution will hopefully shed light on the subtleties of the LLL approximation. At least the LLL solution makes explicit the correspondence between the boson and ferm ion systems suggested in<sup>6</sup>.

To start with, a technical remark is in order. Note that must be chosen negative to make the interaction repulsive. Moreover, the absolute value of must be small enough to make the energy spectrum bounded from below. For the LLL Ham iltonian even this is not su cient. However, if we are the total angular momentum, a (degenerate) ground state can be found. The projection  $\hat{V} = P \vee P$  of the interaction (7) to the Bargmann space H<sub>0</sub> was calculated by G irvin and Jach<sup>13</sup>. It is given by the form ula

Multiplication operator  $z_k$  is not quite a ladder operator for  $\hat{V}$  since

However, it follows from the above calculation that

for all k and l. H ence multiplication of an eigestate by the linear factors  $z_k = z_1$  creates new eigestates with eigenvalues increased by N  $\cdot$ . W e also have

so that the operator  $_{k}^{P} z_{k}$  creates states which are denegenerate with the original one. We can start with the constant function  $_{B}^{\prime} = 1$ , which is an eigenstate for  $\hat{V}$  with eigenvalue N (N 1), and multiply it by the above linear factors to obtain new eigenstates. However, in order to qualify as proper physical states, they also have to obey the usual permutation sym metrics. Let us consider the bosonic case rst. The question is which sym metric polynomials can be represented as linear combinations of the products of the factors  $e_{k1} = z_k z_1$ . Since the factors  $e_{k1}$  span the space  $C = fz_1 + \frac{1}{N} \neq 0$ , which is isom orphic to the C artan subalgebra of the Lie algebra su (N) as a representation of the sym metric group  $S_n$ ,

the problem is solved by the classical invariant theory<sup>14</sup>. As long as we are restricted to C, the subalgebra of sym metric polynom ials obtained from  $e_{k1}$  is freely generated by the power sum s

$$q_k = z_1^k + \frac{k}{N} z$$

for 1 < k N. Now  $q_k$  is obtained by restricting a linear combination of the products of  $e_{k1}$ from  $C^N$  to C. The polynom ials must be invariant in the translations parallel to (1;1;:::;1)since the factors  $e_{k1}$  are. Hence the only possible extension of  $q_k$  to  $C^N$  is

$$p_k = (z_1 z)^k + +_N (z z)^k$$

where  $z = (z_1 + \frac{1}{N})zN$  is the center-off mass. If we allow  $p_1 = z_1 + \frac{1}{N}zN$  among the generators, then by dimensional counting we obtain a complete basis of the symmetric polynom ials. The difference is that the factor  $p_1$  does not have elect on the eigenvalue while the other power sums  $p_k$  increase it by N k. Including the Gaussian factors we obtain the boson eigenstates

where k are non-negative integers. The corresponding eigenenergies are

D is believers can check the result by a straight-forward calculation. Once the answer is known, it is not that hard since  $\hat{V}$  is a derivation up to an additive constant. The ferm ion states can be obtained by exactly the same reasoning starting from the ground state

O beerve that the ferm ion states di er from the boson states only by the factor  $'_{\rm F}$ , while the corresponding eigenenergies are shifted by a constant depending only on the number of particles and the strength of the interaction. Practically all states are degenerate due to the huge symmetry of the interaction potential.

# V. CONCLUSIONS

We have given a short review on the spectrum generating algebras and applied them to derive the composite ferm ion wavefunctions. As an example we studied the exactly solvable model of harm onic interparticle interactions and derived the wavefunctions and energy spectra for spinless ferm ions and bosons. In this case there is a one-to-one correspondence between the ferm ionic and bosonic wavefunctions: Any ferm ion wavefunction is obtained from the corresponding boson wavefunction by multiplying it with a simple Slater determ in nant.
