# Three-dim ensional magnetic ux-closure patterns in mesoscopic Fe islands

We have investigated three-dimensional magnetization structures in numerous mesoscopic Fe/M o(110) islands by means of x-ray magnetic circular dichroism combined with photoem ission electron microscopy (XMCD-PEEM). The particles are epitaxial islands with an elongated hexagonal shape with length of up to 2.5 m and thickness of up to 250 nm. The XMCD-PEEM studies reveal asymmetric magnetization distributions at the surface of these particles. Micromagnetic sim - ulations are in excellent agreement with the observed magnetic structures and provide information on the internal structure of the magnetization which is not accessible in the experiment. It is shown that the magnetization is in uenced mostly by the particle size and thickness rather than by the details of its shape. Hence, these hexagonal sam ples can be regarded as model systems for the study of the magnetization in thick, mesoscopic ferror agnets.

### I. IN TRODUCTION

The spatial con nem ent of the magnetization in a ferrom agnet of m esoscopic or nanom etric size can have a dram atic impact on both the magnetic properties and the magnetization distribution [1, 2, 3, 4, 5]. Besides the technological importance of understanding and controlling such nite-size e ects in magnetic nanoparticles that can be used for magneto-electronic devices, the physics of the magnetization in con ned structures is a beautiful and exciting research topic [54]. A precise theoretical description of the magnetization distribution in particles of a size between about 100 nm and a few m icrons can be obtained in the fram ework of microm agnetism [6, 7]. Generally, the micromagnetic equations can only be solved num erically. M esoscopic m agnetic particles are too sm all for a meaningful description in term s of macroscopic material constants like the magnetic susceptibility. On the other hand, the simple macrospin model { which could be solved analytically [8] { can only be applied for very small (< 10 nm) magnetic particles [9]. It loses its validity in larger ferrom agnets, where the magnetization distribution is strongly inhom ogeneous.

The subtle size-dependence of the m agnetization [10, 11, 12] is particularly important when the particle size is comparable to the so-called m agnetic exchange length [5, 13], i.e. a material-dependent length scale that describes the order of m agnitude for the extension of m agnetic inhom ogeneities like dom ain walls or m agnetic vortices. Besides the size, also the particle shape is known to have a strong in uence on the magnetic properties of nanostructures. Num erous studies on m agnetic particles of di erent geom etries, like rings [14], rectangles [4], nanow ires [15] and various other geom etries [2, 16, 17] have been reported in the last years. Apart from a few exceptions where three-dim ensional magnetic structures have been investigated numerically (e.g. [18, 19, 20]), experimentally [21] or both [22], most studies on magnetic nanostructures that have been published over the last years have focussed on particles in which at least one dimension is so small that the magnetization in the sample is either two-dimensional (thin-lm elements) or one-dimensional (thin nanowires). Therefore, compared to thin lm elements, where the in uence of the particle shape on the magnetic properties has been amply studied, not much is known about the e ect of spatial con nement in three-dimensional magnetic particles.

Similarly, several types of magnetic domain walls [23, 24, 25, 26] have been investigated thoroughly in extended magnetic lms [5]. In these studies, the sample was essentially con ned in one dimension (the lm thickness). Recently, the in uence of geometric con nement on domain walls has been studied in systems with twodimensional [27] and one-dimensional [28] magnetization, and di erent types of head-to-head domain walls have been predicted [29] and observed [30] in thin magnetic strips or rings of di erent width. However, the e ect of a mesoscopic spatial con nement of three-dimensional magnetic domain walls has hardly been investigated up to now.

In this paper we report on three-dimensional magnetization distributions in mesoscopic ferrom agnets. As a model system, we have analyzed several monocrystalline Fe islands of di erent size (up to ca. 2.5 m length and up to ca. 250 nm thickness). These particles are small enough to display pronounced nite-size e ects of the magnetization, while they are su ciently large and thick to sustain inhom ogeneous, three-dimensional arrangements of the magnetization. The experimental part of this study is performed by means of X-ray magnetic circular dichroism with photoem ission electron microscopy (XMCD-PEEM). The direct comparison of




FIG.1: (color online) (a) A tom ic force m icroscopy of a Fe island, about 1 m long. (b) Schem atic presentation of a typical particle geom etry. The angles = 45 and = 3526 are xed param eters that result from the m onocrystalline structure of the islands. The shape is uniquely de ned by the points  $A_1$ ,  $A_2$ ,  $B_1$ ,  $B_2$  and the thickness t. N ote that this set of param eters is subject to various constraints. For instance, the edges ( $A_1$ ;  $A_2$ ) and ( $B_1$ ;  $B_2$ ) are parallel to each other (the x-direction).

high-resolution experim entalobservations with highly accurate m icrom agnetic com puter sim ulations allows for an unam biguous interpretation of som e com plicated, unexpected m agnetization distributions. This analysis leads us to the conclusion that the Landau pattern, which is well-known from m agnetic thin- Im elements, is merely a sim ple variant of a general, m ore com plex m agnetization structure.

### II. SAMPLE PREPARATION

M esoscopic monocrystalline Fe islands have been grown on atom ically at M o (110) bu er layers of thickness 10 nm [31], deposited on A  $\frac{1}{2}O_3$  (11 20). The growth is performed with pulsed laser deposition (PLD) in ultrahigh vacuum at 850 K.U nder these conditions, Fe islands are formed by means of the Stranski-K rastanov growth mode. A cover layer of M o [three atom ic layers], followed by A 1[3nm] has been added to protect the sam ples from oxidation. A more detailed description of the fabrication of self-assem bled Fe/M o (110) islands is reported elsewhere [32, 33]. The islands have a hexagonal shape, a at top and inclined lateral facets, all atom ically at, see Fig. 1a).

If the growth proceeded under them odynamic equilibrium, the shape of all islands would be expected to be identical, and described by the W ul-K aischev theorem (see [34] and references therein). We indeed observe that the islands share a comm on set of features: the angle of inclination of the lateral facets, the horizontal top facet, as wellas the direction of alledges. How ever, the shape of the particles is generally not symmetric and not uniform. The vertical and in-plane aspect ratios slightly di er from one to another. This may arise from kinetic e ects, the in uence of atomic steps on the M o (110) surface or residual strain. The size ranges between about 500 nm to 2500 nm in length and about 50 to 250 nm in thickness. Our observations suggest that the shape of the particles is well reproduced by taking into account only fo01g and

f110g facets. The exam ination of the constraints related to these facets leads to an idealized geom etrical construction scheme for the shape of these islands as described in Fig 1. U sing this scheme, each island is uniquely described by the four points  $A_1$ ,  $A_2$ ,  $B_1$ ,  $B_2$  and the thickness t. Approximate values for the thickness and the coordinates of these four points have been extracted from electron m icroscopy in ages to construct models that were used as input for the numerical simulations. The density of the islands on the substrate is low enough, so that generally speaking, the magnetostatic coupling between the samples is negligible. O byiously, a few exceptional cases can also be found, where two islands have form ed in close vicinity.

These self-assembled Fe islands can be regarded as a model system for the study of magnetization distributions in three-dim ensional, m esoscopic particles. Due to their high structural quality the Fe/M o (110) islands are particularly suited for this investigation. A comparable quality would be diult to achieve with lithographically fabricated samples, especially for particles of such elevated thickness. The well-de ned shape and structure of the self-assem bled islands ensures that the magnetization distribution in the particle is governed by the spatial con nem ent, and not by roughness e ects or by other structural inhom ogeneities. How ever, the consideration of these islands as model system s for the magnetization in thick, structured magnetic particles is only valid if the details of the particle shape (e.g. the inclination angle of the facets or the precise hexagonal shape) are not of decisive in portance for the resulting magnetic structure. E lse, each particle would have its own characteristicm aqnetic structure depending on its shape, thus precluding an extraction of valuable information of general validity. As will be shown in section VIIB, computer simulations dem onstrate that the aspect ratio, the size and the thickness are the most im portant parameters, while details of the shape play only a minor role concerning the overall m agnetization structure.

### III. EXPERIMENTAL SETUP




FIG.2: Example of an experimental observation of the particle shape and the magnetization structure. (a): Two Fe islands, incidentally located next to each other, in aged with LEEM. (b): The XMCD  $\rightarrow$  EEM image displays the in-plane magnetization component parallel to the incident beam. The beam direction is sketched by the white arrow. Due to grazing incidence of the photons (74 with respect to the plane normal) the back side of the island is shadowed, thus it appears dark in the XMCD  $\rightarrow$  EEM image.

The experimental investigation of the magnetic structures was performed with XMCD-PEEM [35]. The principle of XMCD-PEEM is the spin-and helicity-dependent cross-section for photoelectron emission with circularly polarized X-rays. The lateral resolution of this technique is now better than 30 nm [36], so that detailed images of the domain structure in mesoscopic elements can be obtained. The experiments have been carried out at the Nanospectroscopy beam line of the ELETTRA synchrotron radiation facility [37]. The combination of low-energy electron microscopy (LEEM) and PEEM at ELETTRA makes it possible to image both the morphology and the magnetic structure with the same instrument. In the XMCD-PEEM mode, the sam ples have been illum inated with monochrom atic, elliptically polar-

ized X-rays in a m icro-spot of 20  $5 \text{ m}^2$  (in the horizontaland vertical direction, respectively). The local photoelectron current density was imaged with PEEM. The photoelectron density is proportional to the magneto-M, where is a vector that indicates dichroic signal the direction of the incident light and its helicity and M is the local magnetization vector. A reas with M parallel or antiparallel to have di erent secondary electron yields, which leads to a bright and dark contrast. In most cases, we have chosen an irradiation direction perpendicular to the magnetization direction M in the major dom ains. A lthough in this case the major dom ains show no magnetic contrast, this choice of the beam direction is advantageous because the particularly interesting regions that separate the dom ains, i.e. the dom ain walls, display a strong m agneto-dichroic signal. The im aging of the dom ain walls requires a very high spatial resolution. In the energy range of the Fe  $2p_{3=2}$  (L<sub>3</sub>) absortion edge, the photon ux in the illum instead area is about  $10^{11}$ photons per second, which allows for a fast acquisition of single images, in the range from 10s to 30s for images with a eld of view of 2:5 m diameter. The best lateral resolution in XMCD-PEEM mode has been achieved by recording series of about 30 in ages for each photon beam helicity. The images are post-processed using a self-correlation algorithm [55] to m in im ize drift e ects. F inally, the magnetic contrast is obtained by subtracting graphically the two accumulated in ages at opposite light helicities. The magnetic domain con gurations have been correlated to the precise morphology of the nanostructures using LEEM . The contrast in LEEM is determined by the surface topography and its crystalline structure. In addition to the di raction contrast, the so-called interference contrast allow s one to im age surface steps and thickness gradients in thin Im swith atom ic depth sensitivity and a lateral resolution of few tensnm. This LEEM interference contrast allow ed us to unam biguously determ ine the geometry of the self-organized Fe nanostructures and of their surrounding 45 inclined facets. The quantitative values extracted from the LEEM in ages (islands shape, length, width and height) served as input for the micromagnetic simulations. A typical LEEM image and an XMCD-PEEM in age of the same sample are shown in Fig. 2 (a) and (b), respectively.

# IV. M ICROMAGNETICSAND NUMERICAL METHOD

In the fram ework of m icrom agnetism the m agnetization inside the sam ple is represented as a directional eld M = M (r) with the constraint  $M = M_s = const$ ; where  $M_s$  is the saturation m agnetization. For a description of the intrinsic properties of the m agnetic m aterial, a set of m aterial constants is used. B esides the saturation m agnetization  $M_s$ , the exchange constant A and the anisotropy constant K are required. Them aterial parameters are connected with m icrom agnetic energy term s. In

our case of m agnetic particles with cubic anisotropy in absence of an external m agnetic eld, the relevant energy term s are the exchange energy

We have used K<sub>c</sub> = 4:8  $10^4$  J/m<sup>3</sup>, A = 2:0  $10^{11}$  J/m and  $M_s = 1.73$  10° A/m to describe the material of the Fe islands. The easy axes are oriented along the [001], [100] and [010] directions, cf. Fig. 1b). In eq. (2), 1, 2 and 3 are the directional cosines of the magnetization M with respect to the cubic easy anisotropy axes. These material parameters lead to a quality factor Q =  $2K = {}_{0}M {}_{s}^{2}$  / 2:5 10<sup>2</sup>. A value of O 1 indicates that the material is magnetically soft, i.e. that the arrangem ent of the magnetization is prim arily driven by the need to m in in ize the dem agnetizing energy rather than the anisotropy energy. [56] In eq. (3),  $H_s = r U$  is the stray eld and U is the magnetic scalar potential. The potential U satis es Poisson's equation U = = 0 inside the sample volum e V and the Laplace equation U = 0 outside the sample. The volume charges =  $_0 r M$  and the surface charges = n M (n: outward surface norm al vector) are the sources of the stray eld. The reduction or avoidance of

these charges lowers the stray eld energy [7]. For the inward lim it U<sub>i</sub> and the outward lim it U<sub>o</sub> of the potential at the surface, the N eum ann boundary conditions at the surface @V read

In addition, the boundary condition  $\lim_{x \ge 1} U(x) = 0$  has to be fullled. Details on the numerical calculation of U by means of a combined boundary element / nite element method are given elsewhere [38].

If the m aterial param eters and the anisotropy axes are specied, the magnetic energy of the sample is uniquely determined by the magnetization distribution M (r). In the static equilibrium, the magnetization arranges in a way to minimize the total energy E tot = E exc + E cub + E stray. In the computer simulation, the minimization is performed by using the conjugate gradient method [39]. The minimization has to be performed under the constraint  $M_{\rm j} = M_{\rm s}$ , which can be easily ensured by representing the local magnetization direction with spherical coordinates # and '.

The num erical representation and the m icrom agnetic modelling is performed with the nite element method (FEM ), using a code developed by Hertel [38]. In the nite elem ent representation, the sam ple's volum e is subdivided into tetrahedral elements of irregular size and shape. The magnetization is discretized at the corner points of the elements (the nodes). A piecewise linear representation of the magnetization is obtained by m eans of norm alized, linear interpolation functions that are de ned in each element (the so-called shape functions). The FEM is a particularly powerful and accurate technique for m icrom agnetic simulations. It allows the sm ooth m odelling of particles of general geom etry (with curved or inclined surfaces) and gives the possibility to apply adaptive m esh re nem ent techniques. These unique features of the FEM are of essential im portance for the present study where large sam ples with a com plicated shape are modelled.

# V. THE VAN DEN BERG SCHEME




FIG.3: (color online) Simple magnetic ux-closure patterns in thin- lm elements. a), c): Landau und diam ond structure in a rectangle, respectively, b),d): m odi ed Landau and diam ond structure, respectively, in a hexagonal particle. In the hexagonal element, the closure dom ains are subdivided in two regions separated by an additional dom ain wall (dashed line).

In thin- Im elements, magnetic ux-closure patterns are relatively simple and well-known. The Landau pattern and the diam ond pattern (cf. Fig. 3) are typical examples thereof. Such ux-closure patterns are determined by the particle's boundary and the tendency to avoid magnetic surface charges. In su ciently large softmagnetic thin- Im elements, the magnetization is oriented in the Im plane and is locally aligned parallel to the particle edges. This avoidance of magnetic surface charges gives rise to the form ation of magnetic dom ains. The Van den Berg scheme [5, 40, 41] is a simple graphicalm ethod for the construction of ux-closure patterns in thin- Im elements of arbitrary shape. This method is derived from a rather com plicated m athem atical analysis

that assumes an idealized model for two-dimensional thin Im elements with (a) no magnetic anisotropy, (b) perfect avoidance of m agnetic charges, and (c) dom ain walls of vanishing width. A coording to this scheme, the center point of each circle that touches the particle's boundary at least twice is placed on a domain wall. This construction scheme generally leads to symmetric domain structures, that, despite the idealizations assumed in the m odel, correspond very well to dom ain structures as they are obtained in experim ents [4] and m icrom agnetic sim ulations [11, 42]. The Van den Berg schem e was also found to be valid in self-assembled Fe/Mo(110) elements of m oderate thickness (t < 60 nm ) [22]. In our thicker sam – ples, how ever, we observe ux-closure dom ain structures that dier signicantly from the Van den Berg scheme. It should be noted that the occurrence of deviations from the Van den Berg in thick particles is, per se, not surprising, since the scheme has been derived using a thin- Im approximation. A comparable scheme has not yet been reported for three-dim ensional sam ples. A nalytic studies on the magnetic structure in three-dimensionalmagnetic structures have been reported by Arrott et. al. [43, 44], which were, how ever, restricted to special particle shapes. In this paper we report on system atic, qualitative deviations from the Van den Berg scheme in particles of elevated thickness. In order to highlight these di erences, we shall refer to the idealized ux-closure pattern according to Fig.3a) as the classical Landau structure, which will serve us as a paradigm for magnetic domain structures in thin- Im elements. This term is coined with reference to the original work by Landau [45], where the internal wall structure had been neglected. The classical Landau structure is a ux-closure dom ain pattern in rectangular samples. It contains four 90 walls and one 180 domain wall in the middle. The domain walls are assumed to be straight, thin lines. The 90 walls extend from the corners to the central 180 wall, which is parallel to the long edge of the rectangle and with which they enclose an angle of 135. To a very good approximation, this pattern corresponds to experim ental observations of dom ain structures in rectangularm agnetic platelets. But also in particles of non-rectangular shape and even in extended lm s [46] this type of structure has been observed. In a hexagonal particle, the four-dom ain Landau in a rectangle turns into a structure with six domains [cf. Fig.3b)]. A distinction between this structure with six domains and the Landau pattern may be neglected since the dom ain pattern is very sim ilar to the classical structure with four dom ains: two maprdom ains and two closure dom ains. Therefore, such m odi ed variants also have been reasonably labeled as \Landau structure", or som etim es as \Landau-type structure" in the literature, in spite of more or less pronounced di erences from the classical structure. In our case of thick particles, how ever, the di erences are signi cant and we require a different wording. Our study suggests that in the threedim ensional case, the classical Landau structure is replaced by a complex ux closure pattern with characteristic features. We shall call this the generalized Landau structure and we will discuss this structure in detail in section VIIA.

### VI. RESULTS

### A. A sym m etric ux-closure patterns

We have taken LEEM and XMCD-PEEM images of the magnetization at zero eld of about thirty Fe islands. In all cases, ux-closure magnetization patterns have been observed.




FIG. 4: (color online) D i erence between idealized and observed m agnetic dom ain structure. a) LEEM image of the sample shape.XMCD-PEEM image of the m agnetic dom ain structure. c) Schem atic dom ain structure for the given shape according to the V an den B erg schem e. d) A pproxim ate shape of the m agnetic dom ains according to the experim ental observation.

Fig. 4b) shows an example of a typical dom ain pattern observed in the experiments. The grey scale displays the y component of the magnetization, i.e. the projection of the magnetization at the surface along the polarization of the incident beam. The magnetic structure in g. 4b) is clearly subdivided into dom ains, but the shape of the domains is not in accordance with the Van den Berg scheme, as can be seen by comparing g. 4c) and g. 4d). The grey scale in these schem atic drawings refers again to the y component, so that the dashed dom ain walls sketched in Fig. 4c) would not be visible in this experiment, since they separate regions of di erent magnetization direction with the same value of  $m_y$ . Sim ilar to the classical Landau structure, the magnetization distribution in Fig. 4b) is split into four dom ains: two major dom ains where the magnetization is parallel to the long edge and two closure dom ains that connect the magnetic ux between the major dom ains. How ever, neither the shape of the dom ains nor the position of the dom ain walls corresponds to the

W e have found such distorted, asym m etric dom ain patterns bearing only a weak resemblance to the classical Landau structure in all the particles that we have investigated, as we will discuss in section VIC. The reason for the asym m etric structures and the deviations from the Van den Berg scheme lies in the three-dimensional nature of these particles.

Van den Bergscheme.

### B. M icrom agnetic Sim ulations

The XMCD-PEEM experiments only provide inform ation about onem agnetization component (the component parallel to the incident beam) on the at, topm ost surface of the sample. Therefore, numerical simulation methods are employed to investigate the internal structure of the magnetization. The simulation results are cross-checked with the experimental observations to guarantee that the simulated structures correspond to the observed ones.

Simulating them agnetization in these particles is problem atic because of their size, which is enorm ous from the point of view of computationalm icrom agnetism. In particles of large size, it is di cult to avoid discretization errors that result from too large discretization cells. The consequence of discretization errors is not only a rough representation of the magnetization, but also wrong results due to num erical \dom ain wall collapse" [47], i.e. an unrealistic, large change of the magnetization direction within a single disretization cell. To avoid discretization errors, the size of the discretization cells should not exceed the exchange length =  $2A = (_0M_s^2)' 3 \text{ nm}$ . Since the particle volume is of the order of 1 m<sup>3</sup>, simulations with a regular grid would require an unsustainably large number of several millions of discretization cells. An adaptive mesh re nement technique [48] has been em ployed to solve this problem. Such adaptive m ethods are particularly powerful for static m icrom agnetic sim ulations of large particles, where the inhom ogeneities of the magnetization are limited to a small fraction of the sample's volume. These regions, i.e. the domain walls, require a high discretization density, whereas large domains with homogeneous magnetization can be calculated safely with a coarse mesh. Therefore, adaptive renem ent m ethods allow for accurate num erical results while keeping the computational costs (processing time,




FIG. 5: (color online) To avoid discretization errors in the simulation of the three-dimensional magnetic domain structure, the sample is rst reduced to a tenth of its size. By using cycles ofm icrom agnetic energy m in in ization and threedimensional adaptive mesh renement, the sample is gradually increased to its real size (a). A fler this procedure, a niteelement mesh with regions of strongly dienent discretization density is obtained (b). The nite elements are particularly small in regions of strong magnetic inhom ogeneities (vortices, domain walls). Owing to the mesh renement, even the nanometric vortex core with magnetization perpendicular to the surface is fully resolved, as can be seen in the red spot in panel (c). Throughout the paper, unless otherwise specied, the color coding used to represent a magnetization component is chosen according to the bar on the bottom of panel (a).

# $\operatorname{m}\operatorname{em}\operatorname{ory})$ low .

The procedure we have applied for the m icrom agnetic simulations is as follows. First, the exact geometrical shape of each Fe island is extracted from LEEM images and a corresponding nite element model is constructed. Subsequently, the model is scaled down to 1/10 of its actual size. The magnetization distribution in this small island is simulated by means of energy m inimization, using a symmetric vortex structure around the center as initial con guration. Once a converged solution is found, the mesh is adaptively re ned and the equilibrium structure is calculated with the re ned mesh. The cycle of mesh re nement and energy minimization is repeated until the maximum angle enclosed between the magnetization vectors at two neighboring discretization points drops below

=10. Then, the size of the sam ple is increased, and the procedure of mesh re nem ent and energy m inim ization is repeated. W ith this iterative process, the sam ple size is increased in sm all steps towards its real value and the mesh is progressively re ned. This way of slow ly \inating" the sam ple guarantees that the magnetic structure is calculated w ithout discretization errors. The sim -

pler variant of sim ulating the magnetic structure directly with a coarse mesh, without reducing the sample's size, and subsequently applying the mesh re nement procedure is less accurate because the st calculation would lead to large discretization errors. Especially in threedim ensional calculations, it is advisable to prevent discretization errors rather than trying to remove them a posteriori. An example for the simulation of the magnetization by means of stepwise increase of the sample size is shown in Fig. 5a). The typical cell size of a rened mesh is between about 25 nm in the hom ogeneous regions and 1.5 nm in the re ned regions. By increasing the sam ple size, we nd that the sym metric vortex structure in small particles evolves to an asymmetric domain structure above a certain sample size. Such a transition can be seen in Fig. 5a), where the asymmetry occurs after the sample has been increased to 50% of its actual size. The form ation of the asymmetric structure obviously involves a breaking of sym m etry: the vortex which is originally placed in the center may either shift to the right or to the left side on the top surface. As will be discussed later, the sign of the perpendicular component in the vortex core may also have a strong in uence on the resulting dom ain structure.

# C. Comparison between Experiment and Simulation




FIG.6: Experimental and simulated data for veself-assembled Fe/M o (110) islands of diement size and shape (a-e). First row: The shape of the particle is obtained by LEEM imaging. The particle thickness is derived from the width of the (001) facets, which appear as a dark border around the hexagonal top surface, by using the known inclination angles of the inclined facets (cf. Fig. 1). The sample's approximate lateral dimension and thickness is displayed on top of each column. Second row: One magnetization component in the surface plane is imaged as grey scale with XMCD-PEEM. In sample (a), the contrast refers to the magnetization component parallel to the long edge while in the other samples the in-plane magnetization component perpendicular to the long edge is displayed. Notice that only the top surface, i.e. the light grey internal hexagon in the rst row, is imaged. Third row: M icrom agnetic simulation results. To compare the results with the XMCD-PEEM experiments, the same magnetization component is displayed in grey scale. The sample shape was modelled according to the LEEM images and the model explained in Fig. 1.

The simulation results are in excellent agreement with the experimental data. A number of examples are shown in Fig. 6. The experimentally observed asymmetric shape of the end domains and the position of the domain walls are reproduced almost perfectly by the simulations. All the unexpected features of the domain patterns and their deviation from the Van den Berg scheme occur in just the same way in both the experiment and the simulations. Notice that all these details of the magnetic structure develop automatically in the simulation by using a simple vortex as a starting con guration.

The one-to-one correspondence between experimental and simulated surface magnetization is a strong indication that the simulated structures are indeed equal to the experimental ones. Therefore, the simulations can be used to obtain information that is not directly accessible in the experiment, i.e. the three-dimensional structure of the magnetization inside the sample. The investigation of the inner structure of the magnetization is a prerequisite for the explanation of the unexpected experimental results.

#### VII. DISCUSSION

## A. Internal dom ain wall strucure

The magnetization distribution inside the sample differs signi cantly from the distribution observed at the




FIG.7: (color online) M agnetization distribution on di erent cross sections. The example shown here refers to the particle displayed in Fig. 6b). The gures (a) and (d) show the top view on the three-dimensional sample with lateral facets. (b), (e): cross-section through the middle of the sam – ple at z = t=2; (c), (f): M agnetization on the bottom surface of the sam ple, z = 0. (g):  $m_z$  component on the cross-section through the middle of the xz-plane. (h-j): asymmetric B loch wall: m agnetization components on a cross-section at mid-length, parallel to the yz-plane.




FIG. 8: (color online) Simulation of four di erent con gurations in a sam ple of identical shape. The shape and the size of the sam ple is the sam e as in g. 6d). A lthough topologically the structure is very similar in all cases (Landau structure with asym metric B loch wall), the resulting magnetic patterns are signi cantly di erent. In the structures (a) and (b) the B loch component of the internal wall, m<sub>z</sub>, is positive, whereas in (c) and (d) it is negative. The structures (a) and (c) have the sam e direction of the magnetization in the N eel caps, m<sub>y</sub>, which is opposite to the orientation in the structures (b) and (d).

surface. A typical example is shown in Fig. 7a), b,)c) that displays the y component of the magnetization on three cross-sections at the top (z = t), the m iddle (z = t=2)and the bottom (z = 0), respectively. The coordinate fram e is chosen according to Fig. 1. In the middle cross section, the dom ain pattern is alm ost symmetric and in good agreem ent with the Van den Berg scheme, while on the top and the bottom the structure is clearly asymmetric. The twist is in opposite directions on the top and the bottom surface, cf. 7a), c). The inhom ogeneity of the magnetization along the z-direction and the resulting asymmetry in the top and bottom xy-plane result from the form ation of an asymmetric 180 Bloch wall [26, 49]: in the middle of the sample (z = t=2) the major domains are separated by a B loch wall, while on the top and bottom surface, the transition between the major domains is given by a Neelwall (the so-called Neel caps). In a cross section on a plane with x = const. through the middle of the sample, the typical pro le of an asym metric B loch wall resulting from the combination of Bloch and Neel wall can be clearly seen 7h), i), j). There are di erent possibilities for the orientation of the magnetization in this type of domain wall: The magnetization in the Bloch part can point either in the positive or in the negative z direction, and the magnetization in the Neel caps can point either in the positive or negative y direction. The orientation or the chirality of the asymmetric B loch wall can have a strong im pact on the resulting dom ain structure, as shown in Fig. 8. Depending on the direction of the magnetization of the Neel caps and the direction of the inner B loch component, the magnetic domain struc-

ture on the surface m ay be very di erent. In the example shown in Fig.8, the computer simulation rst yielded the structure (a) for this geometry. In the simulations, the aforem entioned breaking of symmetry that is involved with the form ation of such structures results from num er-

ical roundo errors and the direction in which the Neel caps evolve is impredictable. This imponderability can be rem oved by breaking the symmetry with an oblique, weak external eld that is applied during the simulated expansion of the sample, cf. Fig. 5a). With this controlled breaking of sym m etry we obtained the structures shown in Fig. 8, including the structure (d), which alm ost perfectly reproduces the experim ental observation, cf. Fig. 6d). A part from possible m inor di erences concerning the out-ofplane component of the magnetization along the facets, there are fourm ain types of such alm ost degenerate structures, corresponding to the two possibilities for the orientation of the B loch component and the Neel caps, respectively [57]. In a sense, these structures can be com pared to geom etric isom ers of a m olecule: The dom ain structures contain the same components (Landau structure with asymmetric internal walls), but the orientation is di erent (opposite orientation of the Neel caps and/or of the Bloch wall). The dom ain structures of such \isom ers" can di er signi cantly in their patterns on the surface, especially if the sam ple shape is strongly asym m etric.

In any case, the N eel caps of an asym etric B loch wall are oriented in opposite direction on opposite surfaces. The form ation of an asym m etric B loch wall represents an energetically optim ized arrangem ent concerning the stray eld energy. M agnetostatic volum e charges = r Mare largely avoided by the form ation of a B loch wall in the center of the sam ple and surface charges  $= M n^{2}$ ( $n^{2}$ : surface norm al vector) are e ectively suppressed by the N eel caps. D epending on whether the m agnetization in the N eel caps is pointing parallel or antiparallel to the m agnetization direction in the closure dom ains (the

dom ains close to the particle's border in the x direction), the Neel caps are either connected sm oothly to the closure domain or separated by them with a magnetic vortex, respectively [50]. Inside the closure dom ain, on cross-sections with constant value of x, the structure is similar to an asymmetric Neel wall. The main dierence between an asymmetric Neelwalland an asymmetric Bloch wall is the relative orientation of the magnetization in the Neel caps, being parallel in the former and antiparallel in the latter. It has been predicted, by m eans of num erical simulations, that the combination of asym m etric wall types in m esoscopic, soft-m agnetic particles leads to a pronounced in-plane asymmetry on the top surfaces [18, 51]. Our XMCD-PEEM investigations on several mesoscopic Fe islands clearly con m this prediction and provide the rst direct observation of this e ect.

# B. Shape dependence

In the num erous particles that we have investigated, we have alm ost exclusively found the Landau-type uxclosure pattern described above, the generalized Landau structure. A few exceptions of di erent m agnetization arrangements will be discussed in the next sections. The generalized Landau structure consists of four dom ains, two m a pr dom ains that are connected by an asym metric B both wall and two closure dom ains connected to the m a pr dom ains by 90 walls. Our observation of the Landau structure in self-assem bled Fe islands with their quite com plicated hexagonal shape and the inclined facets suggests that the form ation of this arrangement of the m agnetization is rather driven by the particle's aspect ratio and its size than by the rectangular shape.

The question arises to which extent the asymmetric Landau pattern that we observed is specic to our example of hexagonal particles with inclined facets. How sensitively does the magnetic structure depend on the precise shape of the particle? To answer this question, the in uence of the particle shape on the resulting magnetic dom ain structure has been investigated with m icrom agnetic simulations. Unlike the real world, where the

shape of the Fe islands is determ ined by the energetics of the grow th m ode, nite elem ent m odels give the possibility to study magnetic structures in mesoscopic particles of arbitrary shape. Starting from a \real" island, i.e. one that is modelled exactly according to the experiment, we have rst tested to which extent the magnetic pattern is a ected by the inclined facets and the asymmetry of the hexagon. This has been done by simulating the magnetization in a hexagonal particle of same thickness and size, but with symmetric hexagonal shape and a \cookie-cutter" geometry, i.e. an island with perpendicular facets. The result is displayed in Fig. 9b). The asymmetric magnetic structure is practically the same as it has been observed in the real island with inclined facets, indicating that neither the inclination of the facets nor the asymmetry of the hexagon has a decisive impact on the magnetic structure. To further check whether the hexagonal shape is of importance for the resulting magnetic structure, a at, elliptical particle has been modelled. The major axes of the ellipse (parallel to the x and y direction, respectively) correspond to the width and length of the original island and the thickness is again the same. The result [Fig. 9c)] shows that the distorted Landau structure also occurs in this particle. Recent studies [58] show that practically the sam e structure m ay also be found in an ellipsoidal particle of com parable size and aspect ratio. These computer experiments indicates that the generalized Landau structure is hardly determ ined by the particle shape. This is in contrast to two-dimensional samples, where the essential importance of the sample shape re ects in the Van den Berg construction scheme, where the domain structure is determ ined exclusively by means of the particle shape. The occurrence of the three-dim ensional, generalized Landau structure is neither restricted to particles of rectangular, hexagonal or any other speci c shape; not even to at particles. In the three-dimensional case, it is rather the thickness, the size and the aspect ratio that are decisive. The primary tendency of the magnetization in thick, three-dimensional particles appears to be to develop an asymmetric 180 Bloch wall, while in the case of thin-lm elements, the major domains may either be separated by a 180 wall (classical Landau structure) or by 90 walls (diam ond state).

### C. Diam ond structure

By far, the m agnetization states that we have observed m ost frequently are the above-m entioned variants of the Landau structure. The absence of the \diam ond state" in these thick elements is remarkable. The diam ond state is an alternative ux-closure pattern with seven dom ains (cf. Fig.3) that is frequently observed in thinner softm agnetic particles [22, 33, 51] of sim ilar size.

We suspect that the predom inance of the Landau structure and the absence of the diam ond state can be explained with energetic considerations in connection with




FIG.10: In a relatively large and particularly thin island, identi able as such in a LEEM in age (a) by the thin dark boundary (the lateral facets), a \diam ond state" m agnetization structure was found. The diam ond state is characterized by two vortices with opposite vorticity and a diam ondshaped central dom ain, which is clearly recognizable on the right panel (b).

the elevated particle thickness. The thickness dependence of dom ain con gurations in nanoscale Fe/W (110) islands of signi cantly lower thickness (ca. 3-8 nm ) has been studied recently by Bode et al. [52]. In the present case, the idea is the following. Essentially, the Landau structure has one central 180 wall and four 90 dom ain walls, whereas the diam ond structure consists of seven dom ains that are separated by eight 90 dom ain walls. W hile in the case of a 180 wallm agnetic volum e charges can e ciently be avoided by the form ation of an asym metric Bloch wall, a 90 wall inevitably contains volume charges = r M , like a Neel wall does. W ith increasing thickness, the energy connected with these volume charges increases and so does the tendency to avoid them . The tendency to avoid these charged 90 walls and, instead, to form a 180 wall, favors the form ation of the Landau structure over the diam ond structure. If this consideration is correct, the tendency to avoid the diam ond state should decrease with decreasing thickness. W e therefore searched for the diam ond state in islands of large in-plane extension (to ensure that the particle is in a multi-dom ain state) that were particularly thin. In our set of sam ples the typical thickness was about 100-150 nm, but we eventually found an island of 65 nm thickness and about 1000 nm 500 nm lateralextension. The XMCD-PEEM investigation of the magnetization in this island indeed showed that the sample was magnetized in the diam ond state, cf. Fig. 10. This sam ple is the only one in which we found the diam ond state. The fact that we have observed this state only after a selective search aim ed at nding particularly thin elements suggests that the thickness, actually, plays a decisive role. Further studies are required to system atically analyze this suggested thickness dependence of magnetization states.

#### D. Vortex structure

Besides the thickness and the size, also the in-plane aspect ratio has an impact on the resulting magnetization state. This can be seen by comparing the magnetic structure of two islands of sim ilar thickness and width, but di erent length, cf. Fig. 6)b),c). In one case, the aspect ratio (length in x direction vs. width in y direction) is 2.1 and in the other it is about 1.5. The particle with lower aspect ratio has a vortex in the center of the sample. It contains no asymmetric Bloch wall and the closure dom ains are asym metric and twisted. They are stretched in the x direction and they join in the m iddle of the sample at the vortex. In contrast to this, the longer sample has a clearly developed 180 dom ain wall in the m iddle which separates the major domains. O by iously, a su ciently large particle with aspect ratio approxim ately equal to one would not form a Landau structure with a central 180 dom ain wall, but would be magnetized in a simple vortex state with a magnetic vortex structure in the centre of the sample. W ith increasing aspect ratio, the vortex core is stretched until it eventually perform s a kink through the sam ple and form s the center of an asym metric Bloch wall. Thus, by changing the aspect ratio, a transition from a vortex state to a generalized Landau structure occurs at a critical size. W hether this transition is continuous or discontinuous m ay be the subject of future studies.

# E. Bloch switch




FIG.11: (color online) (a-c): z;x and y component of the magnetization of a simulated magnetic domain structure with undulated central domain wall. (f) z-component of the magnetization on a cross-section of constant y. The alternating red-blue regions indicate switches of the B bch component. (d): LEEM in age and XMCD-PEEM in age (e) of a sample in an apparently similar magnetization state. The size of the island is 1500 nm 620 nm 130 nm.

In most cases the simulations yield magnetic structures that agree very well with the ones that have been observed in the experim ents, but occasionally som e interesting di erences between simulation and experiments have occurred. The possible di erences concerning the chirality of the asym m etric central B loch wall have already been discussed in section VIIA. A nother variant of the Landau structure was obtained in one case, where the simulation has yielded a structure as shown in Fig. 11b), c). Instead of the usual straight line, the central domain wall (i.e. the Neel cap) displays a pronounced kink. It is known from studies of asymmetric domain walls in extended magnetic Im s that such a kink is characteristic for a so-called B loch switch [5, 53]. A B loch switch is given when the sign of the B loch component changes along the dom ain wall inside the lm, while the magnetization direction of the Neel caps remains unchanged. In fact, a look at the inner part of the simulated magnetization structure [Fig. 11f)] shows that the arrangement contains Bloch switches. We have also observed a similar kink in the experiment, as shown in Fig. 11e).

This example is the only island in which we have found this kink experimentally, and it can therefore not be ruled out that the kink may have other reasons than a Bloch switch like, e.g., a structural inhom ogeneity of the island. Moreover, the top surface of the island in which we observed the kink was not ideally at, as could be seen by the shadow of the island as described in Fig. 2b). Due to these deviations of the sample morphology from the ideal construction scheme according to Fig. 1, the model for the island shape that has been used in the simulations that yielded a Bloch switch does not correspond exactly

to the island in which the kink has been observed experim entally. Therefore, although a correspondence between experiment and simulation is likely, the available data from simulation and experiment are not su cient for an unambiguous proof that the kink results from a Bloch switch. The results, however, suggest that an asymm etric Bloch wall with a Bloch switch may develop also in patterned particles and that such a Bloch switch would lead to a considerable distortion of the otherwise straight central dom ain wall. To our know ledge, this kind of dom ain wall has not been reported previously in patterned elements.

### VIII. CONCLUSIONS

\The simplest problem in continuum magnetism in a singly connected nite body is the Landau structure (...), but it remains an unsolved problem to describe it in all its details." This is a quote from a paper by A.S. A mott and T.L. Templeton [50] that was written in 1997, at a time when the experim ental resolution was not yet su cient for a direct observation of details of the m agnetization and m ost m icrom agnetic sim ulation m ethodswere not accurate enough for large, three-dimensional computations [59]. Owing to the combination of (a) advanced grow th m ethods yielding high-quality, m onocrystalline m esoscopic Fe particles that can be regarded as model systems, (b) LEEM imaging to obtain detailed information on the particle shape, (c) high-resolution XMCD-PEEM studies that provide information on the in-plane m anetization at the particle surface, and (d) accurate FEM /BEM m icrom agnetic m odelling with adaptive mesh re nement techniques providing a detailed m odel of the three-dim ensional magnetization structure, we have solved the problem of a full description of the Landau structure. The Landau structure seems to occur as a m in im um energy arrangem ent in soft-m agnetic particles of very di erent shape. Generally, the size, thickness and aspect ratio are m ore in portant for the form ation of the generalized Landau structure than details of the particle's shape and its surfaces. The fascinating com plexity of the Landau structure occurs when the particle is thick enough to sustain an asym metric B boch wall. The classical, sym metric Landau pattern occurring in rectangular thin lm elements can be regarded as a sim ple thin-lm lim it of a more general, three-dimensional structure. In the thin-lm lim it, the central asym metric B boch wall is replaced by an ordinary Neel walls, thus sim plifying drastically the arrangement.
