## On The Universal Scaling Relations In Food Webs

In the last three decades, researchers have tried to establish universal patterns about the structure of food webs. Recently was proposed that the exponent characterizing the e ciency of the energy transportation of the food web had a universal value (=1:13). Here we establish a lower bound and an upper one for this exponent in a general spanning tree with the num ber of trophic species and the trophic levels xed. When the num ber of species is large the lower and upper bounds are equal to 1, in plying that the result = 1:13 is due to nite size e ects. We also evaluate analytically and num erically the exponent for hierarchical and random networks. In all cases the exponent depends on the num ber of trophic species K and when K is large we have that ! 1. M oreover, this result holds for any num ber M of trophic levels. This means that food webs are very e cient resource transportation system s.

Understanding energy and material uxes through ecosystem s is central to m any questions in ecology [1, 2, 3]. E cological com m unities can be studied via resource transfer in food webs [4]. These webs are diagram s show ing the predation relationships among species in a com munity. U sually, a group of species sharing the same set of predators and the sam e set of prey is aggregated in one trophic specie [5, 6]. So, each trophic specie is represented by a site and denoted by an integer num ber i = 1; ::: ;K , where K is the total num ber of trophic species. A relation between a pair of sites is represented by a link directed from the prey to predator. There are several quantities introduced in the literature to characterize the food web structure, such as the fractions of the species in the trophic levels (basal, interm ediates and top), the fractions of links am ong them, the connectance, the average distance between two sites, the clustering coe cient and the degree distribution. It turns out that all these quantities are nonuniversal [7] and dependent of the size of the food web. Perhaps, the only variable in common agreement with the literature is the maximum value of trophic levels (M 4). Garlaschelli et al. [8] have considered food web as transportation networks [9, 10] whose function is to deliver resources from the environment to every specie in the network. In this case, food webs appear to be very sim ilar to other system swith analogous function, such as river and vascular networks. In that work they have represented a real food web by spanning trees with minimal lengths. For each specie i the num ber A i of species feeding directly or indirectly on i, plus itself, is computed. They also computed the cost of this transfer, namely  $C_i = \sum_k A_k$ , where k runs over the set of direct an indirect predators of i plus itself. The shape of C<sub>i</sub> as a function of A<sub>i</sub> follows a power law relation C (A) A , where the scaling exponent quanti es the degree of optim ization of the transportation network. They found the same allom etric scaling

relation for di erent food webs. By plotting C<sub>i</sub> versus A<sub>i</sub> for each one of the seven large food webs in the literature, and by plotting C<sub>0</sub> versus A<sub>0</sub> for a set of di erent food webs. The exponent found, varies between 1:13 and 1:16. Therefore, they concluded that the exponent has a universal value (= 1:13) and it is, perhaps, the only universal quantity in food webs. Nevertheless, this matter has been the subject of debates [11, 12].

Here we establish an upper bound  $(m_{ax})$  and a lower one  $(m_{in})$  for the exponent in a general spanning tree with M trophic levels and K trophic species, both xed. In the limit K ! 1, we have that  $m_{ax} = m_{in}$  ! 1. We also evaluate analytically and numerically the exponent for hierarchical and random networks. Our main conclusions are that (a) the result = 1:13 for food webs is due to nite size e ect (sm all K), (b) the exponent depends on the K and when K is large we have that

= 1. M oreover, this results hold for any number M of trophic levels, in plying that food webs are e cient resource transportation networks.

It is worth mentioning that this problem is related to river and vascular networks [9]. Consider K sites uniform ly distributed in a d-dimensional volume. The network is constructed by linking the sites, in such way that there is at least a path connecting each site to the source (a central site). Since each site is feed at steady rate  $\mathbf{F}_i = \mathbf{F}$ , the metabolic rate B clearly is given by  $_{i}\,F_{\,i}=\,F\,K$  . Let  $I_{b}$  represent the m agnitude of ow в = on the b<sup>th</sup> link. Then, the total quantity of nutrients in the network, at a particular time, is given by  $V = \int_{b} I_{b}$ . They de ne the most e cient class of network as that for which V is small as possible. Using this procedure they  $B^{(d+1=d)}$ . For river basins, d = 2 and found that V  $B^{3=2}$ . In vascular system s V  $B^{4=3}$  since d = 3. V The variables  $A_{\,0}\,$  and  $C_{\,0}\,$  of the food webs are related, respectively, to the num ber of transfer sites N and to the total volum e of nutrients V by the following equations:  $N = A_0$  1 and  $V = C_0$   $A_0$ . Then we have that  $C_0 = A_0^{(d+1=d)}$  if  $A_0$  is large enough. The value of the exponent for a food web can be smaller than the one of rivers ( = 3=2) or the one of vascular systems ( = 4=3) because the spanning tree of a food web is not embedded in an Euclidean space.

Let us consider a hierarchical network with M trophic levels. The network is constructed in the following way. We begin with a site representing the environment, the site 0. Then we connect  $n_1$  sites to it, since these sites are feeding directly of the environment they constitute the rst trophic level. O by by, the number of species in this level is  $N_1 = n_1$ . The second level is constructed by connecting  $n_2$  sites to each site of the rst level. Now, in this level, we have  $N_2 = n_1 n_2$  species. This procedure is repeated until the level M.

Since  $A_i$  is the number of species feeding directly or indirectly on site i, plus itself, we have that

The cost of resource transfer, de ned by  $C_i = \begin{bmatrix} k & A_k \end{bmatrix}$ , where k runs over the set of direct and indirect predators of i plus itself is given by

The exponent , as was proposed in the literature [8], can be found by (a) plotting C<sub>i</sub> as a function of A<sub>i</sub> for a network with number of trophic level M and total specie number K xed; U sually, the point (1;1) is neglected due to nite size e ects. It can be also found by (b) plotting C<sub>0</sub> as a function of A<sub>0</sub> for several networks with di erent trophic species number K. This last procedure determ ines the large scale exponent [12]. Note that in hierarchical spanning tree networks, C<sub>i</sub> and A<sub>i</sub> for species in the same trophic level are equal, in plying that we have only M + 1 points in a C<sub>i</sub> A<sub>i</sub> plot. Let us rstly use procedure (a) for networks with constant ram i cation ratio n<sub>i</sub> = n and constant number of trophic levels M = 4. We nd = 1:39 for n = 2 and K = 30 and = 1:27

for n = 3 and K = 120, as it is shown in gure 1. C learly, the exponent depends on value of K, and decreases as long as K grows. In the lim it that n ! 1, the total number of species K also is unlimited and we obtain that the exponent approaches the value 1.




FIG.1: Log-log plots of  $C_i$  versus  $A_i$  for networks with constant ram i cation ratio n = 2 and n = 3. Note that the exponent decreases when n grow s.

Let us return to the more general case of hierarchical models. The large scale exponent can be evaluated by,

$$= \frac{\ln C_0}{\ln A_0} = \frac{\ln [1 + \frac{P_M}{e_1} (+1)^Q]_{i=1} n_i]}{\ln (1 + \frac{P_M}{e_1} (+1)^Q)_{i=1} n_i)} : (1)$$

If at least a ram i cation ratio is large, n ! 1, we have that  $\ln A_0 \quad \ln n$  and  $\ln C_0 \quad \ln n$ . Therefore we nd ! 1 when the number of species is large. We can also use Eq.1 to evaluate the exponent for hierarchical networks with constant ram i cation ration. We nd for this networks = 1:41 (n = 2 and K = 30) and = 1:31 (n = 3 and K = 120). These values can be compared with the ones obtained previously with procedure (a) (see Fig.1).

In the Eq.1 the exponent depends on value of K, decreasing as long as K grows. For example, consider the hypothetical food web with total specie trophic numbers in each level given by N<sub>1</sub> = 38, N<sub>2</sub> = 63, N<sub>3</sub> = 43 and N<sub>4</sub> = 2. We nd the exponent = 1.22. But, if we double the number of trophic species in each trophic level N<sub>1</sub> = 2N<sub>1</sub> the exponent is now 1.19. In that equation the exponent also depends in the relative distribution of the species in each level above with 146 trophic species we change the distributions of species in each level to N<sub>1</sub> = 114, N<sub>2</sub> = 20, N<sub>3</sub> = 10 and N<sub>4</sub> = 2. We nd the exponent = 1.16. The exponent has changed from

= 1.22 to = 1.16

Now, let us consider a random network with M trophic levels and K trophic species. The network is constructed in the following way. First, we determ ine random by the population in each level N ( = 1; 2; :::; M), obeying the restrictions M xed and K xed. Then, the N<sub>1</sub> sites are connected to the environment, constituting the rst trophic level. The second level is constructed by random by connecting the N<sub>2</sub> sites to the N<sub>1</sub> sites of the rst level. This procedure is repeated until the level M

is constructed. In this case, we can evaluate the mean value of  $A_1$  and  $C_1$  in each level, namely

Here specify the trophic level ( = 1;:::; M). These quantities are averaged on several random con gurations. Note that in the last level we have that  $\overline{A}_{M} = A_{i} = C_{i} = \overline{C}_{M} = 1$  and that we always neglect the point (1;1) in all ts




FIG.2: Log-log P lots for random networks. (a)  $\overline{C}$   $\overline{A}$  for a network with K = 123 and M = 4 (b)  $\overline{C}$   $\overline{A}$  graph for a random network with K = 10000 and M = 4. Note that when K is large enough the exponent 1

A graph for a In Fig. 2(a) it is shown the  $\overline{C}$ random network with K = 123, the same number of trophic specie that the Y than E stuary with parasites, and M = 4. A best t furnishes = 1:18. A similar t for K = 93, the sam e num ber of trophic specie that the Little Rock Lake food web, and M = 4 give us = 1:21. Note that the exponent decrease when K increases. C learly, our exponent is larger than that found by [8] for the same trophic species number K. But, when K grows our exponent become smaller that them . O by jously, if = 1:13 represent a universal value for food webs of all the sizes, then random spanning trees networks with the same number of trophic levels M are more e cient than food webs. In g.2(b) it is shown the C A graph for a random network with K = 10000 and M = 4. Note that when K is large enough the exponent 1




FIG.3: Log-log P lots for random networks. (a)  $C_0 = A_0$  for M = 4 and K varying from 50 up to 1000 and (b)  $C_0 = A_0$  for M = 10 and K varying from 200 up to 5000. Note that the large scale exponent has the same value = 1:00 and is independent of M.

The exponent can also be computed by the procedure (b). For each value of K we perform an average for several con gurations and nd the mean value of C<sub>0</sub>. In Fig. 3(a), it is shown the C<sub>0</sub>  $A_0$  plot for random networks with M = 4 and K varying from 50 up to 1000. Now we have that = 1:00. It is worth mentioning, that C<sub>0</sub>  $A_0$  always firmishes = 1 independently of the range of K. We have also simulated random networks with M = 10 trophic levels. In Fig. 3(b) it is shown the C<sub>0</sub>  $A_0$  plot. The results are similar.

Now let us present the central point of this paper, a general argument to demonstrate that the large scale exponent is = 1 for large K. Let us consider a spanning tree with M and K, both xed. To obey the constraint of M xed, we put one site in each level. Now we must put each one of the reminder K M sites. Since  $C_0$  is cumulative, a site put as near as possible of the environment has the minimal contribution to the global cost. On the other hand, a site put as far as possible of the

environm ent has a maximal contribution to C<sub>0</sub>. To construct the network with maximum value of C<sub>0</sub>, C<sub>0µmax</sub>, we must link all K M sites to the site of the last level. In this network we have N<sub>1</sub> = N<sub>2</sub> = :::= N<sub>M 1</sub> = 1 and N<sub>M</sub> = K M + 1. C<sub>0µmin</sub> is obtained by linking the K M sites directly to the site representing the environment. In this case, we have that N<sub>1</sub> = K M + 1 and N<sub>2</sub> = N<sub>3</sub> = :::= N<sub>M</sub> = 1. Note that these constructions are the closest networks to the star-like and chain-like ones, respectively, that obey the constraints of M and K xed. Using the Eq. 1 we have,

Then, the lower and the upper bounds for the exponent are

$$m_{ax} = \frac{\ln C_{0,max}}{\ln (K + 1)} = \frac{\ln [1 + K (M + 1) + \frac{M}{2} (1 - M)]}{\ln (K + 1)};$$

W hen K ! 1, we have that  $m_{ax} = m_{in}$  ! 1.

C onsider again the simulation of random networks. We veried that the constructions with m inimum and maximum  $C_0$  are the ones just described. Moreover, the result above explains why we nd ! 1 when K is large in the simulations of random networks.

In sum mary, we studied the transportation properties of several networks that represent spanning trees of food webs. First, we analyzing an idealized hierarchicalm odel that can be analytically solved. Then we show that the exponent depends on value of K and, in the lim it that K is large enough, the exponent approaches the value 1. A fter, we construct random networks that more realistically represents a spanning tree form ed by food webs. W e evaluate num erically the exponent by several procedures. Again, in all cases the exponent depends on size of web and if K is large ! 1. One important point is that all the results are independent of the num ber of trophic levels M . Moreover, we establish a maximum and a minimum values for the exponent in a general spanning tree with K and M xed. W hen the num ber of species is large these values became equal to 1. Therefore, we must nd = 1 for a large food web and we can conclude that food webs are very e cient resource transportation system s.
