QuasiOne-D im ensional Bosons in Three-dim ensional Traps: From Strong Coupling to Weak Coupling Regime

We analyze a recent experiment on a Tonks-Girardeau gas of ⁸⁷Rb atoms (T.K inoshita, T.W enger, and D.S.W eiss, Science 305, 1125 (2004)). We not that the experimental data are compatible with the one-dimensional theory of Lieb, Seiringer and Yngvason (Phys. Rev. Lett. 91, 150401 (2003)) but are better described by a theory that takes into account variations in the transverse width of the atom ic cloud. By using this theory we investigate also the free axial expansion of the ⁸⁷Rb gas in dierent regimes: Tonks-Girardeau gas, one-dimensional Bose-Einstein condensate and three-dimensional Bose-Einstein condensate.

Two experimental groups [1,2] have reported the observation of the one-dimensional (1D) Tonks-Girardeau (TG) gas [3,4] with ultracold 87Rb atoms in highly elongated traps. A rigorous theoretical analysis of the ground-state properties of a uniform 1D Bose gas, including the beyond-mean-eld TG regime of impenetrable bosons, was performed by Lieb and Liniger (LL) forty years ago [4]. Recently, motivated by the experimental achievem ents, an extension of the LL theory for nite and inhom ogeneous 1D Bose gases under longitudinal connem ent has been proposed on the basis the local density approximation (LDA) [5]. Ohberg and Santos [6] have suggested that the LDA is improved by including a gradient term that represent additional kinetic energy associated with the inhom ogeneity of the gas. This conjecture has been rigorously proved by Lieb, Seiringer and Yngvason [7]. M ore recently we have introduced [8] a variational approach, called generalized Lieb-Liniger theory (GLLT), which reduces to the Lieb-Seiringer-Yngvason theory (LSYT) in the 1D regime and, in addition, gives an accurate description of the crossover from the 1D regime to 3D regime.

In this Brief Report we apply the GLLT to analyze the experim ental results of K inoshita, W enger and W eiss [1]. Contrary to the data of Paredes et al. [2] which are deeply in the TG regime, the data of Ref. [1] cover different quantum -dim ensional regimes and we show that the experim ental atom ic cloud is better described by the GLLT than the LSYT. The GLLT is then used to determ ine the axial free expansion of the ⁸⁷Rb gas. We predict a self-similar expansion whose growth is strictly related to the quantum -dimensional regime of the initial con guration.

In the LSYT [7] the longitudinal density (z) of a zero-tem perature Bose gas is obtained by m in im izing the following energy functional

where $g=2a_s=a_r^2$ is the interaction parameter, with a_s the s-wave scattering length and $a_r=(h=(m!_r))^{1-2}$ the characteristic length of the transverse harmonic potential with frequency !, , V(z) is the longitudinal external potential and e(x) is the Lieb-Liniger function, which is defined as the solution of a Fredholm equation and it is such that e(x) $x=4=(3)x^{3/2}$ for x=1 and e(x) $(2=3)(x=(x+2))^2$ for x=1 [4].

As previously stressed, the LSYT is valid in the pure 1D regime, where the transverse width $R_{?}$ of the Bose gas is frozen and equal to the harm onic length $a_{?}$. In our G LLT [8] the transverse properties of the Bose gas are taken into account by considering the adim ensional width $= R_{?} = a_{?}$ as a variational parameter, i.e. = (z).

where h! $_2$ (2 + 2) =2 is the transverse energy density of the Bose gas. Note that in the low density region where 1 (1D regime) the functional $E_{\rm GLL}$ reduces to $E_{\rm LSY}$. Instead, at higher densities (3D regime) where $e(g=(^2))$ $g=(^2)$, the functional $E_{\rm GLL}$ gives the energy functional of the nonpolynomial Schrödinger equation (NPSE) [9], an elective 1D dierential equation we have derived from the 3D G ross-P itaevskii equation [10] to describe Bose-E instein condensates (BECs) under transverse harm onic connement.

Taking into account the norm alization condition of the longitudinal density (z) to the total number N of atoms, the m in imization of the energy functional E $_{\rm G\,L\,L}$ with respect to (z) gives the equation

where $\,$ is the chem ical potential $\,$ xed by the normalization condition. The m inim ization of the energy functionalE $_{\rm G\,L\,L}$ with respect to $\,$ (z) gives instead the equation

This implicit equation must be solved numerically but analytical results can be obtained in limiting cases. In particular, under the condition $a_s=a_?$ [11], one gets $\frac{P}{\overline{a_?}}$ ($g)^{1=4}$ for $1=a_s$ (3D BEC regime) and 1 for $1=a_s$ (1D regime). Note that the 1D regime contains two subregimes: the 1D BEC regime for $a_s=a_?^2$ $1=a_s$, and the TG regime, where $e(g=(\ ^2))$ $^2=3$, for $a_s=a_?^2$.




FIG. 1 (color online). A xial density (z) of a Bose gas of 50 $^{87}\rm{R}\,b$ atom s in an anisotropic harm onic trap with frequencies! and! z. Four values of trap anisotropy: r = = $_{\rm m~ax}$, where = ! $_{\rm ?}$ =! $_{\rm z}$ and $_{\rm m~ax}$ = 2570. Comparison among various theories: GLLT (full line); GLLT with TF approximation (dotted line); LSYT (dashed line); LSYT with TF approximation (long dashed line). Length in units az, and axial density in units 1=az.

In the experim ent of K inoshita, W enger and W eiss [1] an ensemble of about 6400 parallel 1D traps has been created by means of a 2D optical lattice, that strongly con nes atom s in 1D tubes. The traps di er only in the number of 87Rb atoms each contains. As discussed in [1], each trap can be modelled by an anisotropic harmonic potential, where the axial frequency is $!_z = 2$ 27:5 Hz and the transverse frequency !? is tuned by changing the energy depth ${\rm U}_{\,0}$ of the con $\,$ ning optical lattice. The maximum transverse frequency is 2 lows that the maximum trap anisotropy is $_{max} = 2570$, where $= !_{?} = !_{z}$. K inoshita et al. [1] have worked with $r = m_{ax}$ ranging between r = 1 and $r = 10^{-1}$, a regim e where the Bose gas is quasi-1D.

By adding an imaginary time term at right side of Eq. (3) and solving Eq. (3) and Eq. (4) with a nitedi erence Crank-Nicolson predictor-corrector scheme [12], we calculate the density pro le (z) of the Bose gas using the trap param eters of Ref. [1]. In Eq. (3) we set V (z) = m! $\frac{2}{z}z^2=2$. The results are shown in Fig. 1, where we compare LSYT with GLLT, plotting also their Thom as Ferm i (TF) approximations which neglect the gradient term in Eq. (1) and Eq. (2). Figure 1 shows that, for the trap anisotropy r = 1, the TF approxim ation is remarkably accurate but there are instead quantitative di erences between LSYT and GLLT due to the fact that ((z)) is not strictly equal to one. The dierences between LSYT and GLLT increase by reducing the anisotropy r of the trap, and also the TF approximation worsens. In fact, by reducing rone induces a crossover from the 1D regime to the 3D regime, whose description cannot be accounted for by LSYT that is purely 1D [7]. We have veried that the dierences between LSYT and GLLT are instead reduced by taking larger values of the anisotropy ratio r.




FIG. 2 (color online). Root mean square (RMS) full length of the Bose cloud of $^{87}{\rm Rb}$ atom s. $U_0{=}E_{\rm rec}$ is the trap depth U_0 in units of the atom recoil energy $E_{\rm rec}$, where $U_0{=}E_{\rm rec}=87\left(=_{\rm max}\right)^2$ with $=!_?{=}!_z$ and $_{\rm max}=2570$. Experim ental data are obtained in [1] by averaging over several clouds with dierent numbers of atoms (maximum number $N_{\rm max}=54$).

In Fig. 2 we plot the experimental data of the root mean square (RMS) length of the atom ic cloud obtained by K inoshita, W enger and W eiss [1]. This RMS axial length has been derived as the average over several clouds which have dierent numbers of atoms. In Fig. 2 the RMS full length is plotted versus $U_0 = E_{\rm rec} = 87 \, {\rm r}^2$, where U_0 is the energy depth of the optical potential and $E_{\rm rec}$ is the recoil energy of the gas. K inoshita et al. [1] have compared their data with LSYT [7] in the TF approximation [5]. By performing the averaging procedure of Ref.

[1] on our LSYT results, we obtain the same theoretical curve shown in Fig. 4 of Ref. [1] and plot it (dashed line) in our Fig. 2. W ith the same averaging procedure we obtain also the GLLT curve (dotted line). Figure 2 shows that our GLLT ts better than LSYT the experimental data. As discussed in [1], the experimental data for $\rm U_0=E_{\rm rec}<20$ are strongly a ected by the tunneling between adjacent tubes and the theoretical analysis based on a single tube overestimates the axial width of the Bose cloud.

Our GLLT is a simple and useful tool to investigate also dynam ical properties of a Bose gas under transverse harm onic con nement. The dynam ics of the Bose gas can be described by means of a complex classical eld (z;t) that satis es the equation in $\theta_t = -E_{\rm GLL}$ [j j²;], where j (z;t) j² = (z;t). This time-dependent nonlinear Schrodinger equation can be explicitly written as

where [] is the bulk chem ical potential, given by

The Eq. (5) with Eq. (6) must be solved self-consistently with Eq. (4). It is important to observe that for $a_s=a_2^2$ (TG regim e) one has 1 and and Eq. (5) reduces the time-dependent nonlinear Schrodinger equation (NLSE) introduced by Kolomieski 1=a_s (1D regime or TG regime) et al. [13]. For 1 but $3h^2 = (g =) = (2m)$ still we have $h^2g e^0(g=)=(2m)$ and Eq. (5) becomes equal to the tim e-dependent NLSE proposed by Ohberg and Santos [6], which reduces to that of Kolomieski et al. in the $a_s=a_?^2$ (1D regime or 3D regime) TG regime. For eq. (5) gives $(1 + ga_y^2)^{1-4}$, the Eq. (6) reads $h^2g = (m^2) + h!_2(2^2 + 2^2) = 2$ and Eq. (5) the Eq. (5) gives becomes the time-dependent NPSE [9]. The NPSE coincides with the equation of Ohberg and Santos in the 1D BEC regim e, where $a_s = a_s^2$ 1=a_s, but it accurately describes also the 3D BEC regime, where $\overline{a_{?}}$ (g)¹⁼⁴.

The time-dependent (TD) GLLT given by Eq. (5) must be carefully employed. In fact, Girardeau and W right [14] have shown, studying the interference of two Bosonic clouds, that the time-dependent NPSE of K olom ieski et al. [13] overestim ates the coherence of the Tonks-Girardeau gas. However, the TD GLLT can be safely used to calculate collective properties of the Bose gas. In Ref. [8] we have shown that the time-dependent GLLT gives the expected values for the axial breathing mode $_{\rm Z}$ of the Bose cloud in a harmonic con nement with V (z) = m! $_{\rm Z}^2$ z²=2. In particular, we have found $_{\rm Z}$ = 2 $_{\rm Z}$ in the Tp regime, $_{\rm Z}$ = 3! $_{\rm Z}$ in the 1D BEC regime, and $_{\rm Z}$ = 5=2! $_{\rm Z}$ in the 3D BEC regime.

Here we analyze the free axial expansion of the Bose gas by means of the time-dependent GLLT. We consider the expansion of the Bose gas when the axial harmonic connement is removed (! $_z = 0$) while the radial one is kept xed. By setting (z;t) = (z;t) exp (iS (z;t)=h), the Eq. (5) is equivalent to the two hydrodynamics equations $\theta_t + \theta_r$ (v) = 0 and

the two hydrodynam ics equations $\theta_t + \theta_z$ (v) = 0 and m $\theta_t v + \theta_z$ [$h^2 = (2m^P -)\theta_z^{2P} - + m v^2 = 2 + V +] = 0$ of a 1D viscousless uid with density eld (z;t) and velocity eld $v(z;t) = (h - m)\theta_z S(z;t)$. If the initial axial width of the cloud is larger than the healing length $h = \frac{2m}{2m}$ then one can safely neglect the quantum pressure (QP) term

 $h^2 = (2m^p -)e_z^2 p^2$ in the second hydrodynam ics equation. Note that the bulk chem ical potential of Eq. (6) scales as in the three relevant regimes: = 2 in the TG regime, = 1 in the 1D BEC regime, and = 1=2 in the 3D BEC regime. It is straightforward then to prove that in these regimes the cloud density decreases during the time evolution following the self-similar solution (z;t) = (z=b(t);t=0)=b(t), where the adimensional axial width b(t) satis es the equation

The solution of this equation with initial conditions b(0)=1 and b(0)=0 can be obtained by quadratures. For large t the solution is $b(t)=\frac{p}{2}$!zt. In general, () is not a power law and during the expansion the functional dependence of () changes throughout the whole cloud: the expansion is no more truly self-similar. However, by evaluating the dynamics at the center of the cloud (z = 0) where the initial density is 0, from the two hydrodynamics equations without the QP term one nds

For large t the solution of this equation is $b(t) = \frac{1}{2}$! zt, where naturally appears the e ective polytropic index

that is the logarithm ic derivative of the chem ical potential . In order to verify these analytical results we simulate the free axial expansion of the Bose gas by num erically solving Eq. (5) self-consistently with Eqs. (4,6). In our simulation we employ a real-time C rank-N icholson method [12].




FIG. 3 (color online). A xial free expansion of the Bose gas of 50 $^{87}{\rm Rb}$ atom s with initial anisotropy ! $_{?}$ =! $_{z}$ = 2570. Upper panel: time evolution of the normalized axial width W (t) = $hz^{2}i(t)=hz^{2}i(0)$ of the atom ic cloud. Lower panel: time evolution of the velocity dW =dt of the axial width. TD G LLT given by Eq. (5) and numerical solution of Eq. (7) with from Eq. (9).

In Fig. 3 we plot the time evolution of the normalized axial width W (t) of the Bose gas with N = 50 atoms and initial anisotropy of the harmonic trap given by r=1 (! $_?=!_z=2570$). After a transient the width W (t) grows linearly in time, as clearly shown by the lower panel of Fig. 3, where we plot the width velocity dW =dt. In Fig. 3 we plot also W (t) and dW =dt calculated with two

alternative m ethods: by using Eq. (8) and by using Eq. (7) with given by Eq. (9), in both cases taking into account Eqs. (4,6).

Figure 3 shows that the approximation based on the polytropic index is reliable; note that in all our tests the relative error in the slope of the asymptotic linear grow th is always within 5%.




FIG. 4 (color online). Slope = $\frac{1}{2}$ of the asym ptotic linear growth of the axial width of the Bose gas as a function of the initial density $_0$ of the 87 Rb cloud at the center of the trap. Three values of the initial anisotropy of the harm onic trap: anisotropy ratio r de ned as in Fig. 1.

In Fig. 4 we plot the slope = $\frac{p}{2}$ as a function of the initial density $_0$ at the center of the cloud. smoothly changes from 1 to $\frac{1}{2}$ and than to 2 in the transition from the TG regime to the 1D BEC regime and then to the 3D BEC regime. Figure 4 shows that for 1 in addition to the two plateaus corresponding to = 2 at high densities (3D BEC regime) and to = 1 at low densities (TG regime), an additional plateau appears with = $\frac{p}{2}$ at intermediate densities (1D BEC regime).

In conclusion, we have analyzed a recent experim ent on dilute Bosons in the Tonks-G irardeau regime by using a beyond-mean-eld theory that takes into account transverse variations of the atom ic cloud. Remarkably, our theory shows a better agreement with the experimental results than the simple 1D approach proposed by various authors in the past years. On the basis of this theory, we have predicted a quasi self-similar expansion of the gas when the axial connement is removed, showing that asymptotic linear growth of the axial width strongly depends on the quantum-dimensional regime of the Bosonic cloud.
